RIOT ACT RAZED?

- Federal judge strikes down Anti-Riot Act as unconstitutional, due in part to efforts of fledgling FREE EXPRESSION FOUNDATION

In a stinging defeat for the hard left and its media enablers and collaborators and a momentous victory for constitutional liberty, on June 3 federal District Court Judge Cormac Carney granted the defense motion to dismiss the indictment in the Justice Department's highly political prosecution in California of members of the Rise Above Movement (RAM) under the federal Anti-Riot Act.

In a solidly reasoned opinion, Carney struck down the Anti-Riot Act as unconstitutional and ordered the defendants' immediate release. The RAM members, brought into the courtroom in shackles, were unshackled and walked away free men.

While primary credit must go to the hardworking defense counsel, the FREE EXPRESSION FOUNDATION (FEF) played an important role, providing legal analysis to the defense and submitting an *amicus curiae* brief that Carney, over the government's opposition, accepted for filing. In short, right out of the gate FEF has had a major victory for free speech for all Americans.

As explained in a recent AFP ar-

...ticle (April 8, 2019), the U.S. government's attempted revival of the long-dormant Anti-Riot Act poses a grave threat to Americans' First Amendment rights. The act improperly criminalizes mere intent alone, is in manifest discord with recent Supreme Court decisions, is flagrantly overbroad, and gives far too much discretion to the government to enforce it selectively on

purely political grounds. And selective enforcement is precisely what happened in the RAM prosecutions. The government, bending to political pressure, averted its eyes from clear evidence that antifa groups attacked and disrupted pro-Trump rallies in California and the Charlottesville assembly. Of the hundreds of rowdy people at the rallies, only the eight RAM members were charged by the government.

Carney began his opinion by observing:

It is easy to champion free speech when it advocates a viewpoint with which we agree. It is much harder when the speech promotes ideas that we find abhorrent. But an essential function of free speech is to invite dispute. Speech "may in-

For those who don't know, the AFPRC is a group of AFP subscribers, who in return for paying \$76 a year—which can be paid once a year or split quarterly or semiannually—get an annual AFP subscription along with a special “insider” newsletter called *The Council Courier* and 10% off purchases of books and DVDs. It's a good program for people who are interested in more than just the news. They want to know about us and the organization, too, and are willing to pay just \$17 more a year to do so.

In that commentary, I quote from an Associated Press (AP) article from earlier this year that noted:

All newspaper owners face a brutal reality that calls into question whether it's an economically sustainable model anymore unless, like the Jeff Bezos-owned *Washington Post*, the boss is the world's richest man. . . .

“They're getting eaten away at every level,” said Ken Doctor, a news industry analyst at Harvard's Nieman Lab.

Newspaper circulation in the U.S. has declined every year for three decades, while advertising revenue has nosedived since 2006, according to the Pew Research Center.

Staffing at newspapers large and small has followed that grim trendline: Pew says the number of reporters, editors, photographers, and other newsroom employees in the industry fell by 45% nationwide between 2004 and 2017.

The broader point of the AP article was that

local newspapers, once largely immune to declining circulation, have been hit hard the past few years just like the big media, as more and more people rely on the Internet to get their local information.

For what it's worth, it's not just newspapers that are struggling. Cable and Internet news outlets have been floundering, too, evidenced by announcements of mass layoffs and buyouts at online media firms like “Vice” and “Vox.” Cable news giant CNN even announced recently that it was initiating a series of buyouts for hundreds of employees, a move corporations typically make in order to avoid the public relations disaster of having to fire large numbers of staff or declare bankruptcy.

Perhaps worst of all was the recent sale of Salon.com, a liberal news and commentary website. Once considered the most popular Internet news source for liberals, the site, which still gets millions of views every month, recently sold for \$5 million with the buyer required to make only a \$500,000 down payment.

You don't need a doctorate in business to know that the U.S. news industry is a dumpster fire. And where does America's last real national newspaper stand amidst all of this?

As we've written many times before, the good news is AMERICAN FREE PRESS has zero debt, which means we aren't beholden to faceless shareholders, who are only interested in their pound of flesh—the return on their investment—and couldn't care less about whether they are getting the unbridled truth from their news source. Over the years this has given us the breathing room to do what we've had to do in order to maintain our survival and invest in the future.

That said, this newspaper has certainly not


been immune to the wave of declining circulations plaguing the industry. One simple fact that cannot be ignored today is that the generation of print newspaper readers is aging and dying off. The unfortunate reality is, at some point in the next 10 years, AMERICAN FREE PRESS will have to either switch to an entirely new format that is cheaper to produce than newsprint or—worst-case scenario—go digital-only as the cost of printing outpaces our subscriber base.

News You May Have Missed

Tariffs Are Working

On June 7, President Donald Trump announced that he had worked out a deal with the Mexican government whereby Mexico would do much more to prevent illegal immigrants from crossing the border into the United States. The last-minute agreement avoided a 5% tariff Trump was threatening to slap on goods from Mexico, which was set to go into effect on June 10. The new deal shows that the threat of tariffs worked in spite of naysayers, who predicted there could be no resolution.

Who Funds Migrant Caravans?

Mexican authorities have so far refused to turn over to the U.S. the names of the 26 individuals and organizations whose assets were frozen as part of a new probe into migrant caravans and cartel-linked human smuggling organizations. On June 6, Mexico's Finance and Tax Secretariat seized the 26 accounts, which included some from the United Kingdom and the U.S. It is alleged that the money was being used to help fund the caravans made up of thousands of migrants, who largely originated from Central America.

Doing the Job on the Border

U.S. Customs and Border Protection reported on June 5 that apprehensions of illegal aliens topped 144,000 for the month of May. So far this year, 676,315 illegal aliens have been detained, up 99% over this time last year.

Uncle Creepy Strikes Again

Joe Biden, who is currently leading in the polls for the race to be the Democratic presidential candidate, has been repeatedly accused of creepily touching women and young girls and putting his face in their hair over the years. On June 4, Biden decided to double down on the charges rather than keep his hands to himself. According to *The Hill*, a Washington, D.C. daily, Biden joked about the accusations during a campaign stop when a female voter whispered something in his ear. "We've got a little secret going here," quipped Biden. "I want the press to know she pulled me close."

Democrat Propaganda Outfit Failing

Liberal news and commentary website "The Daily Beast" reports that Think Progress, the far-left propaganda arm of the Democratic Party, is "facing dire financial troubles and bleeding staff." In spite of liberals going off the deep end with Trump derangement syndrome in the age of President Donald Trump, the activist media company anticipates being \$3 million short in its budget for 2019 due to lower donations and ad revenue for the year.

Space City Sisters Shelved

Earlier this year, the Houston Public Library system invited homosexual men who dress as women, called "drag queens," to read stories to little children. Even worse, the library never bothered to do background checks on any of the members of the so-called "Space City Sisters," who were giving the free readings. One man, reported the website "LifeSiteNews," who worked as a "greeter" for kids, had been convicted of molesting four young children (ages four, five, six, and eight), had been jailed, and is listed as a "high risk sex offender" on the national sex offender registry.

What Persecution Looks Like?

How do we know that gays are not persecuted in the United States? Writes Matt Walsh for "The Daily Wire," a news and commentary website, "As everyone knows, June is African-American Music Appreciation Month. It's also National Safety Month and National Smile Month. And we can't forget that it is ALS Awareness Month, Alzheimer's and Brain Awareness Month, Cataract Awareness Month, Hernia Awareness Month, Myasthenia Gravis Awareness Month, National Aphasia Awareness Month, National Congenital Cytomegalovirus Awareness Month, National Scleroderma Awareness Month, and Scoliosis Awareness Month. But all of these holy observances must take a backseat to the most hallowed of them all: LGBT Pride Month. . . [So] don't tell me that this is what persecution looks like."

Left Chews Up Its Own

Earlier in June, a black homosexual man, who works at the front desk of a Holiday Inn Express hotel in Austin, Texas, become an overnight sensation on the Internet after he released a video of

himself telling off a woman who called him a racial slur. His fame was short-lived, though, after far-left activists turned on him when they found out several years ago he committed a crime to them by saying he didn't "get" transgendered people. People Revolt Against NWO

• Mass immigration, failure of globalism behind Europe's recent nationalist resurgence

Nationalists and populists across Europe made tremendous gains in the recent European Union (EU) elections, demonstrating the appeal of these highly demonized political ideologies in an era of economic and political globalization, massive Third World immigration to the continent, and an increasingly out-of-touch elite political class ruling in Brussels determined to push European integration at all costs.

Even traditionally leftwing parties, such as the Social Democrats in Denmark, have taken a more populist approach on issues like immigration. Mette Frederiksen, the 41-year-old leader of Denmark's Social Democrats whose party recently won 25.9% of the vote in Danish elections, has increasingly pushed her party to the right on the key issue of massive Third World migration into Europe, a top issue for many Danish voters. Frederiksen has addressed the issue in more traditionally leftwing terms, arguing that globalization and massive immigration have harmed the middle and working classes of Denmark and other European nations.

"For me, it is becoming increasingly clear that the price of unregulated globalization, mass immigration, and the free movement of labor is paid for by the lower classes," Frederiksen stated in a recent biography.

Frederiksen's Social Democrats have long played a key role in Danish politics, working with more right-leaning parties, including the Danish People's Party—which is seen by many as the most far-right party in the country—on key issues such as immigration. The Social Democrats in Denmark have supported policies that crack down on

refugee resettlement and unchecked migration, positions the traditionally left-leaning party formerly opposed. Frederiksen has argued that SD parties in other European countries must adopt a more hardline stance on immigration, which poses a major threat to their traditional voter base: middle- and working-class Europeans.

"For years, we have underestimated the challenges of mass immigration," Frederiksen argued

at a meeting of Social Democrat parties around Europe late last year. "Economic policy and foreign policy in Europe have been too liberal. We have failed when it comes to maintaining the social contract, which is the very foundation of the social-democratic social model."

The positions on immigration taken by Frederiksen and other populists across Europe stand in stark contrast to the elites in Brussels, who view massive immigration and spreading "diversity" as moral imperatives that must be championed and implemented across the continent.

Outgoing European Commission President Jean-Claude Juncker, epitomizing the mindset of the nation-wrecking globalist elites that have largely dominated the European Union and broader project of European integration, harshly criticized the various populist and nationalist movements and leaders that have come to the fore of European politics, particularly in recent years as Euroskepticism has risen across the continent.

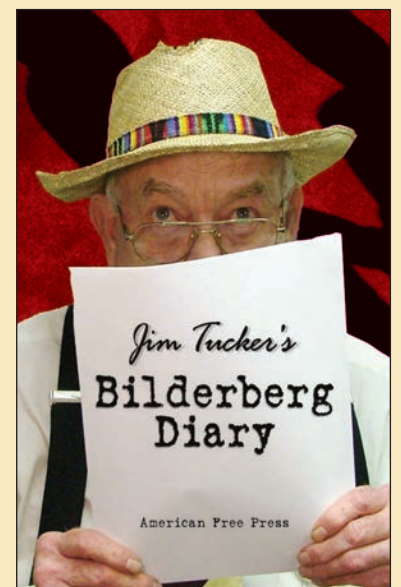
"These populists, nationalists—stupid nationalists—they are in love with their own country, and they don't like the others," Juncker arrogantly and dismissively stated in an interview with CNN shortly before the recent European elections. "In some countries of the European Union, the government, parliament, major parts of society, don't like those coming from far away. I do like those coming from far away, because the main guiding principle of the European Union should be solidarity. We have to act in solidarity with those who are in worse situations than we are."

Many Europeans are beginning to view the suicidal mindset of Juncker and other EU elites as entirely contrary to the interests of their respective nation-states, which have seen massive Third World immigration, rising crime and instability, and a total failure on the part of European Union

institutions and governments in actually integrating the various newcomers into the EU. Many European nations, such as France, Germany, Sweden, and the United Kingdom, have seen a tremendous influx of so-called refugees, asylum seekers, and other Third World immigrants, resulting in protracted cultural, social, and economic problems across the continent.

The so-called “new Europeans” have largely failed to successfully integrate into European society, preferring instead to cling to their national

and ethnic identities, which has contributed to the polarization of society, a fact political leaders like Frederiksen have long recognized.

“In my eyes, it is neither heroic nor humane to bring so many people here that the problems become huge in our own country,” the leader of Denmark’s Social Democrats declared before the 2015 election, “because we’re not very good at integrating in Denmark, and there’s nothing to indicate that we’re going to get better.”

In Italy, the small town of Riace in the southern

province of Calabria recently elected a rightwing government after having been dominated by radical leftists for years. The town, long known as a “global village” whose former political leadership openly welcomed migrants, took in hundreds of refugees and other Third World migrants in recent years, sparking a backlash following reported allegations of corruption, fraud, and unrest among the migrant population.

“The problem is that we had too many migrants and we lost the spirit of openness there was initially,” Antonio Trifoli, the newly elected mayor and former town policeman, stated in a recent interview. Trifoli is affiliated with Italian populist Matteo Salvini and his Lega Nord Party, which has seen a dramatic increase in popularity and political clout in recent elections.

“A whole economic system developed with the migrants, but without making the village dynamic again,” Trifoli said. “The model destroyed itself.”

The clash between globalism and populism continues on the European continent, and at this point, it’s safe to say populism is on the rise, largely because of the disastrous effects of globalism. ★

Bilderberg Insider's Shocking Admission

• Club of Rome founder admitted that 'global warming' is a hoax cooked up to scare public

In the early 1980s, Justin Walker was an idealistic, hard-working member of the British Green Party when, upon being invited to lunch by an apparent fellow "idealist" who also was a well-connected Fiat Motors executive, he heard firsthand that dire claims of impending environmental doom were being fabricated to deliberately instill widespread insecurity, so the overall population could be goaded into world government.

Walker's uncle by marriage was Sir Harry Pilkington, a participant at the very first Bilderberg meeting in Holland in 1954, representing the Federation of British Industries. Pilkington "in 1955 became a director of the Bank of England, a position he held until 1972," Walker told AFP, in an interview just after Bilderberg's 67th meeting this year in Switzerland.

"My own personal experience has shown me that the Green movement is now totally corrupt and totally without any real solutions or meaning for the human race," Walker added. He recalled that, when he joined the Green movement in 1978, most of the party members tried to be "an anti-party party," to distance themselves from conventional party politics, in the belief they actually stood for something and would not let the world's corporate power brokers push them around.

Pilkington, described as a devoted environmental conservationist, in 1980 gave Walker his personal copy of a book called *The World Conservation Strategy*.

"I was very impressed by that because I was in the Green Party, and I felt this is the real way forward for politics," Walker recalled. "And then I read another book called *One Hundred Pages for*

the Future by a man named Aurelio Peccei, who was a senior executive at Fiat Motor Company in Italy, but he also co-founded the Club of Rome—the organization that's behind most of the elite interests in the environment, including, of course, man-made global warming."

Citing the pivotal experience with the Fiat industrialist, Walker continued: "In 1982 I wrote to Aurelio Peccei, and he said, 'Come and see me, have lunch with me.' Unknown to me, my uncle had also approached him because he knew my un-

cle. Well, I was having lunch with Peccei and he suddenly offered me a job to go and work as one of his researchers for the Club of Rome. He then said to me—and these were his exact words that I remember so clearly—"You'll be joining us at a very exciting time. We are creating a global environmental problem that's going to frighten people into wanting global government."

"At the time," Walker said, "being a Green politician, I thought this was wonderful. I didn't know the facts about Bilderberg, because this was before [British conspiracy researcher] David Icke [also a former Green Party member] started doing his research and other people started doing their research, to show that there's a hidden tier of government above our elected governments."

Walker added that, up until 1982, "Nobody mentioned manmade global warming. If anything, they were talking about a mini ice-age. And they were talking about acid rain. This was obviously when they started to get the idea that they could latch onto 'global warming.'"

Walker confessed: "I considered going to work for Peccei for about a week. But I worked for my father at the time, and I was in the Territorial Army and had just been [promoted] to captain. I had a new girlfriend. And I was in the Green Party and thought I was going to get elected to Parliament."

Pilkington died the next year in 1983, and Peccei died in 1984. Pilkington, late in his life, would

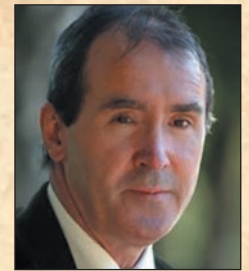

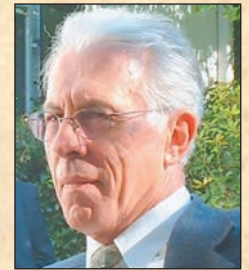

Big Media Covers for Bilderberg

• Globalists want Silicon Valley's help on censorship, election fixing, new war tech

By Mark Anderson

Several ironies and surprises surround the 2019 Bilderberg conference that ran May 30-June 2 in Montreux, Switzerland, not the least of which were reasonably substantial reports in two of America's leading members of the mass media cartel—*The New York Times* and *The Washington Post*.

Why all the fuss from media giants that usually downplay or ignore Bilderberg? Well, the big media's favorite target, President Donald Trump, sent his chief adviser and son-in-law Jared Kushner and Secretary of State Mike Pompeo to Bilderberg, along with several National Security Council and Office of the Secretary of Defense personnel—not to mention the attendance of possible Democratic presidential candidate Stacey Abrams, the radical black leftist attorney who lost her bid for Georgia's governorship.

The *Times* noted in a May 31 piece:

Secretary of State Mike Pompeo is on a weeklong trip to Europe where he is raising sensitive issues with national leaders—from Iranian missiles to Chinese technology to the economic collapse of Venezuela—but the most colorful conversations could take place this weekend out of public earshot in a secretive conclave at a Swiss lakeside resort.

It didn't seem to occur to the *Times* that perhaps such sensitive matters shouldn't even be discussed at Bilderberg, whose participants, representing a broad spectrum of government and corporate power, could have unknown personal connections and may leak sensitive information

about U.S. national security—a key problem with Bilderberg to begin with. At any rate, the *Times* called Bilderberg's 67th meeting in 65 years “an annual forum in which participants agree not to reveal exactly what was said or who said it. It is a shadow version of Davos, the elite annual winter conference in the Swiss Alps that President Trump has attended once but has also criticized.”

While that last passage could almost be mistaken for the late AFP Bilderberg hound Jim Tucker's writings, what the *Times* didn't disclose is that another *Times* reporter—renowned national security writer David E. Sanger—was al-

ready inside Bilderberg as a listed participant. The *Times*'s duplicity was matched by the *Post*. While *Post* writer Adam Taylor scribbled a screed that combined poking fun at Bilderberg's critics with tidbits of real reporting, he pled ignorance about what Bilderberg might ultimately be discussing, to wit:

The involvement of key Trump administration members may spark criticism from those who view the meetings as nefarious gatherings of the global elite. Conspiracy theorists, including a number who have publicly supported Trump, have picketed the event in recent years The meeting's website lists topics for discussion this year, including “China,” “Russia,” “Brexit” and “Climate Change and Sustainability.” One thing not listed, however, is the topic that is apparently driving Pompeo's visit to Europe: Iran, which the Trump administration claims poses a growing threat Could the world's power brokers end up discussing Iran anyway? Perhaps. But it's unlikely that we'll ever know.

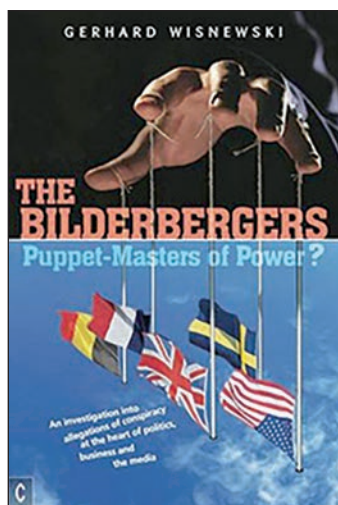
Really? Taylor could simply huddle with fellow *Post* writer Megan McArdle, who joined Sanger inside Bilderberg. And the Bilderbergers' famed Chatham House Rule needn't be an obstacle; the *Post*'s intrepid reporters certainly could pump Megan for information and dodge the rule.

Meanwhile, the alternative press on the ground endured very trying circumstances. Dan Dicks of Press for Truth, Luke Rudkowski of We Are Change, and Glen Bolton of the Conspiracy Cabbie were detained at the Geneva airport while photographing and questioning stone-cold-silent invitees to the Bilderberg meeting.

They did spot former Google CEO Eric Schmidt as he strolled outside the Bilderberg meeting to

ask him whether Bilderberg has had anything to do with de-platforming online conservative-constitutional commentators, with nerdy Schmidt brusquely brushing off the questions. Yet these hard-working reporters were the ones being questioned by police who politely searched the reporters several times. Dicks remarked that freedom of the press seems to nosedive whenever Bilderberg is in town.

Guardian reporter Charlie Skelton, whose annual writings on Bilderberg extended to *Newsweek* online this year, walks the fine line between mainstream and alternative reporting on Bilderberg. In a witty and in many ways insightful *Newsweek* piece he noted:

As the war machine gets smarter, and every last bit of weaponry becomes AI-enhanced, the lines between Silicon Valley and the Pentagon start to [blur]. Sniff this year's Bilderberg and you can smell this new kind of war: "cyber threats" and "the weaponization of social media" are on the agenda . . . This blurring of tech and war takes physical form in some of the participants at Bilderberg. Longtime conference insider and former Google CEO Eric Schmidt chairs the Pentagon's Defense Innovation Board and also heads up the new National Security Commission on Artificial Intelligence.

Two other members of the Defense Innovation Board are here in Montreux: Reid Hoffman [of LinkedIn] and psychologist Adam M. Grant. Alongside Schmidt on the Bilderberg Steering Committee are [two more] tech billionaires, Alex Karp and Peter Thiel. Karp is the CEO of Palantir, a shady data-analytics company which has just won a massive \$800 million Pentagon battlefield intelligence contract. Palantir was set up in 2004 by Peter Thiel with backing from the CIA.

Those are some interesting observations, but consider some highlights of the greater Bilderberg network that often are overlooked by both mainstream and alternative media:

2019 Bilderberg attendee Fernando Medina, the mayor of Lisbon, flew immediately from Switzerland to attend the Pritzker Forum on Global Cities in Chicago June 5-7, where the elevation of municipal power to the global level to sidestep the nation-state was the central theme. That forum, which sees the global cities movement as a means of countering the populist uprising that Bilderberg fears, included a presentation on "Resilient Cities," a Rockefeller Foundation-backed

project that involves technological input from Karp's Palantir firm.

The Trilateral Commission, the younger and somewhat more open Bilderberg sibling which in many ways makes Bilderberg's dealings more visible, for the first time ever held its annual North American Regional Meeting in Silicon Valley, Calif., Nov. 16-17, 2018. Interestingly, the Trilaterals' European Regional meeting held the same month included Canadian "anti-PC" psychology professor Jordan Peterson as one of its speakers, addressing "A Provocation: Will Liberal Democracy Survive?" That meeting also included 2019 Bilderberg participant José Manuel Barroso, former European Commission president.

And 2019 Bilderberg attendee Microsoft CEO Satya Nadella is partnering with two highly suspect companies, NewsGuard and ElectionGuard, to police cyberspace for "fake news" and re-tool our election machinery to make elections more "accountable," even while NewsGuard, which involves using real editors instead of computer algorithms to weed out suspected "disinformation," has advisory board members and investors tied to Bilderberg, the CIA, CNN, and the global cities movement.

The reality is that today's Bilderberg is just one of several groupings within a network that constitutes a powerful private tier of government. And the network's architects are pressing onward, despite being at an apparent crossroads: The Trilateral Commission's 2019 plenary meeting took place June 14-16 in Paris and the commission's next European meeting will be Nov. 22-24 in Stockholm, Sweden. ★

If Julian Assange, WikiLeaks Lose, Journalism May Never Recover

WikiLeaks founder Julian Assange is starting to rack up some small victories that may have big cumulative results, though the question of whether or not he can maneuver from beneath the great legal behemoth of U.S. law is still yet to be determined. All well and good that he is achieving at least some positive results, as WikiLeaks has been a valuable contributor to the field of journalism and the most vital entity forcing government transparency in the digital age.

In May, the UN's special reporter on torture, Nils Melzer, issued a statement clearly chastising the United States, Great Britain, Ecuador, and Sweden for their treatment of Assange.

The public rebuke of those nations against Assange has been a breath of fresh air to observers who clearly see the freedom-disparaging precedents that any Assange prosecution would set. Melzer summed up what the WikiLeaks founder has experienced for nearly a decade.

"In the course of the past nine years," Melzer continued, "Mr. Assange has been exposed to persistent, progressively severe abuse ranging from systematic judicial persecution and arbitrary confinement in the Ecuadorian embassy, to his oppressive isolation, harassment, and surveillance inside the embassy, and from deliberate collective ridicule, insults, and humiliation to open instigation of violence and even repeated calls for his assassination."

In early June, Swedish courts declined to issue an arrest warrant for Assange, eight years after the

European arrest warrant was believed to have been issued. Seeking a new warrant against Assange, Swedish prosecutors failed to get the expected rubber stamp. Rather, the court said that an issuance would be "disproportionate." This is a blow to many leftists in the UK and the U.S., who so desperately wanted Assange to have "rapist" permanently embedded next to a bullet point on his bio. Some leftists hate Assange, believing that he and Wikileaks worked with Donald Trump to undermine the presidential campaign of Hillary Clinton. Now that there is no arrest warrant from Sweden, there is also no extradition warrant from there, either. Regarding Sweden, Assange's record is hereby clean.

The mainstream media's tirades against Assange have been perplexing and self-serving. While they have been using Assange's more disorganized, less rote collection of whistleblowers as stories and sources of stories for over a decade, they are now using Assange and WikiLeaks as a means by which they can delineate between "real journalists" and "mere leakers." There has been no acknowledgment of the changing face of journalism, the dwindling importance and viewership of the mainstream, and, more importantly, the governmental accountability that WikiLeaks has forced.

Since publishing its first document in 2006 (a signed decision by a Somali sheik to assassinate government officials), WikiLeaks has released over 10 million documents. In their first two years alone, WikiLeaks exposed the daily protocol of the U.S. Army at Guantanamo Bay, that some Gitmo prisoners were off-limits to the Red Cross, the illegal activities of banks in the Cayman Islands, "the secret bibles of Scientology," the contents of Sarah Palin's Yahoo! email account (hacked by the

group Anonymous), and a list of members in the British National Party.

WikiLeaks was never accused of being a tool of the American political right or any of its politicians then. That is a new delusion perpetrated by angry partisans. WikiLeaks was valuable and trusted through the final Bush years and even more so during the presidency of Barack Obama when it exposed the war crimes of the U.S. military.

In February 2010, WikiLeaks began publishing documents sourced from Army Private Bradley (Chelsea) Manning. The most notable was the "Collateral Murder" video of a 2007 airstrike in Baghdad that resulted in the killing of two Reuters reporters by U.S. pilots who mistakenly thought they were carrying weapons.

What turned Assange, unfairly, into a partisan figure was the 2016 release of 1,258 emails from a personal server illegally kept in the home of then-Secretary of State Hillary Clinton. Also released were 20,000 emails and 8,000 documents from the Democratic National Committee, many of which showed a concerted internal campaign against Bernie Sanders and in favor of Clinton.

Are the employees and volunteers of WikiLeaks journalists? They've won *The Economist* New Media Award, *Time* Magazine's Person of the Year, the Sam Adams Award for Integrity, the Martha Gellhorn Prize for Journalism, the Voltaire Award for Free Speech, and a variety of journalism awards in Brazil, Kazakhstan, Italy, and the U.S. WikiLeaks was nominated for a Nobel Peace Prize for six consecutive years (2010-2015). Today, its founder sits in jail for exposing financial abuses, human rights abuses, and war crimes. ★

deed best serve its high purpose when it induces a condition of unrest, creates dissatisfaction with conditions as they are, or even stirs people to anger.” *Terminiello v. City of Chicago*, 337 U.S. 1, 4 (1949). Frequently, the public arena is the stage for these disputes. In the Civil Rights Era, for instance, protestors took to the streets to contest segregation and Jim Crow. Today, people continue to take their message to the streets, advocating on hotly contested issues, whether it be abortion, Black Lives Matter, climate change, or healthcare. One person’s protest might be another person’s riot.

Then, carefully analyzing the act, he noted,

[The act] covers far more than acts of violence. It also criminalizes activities that precede any violence and . . . reaches speech and expressive conduct. . . . No violence even need occur. A defendant could be convicted for renting a car with a credit card, posting about a political rally on Facebook, or texting friends about when to meet up.

Carney then identified a critical failing of the act: In manifest discord with *Brandenburg v. Ohio*, 395 U.S. 444 (1969) and other Supreme Court precedents, it does not require that advocacy be directed toward inciting or producing imminent lawless action. He further observed:

A riot is closely intertwined with political activity. A rioting crowd is often protesting the policies of a government, an employer, or some other institution, or the social fabric in general. A riot may well erupt out of an originally peaceful demonstration. The political nature of a riot increases the risk that the Anti-Riot Act criminalizes a substantial amount of protected expressive activity. To protect citizens’ important rights of speech and assembly, courts must be wary of government attempts

Support Free Expression

to censor a particular view, especially on the basis that certain ideas cause “disturbances.” New ideas, more often than not, create disturbances. And to this end, speech may best serve its “high purpose.”

Attorneys Andrew Allen and Glen Allen, who acted on behalf of FEF in this matter, were jubilant about the decision.

“The act is flagrantly unconstitutional,” Glen Allen remarked, “and the fact that the government invoked it against only RAM members and not antifa calls into question the government’s fairness and impartiality. Thank God there is still sufficient integrity in our judicial system to check such abuses.”

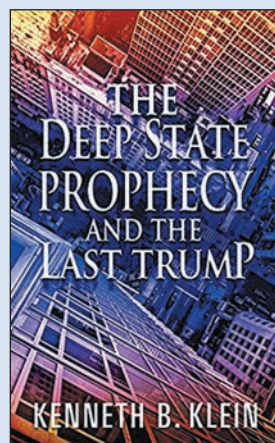
Glen Allen also noted that the FBI and Justice Department relied heavily on reports from “Propublica” and a “Frontline” documentary in preparing the indictment and ignored the more balanced “Heaphy Report.”

Although the California RAM defendants are now free, the Charlottesville RAM defendants, unfortunately, remain in prison. Judge Norman K. Moon in the Charlottesville prosecution, in a prior decision on May 2, 2019, had upheld the constitutionality of the Anti-Riot Act. ★

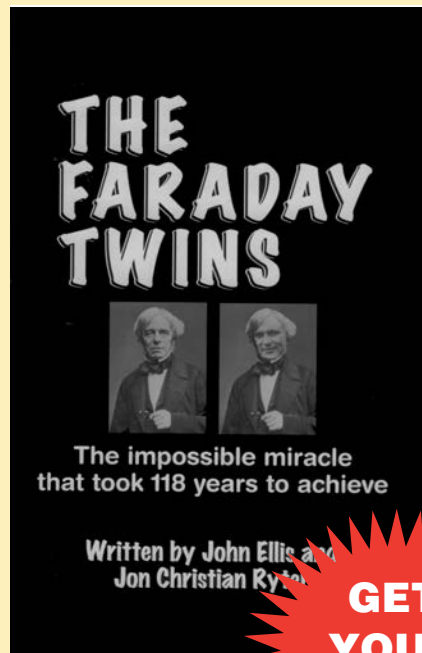

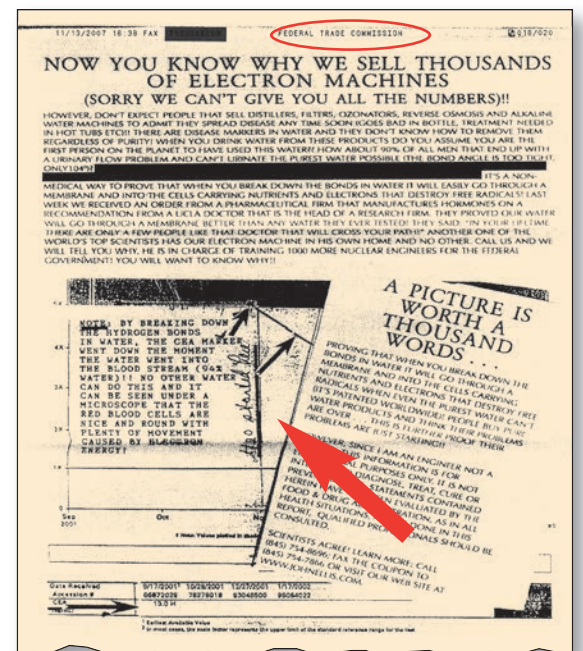

LA Faces Historic Crisis

Homelessness has long been a major problem in California, the most populous state in the union, which ironically boasts one of the nation's largest and most robust economies yet has the highest poverty rate. In recent years, however, it has become increasingly clear that the homelessness problem in major California cities, particularly the Los Angeles metropolitan area, is a full-blown crisis that is threatening public health and sanitation in a way perhaps never seen before.

Homelessness, poverty, and staggering income disparities—common features of Third World countries—are on full display in major cities in California such as Los Angeles, San Diego, and San Francisco. According to a recent homelessness survey conducted annually in Los Angeles County, roughly 59,000 people are living without shelter across the most populous county in the country on a daily basis. That number is up from just under 53,000 in last year's survey, despite an increase in taxpayer-supported funding for public assistance aimed at combating homelessness.

"At this point of unprecedented wealth in the county of Los Angeles, we are equally confronted with unprecedented poverty manifesting itself in the form of homelessness," County Supervisor Mark Ridley-Thomas recently told the *Los Angeles Times*. "Last year's count, we felt we were trimming in a way that would suggest we



were getting our arms around this. And yet this year we are pretty well stunned by this data."

Homeless encampments can be found across Los Angeles County under freeways and overpasses, in public parks and wooded areas, and along the sidewalks of downtown Los Angeles and other major cities in the county. Trash, discarded furniture and other large household items, and piles of rubbish, debris, and human waste litter the city, as garbage and sanitation crews struggle to keep up with the waste. In certain areas of downtown Los Angeles, entire city streets have been consumed with trash, feces, and other debris, some of which is illegally dumped by local businesses and industrial facilities.

"The city of Los Angeles has become a giant trash receptacle," *Los Angeles Times* columnist Steve Lopez recently wrote, arguing that residents are witnessing the "collapse of a city that's lost control."

Heaps of trash, debris, discarded items, and other waste are common features in Los Angeles, particularly in the downtown area. Skid Row, a notorious section of downtown known for its large homeless population, and surrounding areas are in some cases literally covered in garbage and waste, with countless homeless individuals camping and sleeping on the street. The piles of trash and waste are magnets for fleas, flies, rats, and other rodents, leaving area residents fearful for their health and well-being and that of their family and neighbors.

"I can't walk down the street without thinking that a flea could jump on me," Estela Lopez, who works downtown, told NBC4 Los Angeles recently.

Many fear a public health crisis is underway, with diseases such as tuberculosis, typhus, and other contagious diseases common to Third World countries showing up in California.

"Our homeless crisis is increasingly becoming a public-health crisis," California Governor Gavin Newsom declared in his State of the Union address earlier this year. "Typhus. A medieval disease. In California. In 2019."

Disease is spreading largely due to the home-

less crisis, as the garbage attracts disease-spreading vermin. Not only do those struggling with homelessness lack basic shelter and sanitary living conditions, but they also lack reliable access to health services, restrooms and regular showers.

Janice Hahn, who sits on the Los Angeles County Board of Supervisors, stated that area residents are "seeing more encampments, more people sleeping on the sidewalks in dirty, unhealthy, and heartbreaking conditions."

"They are frustrated by this problem," she declared. "We need to give people answers."

Unfortunately, answers and solutions to the homeless crisis are difficult to come by, despite increasing levels of public and private money being directed at tackling the problem. Measure H, an initiative passed by Los Angeles voters in 2017 that added a quarter-cent to local sales taxes to fund programs designed to address the homelessness crisis, has raised close to \$400 million annually, yet the situation only seems to be spreading.

Many argue the driving force is housing affordability. California has some of the highest real estate prices in the country, and modest apartments or townhouses are often exceedingly expensive even for working households. Additionally, substance abuse, mental illness, and other social problems exacerbate the crisis, with many living on the streets addicted to drugs or alcohol and seemingly uninterested in rehabilitation.

This reporter is a resident of Los Angeles County, and can personally testify that the situation is out of control and shows no signs of abating. Cleaning up the county will be a major task for any elected official, and will no doubt require a joint public-private partnership to ensure lasting results. ★

YouTube Inquisitors Demolish History

During the first week of June, YouTube announced a draconian new censorship policy—and immediately erased or demonetized the work of countless videomakers, destroying thousands of livelihoods in the process. Conservatives bore the brunt of the onslaught. The new policy was unveiled in the wake of a highly publicized spat between conservative YouTuber Steven Crowder and “Vice News” commentator Carlos Maza, in which Maza accused Crowder of “bullying” and “homophobia.”

Though justified by liberal Silicon Valley oligarchs as a response to the “racism, sexism, and homophobia” of the alt-right, YouTube’s new censorship plan begins with garden-variety political correctness—and ends in the wholesale falsification of history.

In a June 5 blog post announcing the new policy, YouTube wrote:

Today, we’re taking another step in our hate speech policy by specifically prohibiting videos alleging that a group is superior in order to justify discrimination, segregation or exclusion based on qualities like age, gender, race, caste, religion, sexual orientation or veteran status. This would include, for example, videos that promote or glorify Nazi ideology, which is inherently discriminatory. Finally, we will remove content denying that well-documented violent events, like the Holocaust or the shooting at Sandy Hook Elementary, took place.

The first two sentences sound like a well-meaning but maddeningly muddled mishmash of liberal platitudes. Taken at face value, YouTube is telling us we cannot “allege” that adults are intellectually superior to children and that children should therefore be segregated or excluded from busy streets. Or that 20-year-olds are more physically vigorous than retirees and should be excluded from over-60 basketball leagues. Age discrimination! Or that men are physically stronger than women and should therefore be excluded from women’s athletics. Gender discrimination! Anti-LGBTQ discrimination! Or that poorer people and groups, being in general less capable in intellectual and practical matters than wealthier people and groups, should be given various advantages like free college tuition as part of a policy of reducing inequality. Race and caste discrimination! Or that veterans, having been willing to risk their lives for their country, deserve special benefits. Pro-veterans discrimination!

While the first two sentences of YouTube’s new policy are unintentionally humorous (Veterans? Really?) there is nothing remotely funny about the next: “Finally, we will remove content denying that well-documented violent events, like the Holocaust or the shooting at Sandy Hook Elementary, took place.” This statement,

framed in such a way as to make it sound acceptable to the misinformed multitudes, is truly Orwellian.

“History” is a human construction. It is inherently fallible. It is constantly being revised on the basis of new evidence and interpretations. And the statement includes mention of literally millions of “violent events,” a great many of which are “well documented,” in the sense that there are plenty of documents available relating to any given event. What YouTube apparently doesn’t understand is that virtually all violent and nonviolent events in history are “documented” in complex and contradictory ways and can be interpreted from a wide variety of perspectives.

So how does all that evidence, and all those interpretive perspectives, get narrowed down to a relatively simple narrative about what supposedly happened in a given event? We like to imagine that smart, objective historians sift through evidence and argue about the most plausible interpretations. That is the ideal. Reality is closer to the old adage, “history is written by the victors.” The most powerful people and groups wield various carrots and sticks, forcing the vast majority of historians to consciously or unconsciously toe the official line. The powerless, and their versions of events, are reviled, misconstrued, or consigned to the proverbial memory hole.

Left-wing historians once knew this and openly admitted it. In fact, while I was doing graduate work during the postmodernist-dominated 1990s, they actually exaggerated the degree to which truth is unknowable and “history” is just a myth inflicted by the powerful on the powerless.

But then came 9/11, which was designed by people like Philip Zelickow—a self-proclaimed specialist in “the creation and maintenance of public myths.” 9/11 was a scripted and staged human sacrifice event of the kind studied by ethnologist René Guénon. Part of its purpose was to re-mythologize history, so the common people could once again be force-fed “noble lies.”

In Medieval Europe, if you “denied” the official version of certain mythic “violent events”—the Crucifixion, the Cathar genocide, or even the Inquisition itself—you could be tortured and burned at the stake. With the Enlightenment came the modern discipline of history, which, fallible as it is, offers a better path to truth—the path of absolutely free and fearless debate.

In the wake of the mythic big lie of 9/11, the Enlightenment has been revoked. YouTube is killing heretics by destroying their livelihoods; Internet censorship is today’s Inquisition. ★

side of Lincoln, revealing him to be a constitutional usurper, the first imperial president, and the greatest tyrant in the history of this country. Lincoln locked up an unknown number of civilians in the North for their opposition to the war or to his suspension of the writ of *habeas corpus*. One of those imprisoned was Frank Key Howard, grandson of Francis Scott Key. In a fantastic historical irony, Howard was jailed in Fort McHenry, the same fort over which the majestic flag was flying when his grandfather described it in “The Star-Spangled Banner.” Lincoln also shut down more than 300 newspapers that dared to question his authority. He was even

going to arrest the chief justice of the Supreme Court, who ruled that his suspension of the writ was unconstitutional, but his aides talked him out of it.

While Lincoln forever altered the balance of powers with his overreach, readers should come to understand that his assassination was the result of an “inside job,” orchestrated almost certainly by his mentally unstable secretary of war, Edwin Stanton. William T. Sherman, Philip Sheridan, Ulysses S. Grant, and other northern generals are exposed for what they were—bloodthirsty thugs who trampled upon the time-honored protocols of warfare. Under Lincoln, the “scorched earth” policy of Sherman and his cohorts resulted in the wholesale burning of houses and crops, destruction of land, organized plunder and theft, and unfettered rape of

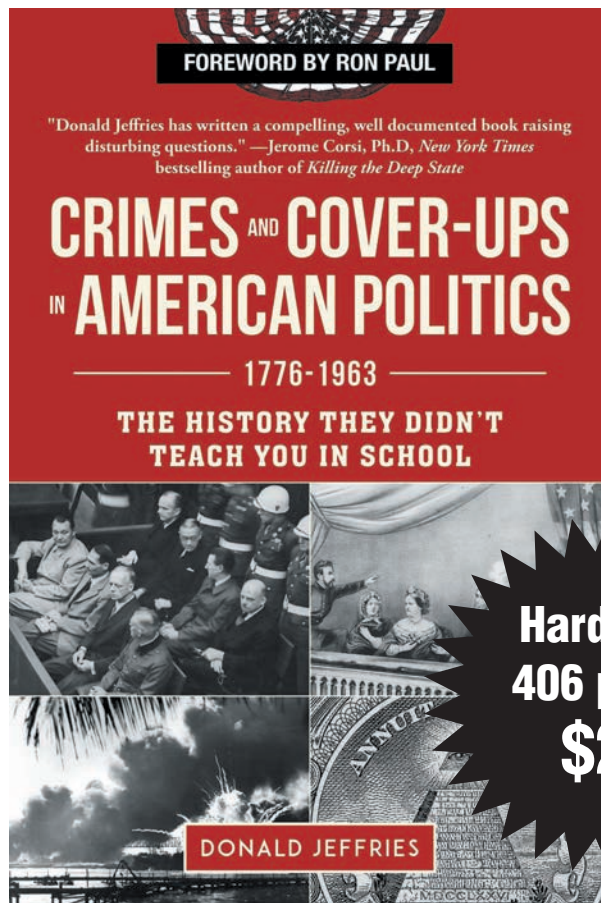

women, especially slave women. Readers will see Reconstruction for what it was—a military occupation of the South, with total subjugation of the remaining populace, which eventually resulted in the birth of the Ku Klux Klan, Jim Crow laws, and a century of “separate but equal” society.

Other topics Jeffries explores include:

- Questions surrounding the assassinations of Presidents Garfield and McKinley;
- The false-flag “Remember the *Maine*” incident, which ushered in America’s first foray into truly international conflict, contradicting the isolationist, common-sense advice in George Washington’s “Farewell Address”;
- World War I and the inexcusable, incomprehensible bloodbath it represented;
- The great Gen. Smedley Butler, whose little book *War is a Racket* still resonates today;
- President Woodrow Wilson’s unconstitutional acts, made possible by the awful precedents set by Lincoln;
- The Treaty of Versailles, which set onerous restrictions on Germany, created payments of reparations to the victors that didn’t stop until 2010, and made World War II inevitable;
- Adolf Hitler’s rise to power, which was not accidental, as was documented in Antony Sutton’s classic book *Wall Street and the Rise of Hitler*;
- The stock market collapse and the Great Depression, which were created by the same bankers who became so empowered by the creation of the Federal Reserve System;
- The Lindbergh baby kidnapping—Bruno Richard Hauptmann, an innocent victim of circumstances and of burgeoning anti-German prejudice, whose execution was state-san-



tioned murder.

• More specifically, when it comes to the era of World War II, readers will learn that President Franklin D. Roosevelt’s reign of terror was second only to Lincoln’s, as he trampled upon the Constitution with impunity, with the lowlight being his largely forgotten Supreme Court “packing” scheme.

Roosevelt, like Wilson, his cousin Teddy, high-profile lawyer Clarence Darrow, and other leading “liberals” of the era had all been passionately in support of World War I (unlike genuine clas-

sical liberals and populists like William Jennings Bryan, Huey Long, and Smedley Butler) and were lusting for World War II. This book presents voluminous evidence that FDR and other high-ranking government officials were desperate to get into the new European war and engineered the “sneak” attack by the Japanese at Pearl Harbor. • The Nuremberg Trials have become accepted as the ultimate “justice” by everyone across the political spectrum. Readers will learn, however, that there was great criticism of the trials at the time, especially from true liberals. Supreme Court Justice William O. Douglas and Sen. Robert Taft were two of the leading voices of opposition.

Then-Senator John F. Kennedy used Taft’s opposition to the Nuremberg Trials as one of the chapters in his best-selling book *Profiles in Courage*. Young Kennedy himself left some choice critical comments on the record about this new brand of “justice.”

• A precedent for this had been set after the Civil War, when a federal government bent on vengeance executed Henry Wirz, the commander of the Andersonville Prison—Camp

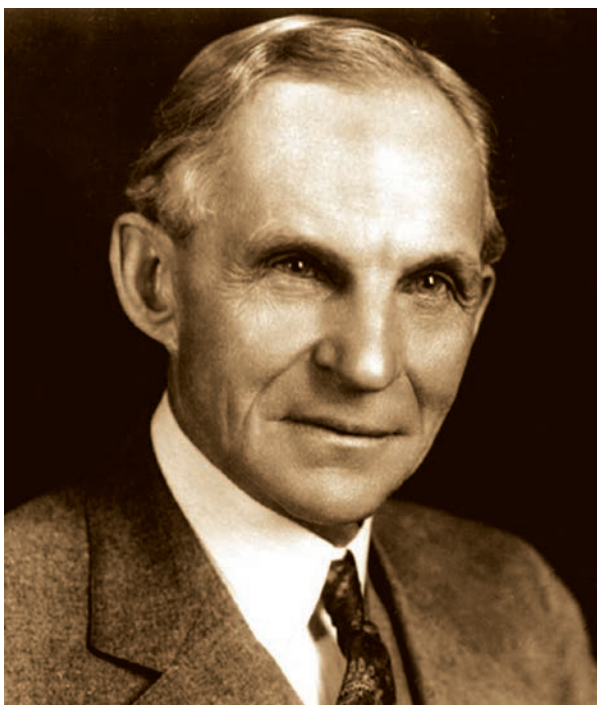

• Trump should send his warmongering national security advisor packing

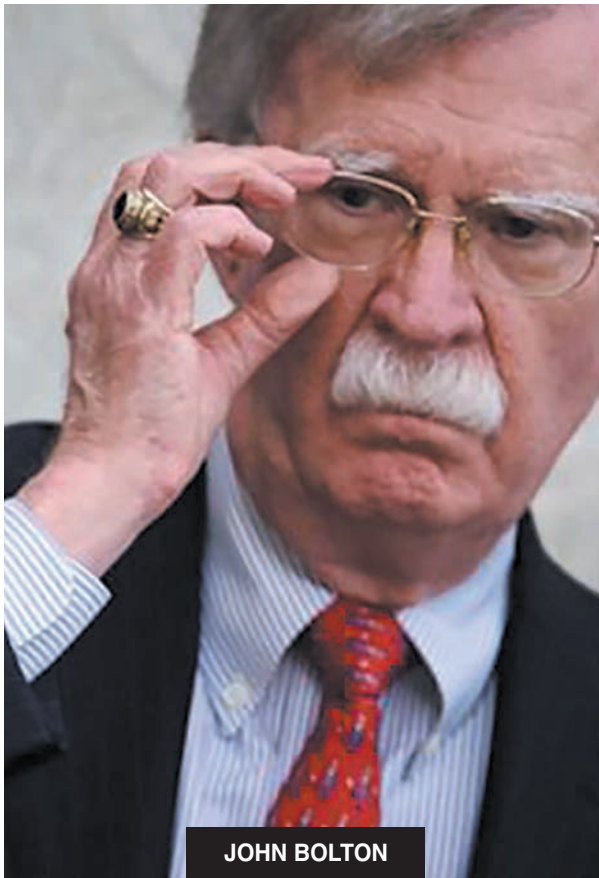

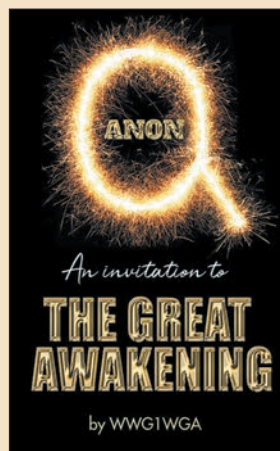

of Iraq, Bolton was sent to The Hague to speak with Bustani, who had been unanimously re-elected to his OPCW post.

“Cheney wants you out,” Bolton told Bustani. “We can’t accept your management style . . . You have 24 hours to leave the organization, and if you don’t comply with this decision by Washington, we have ways to retaliate against you.” Bustani sat dumbfounded as Bolton paused. Bolton looked at Bustani directly once again and finished, “We know where your kids live. You have two sons in New York.” This is the kind of anti-hero tough talk that Trump respects. But does the world? Bolton, alone and as a significant spoke in the Cheney wheel, has spent decades damaging the American reputation abroad. He is the “Ugly American” stereotype so bandied about in foreign literature and film.

5) **The Face of American Hypocrisy.** Bolton is the face of what liberal and libertarian foreign policy analysts see as the hypocritical policies of American foreign policy. While challenging that Americans can be tried in international criminal courts, he favors “unfriendly” African leaders being tried in the same courts. He favors stronger nuclear inspection policies around the globe, but then says that any random international inspections to American nuclear sites would threaten the security of the country. When the Russian hacking story first broke, Bolton called it “an act of war,” again pulling the war card from his pocket quicker than a Vegas whale. When he was chosen for an appointment to the Trump adminis-

tration, it had become a “witch hunt.” He also favors on-site American “monitoring” of foreign elections, which he, of course, does not see as an act of war.

The fact of the matter is that Bolton should have never had a position within Trump’s administration. Trump campaigned against a “deep state” entity that he swore was working against his campaign. Yet, after his election, he began replacing his original nominees with career statisticians bent on expanding America’s military reach.

It may be that Bolton appeals to Trump’s worst personal instincts, the rigid ideologue who talks tough and threatens tougher. Candidate Adopts Anti-War Platform

• Presidential hopeful Tulsi Gabbard rejects interventionism—and the media is killing her for it

Voters looking ahead to 2020 are being bombarded with soundbites from the 20-plus Democratic would-be candidates. That Joe Biden is apparently leading the pack according to opinion polls should come as no surprise, as he stands for nothing, apart from being the establishment favorite who will tirelessly work to support the status quo.

The most interesting candidate is undoubtedly Rep. Tulsi Gabbard (Hawaii), who is a fourth-term congresswoman from Hawaii, where she was born and raised. She is also the real deal on national security, having been there and done it through service as an officer with the Hawaiian National Guard on a combat deployment in Iraq. Though in Congress full time, she still performs her Guard duty.

Gabbard's own military experience notwithstanding, she gives every indication of being honestly anti-war. In the speech announcing her candidacy she pledged to "focus on the issue of war and peace" to "end the regime-change wars that have taken far too many lives and undermined our security by strengthening terrorist groups like al Qaeda." She referred to the danger posed by blundering into a possible nuclear war and indicated her dismay over what appears to be a re-emergence of the Cold War.

In a recent interview with Fox News's Tucker Carlson, Gabbard doubled down on her anti-war credentials, telling the host that war with Iran would be "devastating," adding, "I know where this path leads us, and I'm concerned because the American people don't seem to be prepared for

how devastating and costly such a war would be So, what we are facing is, essentially, a war that has no frontlines, total chaos, engulfs the whole region, is not contained within Iran or Iraq but would extend to Syria and Lebanon and Israel across the region, setting us up in a situation where, in Iraq, we lost over 4,000 of my brothers and sisters in uniform. A war with Iran would take far more American lives, it would cost more civilian lives across the region. . . . Not to speak of the fact that this would cost trillions of taxpayer

dollars coming out of our pockets to go and pay for this endless war that begs the question as a soldier, what are we fighting for? What does victory look like? What is the mission?"

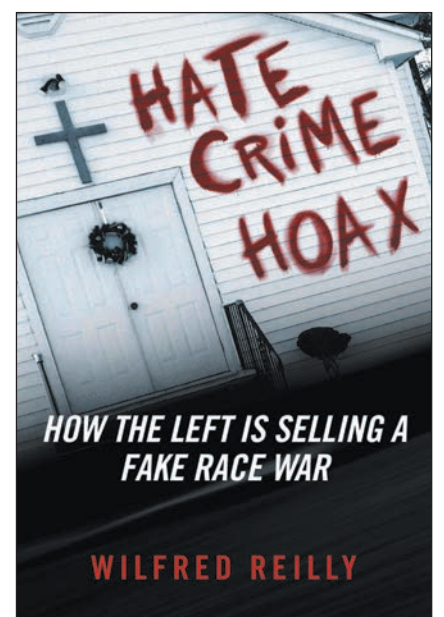
Gabbard, and also Carlson, did not hesitate to name names among those pushing for war, one of which is spelled with B-O-L-T-O-N. She then asked, "How does a war with Iran serve the best interest of the American people of the United States? And the fact is, it does not. It better serves the interest of people like [Israeli Prime Minister Benjamin] Bibi Netanyahu and Saudi Arabia who are trying to push us into this war with Iran."

Clearly not afraid to challenge the full gamut of establishment politics, Gabbard had previously called for an end to the "illegal war to overthrow the Syrian government," also observing that "the war to overthrow Assad is counter-productive because it actually helps ISIS and other Islamic extremists achieve their goal of overthrowing the Syrian government of Assad and taking control of all of Syria—which will simply increase human suffering in the region, exacerbate the refugee crisis, and pose a greater threat to the world." She then backed up her words with action by secretly arranging for a personal trip to Damascus in 2017 to meet with, among others, President Bashar al-Assad, saying it was important to meet adversaries "if you are serious about pursuing peace." She made her own assessment of the situation in Syria and now favors pulling U.S. troops out of the country as well as ending American in-

terventions for “regime change” in the region.

In 2015, Gabbard supported President Barack Obama’s nuclear agreement with Iran, and in 2016 she backed Bernie Sanders’s anti-war candidacy. More recently, she has criticized President Donald Trump’s withdrawal from the Iran nuclear deal. Last May, she criticized Israel for shooting “unarmed protesters” in Gaza, a very bold step indeed given the power of the Israel lobby.

Gabbard could well be the only genuine anti-war candidate that might truly be electable in the past 50 years, and that is why the war party is out to get her. Two weeks ago, the “Daily Beast” displayed a headline: “Tulsi Gabbard’s Campaign Is Being Boosted by Putin Apologists.” The article also had a sub-headline: “The Hawaii congresswoman is quickly becoming the top candidate for Democrats who think the Russian leader is misunderstood.”

The obvious smear job was picked up by ABC’s George Stephanopoulos, television’s best-known Hillary Clinton clone, who brought it up in an interview with Gabbard shortly thereafter. He asked whether Gabbard was “softer” on Putin than were some of the other candidates. Gabbard answered: “It’s unfortunate that you’re citing that article, George, because it’s a whole lot of fake news.” *Politico* then reported the exchange and wrote: “‘Fake news’ is a favorite phrase of President Donald Trump,” putting the ball back in Gabbard’s court rather than criticizing Stephanopoulos’s pointless question. Soon thereafter CNN produced its own version of Tulsi the Russophile, observing that Gabbard was using a Trump expression to “attack the credibility of negative coverage.”

Gabbard responded, “Stephanopoulos shamelessly implied that because I oppose going to war with Russia, I’m not a loyal American, but a Putin puppet. It just shows what absurd lengths warmongers in the media will go, to try to destroy the reputation of anyone who dares oppose their warmongering.”

Gabbard had attracted other enemies prior to the Stephanopoulos attack. Glenn Greenwald at *The Intercept* described how NBC news published a widely distributed story on Feb 1, claiming that “experts who track websites and social media

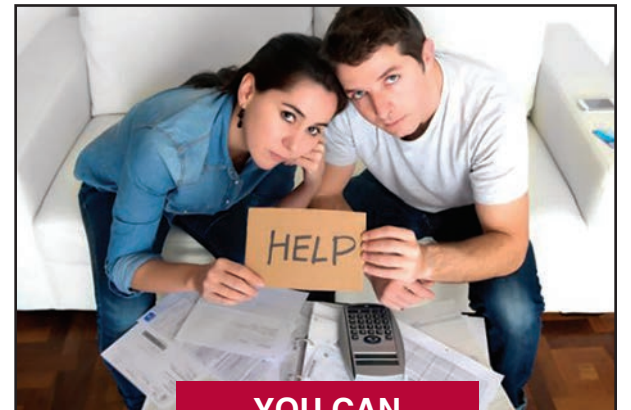
linked to Russia have seen stirrings of a possible campaign of support for Hawaii Democrat Tulsi Gabbard.”

But the expert cited by NBC turned out to be a firm, New Knowledge, which was exposed by no less than *The New York Times* for falsifying Russian troll accounts for the Democratic Party in the Alabama Senate race to suggest that the Kremlin was interfering in that election. According to Greenwald, the group ultimately behind this attack on Gabbard is the Alliance for Securing Democracy (ASD), which sponsors a tool called Hamilton 68, a news “intelligence net checker” that claims to track Russian efforts to disseminate disinformation. The ASD website advises, “Securing Democracy is a Global Necessity.”

ASD was set up in 2017 by the usual neocon crowd with funding from the Atlantic Council and anti-Russian German Marshall Fund. It is loaded with a full complement of Zionists and interventionists/globalists, to include Michael Chertoff, Michael McFaul, Michael Morell, Kori Schake, and Bill Kristol. It claims, innocently, to be a bipartisan transatlantic national security advocacy group that seeks to identify and counter efforts by Russia to undermine democracies in the United States and Europe, but it is actually itself a major source of disinformation.

No doubt stories headlined “Tulsi Gabbard Communist Stooge” are in the works somewhere in the mainstream media. The establishment politicians and their media component have difficulty in understanding just how much they are despised for their mendacity and unwillingness to support policies that would truly benefit the American people, but they are well able to dominate press coverage.

Given the flood of contrived negativity towards her campaign, it is not clear if Gabbard will ever be able to get her message across. But, for the moment, she seems to be the “real thing,” a genuine anti-war candidate who is determined to run on that platform. It might just resonate with the majority of Americans who have grown tired of perpetual warfare to “spread democracy” and other related frauds perpetrated by the band of oligarchs and traitors that run the United States. ★

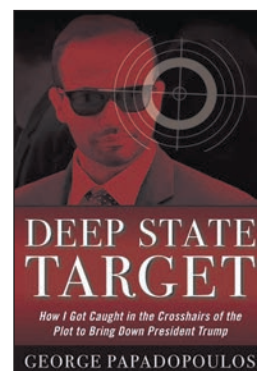

USS *Liberty* Cover-Up Proves the Power of the Israel Lobby

Earlier this month, the U.S. celebrated the 75th anniversary of D-Day with accolades to the armed forces and thanks to surviving veterans. The country stood strongly with the military. But, June 8, two days later, is the 52nd anniversary of a day of shame when Washington turned its back on the U.S. Navy. It was June 8, 1967 when the USS *Liberty*, a surveillance ship stationed off the coast of Egypt was attacked by Israeli fighter aircraft and torpedo boats. The Israelis were unable to sink the *Liberty* but managed to kill 34 American sailors and wound 174. Seventy percent of the crew were casualties of the Israeli attack.

The White House, fearing the Israel Lobby, prevented the U.S. Navy from going to the defense of the *Liberty*, thus sacrificing American lives, and further dishonored the U.S. Navy by ordering Adm. McCain, father of the late Sen. John McCain (R-Ariz.), to orchestrate a cover-up. The surviving crew were threatened with court-martial and imprisonment if they spoke about the event. It was 20 years before one of the surviving officers wrote a book about the greatest act of shame the U.S. government ever inflicted on the U.S. military.

In 2003, 36 years after the Israeli attack on the *Liberty*, Adm. Tom Moorer, former chief of Naval Operations and chairman of the Joint Chiefs of Staff, convened the Independent Commission of Inquiry into the Israeli Attack on the USS *Liberty*, the Recall of Military Rescue Support Aircraft while the *Liberty* was Under Attack, and the Subsequent Cover-up by the United States Government. The commission

consisted of Moorer, Gen. Raymond Davis, former Assistant Commandant of the U.S. Marine Corps, Rear Adm. Merlin Staring, former judge advocate general of the U.S. Navy, and Amb. James Akins, former U.S. ambassador to Saudi Arabia. You can read the report online, at Wikisource, for example, by searching for "The Moorer Report."

The report is devastating. Among the report's conclusions, these stand out:

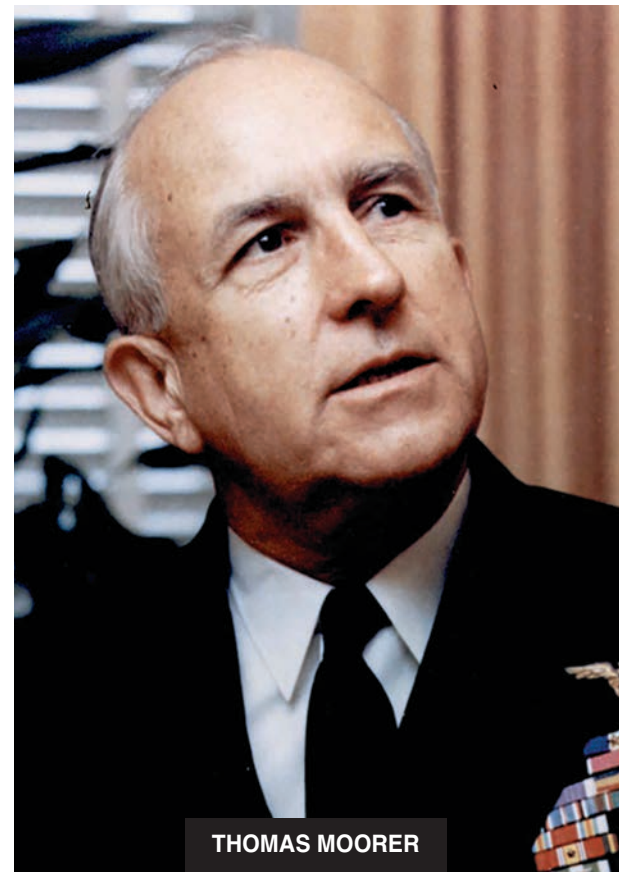
That due to the influence of Israel's powerful supporters in the United States, the White House deliberately covered up the facts of this attack from the American people;

That due to continuing pressure by the pro-Israel lobby in the United States, this attack remains the only serious naval incident that has never been thoroughly investigated by Congress; to this day, no surviving crewmember has been permitted to officially and publicly testify about the attack;

That there has been an official cover-up without precedent in American naval history; the existence of such a cover-up is now supported by statements of Rear Admiral Merlin Staring, USN (Ret.), former Judge Advocate General of the Navy; and Captain Ward Boston, USN, (Ret.), the chief counsel to the Navy's 1967 Court of Inquiry of *Liberty* attack;

That the truth about Israel's attack and subsequent White House cover-up continues to be officially concealed from the American people to the present day and is a national disgrace;

That a danger to our national security exists whenever our elected officials are willing to subordinate American interests to those of any foreign nation, and specifically are unwilling to challenge Israel's interests when they conflict with American interests; this policy, evidenced by the failure to defend USS *Liberty* and the subsequent official cover-up

of the Israeli attack, endangers the safety of Americans and the security of the United States.

After interviewing many of the survivors, Capt. Ward Boston, who was assigned to cover up the attack and afterward repudiated the cover-up, and Bill Knutson, the executive officer of the USS *America* fighter squadron that was called back on orders from the White House, and lengthy discussions with Moorer, my former colleague at the Center for Strategic and International Studies, I have written about the Israeli attack on the *Liberty* a number of times.

My conclusion: All who discount the influence of Israel on the U.S. government are ignorant fools. ★

Trump Fights Back Against Accusers

Those who created and promulgated the absurd Russiagate conspiracy theory may soon find themselves under legal scrutiny. Christopher Steele, the British ex-spy whose name is attached to the infamous dossier that recklessly accused Donald Trump of highly objectionable acts, is one of those worried about the Justice Department's (DOJ) inspector general's Foreign Intelligence Surveillance Act abuse investigation.

Matthew Rosenberg, affiliated with both CNN and *The New York Times*, reported that those close to Steele confirm he is willing to meet with the inspector general's investigators. During a recent appearance on CNN, Rosenberg noted that Steele is also "incredibly concerned and obsessed that this investigation is going to throw him under the bus." Rosenberg explained that Steele's perspective was, "Look, I was working on this dossier other people were paying for—that the Democrats were paying for. I saw things that seemed frightening to me and alarming. And I went to old contacts at the FBI to tell them. I wasn't a paid source in this case.' That's his view of it."

Steele's dossier was not only fodder for celebrities creating toilet humor about the president but was a key rationale for the surveillance warrants against former Trump campaign advisor Carter Page, under the aforementioned Foreign Intelligence Surveillance Act (FISA). Steele, it should be remembered, worked for Fusion GPS, which received funding from the Hillary Clinton presidential campaign and the Democratic National Committee, a crucial fact hidden from the Foreign Intelligence Surveillance court. Anxious not to become a patsy or scapegoat, in Rosenberg's words, Steele "was simply helping them out, and what they did with it, whether they misused it in a FISA or whatever they did, he had nothing to do with that."

Attorney General William Barr earlier this year stated that he expected inspector general Michael Horowitz's investigation to be wrapped up by the end of May or June. Sean Hannity reported this week that sources were telling him Barr may already have a copy of the inspector general's report

on the FISA abuse investigation. If Horowitz speaks with Steele soon it is unclear what that will mean for the inquiry that was thought to be winding down. Barr is also said to be looking into a broader investigation on the origins of the Russian collusion theory, with U.S. Attorney John Durham to head it. Horowitz's internal DOJ report is expected to focus on potential political bias by FBI agents who were at the center of the Russia investigation. This report could not only impede Democratic efforts to impeach Trump but provide him with a powerful weapon in his efforts to portray the Russiagate probe as part of an attempt at a "coup" against him.

Rep. Jamie Raskin (D-Md.) epitomized the attitude of Democrats, saying in an interview, "Their whole point is to go on a wild goose chase and then to create a chain of implausible connections that show that the special counsel report—and what we're doing—is somehow fruit of the poisonous tree. It's absurd."

Democrats are planning to launch an aggressive public relations campaign, revolving around publicizing what they claim is evidence, contained in Mueller's report, that Trump sought to thwart or otherwise shut down his investigation into Russian interference in the 2016 election. This strategy of essentially arguing the case for Trump's impeachment could be significantly impacted by the counter-investigations from the administration. Trump recently gave Barr broad authority to declassify evi-

dence regarding how the Russia probe began.

Democrats reacted predictably to this. "I don't think it will throw us off track, but it will certainly give Republicans ammunition to try to divert attention away from the specifics of the Mueller investigation," said Rep. Hank Johnson (D-Ga.). "It's a profound breach of confidence that the legislative branch has in the executive branch, and a profound disruption in the intelligence apparatus worldwide."

Republicans have long argued that attempts to investigate things like Trump's personal finances are politically motivated and an abuse of congressional authority.

"Because Inspector General Horowitz is known for calling balls and strikes, any validity that he offers in his report that substantiates some of the things that conservative members have been saying for some time . . . will change the narrative overnight," stated Rep. Mark Meadows (R-N.C.), one of Trump's top allies in Congress. "Just like [Democrats] waited for the Mueller report to come out, they should wait for the IG's report to come out. Because the IG's report will actually go at the root of improper motivations on the investigation."

Horowitz is not considered a partisan figure, and last year issued a report that concluded the FBI's handling of a 2016 probe into Hillary Clinton had reflected no political bias. Whether the findings of Horowitz's new probe also please the Deep State remains to be seen. ★

Ghosts of Fallujah Haunting America

• U.S. legislator admits his Marine Corps unit may have killed hundreds of civilians

The admission by Rep. Duncan Hunter (R-Calif.) that his Marine Corps unit may have killed hundreds of civilians, including women and children, in the city of Fallujah in Iraq in April 2004 once again raises the question of whether U.S. forces committed war crimes and used chemical and other unnamed weapons during major battles in Iraq that year.

Hunter was an artillery officer in what became known as the First Battle of Fallujah in April 2004, a city known for its beautiful, ancient mosques 30 miles from Baghdad. It was transformed into a war zone when protesters killed four Blackwater contractors and hung their bodies from a bridge. An operation was launched to find those responsible, but it developed into a full scale engagement. What is remarkable about this First Battle of Fallujah is that it did not last long, so the revelation by Hunter encourages additional scrutiny since it was not the battle that garnered the most controversy. Nevertheless, we have now learned that one artillery unit, by Hunter's reckoning, may have killed hundreds of innocent civilians.

It is worth noting that there is no credible official figure for civilian casualties because the U.S. commanders and the Pentagon played down the

killing of civilians in the Iraq conflict, though some estimates place deaths in the Mideast country at between a half-million and 1 million.

While the first battle was bloody, the Second Battle of Fallujah, in November 2004, was the one that we at AMERICAN FREE PRESS focused on most, believing correctly that the mainstream media was relying too much on official accounts of what transpired and was being denied the truth. AFP followed the story conscientiously, and we continued to do so in succeeding years. We were confident our reporting would be proved accurate and that new facts would emerge to confirm the claims we made that Marines used chemical weapons and depleted uranium munitions.

The U.S. military suffered 71 dead and over 250 injured in the Fallujah battles, leading to comparisons being made with some of the major exchanges of the Vietnam War.

In November 2004, Fallujah was sealed off from the outside world and quickly became a free-fire zone. This would be the Second Battle of Fallujah. There were many Iraqi fighters in the city, but there were civilians, too, who did not want to leave or had been unable to escape.

The battle was akin to what one might associate with the Second World War battle for Leningrad, with many snipers on both sides. In Fallujah, however, Marine Corp commanders had more firepower than the Iraqi fighters and used it

to devastating effect. Some might argue that they used it with abandon.

Within a month, in what was dubbed Operation Phantom Fury, 36,000 homes were leveled, as well as 60 schools and 65 mosques. The city resembled a wasteland. At the time, and later, AFP reported that the Marines used white phosphorus bombs similar to ones the Israelis used later in Gaza, but it was the widespread deployment of depleted uranium (DU) munitions that was to have lasting human damage.

In 2004, and for several years afterwards, the Pentagon admitted having used white phosphorus, a chemical weapon that should not be used against civilians but denied that DU munitions were on the battlefield.

The truth emerged in 2010, however, when a British scientist and his team revealed that levels of radiation illnesses in Fallujah were comparable to, if not higher, than those found in Hiroshima and Nagasaki after the atoms bombs were detonated there in 1945.

It is still believed that other chemical weapons were used in Fallujah by the Marine Corps, but never identified. For example, aside from evidence of radiation, traces of mercury and other poisonous substances were found that could not be linked to known weapons.

The British scientific report entitled “Cancer, Infant Mortality, and Birth-Sex Ratio in Fallujah, Iraq 2005-2009” confirmed that DU was in shells and also in bullets that were fired in large, unreported quantities, causing radiation contamination. DU’s effects can last for a long period and resulted over time in physical deformities among children. The DU bullets were reported to have cut through walls like a hot knife through butter. The Pentagon has been reluctant to confirm whether experimental weapons were used on that battlefield.

Daniel DePetris, a conservative columnist, believes America has learned little from the Iraq War even though most Americans believe it was a disaster that caused thousands of American lives and tens of thousands of casualties.

He offers opinions on what our leaders should do before going to war, but perhaps his best piece of advice to them is “. . . deliver a case to the American people about why military action is appropriate and make them fully aware of what can go wrong.”

He knows, like the rest of us, that in Iraq everything that could go wrong did go wrong, especially in Fallujah. ★

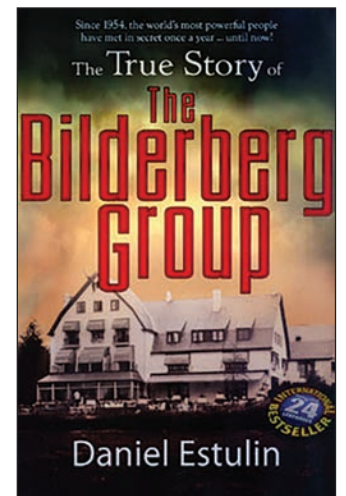

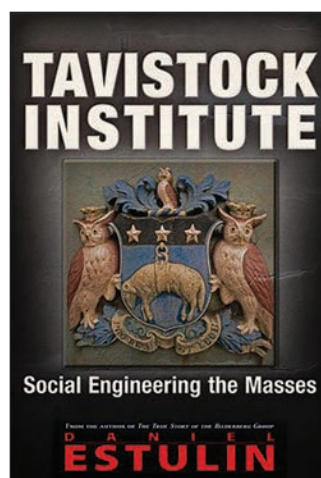
Two New Books on the Global Elite Expose Bilderberg and the Tavistock Institute

Unpunished War Crimes

• Suicidal neocon foreign policy is the real war crime

Rep. Duncan Hunter (R-Calif.) found himself in hot water recently over comments he made in defense of Navy SEAL Edward Gallagher, who faces war crimes charges over his alleged conduct while serving in combat overseas. Gallagher is charged with stabbing a 15-year-old ISIS member while in custody, of taking photos posing with the corpse of the teen, and with killing several civilians.

Defending Gallagher recently, Hunter put his own record up next to the SEAL to suggest that he's an elected congressman who has done worse things in battle than Gallagher.

That's where Hunter's defense earned him some perhaps unwanted attention. While participating in the first "Battle of Fallujah" in early 2004, by Hunter's own account he and his fellow soldiers killed hundreds of innocent civilians, including women and children. They fired mortars into the city and killed at random.

In the sanitized world of U.S. mainstream media reporting on U.S. wars overseas, we do not hear about non-combatants being killed by Americans. How many times has there been any reporting on the birth defects that Iraqis continue to suffer in the aftermath of U.S. attacks with horrific weapons like depleted uranium and white phosphorus?

Hunter described his philosophy when fighting

in Iraq: "You go in fast and hard, you kill people, you hit them in the face, and then you get out. We're going to hurt you and then we're going to leave. And if you want to be nice to America, we'll be nice to you. If you don't want to be nice to us, we're going to slap you again."

This shows how much Hunter does not understand about war. When he speaks of hitting people in the face until they are nice to America, he doesn't seem to realize that the people of Fallujah—and all of Iraq—never did a thing to the United States to deserve that hit in the face. The war was launched on the basis of lies and cooked-up intelligence by many of the people who are serving in the current administration.

And that brings us to the real war criminals. Hunter and his fellow soldiers may have killed hundreds of innocent civilians and even felt justified. Their superior officers, after all, established the rules of engagement. Above those superior officers, going up and beyond to the policymakers, the lie was sold to the American people to justify a war of choice against a country that could not have threatened us if it wanted to.

Vice President Dick Cheney knew what he was doing when he kept returning to the CIA headquarters, strong-arming analysts to make the intelligence fit the chosen policy. John Bolton and the other neocons knew what they were doing when they made claims about Iraq's weapons of mass destruction they knew were false. The Pentagon's Office of Special Plans played its role in selling the lie. So did the media.

Gallagher will face trial and possibly jail for his

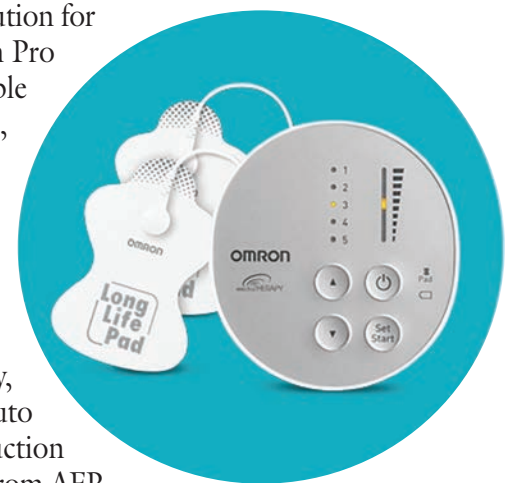
actions. Hunter may even face punishment—though perhaps only at the ballot box—for his admitted crimes. U.S. Citizens Band Together; Privately Fund Border Wall

As President Donald Trump continues to fail to fulfill one of his key campaign promises to build a wall along the southern U.S. border to protect America against the ongoing invasion of Third World migrants, private U.S. citizens are taking the initiative themselves.

Brian Kolfage, a combat veteran who served two tours in Iraq with the Air Force, helped establish We Build the Wall, Inc. along with former Trump adviser Steve Bannon. The non-profit organization set up a GoFundMe page late last year in an effort to raise funds from private U.S. citizens to help finance construction of a border wall along key sectors of the porous U.S.-Mexico border, where illegal immigrants from a variety of countries continue to pour through.

Kolfage is a triple-amputee veteran who received the Purple Heart award for his service in Iraq. He, like many Americans who voted for Trump, is determined to see a border wall built to help protect the U.S. border and hinder illegal immigration.

“As a veteran who has given so much, three limbs, I feel deeply invested to this nation to ensure future generations have everything we have today,” Kolfage stated on the GoFundMe page for We Build the Wall, Inc., which as AFP goes to press has generated over \$23.8 million in donations since it was established. “Too many Americans have been murdered by illegal aliens and too many illegals are taking advantage of the United States taxpayers with no means of ever contributing to our society. I have grandparents who immigrated to America legally; they did it the correct way, and it’s time we uphold our laws, and get this wall built.”

Donations large and small began rolling in almost immediately, and picked up big-time over Memorial Day weekend, when construction of the privately funded wall began. According to *The Epoch Times*, the average donation received by We Build the Wall, Inc. was \$67, and roughly \$2 million was raised by \$5 donations, demonstrating that many Americans want to see a wall built—even if they have to pay for it with private funds.

“I realized that everyone can have an impact, and if you think you can’t have an impact then you’re wrong, because everyone who donated had a big impact,” Kolfage explained to *The Epoch Times*.

The recently completed half-mile section of the border wall was constructed near Sunland Park, N.M. in an area known to have long been exploited by illegal aliens, human and drug traffickers, and others attempting to illegally enter the United States.

According to Mike Furey, the director of con-

struction operations for We Build the Wall, Inc. who has overseen the project, the barrier will be a tremendous asset to U.S. Border Patrol agents.

“We actually, literally, in this first half-mile, going up a 31% grade, have cut off 19 drug trails, walking trails, and trafficking trails,” Furey noted.

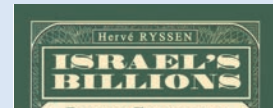
Kolfage and his organization have big plans for the future and hope to continue to generate donation revenue to fund their other planned projects.

“We have made a list of every single landowner on the U.S. border, and we have constantly been going down the list and making contact with each one, networking and figuring out who fits the mold for what we want to do,” Kolfage stated. “Currently, we have about 10 properties in the pipeline after this.”

News broke earlier in June that the International Boundary and Water Commission (IBWC), an agency that regulates waterway issues between the United States and Mexico, ordered that a gate built into the recently completed wall be left open for officials to access certain watersheds. Kolfage and his group protested this decision, and recently announced on Twitter that the “border wall and gate are secure again” after consulting with IBWC officials.

The efforts of Kolfage and thousands of Americans who have supported his project are a testament to the seriousness of the border crisis. Millions of illegal aliens, including countless minors, have flooded the U.S. in recent years, often with fraudulent asylum claims, fake paperwork, and little to no money or skills necessary to compete in an advanced economy. The vast majority are not appearing for their court hearing to adjudicate their asylum claims, and customs and immigration agencies are overwhelmed by the sheer number of individuals seeking to enter the United States.

If the Trump administration and congressional representatives continue to fail to secure the U.S. border and address the border crisis, hard-working and dedicated American patriots will step in and get the job done. ★

Drone Wars

[In regard to AFP's report on drone warfare in the June 3 & 10 issue] what do you want? More rules and laws for the bad guys to obey? There has never been a documented case of a drone striking a passenger aircraft.

In the case of Gatwick Airport in England, the scare started when someone thought they saw a drone. There was no confirmation or second witness. In fact, there was a drone, but it belonged to the airport police who were using their drone to look for the originally reported drone. When reporters and others saw the airport police drone, their irrational fears were confirmed.

First, all small drones are severely limited in range and payload. Second, hitting a moving target, like an airline aircraft, would be exceedingly difficult. If a drone were to meet an airliner, it would most likely be no worse than a bird strike, and there are about 40 bird strike incidents a day, according to federal regulators. If you were able to reach an engine, then, sure, there would be engine damage and the airplane would simply land when able, flying normally on the remaining engine.

Could the drone carry explosives? Maybe a pound or two, but how would you detonate it? The most likely explosive would be a plastic explosive or a



grenade. Maybe not a grenade because it would add so much weight to the drone that it would not have more than a minute or two of flight time, and neither explodes on impact, so your imagined terrorist plot is technically implausible.

Terrorists want the biggest bang for the buck, and small off-the-shelf drones just won't deliver that.

Comparing what mayhem a drone can deliver to the 9/11 attack is simply ridiculous on its face. The A380 fully loaded is 1.2 million pounds, and an off-the-shelf drone might tip the scales at 10 pounds, a mere mosquito on the wind-screen by comparison.
