## TRUMP'S VICTORIES CANNOT BE DENIED

### EDITORIAL

**W**ith the July 27 announcement that the U.S. economy had grown by over 4%, the mainstream media has been forced to concede that President Donald Trump has had a banner first term pushing through his America-first agenda. Even CNN, often called the “Clinton News Network” for its non-stop sycophantic coverage of the Clintons, this month had to admit that it’s a “golden age” for Trump. So let’s take a moment to acknowledge what Trump has accomplished in the year-and-a-half he has been in office.

With the U.S. economy booming along at 4.1% growth, cable business network CNBC reports this is the fastest rate of growth in four years and the third best growth rate in the last decade. Following the economic indicators announcement, Trump told reporters, “We’re on track to hit the highest annual growth rate in over 13 years.”

The U.S. unemployment rate—tracking only Americans actively involved in the workforce, not those who have given up or are under-employed—has dropped to 3.8%. Even the broadest category of unemployment—U-6, which the Bureau of Labor Statistics explains tracks “all persons marginally attached to the labor force”—is at 7.8%, a good indicator of how many Americans are actually working today. Those numbers are especially

strong for minorities. For example, less than 8% of black Americans are jobless today, the lowest reported rate since the early 1970s.

Trump’s administration has been quietly packing the courts with conservative judges, including two new Supreme Court justices—Neil Gorsuch and Brett Kavanaugh. Even the mainstream media has been forced to concede that Trump is winning when it comes to revamping the judicial system. *Fortune* magazine reports that in the next two years, if Trump stays on pace, he will likely be able to fill over 200 of the nearly 900 seats in the judiciary. “And since 39% of his nominees will replace judges appointed by Democratic presidents, his picks will undoubtedly move the judiciary to the right in ideological terms,” reported *Fortune*.

When it comes to world affairs, Trump is moving ahead with his America-first agenda. Last month, Trump visited Europe where, for all of the world to see, he tore into the European Union leaders, ar-



guing that they unfairly protect their economies while stacking the deck against the U.S. Outwardly, Europe’s elected and unelected leaders bristled at Trump’s remarks, but quietly they all sat down at the table to discuss ways to erect a fairer system of trading for everyone involved.

Trump also lambasted wealthy Europeans for fleecing Americans to pay for their defense via NATO, according to which the U.S. is required to pay a ridiculous 4% of U.S. gross domestic product defending Europe from a non-threat while those same countries pay a pittance. While the big media—funded by globalists who make billions off U.S. military overspending—raged at Trump for threatening to quit NATO, there was no doubt that the president’s tough talk resonated at home among working-class Americans.

These are but a few of the victories that the current occupant of the White House is securing for the United States. The next time the far left goes off on Trump, let them know that Americans are moving ahead with or without them, as the current administration finally takes steps to put America first. ★

## Health Calamity Prompts First-Ever Delay Going to Press

In almost two decades of putting out AMERICAN FREE PRESS, we have never once had to delay going to press, but this week, for the first time ever, we had good cause for sending out an issue a few days late.

You may have noticed that this issue of AFP was mailed several days later than normal. That's because we had to wait for our production specialist, Paul Angel, who has prepared every issue of AMERICAN FREE PRESS for printing since our first issue way back in August 2001, to get out of the hospital after some pretty serious emergency heart surgery.

Paul is home now, but the scare threw us all for a loop. The reporters had all checked in, and we had all of the articles, the letters, the advertisements, and other copy ready to go. Without Paul's expertise, though, we were at a bit of a loss as to how we could put it all together so our printer could print it.

Regular readers know we run a tight ship here at AMERICAN FREE PRESS. With all of the censorship, the crackdowns, the virtual book burnings, and the blacklists going around in the past couple of years, we have been forced to seriously cut back on expenses. On a normal day, it's not a bad thing to run a tight ship. Unlike so many other media companies out there, we have never had to take on any debt to finance ourselves, and, as a result, we are not beholden to anyone except for our loyal readers, who demand only one thing from us: the truth. When a critical person, like Paul, ends up in the hospital in an emergency situation, however, it can really throw a wrench in the works. And that is exactly what happened last week right in the middle of our production process.

In all truth, delaying the printing and mailing

even get a much-deserved break, we have a backup waiting right in the wings to step in for him. The problem is, we just don't have the money to commit to hiring new staff.

In 2018, pretty much anyone able to turn on a computer can write a commentary and get it printed or post it to the Internet, but the question is, should they really do it? With so much fake news out there today, we are seeing even seasoned commentators fall for hokum. Having learned from some of the best in the business, such as Bilderberg hound Jim Tucker and renowned reporter and photographer Andrew St. George, however, we at AMERICAN FREE PRESS push our contributors hard to ensure that what we are publishing is as honest and unfiltered as anyone in the business can get, and then we rely on seasoned pro Paul to turn it into a polished, professional product we can all be proud of. That's no small feat, considering what passes for "news" these days.

We need more Pauls in this business, and that is where you come in.

# News You May Have Missed

## Trillions in Wasted Money

With all the media hype over President Donald Trump's recent visit to Europe, it's worth laying out just how much the U.S. has paid to defend Europe in the past few years. The amount of money the U.S. has contributed to NATO over seven years tops \$5.5 trillion. In terms of the total percentage of NATO's budget, the U.S. has consistently paid twice what it is obligated to pay. If the U.S. had paid the agreed upon GDP percentage of 2%, then U.S. taxpayers would have saved \$2.8 trillion.

## Unprecedented Debt

The new federal budget being deliberated by Congress now includes a projected 2019 deficit of \$1.085 trillion. That is up from \$984 billion in February—and more than double the \$526 billion the White House called for in its 2018 budget.

## Hungarians Stand Up to Soros

On June 20, Hungary's parliament thumbed its nose at the European Union and approved a series of bills that makes it a crime to help illegal immigrants. Called the "Stop Soros" package of legislation, individuals or groups that help illegal immigrants not entitled to asylum or that help illegal migrants gain



status to stay in Hungary will be prosecuted and could even face prison-time. "We want to use the bills to stop Hungary from becoming a country of immigrants," said Hungary's prime minister. Also part of the legislative package was a constitutional amendment stating that an "alien population" cannot be settled in Hungary.

## Trump Off on Embassy Estimate

The new U.S. embassy in Jerusalem is expected to cost more than \$21 million, or nearly 100 times President Donald Trump's initial estimate. Documents filed by the federal government show the State Department awarded Maryland-based Desbuild Limak D&K a \$21.2 million contract to design and build an "addition and compound security upgrades" at the embassy, to update the former consular building in Jerusalem. Last March, Trump said, "We're going to have it built very quickly and very inexpensively.

They put an order in front of my desk . . . for a billion dollars. I said, 'A billion? What's that for?' We're actually doing it for about \$250,000." He raised his estimate to between \$300-400,000 during an April press conference with German Chancellor Angela Merkel.

## Two Corrupt Peas in a Pod

Israeli Prime Minister Benjamin Netanyahu's wife, Sara Netanyahu, has been indicted for "fraud with aggravated circumstances and breach of public trust." Israeli prosecutors contend that Mrs. Netanyahu ripped off the Israeli government to the tune of hundreds of thousands of dollars by padding food costs for the prime minister's residence and claiming a cook was working when he was not. In 1977, when Leah Rabin, the wife of then-Israeli Prime Min-



ister Yitzhak Rabin, was about to be indicted, Rabin resigned from office due to his wife's scandal. No one really expects Netanyahu, who is facing corruption charges himself, to be honorable and do the same, however.

## Just Broke

Chicago Alderman Ameya Pawar says he is worried about the coming wave of automation that will likely put millions of people out of work, especially among the poor and working class since most of the robotics are for menial jobs. What's his solution? According to news and commentary website "The Intercept," "Pawar . . . has decided to endorse the universal basic income—an idea that has been picking up steam across the world." Pawar has not detailed what this will entail for Chicago, but the city is already broke, owing some \$20 billion to banks and investors, which amounts to about \$7,500 per resident there.

## Bigger Brother

News and commentary website "The Intercept" recently broke the story about the National Security Agency's (NSA) top-secret spying infrastructure that has been popping up across the country. "The secrets are hidden behind fortified walls in cities across the United States, inside towering, windowless skyscrapers and fortress-like concrete structures that were built to withstand earthquakes and even nuclear attack," reported "The Intercept" recently. "At-

lanta, Chicago, Dallas, Los Angeles, New York City, San Francisco, Seattle, and Washington, D.C. In each of these cities, The Intercept has identified an AT&T facility containing networking equipment that transports large quantities of Internet traffic across the United States and the world. A body of evidence—including classified NSA documents, public records, and interviews with several former AT&T employees—indicates that the buildings are central to an NSA spying initiative that has for years monitored billions of emails, phone calls, and online chats passing across U.S. territory."

## Real Mind Control

The Pentagon's Defense Advanced Research Projects Agency (DARPA) is developing a "neural interface" that would allow troops to connect to military systems by just using their brains and let those systems transmit back information directly to their brains. The so-called "Next-Generation Non-Surgical Neurotechnology," or N3, program will "combine the speed and processing power of computers with humans' ability to adapt to complex situations," DARPA said. The technology would let people control, feel, and interact with a remote machine as though it were a part of their own body.

## Upending Diamond Industry

Scientists recently unearthed the largest hoard of diamonds, estimated to be so valuable it would completely destroy the market for the precious gems. There's only one catch. The scientists believe there are a "quadrillion tons" of diamonds buried 100 miles down, deeper than any drill has ever penetrated. "This shows that a diamond is not perhaps this exotic mineral, but on the [geological] scale of things, it's relatively common," Ulrich Faul, a research scientist in MIT's Department of Earth, Atmospheric,



and Planetary Sciences, told reporters. In truth, for most of human history, diamonds were not that valuable. It wasn't until 1938, amid the ravages of the Depression and talk of another world war, that Harry Oppenheimer, the son of the founder of De Beers diamond company, paid New York-based ad agency N.W. Ayer to convince young American men that diamonds and only diamonds were synonymous with romance, and that the measure of a man's love was proportional to the size and quality of the diamond he purchased his fiancé.

# LA Attack Shows Idiocy, Danger of Left

• Intolerant, violent, anti-American, racist cells terrorize patriotic men's group

Members of a self-proclaimed Western men's organization were physically confronted and attacked by radical leftists after being identified at a popular bar called The Griffin in Atwater Village, a community just north of downtown Los Angeles near the iconic Griffith Park, demonstrating once again the violent nature of the radical left and its activists' total disregard for the Constitution, freedom of speech, and other political traditions.

The incident, which drew national headlines, occurred on the evening of July 14, when members of the Los Angeles chapter of the Proud Boys, a much-maligned activist group that celebrates Western civilization and engages in public activism and protests, met at the local bar for conversation and drinks. When members of the Los Angeles chapter of the Democratic Socialists of America (DSA) and other activist organizations discovered that members of the Proud Boys were meeting at the bar, they made their way to the watering hole to confront the peaceful assembly.

Josh Androsky, a 31-year-old activist and aspiring comedian, was a lead organizer of the group that went to the bar to confront the Proud Boys members. After receiving a text message that the Proud Boys were at The Griffin, he quickly went to work rallying his fellow left-wing activists, including his girlfriend, Madison McCabe, a member of the local chapter of the DSA. Upon arriving at the bar, Androsky, McCabe, and their fellow activists immediately approached employees, insisting that they expel the Proud Boys members, who were easy to identify by their matching polo shirts and red "Make America Great Again" hats.

When the staff refused, the radical leftists quickly confronted the Proud Boys, screaming "No Proud Boys, no KKK, no fascist USA!" and denouncing them as fascists and Nazis, causing chaos in the bar and disrupting other patrons. At one point, McCabe shoved a member of the Proud Boys, who responded in kind by shoving her back, causing her to fall to the floor. Androsky later admitted to stealing one of the member's "Make America Great Again" hats in response to McCabe being shoved, which further escalated the already tense situation. A violent scuffle then ensued, prompting a call to the local police.

At around 10:30 that evening, police arrived and expelled both parties from the bar, which ended up closing early due to the melee. Following the fight and the controversy it generated, owners of The Griffin organized a charity event dedicated toward raising money for local Los Angeles charities and the Southern Poverty Law Cen-

ter, a subversive organization that has hysterically demonized the Proud Boys and other right-leaning groups and organizations. To bolster the establishment's credentials in left-wing circles, the bar's owners have also pledged to post a sign at the entrance of the establishment that reads: "No sexism, no racism, no ableism, no ageism, no homophobia, no fatphobia, no transphobia, no hatefulness."

In an interview with *The Los Angeles Times*, Androsky attempted to justify his group's violent confrontation with the Proud Boys members' who had peacefully assembled, essentially arguing that "racists" and "fascists" have no First Amendment rights in America by implying their ideology is inherently violent.

"The First Amendment protects the right to peaceably assemble," Androsky explained. "There is no such thing as a peaceable assembly of Nazis. Just by virtue of their ideology, they are causing harm."

Androsky's delusional justification is proof positive that the radical left is entirely disconnected from reality in modern America. Their twisted ideology, which justifies preemptive violence against their political opponents—anyone they deem to be a "racist" or a "Nazi"—represents one of the greatest threats to America's democratic traditions.

Expect the radical left to engage in more violence, censorship, political terrorism.

Ironically, despite being derided and slandered as "Nazis," the Proud Boys openly denounce racism and white supremacy. The group, founded by popular alternative media personality Gavin McInnes, describes itself as a "pro-Western fraternal organization for men who refuse to apologize for creating the modern world." They denounce both racism and anti-racism, are opposed to racial guilt, and vehemently support both the First and Second amendments. They are opponents of political correctness and the violent, radical left that has run amok in America, particularly since the heated 2016 presidential election.

A recent tweet by the official Proud Boys Twitter profile captures the overall philosophy of the group quite well.

"We don't care about your race. Be proud of who you are," the Tweet reads. "We don't care about your religion. Pray however you want. We don't care about your sexual preferences. Love whoever you want. We're a diverse group. But we do all have one thing in common. God Bless the West!"

In a related incident, a young man who was alleged to have been a Proud Boy member was brutally assaulted by multiple black men participating in a rally for Nia Wilson, a young black woman recently murdered in Oakland, Calif. by a deranged, homeless white man who was quickly apprehended by local police.

False claims by Shaun King, a notoriously dishonest leader of the Black Lives Matter movement, likely played a key role in the young man being attacked, as King falsely accused him of not only being a Proud Boy member but also interrupting and disrupting the rally for Wilson. Leaders of the Proud Boys have denied that any of their members attended the rally in Oakland, let alone disrupted it.

With the Proud Boys and other right-leaning groups continuing to organize and gain traction in American society and politics, expect the radical left to continue to engage in preemptive violence, censorship, harassment, and other forms of political terrorism. ★

# Jewish Man Guilty of Bomb Threats

• Israeli court says Kadar carried out thousands of bomb threats against U.S. targets

An Israeli court found a dual Israeli-American teenager guilty late last month of making roughly 2,000 bomb threats, most of which targeted Jewish institutions, including Jewish Community Centers across the country, as well as the Israeli embassy and the Anti-Defamation League. He also targeted a number of airports and airliners, malls, police stations, and other institutions in the United States, Canada, the UK, New Zealand, Denmark, Norway, and Australia with fake bomb and public shooting threats between 2016 and 2017.

Michael Ron David Kadar, the 19-year-old Israeli-American man, who has been previously identified as the suspect in the hoax bomb and shooting threats, was found guilty of a slew of crimes including extortion, sending fraudulent messages, money laundering, and computer hacking. Additionally, he was found guilty of assault for attempting to grab the gun of a policewoman who was searching his home.

The bizarre case drew international headlines shortly after President Donald Trump's election, causing alarm in the Jewish community about rising levels of purported and threatened anti-Semitic violence. At the time, the mainstream media and other leftists blamed Trump for encouraging and mainstreaming racism, anti-Semitism, and bigotry more generally, citing the anti-Semitic bomb threats phoned into Jewish Community Centers and other Jewish institutions around the United States.

According to authorities, Kadar made thou-



sands of threatening phone calls between January and March 2017 using an online calling service that allowed him to mask his identity and disguise his voice. In addition to targeting Jewish institutions, airports, malls, and police stations around the world, he also attempted to extort Ernesto Lopez, a Republican state senator from Delaware.

Kadar offered his extortion services through a shady online black-market place called AlphaBay, where he advertised a "School Email Bomb Threat Service," offering clients a custom-designed threat that he would send to schools for a fee of \$30. Kadar's hoax bomb and public shooting threats caused hysteria not only in the organized Jewish community, but at countless institutions he tar-

Turns out one man's threats against Jewish targets in the U.S. had their desired effect: The news media and Zionist spokesmen claimed anti-Semitism was spiking upward due to the election of Donald Trump. Immediately thereafter, a purge of allegedly anti-Semitic material in print and on the Internet was begun.

geted, causing evacuations, panic, and fear.

Psychiatrists said after analyzing Kadar that he suffers from autism and paranoid delusions, but that he is fit to stand trial. His family and defense attorney maintain he suffers from a brain tumor and doesn't understand the severity of his actions. That claim was soundly rejected by Israeli Judge Zvi Gurfinkel, who oversaw his recent trial.

"The defendant has changed his version of events multiple times according to what suits him the most," Gurfinkel stated during the trial. "He very much understands the significance of his actions."

Gurfinkel maintained that the record demonstrated that Kadar was fully aware of the significance of his actions, that he took steps to conceal his identity and actions, and that he advertised his services online. Furthermore, he noted that Kadar stated previously that he actually enjoyed seeing the chaos and panic that resulted after the hoax threats were called in.

"The defendant sowed terror and panic in a systematic and sophisticated way, all while concealing his identity, and disrupted the lives of many people whom he has threatened," Gurfinkel stated.

Kadar potentially faces several years behind bars for the convictions in Israeli court. As AFP goes to press, a sentencing hearing has yet to be set following Gurfinkel's guilty verdict.

In March, several U.S. states and jurisdictions charged Kadar with a range of crimes as well, including the states of Florida and Georgia and Washington, D.C. It is uncertain if Kadar will be extradited to the U.S. to face trial.

Kadar's bomb threats targeting Jewish centers prompted a number of multinational tech companies to kick nationalists off the Internet and resulted in the banning of several book publishers from retail platforms like Amazon.

Since it is now known that a young Israeli-American was responsible for the mayhem, one would expect an apology was due by tech giants and the mainstream media to all of the groups that were falsely blamed for the calls. As AFP goes to press, however, all of those innocent groups and individuals targeted by the hysteria are still waiting for CNN, Google, Amazon, and Paypal to reach out to them.

# Trump Criticizes Bankers' Policies

• President breaks unwritten rule, questions decisions of parasites at Federal Reserve

By Mark Anderson

President Trump had already said and done enough to unnerve the powers-that-be on various fronts—from hedging on free-trade deals to making bold foreign-policy strides with North Korea and Russia—when he upped the ante even further July 19, speaking out against the Federal Reserve central bank that's seen by worshipful monopoly capitalists and their media cohorts as being too kingly for presidential criticism.

Most interestingly, in the wake of the president's nomination of conservative Brett Kavanaugh to the Supreme Court—which the dominant political-media establishment fears will pack the court to Trump's liking for decades to come—there also are grave concerns among those in the same crowd that the president will soon reconstitute the Federal Reserve Board in his image to prevent further interest-rate hikes. Trump sees rate hikes as highly detrimental to his ambitious economic-growth plans, concerning jobs, infrastructure renewal, and U.S. manufacturing.

On July 20, right after Trump complained that the Fed's interest-rate increases are hurting the economy, Richard Bove of CNBC—one of many Fed apologists in the “mediasphere” who quickly leapt to the Fed's defense—noted, “Trump will have the opportunity to fashion the central bank in the image he would like, as he has four vacancies to fill on the board of governors. The result could be a more politicized Fed.”

Bove, looking at this matter from Trump's perspective, added, “President Donald Trump has multiple reasons as to why he should take control of the Federal Reserve. He will do so both because



he can and because his broader policies argue that he should do so. The president is anti-over-regulating American industry. The Fed is a leader in pushing stringent regulation on the nation. By raising interest rates and stopping the growth in the money supply, [the Fed] stands in the way of further growth in the American economy.”

Bove also acknowledged: “The Board of Governors of the Federal Reserve is required to have seven members. It has three. Two of the current governors were put into their position by Presi-

The Federal Reserve is one of the biggest money-making scams in history. It is neither federal nor a reserve and has been picking the pockets of the American people for more than 100 years. It should be abolished.

dent Trump. Two more have been nominated by the president and are awaiting confirmation by the Senate. After these two are put on the Fed's board, the president will then nominate two more to follow them. . . . [I]t is possible that six of the seven board members will be put in place by Trump.”

The Dodd-Frank Act's 2010 passage increased the Fed's power by giving it sweeping authority to regulate the banking industry. The Fed began to penalize banks that disobeyed its new rules, including determining which loans were desirable to approve and which weren't, along with dictating how much banks could pay out for investors' dividends. The Fed also crippled lending in the housing market. Trump, as an opponent of over-regulation, wants to rectify this situation.

The CNBC host conceded what many in the alternative media, including this AFP writer, have been saying all along: It's a myth that the Fed overloads the mainstream money supply to cause price inflation, when, in fact, raising interest rates increases the cost of borrowing and burdens small businesses and consumers with higher debt-servicing costs for lines of credit, credit cards, car loans, some mortgages, consumer loans etc. Higher borrowing costs for businesses translate into higher prices or layoffs, as is also the case with higher energy costs, for instance. Meanwhile, higher consumer rates reduce demand for goods and services, especially when the money supply is already too low in relation to productive output.

“In the second quarter of 2018, the growth in non-seasonally adjusted money supply (M2) has been zero. That’s right, the money supply did not grow at all,” Bove wrote. “This is because the Fed is shrinking its balance sheet ultimately by \$50 billion per month. In addition, the Fed has raised interest rates seven times since Q4 2015. Supposedly there are five more rate increases coming. . . . Current Fed monetary policy is directly in conflict with the president’s economic goals.”

The U.S. reportedly has the tightest monetary policy since the mid-1980s, when Paul Volcker of Trilateral Commission fame headed the Fed and caused back-to-back recessions. Retired Texas A&M economist Dick Eastman, a staunch critic of economic orthodoxy, responded to Trump’s remarks by reminding AFP that the nursery rhyme always trotted out by the media—blaming President Richard Nixon for intervening in the Fed’s policies and “causing” the double-digit inflation of the 1970s and early ‘80s—is a lie. Volcker was behind “extreme open-market purchases of securities” (the “QE” of its day) as head of the New York Fed branch, to which he was appointed after the Nixon years. The resulting double-digit inflation would destroy the savings and loans institutions—competitors of the big banks—and bring about massive banking deregulation.

“Then after that dirty deed is done, Carter appoints Volcker chairman of the Fed itself, and Volcker, having caused the inflation with his ‘QE’ in New York, tightens the money supply at the lending end, to lend less and call in loans more frequently—a tight-money regime that has pretty much persisted to this day. Of course, Volcker got credit for ‘squeezing out’ the inflation that he caused,” Eastman added.

So, while the people, especially America’s middle and lower classes, have been economically shackled for over 100 years due to boom-and-bust cycles and other disturbances wrought by the Fed’s usurious monopoly of credit, the Fed’s defenders wince at the slightest challenge to their financial fiefdom. Kevin O’Brien of *The Washington Post*—a newspaper headed from 1933 to 1959 by former Fed chairman Eugene Isaac Meyer—went hyperbolic over Trump’s remarks, scolding him for breaking “the unwritten rule against presidents criticizing the Federal Reserve.”

In other words, thou shalt not regulate the Fed, even though the Fed is authorized to regulate the nation, perhaps to ruin.

The truth is, the matter goes way beyond regulation. The Federal Reserve, which operates as a private cartel despite its “public” sounding name, hijacked the monetary system of the entire country in December of 1913 by voiding the constitutional money-creation powers reserved to Congress. In the treacherous process, Congress passed the Federal Reserve Act but did not bother amending the Constitution to authorize the Fed’s creation and the massive transfer of monetary power attendant to that creation. Any time such fundamental changes are made without amendment, the American republic’s authority dissolves, making the nation ripe for overthrow by private interests, in this case a banking consortium. ★

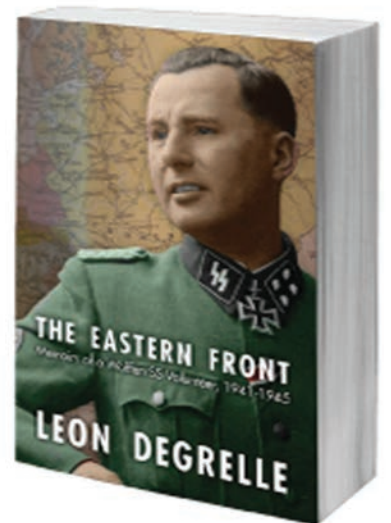

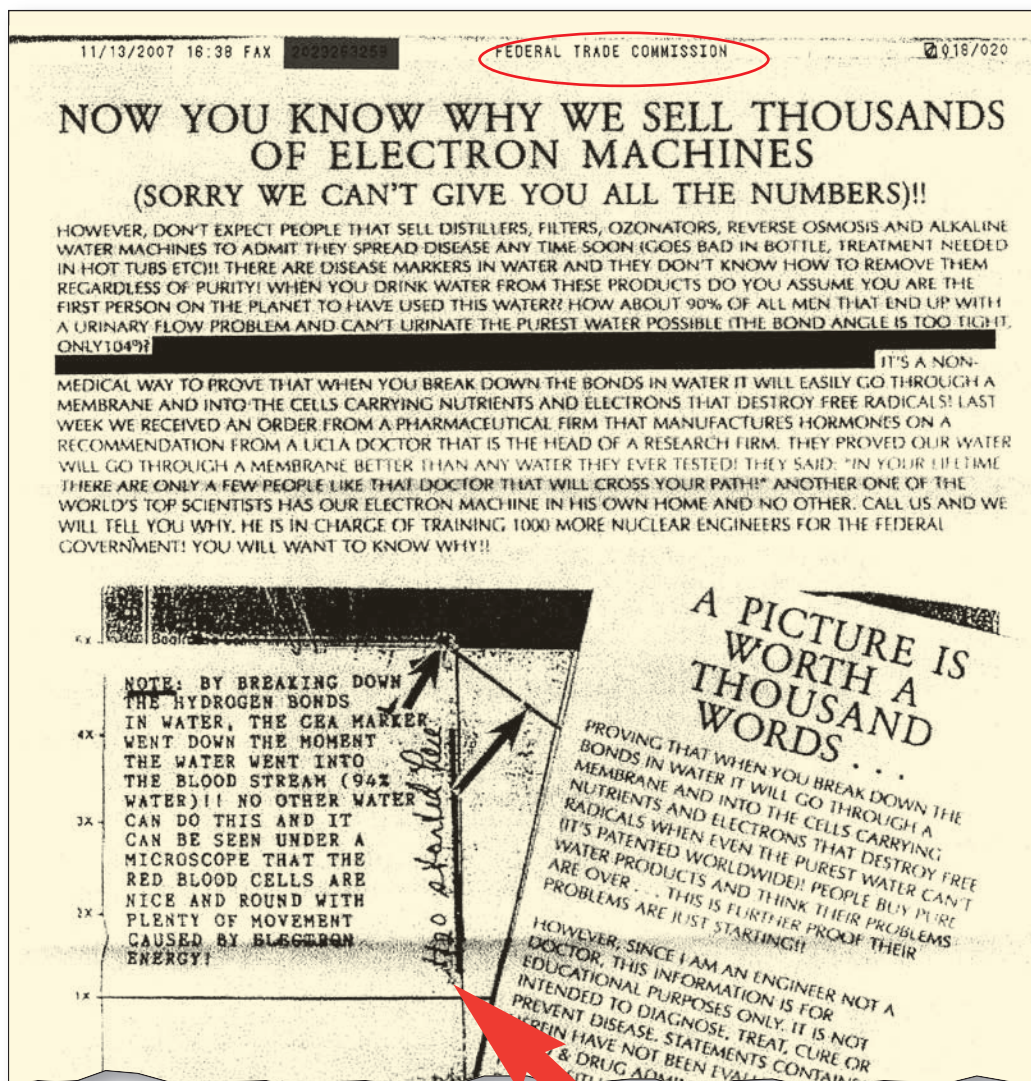

cluding one of the ambulances my grandmother donated (before we entered WWII), encouraged by her friend CARRIE CHAPMAN CATT, who moved around the corner from her in New Rochelle.

As I listened to DR. NORMAN VINCENT PEALE eulogize my father to an overflowing congregation in New Rochelle, I thought about increasing the lifespan of people like my Godfather, DR. JAMES E. 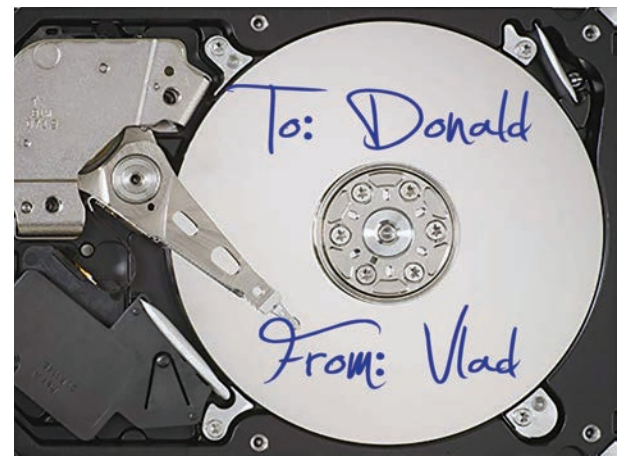

# Who Are the Real Traitors?

- Russian leader provides huge amount of info on Syria, Iraq

Bush so foolishly rebooted the Cold War is to prevent America’s true conservatives from learning that truth and ultimately seeing that the Russians have the potential to be our greatest ally in the ever-widening war against the global socialist elites.

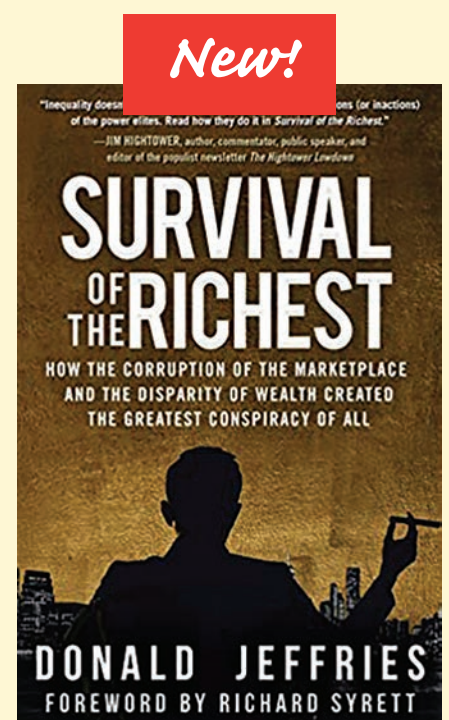

# Post-Helsinki Hysteria Infects Left

• D.C. warmongers scared to death president might actually bring peace to world

**THE D.C. ESTABLISHMENT** is wailing hysterically over the prospect of President Donald Trump refusing to instigate Cold War II so desired by the elite. But does the potential loss of control by the War Party warrant the Beltway elite's accusations of treason against our commander-in-chief and even apparent calls for a military coup?

“**T**reason, Bribery, or other high Crimes and Misdemeanors.” Under the Constitution, these are the offenses for which presidents can be impeached. And to hear our elites, Donald Trump is guilty of them all.

Trump's refusal to challenge Vladimir Putin's claim at Helsinki—that his GRU boys did not hack Hillary Clinton's campaign—has been called treason, a refusal to do his sworn duty to protect and defend the United States, by a former director of the CIA.

Famed journalists and former high officials of the U.S. government have called Russia's hacking of the Democratic National Committee (DNC) “an act of war” comparable to Pearl Harbor.

*The New York Times* ran a story on how many are now charging Trump with treason. Others suggest Putin is blackmailing Trump, or has him on his payroll, or compromised Trump a long time ago.

Wailed Rep. Steve Cohen (D-Tenn.): “Where is our military folks? The commander-in-chief is in the hands of our enemy!”

Apparently, some on the left believe we need a military coup to save our democracy.

Not since Robert Welch of the John Birch Society called Dwight Eisenhower a “conscious agent of the communist conspiracy,” have such charges been hurled at a president. But while the Birchers were a bit outside the mainstream, today it is the establishment itself bawling “Treason!”

What explains the hysteria?

The worst-case scenario would be that the establishment actually believes the nonsense it is spouting. But that is hard to credit. Like the boy who cried “Wolf!” the establishment has cried “Fascist!” too many times to be taken seriously.

A month ago, the never-Trumpers were comparing the separation of immigrant kids from detained adults, who brought them to the U.S. illegally, to FDR's concentration camps for Japanese-Americans.

Some commentators equated the separations to what the Nazis did at Auschwitz.

If the establishment truly believed this non-

sense, it would be an unacceptable security risk to let them near the levers of power ever again.

Using Occam's razor, the real explanation for this behavior is the simplest one: America's elites have been driven over the edge by Trump's successes and their failure to block him.

Trump is deregulating the economy, cutting taxes, appointing record numbers of federal judges, reshaping the Supreme Court, and using tariffs to cut trade deficits and the bully pulpit to castigate freeloading allies.

Worst of all, Trump clearly intends to carry out his campaign pledge to improve relations with Russia and get along with Putin.

“Over our dead bodies!” the Beltway elite seems to be shouting.

Hence the rhetorical WMDs hurled at Trump: liar, dictator, authoritarian, Putin's poodle, fascist, demagogue, traitor, Nazi.

Such language approaches incitement to violence. One wonders if the haters are considering the impact of the words they are so casually using. Some of us yet recall how Dallas was charged with complicity in the death of JFK for slurs far less toxic than this.

The post-Helsinki hysteria reveals not merely the mindset of the president's enemies, but the depth of their determination to destroy him.

They intend to break Trump and bring him

down, to see him impeached, removed, indicted, and prosecuted, and the agenda on which he ran and was nominated and elected dumped onto the ash heap of history.

Thursday, Trump indicated that he knows exactly what is afoot, and threw down the gauntlet of defiance:

“The fake news media wants so badly to see a major confrontation with Russia, even a confrontation that could lead to war. They are pushing so recklessly hard and hate the fact that I'll probably have a good relationship with Putin.”

Spot on. Trump is saying: I am going to call off this Cold War II before it breaks out into the hot war that nine U.S. presidents avoided, despite Soviet provocations far graver than Putin's pilfering of DNC emails showing how Debbie Wasserman Schultz stuck it to Bernie Sanders.

Then the White House suggested Vlad may be coming to dinner this fall.

Trump is edging toward the defining battle of his presidency: a reshaping of U.S. foreign policy to avoid clashes and conflicts with Russia, and the shedding of Cold War commitments no longer rooted in the national interests of this country.

Yet, should he attempt to carry out his agenda—to get out of Syria, pull troops out of Germany, take a second look at NATO's Article 5 commitment to go to war for 29 nations, some of which, like Montenegro, most Americans have never heard of—he is headed for the most brutal battle of his presidency.

This Helsinki hysteria is but a taste.

By cheering Brexit, dissing the EU, suggesting NATO is obsolete, departing Syria, trying to get on with Putin, Trump is threatening the entire U.S. foreign policy establishment with what it fears most—irrelevance.

For if there is no war on, no war imminent, and no war wanted, what does a War Party do? ★

# Russia Fights Collusion Claim; May Indict American Officials

Interfax reports that Alexander Kurennoy, a spokesman for Russia's prosecutor general, the equivalent to Attorney General Jeff Sessions, has named several employees of special services and U.S. officials as "persons of interest" for "potential indictment" because of their suspected involvement in the illegal activities of British citizen William Browder, founder of the Hermitage Fund, an investment fund.

Among those named in the Prosecutor General Office's report are Michael McFaul, Barack Obama's 2012-14 ambassador to Russia, whom Russian investigators want to ask a number of questions.

Also included in Kurennoy's report are the names of several Americans potentially tied to Mueller's "Russian collusion" investigation. They are employees of the National Security Agency, including Todd Hyman, Svetlana Engert, and Alexander Shvartsman. CIA agent Jim Routh, former deputy chief of the U.S. intelligence agency Lt. Gen. Robert Otto, and former Assistant Secretary of State David Kramer are also on the list of people who Kurennoy said Russian prosecutors wish to question.

Asked whether the list was exhaustive, Kurennoy replied, "Of course not." He went on to say, "There are quite a large number of people who should be questioned with the participation of Russian investigators: They are people from among special services, congressmen, senators, their assistants, various civil servants."

Kurennoy also said that he "would very much like to talk with Christopher Steele," the British MI6 agent who fabricated the now infamous "Trump dossier" that is the basis for the whole Mueller investigation. Kurennoy is also asking for

a copy of what he calls Mueller's "Trump file."

Kurennoy's report also mentions, "those same brothers Ziff—recipients of illegal income, American financiers." His report also called them "long-standing partners in the criminal business of William Browder."

During his press conference with President Donald Trump in Helsinki, Russian President Vladimir Putin said, according to news and commentary website "TruePundit.com": "Russian law enforcement officers can interrogate accused of interfering in U.S. elections at the request of the United States and send a response to Washington. At the same time, he added, the Russian side in that case would expect from the American 'that they interrogate those representatives of the U.S. special services whom Moscow suspects of illegal actions on the territory of the Russian Federation, in the presence of Russian investigators.'"

Putin specifically mentioned the case of Hermitage Capital and Browder, who has been convicted in Russia of fraud. "According to our investigation, Mr. Browder and his business partners earned more than \$1.5 billion illegally, neither in Russia nor in the U.S.; they paid the money, and \$400 million was sent to Mrs. Clinton's election campaign. These are official data, which are present in their reports," President Putin said. He went on to say that, "perhaps it was done legally, but the money was received illegally. We have reason to believe that some U.S. intelligence officials accompanied these transactions illegally."

The Russian state-sponsored news agency

TASS has since reported a correction to Putin's claim that associates of Browder donated \$400 million in untaxed Russian money to Hillary Clinton's campaign. The amount has been corrected to \$400,000.

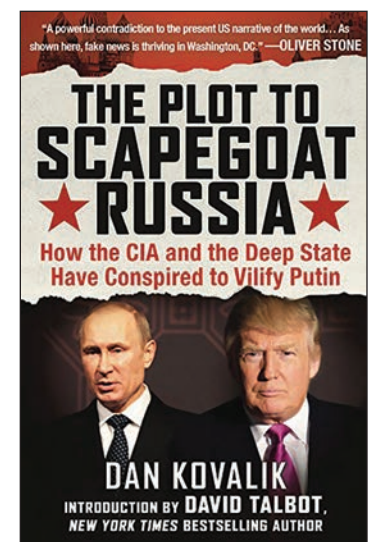
Obviously, Ambassador McFaul was protected with full diplomatic immunity during his time in Russia, so, legally speaking, he could not be indicted in that country. Questioning him, either in Moscow or by Russian investigators in the United States, would be nothing more than a "fishing expedition." But doesn't that term just about sum up the whole Mueller probe?

As for the rest of the possible suspects, under our Constitution, Trump does not have the authority to "turn over" anyone on Kurennoy's list for interrogation. That would require a court order issued by a U.S. judge. ★

# Should U.S. Negotiate With ‘Enemies’?

• Obama, Trump have both faced attacks for talking peace with so-called foes

The world of diplomacy is layered with public relations, secrecy, plausible deniability, and self-interest. While the end goals of peaceful existence and mutually beneficial trade may be the desired outcomes of diplomacy, the debate and ideologies that blanket diplomacy can often get cantankerous. Even before two bureaucrats enter a room to sit at a circular table, questions arise as to the validity of even meeting with the other party. If the other party was once considered an enemy—or is today considered one—should you still enter negotiations?

America once publicly touted the hardline view that “we don’t negotiate with terrorists.” The Iran-Contra scandal showed that to be wildly inaccurate. Since then, documents and records have backed the contrary. There is also the alternative theory posited by political scientists, historians, and journalists that all negotiations are good negotiations.

In 2015, President Barack Obama faced furious Republican opposition when he negotiated with Iran. Today, President Donald Trump faces frothing Democrat—and liberal Republican—opposition for meeting with Russian leader Vladimir Putin.

While the behavior of both parties (and their operatives) in 2018 can be attributed to base partisanship, the subject of negotiation is one that should enter the public dialogue.

Americans have historically had what *The Atlantic* called a “deeply ingrained aversion in American culture toward parleying with ‘evil’ opponents.”

In America, it is preferred that the former or current enemy earns his way to the bargaining

table through good behavior. That good behavior is dictated by the United States government. Maybe the leader has opened up press and political freedom within their own country, or maybe the leader has chosen to cooperate with the International Monetary Fund and the World Bank rather than being deposed in a covert coup sponsored by the CIA. However “good behavior” is defined by the U.S. in that situation will be the determining factor of whether a seat at the table has been opened.

Is it not better that world leaders meet at a negotiating table rather than on the battlefield?

This is a typically American conflict. Obama was involved in a six-nation coalition that negotiated with Iran. Great Britain, France, Russia, China, and Germany joined the U.S. at the table. The U.S. president was the only leader of the six that had to contend with a domestic political battle simply by choosing to negotiate.

Toward the end of the Vietnam War, multiple allies urged the U.S. to negotiate an end to the war with the government of North Vietnam. American diplomats refused to accept any negotiation or agreement, at the time, other than complete surrender.

American diplomats have long negotiated from a position of strength. Not only does this all but secure an agreement that is advantageous for American business and banking, but this also standardized the practice of picking and choosing the partner with whom negotiations can commence. America could be very selective because it was in the dominant position. The rules of diplomacy, written and unwritten, could then be drafted and normalized through that lens.

As for Trump, he now faces a left so overtaken with “Trump Derangement Stress Disorder” that they have forgotten what they believed throughout the Cold War—what they believed about Russia and Russians, what they believed about agreements, and what they believed about the power of conversation.

Negotiation is preferable to both war and inaction, but when negotiation itself becomes the hot button, then the reasons for the meetings or summits loses power.

Trump and Putin are vital world leaders in 2018, regardless of what detractors think of that. They both have their countries enmeshed in dangerous lands in dangerous times. They are each leaders of nations that small countries seek for assistance and guidance. Is it not better that they meet in a boardroom rather than on a battlefield? ★

# Statue of FSU Founder Removed

• Cowardly culture destroyers move in dark of night to erase history, insult patriots

**T**hey did it again. In the dark of night, another reminder of this once-great nation's past was plucked from the ground and unceremoniously thrown into storage. This time it was the statue of the grandson of Thomas Jefferson—Francis Wayles Eppes VII—the founder of Florida State University (FSU) in Tallahassee. It was removed in order to make the university a “more welcoming place for black students,” according to an article in the Gannett Company Inc.-owned *Tallahassee Democrat*. The article said, “Eppes Statue was quietly removed Thursday morning from Westcott Plaza.”

In fact, one of Eppes's relatives—Megan Eppes Barnes—was mentioned in the article. She wrote on her Facebook page: “Under the cover of the night Florida State is erasing its own history. I am proud to be an Eppes and proud to be the great, great, great granddaughter of the founder of FSU. How sad that [FSU President John] Thrasher was so easily convinced to overlook all of the accomplishments and generosity of Francis Eppes and cave to the noisy few that think he is unworthy of recognition.”

To get a more thorough understanding of this latest victim of “political correctness,” this newspaper conducted an exclusive interview with Tallahassee attorney and CPA Pace Allen Jr., a member of the Eppes clan, who earned his undergraduate and law degree from FSU.

“My mother is where the Eppes relationship comes from,” Allen explained. “There were a bunch of sisters. One of them was my mother's mother, my grandmother, and one of the sisters is in the direct line, married an Eppes. So, everybody from that line is a direct descendent of Thomas Jefferson. My mom and the direct descendants of Thomas Jefferson were first cousins, so I'm like a second cousin. My cousins—some of them—are direct descendants of Thomas Jefferson.”

Jefferson has also been attacked by those wishing to erase all history of the Founding Fathers from this country, as Allen explained.

“Thomas Jefferson was considered a great abolitionist for 200 years by most people,” he said, “and a lot of lies have been told about Jefferson, and one of them his treatment of slaves and the DNA testing that I'm personally familiar with. Some of my cousins in town—people come down and get DNA from them to do another DNA test. And some people think that there is a DNA connection between Sally Hemings and Thomas Jefferson. Well, there's not. There was a false report put out many years ago in 200 newspapers, and maybe one or two of the papers made the correction to the actual DNA results. So that's a big, big lie.”

In fact, continued Allen, in Jefferson's first



draft of the Declaration of Independence, a deleted passage reveals the Founding Father's true feelings about slavery.

“There was a whole paragraph condemning slavery,” he said, “and the fact that the king of England would not allow the colonies to outlaw slavery, and Thomas Jefferson could not release his slaves because it was illegal to release them.”

Allen gave the background to the disgraceful removal of Jefferson's grandson's statue.

“The Students for a Democratic Society [SDS] at FSU campus pushed to get rid of the statue because Francis Eppes was a slaveowner,” he said. “But he was mayor of Tallahassee and was a key person in founding what's now FSU.”

SDS is a radical, leftwing student-led organization, with over 120 campus chapters worldwide.

Eppes was a slave owner—as were all landed gentry of the time—but as mentioned above, freeing slaves outright was illegal when there was still debt owed to the crown or its subsidiaries. In fact, after his grandfather's death, Eppes purchased and freed an elder slave, a pesky little fact never mentioned by the SDS. The group first attempted to get the statue removed in 2016, but a referendum introduced by SDS failed by a vote of 71% to 29%.

AFP asked what happened in the intervening years. “They kept putting pressure on—lobbying, I guess—the administration,” Allen explained. “It's kind of ironic that they call themselves the Students for a Democratic Society, but the democratic voting path didn't work, so they made direct lobbying efforts.”

The government-inspired mayhem in Charlottesville in August 2017 helped SDS's cause, as FSU President Thrasher formed a committee con-

cerning the statue—fearing the spread of violence to his campus—to “pacify this small group that was pushing for removal of the statue,” said Allen.

Allen wrote a letter urging the president not to move the statue until an alternative location was selected. “The statue was moved the next morning,” July 19, Allen explained, but he did get a reply to his letter.

“I got a nice reply on Friday, that said we got your thoughtful suggestions and the president would be glad to meet with you,” he said. “Oh, by the way, the statue has been moved.’ But in fairness to the administration, they've been very professional, and I do have a meeting scheduled with President Thrasher July 31. What I'm doing between now and then is getting input from family members all over the state, getting some of their thoughts and ideas [to share] when I have this meeting with President Thrasher. If some context needed to be added, I didn't object to that, and most of the relatives didn't object to that. But I think most of the family just feels that we're destroying—hiding—our history by removing these statues, not only in Tallahassee but around the country.”

He continued, “And at present, I think the consensus is that there's not a great objection to putting some historical context around the statue, or in the area, and so forth.”

Allen was alluding to a proposal made by black history professor Dr. Julian Maxwell Hayter at the University of Richmond, who's suggested using historical markers near the statues to add context. Hayter, named Faculty Member of the Year in 2013-14 by the Richmond College Student Government Association, opposes removing any statues.

“When I meet with President Thrasher,” Allen explained, “that'll be one of the things that we will suggest, is to provide historical context.”

The irony of removing this particular statue is not lost on Allen, who referenced the statue's meaning, which portrays Eppes holding some papers that he delivered to the legislature to found what became FSU.

“Education was the primary inspiration for having that statue here,” explained Allen. “When you remove the statue you're kind of removing and hiding the educational value that can be derived from the statue. So, we're concerned about this particular situation, but also this idea of removing these reminders of history across the country.” ★

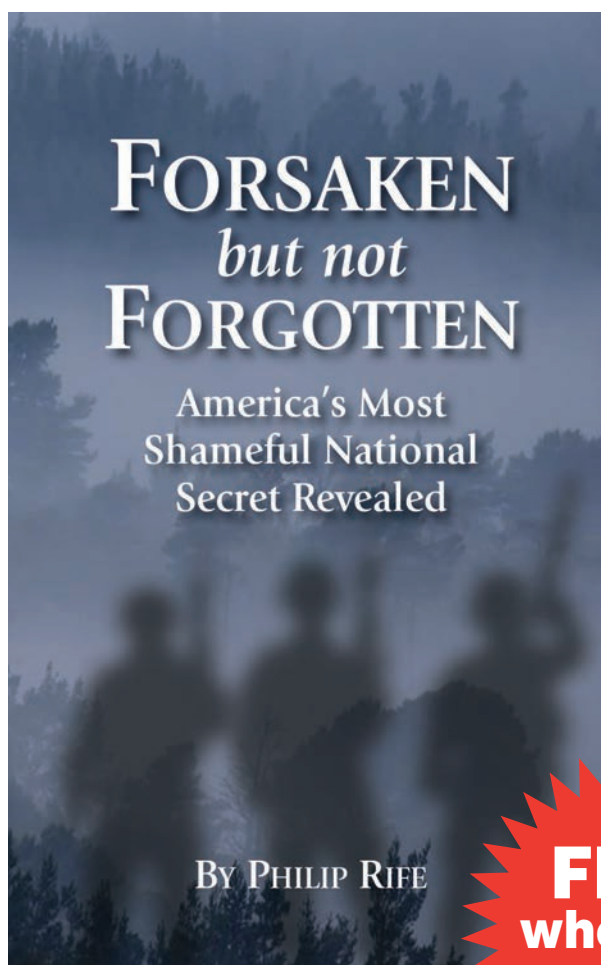

# Trump Calls European Union a 'Foe'

• Unaccountable EU policies firmly in control of globalists, bankers, NWO minions

When asked by CBS News anchor Jeff Glor to name the biggest competitor, the biggest foe, of the United States presently, President Donald Trump gave an interesting answer that surprised both viewers and analysts. He pegged the European Union (EU) as America's biggest global foe.

"Well, I think we have a lot of foes. I think the European Union is a foe, what they do to us in trade," Trump said. "Now, you wouldn't think of the European Union, but they're a foe."

Trump clearly interpreted the question as an economic one, which is in the vein in which it was asked. Trump elaborated by including the more widely accepted answers.

"Russia is a foe in certain respects," Trump said. "China is a foe economically, certainly they are a foe. But that doesn't mean they are bad. It doesn't mean anything. It means that they are competitive."

Glor asked Trump to explain his comments regarding the EU.

"The EU is very difficult," Trump clarified. "I respect the leaders of those countries. But, in a trade sense, they've really taken advantage of us and many of those countries are in NATO and they weren't paying their bills."

NATO spending has been an issue for Trump since the 2016 campaign. It is supposed to be a joint defense and treaty organization, yet the United States pays the largest share of the bills. Trump has pressured member nations to contribute an extra \$14 billion so that the United States is not relied upon so heavily.

Lest anyone believed Trump was for a stronger, more globalistic EU, his intentions were made clear in a recent visit with British Prime Minister Theresa May. He advised May to sue the EU over the Brexit deal rather than negotiate.

Trump's comments were not the first shot across the bow in the verbal spar between the U.S. and the EU. In January, the EU's chief Brexit negotiator, Guy Verhofstadt, cited Trump as part of a three-pronged attack to undermine the EU. Radicalized Islam, which the EU openly accepted, and Russian President Vladimir Putin were named as the other two prongs.

Verhofstadt's remarks are another attempt by the EU hierarchy to attack those who see through the transparency of the forced federalism that was the goal of the globalists who built the EU from its genesis. Behind the forced federalism is an even more dictatorial spirit. The main players within the EU's oligarchy cannot be voted out of office by the citizens of Europe.

Christine Lagarde of the International Monetary

Fund, EU president Jean-Claude Juncker, and Mario Draghi, president of the European Central Bank, cannot stand for election. Their influence over the EU is draconian, yet their accountability is strictly bureaucratic.

Meanwhile, tough talk abounds from an EU leadership that really believes it can win a trade war with the United States, as Greece, Ireland, and France struggle to support their own populations, rebuilding economies that they can only hope will resemble the modern first world.

German Member of the European Parliament Manfred Weber reacted to Trump's concerns over the EU, saying, "Europe does not want a trade conflict. But if Donald Trump decides to treat Europe as an enemy, we will have no choice but to defend European industry, jobs, and interests."

The threat, however, is a shallow one since the

strings between the EU and its member nations continue to loosen due to the inefficient and inequitable ways by which the EU handles industry, jobs, and interests via its own failed policies and ideals. The EU has been beneficial for chosen blocs of the Euro elite; it has been a perpetual struggle for working Europeans adjusting to a post-Cold War world.

Weber is now using the United States as a convenient enemy in an attempt to inspire the uneasy nations into a unified front—unified behind the goals of the globalists, bankers, and internationalists that control the EU from beyond the ballot boxes.

Weber added, "The decision has to be a wake-up call for us Europeans: With the U.S. closing in on itself, we should be bridge-builders and reliable partners for the rest of the world."

As Americans learned after 9/11, defining an enemy can unite citizens who were otherwise in conflict. Yet, there is a distinct time frame of effectiveness for this strategy until the citizenry discovers the "man behind the curtain."

It does appear that the EU is a foe to the United States, but no more than it is a foe to its own working classes. It can also be argued that defining a foe is a tricky game. Is Syria a foe when Saudi Arabia is not? Are Russia and China foes or friends? What empirical data or litmus test draws that line? Do we allow new leaders to check those boxes country-by-country and then expect instant acceptance of the roles by the people?

Geopolitical relationships are complex. To attach any label to any nation or continent may be faulty, by nature. It is surely fair game, however, to criticize a nation's political structure, its politicians, and its policies. When Trump criticizes the EU for not paying its fair share to NATO, enacting policies detrimental to its own people, and working against democratic principles in its own EU leadership, the comments are as valid as the comments of nations that criticize the United States for being a perpetual war state. Public comments between nations are a form of instant accountability, and they are comments that should be welcomed rather than muted. ★

# The Mysterious ‘Others’ Who Compromise National Security

President Donald Trump reckoned on Monday that the United States intelligence community (IC) just might be overreaching in its assessment that Russia had sought to interfere in the 2016 U.S. election but then decided on Tuesday that he misspoke and had the greatest confidence in the IC and now agrees that they were correct in their judgment. But Trump, interestingly, added that there “could be other people also” that had been involved in interfering in the election, presumably either in an attempt to understand what was going on or to subvert it, though he was not specific and the national media has chosen not to pursue the admittedly cryptic comment. Many inside-the-Beltway pundits believe that he was primarily referring to China, both due to possible motive and to the possession of the necessary technical resources to carry out such an operation.

Indeed, the China hypothesis gains strength because there are credible reports that China may have hacked the 30,000 Hillary Clinton emails that are apparently still missing. China also was described as America’s principal enemy last week by *The Spectator*, which denounced Russiagate as much ado about nothing, citing Byron York of the *Washington Examiner* who described the enterprise as “. . . a small, poorly funded operation with a level of effectiveness that is impossible to measure but could be near zero” before also observing that:

Meddling in other countries is something that sovereign nations, especially rich and powerful ones, do [but] the Russians don’t seem very good at it. The activities outlined in Mueller’s indictments are partly pathetic, partly comical. Beginning in 2014, the Russians took out Facebook and Twitter ads under false names. Some supported Bernie Sanders and Jill Stein. Some attacked Marco Rubio and Ted Cruz. Much of their effort was directed against Clinton. Someone, for example, built a cage to house an effigy of Mrs. Clinton. But the Russians concentrated on Hillary because they, like everyone else, thought she was going to win. Late in the game, they sponsored some pro-Trump ads and events.

While this Kabuki was going on, the Chinese, who have been identified hacking into Pentagon computers, were reportedly also working quietly and methodically to expand their influence worldwide and increase their military readiness. Their military technology has already caught up to that of the United States in a number of areas, and, as America de-industrializes, the advantage to a still-growing China high-tech sector will increase. A

number of congressmen have also described China as the number one cyber threat, aided and abetted by illegal technology transfers and wide-scale industrial espionage.

Identifying just how one interferes in an election in a large country with numerous polling stations located in different states using different systems is, of course, problematical. But a country’s government can be undermined in other ways. A consensus is growing that China is a competitor or even an enemy, according to one White House advisor, a state engaged in “economic aggression” against the U.S. It has apparently es-

chewed the violent route to obtain hegemony and is instead seeking an empire in the old-fashioned British model, based on economic dominance through penetration of markets and the achievement of comparative advantage. It is the same model that the United States, at least initially, used successfully post World War II.

But Trump referred to “others” in the plural as interfering in the 2016 election. Surely America’s friends and allies would not spy on Washington, or would they? The British or Germans would not be so bold as to hack into U.S. government accounts, but they are certainly quite willing to do random collection of telecommunications information out of their embassies in northwest Washington and their consulates general in places like Seattle and Los Angeles, near defense industry hubs. Those antenna and dish arrays on the tops of their buildings are not there to enable telephone calls to the homeland.

And then there is, of course, Israel. Trump continues his delusional babble on how wonderful Is-

rael is, even citing it in his Helsinki press conference comments:

We’ve worked with Israel long and hard for many years, many decades. I think we’ve never, never has anyone, any country been closer than we are. President Putin also is helping Israel and we both spoke with Bibi Netanyahu and they would like to do certain things with respect to Syria, having to do with the safety of Israel. So in that respect, we absolutely would like to work in order to help Israel and Israel will be working with us. So both countries would work jointly. . . . But I think that their working with Israel is a great thing and creating safety for Israel is something that both President Putin and I would like to see very much.

Israel’s intelligence operations directed against the American government and people are well-documented and have been going on for 70 years. Their propaganda has clearly convinced Trump and others like him, but Israel is the aggressor in the Middle East, not the victim, and is a strategic liability for the United States, though it would be difficult to explain that to the president in ways that he would understand. Some might argue that Israel does not need to steal U.S. secrets because we Americans share everything with them anyway. That would not be correct, as Israel features as No. 1 on the FBI list of foreign countries that are ostensibly friendly that spy on the U.S. Israeli companies also provide the telecommunications technology that enables it to tap into phones nationwide, including at the White House.

So Russiagate is a lot less than it seems while competitors and friends have also been interfering in how our government runs and thereby compromising national security. One might propose that Special Counsel Robert Mueller determine who those “others” referred to by Trump are and begin to look into their activities. The results just might surprise a lot of Russia haters. ★

# China Represents a Special Danger

• Continued militarization of Pacific Ocean, interest in India seen as concerns

If there is an ever-present danger of a major war anywhere in the world it is in the Indo-Pacific region where China has exploited America's focus on North Korea and NATO to continue plotting its militarization of the region.

Over six months ago, AFP warned its readers that Washington would, at its peril, take its eye off the ball with regard to China, and that not enough congressional attention was being paid to how China's Liberation Army had converted the Spratly Islands in the South China Sea into virtual military zones with all the equipment needed to attack the U.S. fleet in the event of a conflict. Runways had been built to handle fighter aircraft, with underground storage bunkers for munitions. Advanced radar has also been installed as well as anti-ship and ground-to-air missile batteries.

While the U.S. mainstream media has ignored this story, it has received widespread coverage in India, Australia, Japan, Vietnam, and Taiwan. They have been watching the Chinese military spread its influence across the region, in both the Pacific and Indian oceans, but especially in the Pacific where China seeks to control the movement of all traffic in the South China and East China seas.

The increasing militarization of the region has taken place despite a promise not to do so by Chinese President Xi Jinping in the White House Rose Garden in 2015.

As one European diplomat with experience of the region told this writer on condition of anonymity: "The moment you take your eye off China is the moment you lose and bad things begin to happen. The Chinese will always tell you one thing and do another when your back is turned."

One man who has not taken his eye off China is Defense Secretary Gen. James Mattis. In June, Mattis warned China about its behavior. His remarks attracted little media coverage, yet he was direct and uncompromising in calling out the Chinese for their behavior.

"There are consequences that will continue to come home to roost, so to speak, with China if

they do not find the way to work more collaboratively with all of the nations who have interest."

For someone of his stature to make those remarks was startling. In diplomatic speak it was a warning to China that the United States as well as other countries in the region would not roll over but instead act if they had to.

What was especially interesting was that his warning came within days of a major decision that he made on May 30 to change the name of the U.S. Pacific Command from PACOM to INDOPACOM, the Indo-Pacific Command, which will be responsible for the whole of Asia. The U.S. fake news media and Congress were too focused on North Korea to take note of this change, though it could not have escaped the notice of the Chinese.

It was not a mere name change but the confirmation of a strategy that the U.S. and its allies, in-

cluding India, have a vested interest in ensuring the free movement of all shipping in the Indian and Pacific oceans. The fact that India, a major nuclear power, was added to the name change confirmed that Mattis and his generals were determined not to permit China to think it had free rein to exercise any military control over the Indian Ocean.

As a sign he meant business, Mattis said the new Indo-Pacific Command has been given fifth-generation fighters to replace the third-generation fighters they had been using.

"We've added our most capable ships to the commander of Indo-Pacific Command's fleet during the last year or two, and we will continue to address this theater as a priority and properly defined as now the Indo-Pacific Command," he declared.

It was confirmation that Asia represents America's greatest military challenge. In response, Mattis has designated 375,000 personnel to a fleet of 200 ships that includes a five-carrier strike group and 1,100 aircraft, which is only a part of a far greater allied force.

Many media figures poked fun at former White House senior strategist Steve Bannon when he warned in March 2016 that war with China was coming. He said that the South China Sea represented one of the world's most dangerous international flashpoints.

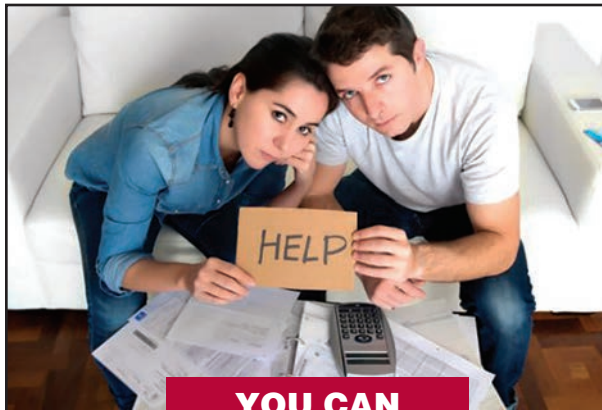
"We're going to war in the South China Sea in five to 10 years," he declared, adding, "There's no doubt about that. They're taking their sandbars and making basically stationary aircraft carriers and putting missiles on those."

Bannon's warning can no longer be easily dismissed. With so much military hardware in place, a collision between warships might be enough to set in place a chain of events that could lead to a full-blown war.

In that event, the U.S. and its allies would shut off China's supply routes into and out of the Pacific and Indian Oceans and starve the Chinese military of much-needed energy supplies for its war machine. Using Taiwan, the U.S. would also close the only window China might hope to seize and open into the Pacific. ★

# U.S. Taxpayer Party Offers Solutions at July Convention

- Party members cover issues with broad appeal to voters

**H**OLT, Mich.—Attending the U.S. Taxpayers Party of Michigan (USTP) nominating convention on July 14 was a refreshing experience, in light of the principled remarks of USTP Chairman Bill Mohr on why he feels a proposed convention of the states is an ill-advised idea—along with a variety of relevant ideas and concerns expressed by USTP candidates nominated that day to run for office.

All told, the USTP puts principles before party in an age of almost universal deceit by two dominant parties that too often act as one. And the platform of the USTP, which is the Michigan affiliate of the national U.S. Constitution Party that ran presidential candidate Darrell Castle on the 2016 ballot, plays no word games and ventures into policy areas that could appeal to a wide range of voters.

Although the recently updated platform's 22 planks include familiar constitutional-conservative items like protecting human life from conception to natural death and protecting the right to bear arms under the Second Amendment, it also includes items one rarely hears about in today's twisted political arena, such as eliminating the standard school property tax liability for private and homeschoolers to reduce the burden on families who do not utilize public schools.

And while conservative organizations tend to shy away from environmental issues due to the public's media-programmed assumption that only left-wing outfits concern themselves with such matters, the USTP platform includes common-sense views on environmental issues.

For instance, one of the planks stresses “equity in the protection of our water and other natural resources.” Another plank, focusing on an issue that's long been a nationwide concern despite the efforts of major media and government agencies to suppress it, calls for eliminating the use of fluoride and chlorine for treating municipal tap water, proposing instead a conversion to “oxygenation.”

In fact, among the various topics brought to the floor during the convention, water issues received considerable attention. Both Earl Lackie, nominated to run in November for Michigan lieutenant governor, and Todd Schleiger, who got the USTP's nod to run for governor, raised serious concerns about Michigan allowing Nestlé Waters North America to perpetually plunder Michigan groundwater, essentially for free.

They noted that Nestlé pays only \$200 per year per withdrawal site to the Michigan Department of Environmental Quality (MDEQ) to extract increasingly huge amounts of groundwater. The MDEQ defines that \$200 payment as “an annual water-use reporting fee.” This incredibly lowball amount is confirmed by MDEQ documentation. The Swiss-based food and beverage giant in April won a permit renewal to boost its groundwater

extraction to 400 gallons per minute (gpm), formerly limited to 200 gpm, from the aquifer near Ewart, Mich. Once a new pumping infrastructure is complete, the 400 gpm extraction will begin filling “Ice Mountain” brand plastic bottles.

Assuming the Ewart plant was to run at full capacity around the clock, 400 gpm translates to 576,000 gallons per 24 hours, which is just over 4 million gallons per week. In one year, that's 193.5 million gallons.

USTP candidates have also pledged their adherence to a plank opposing usury. Specifically, the plank calls for banks and credit card companies to comply with Michigan's “usury and consumer protection laws.” Other planks uphold the value of family farming, better ballot-access laws for alternative parties, tort reform, and restitution instead of incarceration of prisoners. The national issues on the USTP platform mirror those of the national Constitution Party.

Mohr posted the full list of the USTP's candidates running in the November midterm election at the website [ustpm.org](http://ustpm.org), including four for the House and one for the Senate.

Mohr also stressed one of the newest planks in the USTP platform, which calls on constitutionalists to be wary of frequent calls for a “conference of the states” to balance the federal budget, among other stated goals of state and local officials who are fed up with the federal government's excesses. Such a conference does not appear to pass constitutional muster, among other defects.

“There's nothing in the Constitution that allows for a conference of the states where state officials could select delegates who would actually represent the states,” Mohr told AFP after the USTP meeting.

He clarified that, contrary to the hopes of concerned state officials, “the Constitution does not guarantee state input at an Article V Constitutional Convention” (or “con-con” as it's called for short).

“In other words, the choice of con-con delegates would be limited to the whims of Congress,” he added. “If three-fourths of the states ratify a call for an Article V con-con, that's all the input the states get.”

Mohr said his party opposes the introduction of a national ID—which some try to justify for immigration-enforcement enhancement.

“Employers already have laws in place regarding the immigration problem without [needing to support] a national ID,” Mohr told fellow party members. ★

# British Ministers Could Be Charged With Drone Killings of Civilians

- Parliamentary committee admits there's been no oversight of killer drone program

For years now, critics of Washington's remote-controlled killer drone program have been working to rein it in, but so far they have had little luck getting anyone to listen. Now, across the Atlantic, British government ministers and military personnel, who have worked with the U.S., could face criminal proceedings for their complicity in American drone strikes that have killed innocent civilians in different parts of the world.

While little is known about the secret war waged with drones, manned mostly by American military personnel but often aided by members of foreign forces such as the British, it is generally agreed that there has been what is often referred to as collateral damage, which in Pentagon parlance is a euphemism for the killing of innocent civilians.

While drones have become a highly effective military tool, deployed to strike at targets while operators sit and guide them from half a world away in the U.S. or in Britain, the intelligence used to guide drones to their targets is often flawed.

An all-party British parliamentary committee that has devoted two years to studying the use of drones has issued an alarming warning that British military personnel and even government ministers could be judged legally complicit in drone strikes that killed innocent men, women,

and children in Afghanistan, Iraq, Syria, Pakistan, Yemen, Somalia, and other conflict zones.

The parliamentary investigators revealed a little-known fact that the British have been operating their own drones in conjunction with U.S. drones, particularly the highly advanced and lethal MQ-9A Reaper drones. Little political and media scrutiny has been devoted to drone warfare, making this report in many respects star-

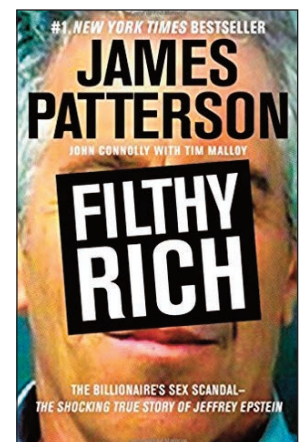
ling. It confirms that there has been virtually no oversight of drone use.

The expanded use of drone warfare became a prominent feature of the Obama presidency's preferred form of warfare. Ironically perhaps, it did not garner the criticism it might have had a Republican president been authorizing the widespread use of drones that often killed innocents.

The British parliamentarians were especially

concerned about the fact that their own government's approval was not required or sought for drone strikes, or for the manner in which British drones were interlinked with Reaper drone operations carried out by allies, particularly the U.S. The committee argued that if U.S. drones killed innocents, the obvious risk was that British operators could be judged complicit.

Presently, the U.S. has drone centers in Britain to manage, track, and direct drones as they make their way to kill zones, while the British military launches its own drones from U.S. and other allied drone operations centers across the globe, particularly in the Middle East in Qatar, Jordan, and Saudi Arabia.

While the U.S. likes to see its enemies brought before the International Criminal Court in The Hague for war crimes involving the killing of civilians, it has refused to accept the court's legal jurisdiction over Americans. Therefore, U.S. military personnel and politicians will never be brought before it to face charges. The same applies to Israel. The opposite is the case for Britain. It is a full-fledged signatory to the Rome statute that set up the court and accepts its legal protocols. Therefore, if British drone operators and political figures were judged legally complicit in U.S. drone warfare that killed civilians, they could face war crimes charges on the basis that Britain is an integral part of the U.S. drone campaign and strategy.

A senior member of the parliamentary committee, Baroness Vivien Stern, spelled out the problem facing Britain by stating that since Britain shares drone bases, surveillance, intelligence, and personnel with its allies, there is an increased risk of Britain acting unlawfully.

The report warned of the danger that the UK was "supporting a drone program where the U.S. commits unlawful acts." It also concluded that the support provided by the UK in the drone war constituted the provision of material assistance to "a state that appears to be violating international law." In the committee's opinion, that state was the United States of America.

The main concern of investigators regarding Britain's vulnerability to war crimes charges was that British drone operators and its intelligence services have been assisting in conflicts in countries like Yemen and Somalia where Britain has not been formally at war. Therefore, Britain has been an illegal combatant, making its military personnel complicit in any crimes committed by the U.S. and its allies, for example, the Saudis. In Yemen, many innocent civilians have been killed by drone attacks launched on behalf of the Saudis.

Prof. Richard Clark, former director-general of the Royal United Services Institute who was a prominent member of the committee, remarked that when it came to "collateral damage" the fault was not defective drones but the misidentification of targets.

Some committee members thought it was ridiculous that, while the U.S. admitted to the deaths of at least 900 innocent civilians in drone strikes, the British government claimed that it had directed only one drone strike in Afghanistan

in which there had been civilian casualties. The report appeared to conclude that this was not true, and that Britain had adopted a secret drone kill strategy without consulting parliament or the British people and had not owned up to killing innocent civilians. ★

# D.C. Kleptocrats Spending About \$52,000 Per Second

According to financial writer Simon Black, the federal government is spending approximately \$52,000 per second. This, not last year's tax cuts, is the reason why the national debt has reached a record \$21 trillion, which is more than America's gross domestic product.

Another ominous sign is that this year both Social Security and Medicare will have to draw down on their reserve funds to be able to pay benefits. The Social Security and Medicare trust funds will both soon be bankrupt, putting additional strains on the federal budget and American taxpayers.

The excessive debt caused by excessive spending will inevitably cause a major economic crisis. Yet, with a few notable exceptions, there is little to no desire in Washington to cut spending. Instead, both parties are committed to increasing spending on warfare and welfare while ignoring the looming entitlements crisis.

Examples of fiscal irresponsibility on Capitol Hill are easy to find. For instance, even though the United States is currently spending more on its military than the combined budgets of the next seven highest spending countries, Congress recently increased military spending by \$82 billion. This brings the total the U.S. spends on a futile effort to police and democratize the world to \$716 billion. The House has also recently passed a farm bill that increases spending by more than \$3 billion over the next five years. This bill does not

take a step toward ending subsidies to wealthy farmers and even continues providing farm subsidies to non-farmers. Pressure on Congress to increase spending on farm subsidies is likely to increase as farmers become collateral damage in President Donald Trump's trade war.

Many progressives are attacking the House farm bill because it makes some reforms to the "SNAP" (food stamp) program, even though the House version of the bill increases the budget for food stamps by at least \$1.7 billion over the next five years.

When the economic crisis hits, there will be no choice but to cut spending and raise taxes. Of course, Congress is unlikely to raise taxes or cut benefits. Instead, it will rely on the Federal Reserve to do the dirty work via the inflation tax. The inflation tax is the worst type of tax because it is both hidden and regressive.

One of the worst features, if not the worst, of the tax reform plan is increasing the inflation tax by authorizing the use of "chained CPI." Chained CPI hides inflation's effects by claiming that rising prices do not harm Americans as long as they can still afford low-cost substitute goods to replace products they can no longer afford due to the Federal Reserve's devaluation of the currency—as if people forced to buy hamburger instead of steak are not negatively impacted by inflation.

Increasing federal debt will most definitely put pressure on the [privately owned] Federal Reserve to keep interest rates low to prevent federal interest payments on the debt from skyrocketing. Eventually, the Fed's monetization of the debt

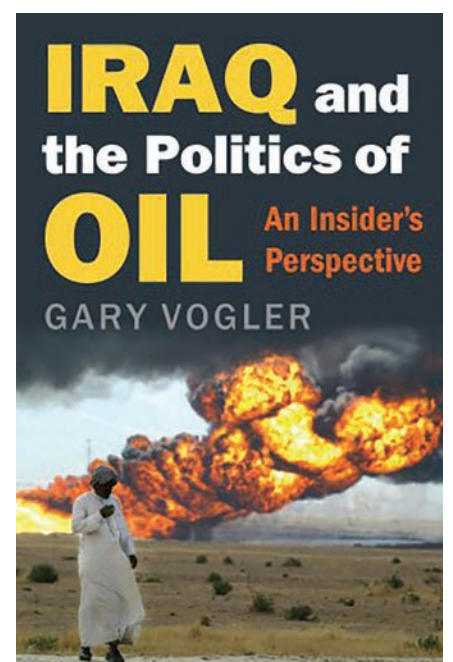
will lead to hyperinflation and a rejection of the dollar's world reserve currency status.

The question is when, not whether, the welfare-warfare state and the fiat currency system will end. Hopefully, those who know the truth will succeed in growing the liberty movement so we can convince Congress to gradually unwind the welfare-warfare state, restore a true free market in money, and stop trying to run the world, run the economy, and run our lives. ★

# Israel Evacuates 'White Helmets,' Proving They're Western Lackies

In mid-July, the Israel Defense Forces (IDF) facilitated the evacuation of hundreds of members of the White Helmets organization in Syria, a so-called humanitarian and medical aid organization funded by the West that is hostile to the Syrian government led by President Bashar al-Assad. Israeli forces assisted members of the White Helmets and their families to cross the Syrian-Israeli border and make their way to Jordan, where they await permanent resettlement in the West, according to published reports.

The operation was coordinated at the highest levels of the Israeli government, which was working closely with Western governments hostile to Assad, demonstrating once again the blatant conspiracy involving the U.S. and its NATO allies, Israel, and various international organizations funded and directed by the West to destabilize and eventually overthrow the sovereign Syrian government.

For several weeks now, the governments of the United States, Canada, the United Kingdom, and France have encouraged Israel to help transfer roughly 800 White Helmets members out of Syria, with the Israeli military receiving a list of names of all the individuals needing to be evacuated. The White Helmets and other non-state actors with close ties to Western intelligence and so-called charities have long been active in efforts to undermine and destabilize the Syrian regime, causing chaos, violence, and bloodshed in the region.

"Following an Israeli government directive and at the request of the United States and additional European countries, the IDF recently completed a humanitarian effort to rescue members of a Syrian civil organization and their families," the Israeli military explained in a public statement following the operation. "The civilians were evacuated from the war zone in Southern Syria



due to an immediate threat to their lives. The transfer of the displaced Syrians through Israel is an exceptional humanitarian gesture."

The White Helmets members and their families met along the Syrian-Israeli border under extreme secrecy to await evacuation out of Syria to Jordan. They were then bused to Jordan, with the Israeli military facilitating the operation, offering both food and protection to those being transported. The Jordanian government granted the Syrian activists and their family members temporary asylum while they await resettlement in the West for "humanitarian" reasons.

Since the Syrian civil war began, which has pitted forces loyal to Assad against subversive activist groups with close ties to the West—such as the White Helmets—and various terrorist groups, countless civilians have been displaced. Israel has provided humanitarian and medical aide to those who are hostile to Assad, but has refused to accept any refugees, preferring instead to encourage their migration and resettlement in the West. ★

# Exposing the Holocaust Deniers at America's 'Paper of Record'

• Why isn't *The New York Times* discussing these holocausts?

America's self-styled newspaper of record, *The New York Times*, is regarded as a trusted news source—by the ever-shrinking number of people who aren't paying attention. Donald Trump got elected president on the platform, "*The New York Times* and the rest of the MSM is fake news." Such a thing never could have happened in the past, when most people believed whatever the mainstream propaganda machine told them.

Two recent *Times* stories illustrate the mendacity of America's most famous newspaper.

The first, a July 13 opinion piece by Michelle Goldberg, addressed Trump's meeting with German Prime Minister Angela Merkel under the headline " 'Evil Has Won': Pro-American Germans Feel Betrayed." Ms. Goldberg's article begins:

He remembers getting packages of food from the Cooperative for American Remittances to Europe, or CARE: "The victor sends the one who is defeated, and who began the war, CARE pack-

ages! Imagine that. It doesn't happen too often."

If holocaust denial is a crime, Ms. Goldberg, Scharioth, and the *Times*' editors and publishers are suspects. They apparently deny the holocaust the U.S. occupiers committed against Occupied Germany during the immediate aftermath of World War II.

The anti-German holocaust began as German prisoners of war—likely more than a million of them—were apparently murdered under orders from Gen. Dwight Eisenhower. The German prisoners were locked behind barbed wire without food, heavy clothing, sanitation or shelter, and allowed to die of starvation, exposure, and disease.

This is the same method used by the CIA and its Northern Alliance puppets to murder thousands of Taliban prisoners in 2001. The helpless prisoners, whose only crime was to defend their homeland against a criminal invasion, were locked in sealed shipping containers in the hot sun, without water or air, and left to broil to death—another holocaust you will never read about in the *Times*.

Eisenhower's holocaust of German POWs was followed by an even greater one directed against German civilians. As historian James Bacque argues in his books *Other Losses* and *Crimes and Mercies*, the American occupiers deliberately starved the German people, while our allies, the Soviets, conducted a brutal ethnic cleansing of many territories under their control. According to Bacque, more than 10 million innocent ethnic German civilians, possibly a great many more, perished in the made-in-the-USA holocaust of Germany.

For an introduction to these and other dis-

turbing facts about World War II, I recommend Ron Unz's article "American Pravda: Post-War France and Post-War Germany," which includes links to free online versions of many of the books that, taken together, overturn the Western establishment's heroic myth of the "Good War." Anyone who takes the time to read this material will wonder why the Germans, who many say were the biggest holocaust victims of World War II, are still being forced to pay "holocaust reparations" to Israel.

Another criminally false, mendacious, and arguably genocidal *Times* article was published July 10 under the headline "The Last 9/11 Fire Chief Bows Out." The article parrots the long-debunked official story denying the obvious reality—visible to anyone with eyes—that the Twin Towers were blown to kingdom come with explosives: "About one-fifth of the core structural columns in each tower were sundered by the planes. The surviving columns were bolted to the floors, which were exposed to uncontrolled fires. Weakened by heat, the links failed, the columns buckled, the towers collapsed."

The explosive demolitions of the Twin Towers created pyroclastic clouds characteristic of nuclear detonations and volcanos. The spectacle of thousands of people being incinerated, with survivors chased through the streets by clouds of billowing dust, traumatized the American people and incited a series of ruinous wars against Israel's enemies. Those wars have cost more than \$6 trillion and led to the deaths of more than 30 million people, according to avoidable mortality expert Dr. Gideon Polya.

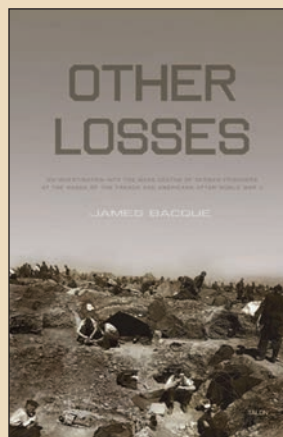

# Taboo Topic Has Facebook in Hot Water

**O**n July 17, the avowed founder and CEO of Facebook—the ubiquitous Internet tool used for anything from sharing family photos, news, and a variety of other functions—gave an interview to Silicon Valley’s “premier journalist” Kara Swisher. In the 90-minute audio interview, Swisher at one point asked Zuckerberg about so-called “fake news,” and referenced the ongoing doubt that many have about the official narrative of the Sandy Hook Elementary School shooting. Zuckerberg then “gave an unprompted example of Holocaust deniers to make his point about allowing hoaxes to be published on the site.”

**Swisher:** “Okay. ‘Sandy Hook didn’t happen’ is not a debate. It is false. You can’t just take that down?”

**Zuckerberg:** “I agree that it is false. I also think that going to someone who is a victim of Sandy Hook and telling them, ‘Hey, no, you’re a liar’—that is harassment, and we actually will take that down. But overall, let’s take this whole [thing] closer to home. . . .”

“I’m Jewish, and there’s a set of people who deny that the Holocaust happened.

“I find that deeply offensive. But at the end of the day, I don’t believe that our platform should take that down because I think there are things that different people get wrong. I don’t think that they’re intentionally getting it wrong. . . .”

**Swisher:** “In the case of the Holocaust deniers, they might be, but go ahead.”

**Zuckerberg:** “It’s hard to impugn intent and to understand the intent. I just think, as abhorrent as some of those examples are, I think the reality is also that I get things wrong when I speak publicly. I’m sure you do. I’m sure a lot of leaders and public figures we respect do too, and I just don’t think that it is the right thing to say, ‘We’re going to take someone off the platform if they get things wrong, even multiple times.’

“What we will do is we’ll say, ‘Okay, you have your page, and if you’re not trying to organize harm against someone, or attacking someone, then you can put up that content on your page, even if peo-

ple might disagree with it or find it offensive.’ But that doesn’t mean that we have a responsibility to make it widely distributed in News Feed.”

\* \* \*

As most aware observers can attest to, the Holocaust has been nurtured into a religion by those with the most to gain by doing so, and any questioning of the official narrative is met with outrage from defenders of this narrative.

For Zuckerberg, the reaction was swift and severe, from the man on the street—raised to believe that if it’s on TV it’s true—to some parents of those children slain at Sandy Hook, to Israel’s unofficial PR and intimidation arm, the Anti-Defamation League (ADL).

“Holocaust denial is a willful, deliberate and longstanding deception tactic by anti-Semites that is incontrovertibly hateful, hurtful, and threatening to Jews,” screeched ADL head Jonathan Greenblatt. “Facebook has a moral and ethical obligation not to allow its dissemination.”

Zuckerberg immediately emailed Swisher to “clarify” his comments on the Holocaust:

I enjoyed our conversation yesterday, but there’s one thing I want to clear up. I personally find Holocaust denial deeply offensive, and I absolutely didn’t intend to defend the intent of people who deny that.

Our goal with fake news is not to prevent anyone from saying something untrue—but to stop fake news and misinformation spreading across our services. If something is spreading and is rated false by fact checkers, it would lose the vast majority of its distribution in news feed. And of course if a post crossed a line into advocating for violence or hate against a particular group, it would be removed. These issues are very challenging but I believe that often the best way to fight offensive bad speech is with good speech.

I look forward to catching up again soon.

So Zuckerberg still didn’t say he would outright ban “Holocaust denial,” just severely limit its reach on Facebook.

Again, if Zuckerberg would have studied the ADL’s playbook, he’d be aware that even one groveling apology—which he did not perform—would not be enough. The ADL only accepts repeated and total remorseful genuflection from the “offender” to show the world what a horrible mis-

take they made. And although the ADL will appear to accept this last step to contrition, they never fully forgive the transgressor.

“Holocaust denial” will never be allowed a mainstream platform, and certainly not one as large as Facebook, and no doubt, the long hand of the ADL reached out to one of its assets to help nudge Zuckerberg along, or out.

Trillium Asset Management, “the oldest investment advisor exclusively focused on sustainable and responsible investing,” had had enough. The day after Facebook released its “disastrous” quarterly earnings report, Trillium filed a proposal to oust Zuckerberg from Facebook, upset they “are unable to check Zuckerberg’s power given he holds roughly 60% of Facebook’s voting shares as both chair and CEO.”

Although Facebook recorded 1.47 billion “daily active users” around the world and revenue of \$13.23 billion, Wall Street uses “consensus estimates” to either reward or punish companies they wish to control. In Facebook’s case, they beat down the share price, wiping out more than \$150 billion in its market value—its largest one-day decline—and shaving off around \$20 billion of Zuckerberg’s personal wealth, moving him from the fourth richest person in the world to the eighth, in just two hours.

If the past is the predictor of the future—at least where criticism of this sacred cow is concerned—Zuckerberg will either prostrate himself to the ADL and ban “Holocaust denial” on Facebook, or he will assume a less active role in the company he ostensibly founded—or be forced out completely. ★

# Advanced Data Transmission Hazardous to Your Health?

• Caution urged in implementing fifth generation (5G) technology

As ever more sophisticated cellphones and increasingly powerful communication towers are introduced—hurting toward 5G networks—the potential negative health effects on people and animal life simply are not seriously considered, if they're mentioned at all. If there are profits to be made and the people seemingly “consent” by “buying into” such advancements, they're introduced.

5G is defined as the fifth generation of wireless communications, surpassing and replacing the current “4G LTE” system. Expected to be officially launched worldwide around 2020, the four major carriers planning deployments are AT&T, Verizon, Sprint, and T-Mobile. “Vodafone performed the first UK trials in April 2018 using mid-band spectrum, and China Telecom’s initial 5G buildout in 2018 will use mid-band spectrum as well,” the online encyclopedia Wikipedia notes.

Few can deny the benefits to individuals, businesses, and governments stemming from ultra-fast data transmissions, video downloads, and a great environment for super-fast online gaming, among other things.

However, Martin L. Pall, a Washington State University professor emeritus of biochemistry, gave a little-publicized presentation in March 2016

in Stockholm, Sweden where he outlined what appears to be a solid scientific case against humanity getting so easily carried away by the dizzying array of electronic gizmos on the market—which operate via low-intensity microwave electromagnetic fields (EMFs) that he says are far more hazardous than commonly assumed.

The big problem, according to Pall, is that for 47 years, American authorities and the industry have downplayed the risks of such EMFs. A 1971 research report from the Office of Naval Research, said Pall, “listed over 100 different effects from low intensity non-thermal [microwave EMF] exposures.”

Thus, long before today’s world of omnipresent cellphones, smart appliances, smart electrical meters, and various other gadgets arrived, this naval report listed “40 different neuropsychiatric effects, including changes in brain structure and function; eight different endocrine (hormonal) effects, cardiac effects, including inducing arrhythmias that can be life-threatening; chromosome breaks; histological changes in the testes; and cell death, a process documented in neuro-degenerative diseases.”

Pall continued: “So, this was already known in the ‘ancient’ past. There have been dozens of other reviews to the same effect. Among the effects that have been repeatedly documented since 1971 are lower male fertility . . . and also lowered female fertility (less studied). There are also reports of high levels of spontaneous abortion after

exposure. Some of these are animal studies; some are human studies.”

Pall carefully noted that biased industry studies have only expressed reservations about thermal effects—where heat is generated via electromagnetic energy.

“Despite all the evidence for non-thermal [health] effects, our current safety guidelines/standards are all based on the assumption that only thermal effects need be of concern,” Pall explained. He added that, in 2015, “an appeal to the UN and all member states was signed by 206 scientists from 40 countries. The appeal said current safety guidelines and standards were inadequate because they don’t take into consideration non-thermal effects.”

Pall, who outlined the mechanisms in the human body that make it vulnerable to such EMFs, summarized that while his presentation is backed by plenty of evidence, at a bare minimum he can prove “that when industry supporters claim there are no possible mechanisms [affected in the human body], then they’re wrong. And they do make those claims.”

He concluded by noting that “[non-thermal] microwave frequency EMFs attack each of the four things we most value as individuals and as a species: our health, our brain function, the integrity of our genomes, and our ability to produce healthy offspring.”

Some 5G critics, including Mark Steele, a long-time British analyst with a military-technology background, say that 5G technology was developed by the military for weapons and surveillance purposes and then handed down to telecom companies, under which it will usher in a hellish life wrought by hyper-spying, in an environment highly injurious to human health.

Yet others, mainly industry people and government regulators, say 5G critics are way off base and that the best is yet to come in beneficial human communications.

Time will soon tell. Erring on the side of caution before things go any further, however, appears to be the best prescription. ★
