## SOROS WANTS TO PICK SUPREME COURT JUDGES

• Billionaire Bolshevik dumps big bucks into smear campaign

A group called Demand Justice (DJ) has popped up on the scene—armed with oodles of funding derived mostly from internationalist multi-billionaire seditious George Soros. DJ's goal is to taint public discourse and stop Congress from confirming President Donald Trump's latest Supreme Court nominee, Brett Kavanaugh.

Kavanaugh, a well-qualified former D.C. circuit judge, pledged not to legislate from the bench and said he will rule according to an "originalist" interpretation of the Constitution, in keeping with the objective textual meaning established by the nation's framers.

This gives hardened leftists like those in DJ a rather severe case of the ideological jitters, since "progress" from a leftist-progressive viewpoint requires a judiciary that will subjectively read things into the Constitution that simply aren't there. Absent an activist court, some of the left's most sacred cows, such as unfettered access to abortion—especially since confirming Kavanaugh evidently would create the most conservative-leaning Supreme Court in history—would be at risk of being gored.

DJ, organized and financed by a 501(c)(4) named the Sixteen Thirty Fund, was formed this past spring. The Open Society Policy Center (OSPC), one of Soros's primary donation vehicles, contributed about \$2.2 million to the Sixteen Thirty Fund between 2012 and 2016 according to documents posted by "DailyCaller.com." The fund has financial statements on file that show just three contributors accounted for 70%—or about \$11.5 million—of the fund's to-

tal donations and grant revenue. Disclosure forms filed in 2016 present similar facts.

According to the OSPC's tax forms, the Soros group "gave hundreds of thousands of dollars to the [Sixteen Thirty Fund] each year between 2012 and 2016, the last year in which records are publicly accessible. The [OSPC] gave the fund \$350,000 in 2012; \$772,000 in 2013; \$125,000 in 2014; \$550,000 in 2015; and \$481,483 in 2016," the news website "DailyCaller.com" noted.

As if Soros's money isn't enough of a problem, DJ's staffers include alumni from Hillary Clinton's 2016 presidential campaign and from the Obama administration—strongly indicating that the deranged former secretary of state and her former White House boss simply won't accept her 2016 loss and are working through DJ to upset Trump's agenda in the judicial arena. Accordingly, DJ reportedly plans to put \$5 million behind a multi-platform effort to stop Kavanaugh's confirmation. Television ads will promote embattled Democratic Senate incumbents in Indiana, North Dakota, and West Virginia who face competitive Republican challengers this November.

DJ also will run ads in Alaska and Maine, urging GOP Senators Lisa Murkowski and Susan Collins to oppose Kavanaugh, because Collins and Murkowski have parted ways with their party on the Obamacare federal health-insurance repeal as well as federal funding for abortion provider and accused baby-parts peddler Planned Parenthood. The TV spots will "urge the senators to protect abortion access by withholding support for nominees [like Kavanaugh] who oppose the 1973 *Roe v. Wade* decision," "DailyCaller.com" added. ★

## End the Farcical 'Russian Collusion' Witch Hunt, Already

The first real trial of anyone indicted by special counsel Robert Mueller kicked off in early August in Alexandria, Va., and, as we predicted, it was a real circus sideshow. A parade of witnesses were brought forth by Mueller's team, who are seeking to show that former Trump campaign chairman Paul Manafort committed multiple crimes over the years related to his work in Washington. Hundreds of reports have been filed on the case. On the first day, CNN dedicated nearly half of the day to discussing, among other things, what this all means for President Donald Trump. Of course, missed in all of the breathless reporting, however, was that not one of the crimes Manafort is accused of committing relates to the original reason for creating the special prosecutor in the first place: charges that Trump colluded with Russia to win the presidential election.

We have editorialized on this issue many times since the special prosecutor's office was first set up in May 2017. Now, don't get us wrong. Anything that roots out rot and corruption in a cesspool like Washington, D.C. is definitely a good thing, but that's not what is really happening here.

Mueller could have easily pawned off any evidence of Manafort's alleged tax fraud and money laundering to the Justice Department and moved on, but instead he's having his own lawyers keep the heat on Manafort.

That being said, the only reason we can surmise for the continued hammering of Manafort is wishful thinking that the former political operative and lobbyist will eventually sing and reveal some deep, dark secrets about Trump and Russia that the multi-million-dollar investiga-

tion has yet to uncover.

By now everyone has heard that Mueller has indicted 31 people and three companies. There may now be more, but that is all we know as AFP goes to press. What is key here, however, is that out of those 31 individuals, only five are U.S. citizens. The remaining 26 indictments include Russians and one Dutch citizen—none of whom have been accused of working directly with the Trump campaign to benefit his presidential aspirations at the expense of Democrat Hillary Clinton.



Even more important is the fact that none of the indictments of the five Americans allege any collusion between the presidential campaign of Donald Trump and Russia.

Richard Gates, who accepted a plea deal, was only accused of financial crimes that took place while he worked for Manafort as his business partner, which was long before the two worked for Trump.

One man who has not been mentioned much by the mainstream media is Richard Pinedo, a Californian, who also copped a plea deal for crimes related to a shady website he ran that allowed people's bank account information to be bought and sold. It has been alleged that Pinedo's site was exploited by Russian spies,

who were purportedly meddling in the U.S. election, but how this relates to the Trump campaign is beyond us.

AFP has written about Army Gen. Michael Flynn and his takedown by the Deep State many times before. Flynn pled guilty to lying to the FBI about discussions he'd had with the Russian ambassador—but those talks took place in late December 2016, more than a month after Trump had won the Nov. 8 election, something the mainstream media never bothers to mention.

Finally—even if you allow that former Trump campaign aide George Papadopoulos met with a Russian spy to boost the Trump campaign—it looks more and more that Papadopoulos's meetings went nowhere and any evidence he provided as a result of his plea deal has led to no new indictments of Americans.

So if none of the individuals—not even the Russians—who have been targeted by Mueller has anything to do with Russian collusion, what is really going on in Washington today?

We can only guess that the ultimate goal of the Mueller probe has always been to hamstring Trump, discredit him in the eyes of the American people, and undermine anything he wants to do, up to and including any attempts he makes to foster peace with Russia. It's been a year and a half since Mueller was given free rein to subvert the president. It's long past time to end the witch hunt. ★

# News You May Have Missed

## Sad State of Affairs

According to the Freedom Forum Institute's annual "State of the First Amendment" (SOFA) survey, only one out of 1,000 people polled last May and June was able to name all five First Amendment rights. Incredibly, 40% of respondents couldn't even name one. Among those who could name one or a few, the right to freedom of speech was the most commonly remembered, with 56% of respondents being able to list it. As far as the others were concerned, just 15% of respondents named freedom of religion, 13% named freedom of the press, 12% named freedom of peaceful assembly, and only 2% named the freedom to petition the government.

## Guns for Elites

Everyone in the U.S. knows by now how much anti-gun protester David Hogg hates guns, but, according to the National Rifle Association (NRA), he doesn't hate them enough to not be protected by them. Hogg, who rose to fame following the mass shooting at his high school in Florida, together with a group of anti-Second Amendment demonstrators protested outside the NRA headquarters recently. NRA supporters, who were there, took photos of Hogg waving anti-firearms posters, and, ironically, the pictures clearly show armed guards surrounding the young man. Hogg later unwittingly posted a photo to the Internet showing even more armed security protecting him. Other armed police officers were seen standing in a parking lot, ready to protect the teen with more guns.

## Hypocritical Censorship

Social media giant Twitter recently suspended conservative black commentator Candace Owens for satirizing *New York Times* editorial board member Sarah Jeong's anti-white tweets. In her own posts, Owens sent out a pair of tweets paraphrasing Jeong but instead swapped out the word "white" with "Jewish" and "black." Ms. Owens responded to the online censorship, saying, "I wouldn't have minded if I was locked out, because I actually agree with Twitter that that language is inappropriate. My point in tweeting that and replacing the word with black and Jewish yesterday was to show how different that mentality is when you see it in that context and you see talking about Jewish people and predisposed to burning under the sun or black people saying they should live underground. It's horrifically racist, but somehow we've gotten to a point in society where it's OK to say the exact same thing about white people, and that's problematic." A few days later, Twitter restored Ms. Owens's account access following a backlash, claiming the suspension was an "error."

## Fake Climate News

*National Geographic* finally admitted to facilitating "fake news" when it comes to "climate change." The magazine's most popular video ever, which showed heart-wrenching images of a starving, dying polar bear, perpetuated the narrative that the animal's imminent death was due to climate change, but the problem is, conceded the magazine, there was no evidence to show climate change was behind the bear's condition. In reality, the bear was dying most likely due to old age or sickness. "We had lost control of the narrative," admitted Cristina Mittermeier, the photographer of the polar bear. Mittermeier admitted she deceived everyone in a piece that was published recently by *National Geographic* titled "Starving-Polar-Bear Photographer Recalls What Went Wrong" for the magazine's August issue.

## Mountains of Trash

Mountains of trash have been piling up at U.S. recycling centers after China stopped accepting materials from the United States. In the past few years, U.S. recyclers have been selling recyclable materials to China for pennies. The waste was loaded onto ships and then processed in Chinese cities. Much of the materials wound up in garbage

dumps in China, but some of it was recycled. Now, one of the ways China is getting back at the U.S. for slapping tariffs on cheap Chinese products is by rejecting U.S. trash. It is a problem that could be easily solved by Americans if they simply reduced their trash and ended our disposable society. It might also be time to return to paper bags at grocery and other stores instead of plastic bags.

## Human IQs Dropping Rapidly

Science is confirming something that, deep down, we all know to be true: People really are dumber today than they were in the past. A new study, published recently by Norwegian researchers, analyzed IQ scores between 1962 and 1991 and found

that scores increased by almost 3 percentage points each decade for those born between 1962 to 1975, but there has been a steady decline among those born after 1975. The initial rise was attributed to the so-called "Flynn effect," a term for the bump in intelligence levels that occurred during the 20th century, most likely the result of better access to education. Scientists are still unsure why the decline is taking place, but they speculate that it is being caused by changes in the education system, media, nutrition, reading less, and being online more, as well as better standards of living.

## Legal Theft

The South African government, led by President Cyril Ramaphosa from the African National Congress (ANC), wants to let the country steal land from white farmers and hand it to black owners without compensation—whether the blacks know how to run a farm or not. According to reports, the ANC has already targeted 139 farms that they plan to expropriate in the coming weeks, as part of the enactment of new language added to the country's constitution. AFP urges the U.S. State Department to fast-track asylum requests for white South Africans. So far, only Australia and Russia seem interested in helping the white people of South Africa—who are slowly but surely being genocided—escape this modern-day extinction.

## We Don't Want Him Here

U.S. officials with the Department of Homeland Security and Immigration and Customs Enforcement have been pushing back against claims that they are thugs who threaten and brutalize illegal immigrants when they try to sneak into the U.S. For instance, in a press release earlier this month, U.S. agents say they filed rape charges against Ramon Pedro after he and a young girl were stopped while attempting to enter the U.S. last April. The two had been processed and then hospitalized with free healthcare for tuberculosis. Last month, however, U.S. authorities discovered the girl was not only not related to Pedro but was being sexually abused by him. The girl's mother had reportedly given the girl to Pedro to bring to the United States where she was told he would find her a job. "On July 27, the Huron Police Department arrested him for multiple felony offenses for rape, oral copulation, forcible sexual penetration, and endangering/causing injury to a child," an official told reporters. "He is currently detained in Fresno County Jail on a \$310,000 bond."

# The Dems' Tyrannical Plan to 'Cleanse' The Internet

- Tech companies will be forced to ban dissident thoughts

Senate Democrats have outlined a tyrannical plan for combating so-called fake news and purported “foreign meddling” in America’s electoral process in a recently circulated memo calling for tougher regulation of the tech industry.

Sen. Mark Warner (Va.), a top Democrat on the Senate Intelligence Committee, released a memo that was recently obtained by “Axios,” a media outlet founded by a group of reporters formerly connected to Washington daily newspaper *Politico*, which offered recommendations to the government for combating disinformation, fake news, and other supposed problems posed by the rise of social media and large tech companies.

The white paper, entitled “Potential Policy Proposals for Regulation of Social Media and Technology Firms,” recommends that large social media platforms introduce mandatory location and identity verification tools which require users to authenticate their geographical origin and identity.

The paper also recommends that media platforms be held legally liable for “defamation, invasion of privacy, false light, and public disclosure of private facts” on their platform.

“The size and reach of these platforms demand that we ensure proper oversight, transparency and effective management of technologies that in large measure undergird our social lives, our economy, and our politics,” the paper

argues. “The hope is that the ideas enclosed here stir the pot and spark a wider discussion—among policymakers, stakeholders, and civil society groups—on the appropriate trajectory of technology policy in the coming years.”

The release of the controversial memo comes as a number of conservative and independent media outlets face increasing levels of censorship by some of the largest tech companies operating today. AMERICAN FREE PRESS has certainly taken repeated hits from tech companies as well as banking giants going after AFP’s sales on the Internet. Many extreme right-wing websites, such as the “Daily Stormer,” as well as leading figures in the alt-right movement, such as Richard Spencer, have felt the tyrannical effects of online censorship and de-platforming.

Now, under pressure from a variety of subversive lobbying organizations, left-wing agitators, and even large corporations, some of the world’s leading tech firms and social media platforms have outright censored Alex Jones and his popular “InfoWars” media outlet.

Earlier this week, YouTube, Facebook, and Apple announced they were removing content related to Alex Jones and “InfoWars” from their platforms for so-called “hate speech” and other alleged violations of the platforms’ terms of service.

Additionally, libertarian and anti-war activists, including Scott Horton, the editorial director of “AntiWar.com,” and Daniel McAdams, the director of the Ron Paul Institute, had their Twitter accounts suspended.

Critics argue that tech giants have unfairly

targeted conservatives and other right-leaning commentators and independent media outlets, though some left-wing groups and individuals have been hit hard as well.

In a powerful op-ed published by Fox News, Nigel Farage argued that the recent censorship of Jones “represents a concerted effort of prescription and censorship that could just as soon see any of us confined to the dustbin of social media history.”

“These platforms that claim to be ‘open’ and in favor of ‘free speech’ are now routinely targeting—whether by human intervention or not—the views and expressions of conservatives and anti-globalists,” the former British politician and leader of the UK Independence Party argued.

Meanwhile, *The New York Times* reaffirmed its support for a newly hired editorial board member with a long history of extreme anti-white statements posted to the Internet, which were recently exposed by social media users following the announcement of her hiring. Sarah Jeong, a technology reporter, was recently promoted to the *Times*’s editorial board. Her ugly social media posts, which denigrated and targeted white people specifically, are apparently acceptable to not only her employer but also the very same social media platforms shutting down and censoring conservatives for alleged “hate speech.”

Many have called on President Trump to act to ensure large social media outlets do not unfairly target their political opponents, which is clearly the intention of many of these companies. ★

# Americans Live in a World of Lies

• Government and media spin a web of fiction from economy to Russian collusion

**T**he U.S. government and the pressitutes that serve it continue to lie to us about everything. Recently, the Bureau of Labor Statistics (BLS) told us that the unemployment rate was 3.9%. How can this be when the BLS also reports that the labor force participation rate has declined for a decade throughout the length of the alleged economic recovery and there is no upward pressure on wages from full employment? When jobs are plentiful, people enter the labor force to take advantage of the work opportunities. This raises the labor force participation rate. When employment is full—which is what a 3.9% unemployment rate means—wages are bid up as employers compete for scarce labor. Full employment with no wage pressure and no rise in the labor force participation rate is impossible.

The 3.9% unemployment rate is not due to employment. It results from not counting discouraged workers who have ceased to search for jobs because there are no jobs to be had. If an unemployed person is not actively searching for a job, he is not counted as being in the labor force. The way the unemployment rate is measured makes it a hoax.

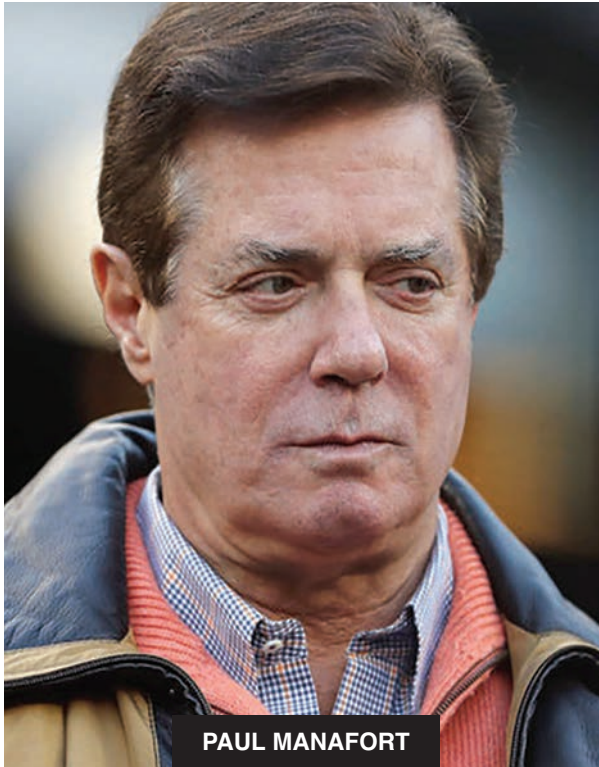
[According to the BLS, the broadest measure of the unemployment rate, U6, which tabulates people marginally attached to the workforce to include part-time workers and people actively seeking jobs, stands at 7.9%—Ed.]

The government tells us that there is essentially no inflation despite the fact that prices have been rising strongly—the price of food, the price of home repairs, the price of drugs, the price of almost everything. Two years ago, the American Association of Retired People's Public Policy Institute reported that the average retail drug price has been increasing "at a worrying pace of 10% a year, and about 20 drugs have astoundingly had their prices quadruple since just December. Sixty drugs doubled over the same period. Turing Pharmaceuticals is one of the most pronounced examples of this kind of behavior. The company

given away to China and other Asian countries where labor costs are low. The U.S. global corporations make higher profits by shrinking the U.S. tax base. Neoliberal economists defend this absurdity as "free trade" that benefits Americans.

The millions of Americans whose jobs were given away to foreigners know that they have not benefited. They know the story told by neoliberal economists and financial pressitutes is a lie.

The lies, of course, go far beyond the economic ones. Russiagate, which has dominated the print and TV media since the last presidential campaign, is a massive lie that continues day after day. On Aug. 3 the NPR pressitutes, for example, were smacking their lips over the prospect that former Trump campaign aide Paul Manafort was on trial and might give special Russiagate prosecutor Robert Mueller a conviction that could lead to Trump's removal from the White House. The pressitutes speculated that a convicted Manafort would tell on Trump in exchange for a lighter sentence.

The NPR pressitutes did not reveal that Manafort was not on trial for anything related in any way to Russiagate. Manafort is being tried on income tax evasion charges dating from a decade ago when he was a consultant to Ukrainian politicians. There is no doubt but that these are false charges whose purpose is to coerce Manafort into protecting himself by making false charges against Trump. If Manafort is convicted it will not be on the basis of any evidence. Manafort will be convicted by the pressitute media which will convince jurors that Manafort is "one of those rich who don't pay taxes."

That Trump permits this witch hunt to continue—a witch hunt that far oversteps Mueller's Russiagate mandate for which not a shred of evidence has been found—shows how the pressitutes working hand-in-hand with the military-security complex and Democratic National Committee have disempowered the president of the United States. While Americans sit there sucking their thumbs, the coup against the president proceeds before their eyes. ★

bought a lifesaving cancer medication only to increase its price from \$13.50 to \$750 per pill."

Incomes, of course, have not doubled. In real terms incomes have declined. Moreover, expenditures on medicines are a huge percentage of the budgets of the elderly and those on Medicare. According to the Kaiser Family Foundation, the average annual cost of prescription medicines for the elderly accounts for three-fourths of the average Social Security pension and for about half of the median income of people who receive Medicare benefits.

Real jobs have also declined. The jobs that the financial pressitutes report to be unfilled are not jobs that provide a living. The BLS reported that the number of Americans working multiple jobs rose in July by 453,000, bringing the number of Americans who hold multiple part-time jobs to just over 8 million.

Looking at July's payroll jobs report again we see the Third World complexion of the U.S. work force. The alleged new jobs are concentrated in lowly paid domestic services: temporary help services, healthcare and social assistance, waitresses, and bartenders.

There is scant sign of a vibrant economy, but high debt is everywhere. Debt is growing faster than the income needed to support it. The U.S. government is on course for another \$1 trillion annual budget deficit. The federal, state, and local tax base has been devastated by the global corporations' export of high-productivity, high-value-added manufacturing and professional skill jobs. In the name of "free trade" the tax base for Social Security, Medicare, and public pensions has been

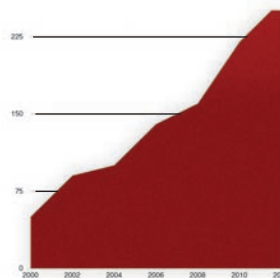

# Russian Witch Hunt Never Ends

• What mainstream is saying about “Russian spy” Maria Butina is fake news

I am somewhat perplexed about the furor over alleged “Russian spy” Maria Butina, a 29-year-old Russian woman currently living in Washington, who was arrested three weeks ago and charged with conspiracy in acting as an agent of the Russian government tasked with developing ties with American citizens and infiltrating certain political groups. She is reportedly being held in solitary confinement and not allowed bail as she is considered a “flight risk.”

Miss Butina, a student at American University and a co-founder of the pro-gun rights Russian advocacy organization Right to Bear Arms, is charged with operating under the direction of Alexander Torshin, a high-level official reportedly close to President Vladimir Putin who currently works for the Russian Central Bank. According to the Justice Department, Torshin was recently sanctioned by the U.S. Treasury’s Office of Foreign Assets Control over information provided by the Spanish government indicating that he has been involved in the past in money laundering, a charge which he denies.

It is important to note that Torshin is not an intelligence officer. Nor has he ever been accused of spying. He is a banker and so-called oligarch, admittedly with powerful political friends in Russia. And Miss Butina was not acting as a spy nor as an intelligence officer seeking to obtain classified information or develop potential agents in the United States. She operated completely openly to cultivate relationships in her areas of interest and was not engaged in espionage in any traditional sense. She did not communicate secretly with Moscow, which is why the FBI was able to obtain her emails that it considers to be suspicious.

Miss Butina was not actually charged with trying to recruit American citizens to act covertly on behalf of Russia or to promote Moscow’s international agenda, whatever that might be, though there was considerable innuendo in the court documents suggesting just that. She was caught sending emails, attending classes at college, and arguing to defend her homeland. And, most of all, she was networking, which is completely legal even here in the post 9/11 United States, where basic rights have been vanishing on an almost daily basis. One might even describe her as a bit of a “hustler,” that old fashioned expression for an opportunist working the circuit of the rich and powerful. When the 2016 election results came in, she exuberantly posted a message about the Trump victory on a Russian social media site saying, “A supporter of the rights to arms and the restoration of relations with Russia. Congratulate [sic] everyone!”

Miss Butina, suspected of serving as a directed agent of the Russian government acting through Torshin, allegedly was attempting to create relationships

with right-wing elements in the U.S. She has actually only been charged with conspiracy relating to her claimed relationship with Torshin and failure to register as a foreign agent. Registration for individuals or groups acting on behalf of a foreign government is required under the Foreign Agents Registration Act of 1938 (FARA). The FBI apparently has obtained her emails suggesting that she was taking direction from Torshin to do certain things that would enhance her profile with the National Rifle Association (NRA) and other conservative groups that were allegedly being targeted.

It is highly unusual to arrest anyone for violation of FARA, suggesting that the authorities are seeking to pressure Miss Butina into revealing additional information that will ultimately demonstrate a grand Russian plot to infiltrate American institutions. The normal penalty being required under FARA is for that group or individual to register, sometimes after payment of a fine. Russian government media outlets “RT America” and “Sputnik News” were recently required to register, and did so, to comply with Treasury Department demands. Meanwhile, ex-congressmen who go on to serve as agents of foreign governments as lobbyists have been known to violate FARA and not one of them has ever been arrested and jailed.

In any event, it would be difficult to imagine why anyone would consider the NRA to be a legitimate intelligence target. It only flexes its admittedly powerful legislative muscles over issues relating to gun ownership, not regarding policy on Russia. And as for the Russian equivalent, the Right to Bear Arms, I can personally testify that the group appears to be

completely legitimate. I was in Moscow in December 2015 speaking at a conference and noted the organization’s gathering at a hotel for its own annual meeting. I might have even met Miss Butina and Torshin at that time after I wandered in and spoke with a number of members, all of whom appeared to be personally engaged and completely legitimate, well able to explain the virtues of gun ownership in Russia. Guns, including Kalashnikov assault rifles, were on sale at the event. Russia does, in fact, have nearly 7 million registered gun owners. The process of obtaining a license is onerous, but it can be done and Right to Bear Arms is dedicated to making the registration easier and guns more accessible.

In short, Miss Butina and by extension Torshin have done nothing wrong. Both are energetic advocates for their country and gun rights, which they appear to believe in, and Miss Butina has broken no law except not registering, which in itself assumes that she is a Russian government agent, something that has not been demonstrated. To put the shoe on the other foot, will every American who now travels to Russia and engages in political conversations with local people be suspected of acting as an agent of the U.S. government? Once you open the door, it swings both ways.

As always, the hypocrisy in the U.S. case, which might reasonably be viewed as part of the current hysteria about Russia, is manifest. The nation of Israel has literally hundreds of paid lobbyists swarming all over Capitol Hill pushing hard on issues being promoted by the government of Prime Minister Benjamin Netanyahu. Many of the objectives of the lobbying are damaging to the United States, to include advocating a war with Iran, but not a single one of those lobbyists or the Jewish groups they represent has ever been required to register with FARA. But if you are a Russian and you are caught talking to anyone in any way influential, there is apparently hell to pay. You are automatically assumed to be part of a conspiracy. The irony is, of course, that the Israelis and their American enablers really are part of a conspiracy to subvert America’s government and institutions and they get away with it while the Russian agenda, if there is one, remains to be proven. ★

# Nunes: Ban Electronic Voting

• House member says current vote-count systems unreliable

At least one member of Congress, and some conventional media, including the *Chicago Sun-Times* and *The Hill*, have suddenly stumbled upon the issue of the untrustworthiness of electronic voting machines largely due to accusations of Russian meddling. AFP has been exposing this issue for two decades while covering key activists laboring to return accuracy and integrity to U.S. elections. Today, these machines are provided to about 96% of the nation's approximately 200,000 voting precincts, mainly by the “big three” private vendors: ES&S, Hart InterCivic, and Dominion.

House Intelligence Committee Chairman Devin Nunes (R-Calif.), to his credit, recently “called for a ban on electronic voting systems,” according to *The Hill*, a Washington, D.C.-based newspaper.

“The one thing we’ve been warning about for many, many years on the intelligence committee is about the electronic voting systems,” Nunes told host Buck Sexton during an interview in late July on Hill TV’s “Rising” program. However, since most intelligence committee meetings are closed, little if anything has been stated publicly about electronic-voting doubts—until now.

Referring to such voting systems, Nunes went so far as to say: “Those are really dangerous in my opinion and should not be used . . . and we need a paper trail so that you can go back in case

you have to do a manual recount.”

But while Nunes spoke some sense, *The Hill* veered off into the usual mainstream-media “muck” by saying that the only reason to question electronic voting is Russian “meddling” in the 2016 U.S. elections—referring to Department of Homeland Security (DHS) allegations that “Russia had ‘successfully penetrated’ the voter rolls in a small number of states in 2016.” The DHS also warned California and 21 other states “that Russia attempted to breach their systems.”

“They need to define what they mean by ‘meddling,’” responded longtime honest-vote activist Jim Condit, who helped the Collier brothers research their groundbreaking 1992 book *Votescam: The Stealing of America*.

“The establishment doesn’t want people knowing that anybody can change the actual vote count, so they have to say that the vote count is ‘safe’ and use words like ‘meddling,’” added Condit. His research with the Colliers and subsequent work taught him, “If a Sherlock Holmes or a Columbo were investigating election fraud, the ‘big three’ companies should top the list of things to investigate.”

Condit continued: “But the bottom line is that the machine companies all demand that county election officials [regardless of party] sign a contract that they will not be allowed to look at the software. Apparently, it’s universal that no one can come in and inspect the source code.”

Thus, Condit suggested that all elections, especially this year’s mid-term congressional races projected as “close calls,” should be analyzed for signs of election fraud. The suspected strategy is to give close-call elections to anti-Trump

candidates, especially in states and districts won by Trump in 2016, so that corrupt party hacks and their corporate media allies can label Trump as a liability and pack a new Congress that can impeach him.

Vickie Karp of Vote Rescue, a Texas activist group seeking a return to paper ballots, sees plenty of irony.

“It’s only because so many people hate Trump that some in the country believe electronic voting can’t be good since Trump got elected,” she told AFP. “I’ve been kind of amused at the turn of events with this Russian plot. If we just used paper ballots and counted the votes on election day in front of the people at the precinct level, to preserve the custody chain, we’d finally find out who our real leaders are.” ★

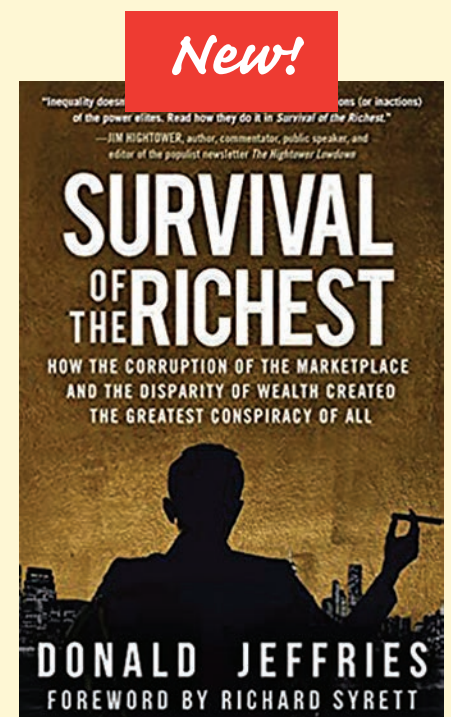

# Texas Wants Honest Voting System

• Lone Star State Republicans support verifiable voting backed with paper ballots

A letter signed by 110 conservative coalition leaders in favor of Texas voters having the option of using verifiable paper ballots as a back-up measure to supplement electronic voting, or using them directly without machines, enabled honest-election activist Dr. Laura Pressley to persuade the Republican Party of Texas Platform Committee to adopt a pro-paper ballot plank during the recent Texas Republican State Convention.

The Republican Party embracing verifiable voting follows on the heels of Dr. Pressley's ongoing, potentially landmark lawsuit, which is pending before the Texas Supreme Court. It would require the Lone Star State to abandon what she argues are its unaccountable and illegal election practices and follow its own election code and the state constitution.

Having noticed irregularities in 2014 when she sought to verify the results of her "loss" as a candidate in an Austin City Council race, Dr. Pressley adopted the credo "trust, but verify" and studied the Texas Election Code. She found that, contrary to the law, "there were no legal ballots for a recount, and no results tapes to document and verify what the results were."

A Harris County cabal in the greater Houston area sent representatives to the state GOP convention to try and block all paper-ballot platform proposals. Once a state as populous as Texas opts for paper ballots, the shift could potentially go nationwide, which could spell trouble for electronic voting machine vendors whose contraptions are used in over 90% of U.S. voting precincts, with lucrative contracts at stake.

The officials at the convention, who've been on a mission to stamp out all paper-ballot options across Texas—evidently to protect their sole electronic voting machine vendor, Hart InterCivic,

whose machines lack a paper back-up option—including Harris County Clerk Stan Stanart. Interestingly, while the Platform Committee was chaired by Mark Ramsey (a member of Harris County's State Republican Executive Committee opposed to paper ballots) Stanart testified to the very same committee before Dr. Pressley did.

Asked what happened to get the platform committee to resist the Harris County group and adopt the pro-paper ballot plank, Dr. Pressley replied, "Because we had such strong testimony and pres-

sure from the grassroots, they retreated and removed their own suggested planks against paper ballots. State Sen. Bob Hall is credited with taking the Harris cabal to the woodshed. We saved Texas at that convention."

Dr. Pressley, who holds a Ph.D. in physical chemistry from the University of Texas at Austin and holds four U.S. patents in semiconductor device technology, explained: "The Hart InterCivic voting system uses phone modems. The memory cards (an electronic ballot box) are taken from individual voting machines to a substation in order to modem the results to the 'central accumulator tally computer' as is done in large counties. Smaller counties physically take the cards to the central computer. My requests to Harris County for original audit logs [from Hart machines] have been denied so far. I may have to take the matter to the attorney general."

The plank's essential points are as follows:

We support modifications to and the strengthening of election laws to ensure ballot integrity and fair elections. We support the Secretary of State strictly enforcing printing of results tapes for electronic voting for early voting and election day at polling locations after the polls close for all counties. We support increased scrutiny and security in balloting by mail; prohibition of Internet voting and any electronic voting lacking a verifiable paper trail. . . . prosecution for election fraud with jail sentences. . . . We support all means of protecting the integrity of our elections, including the optional use of paper ballots. ★

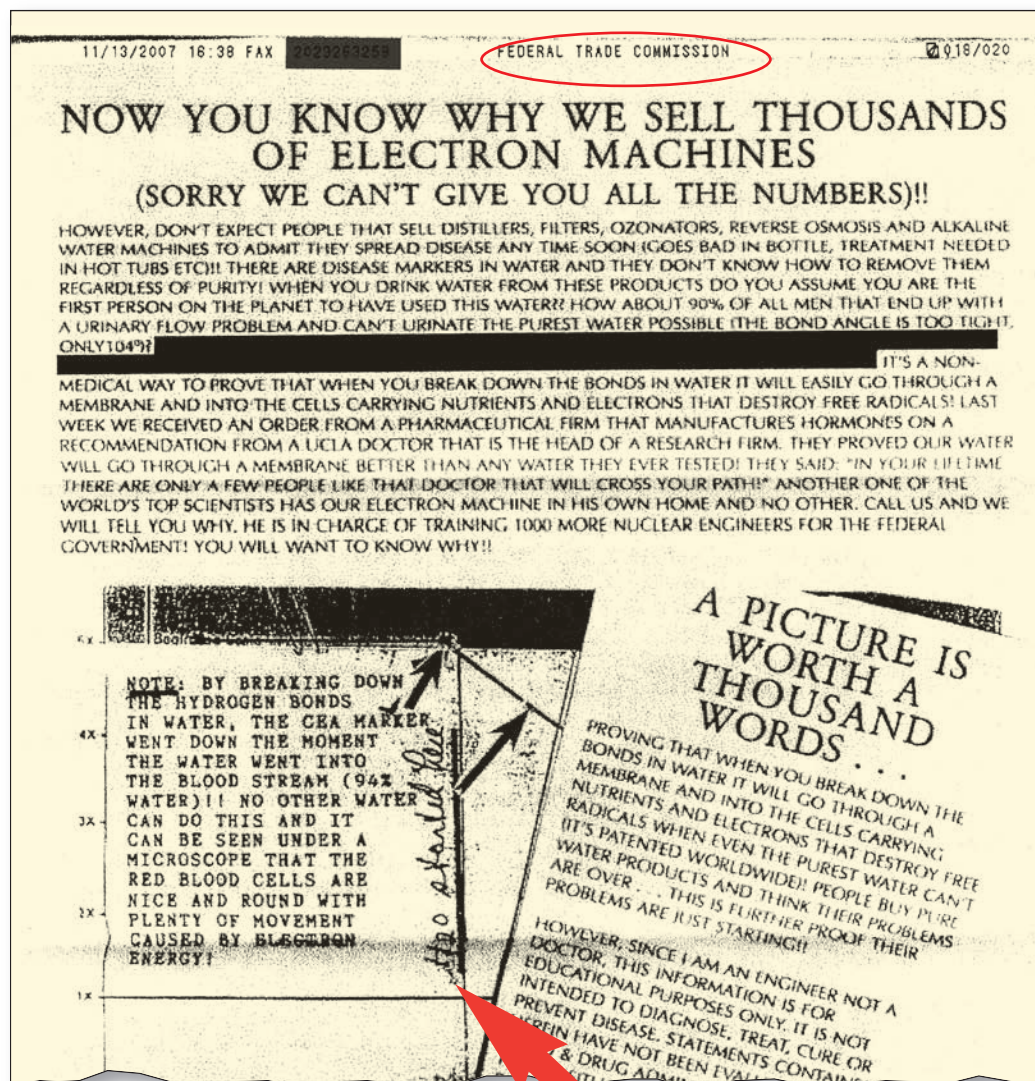

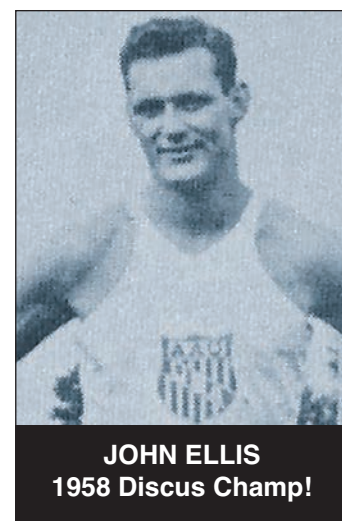

cluding one of the ambulances my grandmother donated (before we entered WWII), encouraged by her friend CARRIE CHAPMAN CATT, who moved around the corner from her in New Rochelle.

As a youngster, I remember all the sewing machines and their many friends at my grandmother’s house sewing thousands of pre-die cut clothes together to keep children warm during the brutally cold English winters. Carrie is most famous for her speech before Congress that resulted in the 19th Amendment to the Constitu-

# Majority of Business Owners Support Increased Tariffs

- Financial poll shows support for Trump's financial policies

While the mainstream media continue to wail about how President Donald Trump's application of tariffs on imports will only incite "trade wars" and could not possibly generate even a single shipping crate's worth of benefits, an early-August UBS Investor Watch poll says otherwise.

According to the poll, 71% of business owners, from both small and large companies, support levying additional tariffs on Chinese goods. In addition, more than 70% of business owners have a positive one-year outlook on the state of the economy.

As for the poll's rating of the president, 55% of business owners feel the administration has had a positive impact on their business overall, with 20% reporting a negative impact.

And though you'd never know it by perusing the pulp of *The New York Times* or *The Washington Post*:

- 64% of those polled want more tariffs on European goods.
- 66% support more tariffs on imports from Mexico.
- 60% would like to see additional tariffs on Canadian goods.
- Among high net-worth investors, 59% support more tariffs on Chinese goods.

"China is the top concern when it comes to U.S. trading partners, with 88% of business owners [polled] claiming they believe China engages in unfair trade practices with the U.S.," the "Daily Caller" website, a conservative news outfit, noted on Aug. 2. "Trump has taken a great deal of criticism from

lawmakers on both sides of the aisle, who believe his trade policies are protectionist and will hurt long-run economic growth."

That's accurate enough, though "unfair trade practices" falls far short of describing the huge trade surplus China enjoys at America's expense—a deficit on the U.S. side of the ledger that was \$375.2 billion in 2017 alone, up from \$347 billion in 2016. It could be argued that the tariffs on Chinese goods simply represent "payback time," given the decades of growing trade deficits, widespread industrial-production losses and plummeting consumer purchasing power the U.S. has been forced to endure under "free trade" agreements written well outside of public view.

When it comes to lawmakers and free trade, partisanship suddenly becomes muted and legislators who can barely agree that water is wet suddenly march in lockstep, screaming about how protectionism should be forbidden, just as tariffs should be forbidden. Why? Because both concepts adversely impact the ruling internationalist establishment—collusive central banks, investment banks, certain law firms and insurance interests, influential tax-exempt think tanks and arm-twisting lobbying firms, the Bilderberg and Trilateral Commission groupings etc.—to which many members of Congress are beholden.

The institutional bias runs deep. This writer recalls in 2011 covering a meeting of the World Bank and International Monetary Fund in Washington. There, a *Wall Street Journal* reporter hanging around in a food court warned me that using the words "tariff" and "protectionism" too often, or discussing them conceptually and objectively, much less advocating them, was largely taboo within the gilded walls of those institutions.

Since the media is a tool of the trans-nationalist elite who run the above-noted interlocking interests, Americans are hard pressed to get a clear and complete explanation not just about the degree of support for Trump's tariffs, but also about

tariffs themselves.

Tariffs, it is said, raise prices, but so do domestic income and property taxes as tax-related costs are passed off to the end consumer. Better to raise taxes at the water's edge and make corporations who sought cheap labor overseas pay for the privilege of selling their goods in the U.S. market. This arrangement, by limiting the sale of imports via import taxes [tariffs], has the added benefit of protecting domestic investments and production within the U.S. That, in turn, fosters a more nationalistic economic outlook, meaning that protectionism deflates the plutocratic, internationalist system. Hence the reason that "protectionism" and "tariffs" are rated as dirty words whenever they're advocated. ★

# Was it Tariffs That Made America Great?

- First major bill ever passed by U.S. Congress was the Tariff Act of 1789

“**M**ake America Great Again!” will, given the astonishing victory it produced for Donald Trump, be recorded among the most successful slogans in political history. Yet it raises a question: How did America first become the world’s greatest economic power?

In 1998, in *The Great Betrayal: How American Sovereignty and Social Justice Are Being Sacrificed to the Gods of the Global Economy*, this writer sought to explain.

However, as the blazing issue of that day was Monica Lewinsky and Bill Clinton, it was no easy task to steer interviewers around to the McKinley tariff.

Free trade propaganda aside, what is the historical truth?

As our Revolution was about political independence, the first words and acts of our constitutional republic were about ensuring America’s economic independence.

“A free people should promote such manufactures as tend to render them independent on others for essentials, especially military supplies,” said President Washington in his first message to Congress.

The first major bill passed by Congress was the Tariff Act of 1789.

Weeks later, Washington imposed tonnage taxes on all foreign shipping. The U.S. Merchant Marine was born.

In 1791, Treasury Secretary Alexander Hamilton wrote in his famous “Report on Manufactures”:

“The wealth . . . independence, and security of a country, appear to be materially connected with the prosperity of manufactures. Every nation . . . ought to endeavor to possess within itself all the essentials of national supply. These compromise the means of subsistence, habitation, clothing, and defense.”

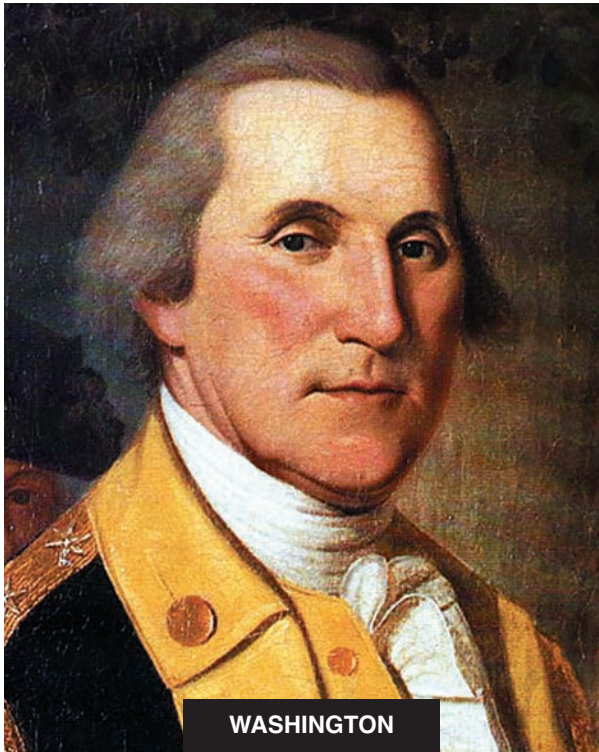
During the War of 1812, British merchants lost their American markets. When peace came, flotillas of British ships arrived at U.S. ports to dump underpriced goods and to recapture the markets the Brits had lost.

Henry Clay and John Calhoun backed James Madison’s Tariff of 1816, as did ex-free traders Jefferson and John Adams. It worked.

In 1816, the U.S. produced 840,000 yards of cloth. By 1820, it was 13,874,000 yards. America had become self-sufficient.

Financing “internal improvements” with tariffs on foreign goods would become known abroad as “The American System.”

Said Daniel Webster, “Protection of our own labor against the cheaper, ill-paid, half-fed, and pau-

per labor of Europe, is . . . a duty which the country owes to its own citizens.”

This is economic patriotism, a conservatism of the heart. Globalists, cosmopolites, and one-worlders recoil at phrases like “America First.”

Campaigning for Henry Clay, “The Father of the American System,” in 1844, Abe Lincoln issued an impassioned plea, “Give us a protective tariff and we will have the greatest nation on Earth.”

Battling free trade in the Polk presidency, Congressman Lincoln said, “Abandonment of the protective policy by the American government must result in the increase of both useless labor and idleness and . . . must produce want and ruin among our people.”

In our time, the abandonment of economic patriotism produced in Middle America what Lincoln predicted, and what got Trump elected.

From the Civil War to the 20th century, U.S. economic policy was grounded in the Morrill Tariffs, named for Vermont Congressman and Senator Justin Morrill who, as early as 1857, had declared, “I am for ruling America for the benefit, first, of Americans, and, for the ‘rest of mankind’ afterwards.”

To Morrill, free trade was treason: “Free trade abjures patriotism and boasts of cosmopolitanism. It regards the labor of our own people with no more favor than that of the barbarian on the Danube or the coolie on the Ganges.”

Throughout American history, tariffs have helped fund infrastructure projects.

William McKinley, the veteran of Antietam who gave his name to the McKinley tariff, declared, four years before being elected president: “Free trade results in our giving our money . . . our manufactures and our markets to other nations. . . . It will bring widespread discontent. It will revolutionize our values.”

Campaigning in 1892, McKinley said, “Open competition between high-paid American labor and poorly paid European labor will either drive out of existence American industry or lower American wages.”

Substitute “Asian labor” for “European labor” and is this not a fair description of what free trade did to U.S. manufacturing these last 25 years? Some \$12 trillion in trade deficits, arrested wages for our workers, 6 million manufacturing jobs lost, 55,000 factories and plants shut down.

McKinley’s future vice president, Teddy Roosevelt, agreed with him, “Thank God I am not a free trader.”

What did the protectionists produce?

From 1869 to 1900, GDP quadrupled. Budget surpluses were run for 27 straight years. The U.S. debt was cut two-thirds to 7% of GDP. Commodity prices fell 58%. U.S. population doubled, but real wages rose 53%. Economic growth averaged 4% a year.

And the United States, which began this era with half of Britain’s production, ended it with twice Britain’s production.

Under Warren Harding, Cal Coolidge, and the Fordney-McCumber tariff, GDP growth from 1922 to 1927 hit 7%, an all-time record.

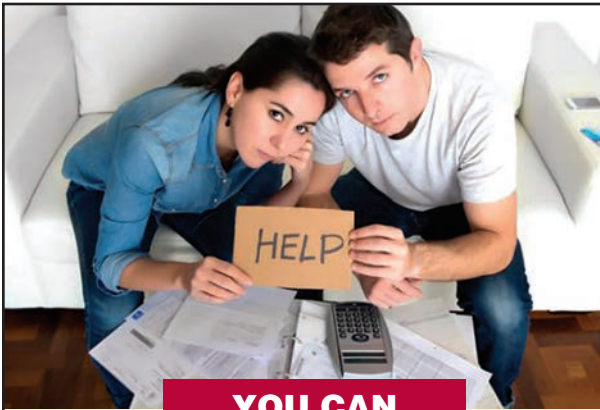
Economic patriotism put America first, and made America first.

Of GOP free traders, the steel magnate Joseph Wharton, whose name graces the college Trump attended, said it well: “Republicans who are shaky on protection are shaky all over.” ★

# Presidential Rape Allegations

- Media cares only about abuse of women if there's a buck in it for them

In the wake of sexual harassment claims that rocked major U.S. industries including Hollywood and the mainstream media—colloquially known today as the #MeToo movement—it is interesting to consider how many U.S. presidents have been accused of literal rape over the years.

In 1873, for example, Maria Halpin accused President Grover Cleveland of sexually assaulting her on the evening of Dec. 15 that year. In her affidavit, Halpin alleged that Cleveland sexually assaulted her “by use of force and violence and without my consent.” Halpin added that Cleveland “told me he was determined to ruin me if it cost him \$10,000, if he was hanged by the neck for it. I then and there told him that I never wanted to see him again [and] commanded him to leave my room, which he did.”

Ms. Halpin became pregnant as a result of the assault, and the boy she gave birth to became the basis of the campaign slogan, “Ma, Ma, Where’s my Pa?” Cleveland and his powerful associates smeared Ms. Halpin as promiscuous and a drunk. She was later thrown into the Providence Lunatic Asylum, and the child was taken from her and sent to an orphanage in Buffalo. Ms. Halpin died at age 66 in 1902, with \$200 to her name, irreparably scandalized and wronged.

In Kitty Kelly’s 1991 book *Nancy Reagan: The Unauthorized Biography*, she reported the allegations of actress Selene Walters. Ms. Walters, a 19-year-old actress at the time, claimed that the



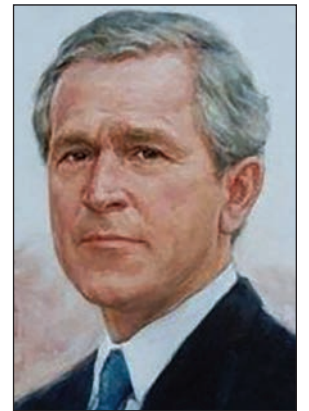

then-41-year-old Reagan forced himself sexually on her during a date in 1952. This quintessential “date rape” stayed surprisingly under the radar, even after Walters reiterated her story in the April 29, 1991 issue of *People* magazine. Reagan was confronted by the press about the accusation just as Kelly’s book was being released. He was about to enter church at the time, and issued one of his trademark responses, “I don’t think a church would be the proper place to use the word I would have to use in discussing that.”

Bill Clinton was accused of varying degrees of sexual harassment by many women. One of them, Juanita Broaddrick, claimed that, when Clinton was the governor of Arkansas, he had brutally raped her in a Little Rock hotel room in 1978. Four witnesses backed her story, including a nurse who treated her injuries. NBC News, to its eternal discredit, sat on the story for a year as the impeachment process unfolded, in an ob-

vious attempt to save Clinton further negative publicity.

George W. Bush was accused of raping a black woman, Margie Schoedinger. Virtually the entire press, including abroad, ignored this story completely. The only paper to cover it, in fact, was England’s *New Nation*, which represented London’s black community. Schoedinger told American journalist Jackson Thoreau that Bush himself had threatened to have her killed, and was quoted as saying, “People have to be held accountable for what they do and that is why I am pursuing this lawsuit.” Sadly, Ms. Schoedinger supposedly shot herself shortly thereafter.

Donald Trump, like Bill Clinton, has had myriad allegations of sexual harassment leveled against him. The most serious of these was from a woman known only as Jane Doe, who accused Trump and fellow billionaire Jeffrey Epstein (convicted of soliciting underage girls for prostitution) of raping her when she was a 13-year-old aspiring model.

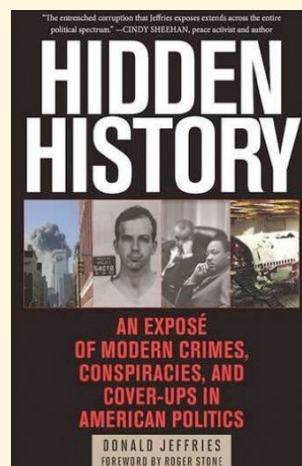
She dropped her lawsuit against Trump in November 2016 on the eve of the presidential election. Jane Doe failed to show up for a Los Angeles press conference, allegedly out of tremendous fear. Her attorney Lisa Bloom cited “numerous threats” against her client. Jane Doe herself had quoted Trump as threatening to have her and her family “physically harmed, if not killed,” if she didn’t keep quiet. She also claimed that Trump responded to her screams of protest by striking her in the face and screaming that he would do what he wanted.

It appears that the mainstream media really isn’t worried about rape allegations against presidents unless exposing them can increase their ratings—and thus their profits—or help them to ruin a president they don’t like ★

# 'Toronto First,' Says Goldy

**A** young and increasingly popular independent political commentator and alternative media personality is running for mayor of Toronto, the largest city in Canada and home to an increasingly diverse population. She is vowing to "Make Toronto Safe Again" while pledging to "Put Toronto First," borrowing popular catch phrases from President Donald Trump's populist talking points and political campaign.

Faith Goldy, who boasts close to 100,000 followers on Twitter and well over 65,000 subscribers on YouTube, is a former reporter for "TheRebel.Media," one of Canada's largest and most influential independent media outlets. She has also contributed to a number of other mostly Canadian-based media outlets, sparking controversy for her populist views and straightforward reporting on a variety of contentious issues, including mass Third World immigration to the West, political correctness, and related issues. Ms. Goldy attended the Unite the Right rally in Charlottesville, Va. last year, covering the event for "The Rebel.Media." She has since ventured out on her own as an independent journalist and reporter, covering Canada's immigration crisis and the radical antifa movement, among other topics.

In a recent interview with this newspaper, Goldy explained her decision to run for mayor in her hometown of Toronto.

"I don't recognize our city anymore. Every day, there's a new headline about a stabbing, shooting, or mass shooting on our streets," Ms. Goldy told

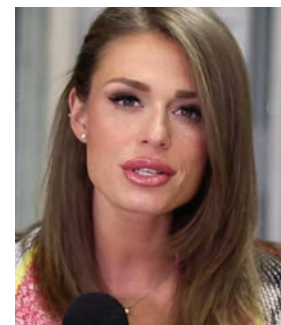
this reporter. "To boot, millennials my age are working two or three jobs and are still barely able to make rent. Meantime, our commutes to get between jobs have become worse than ever. Toronto needs a strong voice that's tough on crime and easy on taxpayers—I am that voice."

Ms. Goldy's mayoral platform outlined on her website focuses on four key issues: making Toronto safe again, putting Toronto and its legal residents first, ensuring affordable housing for Toronto residents, and fixing and improving Toronto's roads and infrastructure.

"I will reinstate Toronto's Anti-Violence Intervention Strategy and bring back the invaluable policy of carding so our officers have the tools they need to make sure our city is welcoming to everyone except criminals," Goldy told this reporter. "I will bring back the School Resource Program committing twice the number of officers in twice as many schools. I will turn TCHC [Toronto Community Housing Corp.] complexes into gated communities with officers monitoring ID and license plates of people going in and out, so to protect the most vulnerable in our city. And, I will bring job fairs and training to the most violent neighborhoods in our city to help keep our kids away from guns and gangs."

Ms. Goldy has also been highly critical of Canada's open borders policies, which have welcomed illegal immigrants and purported refugees at the expense of Canadian citizens. She has vowed to put Toronto first and prioritize the interests of all Toronto residents.

"I want every homeless person in our city to have a warm bed this winter," Goldy proclaimed, "but right now, they're being crowded out of our strained shelter system by an invasion of illegal mi-

grants monopolizing our resources. As mayor, I will evacuate every illegal migrant from our public housing and bus them to the front steps of the prime minister's official residence. Not a single Toronto taxpayer was asked if they wanted to erase our southern border, and we won't be burdened with the exponential costs of the federal government's decision to do so."

Unsurprisingly, Ms. Goldy has been hysterically denounced by the fake news media and political establishment in Canada, who have portrayed the populist and outspoken young Canadian as a far-right extremist.

"Since announcing my bid to become mayor, our city's press has taken to the airwaves, defaming me," she explained. "These fake news claims are nothing more than a diversion tactic, plain and simple. Toronto's establishment media wants to distract taxpayers in this town from hearing my message because they know it will resonate."

Various political lobbies and subversive activist organizations, such as the Southern Poverty Law Center and Anti-Defamation League, for example, have lamented the rise of populist and nationalist political candidates such as Ms. Goldy in both the United States and Canada.

Thankfully, more and more citizens are ignoring the smears from dishonest organizations working overtime to prevent populists and patriots such as Ms. Goldy from becoming elected representatives. ★

## Canada's Orwellian Gun Laws Fail Citizenry

**T**here have been several high-profile shootings in Toronto so far this year. The most serious incident occurred on July 22 in Toronto's Greektown, resulting in the deaths of two and the wounding of several others. On cue, there were hysterical calls for gun control and "banning" handguns in the city of Toronto, but what's a country to do that already has absurd gun control laws in place?

Canada is already well known for restrictive gun laws. Handguns are so difficult to legally own, most people don't even entertain the thought of owning one. There are many tales online that illustrate the ridiculous procedures that are involved with transporting handguns, for example. It may be hard to believe, but a gunowner needs to apply to the

police to transport a handgun.

Here is one man's story:

I needed to take my handgun to the gunsmith last week for a minor maintenance issue, dropping it off before work with the plan of picking it up afterwards. I live on one end of the city; the gun store is on the other. . . . To transport a restricted firearm, the class in which handguns fall, the law requires I take "a route that, in all circumstances, is reasonably direct for the specific indicated purposes." The precise interpretation of that depends on the jurisdiction, and the police officer who catches you, but one firearms expert told me even a simple stop on the way home could be illegal.

The stakes are higher for gun owners than most other groups in Canada in the event of a slip-up. What if my cable lock isn't closed all the way? What if I forget my license at home? What if I need to stop to change a flat tire on my way home from the range?

The man points out something that few know but if true is truly insane: [Gun owners are] subject to warrantless home searches, despite a constitutional right to freedom from search and seizure. Long guns are much easier to own, but they have been under siege over the years as well. All long-guns had to be registered with the government until relatively recently when rural citizens finally pushed the government to scrap its ludicrously expensive and largely ineffective long-gun registry.

So, even with strong gun control laws, we are still seeing regular gun violence in Toronto and other places in the country. As can be seen in the handgun transportation illustration above, handguns are already nearly banned in this country, but it is not stopping gun violence. Criminals will always get the weapons they want. And, unlike the lawful citizen, they are not going to follow the rules and worry about a "non-scheduled stop" at the coffee shop. ★



# Can He Make Brazil Great Again?

• “Brazil first” candidate Jair Bolsonaro rising in polls despite media’s harsh attacks

“I’m not good. But the others are very bad. They try to bring me down, but I continue to rise in the polls.” No, I’m not quoting candidate or even President Donald Trump. Those words were recently spoken on Brazilian television by the man who appears to be on a pretty good track to become that nation’s next president.

Seven-term Congressman Jair Bolsonaro, who represents Rio de Janeiro in Brazil’s House of Representatives, may not be a name known to Americans, but it is well known to Brazilians, as every day more and more of them are rallying behind him and his nationalistic message.

Like Trump, Bolsonaro has a long-established record of “controversial” comments. “This idea of ‘oh poor little black person, oh poor little poor person, oh poor little woman, oh poor little indigenous person, everybody’s a poor little something!’” he told news and commentary website “Vice News.” “I don’t try and please everybody,” he told *The Washington Post*. “I’d rather have a dead son than a gay son.”

The *Post* also reports that he once told a congresswoman she “wasn’t worth raping.”

And just when one might think his latest verbal explosion has “crossed a line” that will hurt him in the polls, his popularity rises.

The Brazilian media regularly refers to Bolsonaro as a misogynist, xenophobe, racist, and homophobe. With each accusation, Bolsonaro claims that the media portrays him unfairly as he, like Trump, travels all over his nation, drawing huge crowds to his rallies.

His rally speeches focus on his conservative views on a slew of social and economic issues as he accuses his critics of peddling fake news:

“Homophobic, racist, and sexist—that is how the global media label the American President Donald Trump,” he recently said. “The American people didn’t swallow that, and he was elected. . . . In Brazil something similar is happening. I’ve been suffering these accusations for longer than he has. . . . People only say negative things about Trump, but how come the economy has improved?”

Bolsonaro has vowed to be tough on crime and repeatedly bashes China: “We will do business with the Chinese,” he said, “but we will not hand our territory over to anybody.” At another rally he told reporters, “[O]pen your eyes because the Chinese are buying Brazil. Okay?”

Like Trump, who frequently spoke of “slimeballs” and “bad hombres,” Bolsonaro warns of “*vagabundos*” (losers), “*canalhas*” (creeps), and “*bandidos*” (crooks). His campaign message is well received because Brazilians, much like Americans were in 2016, are fed up. Inflation is high, crime is high, un-



employment is high, and the establishment politicians are corrupt and rich, allowing only a few elites to reap the benefits of Brazil’s economy.

Recently, Bolsonaro was welcomed at an airport in Paraiba, a state in the northeast of the country, with chants: “Mito, Mito, Mito” (Legend, Legend, Legend) and “Um, dois, três, quatro, cinco mil, queremos Bolsonaro presidente do Brasil!” (One, two, three, four, five thousand; We want Bolsonaro to be president of Brazil!). To the caravans of people wearing t-shirts with the words “The Right of Paraiba” and “The Order of the Conservatives,” Bolsonaro responded: “Brazil above all. God above everyone.”

Like Trump, Bolsonaro is the “law and order” candidate. He often says at his rallies, “We can’t treat criminals as victims,” “You fight violence with violence,” “If the criminal is carrying a .38 pistol, you must have a rifle; if he has a rifle you have to have a bazooka or a war tank. It’s not with peace and love. Nobody can stand political correctness anymore.”

Another thing working in Bolsonaro’s favor is Brazil’s evangelical movement, which, in the last 30 years, has grown from 6.6% to 22.2% of the country’s population. In Brazil’s Congress, the “Evangelical Bloc” has become increasingly powerful, with the majority of its members voting to impeach Dilma Rousseff last year. In a country where voting is mandatory, it’s easy to see how Bolsonaro’s base has quickly grown as he’s picked up the endorsements of key evangelical leaders such as Silas

Malafaia from Assemblies of God Church and Edir Macedo from the Universal Church.

Malafaia from Assemblies of God Church and Edir Macedo from the Universal Church.

Bolsonaro also enjoys a wider appeal outside the “Evangelical Bloc” to a growing socially conservative segment of the Brazilian population that feels their country has lost its way with far too socially liberal policies. In a country where abortion is illegal and where almost half of the population is against “same-sex marriage,” despite it being “legalized” in Brazil in 2013, Bolsonaro’s message of social and moral conservatism is well received.

Like Trump, Bolsonaro has the passion and charisma that anyone running for president needs. He can take a joke, he’s funny, and he speaks in a very “common,” accessible, jargon-free manner.

He is betting on social media. He has 5 million followers on Facebook, more than any other Brazilian politician, and posts several videos a day, many of which are viewed by more than 1 million people.

His campaign is well-organized. In Belém, for example, he had the city deploy women to deal with the female protesters they had predicted would show up because sending men to confront them might have produced ugly press coverage.

On April 30, Bolsonaro was trailing Lula, Brazil’s former president, with 15% of the votes. But Lula is currently under investigation for seven charges of corruption and 64 charges of money laundering. If Lula is convicted, most alternative scenarios of how the 2018 election might play out show Bolsonaro winning, especially after Aécio Neves, a senator who came in second place in the 2014 presidential elections, also became another name in the sweeping corruption probe. The same happened with Geraldo Alckmin, Sao Paulo’s governor, who fell from 28% to 17% after being included in the same probe.

When asked directly what he thought about being compared to Trump, Bolsonaro joked, “I like Trump’s position. . . . The only difference is that I’m richer!” ★

# Activist Explains Why He Refuses to Kow Tow to Left

Civil and human rights activist Jason Eric Kessler, the organizer of last year's Aug. 12 Unite the Right rally in Charlottesville, Va., has Unite the Right 2 scheduled in Washington, D.C. for Aug. 12. Kessler—who grew up in Charlottesville and Las Cruces, N.M.—sat down with this reporter for 90 minutes to discuss the genesis of last year's rally, marred by government-instigated violence, and why he planned another.

AFP asked Kessler—who voted for Obama—how he came to organize the Charlottesville rally.

"In Barack Obama's second term," he began, "he just started taking this radical anti-white shift, and you started seeing a lot of just false narratives being propagated through the media, that were starting to get on my nerves."

Additionally, the mainstream media's handling of the George Zimmerman-Trayvon Martin altercation—and the Michael Brown-Darren Wilson and Freddie Gray altercations—had an impact on Kessler's thinking.

"[The media] kept trying to find a new Trayvon over and over and over again. Every single time a black guy got shot, they immediately called it racism," he explained. "And I said to myself, 'Well, that doesn't line up with the facts. We don't know what the facts are yet.'"

Shortly thereafter, he took note of and exposed a local politician's anti-white public statements, which the corrupt fake news media was ignoring.

"I achieved some local renown for exposing these racist, anti-white tweets by Charlottesville Vice-Mayor Wes Bellamy," he explained, "who is about as close to a black nationalist—he's definitely a black supremacist. He's said a lot of stuff about how he hates white people, he hates white women, he likes being down South so he could look down on white people from his position of power."

This angered Kessler and drew him closer to an activist stance.

"While you can lose your job and become a pariah if you say something about Jews or black people," he said, "you can say you hate white people for a living—like Wes Bellamy does, or like a lot of these Black Lives Matter university professors do—and you get paid a six-figure income for it."

He began rubbing elbows with the folks in the conservative movement, communicating online with members of the so-called alt-right, and traveling around the country to various rallies.

"That led up to the Unite the Right rally," he said, "which was a concept that I had come up

with because I'd been reporting on . . . Bellamy trying to tear down the statue of Robert E. Lee, where they were equating Southern history exclusively with slavery. He was going after Thomas Jefferson, whose home, Monticello, is here in Charlottesville. And through my reporting on a right-wing website called VDARE, which mostly deals with immigration issues, I think some of these alt-right guys like [Richard] Spencer had become aware of the issue in Charlottesville surrounding that monument, and they had come and done a rally there with some torches on May 14."

AFP asked what went so wrong at the Charlottesville rally.

"When I created this event I thought I would get all kinds of people," he explained, "but as I found out, the more moderate elements really did not want to be on the same stage as these more controversial speakers. They didn't want to be labeled as racist or whatever, so the character of the rally really became a lot more extreme than I had intended. It took on tones of Nazism."

On top of that, several levels of Virginia's government were the main instigators of the violence.

"The Charlottesville police were supposed to provide eight squadrons of police officers," he explained, "they were supposed to have 200 officers in the park, they were supposed to be keeping the sides separated, but in fact, it was revealed in the independent review, that the police chief just said, 'Let them fight. It'll make it easier to declare an unlawful assembly.'"

He continued: "The Charlottesville Police Department didn't even show up, not until they cleared the unlawful assembly, at which point they pushed people out of the park where they had peacefully gathered. All the violence was in the street, not in that park. So, they pushed the peaceful demonstrators into antifa, and it just led to chaos."

Antifa is a loose conglomeration of violent, "anti-fascist" groups in the U.S.

Kessler is convinced Charlottesville is respon-

sible for the only death that occurred that day.

"All of that chaos that happened was the fault of the Charlottesville government," he stated. "Even that car going into the crowd—which was a tragedy—was precipitated by Redneck Revolt members chasing that car with an AR-15."

Redneck Revolt is an anti-capitalist, anti-racist, and anti-fascist far-left group that supports gun rights, with their members openly carrying firearms.

"There's multiple evidence and admissions from a Redneck Revolt member named Dwayne Dixon that that's what they were doing," he continued, "and I have witnesses . . . who saw that happening. It's a whole mess that was entirely avoidable if the Charlottesville government had just respected free speech rights, but they never had any intention of doing that."

Kessler summed up why he is organizing the D.C. rally.

"First and foremost, it was important to stand up for the First Amendment," he explained, "because the goal of antifa is to use violence to shut down speech that they don't like. If the people that they disagree with most—me being one of them—were to give up, then that would validate their tactics. And those are the kinds of stories you'd be reading about right now, if I had not decided to do this: 'Antifa: Their Tactics Work.'"

# Former Georgia Rep. Says D.C. 'Occupied by Zionists'

In the shadow of the more than 500,000 Americans who are homeless on any one night, Congress is poised to give the Zionist state of Israel \$38 billion over the next decade—more than half of all direct military aid the U.S. provides worldwide—forcing many Americans to ask who really controls the levers of power in this once-great nation.

One of those Americans, former Rep. Cynthia Ann McKinney (D-Ga.)—currently an educator, as well as an anti-war and human rights activist—knows more than most who's in charge, and for those who still think it's their president, senators, or representative, it's time to smell the coffee.

Ms. McKinney—who earned her Ph.D.—sat down with this reporter for an hour-long candid discussion of the power of Israel in the United States. She is one of several U.S. politicians targeted by the American Israel Public Affairs Committee (AIPAC) for not being sufficiently servile to the Mideast state, and who lived to tell about it, specifically about the pledge of allegiance to Israel all U.S. politicians are forced to sign if they want any real chance at reelection.

AIPAC targeted Ms. McKinney for termination for her refusal to sign “the pledge,” but many other politicians weren't as lucky, like former Illinois Gov. Rod Blagojevich.

“He's in prison not because he had a conversation,” explained Ms. McKinney. “It's because of his appointment to the Senate. The Israel-first people had their candidate he was supposed to appoint to the Senate, and he didn't do that . . . and they sought their revenge. That is the underlying reason for his prosecution.”

She continued: “You can cite as an example to Rep. Jim Traficant. They've got a whole trail of people who have been in prison. You can go to Bob Ney from Ohio. You can go to Curt Weldon; he didn't go to prison, but he got kicked out, with an FBI raid, just because he talked about 9/11. So, you've got a trail of detritus, the carcasses of politically dead politicians—with my carcass there as well—for the vultures to feed on.”

Ms. McKinney first detailed “the pledge”—a result of President George H.W. Bush's defiance of AIPAC—on a PressTV episode, which she elaborated upon to this reporter. “The pledge was a piece of paper that was faxed to my home,” she said, unabashedly sent from AIPAC. Its demands were clearly listed. “I only remember the first three,” she said. “There were five or seven. I can't remember.”

Jerusalem is the capital, the military superiority of Israel, and economic assistance were the three that stood out, she said.

“The third one that I remember was about keeping the levels of aid consistent with Israel's request,” she explained, “so that I would not vote for aid levels to go down.”

“In other words, do everything that Israel wants?” asked this reporter. “Yes,” she answered.

American-Jewish politicians did AIPAC's dirty work, with Congress resembling more the German Democratic Republic's *Volkskammer* (unicameral legislature) than the bastion of representative democracy.

“You knew when there were these certain point people,” she explained, “and when those point people [Ben Cardin, Eliot Engle, Jerry Nadler, Jerry Ackerman] authored legislation, you knew that was AIPAC's making, and they were also in the room taking notes on who said what during the deliberations of the bill.”

Ms. McKinney recalled a time when AIPAC's authorship of a bill was exposed. “There was a letter or bill or something that AIPAC had sent over to one of the congressional offices,” she explained, “and the congressional office was not savvy enough to erase the original title, which was AIPAC's. Then that became like a little mini-firestorm, but there is no such thing as a real firestorm with AIPAC, because they are able to suppress everything.”

Ms. McKinney lasted through six terms without ever signing the pledge. “I was offended by it,” she said. “My entire 12 years in Congress was bumping up against these people who controlled everything. They literally controlled the budget process; what got in the budget, what got a line item.”

Ms. McKinney explained how AIPAC uses “the pledge” to control Congress. “I would get a call and the person on the other end of the phone would say, ‘I want to do a fundraiser for you,’” she explained. “And then we would get into the planning. I would get really excited because you have to have money in order to run a campaign. And then two weeks, three weeks into the planning they would say, ‘Did you sign the pledge?’ And then I would say, ‘No, I didn't sign the pledge,’ and then my fundraiser would go kaput.”

She added: “The Zionist, Israel-first money is what underpins the Republican and the Democratic parties.”

She then described how it's done. “The way it works is that the pro-Israel money is in your environmental PAC [political action committee], is in your labor union PACs, is in your corporate PACs,” she explained. “It's across the board.”

Ms. McKinney, who never took a “free” trip to Israel, remains unapologetic. “The U.S. national interest is not equivalent to the Israeli national interest,” she stated.

“Is the U.S. a Zionist occupied government?” asked this reporter.

“Yeah, yeah, for sure,” she chuckled. ★

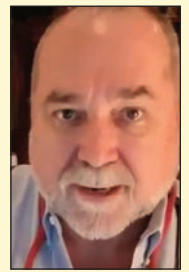

# President Gets 9/11 Memo, But Will He Respond to It?

• Group of 27 scholars unite to demand Trump expose truth

“God Bless America and God Bless Donald Trump.” So begins a collection of memos to President Donald Trump by 27 experts on the attacks of Sept. 11, 2001.

The presidential briefing on 9/11 was organized by Robert David Steele, a former CIA Clandestine Services Officer and founder of the Open Source Intelligence movement. Contributors include David Ray Griffin, widely considered the unofficial dean of 9/11 studies, Peter Dale Scott, the University of California-Berkeley professor emeritus who popularized the term “deep state,” Richard Gage of Architects and Engineers for 9/11 Truth, and two dozen others including yours truly.

Steele knows people close to Trump and believes the president will “get the memo.” In a recent radio interview, Steele said:

I’ve written a letter of transmittal to the president that focuses on what’s in the book and what he can do next. It’s about six pages long. I would say the chances of [President Trump] reading that memo are 80% or better. The chances of his getting a one-page summary are 95%. The chances of his actually getting the binder are probably down around 60%. The chances of his reading all the memos are in the 40% range. The bottom line is that Donald Trump knows this book has been published. He knows this book exists. He knows this book is calling him out on fulfilling his promise to get to the bottom of 9/11. And so I’ve presented him with something he cannot ignore as he goes toward his planned speech on the 11th of September this year.

Though the mainstream fake news media constantly attacks Trump’s “conspiracy theories,” it never mentions the president’s most explosive campaign promise: Elect Trump and “you will find out who really knocked down the World Trade Center.” Donald Trump made that promise on Feb. 15, 2006 to a cheering crowd in Bluffton, S.C. Why isn’t the media holding Trump’s feet to the fire on this astounding promise—if only to further demonize him? Perhaps because the people who control the media are terrified that Trump might actually act on it? Or perhaps because they know how obvious it is that the World Trade Center was blown to kingdom come with high explosives, so they don’t want to draw attention to the issue?

The media’s treasonous participation in the 9/11 cover-up underlines the truth of Trump’s charge that mainstream newspapers and TV channels are purveyors of fake news. The MSM’s false and li-

belous claim that radical Muslims were responsible for 9/11, when, in fact, the deed was done by Israeli agents and their treasonous American accomplices, is the biggest fake news story ever concocted.

The fake news 9/11 official story is a racist lie. It directly triggered the murder of 32 million Muslims worldwide, according to avoidable mortality expert Gideon Polya. The racist assault on the Muslim world, whose major beneficiary is Israel, has created a flood of tens of millions of refugees that has overwhelmed Turkey, Pakistan, and various European nations. Yet the murderous, racist, genocidal 9/11-lie-purveying MSM says its truth-seeking critics are the racists. It should cast out

the beam in its own eye before worrying about the mote in the other side’s.

Trump could use 9/11 truth as a “nuclear option” to blow up the entire deep state and its lapdog media. But he would need the support of a dedicated core of patriots in the military and law enforcement communities. Whether that patriotic core has reached critical mass yet is an open question.

The contributors to Steele’s “Memorandums for the President on 9/11” certainly hope that it has. Among them are ex-insider whistleblowers Tom-Scott Gordon, Susan Lindauer, and Scott Bennett.

Gordon was part of a team that documented the need to demolish the World Trade Center by 2007 at the latest, due to structural flaws, corrosion, and asbestos. Conventional, legal demolition would have been prohibitively expensive. 9/11 provided “urban renewal by other means.”

Ms. Lindauer was a CIA asset reporting to Case Officer Richard Fuisz. Both knew about 9/11 in advance but weren’t given full details. On Sept. 11, 2001, Ms. Lindauer was on the phone with Fuisz. According to Lindauer, as they both watched the explosive demolitions of the towers on television, Fuisz flew into a rage, screaming “the goddamn Israelis!”

Bennett, a U.S. Army counter-terrorism officer working out of the Joint Interagency Operations Center at U.S. Central Command, was ordered to investigate Booz Allen Hamilton’s Terrorist Financing Operations Director, Rabbi Dov Zakheim—the comptroller of the Pentagon on 9/11, when \$2.3 trillion went missing. What Bennett found implicates Zakheim and others in high treason.

These and other 9/11 whistleblowers could help Trump finish off the deep state. Mr. President, are you listening? ★

# Israel's Military Strategy a Failure

• Zionist state refuses to abandon dream of gobbling up territory of neighbors

**T**he failure of the coordinated efforts of the West, its Arab allies, and Israel to redraw the map of the Middle East by forcing regime change in Syria has exposed Israel's declining power across the region.

Russia's intervention in the Syrian war on the side of Syria's government turned the tide against ISIS, al Qaeda, and the al-Nusra Front who received arms, intelligence, and training from the West and its allies, especially Britain, France, Turkey, Jordan, Israel, and Saudi Arabia. It also placed a spotlight on a regime-change policy that had all the hallmarks of a neoconservative agenda that risked helping Israel find an excuse to go to war with Hezbollah in Lebanon and provoke a major confrontation with Iran that would drag in Western powers.

Israeli warhawks have their eyes on the Golan Heights. Once they get it they want to keep it forever.

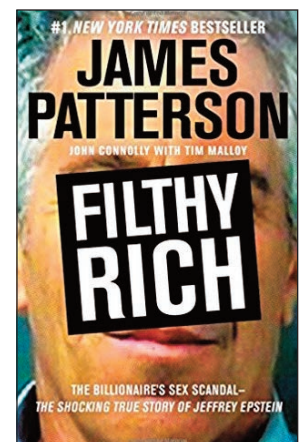

Eastern Europe, in the Golan Heights, enabling Israel to eventually argue before the UN that it could not hand over an area populated by Jews to a non-Jewish regime.

Another strategy is the building of expanded military fortifications in the Golan Heights. An intelligence source in Moscow who spoke to AMERICAN FREE PRESS off-the-record warned that Israel may have put missiles with a nuclear capability in the Golan Heights.

"But you have no hope getting that confirmed," the source added.

Netanyahu has long believed if Washington can be persuaded to publicly declare the Golan Heights Israeli territory the sovereignty issue will be over. He believes he has found a way to do that, knowing oil and gas provide a route map to Washington decision makers' bank accounts and influence. When he learned that the Golan Heights held massive quantities of oil and gas, he made an unknown American company, Genie Energy in New Jersey, a partner to sharing in those riches, giving it the rights to explore 135 square miles of the Golan Heights. It was, of course, no ordinary little company. Its board membership tells you how powerful it could be in ensuring Israel gets what it seeks while Genie gets the energy riches. The board includes Dick Cheney, Lord Jacob Rothschild, Rupert Murdoch, former CIA director James Woolsey, and Larry Summers, the treasury secretary under Barack Obama.

It must, therefore, have come as a shock to Israel when Russia suddenly announced that it was entering the Golan controversy. On Aug. 2, Russia dispatched its military police to patrol the Golan Heights where it meets the border with Syria. The tactic was designed to stop Israel exploiting Islamist activity in the area to continue bombing the Syrian military.

Russia said its military police would operate eight command posts under a UN mandate to monitor the Golan Heights.

UN forces withdrew from the border area in 2012 fearing they were vulnerable. The Russian military appears to have no such fear. In a move sure to anger Netanyahu, Russia said it would transfer control of the command posts to the Syrian military when tensions eased. ★

# Charles Manson's Death Spurs Controversy Over True Offspring

• Multiple men claim they are cult leader's legitimate heirs

By S.T. Patrick

When Charles Manson died at 83 in November, the controversies surrounding his life should have ended. Yet, in death as in life, Manson's funeral, remains, and estate were almost instantly in legal limbo since his demise from respiratory failure- and colon cancer-induced cardiac arrest.

As someone who knew Manson and had communicated with and interviewed him many times, Nikolas Schreck, the author of *The Manson File: Myth and Reality of an Outlaw Shaman*, has been troubled by the events surrounding Manson's death.

In an email exchange with this writer, Schreck wrote, "No matter what anyone thinks of Manson, all of this is an indignity no human being should have ever been subjected to."

Toward the end of his life, Manson's health had been waning. California prison officials had released little information, citing state and federal medical privacy laws that prohibit the California Department of Corrections "from commenting on protected health information for any inmate in our custody."

Now that Manson's life has ended, researchers and officials may delve deeper into his medical and psychological history.

The funeral for Manson was stalled for four months over legal wrangling regarding the body—and the organization of the publicity. Entertainment website "TMZ" reported that the body had

already decomposed badly and required heavy makeup and gloves. Manson's former fiancé Afton Burton and Manson "family" member Sandra Good were reportedly in attendance.

The battle for the body and the valuable estate commenced almost immediately upon Manson's death. Schreck supported the legal claims of Michael Brunner, Manson's son by Mary Brunner, as what he called "the only legitimate heir." Brunner was born Sunstone Hawk, also known as Michael Valentine Manson, and was the only child reared by Manson at Spahn Ranch. The court ruled in favor of Jason Freeman, who the media referred to as "Manson's grandson." What Freeman did with the body and then allowed at the funeral disgusted Schreck.

"As it turns out, as soon as Freeman won the case, he ordered Manson's body embalmed (after four months of rotting at a county coroner morgue, refrigerated but not frozen!) so that he could film it for a trash reality TV show called

'Manson's Bloodlines,'" Schreck wrote. "As I soon discovered, the entire funeral was a phony film shoot paid for and organized by a film production company solely so that they could get footage of Manson's corpse for their sleazy documentary. It is a grotesque tale of media exploitation that embodies our fake reality TV age. Ultimately, the 'grandson' and his partners in crime have sunk so low as to provide some of Manson's remains to true crime 'murderabilia' collectors."

Schreck calls the evidence that Freeman is the biological grandson of Manson "flimsy" and states that the relationship of Freeman to Manson has never been proven through DNA testing.

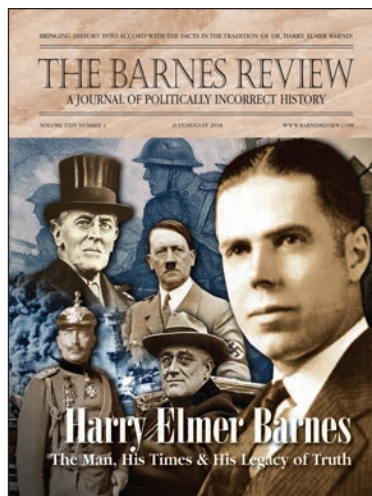
Manson had three children: Michael Brunner; Charles Manson Jr., who changed his name to Jay White and committed suicide in 1993; and Luther, born to Manson's wife, Candy, a prostitute in the Manson stable in the late 1950s and early 1960s.

Much of the debate over the remains and estate evolved from Manson's own personal communication and his propensity to waver emotionally. Manson pen pal Michael Channels possessed a will dated Feb. 14, 2002, that leaves the body and the estate to him. In contrast, Manson's friend Ben Gurecki also had a will, dated January 2017. In it, Manson leaves the body and estate to Matthew Roberts, who alleged that he, too, was Manson's son.

question of Freeman's relationship to Roberts, who believes that Charles Manson Jr. (Jay White) was his father. Tests proved that Freeman and Roberts did not have a shared ancestry. Roberts was the one disappointed, as it, to him, also revealed that he did not know the real identity of his father. However, if Freeman also has no proof of lineage from Manson, the results simply just show that Freeman and Roberts are not related. They neither prove nor disprove that either is related to Manson.

Freeman had originally agreed to have Manson cremated, which he did on March 20—after maximizing the profits and media attention from the funeral, the murderabilia collectors, and the estate. Unfortunately for Schreck and many other friends and researchers of Manson's who simply wanted the body respected, Kern County courts ruled that Freeman is the heir.

Manson's legacy can and will be debated for decades. The *Los Angeles Times* article announcing the death led with "Mass killer Charles Manson . . ." The death was another opportunity for the mainstream media to praise Vincent Bugliosi, the district attorney who prosecuted Manson and then wrote the book *Helter Skelter* about the case. Schreck has spent over 1,000 pages debunking Bugliosi's myth, an updated edition of which will be available soon. ★

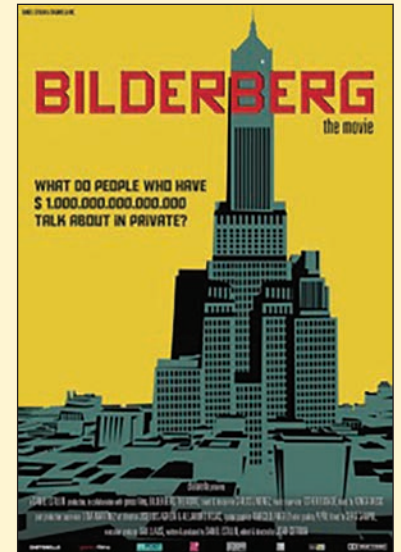

# Rather Covers for Fake News Media

• Fraud journalist blasts Trump, supports establishment's lying press

When the mainstream media is attacked, it can always count on its own aging lions to protect the den. The barrels of former CBS news anchor Dan Rather's ideological bully pulpit recently turned to President Donald Trump. In an interview with CNN's Don Lemon, Rather said Trump's attacks on the media were "straight out of Orwell." Rather also referred to Trump as an "authoritarian" and someone who believes that "the one and only truth comes from him."

Ironically, but not surprisingly, Rather has built a career on portraying himself as an authority on major events and someone who should be trusted to relay truth to the American public. The problem with Rather's career is that those dubious goals were diametrically opposed to the plot points of his dishonest rise and notorious fall.

Rather's rise at CBS can be attributed to having been in Dallas on the day President John F. Kennedy was assassinated. However, his bungling of details also coincides with the same event.

Rather was among a handful of reporters to have seen the Zapruder film the day after the assassination. The American public at-large would not view the film until March 6, 1975, when Robert

storm-chasing reporters who would tie himself to a tree as a hurricane approached. Clutching the tree as if his life was in jeopardy, the moment of truth would inevitably come when a random elderly person would walk through the background, unaffected by the winds.

In 1980, Rather earned the critical nickname "Gunga Dan" from *Washington Post* TV critic Tom Shales for his over-dramatized walk across the Afghanistan border. Rather told America he was "risking his own safety." The accompanying interpreter seemed wholly unaffected.

The fall of Rather occurred when he, once again, jumped the gun on news—and truth—by reporting false information about George W. Bush's Air National Guard Service in Texas. This was the end for an overdramatic news anchor who always fancied himself as "hard news." Today, Rather still brandishes a reporter's notebook that can be used at any moment if his AXS-TV interviewees—such as Kid Rock or Crystal Gayle—need to share any information on deep background.

Rather had mastered fake news before "Fake News" was a hip criticism. And while he was a maestro, he was not a solo act. In 1993, NBC had to settle a defamation suit with General Motors when its cornerstone "Dateline NBC" program rigged a fiery crash. After the 1996 Atlanta Olympics bombing, NBC massacred alleged bomber Richard Jewell in a trial-by-media outbreak that was nothing short of omnipresent—and false. Rather's CBS News broadcasts followed NBC's lead. Despite doubts, all three networks (and all of the cable outlets) aired false reports on the death of Pat Tillman and the faux-heroic

Groden showed the "Z-Film" on an episode of "Good Night America" with Geraldo Rivera.

Upon Rather's viewing, he rushed to air with the shocking description of what he had seen—a presidential head that "went forward with considerable violence." As it turns out, both Oliver Stone and the writers of "Seinfeld" were more accurate than Rather when they described Kennedy's head obviously jolting "back and to the left." Rather also later reported that President Nixon was about to fire the FBI's J. Edgar Hoover and a top Vietnam official. These last two reports were later proven to be false.

Rather was notorious for being one of the first

story of Army private Jessica Lynch in Iraq.

New journalists at old media encampments are told by the Rathers of the world that the mainstream media is reliable, and social media giants like Facebook are told that these same media organizations should be the arbiters of fact.

A December *Washington Post* headline may tell the sad truth of media believability. The headline read "Polls Show Americans Distrust the Media. But Talk to Them, and It's a Very Different Story." When you ask an individual American about their trust in the mainstream media, they will most likely describe their negative view of the MSM. But like similar polls about trusting politicians, they will blast the national media while exhibiting faith in their local media or their favorite mainstream national media outlet. And while distrusting media is a commonplace opinion, media sources are still regularly cited when one person wants to prove the veracity of an event to another person. "I just saw it on the news!" still holds considerable weight in a personal debate.

One of the largest hurdles still faced by the consuming public is the idea of partisanship in news. Much of the public distrust in national news outlets has to do with a perceived partisan bias held by the media outlet. A Fox News diehard has serious reservations about CNN, MSNBC, and *The Washington Post*. A nightly CBS News viewer distrusts Fox News, *National Review*, and *The Weekly Standard*. In holding either view, the consumer fails to understand that on large, overarching issues, all major media in America functions on one accord. They are pro-war; they favor the financial and media elite; they unflinchingly trust government spokesmen, retired military officers, and establishment historians; and they always favor Big Pharma, Big Agriculture, Big Education, Big Finance, and the biggest lies in the history profession. On these issues, Fox News and MSNBC agree. Therefore, how can one be trusted and the other be reviled?

To find a news outlet that challenges the state-sponsored media dictates that are shared by all mainstream outlets, a consumer has to look toward the alternative media. The mainstream media is in a death spiral, accelerated by their own refusal to report critically on the most difficult stories, trends, and ideas of our time. A viewer's or a reader's time and money are the only vote they have regarding their media.

Real change requires an absolute change in lifestyle. To affect the reliability and the availability in trustworthy media, it is imperative that consumers support those alternative media outlets they find valuable. Like any failed idea, collapsing company, or crumbling empire, the mainstream's frustrated loyalists (e.g., Rather) will sound their horns until the last noise is made. And if there is to be a true change in the American media, the final blow of the trumpet will permeate an empty forest and, thus, will not make a sound. ★

# WikiLeaks Whistleblower Awaits Fate

• Ecuador should decide future of gutsy Julian Assange within a few weeks

As the future of WikiLeaks founder Julian Assange twists in the political winds, the United States, Great Britain, and Ecuador continue to negotiate over the life of the Australian computer programmer and hacker.

Assange has been housed at the Ecuadorian embassy in London since 2012. According to one of his lawyers, Assange's health is suffering and, for the past four months, he has been held in a situation that can be more accurately described as "solitary confinement." The end of WikiLeaks, as well as Assange's own version of freedom, may soon be near.

The white-haired Australian, Assange, 47, founded WikiLeaks in 2006, but his presence in the global spotlight dates back to 2010 when he published a series of leaks given to him by U.S. Army soldier Bradley (Chelsea) Manning. The leaks, factual yet damaging to the U.S. military's public image, prompted a federal criminal investigation into WikiLeaks and its founder. Allied nations were encouraged to do the same.

In November 2010, the Swedish government charged Assange with sexual assault and rape. Assange continued to deny the allegations as a political attack. Concerned about being extradited if he surrendered to Swedish authorities, he surrendered to UK officials in December 2010. He was released 10 days later after posting bail. Sweden dropped the charges in May 2017, yet the real possibility of extradition to the United States remained.

When it became apparent that his extradition challenge would prove unsuccessful, Assange absconded and was granted asylum by the Ecuadorian government in August 2012. He was granted Ecuadorian citizenship in December 2017.

Technically, Assange is not a prisoner of any government. That is the inevitability that he is trying to avoid. He may leave the embassy, but doing so would trigger the execution of an active warrant that still exists in the UK for jumping bail. If arrested, extradition to the United States seems likely.

Time may be at hand for Assange. On July 27, Ecuadorian President Lenin Moreno admitted that he has been in talks with the British government to revoke the asylum. Moreno had been a detractor of Assange since taking office in May 2017.

"Mr. Assange is a hacker," Moreno told reporters. "That's something we reject, and I personally reject."

An avid tweeter, Assange has been without Internet, phone, and visitation privileges for months after he criticized the British government for

claiming that the Kremlin was behind a nerve gas attack on Sergei Skripal, a Russian intelligence officer, in England earlier this year. He had also been punished by Ecuadorian officials for tweeting about the Catalan independence movement in Spain.

President Donald Trump praised WikiLeaks amidst the 2016 election campaign, and private tweets from Assange show that the phrase "sadistic sociopath" was used in his description of Hillary Clinton. Special counsel Robert Mueller in July indicted 12 Russian military intelligence officers of conspiring to interfere in the 2016 U.S. presidential election by hacking into the personal and professional email accounts of top Democrats and turning them over to WikiLeaks. Assange has repeatedly denied that the Russian state was the source of the leaks regarding Clinton.

Because there is a clause in the UK-Ecuadorian extradition treaty that bars one country turning citizens over to the other, Assange's Ecuadorian citizenship may have to be rescinded for extradition to occur.

A Trump administration that many had assumed

would be friendly to Assange has been more critical in recent months.

In April, Attorney General Jeff Sessions hinted to the media that he would consider bringing criminal charges against Assange.

"We are going to step up our efforts and already are stepping up our efforts on all leaks," Sessions said. "We will seek to put some people in jail."

Former U.S. litigator Glenn Greenwald, founder of "The Intercept" website, believes that extradition to the United States would not be as automatic as is being reported by many news outlets. He calls the British government "subservient" to the United States, yet he points out that the British judges lean more independent. He also points out that the specifics of the U.S.-UK treaty may not allow extradition.

"Political crimes, like publishing documents and engaging in journalism—that really isn't what extradition is for," Greenwald said. "And in fact . . . is excluded from most extradition treaties, including the one between the U.S. and the UK."

Freedom proponents, whistleblowers, libertarians, and government transparency activists all hope that extradition to the United States would eventually lead to a pardon from Trump. If Trump's first-term maneuvers are any indication, however, that seems unlikely. Trump continues to appoint neoconservatives to key decision-making positions within the administration.

If Assange is extradited to the U.S., it will be a test for Trump. Americans will find out if the independent torch that he so boldly displayed throughout the 2016 campaign is still a reflection of his steadfast beliefs or if it was a façade. For Assange, his life is now in the balance, wavering like the First Amendment freedoms that Americans once thought were constitutionally guaranteed. ★
