Famed Arizona Sheriff Will Seek Reelection

- Illegal aliens, radical leftists praying Joe Arpaio will not win
- Patriot lawman blasted for speaking to AMERICAN FREE PRESS

AFP had the great fortune recently to sit down with former Maricopa County, Ariz. Sheriff Joe Arpaio in which "Sheriff Joe" filled us in on what has happened since we last interviewed him in May. This interview was conducted by AFP reporter Dave Gahary.

AFP: Thanks, Sheriff, for taking the time to sit down with us, especially after some pretty nasty leftist organizations have smeared you for being courageous enough to talk candidly with us in the past. We understand you are running for your old job in Maricopa County. How is that going?

Arpaio: I think you did a great article last time we talked. One day, I saw a sign up that said "Joe, one more time," a digital billboard, and it started some interest in my quest to become sheriff of Maricopa County again. And then, people on Facebook and Twitter, via cards and letters, hundreds of thousands of people in the last two months, basically said, "We would like you to run again," and that sort of swayed me.

Not only that, I travel around the country and, wherever I go, people recognize me, and they come up, say, "We're sorry you're gone." So, regardless of all the critics, especially the fake



news media, I think, after running seven times for office, I recognize a gut feeling when I have one—and a silent majority. So I talked to my wife, and she agreed, and we decided on Aug. 25 to kill three birds with one stone: That's my wife's birthday; that's when the president pardoned me; and that's when I announced that I was going to run for sheriff again.

AFP: Has the media covered this?

Arpaio: Yes, except Fox, of course. They haven't had me on for a year.

That's very interesting, since I've known them for 24 years. I've had local media call me. I did not do a press conference. I simply told everybody that I would meet them one-on-one, just like I'm talking to you, and so I feel good about it.

AFP: It looks like Arizona needs you.

Arpaio: Right. We're being flooded with drugs coming across the border, and I like to think that when we used to grab all these guys, I was doing a favor for the whole country, because most of [these drug smugglers] were trying to come through Maricopa County into other areas. These are the drugs that are killing our young people.

AFP: What about all the smears?

Arpaio: I see a lot of big media people calling me a convicted felon. I'm not a convicted felon, so I'm fighting back. I'm suing Andrew Cuomo, CNN, *Rolling Stone*, *The Huffington Post*, *The New York Times*, and a few others.

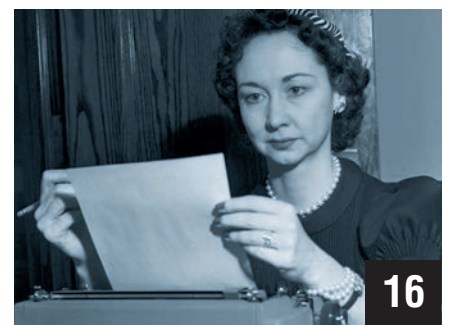

It's Time to Cancel the "Cancel Culture"

There's a popular, old adage that says, "Rules are for thee, but not for me." A similar expression goes something like, "Rules are for little people." And when it comes to leftists, these sayings are quite appropriate. They regularly point fingers, make accusations, and mob good people, all the while conveniently overlooking their own gaffes and general bad behavior.

In the years before the Internet, it used to be considerably harder to smear someone on a national—let alone global—scale. The accuser would have needed a massive platform like a cable news network or a major newspaper to do it. A few sleazes like the Southern Poverty Law Center's (SPLC) Morris Dees and David Brock of Media Matters figured it out. They knew how to exploit the media, and if they wanted to hide their own past acts, it was easy to do, because, in spite of what you may read today, leftists have always dominated the news industry. And they generally stick together.

Today, however, all a keyboard warrior needs is a cellphone and a data plan to target individuals and groups with whom they disagree, and they can do considerable damage in what the kids these days are calling "callout" and "cancel culture."

Generally speaking, here's how it works in the age of the Internet. An individual, who's usually on the left of the political spectrum, will see something on the Internet that offends him. Rather than simply ignore it and move on, however, he will quickly formulate the beginnings of a smear campaign, firing off a volley of abrupt "tweets" or posts faster than most people can even button their pants. He then calls on others in his social circle to join him in condemning that poor, unfortunate soul, who

then do the same with their social circles. The smear is then heard around the world, until, before you know it, thousands of people are chiming in. Often, even before the target has time to defend himself, hundreds of strangers have taken to calling him all sorts of horrible things, judging his life, claiming to know his very thoughts, condemning him for the crime of "wrong speak." Within a few minutes, the original wrongspeak will have been "doxxed," his name and address passed around freely, and his employer and neighbors might have been contacted by rapid mobs and activist-journalists with the sole intent of destroying their target entirely.

This is no exaggeration. There have been many cases of this happening to people over the years. In 2013, for example, just before 29-year-old public relations executive Justine Sacco boarded a plane from New York to South Africa, she tweeted a joke, "Going to Africa. Hope I don't get AIDs. Just kidding. I'm white." She had been on her way to visit family over the Christmas holiday, but before she even departed the plane after the 11-hour flight, her joke had been forwarded to tens of thousands of people, her employer had been contacted, and she had been sacked.

Over the years, groups like the George Soros-funded Media Matters for America have taken cancel culture to the next level, figuring out exactly how to capitalize—and profit—off of this, building up millions of followers, who willingly and gleefully join in the roasting and the very kinds of public shaming that early Americans outlawed as cruel and unusual punishment—even if the accusations were false.

In the past decade alone, multi-million-dollar smear machine Media Matters has gone after


many conservative organizations and individuals in an effort to tarnish their reputations in the eyes of their supporters with outrageous claims that they don't even verify are true. For full disclosure, Media Matters has repeatedly targeted this newspaper. One way they have done this is to call out advertisers and threaten a public shaming by alleging AFP is some kind of a "hate group" to be shunned.

But they will also call out public figures whom AFP has interviewed and threaten them, as well. One of those intended victims was Sheriff Joe Arpaio. Once Media Matters heard that Arpaio was running for his old office, they ordered up one of its whiny hit pieces on that patriotic American lawman.

But Joe has a stiff backbone, and refused to buckle. You can read his candid interview with AFP's Dave Gahary on page 1.

And, on page 12 of this week's issue, editor and designer Paul Angel, in a lighthearted, pointed commentary, refutes the pathetic little fictional tale Media Matters repeats verbatim again and again about AFP. It's long past time for all the sane people of the world to band together and cancel "cancel culture"—especially when it originates with groups like *The New York Times*, the ADL, the SPLC, and Media Matters. ★

News You May Have Missed

Big Loss for Climate Change

For the past two decades, much of the hysteria about “climate change” has been based around the so-called “hockey stick” graph produced by Michael Mann. Critics contend that the hockey stick graph is a fraud and that it was produced by man-made computer software that was rigged to produce a hockey stick shape no matter what data were entered. Mann didn’t like being called a fraud by his critics, so he sued one of his most outspoken critics for defamation. In late August, the Supreme Court of British Columbia, Canada, threw out Mann’s lawsuit against Dr. Tim Ball. But there’s more. Not only did the court dismiss the nine-year, multi-million-dollar lawsuit, it also awarded full legal costs to Ball. Obviously Ball was able to prove that Mann’s hockey stick was nothing more than horse hockey.

Deep State Media Ties

If you’re looking for evidence that the mainstream media is nothing more than a mouthpiece of the establishment, look no further than CNN’s latest hire. According to news and commentary website “The Daily Caller,” CNN recently hired former FBI Deputy Director Andrew McCabe, making him the 10th former FBI, CIA, military, and NSA official on their roster.

Catering to a Pedophile Rapist

You just can’t make this stuff up. Associated Press reports that the U.S. Court of Appeals for the Ninth Circuit has ruled against Idaho, arguing officials there must provide transgender surgery to an inmate who had been convicted of a sex crime against an underage victim. The federal judge claimed that the state’s denial of the surgery for 31-year-old Adree Edmo amounted to “cruel and unusual punishment.” Republican Gov. Brad Little noted the insanity of the court’s ruling: “The hard-working taxpayers of Idaho should not be forced to pay for a convicted sex offender’s gender reassignment surgery when it is contrary to the medical opinions of the treating physician and multiple mental health professionals.” Edmo was convicted in 2012 for sexually abusing a child younger than 16 and is currently being held in a men’s prison, scheduled for release in 2021.

Bye Bye, Antifa Professor

An Iowa college adjunct professor who admitted “I affirm that I am Antifa” to a local news outlet resigned after the administration removed him from the classroom for the fall semester, reports the *Cedar Rapids Gazette*. Although Jeff Klinzman’s “vociferous rhetoric and outlandish online modus operandi” is strongly anti-Christian and has called for violence, he now intends to sue the college for violating his First Amendment rights. Kirkwood Community College President Lori Sundberg re-

leased a statement in late August noting the college had accepted Klinzman’s resignation after “we had this outcry from the public and what we perceived as threats,” which led her to remove him from the classroom, with pay, for the semester. “We were trying most definitely to respect his right to free speech. At the same time, I have to respect that I have students’ lives on my campus that I’m responsible for.” Antifa is the violent, radical, left-wing group that has been attacking conservatives and vandalizing property around the country.

You’re Breaking Our Hearts . . .

Liberal journalists are boo-hooing that conservatives have been taking a page out of the left’s book by digging up old, embarrassing writings that the leftist reporters had posted to the Internet for the purpose of publicly shaming and discrediting them. Commenting on a *New York Times* opinion piece about the latest trend, Lydia Polgreen, editor-in-

chief of the far-left news website “Huffington Post,” wrote, “This is an extremely alarming piece and should worry anyone who cares about independent journalism.” *Times* publisher A.G. Sulzberger issued a public statement, crying: “Now, the political operatives behind this campaign will argue that they are ‘reporting’ on news organizations in the same way that news organizations reported on elected officials and other public figures. They are not.” Apparently, Sulzberger doesn’t like the bitterness of a dose of his medicine.

Even the Poor Are Rich

A new study from Just Facts, a nonprofit research organization, revealed that if the poorest 20% of Americans were their own nation, they would be considered one of the richest nations in the world. This is largely due to all of the social welfare spending in the United States that includes free medical

care, food stamps, housing assistance, and even transportation rebates. When it comes to the poor, America is already a socialist state.

A Wave of Violence

Liberals have been up in arms over the recent shootings in Texas, a state with liberal gun laws run by a conservative government, but they have been noticeably quiet about Chicago, where a real violent crime wave has swept the city. Over the weekend of Aug. 24-25, 29 people were shot, six fatally, in Chicago. Just before that, at least 28 were shot, five fatally, over the weekend of Aug. 16-18. In the weekends before that, 47 people were shot, four fatally, over the weekend of Aug. 9-11, 53 individuals were shot, seven killed, during the first weekend of August, and another 48 were shot, nine fatally, during the last weekend of July. Chicago has some of the strictest gun control laws in the country.

A Tsunami of Violence

Another illegal immigrant has been charged with rape in Montgomery County, Md., making him the seventh illegal immigrant to be charged with sex crimes since July 25. Once a quiet suburb of Washington, D.C., Montgomery County has seen crime spike there in the past decade as wave after wave of Central American immigrants flooded the county and incorporated cities within. Critics of U.S. immigration policy contend the wave of criminal activity is related to Montgomery County becoming a sanctuary jurisdiction for illegal aliens.

A Real Gift for Stupidity

Public schools in New York City are looking at closing down their gifted and talented programs because, according to *The New York Times*, there are too many white and Asian kids in them.

Big Apple’s Rotten First Lady

New York City’s first lady, Chirlane McCray (pictured), is facing backlash after she overruled New Yorkers, who voted to have a monument built in honor of St. Frances Xavier Cabrini, the patroness of immigrants who once lived in Brooklyn. Calls for a statue of St. Cabrini, commonly known as Mother Cabrini, began as part of the “She Built New York City” project, a public arts program aimed to increase the number of statues of women in the city. More than 320 women were nominated online, and Mother Cabrini received 219 votes, the most of any nominee. But McCray set up her own panel and chose the statues, ignoring input from New Yorkers. Among others, the statues her panel chose will honor a man who was made famous for dressing up as a woman and a transgender activist involved in an infamous homosexual riot in the 1970s.



FBI Stonewalls on the Release of Damning Strzok-Page Memos

The FBI is stonewalling efforts to release further text messages between former lovers and bureau employees Peter Strzok and Lisa Page. Conservative legal watchdog Judicial Watch has been attempting to obtain these messages for quite some time. According to the organization's director of investigations, Chris Farrell, the two FBI officials' bias against Donald Trump was so overt that in one message Strzok joked about being able to "smell the Trump supporters" as he shopped in Walmart. Farrell and Judicial Watch are most interested in unreleased texts that may contain specific names, dates, and places.

This story exemplifies how slowly the wheels of justice grind in this country, when assets of the intelligence community are involved. Over a year ago, in April 2018, Department of Justice Inspector General (IG) Michael Horowitz officially referred fired Deputy FBI Director Andrew McCabe for criminal prosecution. McCabe's multiple lies under oath, to FBI agents and investigators for the inspector general, were documented in a report published by the Office of the Inspector General. That would seem to be a clear example of perjury.

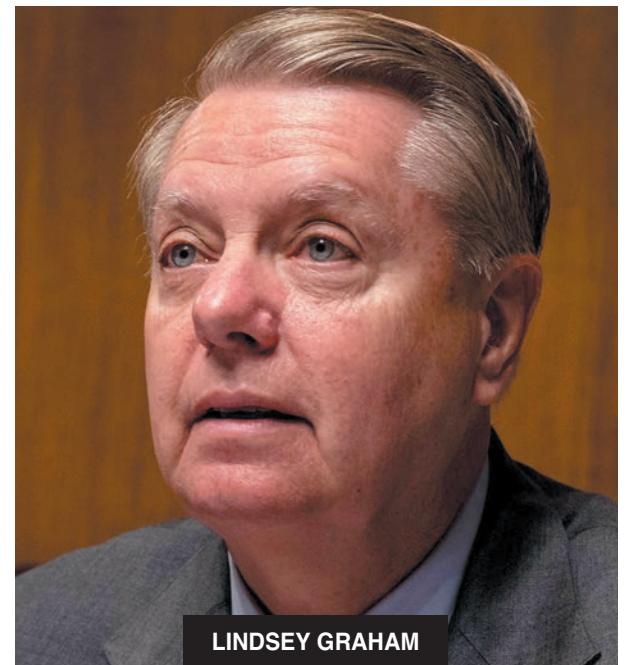
To quote from the IG report: "We found that, in a conversation with then-Director Comey shortly after WSJ [*Wall Street Journal*] article was published, McCabe lacked candor when he told Comey, or made statements that led Comey to believe, that McCabe had not authorized the disclosure and did not know who did. This conduct violated FBI Offense Code 2.5 (Lack of Candor—No Oath). We also found that on May 9, 2017,

when questioned under oath by FBI agents . . . McCabe lacked candor when he told the agents that he had not authorized the disclosure to the WSJ and did not know who did. This conduct violated FBI Offense Code 2.6 (Lack of Candor—Under Oath). . . ." As federal prosecutors mulled over whether or not to charge McCabe on charges of lying to federal agents, CNN hired the former FBI deputy director.

President Donald Trump's attorney general, veteran Deep State insider William Barr, notably refused recently to prosecute former FBI Director James Comey, despite the referral from the IG. According to *The Hill*, the Justice Department was, laughably, worried about looking "petty and vindictive." Even Sen. Lindsey Graham (R-S.C.) called Barr's decision "shocking."

Trump told reporters he knew nothing about the situation but repeated his earlier statement that the former FBI chief had "illegally leaked classified documents to the press." Trump also boasted on Twitter about "total and complete vindication and exoneration from the Russian, WikiLeaks, and every other form of hoax perpetrated by the DNC, radical Democrats, and others" following the dismissal of the Democratic National Committee's multi-million-dollar lawsuit against Trump and Russia.

Further confounding his loyal supporters, Trump celebrated Barr's refusal to prosecute Comey, tweeting, "The fact that James Comey was not prosecuted for the absolutely horrible things he did just shows how fair and reasonable Attorney General Bill Barr is." Revealing again the curious perspective he so frequently takes, that of a powerless outsider rather than the president of the United States, Trump also claimed: "So many people and experts that I have watched

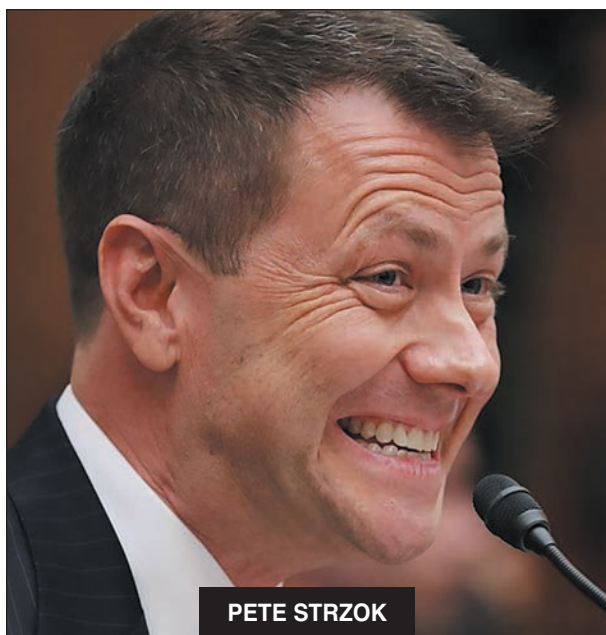

and read would have taken an entirely different course. Comey got Lucky!"

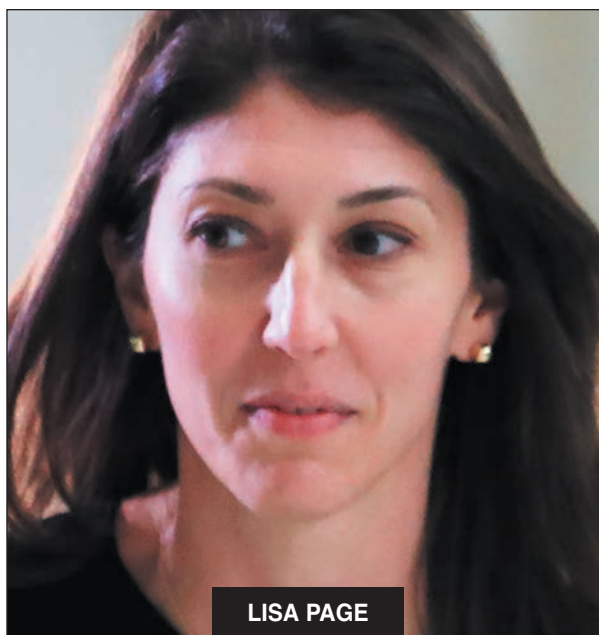
Trump's comments contradicted his earlier tweet, that "The disastrous IG report on James Comey shows, in the strongest of terms, how unfairly I, and tens of millions of great people who support me, were treated. Our rights and liberties were illegally stripped away by this dishonest fool. We should be given our stolen time back."

Washington, D.C. attorney Mark Zaid offered a Deep State apology for Barr, telling *The Hill* that Comey's mistakes were "relatively common" within the government, and that prosecuting him would force the Justice Department "to pursue many more cases like it."

The New York Times summed up the feelings of the establishment in a recent article: "Federal prosecutors in Washington appear to be in the final stages of deciding whether to indict Andrew G. McCabe . . . on charges of lying to federal agents, according to interviews with people familiar with recent developments in the investigation . . . But prosecutors may face headwinds if a case were to go to trial. One prosecutor quit the case [Ms. Shields] and has expressed frustration with how it was being managed, according to a person familiar with her departure, and a key witness [Ms. Lisa Page] provided testimony to the grand jury that could hurt the government's case. Additionally, Washington juries are typically liberal, and prosecutors could end up with jurors sympathetic to Mr. McCabe who believe that he, not the president, is the victim of a political witch hunt. . . . Though the meetings between Mr. McCabe's lawyers and top law enforcement officials suggest that prosecutors seem intent on moving forward with the case, they could also decide to pass on an indictment. . . . It would be an unusual move if prosecutors were indeed planning to charge Mr. McCabe." ★

A Crisis in the Electoral College

• Institution was created to ensure states with smaller populations aren't left out

The Electoral College, one of the longest-standing constitutional mandates never to have been eroded, may be on the road to complete abolishment within the next decade. Currently, it is under fire for diluting the decision of the popular vote, but that was a major factor of the founders' original intent, and for good reason.

In late August, the U.S. Court of Appeals for the Tenth Circuit ruled that an elector cannot be legally bound by either the popular vote or the candidate to which they have pledged. The Constitution allows an elector to vote however and for whomever they see fit. An elector, ruled the court, has the same constitutional rights as a regular voter, who also cannot be legally bound to a candidate or party.

The case involved Michael Baca who, at the meeting of electors in Colorado, was a part of a group called the "Hamilton electors." Those electors had decided that both Donald Trump and Hillary Clinton were unfit for office. Colorado's nine electors were supposed to go to Clinton. Nebraska and Maine are the only two states that do not have winner-takes-all rules and thus allow a splitting of the electoral votes based upon the proportional outcomes of the state's popular vote. Baca crossed Clinton's name out and wrote in Gov. John Kasich (R-Ohio). Then-Colorado Secretary of State Wayne Williams, a Republican, removed Baca as an elector, a move the court has decided was illegal.

There are two sides to this difficult constitutional conundrum. One side, expressed by current Colorado Secretary of State Jena Griswold, a Democrat, says: "This court decision takes power from Colorado voters and sets a dangerous precedent. Our nation stands on the principle of one person, one vote." Griswold views the electoral college as a constitutional formality, a process that should absolutely mirror the state's popular vote. If electors are completely free to vote for the candidate of their choice, then we have a process that exposes electors to bribery, threats, political persuasion, peer pressure, and potential extortion. On the other hand, the Constitution does explicitly allow electors the freedom of the ballot. Amending that freedom would require changing a tenet of the Constitution.

While the rights of the electors have been a significant issue in recent years, others have continued to debate whether the electoral college is still a valid institution in 2019. They have wondered what purpose the electoral college really serves, if, as happened in 1876, 1888, 2000, and 2016, the winner of the popular vote—the will of the people—lost the presidential election.



The electoral college was designed to increase the importance of the nation's "heartland," which, at the time, meant states outside of Virginia, Massachusetts, and Pennsylvania. Why would a small, independent state agree to "form a more perfect union," after all, if the voices of its people will be muted by the population centers of the new country? The creation of the Senate, wherein every state has two senators regardless of population, also serves the function of creating an equilibrium between states.

The House of Representatives is different; it is more democratic in that the number of representatives for each state is allocated by census figures. The founders were distrusting of "mob rule," the emotional whims of the people, even when they were an organized mob.

In *Federalist No. 68*, Alexander Hamilton laid out the reasons for an electoral college system that was detached from and not beholden to the nation's officeholders. Because the electors were not politicians, per se, they would also not be influenced by foreign interests, a legitimate concern in 1787, which now would have shifted to a fear of an elector having a long-standing tie to corporate interests. The people would choose their electors in a much more direct election than it would be the president himself.

In *Federalist No. 10*, James Madison worried about "an interested and overbearing majority." The number of electors for each state are the sum of its U.S. representatives plus U.S. senators (two). It is the addition of the mandatory two senators that brings Wyoming—America's least-populated state—closer in electoral value to California, which is America's most-populated state.

Without the electoral college, candidates would have to concern themselves only with the major population centers of the United States. The heartland, the part of the country that many coastal elites already deride as "fly-over states," would be rendered voiceless. "One person, one vote" would still exist in Wyoming or Alaska, but it wouldn't matter. Wyoming today has 577,737 residents. That is the size of Oklahoma City and smaller than Las Vegas, Milwaukee, and Louisville. If the popular vote was the sole deciding factor, why would a candidate ever step outside of New York City, Los Angeles, Chicago, Houston, and Philadelphia to campaign?

The electoral college is the sole lifeline for medium and small states in presidential elections. It is possible that Nebraska and Maine have already offered a potential solution, if the country is willing to see it. If all states split their electors proportional to their popular vote, then the popular vote would be better represented, yet the smaller states would still retain their number of electors. Neither party, however, may be willing to bend. Democrats (pro-popular vote) know they control the population centers and Republicans (pro-electoral college) know they dominate the rural regions.

Neither wants to move in the opposite direction and thereby lose control of what currently benefits them. ★

Shutting Down Tulsi

• DNC working to keep Gabbard out of debates

The Democratic Party has clamped down on its only anti-war presidential candidate, Rep. Tulsi Gabbard (D-Hawaii). In an attempt to trim the countless numbers of presidential aspirants, the party issued a decree that to continue to participate in the next round of debates, a candidate had to have achieved a rating of 2% or higher in at least four polls approved by the Democratic National Committee (DNC). While Gabbard has exceeded 2% in 26 national and state polls, including those run by establishment outlets like *The Economist* and the *Boston Globe*, only two of them are on the DNC’s “certified” list. Journalist Michael Tracey of “RealClearPolitics.com” wrote, “Tulsi Gabbard is on the verge of being excluded from the next Democratic presidential debate on the basis of criteria that appear increasingly absurd.”

Gabbard memorably demolished establishment favorite Sen. Kamala Harris (D-Calif.) in an earlier presidential debate this year. While Harris’s support appears to have plummeted as a result of Gabbard taking her to task for her abysmal record as attorney general of California, the feisty populist hasn’t climbed in the unreliable, unnecessary, and prejudicial pre-election polls. In post-debate online polls, however, Gabbard has consistently shined, dominating all of her Democratic Party peers. Such a glaring dichotomy between Internet opinion and mainstream polls is curious, to say the least. It immediately evoked comparisons to the 2012 Ron Paul presidential campaign, when he crushed all opponents in every Internet poll and drew bigger crowds than all the other contenders combined yet wasn’t officially credited with a single primary win.

Gabbard has incurred the wrath of the liberal establishment with her populist stances. The hosts on the television talk show “The View” were openly antagonistic during her guest appearance, and comedian Stephen Colbert practically went apoplectic at her anti-war stance when she was on his show.

Gabbard has also introduced a bill to audit the Federal Reserve, is outspoken about the deadly

GMO food products, came out strongly for civil liberties and the free speech of those she disagrees with during one debate, and has been the only high-profile politician to speak out publicly in support of hounded whistleblowers Julian Assange and Edward Snowden.

Considering the in-your-face corruption from the 2016 presidential campaign, revealed by WikiLeaks, that exposed a glaring effort to rig the primaries for Hillary Clinton over Bernie Sanders, one would think that the Democrats would be a bit more circumspect this time. The Democrats did everything they could to steal the nomination away from Sanders, who was drawing far bigger and more enthusiastic crowds than Clinton, even feeding her debate questions in advance, and utilizing the power of the ridiculous “Super Delegates” to give her a majority in many states where Sanders actually won the vote. The media bias for Clinton was so obvious that at one point, when Sanders had won eight primaries in a row, the mantra from virtually every “journalist” was that Hillary’s nomination was “inevitable.”

The presidential debates have long been used to exclude the rare outsider who attempts to attain the nation’s highest office. Ralph Nader was notably excluded from presidential debates, again for supposedly not reaching a certain threshold in “approved” polling. Pat Buchanan not only wasn’t permitted on stage when running as the Reform Party’s candidate in 2000, he was scorned and attacked by every pillar of the Republican Party establishment after pulling off a dramatic upset in the 1996 New Hampshire primary. Buchanan was cheated out of what seemed a clear win in Arizona; former Arizona Gov. Fife Symington actually phoned Buchanan’s state headquarters that afternoon and congratulated him on what the polls were showing to be a victory by a wide margin. While networks reported a huge Buchanan lead all throughout the day, suddenly Steve Forbes was said to be winning, with Bob Dole second and Buchanan lagging behind in third place. There were numerous irregularities, including the voters being permitted, for the first time in the state’s history, to vote in any precinct they wanted, and an incredible 60,000 voters receiving special “duplicate” ballots that allowed them to vote twice.

After the first Democratic Party presidential debate of 2019, the most googled name in the

country was “Tulsi Gabbard.” After the second debate, Gabbard was at the top of Twitter’s “trending” list. Twitter simply removed her. Gabbard is now suing Google for \$50 million. “Google’s discriminatory actions against my campaign are reflective of how dangerous their complete dominance over Internet search is. . . .” Gabbard stated. “This is a threat to free speech, fair elections, and to our democracy, and I intend to fight back on behalf of all Americans.”

Neither Buchanan nor Paul ever really publicly questioned the electoral fraud that derailed their presidential runs. Donald Trump notably did, even though he eventually won. Will Gabbard call out the rigged process? ★

State in America and its interests have nothing to do with American liberty. In fact, our liberty is what the Deep State wants to abolish.

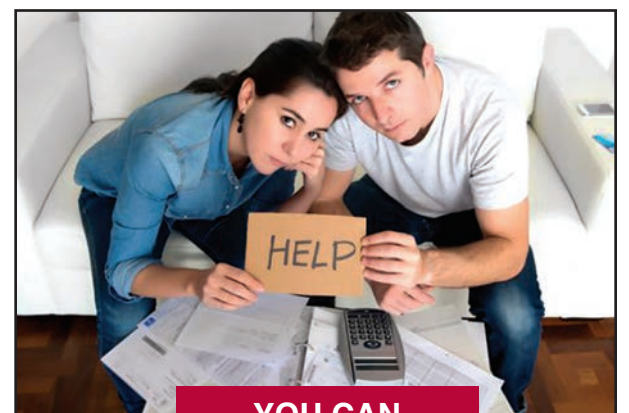
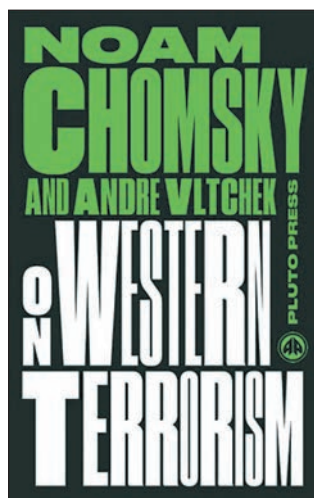
When it comes to the Federal Reserve, I stand firmly by my conviction that it needs to be audited and then ended as soon as possible.

Military Will Censor Free Speech?

• Special division of Pentagon may be tasked with ferreting out “fake news”

The Defense Advanced Research Projects Agency (DARPA), the arm of the U.S. Department of Defense responsible for the development of emerging technologies for use by the military, has been tasked with the job of identifying so-called “fake news,” and then instituting ways to dispose of it.

Of course, one man’s fake news is another man’s real news, so who’s to decide? The Pentagon, apparently.

In the past, DARPA was focused on rockets, satellites, weapons, war materiel, stealth technology, computers, drones, and “cool” stuff like that. In fact, DARPA created the first computer mouse (1964) and the forerunner to the Internet (1969), with the latter released in 1992 for commercial use.

Housed at a secretive complex in Arlington, Va. (in the Ballston Quarter, home to the U.S.’s first shopping center built around a multi-story parking garage), DARPA has around 220 employees in six technical offices who oversee about as many research and development (R&D) projects.

Originally called Advanced Research Projects Agency (ARPA)—created in 1958 by U.S. President Dwight D. Eisenhower in response to the 1957 launching of Sputnik 1 by the Soviets—DARPA collaborates with industry, academia, and governments to formulate and execute R&D “projects to expand the frontiers of technology and



science, often beyond immediate U.S. military requirements.”

Most of what DARPA does is top secret, and for good reason, but can we be assured they are working in the people’s best interest? With this latest project, we should all be wary.

On Sept. 3, DARPA released a post on its website entitled “Uncovering the Who, Why, and How Behind Manipulated Media,” where the agency lays out its case about the “threat of manipulated multi-modal media,” and why this danger must be

confronted and defeated. “Multi-modal media” refers to text, audio, and video, and those pulling DARPA’s strings are worried that technology has advanced and become accessible to the point that an average Joe or an ordinary Jane could manipulate the above and spread their creations “virally” through social media. DARPA plans to use algorithms to “spot fake news with malicious intent” before it can go viral.

“The creators of convincing media manipulations are no longer limited to groups with significant resources and expertise. Today, an individual content creator has access to capabilities that could enable the development of an altered media asset that creates a believable, but falsified, interaction or scene,” reads the DARPA statement. Apparently, the “real” fake news media (*The New York Times*, CNN etc.) isn’t fond of competition.

DARPA’s project to tackle the fake news tsunami is called Semantic Forensics, SemaFor for short, which “seeks to develop technologies that make the automatic detection, attribution, and characterization of falsified media assets a reality.”

“The goal of SemaFor,” the post continues, “is to develop a suite of semantic analysis algorithms that dramatically increase the burden on the creators of falsified media, making it exceedingly difficult for them to create compelling manipulated content that goes undetected.”

Simply put, the program hopes to determine how the “fake news” was created or altered, its purpose, and who did it, so DARPA can “quickly determine if it should be deemed a serious threat or something more benign,” ultimately “to defend against large-scale, automated disinformation attacks.”

Now, here’s where it gets scary.

Although the secret algorithms DARPA will program to determine what’s real and what’s fake—initially “to scan and evaluate 250,000 news articles and 250,000 social media posts”—the agency is not authorized to remove the “fake” media. So, who will?

Your favorite left-leaning, high-tech giants will be handed that job. Google, Facebook, and other tech giants will morph into DARPA’s order-takers.

That the incestuous relationship between government and industry appears to be entering a new phase should come as no surprise to this newspaper’s readers. DARPA has been acting as a revolving door between government and industry for years. In fact, former DARPA Director Regina E. Dugan, its first female director, began working for DARPA in 1996, left the agency in 2000, started Dugan Ventures in 2005, came back to DARPA, left in 2012 for Google, went over to Facebook in 2016, and then on to “other endeavors.”

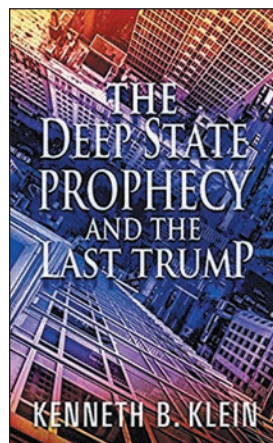
And that’s just one of DARPA’s directors.

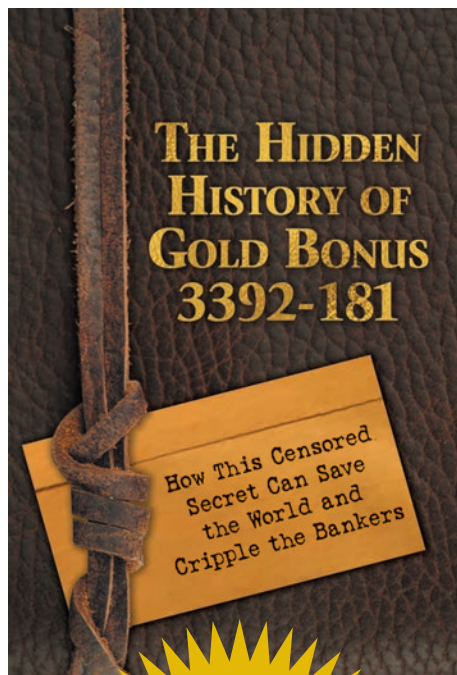

YouTube on a Banning Binge

• World's largest social media companies under pressure from Thought Police

Late last month, several prominent right-leaning YouTube channels were purged from the popular video-sharing site, largely at the behest of radical left-wing activist organizations and malicious journalists, who have been working tirelessly to deplatform and shut down those espousing pro-white, populist political perspectives.

Right Wing Watch, a leading radical left-wing activist organization posing as an independent media outlet that has been active in targeting and smearing content creators for their right-wing political views, reported on Aug. 27 that multiple pro-American YouTube channels were suspended or permanently banned in the wake of the YouTube purge.

The YouTube channel of James Allsup, an independent journalist and political activist that this paper has reported on in the past, was entirely deleted, as were the official channels for the American Identity Movement, VDare, and TRS Radio, right-leaning groups, organizations, and media outlets opposed to excessive immigration, political correctness, anti-white political and media bias, and other aspects of the radical anti-white left-wing agenda. Several other channels were also targeted and banned.

Some of the targeted channels, including the official YouTube channel for VDare, were reinstated by YouTube after further review, but many channels remain shut down, including Allsup's channel, which arguably had the most reach on the popular social media platform with over 400,000 subscribers and millions of views.

Like countless other dissident right activists and content creators, Allsup has also been banned from Facebook, Instagram, Twitter, and many other popular social media sites and online payment processors.

"It's gone. Today YouTube decided to delete



my channel without cause," Allsup wrote on Gab, an emerging social media platform dedicated to free speech, following his recent ban from YouTube. "I had no channel strikes, no violations, nothing—simply an email telling me that my livelihood, my means to exercise my political voice, my business I'd built over almost three years, was taken away from me."

Right-leaning dissidents and even more mainstream conservatives critical of the radical left-wing agenda to destroy America and traditional Western civilization have faced increasing levels of online censorship and political oppression in recent years. In early June, YouTube issued a press release outlining updated policies and practices the Internet giant would be using to more effectively tackle "hate" and "extremism" on its platform. In the wake of the announcement, countless YouTube channels were censored or had certain videos deleted. Many others had their channel monetization features disabled.

The Anti-Defamation League (ADL), a virulently anti-free speech organization dedicated to stifling America-first, populist political perspec-

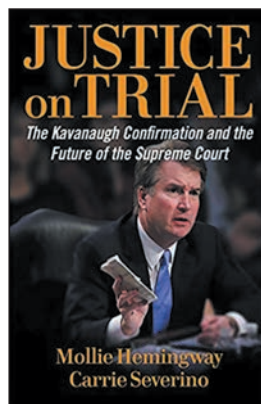

tives, has worked closely with YouTube, Facebook, and other leading social media and technology giants to combat so-called "hate speech" and the spread of "extremist" content, which essentially amounts to any expressed political or historical opinion the organization finds offensive. At the time, the ADL praised YouTube's new policy, calling it "an important step forward," but argued that much more needed to be done.

"Online hate and extremism pose a significant threat—weaponizing bigotry against marginalized communities, silencing voices through intimidation, and acting as recruiting tools for hateful, fringe groups," Jonathan Greenblatt, the CEO of the ADL, said in response to YouTube's updated policies. "That's why ADL has been working with technology companies, including YouTube, to aggressively counter hate on their platforms. We were glad to share our expertise on this and look forward to continuing to provide input. While this

is an important step forward, this move alone is insufficient and must be followed by many more changes from YouTube and other tech companies to adequately counter the scourge of online hate and extremism.”

Just weeks before the latest YouTube purge, the ADL released a study highlighting several YouTube channels, including the channel for this newspaper, that “continue to disseminate anti-Semitic and white supremacist content despite the company’s June 2019 crackdown on hate speech,” according to the biased activist organization. Many of the channels recently banned by YouTube were featured in the ADL’s report, prompting speculation that YouTube is doing the bidding of the ADL in purging dissident right content creators.

Following this, YouTube purged several of AFP’s videos, including an extremely popular, factual interview with the New Jersey police officer who arrested several admitted Israeli spies—now known as “the Dancing Israelis”—who were posing as movers following the Sept. 11 attacks.

Allsup summed up what many people who had videos felt about the tech giant’s practices.

“One of my final videos was ‘I Will Soon Be Banned and Here Is Why,’ in which I detailed how the attacks against me were originating and being

pushed by the ADL—a viciously anti-white hate group,” Allsup noted on Gab. “They had planted a story that called for my banning and were some of the only ones promoting that story.”

He continued: “Good job, ADL. By getting me banned after I predicted you would ban me, you have really done a great job proving how little power and control you have over American political discourse. Only a conspiracy theorist would believe that, though, right?”

Unsurprisingly, even the latest round of purges by YouTube was not enough to placate or appease the ADL. Greenblatt noted on Twitter that he was glad YouTube was removing some of the channels and videos his subversive, anti-American organization found offensive, but “the company has more work to do.”

The ADL and other anti-American organizations working tirelessly to target and persecute political dissidents in this country are becoming increasingly blatant in their efforts to destroy the First Amendment and any semblance of free speech and free intellectual inquiry. Thankfully, more and more Americans are recognizing this subversive agenda while censored content creators are utilizing alternative media platforms and technologies to express their political views. ★

Case in point . . .

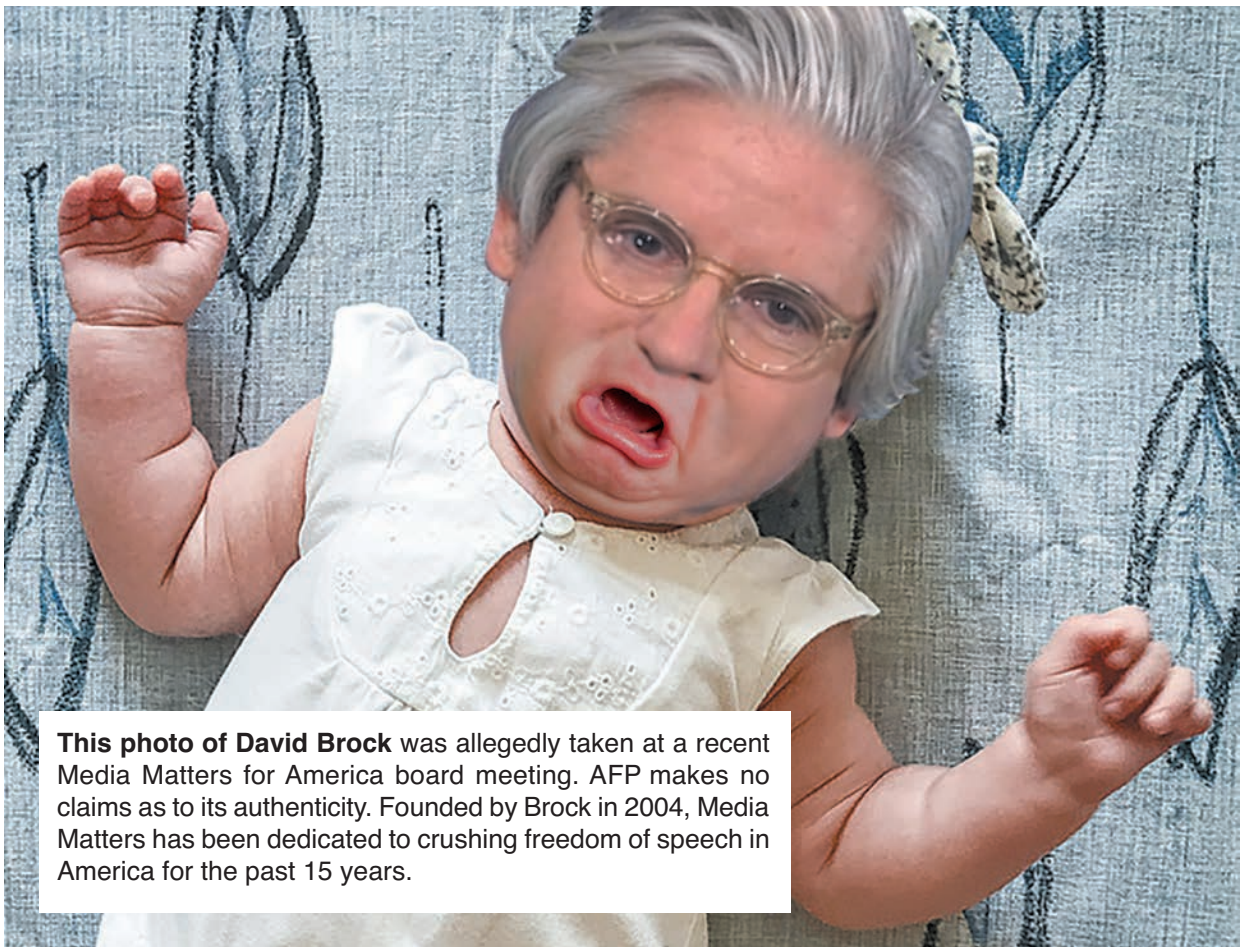

Hananoki claims in the article that “AMERICAN FREE PRESS is an anti-Semitic outlet that has repeatedly and falsely claimed that the Holocaust is a ‘hoax.’” However, Media Matters readily admits that AFP “scrubbed” an interview with author Victor Thorn about a book (not published by AFP) and a book about the Holocaust and the JFK assassination (also not published by AFP) from our website. Is the Holocaust a subject that

can never be discussed? Is every claim made by every “holocaust survivor” to be accepted as true, when we know, for instance, that multiple “survivors” have been outed as liars by their own communities?

Hananoki also cited an article published on AFP’s website about Elie Wiesel with the headline “Meet the Man Who Invented the ‘Holocaust.’” Of course, what Media Matters fails to admit is that Wiesel’s own children sheepishly claim that their father’s famous Holocaust book *Night* is “mostly fiction” and that the book was originally supposed to have been listed under the category of “fiction and literature,” according to the publisher. Even the Jewish newspaper *Forward* said the book should not be “taken as documentary.”

So, by the formula of Media Matters, Wiesel cannot be criticized for foisting a phony book on the public, claiming it was fact, simply because he is Jewish. That would be anti-Semitism—we think. He also included his observations of several bar patrons from India he had encountered during a night out on the town. Wright-Piersanti tweeted: “There are four Indian guys with mohawks . . . and each one is a ‘douche’ in his own awful way. I hate mohawk Indians. . . . I don't hate Mohawk Indians, though. I love those guys. I just hate Indians with mohawks. Different Indians, different mohawks.”

Did he say “hate”? Yes, he said “hate.” Have you ever seen something like that from AMERICAN FREE PRESS in any forum? Of course not.

Worst of all, though, is the case of Carusone himself, the president of Media Matters for America. After trying to orchestrate an advertiser boycott of conservative talk show host Tucker Carlson, Carlson did a little Media Matters-style yellow journalism and uncovered multiple “racist,” “transphobic,” and “anti-Semitic” smears on Carusone's own social media account. I don't like suing the media. I've worked closely with the media my whole career. But you have to take a stand. This is getting ridiculous. They are trying to destroy me, and that I don't like. These [mainstream] newspapers and TV stations seem to copy what others say. They ought to do some research.

I'm not taking any prisoners in this race. Whatever it takes, I'm gonna win this election. From what I see, the current sheriff is doing nothing. I want to make Maricopa County safe again. I am proud of the fact that I got 560,000 votes in the last election, even though they had the mayor of Los Angeles importing people to march down the streets carrying signs against me. We have a sanctuary county now.

AFP: You have had a lot of experience. What are they saying about that?

Arpaio: They throw my age out there. It's not “Joe Arpaio.” It's “Joe Arpaio, 87.” Every time they mention my name they throw the age in. I'm not worried about my age. I've been working 14 hours a day since I retired. So, they wanna hit me on the age issue? Let 'em hit it. I'm gonna continue my illegal immigration fight, within the parameters of the [U.S.] Constitution, and I'm going to keep fighting the drug traffic. I am officially out of retirement.

AFP: Politics is such a dirty game. Are you sure you want back in?

Arpaio: There's no such thing anymore in politics as loyalty. All they worry about is getting elected, and they flip-flop. But I will work with Republicans and Democrats alike. We all should stick together and try to get something done. The Democrats—all they care about today is going after President Trump.

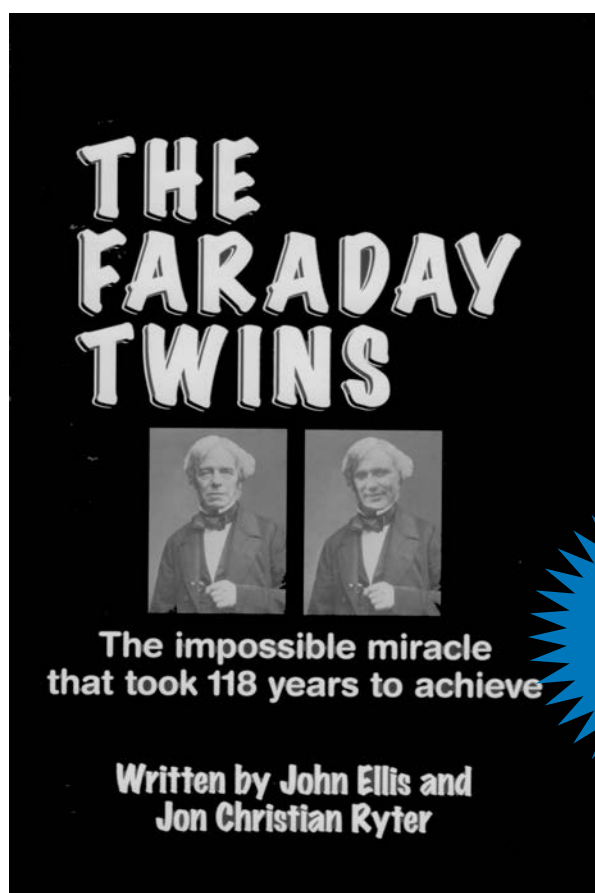

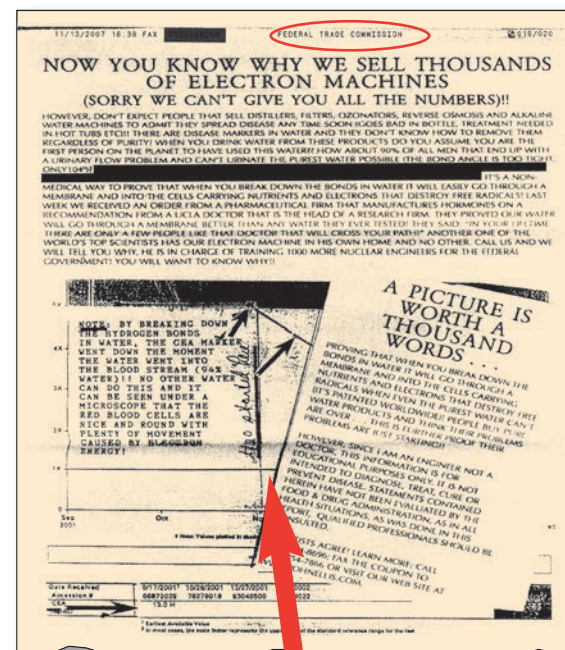

Will Court Agree to Exhumation?

• Researcher convinced murder of Dorothy Kilgallen linked to JFK assassination

Dorothy Kilgallen looked like your favorite aunt, prim and proper, the one who would wink at you as she snuck a sip from her carefully concealed flask. America knew her from her role as a recurring panelist on the popular game show “What’s My Line?” a role she kept for the final 15 years of her life. On Nov. 8, 1965, Kilgallen was found dead in her five-story Manhattan townhouse. The cause of death was ruled to be a lethal combination of barbiturates and alcohol, a ruling author Mark Shaw disputes. Shaw recently asked the Supreme Court of the State of New York for permission to exhume the body of Kilgallen. The author of *The Reporter Who Knew Too Much: The Mysterious Death of What’s My Line TV Star and Media Icon Dorothy Kilgallen*, Shaw believes Kilgallen was murdered.

In the petition to the state, Shaw asks for permission to exhume the “late Ms. Dorothy Kilgallen, the Pulitzer-Prize nominated media icon who did not die accidentally at the young age of 52 by ingesting one barbiturate but was poisoned with a combination of three dangerous barbiturates in 1965 following her exhaustive 18-month investigation of the JFK assassination.”

Shaw’s 129-page petition is a lot to unpack, and its length resembles that of his book. Essentially, Shaw, under the official guidance of famed forensic pathologist Dr. Cyril Wecht, would like to take a DNA sample of Kilgallen to match with former journalist Ron Pataky, the last person to see Kilgallen alive and the man Shaw believes murdered her. Pataky, 84, is still living and would either have to consent to the DNA sample or be court-ordered to submit. Pataky was the only new person who became close to Kilgallen in her eventful final months.

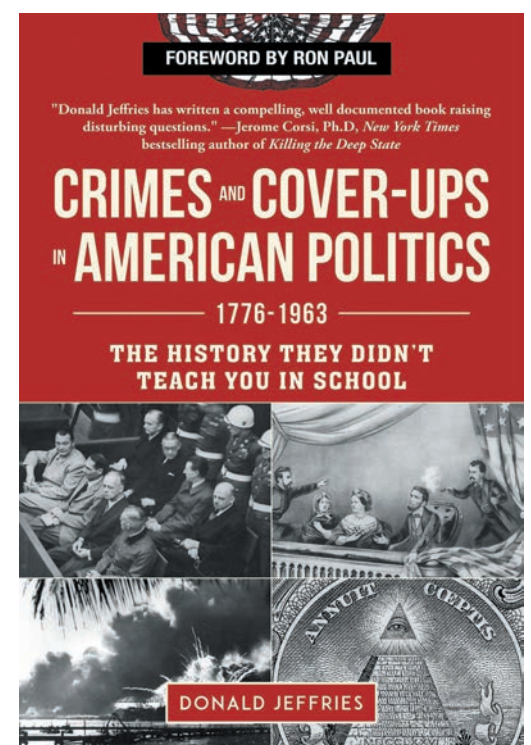
For 18 months Kilgallen had diligently researched a series about the John F. Kennedy assassination. She had doubted the official narrative very early and became the first reporter to print Dallas Police Chief Jesse Curry’s initial instructions to his officers, to “Get a man on top of the overpass and see what happened up there,” not “Get a man inside the Texas School Book Depository,” which Curry later claimed.

Kilgallen seems to have had a tenuous relationship with the CIA, receiving information from them while also exposing some of their most then-secret misdeeds. For example, she used information from CIA-trained exiles in Miami to write anti-Fidel Castro stories before then becoming the first reporter to imply that the CIA was working with the Mafia to assassinate Castro. It was at this point that FBI director J. Edgar Hoover began

a dossier on Kilgallen's activities.

In 1961, Random House commissioned Kilgallen to write a book called *Murder One*. She had already become well known for her coverage of infamous murder trials around the United States. The project lasted throughout the remainder of her life with the JFK assassination pausing its release solely to become its most important section. Kilgallen was holding a secret and it had something to do with Jack Ruby, Lee Harvey Oswald's assassin.

whom she had worked doggedly throughout her final year. She did give forewarning to one of her best friends, stating, "In five days, I'm going to bust this case wide open."

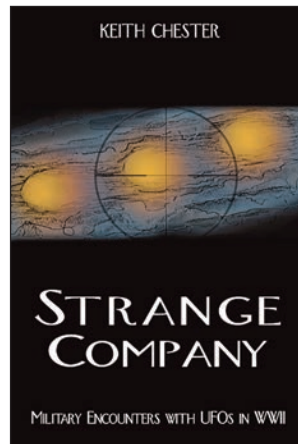

After Mass Shootings, Texas Enacts Pro-Gun Laws to Protect Good Guys

On Sept. 1, several laws were implemented in Texas that make it easier to store or carry guns in public places for defensive purposes. The bills, passed in May and June, ironically took effect in the immediate aftermath of yet another reported mass shooting in the state, this time in Odessa on Aug. 31.

These new laws represent the uniquely bold manner in which Texas seeks to address the state's lengthening list of shootings. The list also includes incidents at Santa Fe High School near Houston in May 2018, at First Baptist Church in Sutherland Springs in November 2017, and at El Paso's Walmart on Aug. 3.

The laws include House Bill 1143 under which school districts may not prohibit licensed gun owners, including school employees, from storing a firearm or ammunition in a locked vehicle in school parking lots, provided the items are not in plain view. House Bill 1387 loosens restrictions on how many armed marshals a public school district may appoint. Senate Bill 535 was amended to remove the restriction on licensed gun owners from carrying their weapons in places of worship.

The bold moves from Texas follow legislation being proposed in many states and on a national level to curtail Americans' Second Amendment rights.

For starters, how can any state, or the nation, ra-

tionalize the enactment of arbitrary "red flag" gun laws when there already are 20,000 local, state, and federal gun regulations on the books?

Then there's the unbending insistence by the police and big media that every mass shooting could only have involved one apparent shooter, a stubborn narrative that goes all the way back to Lee Harvey Oswald in terms of Texas lore.

According to police accounts out of Midland, Texas, next door to Odessa, CNN noted in its earliest report that, "as of now, police believe there are two suspects, both driving in different directions. One suspect is in a small Toyota pickup truck; the other is in a United States Postal Service van."

But just one day later on Sept. 1, when Odessa police, joined by Texas Gov. Greg Abbott (R), held a press conference, they said that while various details still were being sorted out and little was known about the main suspect, the one hard fact was that the apparent assailant, later identified as 36-year-old Seth Aaron Ator, had acted alone and had been shot dead by police before he could enter a crowded movie theater.

The discrepancy was more dramatic in El Paso, where eyewitnesses said three armed men dressed in black entered the Walmart's front doors as the shooting started. The mainstream media did not follow up on these claims.

Odder still is the Sutherland Springs church assault on Nov. 5, 2017 reportedly carried out by now-deceased gunman Devin Patrick Kelley. The incident appears to be full of holes—in the sense that the church's one-story exterior appeared to have never been hit by 400 AR-15 rounds, as Pastor Frank Pomeroy claimed.

Pictures of that event's immediate aftermath, coupled with AFP's visit to the scene one month after the event, show the sanctuary's old stained glass windows fully intact with old caulk crumbling around each window's edge (indicating they had never been disturbed), along with the church ex-



terior still being clad in the old asbestos white siding that's long been discontinued, raising the question of why a church pummeled with hundreds of AR-15 rounds would not have been re-sided with distinctly new, modern materials.

Whatever the truth may be about these shootings, it's wise to remember that while it's against statutory law, of course, to commit the felony crime of murder with a firearm, or with any other kind of weapon, it's also constitutionally forbidden to disarm the American people.

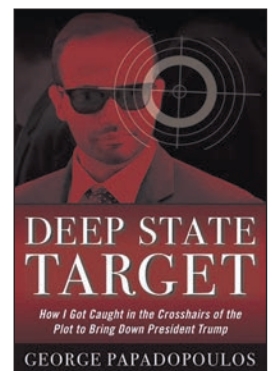
The public should demand full, un-redacted crime reports from police, no matter how disturbing the crime-scene photos, autopsy details, and diagrams may be, so there can be a more accurate assessment of the nature of these shootings.

Asking tough questions may sound like the work of "conspiracy theorists" fishing for "hoaxes." But the withholding of detailed forensic information, combined with the media's overly emotional reports, which ignore glaring inconsistencies of the case at hand, is what fuels loose theories and makes it especially tough to separate fact from fiction. ★

Leftists Attack Parade Marchers in Boston

A “Straight Pride” parade held in downtown Boston the last Saturday in August resulted in multiple scuffles, at least 36 arrests—almost all of whom were leftists—and four injured police officers, according to local reports, in yet another demonstration of the threat the radical left poses to American society and political traditions.

Estimates vary, but roughly 1,000 participated in the parade and counter-protest, with multiple reports indicating that left-wing counter-protesters—including self-identified antifa members—outnumbered those participating in the parade.

The event sparked controversy from the beginning, with debate raging on both sides as to whether or not such a parade is welcome in Boston, a city known for its left-wing politics.

The organizers eventually secured the required permit and largely cooperated with local law enforcement and city officials. Many commentators, including Stephen Colbert, mocked the parade, while other celebrities and left-wing activists expressed their outrage at the event.

John Hugo, one of the key organizers of the event, argued that the parade was about protecting the First Amendment and ensuring free speech and assembly can still be exercised in American society, as well as celebrating the “oppressed mi-

nority” of heterosexual Americans who have been suppressed by mainstream cultural institutions in recent years, as the homosexual agenda is forced upon American society.

“Why is it that other people can have a pride parade and it’s considered OK, and they have about 2,000 LGBTQ events every year, but we want a few hours and they all get out and protest and give us the finger and swear at us?” Hugo asked in an interview with the *Boston Herald*. “Give me a break.”

“The people who demand tolerance are the most intolerant,” he continued, referring to the radical left-wing protesters who targeted the parade and its attendees. “That’s hypocrisy.”

The parade, which began at Copley Square and ended at City Hall Plaza in downtown Boston, drew the typically hysterical and confrontational left-wing mobs seen at virtually every other conservative or right-leaning public event in recent years. Some members of antifa and other left-wing counter-protesters, who have engaged in premeditated acts of political violence and sabotage with impunity since the 2016 presidential campaign season, attempted to disrupt the event and violently confront those marching in the parade. Local police commendably kept the peace and generally protected the parade attendees’ First Amendment rights, as black-clad antifa openly threatened violence against those supporting the parade.

“We’re covered in black so when we attack these guys we can’t be prosecuted,” Jon Crowley, who openly identifies with the antifa movement,

explained to the *Boston Herald*, demonstrating once again the violent nature of the radical left.

The overwhelming majority of those arrested were counter-protesters of the legally sanctioned parade, with charges ranging from disorderly conduct to assaulting a police officer. Many of those arrested and cited during the parade appeared before Boston Municipal Court Judge Richard J. Sinnott this week. Local prosecutors have insisted that charges be dismissed against counter-protesters, but Sinnott has largely refused, an indication that local judicial and law enforcement officials take their oath of office to uphold and defend the Constitution seriously.

Lawrence A. Calderone, the vice president of the Boston Police Patrolmen’s Association, expressed joy and gratitude that Sinnott was holding those arrested accountable for their actions and refusing to dismiss their charges at the behest of city prosecutors.

“We think that these offenders that are here, most of them outside of the city of Boston, not residents of Boston, came here as agitators,” Calderone stated, “here for a specific reason, here to create havoc, not only for the police department but for the general citizenry that are around, for the visitors that are in downtown Boston trying to enjoy the last weekend of the summer.”

Those concerned about the rule of law and cherished American political traditions such as free speech and assembly also welcome Sinnott’s non-sense approach to enforcing the law. ★

Bibi's Warmongering

Israeli Prime Minister Benjamin Netanyahu's recent offer to help Brazil put out massive fires in the Amazon came as he was starting his own bonfires in the Middle East where he has a history of promoting political arson.

While the outreach to Brazil was designed to promote Israel as a nation interested in the environment—and to capitalize on Netanyahu's close ties to the government there—Netanyahu was busy stoking fires of a different type in Syria and Lebanon. He threatened each country that if it retaliated against Israeli bombing and the deployment of swarms of drones armed with explosives against targets in their nation, they would face the full might of Israel's military. Somewhat ironically, after attacking Lebanon, he told the Lebanese to calm down.

It was straight out of Netanyahu's devious playbook. He has been busy for years attacking Hezbollah targets in Lebanon and Iranian facilities in Syria, with the aim of goading Hezbollah and Iran into a military response. Such a response, he is convinced, would then permit him to falsely claim Israel was under attack and that it had the right to retaliate as a matter of self-defense. His long-term aim has been war with Iran and Hezbollah, with the hope that it will draw in the U.S. In the past year, he has begun to feel more emboldened with support from U.S. necons like Secretary of State Mike Pompeo.

Recent Israeli attacks in Beirut led Lebanese President Michel Aoun, a Maronite Christian, to declare that Netanyahu's use of armed drones to target Lebanon was an act of war. Netanyahu got the response from Hezbollah that he wanted when its leader, Hassan Nasrallah, threatened that Hezbollah would retaliate for the killing of several of its men in a drone strike. Nasrallah

warned Israeli troops on the border with Lebanon that they should be on alert. Netanyahu predictably responded that any threats and actions from Lebanon would be met with a massive military reply. It was classic Netanyahu.

Nevertheless, this was not a typical Netanyahu strategy. He has a grander motive for attacking Lebanon and Syria that was not apparent in coverage of the developing crisis in the international media and especially in U.S. mainstream media outlets, which reported the story as they have always done, that Israel was merely targeting its enemies, in particular Iranian proxies who pose a threat, even if no threat is apparent or imminent.

To understand the bigger picture, one often has to turn to foreign diplomatic and intelligence sources to get the inside track on what is really going on. This writer learned from talking to long-time sources that Netanyahu and his advisers have panicked ever since President Donald Trump began talking about the prospect of getting a deal with Iran. They fear the televised scenes that would accompany a possible face-to-face meeting between him and Iran's President Rouhani. In an effort to stop this from ever happening, Netanyahu has decided to ramp up tensions in the Middle East with the aim of engaging Iran.

So far, Iran has not taken the bait, but who knows what Netanyahu may do should a summit between Trump and Rouhani become a reality? Israel is increasingly aware that some of the G7 leaders, especially French President Macron, recently pressed President Trump to employ the same strategy he has used with North Korea; in other words, engage Rouhani on a personal level.

There is, however, a back story to all this that has not made news. It is the role being played by the Saudis, who have been working secretly with Israel to prevent any U.S. political rapprochement with Iran.

This writer learned about the Saudi element of this crisis by reaching out to a long-time Euro-

pean intelligence source who wished to remain anonymous. The source spelled out the Saudi role and how it dovetailed with Israel's policy.

According to the source, the Saudis and Israelis have a joint military-intelligence project underway to persuade Trump that Iran is the biggest threat to Middle East peace. Secret meetings have been held in Tel Aviv and Riyadh to plan joint operations against Iran, as well as against Iran's allies in Syria and Lebanon. Netanyahu and the Saudi leader Mohammed bin Salman (MBS) have effectively forged a pact. This development worries the leaders of Russia, China, and some European nations since MBS is considered by European intelligence chiefs to be a dangerous wild card in the region and someone Netanyahu would not be able to control.

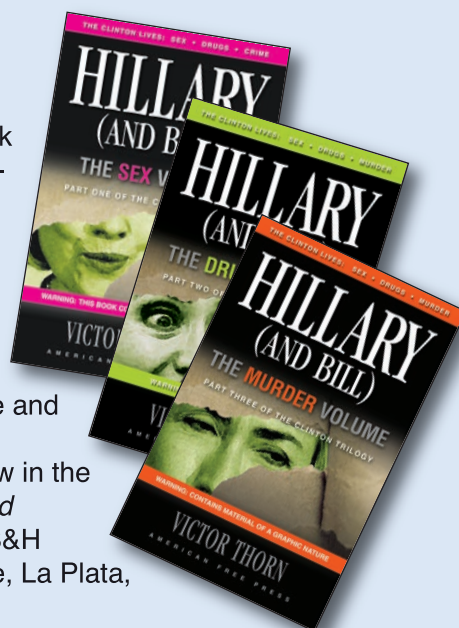
"This is not a positive development when it appears President Trump could deliver a deal with Iran that would calm the region and bring the Iranians into the Western fold," the source added. "The prospect of it happening terrifies Netanyahu and MBS, though I suspect the Israeli people would be relieved to have Iran as an ally, not an enemy. You have to understand that with Netanyahu everything is about his ego. With MBS it is about his hatred of Shia Islam."

For the first time in several years, there is a real possibility that there could be an historic meeting between Trump and his Iranian counterpart. It would be applauded by world leaders, and it might signal a new era in U.S. Middle East politics. But, with unseen forces opposed to peace, there is always the likelihood of war. ★

Pollard & the Pervert

• Lewinsky tapes used to blackmail Clinton for spy's release?

In *Clinton Inc.: The Audacious Rebuilding of a Political Machine*, author Daniel Halper released a bombshell that still resonates with many researchers of the Deep State today. In 1998, Israel's Prime Minister Benjamin Netanyahu attempted to blackmail President Bill Clinton with tapes of Clinton and intern Monica Lewinsky's most salacious phone calls. What Netanyahu wanted was the release of spy Jonathan Pollard.

Pollard was a U.S. naval analyst who in 1987 was convicted of spying and passing top secret documents to Israeli intelligence. As part of a plea agreement for violating the Espionage Act, Pollard was given a life sentence. Pollard's release had become a *cause célèbre* for conservative Israeli politicians such as those in Netanyahu's Likud Party. Netanyahu has a vested interest in the success of Israeli intelligence. After graduating high school, he devoted five years to the highly secretive Sayeret Matkal, the special forces unit of the Israel Defense Forces (IDF).

In 1998, Netanyahu was in Maryland attending the Clinton-hosted Wye River talks between Israel and the Palestinian Authority. According to Halper, at one point, Netanyahu pulled the president aside to tell him that the Israelis had overheard the potentially damaging phone calls with Lewinsky.

"According to information provided by a CIA source," Halper wrote, "a stricken Clinton appeared to buckle. . . . Not wanting to directly threaten the powerful American president, a crucial Israeli ally, Clinton was told that the Israeli government had thrown the tapes away. But the very mention of them was enough to constitute a form of blackmail."

Though Halper could not get U.S. intelligence officials to confirm for him the extent of the Israeli eavesdropping that was active in the 1990s, *Insight* magazine in 2000 reported that Israel had penetrated no fewer than four telephone lines into the White House. From a remote location in Washington, D.C. the Israelis were able to immediately relay transmissions from those lines to Israel. While it seems obvious that they would have been recorded and kept for such purposes as they were used at Wye River, Israel, of course, has called the claims "outrageous."

While most of *Clinton Inc.* stems from on-the-record conversations and "the Monica Files," sets of documents gathered for potential use in possible future litigation between Clinton and Lewinsky, it could easily be charged that Halper, a former online editor with the conservative *Weekly Standard*, was yet another cog in the "vast right-wing conspiracy." That is, if no less than *The New York Times* had not all but validated Halper's story.

The Netanyahu-Clinton conversation regarding Pollard was confirmed in a November 1998 *Times* article by James Risken and Steve Erlanger. Clinton had gone to Director of Central Intelligence George Tenet about the possible release. Tenet threatened to resign if Clinton acquiesced to Netanyahu's request.

The *Times* reporters quoted White House spokesman David C. Leavy concerning why Clinton appeared to have a change of heart on an issue he had not seriously considered before and an issue that caused American law enforcement and intelligence officials to go "into nearly open rebellion."

According to Leavy, at Wye River Clinton had been "impressed by the force of Mr. Netanyahu's arguments" on Pollard.

One U.S. official told the *Times* that until Tenet spoke up forcefully, "[Pollard's release] was clearly on the table."

Pollard is a special case within spy craft. In his nearly 18 months of espionage in 1984 and 1985, he had purloined more top-secret documents than almost any other spy in American history—and this was for an Israeli government that publicly professes a shared kinship with their American counterparts.

Since 1998, almost every high official in defense and intelligence has commented on Pollard's situation. A bevy of strange bedfellows has populated both sides of the argument over clemency. The late Sen. Arlen Specter (R-Pa.) even argued for a full pardon. Presidents from Reagan to Obama refused to release Pollard on clemency despite an overwhelming wave of political support from D.C. to do so.

Pollard was released on parole—a legal condition at the time Pollard was convicted for those who have served over 30 years of a life sentence—on Nov. 20, 2015. His parole restrictions have remained stringent, despite multiple attempts by attorneys at lessening or releasing them altogether. He has been ordered to stay in New York City for five years. After that, it is believed he will emigrate to Israel, a returning hero to a land and a people that were never really his own.

Halper knew what would happen to him when *Clinton Inc.* was released. He "was well aware that the former (and perhaps future) first family and its massive retinue of loyalty enforcers, professional defamers, and assorted gadflies would rue my intent to examine the real Clintons." But unlike many who have exposed the Clinton family's past and present transgressions, Halper today remains alive, an editor for the news website "Drudge Report." ★

'Gay Gene' Study Shocks Liberals

• Scientists conclude homosexuality is a lifestyle choice, not a genetic condition

Throughout most of human history, homosexuality—especially open homosexual behavior—has been discouraged. One thing the Abrahamic monotheistic religions of Judaism, Christianity, and Islam all agree on is that God destroyed the people of Sodom and Gomorrah as punishment for their out-of-control public homosexual behavior. The other great religions, too, condemn homosexual acts. The Dalai Lama, to take one well-known example, has repeatedly violated the liberal taboo on criticizing homosexuality. Why? Because Buddhist teachings clearly oppose all forms of sodomy.

During the past few decades, the homosexual rights movement has overturned the collective traditional wisdom of the human race. Sodomy is now considered a basic human right.

Liberals say that some people are born gay. It would be cruel and discriminatory to deny them the same right to sexual satisfaction and marriage as everyone else.

Conservatives view sexual preference as more learned than innate. They argue that homosexual acts, like other deviant sexual practices, are choices available to all—but bad choices that generally ought to be discouraged, whether by custom, religion, force of law, or all of the above.

So who is right?

The liberal belief that people are born gay has just been debunked by a highly authoritative new scientific study, shattering the whole basis of the argument that homosexuality is a basic human right.

According to the new study published Aug. 30 in *Science* magazine, less than one-third of an individual's propensity to engage in homosexual acts can be explained by genetics—and this in-



fluence is the result of combinations of many genetic influences. In other words, there is no "gay gene"; nobody is "born gay."

The researchers found that the sum total of various detectable genetic factors had only a small influence, between 8% and 25%, on the likelihood of someone's homosexuality. So what kind of genes make it a little bit more likely that the person will engage in homosexual acts?

The New York Times reported: "In a finding that could be especially sensitive, the researchers found that whether someone ever engaged in same-sex sexual behavior showed genetic correlations with mental health issues, like major depressive disorder or schizophrenia, and with traits like risk-taking, cannabis use, openness to experience, and loneliness."

It is certainly understandable that someone who feels unusually lonely might go to a gay bar,

someone who seeks out unusual experiences might try sodomy and get hooked on it, or that someone who craves risk might be unusually willing to risk contracting AIDS and other diseases by engaging in adventurous non-procreative sexual behavior. But none of this offers the slightest support to the now-falsified notion of being "born gay."

Since there is no such thing as a "homosexual" or a "gay person," just sexual acts that all people can choose or avoid, liberals arguing for a basic human right to sodomy will have to abandon the "born gay" paradigm in favor of libertarianism. That is, they will have to argue that neither religion nor state nor custom should impede or regulate the sexual behavior of consenting individuals.

At first glance this argument seems persuasive. Why should any of us worry about what other people do with their own bodies?

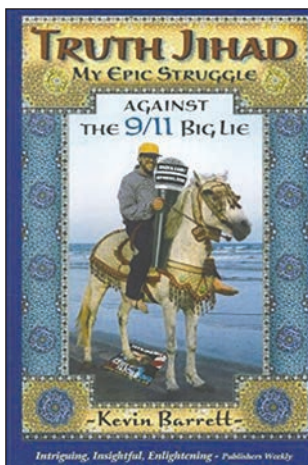
Conservatives answer that the collective wisdom of the ages dictates that sexuality should be restricted to reproductive relationships. The basis of all human

relationships is the reproductive family. Channeling sexual desire, especially the testosterone-fueled desires of young males, away from debauchery, rape, and pillage, and toward caring for women and children and other weaker members of society, is the most basic human imperative. Any society that makes no effort to restrict sexuality to heterosexual reproductive marriage, but instead allows it to run rampant, will soon suffer the fate exemplified, in extreme form, in the stories of Sodom and Gomorrah.

Conservatives, following the great Christian thinker René Girard, also note that public displays of sexuality tend to excite imitation. So while private sexual behavior, as long as it is genuinely private (i.e., unknown to others) is not a problem, public sexual display or communication will always tend to stir up others and tempt them to imitate whatever is being displayed or communicated.

In today's post-Christian West, each generation pleasures itself by breaking the previous generation's taboos. Which taboos will be broken next? Will incest, necrophilia, and bestiality soon be viewed as basic human rights? Will public sex become the norm? Will adults claim the "basic human right" to have sex with consenting children and animals? Will the United Nations try to force these practices on all of the world's peoples, including those who have held more tightly to their sacred traditions than Westerners have? ★

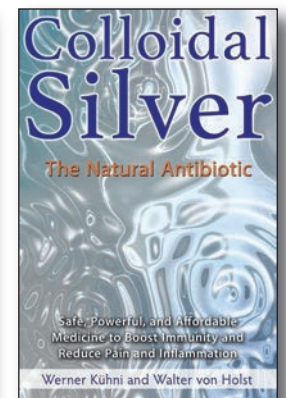
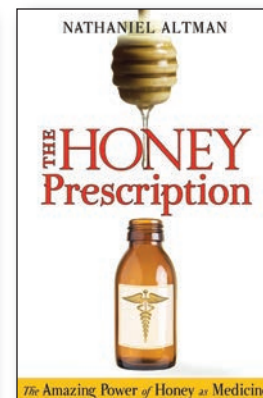
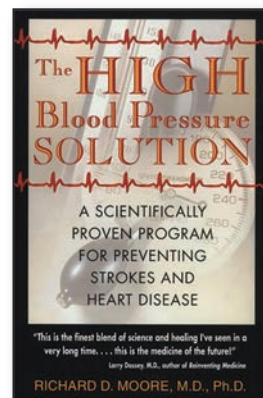
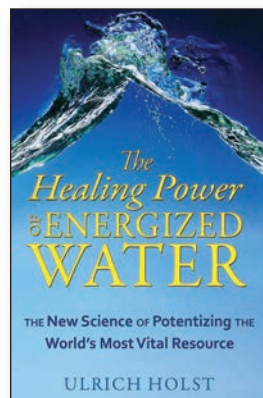
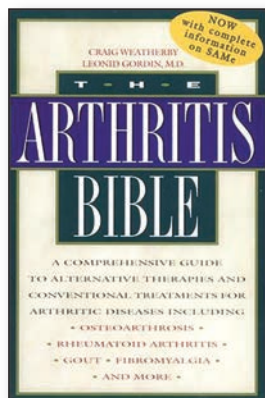
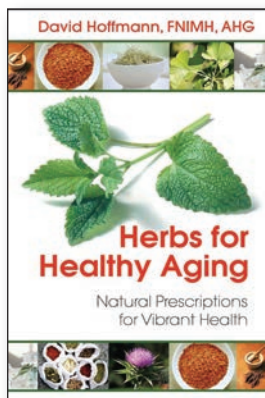

Studies Contradict Leftist Narrative That White Cops Are Racist Killers

A recent study from Michigan State University and the University of Maryland flatly contradicts the popularly held, mainstream media-driven notion that white police officers are targeting black citizens. The research, in fact, demonstrates that white police officers are not more likely to shoot minorities than nonwhite officers are.

“Until now, there’s never been a systematic, nationwide study to determine the characteristics of police involved in fatal officer-involved shootings,” Michigan State University professor and study co-author Joseph Cesario declared. “There are so many examples of people saying that when black citizens are shot by police, it’s white officers shooting them. In fact, our findings show no support that black citizens are more likely to be shot by white officers.”

Cesario went on to say: “We found that the race of the officer doesn’t matter when it comes to predicting whether black or white citizens are shot. If anything, black citizens are more likely to have been shot by black officers, but this is because black officers are drawn from the same population that they police. So, the more black citizens there are in a community, the more black police officers there are.”

Cesario bluntly maintained: “Many people ask whether black or white citizens are more likely to be shot and why. We found that violent crime rates are the driving force behind fatal shootings. Our data show that the rate of crime by each racial group correlates with the likelihood of citizens from that racial group being shot. If you live in a county that has a lot of white people committing crimes, white people are more likely to be shot. If you live in a county that has a lot of black people committing crimes, black people are more

likely to be shot. It is the best predictor we have of fatal police shootings.”

The response from the academic world to Cesario’s findings was predictable. He was criticized for a decision to “sidestep the benchmark” of using population as a determining factor in calculating racial disparity. Princeton professor Jonathan Mummolo, for example, argued that flawed methodology assumes that black and white officers encounter black civilians in equal numbers, or in even temperaments. University of Nebraska professor Justin Nix, in a 2017 study, found that police had killed nearly twice as many whites as blacks that year.

An independent study of all the numerous cases of egregious police behavior, documented in videos by victims, onlookers, and the police cameras of law enforcement itself, shows a great diversity in those harassed, tasered, and shot. There is just as much diversity in terms of law enforcement officers who act inappropriately.

In one of the more horrendous miscarriages of justice imaginable, homeless man Kelly Thomas was viciously beaten to death by a group of police officers in July 2011. One of the two officers actually charged in the case, and the one who precipitated the violence, was Manuel Ramos, who is Hispanic. The victim here, Thomas, was white. The entire crime was caught on videotape, as Thomas repeatedly pled for his life and called out for his father. Despite this documented evidence, a brain-dead jury found the officers not guilty.

As in seemingly all cases of police brutality, the “brotherhood” comes together, and in this instance, the officers’ superior, Stephen Rubio, ludicrously maintained that the only “slight” violation of department policy he witnessed while watching the entire 33-minute video was the officers’ use of profanity.

Other notable examples of law enforcement abusing their authority include the female officer—who’d already been transferred from an-

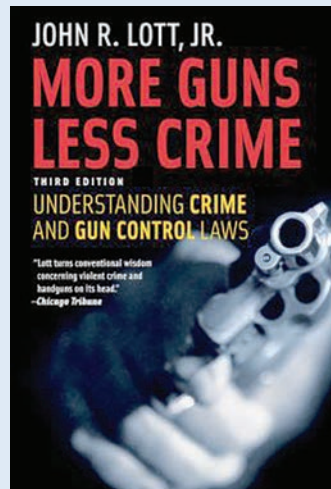
other police force after shooting a woman reaching into her purse—who shot and killed a young white male who answered her knock at his front door with a video game controller in his hand. In 2017, Australian-born white woman Justine Damond was shot and killed by Somali-born Minneapolis police officer Mohamed Noor as she leaned into the driver’s side window of the squad car. Damond had called the police to report a loud altercation in the neighborhood, and was calmly talking to Noor’s partner at the time.

In a typically underreported 2014 incident, unarmed 20-year-old white Dillon Taylor was shot and killed outside a Utah convenience store by a black police officer. White, black, and Hispanic officers have been caught on film shooting deaf people who naturally didn’t respond to their verbal commands, in the back, shooting jaywalkers, slamming skateboarder kids to the pavement, and throwing people of all races and genders out of wheelchairs.

The only constants in these tragic cases is the failure of either law enforcement oversight or the legal system to hold bad police officers accountable for their behavior and the inconsistent press coverage, of course, which all depends upon the races of the victims and officers, but generally portrays all white police officers as dangerous. ★

California Court Overturns Conviction of Illegal Alien Killer of Kate Steinle

- Sanctuary state jury shoots down gun conviction of repeat offender

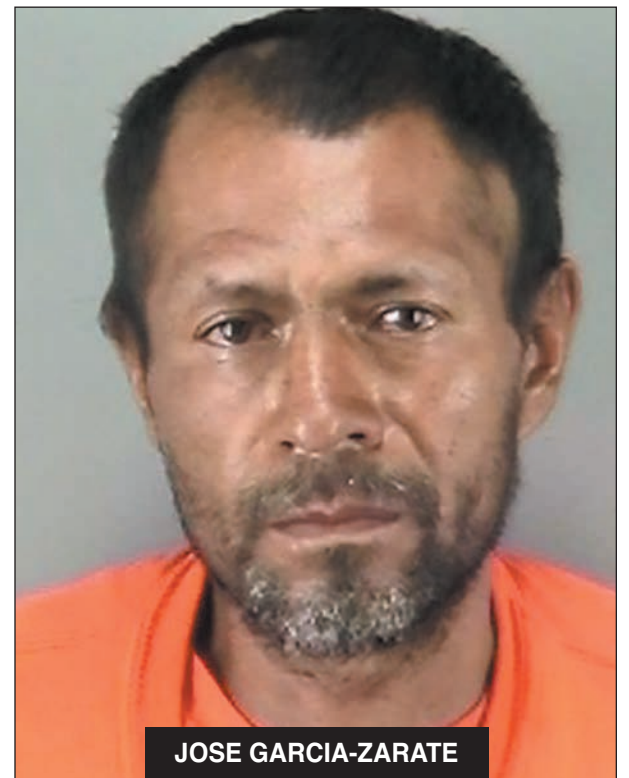
An appeals court in San Francisco has overturned the conviction of an illegal alien who shot and killed 32-year-old Kate Steinle. Her senseless death in the summer of 2015 sparked outrage and fueled the debate over illegal immigration in the lead up to the 2016 presidential election.

In late August, the First District Court of Appeal in San Francisco overturned the one conviction against Jose Inez Garcia-Zarate, who had previously been acquitted of first- and second-degree murder, involuntary manslaughter, and assault with a semi-automatic weapon in November 2017, for his role in Steinle's death. Garcia-Zarate was convicted of one count of being a felon in possession of a firearm by the state of California, but even that conviction has now been dismissed after the state appeals court overturned it.

Garcia-Zarate still remains in federal custody and is facing federal charges relating to gun possession and illegally residing in the country. The man, who has had many run-ins with law enforcement for drug-related crimes in several states including multiple felony charges, had previously been deported from the United States to his native Mexico on five separate occasions, yet

continued to re-enter the country illegally.

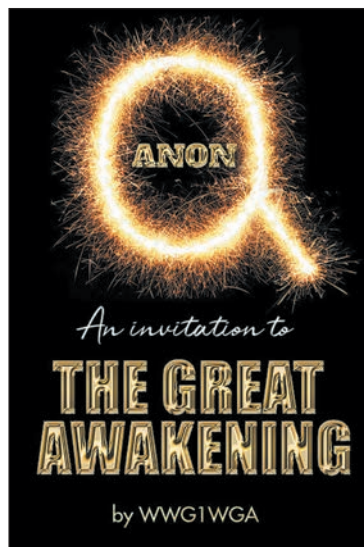
"The state-court ruling has no legal effect on the federal prosecution, which will continue," U.S. Attorney David Anderson stated following the appeals court ruling. "A repeatedly deported,

previously convicted felon has no right to possess a firearm under federal law, even if California extends him sanctuary."

According to court records, on July 1, 2015 Garcia-Zarate was present at the Embarcadero near the waterfront in San Francisco, a popular tourist hot spot. Steinle was walking with her father and another friend near Pier 14 when she was struck by a stray bullet that was fired from a gun Garcia-Zarate picked up. Garcia-Zarate's attorneys have argued that the drug-addled illegal alien did not realize he had picked up a gun, which was wrapped in a T-shirt, until he had accidentally misfired it. The bullet ricocheted after being fired, eventually striking Steinle in the back, resulting in her death. Garcia-Zarate then threw the gun, which was later discovered to

have been stolen from a Bureau of Land Management agent's car, into the water off the pier, and proceeded to walk away before he was apprehended.

The young woman's tragic death was used as a rallying cry for immigration hawks and then-candidate Donald Trump, who repeatedly invoked Steinle's death during rallies and other speaking engagements to highlight the dangers of illegal immigration and open borders along with the perils of sanctuary cities and states like California. Months before Steinle's death, Garcia-Zarate was released from custody after a drug case against him was dropped by local authorities in San Francisco. Because of the city and state's liberal sanctuary laws, federal immigration officials were not made aware of his release even though he was residing in the country illegally and was a serial criminal.

"Kate Steinle was tragically killed because San Francisco proudly proclaims itself a sanctuary city," U.S. Citizenship and Immigration Services Acting Director Ken Cuccinelli tweeted following the appeals court decision. "How many more innocents will die before sanctuary cities stop harboring violent criminals? This defies common sense, public safety, and human decency."

The San Francisco Police Officers Association was equally as critical of both state and local officials' handling of the case and the absurd sanctuary laws, which protect illegal aliens rather than American citizens.

"This is yet another disgusting injustice perpetrated by a broken criminal justice system that is more intent on re-harming victims of crime and their families than holding violent offenders accountable," Tony Montoya, the president of the Police Officers Association, stated in the aftermath of the state appeals court decision. ★

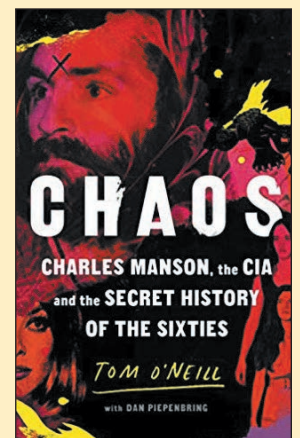

Timing Not Yet Right for Tariffs

Economist Michael Hudson once said, “Lenin said that capitalists would sell the Communists the rope to hang them. But as matters turned out, capitalists let China sell them the labor that served to hang American capitalism.”

I was surprised to be given credit by readers for Trump ordering American corporations out of China and to bring the jobs back to the American workers that the corporations had abandoned. American economists, financial media, and Washington policymakers had never paid any attention to my analysis of U.S. economic decline in terms of globalism and the offshoring of U.S. jobs and technology, and I thought readers hadn’t, either. Many readers tell me that economics is over their heads. My economic articles are the least read on my website.

I was again surprised when foreign media, including Press TV in far distant Iran, immediately contacted me requesting an interview about my influence on the White House. What does it all mean?

First, I will say that it is possible that someone showed Trump my “tariffs” column, and that the light switched on. But it is also possible that Trump ordering the corporations home is just an escalation in his threats and reflects not his understanding but the impotence of tariffs to correct the lack of good jobs for Americans and the decline in their real incomes.

However, in the event a light went on in the White House, and that Trump might be shown how to proceed in bringing the offshored jobs back to America where they belong, I will address the issue.

When the Soviet Union unexpectedly and suddenly collapsed, China and India gave up on socialism and opened their economies to Western

capital. The Soviet Union did not collapse because Reagan won the Cold War, a goal that Reagan disavowed, but because hardline elements in the Communist Party leadership were concerned that Mikhail Gorbachev was careless in trusting the Americans and was retreating from the Soviet Empire too cavalierly. To halt the dissolution of the empire that protected Russia from land invasion, the

hardline Communists placed Gorbachev under house arrest. It was this that initiated the collapse that left Boris Yeltsin, a Washington puppet, in charge, as Washington dismantled the Soviet Union and proceeded to steal—together with Israel—Russia’s resources.

The conclusion reached by India and China, the countries with the largest populations, was that socialism leads to collapse, but capitalism leads to riches. For the first time the vast under-employed labor resources of the world’s two most populous countries were available for foreign exploitation. The labor could be exploited, that is, paid less than its contribution to output, because an immense over-supply of labor existed in the labor market. The excess supply of labor meant that a work force could be hired for far less than it contributed to the corporation’s earnings.

Corporate CEOs and directors—and Wall Street—noticed this opportunity to increase profits. The first corporations that rushed into China were disappointed, and the word went out that the opportunity wasn’t as good as it looked. But China worked to make offshored production a lucrative adventure, and manufacturing jobs left the U.S. in the droves. The consequence was that the U.S. middle class shrank, and with it the tax base of states and cities. America ceased to prosper, but the economic hurt was covered up with fake inflation, employment, and GDP growth reports, and Federal Reserve printing of massive amounts of money that propped up the prices of financial assets and real estate.

When the hurt became harder to hide, China was blamed for hurting American workers by exporting too much to America. The people blaming China did not bother to look at the percentage of imports from China that consisted of Apple computers and iPhones, Nike shoes, Levi Strauss jeans etc. The offshored production of U.S. firms constitutes a large percentage of imports. Goods and services produced by U.S. firms offshore count as imports when they are brought back to the U.S. to sell.

In other words, the “Chinese import problem” was in fact the offshored production of U.S. firms brought back to sell to Americans who no longer

were involved in the production of the goods and services and, therefore, did not have any income from the production of what they purchased. In contrast, the offshoring corporate shareholders were rolling in money.

India benefited from receiving U.S. technology and software engineering jobs, which could be performed anywhere and the work product sent over the Internet. Indian education and English language skills made it easy for U.S. tech firms to use work visas to bypass U.S. university graduates.

What resulted over the last quarter-century was the dismantling of the supply chains and labor force that supported American manufacturing and industry. The once-booming factories and industrial sites are closed and run down or converted into condos or apartments. If Trump can bring the U.S. corporations home, where do they go?

The offshoring era wasn't a six-month economic recession. It was years when skilled and experienced labor aged and died, and no new entrants learned the skills and work discipline. Today China is a fully developed manufacturing and industrial economy. The United States is not.

For U.S. corporations to come back home, they have to leave a developed economy in China for a semi-developed or undeveloped one in the U.S. If they are compelled to do this all at once, they will lose their production in China before they can recreate the plant and equipment, work force, supply chains, and transportation systems essential to renew the U.S. as a manufacturing and industrial power. If you look at the payroll jobs reports, it has been many years since the U.S. created manufacturing and industrial jobs.

A quarter-century of capitalist flight from the American work force has left the United States similar to India a half-century ago, a country whose jobs consist mainly of lowly paid domestic service jobs. The absence of livable jobs is why so many Americans aged 24-34 cannot live an independent existence and live at home with parents or grandparents. It is why university graduates cannot repay their student loans and have been turned into debt slaves.

In order to bring American corporations home from China, this is what Trump has to do. The transition has to be gradual. The corporations can only phase out their offshored production in China as they can recreate the necessary conditions for producing in the U.S. The process is, in effect, like bringing development to an undeveloped economy.

Trump, that is, the U.S. government, will have to compensate the corporations for the enormous increase in their labor (and regulatory, liability etc.) costs associated with again producing for U.S. markets with U.S. labor by changing the way the corporations' income is taxed. Companies that produce for their domestic market with domestic labor would have a low tax rate. Companies that produce abroad with foreign labor for their U.S. market would have a high tax rate. The difference in the tax rates can be calculated to offset the labor cost differential. Companies that produce abroad for sale abroad would not be affected.

If Trump orders U.S. corporations out of China before they can reconstruct the conditions for manufacturing and industry in the U.S., the firms will be without sales and revenues and fail.

The question is raised whether Trump can order U.S. firms to leave China and return home. There are two reasons Trump's order might be simply

rhetoric. One is that the corporations are content with their existing profits that flow from low-cost labor and have no intention of losing the cost savings. U.S. global corporations have the wealth to interfere in U.S. elections and elections in every country in which they have a presence. If Trump goes against the global corporations, he will not receive their campaign funds. His opponent will, instead.

Trump can make the argument that the offshoring deal only worked for the corporations, not for the American people. "Free-market" economists gave assurances that better jobs would take the place of the manufacturing jobs moved offshore and that offshore production would pay back to the U.S. consumer in lower prices more than the loss of

wages from the offshored jobs. This was not the case. Have any of you experienced lower prices of Nike shoes, Levi jeans, or Apple computers and iPhones? The corporations did not deliver on the free-market promise. They lowered their costs but kept the prices up. Not a single one of the better jobs materialized. Trump will need these arguments to put the corporations on the defensive.

The second reason is that Trump is alleged not to have the power to order U.S. corporations to leave China and to return to their American work force, whatever is left of it. At one time this was probably the case. In 1952, President Truman nationalized the American steel industry in order to prevent a strike that would have stopped steel production during the Korean War. The Supreme Court ruled against Truman. But today, after the extraordinary accumulation of powers in the presidency from the Clinton, George W. Bush, and Obama regimes, and the powers given by Congress to the executive branch to fight "the war on terror," the president can rule by executive order.

Trump has cited the 1977 International Emergency Economic Powers Act as law empowering him to order U.S. firms home from China. He has many additional powers. A president who has the power to detain in violation of habeas corpus U.S. citizens indefinitely without evidence presented to a court, and who can order the execution of U.S. citizens on suspicion alone without due process of law, can order whatever he wants.

Based on the powers created by Republicans during the George W. Bush regime and Democrats during the Obama regime, Trump has the power to arrest CEOs and boards of directors who have offshored production on the grounds that they are conspiring with China to steal American jobs and to drive the United States down into the ranks of third

world countries. A far better case could be made for this than for the absurd Russiagate story that was used to stop Trump from normalizing relations with Russia.

Trump is correct that if the U.S. is to remain a world power, it is necessary to restore manufacturing and industrial capability. If the U.S. is to absorb the massive number of third world peoples it has admitted, it is necessary to restore middle-class jobs and the ladders of upward mobility.

The way Trump should proceed is to explain to the corporations that they have inflated their profits in the near term at the cost of destroying consumer purchasing power, and thereby their sales, in the longer term. Americans whose real incomes are not rising do not have the discretionary purchasing power with which to purchase the goods and services that provide revenues to U.S. corporations. Of course, the CEOs and directors are not here in the longer run, and they might not care. But a president can make it a patriotic issue and put them on the spot.

Next, Trump needs to work with the corporations to alter the way they are taxed and to recreate the conditions necessary to restore manufacturing in the U.S. This is not a simple task. It requires cooperation, not conflict.

In the meantime, immigration must be put on hold, as there is no economy to absorb the immigrants, and Washington needs to stop its wars. The associated costs, debt, and risks are far greater than the benefits. If the U.S. does not reverse its course, it will end up an undeveloped country. This is a far greater threat to us than alleged dictators and alleged terrorist-supporting states in the Mideast. ★

Will Trump Finally End the War in Afghanistan?

• U.S. embroiled in far too many foreign wars

By Patrick J. Buchanan

In mid-August, President Donald Trump met in New Jersey with his national security advisers and envoy Zalmay Khalilzad, who is negotiating with the Taliban to bring about peace, and a U.S. withdrawal from America's longest war.

U.S. troops have been fighting in Afghanistan since 2001, in a war that has cost 2,400 American lives.

Following the meeting, Trump tweeted, "Many on the opposite sides of this 19-year war, and us, are looking to make a deal—if possible!"

Some, however, want no deal; they are fighting for absolute power.

On Aug. 17, a wedding in Kabul with a thousand guests was hit by a suicide bomber who, igniting his vest, massacred 63 people and wounded 200 in one of the greatest atrocities of the war. ISIS claimed responsibility.

Two days later, 10 bombs exploded in restaurants and public squares in the eastern city of Jalalabad, wounding 66.

Trump is pressing Khalilzad to negotiate draw-downs of U.S. troop levels from the present 14,000, and to bring about a near-term end to U.S. involvement in a war that began after we overthrew the old Taliban regime for giving sanctuary to Osama bin Laden.

Is it too soon to ask: What have we gained from our longest war? Was all the blood and treasure invested worth it? And what does the future hold?

If the Taliban could not be defeated by an Afghan army, built up by the U.S. for a decade and backed by 100,000 U.S. troops in 2010-2011, then are the Taliban likely to give up the struggle when the U.S. is drawing down the last 14,000 troops

and heading home?

The Taliban control more of the country than they have at any time since being overthrown in 2001. And time now seems to be on their side.

Why have they persevered, and prevailed in parts of the country?

Motivated by a fanatic faith, tribalism, and nationalism, they have shown a willingness to die for a cause that seems more compelling to them than what the U.S.-backed Afghan government has on offer.

They also have the guerrillas' advantage of being able to attack at times and places of their own choosing, without the government's burden of having to defend towns and cities.

Will these Taliban, who have lost many battles but not the war, retire from the field and abide by democratic elections once the Americans go home? Why should they?

The probability: When the Americans depart, the war breaks out anew, and the Taliban ultimately prevail.

And Afghanistan is but one of the clashes and conflicts in which America is engaged.

Severe U.S. sanctions on Venezuela have failed to bring down the Nicholas Maduro regime in Caracas but have contributed to the immiseration of that people, 10% of whom have left the country. Trump now says he is considering a quarantine or blockade to force Maduro out.

Eight years after we helped to overthrow Col. Muammar Qadhafi, Libya is still mired in civil war, with its capital, Tripoli, under siege.

Yemen, among the world's humanitarian disasters, has seen the UAE break with its Saudi interventionist allies, and secessionists split off southern Yemen from the Houthi-dominated north. Yet, still, Congress has been unable to force the Trump administration to end all support of the Saudi war.

Two thousand U.S. troops remain in Syria. The northern unit is deployed between our Syrian Kurd allies and the Turkish army. In the south, they are positioned to prevent Iran and Iranian-backed militias from creating a secure land bridge from Tehran to Baghdad to Damascus to Beirut.

In our confrontation with Iran, we have few allies.

The Brits released the Iranian tanker they seized at Gibraltar, which had been carrying oil to Syria. But when the Americans sought to prevent its departure, a Gibraltar court ruled against the United States.

Iran presents no clear or present danger to U.S. vital interests, but the Saudis and Israelis see Iran as a mortal enemy and want the U.S. military rid them of the menace.

Hong Kong protesters wave American flags and seek U.S. support of their demands for greater autonomy and freedom in their clash with their Beijing-backed authorities. The Taiwanese want us to support them and sell them the weapons to maintain their independence. The Philippines wants us to take their side in the dispute with China over tiny islets in the South China Sea.

We are still committed to go to war to defend South Korea. And the North has lately test-fired a series of ballistic missiles, none of which could hit the USA, but all of which could hit South Korea.

Around the world, America is involved in quarrels, clashes, and confrontations with almost too many nations to count.

In how many of these are U.S. vital interests imperiled? And in how many are we facing potential wars on behalf of other nations, while they hold our coat and egg us on? ★

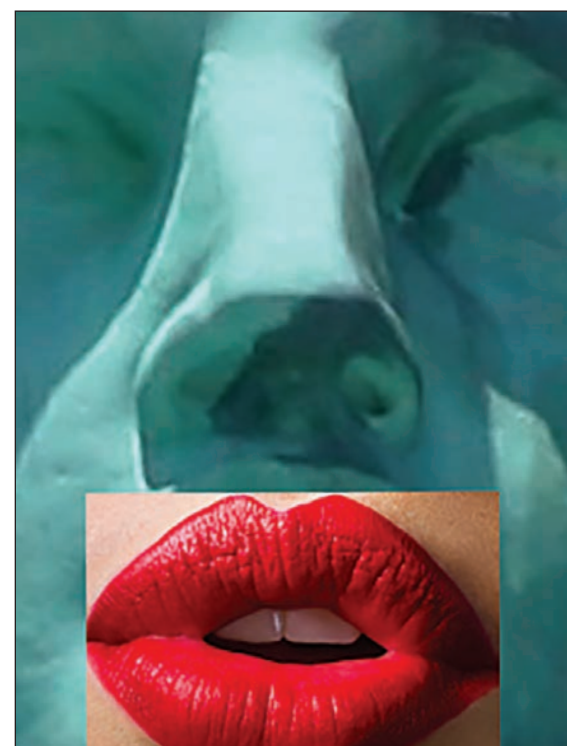
