## DHS SAYS ANTIFA A TERROR GROUP

- Government finally catches on to far left threat
- Neo-Bolshevik network coddled by leftist media

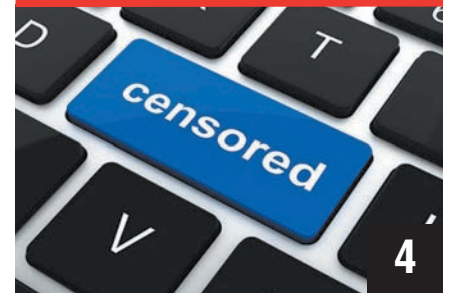
**T**he Department of Homeland Security (DHS), founded in the aftermath of 9/11 ostensibly to safeguard and protect the United States and its citizens from foreign and domestic threats, announced its new counterterrorism strategy earlier this summer.

In the ensuing weeks, the mainstream media latched onto DHS noting the few lone-wolf white supremacist mass killings as cause for concern. What the fake news media totally neglected to mention, however, is that the U.S. agency also cited the extremist, anti-government views and actions of antifa—a radical, far-left group that has been defended by multiple mainstream media talking heads.

“Today, the United States faces an evolving threat environment, and a threat of terrorism and targeted violence within our borders that is more diverse than at any time since the 9/11 attacks,” Acting Department of Homeland Security Secretary Kevin McAleenan stated during a recent event at the prestigious Brookings Institute, where he an-

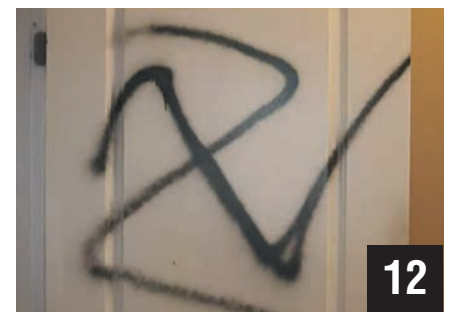

## PTDS Afflicts Vast Majority of Democrat Politicians

In this issue of AMERICAN FREE PRESS, we are dedicating considerable editorial space to debunking the latest absurd charges that are being leveled at the president. We're talking about the purported whistleblower claim that was directed against President Donald Trump alleging that he pressured a foreign official to investigate a political opponent. Once again, the American people are being subjected to a ridiculous cycle of outlandish claims concerning the president on the part of top Democrats and of the mainstream media, followed by frantic backpedaling when it is discovered those claims are nothing but fake news.

What America doesn't need right now are tens of millions more taxpayer dollars wasted on witch hunts that turn up nothing.

Right from the start, there were a number of problems with the whistleblower's statement—even aside from the fact that former Vice President Joe Biden, the supposed target of Trump's request, isn't Trump's political opponent. Biden is hardly the Democrats' presidential candidate. In fact, new polls have him losing to Sen. Elizabeth Warren (D-Mass.). But none of this has stopped unhinged Democrats from already calling for the president's impeachment and mainstream media outlets slavering over garbage news from anonymous sources that eventually they'll have to retract.

This week, among our own reports, we are publishing key excerpts from the official transcript of Trump's July 25 phone conversation with Ukrainian President Volodymyr Zelensky that clearly show anyone who claims Trump pressured the Ukrainian leader to investigate Biden and his son is lying.

There really is no reason for any of this, because the transcripts of both Trump's phone

call and the whistleblower's statement are easily obtained. Everyone can see for themselves what was discussed, including Trump asking the Ukrainian leader to cooperate with the official U.S. probe of the origins of the Russiagate scandal as well as corruption charges involving the Bidens. They are available on the internet for anyone to read for themselves for free. It is very obvious the president did not threaten or pressure anyone during the call. In fact, it was extremely friendly.

Despite this, however, Rep. Adam Schiff (D-Calif.)—the man who is actually in the position to oversee the entire U.S. intelligence community—completely made up his own version of the phone call without concern for the truth in his opening statement on Sept. 26 right before National Intelligence Director Joseph Maguire was scheduled to testify on the whistleblower's statement. It's worth noting that Maguire had already rejected the whistleblower's claim for lack of merit.

Here is what Schiff claimed that Trump had said to Zelensky "in essence":

I have a favor I want from you, though, and I'm gonna say this only seven times, so you better listen good. I want you to make up dirt on my political opponent, understand? Lots of it—on this and on that.

I'm gonna put you in touch with people and not just any people. I'm gonna put you in touch with the attorney general of the United States, my attorney general, Bill Barr. He's got the whole weight of the American law enforcement behind him and I'm gonna put you in touch with Rudy [Giuliani].


Now turn to page 18 in this week's issue and read for yourself what Trump actually said, verbatim, according to the official transcript

that was logged just after his phone call. Schiff's statement is so far removed from what the president and the Ukrainian leader had to say that this was beyond paraphrasing. Schiff intentionally lied about what the president said to bolster his call for impeachment and mislead the American public—tactics reminiscent of the now thoroughly debunked Russiagate investigation.

It is confusing to us—and to anyone not clearly blinded by PTDS (President Trump Derangement Syndrome)—why no one in Washington seems to be concerned at all about the legitimate allegations of corruption on the part of Biden and his son, Hunter, as well as the strange circumstances involving Ukraine in the Russiagate probe. That is why we also decided this week to publish key excerpts from a statement issued by the former prosecutor of Ukraine, who says Biden not only personally pressured the Ukrainian government to stop his investigation into corruption but also threatened to withhold billions in aid if the prosecutor wasn't fired and the probe stopped. Isn't that what Trump is being accused of doing?

# News You May Have Missed

## Lowest Limit Ever

The Trump administration has for fiscal year 2020 imposed the lowest-ever limit on refugees that will be accepted into the United States, setting the limit at 18,000. Last year, they set the limit at 30,000. Officials said the reduction was critical so they could direct vital resources at stemming the flow of illegal immigrants crossing into the United States at the southern border and address the “staggering” backlog of asylum seekers.

## Good News

At a hearing in late September, Judge Stephanie M. Rose of the U.S. District Court for the Southern District of Iowa ruled that University of Iowa officials must pay out of their own pockets for discriminating against a prominent Christian student group, calling the university’s conduct “ludicrous” and “incredibly baffling,” reports Fox News. The judge said the university and its officers violated constitutional law when they kicked InterVarsity Christian Fellowship, and other religious groups, off the campus in June 2018 because the groups required that their leaders uphold Christian beliefs. The university had barred the fellowship’s access to campus, froze its bank account, shut down its website, and told students that it was “defunct” for lack of interest. According to the judge, this violated the group’s First Amendment rights.

## Trust Bust

A new poll conducted by YouGov Blue and Data for Progress found that two-thirds of Americans support the idea of the U.S. federal government breaking up Big Tech companies like Google, Facebook, Twitter, and Amazon. Only 12% opposed it. Cross your fingers, as this could ultimately affect the ability of these predominately leftist companies to unilaterally censor whomever they disagree with.

## Child Abuse

On Sept. 23, 16-year-old Swedish environmental activist Greta Thunberg gave a fiery speech at the UN, angrily accusing adults of “stealing her childhood.” But, as Jim Holt with news and commentary website “Gateway Pundit” rightfully pointed out, “The Marxist Globalists stole her childhood by feeding her lies and propaganda about global warming—she believes the lies, so she is now living in fear.” She, along with her mother, has also been photographed wearing tee shirts in support of the violent and radical leftist group antifa. And there’s more: “Thunberg has a myriad of mental health is-

suess,” he writes. “She is autistic, has obsessive-compulsive disorder, and suffers from Asperger syndrome, and the left is pushing her out onto the world stage and exploiting her.” Her parents should be ashamed of abusing their child, not applauded by radical leftists.

## More About Omar’s Sham Marriage

According to conservative news website “The Federalist,” more evidence has surfaced showing that Rep. Ilan Omar (D-Minn.) committed fraud by pretending to marry her brother so she could get him U.S. citizenship. Earlier in September, Omar posted a photo to the internet where she referred to her father by the name “Nur Said.” In 2009, Rep. Omar married a man named Ahmed Nur Said Elmi. “The Federalist” notes that, in some Muslim countries, a person’s surname is actually the father’s name. This would mean that Ahmed Nur Said Elmi is actually the son of Nur Said and is Omar’s brother. When “The Federalist” and other media outlets raised this, Omar reportedly took the photograph down.

## No One Cares Part I

In the beginning of the school year this year, the University of North Carolina at Charlotte promoted a white privilege workshop on campus and encouraged students to attend. The event was supposed to teach students about “the meaning and implications of whiteness” and how “engaging in anti-racist practice is crucial in creating racial equity.” When all was said and done, however, it was evident students couldn’t care less about the subject, as only nine students bothered to show up to it, according to reports from the college.

## No One Cares Part II

Since fast-food chain Chik-fil-A was boycotted by gay activists for donating to organizations that opposed same-sex marriage in 2012, the third-largest U.S. restaurant chain has more than doubled its annual sales, proving that the majority of Americans couldn’t care less about politics so long as a company’s business practices are solid (and the food tastes good).

## Gone Too Far

New York has gone off the deep end when it comes to charges of hate crimes. Police in Gouverneur, N.Y. say they are charging an 11-year-old white girl with assault and a felony hate crime after she got into a fight with a 10-year-old black girl on a school bus. According to the police report, the little girl used “racially motivated language” toward the other girl while the two were on the bus. And it’s not stopping

there. In Buffalo, N.Y. local officials are advancing new laws that would charge parents if their kids get into a fight at school. Not everyone believes turning Americans into criminals for childish behavior is the right thing to do. “I had a mother call me who wanted a 3-year-old on the playground arrested,” Ross Ellis, the founder and chief executive of Stomp Out Bullying, told *The New York Times*. “I get that you don’t want your child beaten up, but it’s got to stop on both ends.”

## Left Coast Hypocrisy

The Left Coast of the United States loves to lecture the rest of the country on such things as how to eat healthy, what kind of car you should drive, and whether you should be able to use a plastic straw. A new study, however, reveals that California has the worst air in the entire country—almost entirely the result of the pollution caused by too many cars on the roads. Now the Trump administration is saying, “enough,” and threatening to withhold billions in highway funds unless the state cleans up its act. In a letter to state officials, Environmental Protection Agency (EPA) Director Andrew Wheeler wrote, “California has failed to carry out its most basic responsibilities under the Clean Air Act, and, as a result, millions of Californians live in areas that do not meet our nation’s air quality standards. EPA stands ready to work with California to meet the Trump administration’s goal of clean, healthy air for all.”

## Ban Pointy Knives

Due to the rising number of knife attacks in the United Kingdom, church leaders in the diocese of Rochester are now calling on the government to ban pointy knives. Reports the UK news website “Premier”: The religious officials recently issued a public letter saying, “The UK has worked for the public good by restricting handguns, paracetamol, smoking in public, and plastic bags—now it is time to say ‘no bloody point.’” It’s not like conservatives didn’t warn liberals that this was going to happen if they went on a banning spree and outlawed certain types of weapons.

# Free Speech Coalition Forms to Stop ‘Digital Book Burning’

**A** growing number of concerned figures on the internet, all with a significant audience on social media, have formed an organization, presently known as Stop Bit Burning. This writer is proud to be a part of the effort to turn the tide against the draconian censorship that has dramatically impacted independent voices on every social media platform.

On Sept. 27, this writer participated in a cyber conference with several popular YouTubers and other interested parties. It was the first meeting of those interested in exploring all possible avenues, with the goal of restoring free speech on the internet.

Dustin Nemos, who is spearheading the campaign, presided over the meeting, along with the attorney he’s retained, Todd McMurty. McMurty is also one of the attorneys for embattled Kentucky teenager Nicholas Sandmann. McMurty discussed all the potential legal options, including anti-trust and class-action lawsuits.

Some prominent voices outside the internet are troubled by the heavy-handed tactics of YouTube, Google, Twitter, and Facebook. Republican Sens. Ted Cruz (Texas) and Josh Hawley (Mo.) wrote a letter to the Federal Trade Commission in which they stated: “Big tech companies like Google, Face-

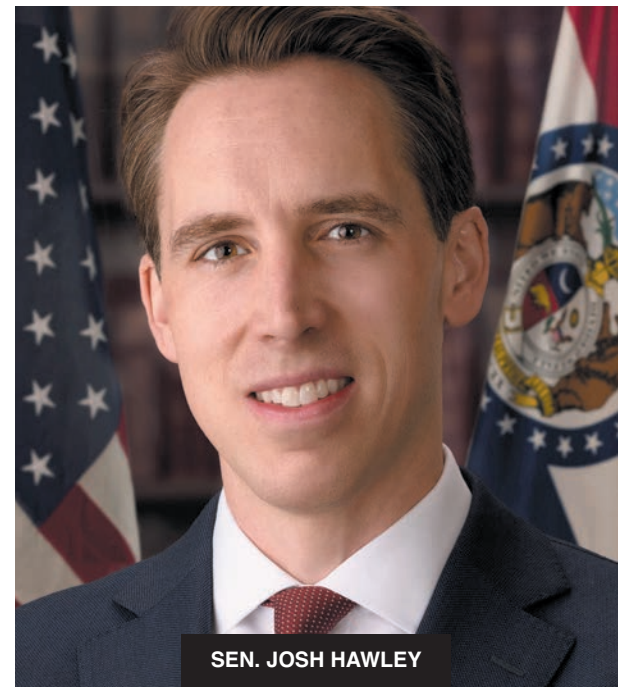
book, and Twitter exercise enormous influence on speech. The vast majority of internet traffic flows through just a handful of these companies. They control the ads we see, the news we read, and the information we digest. And they actively censor some content and amplify other content based on algorithms and intentional decisions that are completely nontransparent.”

Earlier this year, liberal professor and psychologist Dr. Robert Epstein told the Senate Judiciary Committee that Google has the ability to manipulate votes by using proprietary tools that bias search results, which could potentially swing some 10 million votes. In June 2019, Project Veritas exposed how Pinterest was blocking pro-life groups by classifying them as “pornography,” as well as tampering with autocomplete, trends, notifications, and recommendations for search terms such as “Christian.” Twitter responded by suspending the Project Veritas Twitter account, and YouTube took down the video in question, citing a privacy complaint.

The popular YouTube channels run by Dustin Nemos, Sean of SGT Report, and Crrow777 (all of whom participated in the Sept. 27 conference) have had their videos demonetized and removed, and some have had their accounts at least temporarily shut down. Alex Jones, the biggest name in the conspiracy world, was completely de-platformed by the social media giants and even had his PayPal account canceled. His longtime associate Paul Joseph Watson was permanently banned from Facebook, along with high-profile conservatives Candace Owens and Laura Loomer. This newspaper has also been demonetized, has had videos removed, and had ad campaigns canceled with no notice from Google.

As Nemos put it, “I believe a movement of millions of frustrated and angered patriots can stand together to take on these Big Tech companies—and put a stop to this digital book burning.”

The big tech companies have used the defense that they are private companies, which provide a public forum, and as such have the right to monitor or delete anything that violates their standards. Free-speech purists would argue that they are akin to a public town square and, in effect, are essential to anyone maintaining a normal lifestyle. If they

are permitted to ban views they disagree with, it isn’t all that different from public utilities denying water and electricity to political “heretics.”

Another individual involved in this groundbreaking effort is Zach Vorhies, who announced on Twitter, “I was a senior software engineer at YouTube/Google until I discovered their AI censorship weapons. Now I am a whistleblower fighting for justice.”

“Independent voices that threaten the establishment media narrative are being erased from the internet—BitBurned away,” Nemos explained to this writer. “If we don’t unite now, we will be snuffed out one by one until the only voices you hear are fake news.”

Crushing dissent is nothing new. No less a figure than the legendary philosopher Plato despised his fellow philosopher Democritus and campaigned to have his writings burned. The effort was a resounding success; only fragments remain of what was once Democritus’s vast body of work. But, in the digital age, when technology permits information to be transmitted almost instantaneously to most of the world, it is particularly indefensible. While those targeted thus far by the social-media monopolies have mostly been conservatives, all Americans should be outraged over any attempt to restrict free speech. ★

# DHS Also Warns of 'White Supremacist' Threat

nounced the new strategy. Thus, he said, DHS must “expand its counterterrorism mission focus beyond terrorists operating abroad, to include those radicalized to violence within our borders by violent extremists of any ideology.”

In late August, DHS published the “Strategic Framework for Countering Terrorism and Targeted Violence,” a 40-page report outlining the department’s view of the various and evolving threats facing the country, ways in which it can better coordinate with state and local governments as well as private institutions to identify and counter the threats, and how it will communicate with and educate the public on these matters.

The newly announced report does single out the alleged threat of “white supremacist violent extremists,” a policy that organizations such as the Anti-Defamation League (ADL) and Southern Poverty Law Center (SPLC) have lobbied the federal government to adopt for years.

Although threats emanating from foreign terrorist organizations remain a priority, added DHS, domestic terrorists and homegrown extremists, driven by a variety of ideologies, comprise a “growing share of the threat to the Homeland.”

This newspaper has repeatedly debunked the myth that so-called white supremacy is a threat to the country, something that groups like the ADL and the SPLC seek to perpetuate in order to raise money by frightening liberals. The re-

ality is that violence carried out by crazed individuals is not a significant threat to the population at large, and that most people who do harbor views that could be considered racist tend to be law-abiding and peaceful.

But what was not reported by almost all of the media outlets in the United States was that DHS specifically cited “anti-government/anti-authority violent extremism,” which has been an additional “significant motivating force behind domestic terrorism.” Officials referred to the antifa-inspired attempted firebombing of an ICE facility in Washington earlier this year, which this paper reported on at the time.

AFP has repeatedly outed the major media outlets and “pundits” that defend and enable violence carried out by the radical, far-left organization. Highly paid talking heads from CNN, MSNBC, and NBC as well as journalists from major U.S. newspapers have all come to the defense of this group of black-clad, masked individuals, who can be seen on video beating up and harassing innocent people as well as police. As noted, one antifa member went so far as to firebomb a U.S. immigration facility and shoot at law enforcement officials.

Now, U.S. law enforcement is at least acknowledging the growing threat from this organization—but it comes a little too late for the thousands of victims antifa has already terrorized. ★

# Facebook Wants Censorship Powers

• Mark Zuckerberg declares social media site a “fully censoring publisher”

Facebook, like a digital Random House, is a publisher. Or, that’s how CEO Mark Zuckerberg now defines his social media conglomerate of 16 years. In declaring itself a publisher and not a platform, it has simultaneously broadened its right to censor while exposing itself to myriad legal entanglements.

A platform is a medium, a company, a technology, or a means by which information can be distributed. Your phone and your text messenger app are platforms. If you curse or say something offensive on a call or in text, AT&T or Verizon or Sprint or Apple won’t censor you. They are merely providing the means by which you can communicate, but you will be responsible for the consequences of your own free speech decisions. A publisher, on the other hand, chooses the content it will allow to be published under its moniker. Producers of magazines, newspapers, and television news are publishers. Thus, they are legally responsible for the validity and effects of the content which they produce.

This new specification of purpose for Facebook was brought in response to a lawsuit joined by conservative activist Laura Loomer after she and others were banned from the social media giant. In a motion to dismiss Loomer and the others’ suits, Facebook claimed, “Under well-established law, neither Facebook nor any other publisher can be liable for failing to publish someone else’s message.” Loomer was banned under the “dangerous individuals” policy set up by Facebook to bar those they feel may cause violent, public disturbances.

The problem for Facebook now is that they can be held responsible for a litany of libel charges. Much of the Facebook chatter is personal, some heated. Unless Facebook knows the story behind someone’s strife with someone else, how can they discern truth from fiction, libel from fact? As a publisher and not a platform, they would be responsible for the validity of all content. Zuckerberg curiously agreed.

When asked if, indeed, Facebook is responsible for the content published on its app, Zuckerberg agreed that it is. “We didn’t take a broad enough view of our responsibility, and that was a big mistake,” Zuckerberg said. “It was my mistake, and I’m sorry. I started Facebook, I run it, and I’m responsible for what happens here.”

At this point, the team of attorneys accompanying Zuckerberg must have been stricken with shock. The American Bar Association already stated publicly that Facebook is the number one locale for evidence in divorce cases. Imagine the number of personal libels, declarations of impending suicides, threats of violence, instances of

teen bullying, and copyright infringements are posted on Facebook in an hour. In asking users to “report” offensive content, the onus has always been on the masses. Zuckerberg, in one swoop, admitted that it is now on Facebook, whether the offense is reported or not.

Facebook very much wants to hide behind Section 230 of the Communications Decency Act of 1996. Written to combat an exploding porn industry at the dawn of the internet, Section 230 allows owners of websites, forums, and message boards to set guidelines and standards that can be controlled and enforced through an editing process. In doing so, they can further retain their status as a platform and not a publisher, while making discretionary choices about content.

Michael Brendan Dougherty of the “National Review” website wrote that Section 230 “is now the legal remit under which social-media giants shadow-ban, block, and censor conservative speech.” Loomer absolutely agrees.

Facebook wants wider censorship powers. If they are to remain a platform, they would have to

micromanage statements, similar to when a radio station chooses to bleep a curse word from a song or a statement. Zuckerberg’s goal is to ban a collection of artists rather than words in a song. In doing so, arguing that you are a platform as you wade in a swamp of censorship hypocrisy is untenable. A book publisher, for example, can choose who it prints and who it rejects. It isn’t obligated to print every manuscript it receives.

For Facebook, they desire having the pie and eating it, too. They’ve maintained all of their free speech rights without caring an iota about a responsibility that they have placed on the shoulders of the individual user. They want their very profitable billions of users (marks for advertising revenue) to continue using the service, and using it as they do now, as a vital part of their daily communications and socialization. Yet they want the censorship baton to fall upon their own chosen targets without judgment or litigation. After all, how can they remain the largest tool in the Deep State’s kit if they cannot fully control the information that passes through their doors? ★

# U.S. Universities Bow to Pressure

• Trump's Education Department says protesting Israel is a hate crime

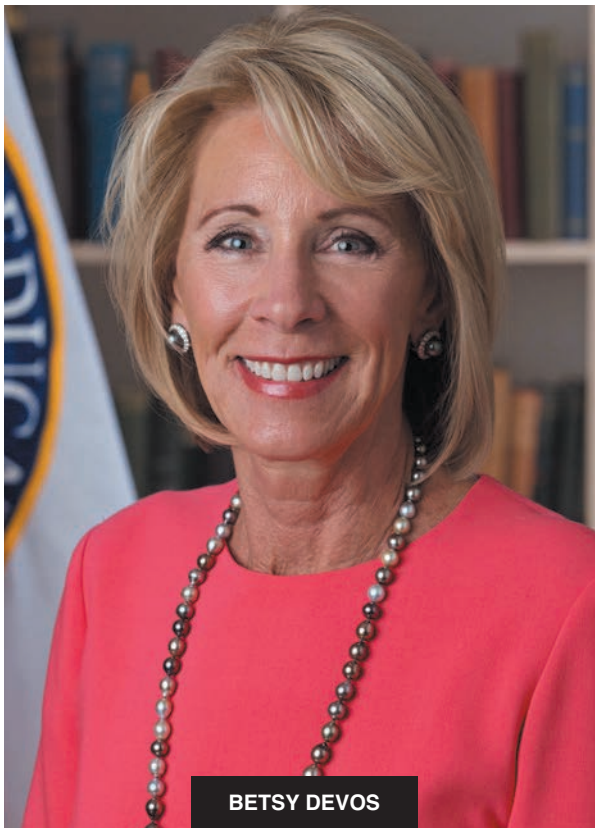
The Israel lobby in the United States and its counterparts in Europe have been paying particular attention to curtailing the activities of the Boycott, Divestment, and Sanctions movement (BDS). This is because BDS, which is non-violent and based on established human rights principles, is extremely appealing to college students, who will be tomorrow's leaders. Israel, which promotes its own largely fictional narrative about itself, is reluctant to allow any competing stories about its foundation and current activities, so it has worked hard to exclude any and all criticism of its practices on college campuses and even among students in public high schools.

Unfortunately, many colleges and universities are all too ready to compromise their principles, such as they are, whenever a representative of Israel or of Jewish groups comes calling. A popular line that has proven to be particularly effective is that Jews on campus feel threatened whenever anyone advocates for the Palestinians or Iranians, intended to convey that their civil rights are being violated. Even if that type of allegation is actually relevant to whether or not one allows free speech and association, one wonders how violated the Palestinians and Iranians must feel when confronted by the endless stream of hostility emanating from the U.S. media and Hollywood as well as from select politicians representing both parties and the White House.

In the most recent manifestation of suppression of views critical of Israel, the federal government's Department of Education has ordered Duke University and the University of North Carolina at Chapel Hill to reorganize the Consortium for Middle East Studies program run jointly by the two colleges based on their failure to include enough "positive" content relating to Christianity and Judaism. The demand came with a threat to suspend federal funding of Title VI Higher Education Act international studies and foreign language grants to the two schools if the curriculum is not changed.

Of course, the demands have nothing to do with Christian groups demanding inclusion and everything to do with organized Jewish pressure to present Israel in a positive light while also casting aspersions on the Jewish state's perceived enemies in the region and also on university campuses. Anyone who has even cursory knowledge about the Middle East knows that Christians and Jews constitute only a tiny minority in the region, so the emphasis on teaching about Islam, the Arabs, and the Persians makes sense if the instruction is to have any actual relevance.

One particular event that apparently led to an earlier investigation in June launched by the Education Department consisted of a conference in

March called "Conflict Over Gaza: People, Politics, and Possibilities." A Republican congressman was outraged by the development and asked Education Secretary Betsy DeVos to investigate because the gathering was full of "radical anti-Israel bias."

Even *The New York Times* acknowledged in their coverage of the story that "Betsy DeVos, the education secretary, has become increasingly aggressive in going after perceived anti-Israel bias in higher education." Her deputy—who has served as a focal point for the effort to root out anti-Israel sentiment—is Assistant Secretary of Civil Rights Kenneth L. Marcus, who might reasonably be described as "a career pro-Israel advocate."

Marcus is the founder and president of the Louis D. Brandeis Center for Human Rights Under Law, a foundation that he has used to exclusively defend the rights of Jewish groups and individuals against BDS and other manifestations of Palestinian pushback against the Israeli occupation of their country. He has not hesitated to call opponents anti-Semites and has worked with Jewish students to file civil rights complaints against college administrations, including schools in Wisconsin and California. In an op-ed that appeared, not surprisingly, in *The Jerusalem Post*, he observed that even when student complaints were rejected, they created major problems for the institutions involved. "If a university shows a failure to treat initial complaints seriously, it hurts them with donors, faculty, political leaders, and prospective students."

Last year Marcus reopened an investigation into

alleged anti-Jewish bias at Rutgers University that the Obama administration had closed after finding that the charges were baseless. Marcus indicated that the re-examination was called for, as his office in the Education Department would henceforth be using the State Department definition of anti-Semitism that includes "denying the Jewish people their right to self-determination," making much criticism of Israel a hate crime.

In the current North Carolina-Duke case, DeVos and Marcus expressed concern over content that had "a considerable emphasis placed on understanding the positive aspects of Islam, while there is an absolute absence of any similar focus on the positive aspects of Christianity, Judaism, or any other religion or belief system in the Middle East." The complaint called for balancing content relating to "the historic discrimination faced by, and current circumstances of, religious minorities in the Middle East, including Christians, Jews, Baha'is, Yazidis, Kurds, Druze, and others."

Zoha Khalili, a staff lawyer at Palestine Legal, explained how the message coming from Washington is actually quite simple and has nothing to do with balance: "They really want to send the message that if you want to criticize Israel, then the federal government is going to look very closely at your entire program and micromanage it to death. . . . [It] sends a message to Middle Eastern studies programs that their continued existence depends on their willingness to toe the government line on Israel."

The possible consequences are very clear. If you are an educational institution that criticizes Israel in any way, shape or form, you will lose any funding you receive from the federal government. The move has nothing to do with budgetary demands or the national security of the United States or even with the efficacy of the programs that are being funded. It has everything to do with promoting Israeli interests. That a demonstrated and outspoken Israeli advocate like Marcus should be placed in a key position to decide who gets what based on his own biases is a travesty, but it is something that we should all be accustomed to by now, as there is apparently no limit to what the Trump administration is willing to do for Israel and for that monstrous country's powerful, wealthy, and incessantly vocal supporters in the United States. ★

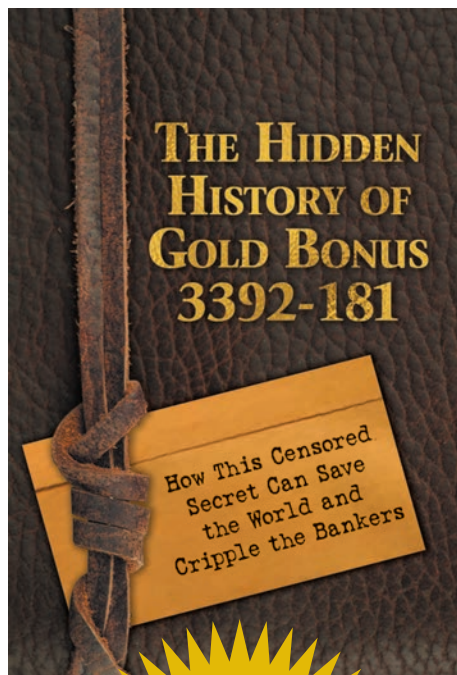

# Fake News CNN Smears Politicians Who Criticize Israel, Israeli Policy

President Donald Trump has repeatedly branded CNN “fake news.” On Sept. 9 Trump tweeted that CNN is “bad for the USA” and that foreign leaders are always asking him why CNN and other mainstream media “hate the USA so much.”

If Trump answered the foreign leaders honestly, he would tell them CNN’s disloyalty to the U.S. is rooted in its loyalty to a foreign power. CNN offers relentlessly pro-Israel coverage, demonizes Israel’s enemies, and smears patriotic American politicians, including Jews, who say things Israel doesn’t like.

On Sept. 19 and 20 CNN outdid itself, publishing back-to-back articles designed to destroy the reputations and electoral chances of Marianne Williamson, a Jewish Democrat running for president, and Jason Lewis, a Minnesota Republican senatorial candidate. Both articles were authored or co-authored by Andrew Kaczynski, and both followed the same script: Dig up something the candidate said many years ago that could be construed as offensive to Israel, then use distortion and loaded language to create the appearance of a major scandal.

Kaczynski’s hit pieces against Williamson and Lewis were scripted to unleash the collective rage of the 500,000 political foot soldiers of what sociologist James Petras calls the Zionist Power Configuration (ZPC). The CNN-instigated outpouring of orchestrated hate from this army of Zionist fanatics will make it harder for Williamson and Lewis to win election to high office. And it will terrorize others by showing how dangerous it is to say anything that deviates from Israel’s script. One loose word and you’ll never work in this town again!

What did the candidates say that Israel hates to hear? Williamson “entertained 9/11 conspiracy theories” in a 2012 interview on my radio show, while Lewis once spoke of U.S.-Israeli dual citizen officeholders as a potential problem for the U.S. In

a sane world, neither candidate’s remarks would be controversial. Indeed, they would be viewed as massive understatements. The 9/11 neocon coup, and the related problem of dual citizens running the U.S. government, are much bigger problems than Williamson’s or Lewis’s words would indicate.

CNN’s Israel-loyal owners know that if the American people ever learn what is being done to them, the jig is up. So even the faintest hint of truth about 9/11 and dual citizens and other Israel loyalists running the U.S. government must be brutally suppressed.

How did CNN, America’s biggest news network, become an instrument of Israeli policy and a tool of Israeli infiltration of America? Therein lies a tale. CNN’s founder, Ted Turner, grew the company and quickly became America’s biggest media mogul, perhaps its only major media mogul who wasn’t a Jewish Zionist. According to an online article published on multiple websites “Six Zionist Companies Own 96% of the World’s Media,” Turner’s rise to prominence in the 1980s, especially his bid to buy CBS, panicked the ethnic-nepotism mob that dominates big media boardrooms. Mobilizing such allies as billionaire Laurence Tisch and Time Warner CEO Gerald Levin, the MSM Kosher Nostromy stymied Turner’s efforts to gain control of a major network, then finally bought him out and took over CNN.

Trump, like Turner during the 1980s, is trying to operate as an American in an environment dominated by Israel loyalists. Just as Turner’s media colleagues, employees, and competitors included a wildly disproportionate number of people who, for ethnic or ideological reasons, were fanatically devoted to Israel, so too has Trump found himself in an Israel-centric environment. Trump’s biggest financial backer, Sheldon Adelson, the Las Vegas casino magnate, is a maniacal Israel-firster. His “first son-in-law” Jared Kushner is likewise a Zionist. And most of his foreign policy advisors, including Mike Pompeo and now John Bolton’s replacement, Robert O’Brien, made their stripes by kissing up to Israel—notably by opposing normalization of relations with Iran, which would be very much in the interest of the U.S. but not at all in the interest of Israel.

The Israel loyalists around Trump have tricked the president into entering the fast lane toward war with Iran—a fast lane with no exit. Iran won’t back down. So Trump has two choices: He can either allow the neocons, and their compliant Israel-centric media, to drag America into another far more disastrous Middle Eastern war or he can shake off the neocon influence and bring on a new team of America-first advisors who think more like Rand Paul and Tucker Carlson than Pompeo and Bolton.

If he decides to put America first, Trump is going to have to up the ante in his war with our Israel-first media. Antitrust action and arrests of foreign agents would be a good start. ★

# Media Displays a Clear Bias Against Legal Gunowners

- Coverage of town hall meeting on mass shootings suppressed

The last in a three-part series of townhall meetings to explore mass shootings, sponsored by San Antonio District 8 Councilman Manny Pelaez, was heavily attended by pro-Second Amendment supporters who stood their ground and made sure the forum didn't become another anti-firearms crusade, yet local media spiked the story of this heavy turnout by Second Amendment defenders.

Independent cameraman Ron Avery, on hand at the forum to assist this AFP writer in getting the real story, set up his equipment right next to the videographer for KSAT Channel 12, the influential local ABC affiliate. Avery noted that the KSAT technician shot the same nearly two hours of footage that he shot, but KSAT's website and its television broadcasts failed to utilize the station's livestream footage and did not even report on the presence of the more than 100 Second Amendment advocates out of the estimated 150 people in attendance, let alone what those advocates had to say.

Avery and independent local newspaper publisher Doug Kirk, who accompanied Avery at the forum, said the situation provides a painfully clear example of the entrenched U.S. media bias against the bedrock principles of self-defense and national defense enshrined in the U.S. Constitution.

Stephen Willeford, the Sutherland Springs resident known for using his handgun to engage the active shooter at the First Baptist Church "mass shooting" in that quiet, rural Texas community on Nov. 5, 2017, attended the townhall meeting and received a standing ovation when he revealed his identity while sharing his views.

The mainstream media's response to Willeford's presence and remarks? Crickets, even

though he was honored on the Senate floor of the Texas legislature in January.

"I know what it's like for my community to be attacked. I'm from Sutherland Springs; I'm the man who ran across the street and engaged an active shooter. I understand if you don't want to own a gun. As for me, I'll protect my family, I'll protect my neighbors, I'll protect my community, and I'll protect innocents everywhere I can," Willeford said, amid sustained applause.

"There are three kinds of people in this world: sheep, sheepdogs, and wolves," he added. He then compared the disarmament of the population with defanging the sheepdog, so as to make it easy prey for the wolves. "The Second Amendment keeps that [defensive weapon] in our hands, to protect our communities and even our nation if we have to," Willeford went on to say.

KSAT's online post about this last townhall meeting (a report which even got the day wrong by saying the townhall happened "Thursday" when it took place Wednesday, Sept. 18) simply noted: "Pelaez kicked off the townhall with statistics, as he has done in past townhall meetings. Ideas included the topic of background checks and gun buyback programs."

In fact, the statistics that Pelaez presented showed that AR-15 "assault rifles" are eclipsed significantly by handguns in the commission of crimes. ★

# The Media's Love Affair With Hate Crimes

• Too often they're duped by hate crime hoaxers yet never correct the record

Yet another highly publicized “hate crime” has turned out to be a total fabrication after the purported victim and her family publicly admitted the entire incident was made up.

The alleged hate crime made national headlines and went viral after the purported victim, a 12-year-old black girl in Springfield, Va., gave numerous interviews to various media outlets late last month.

The sixth-grade student at Immanuel Christian School, a private institution in Fairfax, Va., originally told her grandparents, school officials, and the media that a group of three young white students pinned her down and tried cutting off her dreadlocks. She alleged the young white students called her “ugly” and her hair “nappy,” and held her hands down and covered her mouth while they attempted to cut her hair with scissors.

“They kept laughing and calling me names,” she told CBS affiliate WUSA-TV in an interview following the alleged attack. “They called me ‘ugly,’ said, ‘I shouldn’t have been born.’ They called me ‘an attention-seeker.’”

The girl’s mother called for the alleged suspects to be kicked out of the school for their apparent racially-motivated attack. The problem is, the charge turned out to be a complete fabrication.

The initial reporting of the alleged “hate crime” sparked national outrage and a police investigation. On Sept. 30, school officials and the girl’s family confirmed the alleged “hate crime” attack had been fabricated by the young student.

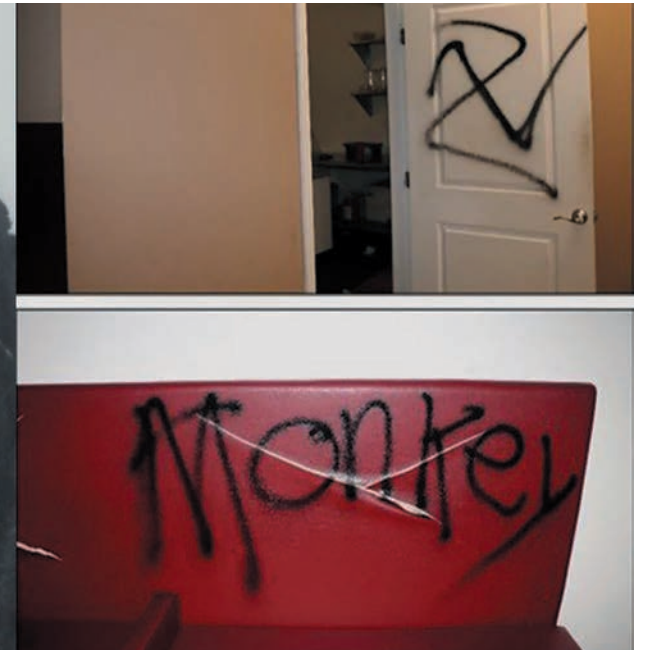
“We can now confirm that the student who accused three of her classmates of assault has acknowledged that the allegations were false,” Stephen Danish, the school’s principal, said in a statement sent to parents, community members, and the media. “We’re grateful to the Fairfax County Police Department for their diligent work to investigate these allegations. While we are relieved to hear the truth and bring the events of the past few days to a close, we also feel tremendous pain for the victims and the hurt on both sides of this conflict.”

The girl’s grandparents, who are her legal guardians, also released a public statement apologizing for the false allegations and the tremendous pain and suffering caused by the latest fake “hate crime” in America.

“To those young boys and their parents, we sincerely apologize for the pain and anxiety these allegations have caused,” the grandparents wrote. “To the administrators and families of Immanuel Christian School, we are sorry for the damage this incident has done to trust within the school family and the undue scorn it has brought to the school. To the broader community, who rallied in such passionate support for our daughter, we apologize for betraying your trust.”

**Here is another in a long line of bogus hate crimes.** Ex-NFL football player Edawn L. Coughman, evidently in a financial bind, decided to cash in by crafting a hate crime against himself. He painted ethnic slurs and racist imagery on the interior of his own bakery and concocted a fanciful tale. He has been charged with filing a false police report and attempted insurance fraud. How many hate crimes that are reported to the police and then publicized in the media turn out to be fake?

They went on to indicate they “understand there will be consequences” for the false accusations, and that they are “prepared to take responsibility for them.” They are to be commended for their honesty and their willingness to take responsibility for their granddaughter’s actions, which were, after all, those of a 12-year-old child. She can be forgiven. But the mainstream news media cannot. They refuse to take responsibility for jumping the gun and not checking the facts before reporting such stories. Worse, when their fake news is exposed, they simply ignore their unprofessional behavior and rarely if ever admit they have been had. This kind of slipshod reporting can be very dangerous, as it can falsely inflame the passions of viewers.

## ANOTHER FAKE CRIME

In related news, a former NFL football player was also recently accused of staging a fake “hate crime” after it was discovered he had attempted to destroy and vandalize his business in an effort to portray himself as the victim of a racially motivated robbery.

Edawn Louis Coughman, 31, was arrested by police officers in Georgia on charges relating to insurance fraud and filing a false report of a crime, the *Atlanta Journal-Constitution* reported.

Police were dispatched to Create and Bake Restaurant and Coughman’s Creamery about 9:30 p.m. on Sept. 25 following a report of a burglary at the business owned by Coughman. Police searched the area and eventually pulled over Coughman,

who was driving nearby. They then went to the restaurant, where they discovered damage and vandalism at the property.

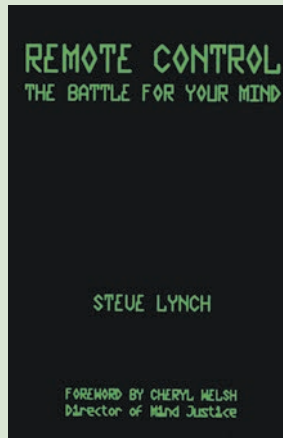
“Officers saw racially motivated words, swastikas, and ‘MAGA,’” a police spokesperson said. “Several booth cushions were sliced open. They also found broken mirrors, cut wires and a damaged video surveillance system. The smell of spray paint was very fresh. When officers touched it, the paint appeared wet.”

Coughman explained to officers that he reported the damage to his insurance company earlier in the day but did not call police. Police eventually searched Coughman’s truck and found black spray paint and a crowbar, which were used to break in and vandalize his own business in order to commit insurance fraud. They also found television screens that had been ripped from the walls of the restaurant.

“It appears as though Edawn conjured a premeditated plan to damage his own property, attempt to make it appear as a hate crime, file a claim with his insurance company, and sell off the undamaged appliances and electronics,” the police spokesperson said following the incident.

Coughman has not admitted to staging the incident and apologized, however. He and his attorney have maintained his innocence as he awaits a future trial date. ★

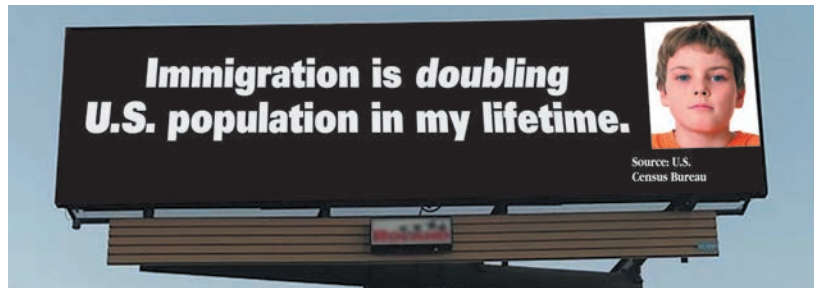

# The Democrats' Latest Absurd Attempt to Impeach Trump

In a shocking new attempt to revive stalled impeachment efforts against Donald Trump, the Democrats are accusing him of doing the exact same thing they are guilty of. The allegation is that Trump threatened Ukrainian President Volodymyr Zelensky with withholding foreign aid if he didn't look into the financial dealings of former Vice President Joe Biden's son, Hunter. Leahy (D-Vt.) wrote a letter to Ukraine's prosecutor general, Yuriy Lutsenko, expressing concern at the closing of four investigations they said were critical to the Mueller probe. In the letter, they implied that their support for U.S. assistance to Ukraine was at stake. Describing themselves as "strong advocates for a robust and close rela-

tionship with Ukraine," the Democratic senators declared, "We have supported [the] capacity-building process and are disappointed that some in Kyiv appear to have cast aside these [democratic] principles to avoid the ire of President Trump," before demanding Lutsenko "reverse course and halt any efforts to impede cooperation with this important investigation." So, it's okay for Democratic senators to encourage Ukraine to investigate Trump, but it's not okay for the president to allegedly encourage Ukraine to investigate Hunter Biden?

Trump, as always, was quick to react on Twitter, proclaiming, "Democrats wrote to the Ukrainian government in May 2018 urging it to continue investigations into President Donald Trump's alleged collusion with Russia in the 2016 presidential campaign—collusion later found not to exist."

Predictably, the senators contended that their attempted interference was "different." Leahy responded to Trump on Twitter: "So, so wrong. Again. Our letter was about concern **\*\*EVEN IN 2018\*\*** about WH pressure on Ukraine, to benefit you personally. And unlike you, we have strongly and consistently supported assistance to Ukraine as it struggles with Russian aggression."

Even more damnably, Biden bragged, and the video exists as proof, about bribing Ukraine with

\$1 billion to fire Prosecutor General Viktor Shokin, who was investigating Hunter's company. "I said, 'You're not getting the billion.' I'm going to be leaving here in, I think it was about six hours. I looked at them and said: 'I'm leaving in six hours. If the prosecutor is not fired, you're not getting the money,'" Biden recalled at an event fittingly hosted by the Council on Foreign Relations. "Well, son of a bitch, he got fired. And they put in place someone who was solid at the time." Biden, who was vice president when this conversation took place, also insisted that President Barack Obama was in on the threat.

A half-dozen Ukrainian officials confirmed Biden's account to "Common Sense Nation" but maintained that the pressure wasn't merely applied in one dramatic conversation, but actually over several months from late 2015 to early 2016. One fact is incontrovertible: Shokin was fired. The Ukrainians further told "Common Sense Nation" that Shokin was conducting a wide-ranging probe into natural gas firm Burisma Holdings, which boasted Hunter Biden as a board member. Banking records showed that Biden's American firm Rosemont Seneca Partners LLC received regular transfers, which were normally more than \$166,000 monthly, from Burisma during the period of early 2014 through late 2015. This coincided with the time when Biden was the primary U.S. official responsible for monitoring Ukraine's dicey relations with Russia.

Shokin told "Common Sense Nation" that, before he was fired, he had made "specific plans" that "included interrogations and other crime-investigation procedures into all members of the executive board, including Hunter Biden."

To those familiar with Hunter Biden's dubious business practices in Ukraine, and his then vice president father's overt efforts to interfere, it must seem exceedingly strange to see Trump accused of attempting to get Ukrainian officials to investigate that, and to conclude that those attempts constitute an impeachable offense. Not to mention the Democratic Party senators on the record as having threatened to withhold aid, the exact same supposedly impeachable offense they contend Trump is guilty of. Biden, showing incredible gall and no shame, called Trump's alleged actions "abhorrent." "If these reports are true, then there is truly no bottom to President Trump's willingness to abuse his power and abase our country," Biden declared.

Trump told reporters, "It is a political war. . . . The way you had built up that call, it was going to be the call from hell. It turned out to be a nothing call."

Americans await the next act in an increasingly absurd production. ★

## Joe Biden's Ukrainian Victim Speaks Out

**The following is an excerpt from the witness statement of former Ukrainian Prosecutor Viktor Mikolajovich Shokin, who testified on behalf of another Ukrainian accused of corruption in the country at the behest of Western authorities.**

The circumstances of my dismissal were that I tendered my resignation to the Rada at the request of President Poroshenko. Poroshenko asked me to resign due to pressure from the U.S. presidential administration, in particular from Joe Biden, who was the U.S. vice president. Biden was threatening to withhold \$1 billion in subsidies to Ukraine until I was removed from office. After I yielded to the president's request and submitted my voluntary resignation, Poroshenko commented about it in the media. He said that I had carried out a colossal amount of work as general prosecutor, which is something none of my predecessors had been able to do, especially with regard to my work on reforming the different bodies of the prosecutor's office, and creating the Specialized Anticorruption Prosecutors Office, which enabled the National Anti-corruption

Bureau of Ukraine to conduct legal work, and on creating self-governing prosecution authorities. . . .

The truth is that I was forced out because I was leading a wide-ranging corruption probe into Burisma Holdings ("Burisma"), a natural gas firm active in Ukraine, and Joe Biden's son, Hunter Biden, was a member of the board of directors. I assume Burisma, which was connected with gas extraction, had the support of the U.S. Vice President Joe Biden because his son was on the Board of Directors. . . .

On several occasions President Poroshenko asked me to have a look at the criminal case against Burisma and consider the possibility of winding down the investigative actions in respect of this company, but I refused to close this investigation. Therefore, I was forced to leave office, under direct and intense pressure from Joe Biden and the U.S. administration. In my conversations with Poroshenko at the time, he was emphatic that I should cease my investigations regarding Burisma. When I did not, he said that the U.S. (via Biden) was refusing to release the \$1 billion promised to Ukraine. He said that he had no choice therefore but to ask me to resign. ★



# Will Biden Be the First Casualty of Fanatical Impeachment Probe?

**E**ven before seeing the transcript of the July 25 phone call between President Donald Trump and Ukrainian President Volodymyr Zelensky, Speaker of the House Nancy Pelosi (D-Calif) threw the door wide open to the impeachment of Trump by the Democratic House.

Though the transcript did not remotely justify the advanced billing of a “quid pro quo,” Pelosi set in motion a process that is already producing a sea change in the politics of 2020.

The great Beltway battle for the balance of this year, and perhaps next, will be over whether the Democrats can effect a coup against a president many of them have never recognized as legitimate and have sought to bring down since before he took the oath of office.

Pelosi almost immediately started this rock rolling down the hill.

She has made impeachment, which did not even come up in the last Democratic debate, the issue of 2020. She has foreclosed bipartisan compromise on gun control, the cost of prescription drugs and infrastructure. She has just put her own and her party's fate and future on the line.

With Pelosi's assent that she is now open to impeachment, she turned what was becoming a cold case into a blazing issue. If the Democrats march up impeachment hill, fail, and fall back, or if they vote impeachment only to see the Senate exonerate the president, that will be the climactic moment of Pelosi's career. She is betting the future of the House, and her party's hopes of capturing the presidency, on the belief she and her colleagues can persuade the country to support the indictment of a president for high crimes.

One wonders: Do Democrats blinded by hatred of Trump ever wonder how that 40% of the nation that sees him as the repository of their hopes will react if, rather than beat him at the ballot box, they remove him in this way?

The first casualty of Pelosi's cause is almost certain to be the front-runner for the party nomination. Joe Biden has already fallen behind Sen. Elizabeth Warren in Iowa, New Hampshire, and California. The Quinnipiac poll has her taking the lead nationally for the nomination, with Biden dropping into second place for the first time since he announced his candidacy.

By making Ukraine the focus of the impeachment drive in the House, Pelosi has also assured that the questionable conduct of Biden and son Hunter Biden will be front and center for the next four months before Iowa votes.

What did Joe do? By his own admission, indeed his boast, as vice president he ordered then-Ukrainian President Petro Poroshenko to either fire the prosecutor who was investigating the company that hired Hunter Biden for \$50,000 a month or for-

go a \$1 billion U.S. loan guarantee that Kiev needed to stay current on its debts.

Biden insists the Ukrainian prosecutor was corrupt, that Hunter had done no wrong, that he himself was unaware of his son's business ties.

All these assertions have been contradicted or challenged.

There is another question raised by Biden's ultimatum to Kiev to fire the corrupt prosecutor or forgo the loan guarantee. Why was the U.S. guaranteeing loans to a Kiev regime that had to be threatened by the U.S. with bankruptcy to get it to rid itself of a prosecutor whom all of Europe supposedly knew to be corrupt?

Whatever the truth of the charges, the problem here is that any investigation of potential corruption of Hunter Biden, and of the role of his father, the former vice president, in facilitating it, will be front and center in presidential politics between now and New Hampshire.

This is bad news for the Biden campaign. And the principal beneficiary of Pelosi's decision that put Joe and Hunter Biden at the center of an impeachment inquiry is, again, Warren.

Warren already appears to have emerged victorious in her battle with Bernie Sanders to become the progressives' first choice in 2020. And consider how, as she is rising, her remaining opposition is fast fading.

Sen. Kamala Harris (D-Calif.) has said she is moving her campaign to Iowa for a do-or-die stand in the first battleground state. Sen. Cory Booker (D-N.J.) has called on donors to raise \$1.7 million in 10 days, or he will have to pack it in. As Biden, Sanders, Harris, and Booker fade, and “Mayor Pete” Buttigieg hovers at 5% or 6% in national and state polls, Warren steadily emerges as the probable nominee.

One measure of how deeply Biden is in trouble, whether he is beginning to be seen as too risky, given the allegations against him and his son, will be the new endorsements his candidacy receives after all the charges and countercharges.

If there is a significant falling off, it could be fatal. ★

# Impeachment or CIA Coup Attempt?

**Y**ou don't need to be a supporter of President Donald Trump to be concerned about the efforts to remove him from office. In late September, House Speaker Nancy Pelosi (D-Calif.) announced impeachment proceedings against the president over a phone call made to the president of Ukraine. According to the White House record of the call, the president asked his Ukrainian counterpart to look into whether there is any evidence of Ukrainian meddling in the 2016 election and then mentioned that a lot of people were talking about how former Vice President Joe Biden stopped the prosecution of his son who was under investigation for corruption in Ukraine.

Democrats, who spent more than two years convinced that "Russiagate" would enable them to remove Trump from office only to have their hopes dashed by the Mueller report, now believe they have their smoking gun in this phone call.

Is this about politics? Yes. But there may be more to it than that.

It may appear that the Democratic Party, furious over Hillary Clinton's 2016 loss, is the driving

force behind this ongoing attempt to remove Trump from office, but at every turn we see the fingerprints of the CIA and its allies in the Deep State.

In August 2016, former Acting Director of the CIA Mike Morell wrote an extraordinary article in *The New York Times* accusing Trump of being an "agent of the Russian Federation." Morell was clearly using his intelligence career as a way of bolstering his claim that Trump was a Russian spy—after all, the CIA should know such a thing, but the claim was a lie.

Former CIA Director John Brennan accused Trump of "treason" and of "being in the pocket of Putin" for meeting with the Russian president in Helsinki and accepting his word that Russia did not meddle in the U.S. election. To this day there has yet to be any evidence presented that the Russian government did interfere. Brennan openly called on "patriotic" Republicans to act against this "traitor."

Brennan and his Deep State counterparts James Comey at the FBI and former Director of National Intelligence James Clapper launched an operation, using what we now know is the fake Steele dossier, to spy on the Trump presidential campaign and even attempt to entrap Trump campaign employees.

Notice a pattern here?

Now we hear that the latest trigger for impeachment is a CIA officer assigned to the White House who filed a "whistleblower" complaint against the president over something he heard from someone else that the president said in the Ukraine phone call.

Shockingly, according to multiple press reports the rules for CIA whistleblowing were recently changed, dropping the requirement that the whistleblower have direct, firsthand knowledge of the wrongdoing. Just before this complaint was filed, the rule-change allowed hearsay or second-hand information to be accepted. That seems strange.

The Democrats have suddenly come out in praise of whistleblowers—well, not exactly. Pelosi still wants to prosecute actual whistleblower Ed Snowden. But she's singing the praises of this fake CIA "whistleblower."

Senate Minority Leader Chuck Schumer (D-N.Y.) once warned Trump that if "you take on the intelligence community, they have six ways from Sunday at getting back at you."

It's hard not to ask whether this is a genuine impeachment effort or a CIA coup. ★

For that purpose, I just recalled our ambassador from the United States and he will be replaced by a very competent and very experienced ambassador who will work hard on making sure that our two nations are getting closer. I would also like and hope to see him having your trust and your confidence and have personal relations with you so we can cooperate even more so. I will personally tell you that one of my assistants spoke with Mr. [Rudy] Giuliani just recently, and we are hoping very much that Mr. Giuliani will be able to travel to Ukraine and we will meet once he comes to Ukraine. I just wanted to assure you once again that you have nobody but friends around us. I will make sure that I surround myself with the best and most experienced people. I also wanted to tell you that we are friends. We are

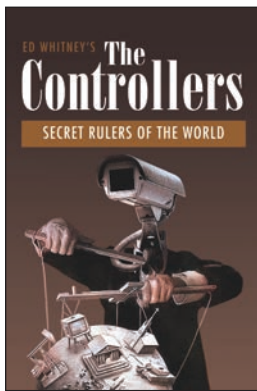
great friends, and you, Mr. President, have friends in our country, so we can continue our strategic partnership. I also plan to surround myself with great people and in addition to that investigation, I guarantee as the president of Ukraine that all the investigations will be done openly and candidly. That I can assure you.

**The President:** Good, because I heard you had a prosecutor who was very good, and he was shut down, and that's really unfair. A lot of people are talking about that, the way they shut your very good prosecutor down, and you had some very bad people involved. Mr. Giuliani is a highly respected man. He was the mayor of New York City, a great mayor, and I would like him to call you. I will ask him to call you along with the attorney general. Rudy very much knows what's happening, and he is a very capable guy. If you could speak to him that would be great.

The former ambassador from the United States, the woman, was bad news and the people she was dealing with in the Ukraine were bad news, so I just want to let you know that. The other thing, there's a lot of talk about Biden's son, that Biden stopped the prosecution, and a lot of people want to find out about that, so whatever you can do with the attorney general would be great. Biden went around bragging that he stopped the prosecution so if you can look into it. It sounds horrible to me. ★

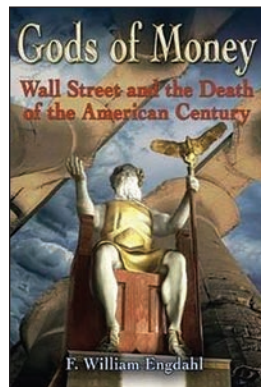

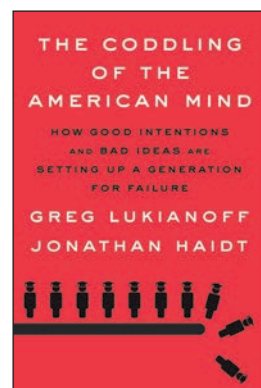
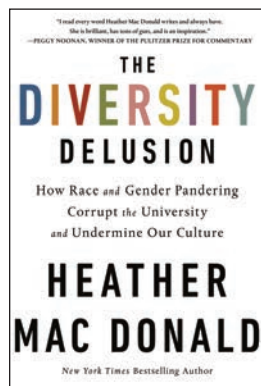
*The Controllers:

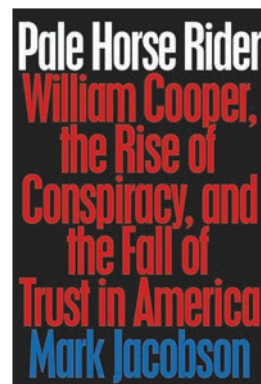

# Biden vs. Whistleblowers

• Supports prosecution of those who expose state crimes

Whistleblower Edward Snowden today lives in Moscow, as he has since his U.S. passport was revoked in 2013 when he was charged with violating two counts of the Espionage Act of 1917, as well as theft of government property. Snowden felt no affinity for Russia, and the former Soviet Union was not the desired destination for the American, who, two days after his 30th birthday, landed at Sheremetyevo Airport in Moscow. He had applied for asylum in the more desirable France and Germany, only to see his applications pulled under pressure from U.S. officials. Those U.S. officials Snowden names as being most responsible for his exile in Russia: John Kerry and Joe Biden.

In a Sept. 16 interview with MSNBC's Brian Williams, Snowden was asked if he is "actively seeking to get out of Russia," if he is "seeking asylum elsewhere." The tone of the host's question was one of the Cold War era when Russia was supposed to be the last stop to nowhere. It is a tone typical of the mainstream media and the Democratic Party in 2019, a media and a party still refusing to believe Russiagate was a failed notion.

"It was never my intention to end up in Russia," Snowden, the author of the new book *Permanent Record*, told Williams. "I was going to Latin America and my final destination was hopefully going

to be Ecuador. I applied for asylum in 27 different countries around the world. Places like France and Germany, places like Norway, that I felt the U.S. government and the American public could be comfortable that was fine for a whistleblower to be in, and yet every time one of these governments got close to opening their doors, the phone would ring in their foreign ministries, and on the other end of the line would be a very senior American official.

"It was one of two people. Then-Secretary of State John Kerry or then-Vice President Joe Biden. And they would say, look, we don't know what the law is, we don't care if you can do this or not, we understand that protecting whistleblowers is a matter of human rights and you could do this if you want to. But if you protect this man, if you let this guy out of Russia, there will be consequences. We're not going to say what they're going to be, but there will be a response."

Snowden doesn't understand how the current animosity toward Russia gels with the apparent U.S. desire to keep him there. "If the United States continues to be so concerned about Russia," he concluded, "shouldn't they be happy for me to leave? And yet we see they're trying so hard to prevent me from leaving. I would ask you, why is that?"

The Snowden question is a good one, and it's one that should be asked of all Democratic candidates for president. Rep. Tulsi Gabbard (D-Hawaii) has said she would drop all charges against Snowden and WikiLeaks's Julian Assange, but the views of the other candidates have been more nuanced. Even John Nichols of the left-leaning magazine *The Nation* has recently argued that Snowden should be a campaign issue.

Biden not only has a record of action against Snowden; he has also made very public statements against Assange.

Biden was the attack dog of the Obama administration against the WikiLeaks founder. In 2010, Biden likened Assange to a "hi-tech terrorist," claiming that Assange's work in publishing U.S. war crimes and financial crimes put lives at risk and made it more difficult for the U.S. to do business globally.

Tying Chelsea Manning into the mix of Biden's

potpourri of whistleblowing criminals, Biden said that Assange's work would be criminal if it could be proven that he had encouraged or aided Manning's actions, thus implying he believes that all three are criminal in their whistleblowing.

"I would argue it is closer to being a hi-tech terrorist than the 'Pentagon Papers,'" Biden told NBC's "Meet the Press" in 2010. "But, look, this guy has done things that have damaged and put in jeopardy the lives and occupations of people in other parts of the world."

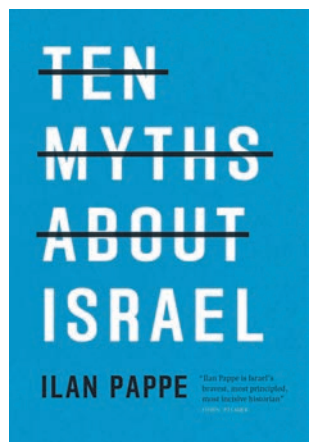
Yes, Biden said that exposing war crimes and war criminals hurts the careers of war criminals around the world and may even endanger their lives.

Sure, Biden wasn't the most egregious Democrat in dealing with whistleblowers who are trying to save lives and protect real freedom. Hillary Clinton accused Assange and WikiLeaks of "mounting an attack" upon the world. Biden, however, has the most immediate responsibility as a frontrunner in the Democratic presidential race. As the only candidate with experience in and around the Oval Office, his history in dealing with whistleblowers is telling and it is vital. And on this, he has failed. ★

# Mystery Surrounds the Attack on Saudi Arabian Oil Facility

The Sept. 15 attacks on a Saudi oil facility and oil field were not as bad as suggested. Within a matter of days, the operation was up and running again even though the price of oil spiked for a week, producing massive profits for the big oil corporations. But the real story has yet to be told. Who did it? Was it intended to cause maximum damage? Was there a massive intelligence failure on the part of the U.S. and its Arab and Israeli allies?

The U.S., Saudi Arabia, and even some European allies are claiming the attacks were carried out by Iran, with some suggesting that they were launched from Iranian territory, but a European intelligence source, who spoke to AFP on condition of anonymity, said that he was astonished by the fact that such an attack could take place from Iran or Yemen and not be detected.

“A fly could not leave Iranian or Yemeni airspace without being spotted on radar, but we are being told that a combination of 20 drones and missiles were fired from Iran or Yemen and that 17 struck their targets with pinpoint accuracy only achieved by the Pentagon’s most sophisticated Tomahawk cruise missiles and its new attack drones. . . . That leaves one asking if the attack could have come from Iraq or elsewhere, he said.

He added: “One also has to ask, would Iran be so dumb as to leave its fingerprints on such an attack by using its own airspace to launch the weapons? I think not. Were the weapons Iranian? That’s likely, but the weapons the Saudis are using to kill people in Yemen are American weapons. It does not follow, as we know that American forces are firing them at Yemen.”

The source is correct about the radar umbrella over Iran and also Yemen. Iran is likely the most watched country in the Middle East. There are U.S. and allied radars on ships in the Gulf and in U.S. military facilities in the Saudi allied nations, including Kuwait and Bahrain. The Saudis also have U.S. Patriot missile batteries, and Israel constantly monitors Iran. Had Iran launched the drones and missiles from its territory the evidence would have been incontrovertible and available in seconds.

The Houthis, who control Yemen, claimed that they launched the attacks on the Abqaiq oil processing facility and the Khurais oil field, and it would not be the first time they have used missiles and drones to attack targets in Saudi Arabia. Like the Mujahideen that once fought the Soviets to a standstill in Afghanistan with U.S. weaponry, the Houthis have become a formidable force, using weapons supplied by Iran and other Shiite nations. In the wake of this Saudi attack, they issued footage on Sept. 28 of an attack on a large Saudi military convoy that ventured into Yemen.

They claimed that they seized hundreds of Saudi prisoners, including senior Saudi officers.

One intriguing theory about the Sept. 15 attacks comes from Stephen Bryen, a writer with the online “Asia Times.” He believes that the Iranians mounted a sophisticated covert operation from within Saudi Arabia—a plan that took months. The location enabled Iranian operators to achieve pinpoint accuracy by guiding their weapons to targets using cameras mounted on them, thereby not needing satellites. But his most controversial claim, supported by satellite imagery of the damage at the Abqaid refinery, is that there were no explosives in the missiles used to penetrate the tanks at the plant, because the tanks were not on fire. The fires seen on news footage were, therefore, from less significant structures. In other words, Iran was sending a message that it could have inflicted considerably more damage had it so wished.

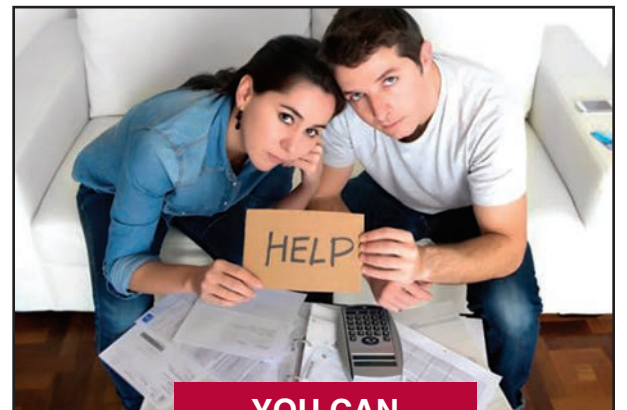
“The satellite photos we have show no fire on the tanks that were hit. Why not? Maybe because the idea was to blow some holes in the tanks to show what could happen—a demonstration,” wrote Bryen.

In the meantime, Saudi Arabia’s oil supply is back to normal, and all the hype surrounding the attack, especially fears of conflict following Secretary of State Mike Pompeo’s claim that it was “an act of war,” have subsided. Nevertheless, more U.S. troops and Patriot batteries have been sent to Saudi Arabia and, in a somewhat disturbing tone, Saudi spokesmen said the U.S. had not ruled out military action against Iran. That leaves one wondering why the Saudis think they have the authority to speak for President Donald Trump and the U.S. military.

The media warning that the attack on Saudi oil facilities risked impacting world energy supplies never materialized. Nevertheless, the issue should encourage more Americans to ask questions about the U.S. Strategic Petroleum Reserve (SPR), always considered a major plank in this nation’s security. It is mentioned every time something happens in the Middle East, yet the Obama administration, and now Trump and Congress, ignored the significance of the reserve. Not only has the infrastructure around it been crumbling, but there are plans to sell off a large percentage of its oil over the next decade to raise cash.

In 2016, a Department of Energy report to Congress about the SPR issued the following key warning that has since been ignored: “The SPR’s aging surface infrastructure will begin to fundamentally compromise the reserve’s capabilities. Investing in a second life extension project is essential to ensure the long-term integrity of SPR assets and the ability of the program to carry out its mission.”

Instead, both parties in Congress have chosen to agree to a policy outlined in a blueprint by Trump to sell half of the 700 billion barrels of crude to raise over \$16 billion. ★

# Is Brexit Done for Good?

Despite all of the fearmongering and even interference from UK courts, Prime Minister Boris Johnson has vowed to pull the UK from the European Union by Oct. 30. So far, the negotiations between globalists in Brussels and the UK have been a sham, but that may change as the fiery new prime minister releases his version of Brexit in the coming weeks.

When the British people voted to exit the European Union (EU) I said in many interviews and also in written columns that I doubted it would ever happen. It has been three years, and it has not.

Some hosts wondered why I doubted the British government's willingness to comply with a majority vote, but it was obvious to me that pressures from special interests inside and outside the UK, especially the pressure from Washington, would prove to be more influential with the British government than a majority vote of the British people.

Washington expressed its view to the UK government that it was not in Washington's interest for the UK to exit the EU. Various special interest groups, including pro-immigrant organizations, began the propaganda campaign that the UK would end up a backwater excluded from European trade. The same predictions of doom used when populations of countries rejected joining the EU were resurrected. Instead of obeying the vote, the populations were subjected to propaganda that staying out of the EU is a death sentence.

In other words, the elites prevailed over democracy. This has been going on for three years in the UK while former Prime Minister Theresa May negotiated an exit. The deal was a disaster. It required the British to pay 60 billion pounds sterling to buy its way out, to continue to accept Third World immigrants, and to continue to accept the supremacy of EU law over UK law. In other words, it was exit in name only.

To me, it looked like a deal designed to block an exit and to create a situation in which means could be employed to overturn Brexit. That has now happened. Eleven judges on the British Supreme Court have stepped in and blocked the temporary suspension of Parliament by Prime Minister Boris

Johnson and the Queen, a legal procedure used for centuries that the court ruled "unlawful."

In other words, the court made a political intervention in favor of the opponents of Brexit.

The minority opposed to the UK exiting the EU is trying to use the court's decision to force Johnson to resign. Opponents are trying to conflate the court's ruling that the five-week suspension of Parliament is unlawful with the argument that Brexit itself is unlawful.

The British political website "Spiked-Online" sees the ruling this way:

Today's Supreme Court ruling is a vile assault on the democratic order. In finding that Boris Johnson's proroguing of parliament was unlawful, and that parliament is not prorogued, the 11 justices have made an explicitly political decision in favor of the "remainer" elite. They have taken sides. Ignore the utterly unconvincing pleas of the "remainer" fanatics who brought this case, all of whom robotically insist that this is not a political decision, just a legal, constitutional one. No one is buying that. This was a decisively political act by 11 unelected judges, who have taken sides against the government of the day, and this opens up a new, dark era in British political life.

This judgment is a disaster for law and for politics. It's bad for law because it will convince many more people that the law has become a political instrument, wielded by the wealthy to achieve openly political ends that they failed to achieve in the public, democratic sphere. And it is bad for politics because it points to the formation of a new politicized but untouchable elite which has power over the entire nation and everyone in it. That should terrify anyone who believes in real democracy. When *The Daily Mail* accused judges of behaving like enemies of the people, the "remainer" elites went into meltdown. Our message to them today is clear: If you don't want to be called an enemy of the people, stop behaving like one.

Legal authorities will disagree as to whether the court saved democracy or destroyed it.

I would say the court destroyed democracy, because the court consciously ruled against the majority of the people who voted to exit the EU. And most certainly, the court asserted its authority to be higher than that of Parliament. I am not an expert on this matter, but from what I do know, however much or little it is, the function of the British Supreme Court is to rule on the constitutionality or lawfulness of laws that Parliament passes, not on the lawfulness of Parliamentary procedures.

I would not be surprised if former Prime Minister May was well paid by Washington to stall Brexit for three years, and I would not be surprised if Johnson’s suspension of Parliament was an orchestration designed to sink Brexit. British prime

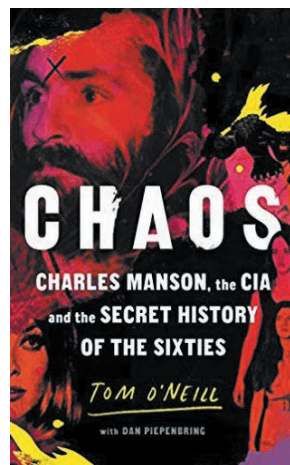
ministers are well rewarded for serving Washington’s interest rather than the interest of the British people. Consider Tony Blair, who enabled Washington’s invasion of Iraq, for example, whose current net worth is \$76 million.

Perhaps this was only to be expected. When legislative bodies sacrifice the interests of the people to the interests of organized lobbies, they undermine their own authority and open themselves to the despoliation of their powers by other elements of government. ★

# Child-Activist Has Powerful Backers

• Teenage Swedish environmentalist funded by world's richest leftists

Sixteen-year-old Swedish eco-celebrity Greta Thunberg is not just some random, organically grown environmental activist. Thunberg, not surprisingly, comes from a family of prominent entertainers. Her sudden emergence as the voice of those warning about “climate change” was orchestrated by some powerful and predictable forces.

Like far-left Rep. Alexandria Ocasio-Cortez’s “Green New Deal,” Thunberg’s impassioned pleas are backed by globalist organizations like the World Economic Forum, the Bill and Melinda Gates Foundation, the Rockefeller Institute, and the World Resources Institute. But Thunberg’s primary handler appears to be 23-year-old German “climate protection” activist Luisa-Marie Neubauer. Neubauer is the youth ambassador for perhaps the phoniest of all the fraudulent “charities,” the ONE Foundation run by rock star Bono. ONE was exposed years ago for giving just barely 1% of all donations to actual causes. In numerous photos, Neubauer can be seen standing behind young Thunberg. Among those financing One Foundation are Gates and George Soros. All of these forces support implementation of the dangerous Agenda 2030 in Germany.

In keeping with the forced austerity programs the elite all favor, Goal #12 of Agenda 2030 is titled, “Ensure sustainable consumption and production patterns.” To quote from the document: “In 2017, worldwide material consumption reached 92.1 billion tons, up from 87 billion in 2015 and a 254% increase from 27 billion in 1970, with the rate of extraction accelerating every year since 2000.

This reflects the increased demand for natural resources that has defined the past decades, resulting in undue burden on environmental resources. Without urgent and concerted political action, it is projected that global resource extraction could grow to 190 billion tons by 2060.” It goes on to express concern about the “almost 12 tons of resources” extracted per person. The Agenda urges, “Well-designed national policy frameworks and instruments are necessary to enable the fundamental shift toward sustainable consumption and production patterns.”

Translated, this means that our leaders want to continue the mantra, “We must all sacrifice,” which has been preached relentlessly for many years. The “we” in question does not mean the 1%, of course; those at the top never sacrifice anything. It is instead another reminder that our leaders want the standard of living for the majority of Americans to continue diminishing. They promote smaller housing and fewer creature comforts, in order to lower the expectations of everyday people.

What is noticeably missing from Thunberg’s scripted rhetoric is any mention of the 1%, or any mention of huge corporations, which spew out more pollution than all the common people combined could ever hope to. As international peace activist Cindy Sheehan has pointed out, neither Thunberg nor any other “environmental activist” ever mentions the significant damage to the planet that our continuous wars have caused. There is also never any criticism of countries like China and India, whose impact on the environment is at least as significant as anything caused by the United States, to put it kindly. And there is also no mention of geoengineering and secret weather research, and their almost certain contribution to the in-

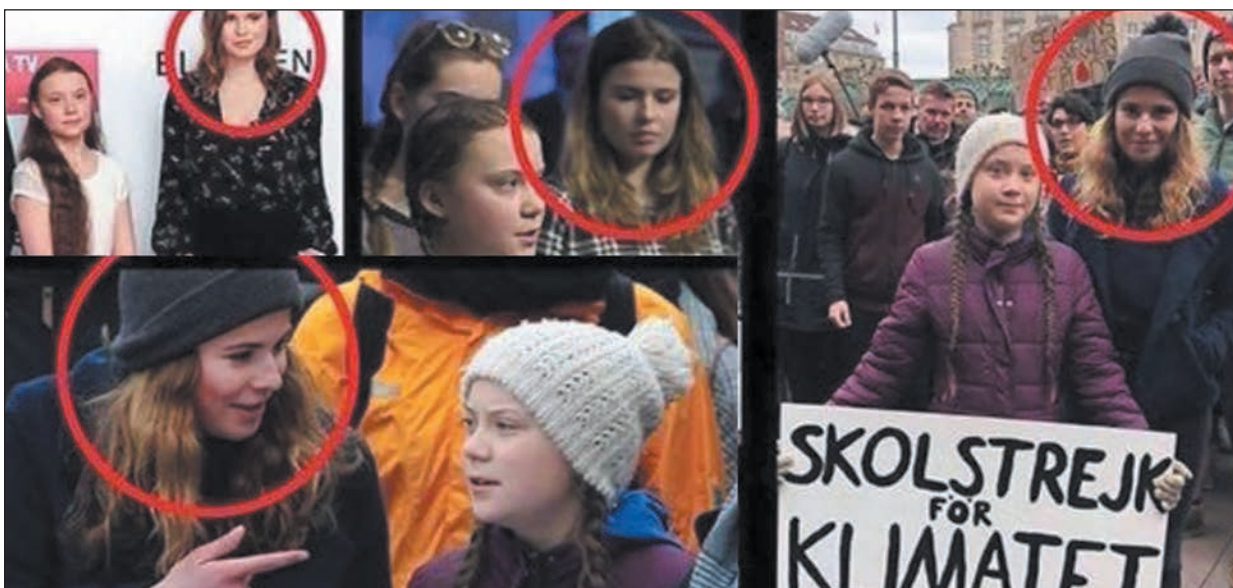

creased extreme weather all over the world.

French reporter Marc Reisinger wanted to find out exactly just how knowledgeable these young environmental activists were about the subject they were pontificating on and decided to question them.

“I realized that they did not know the cause of the issue they were protesting about: global warming,” he stated. A disappointed Reisinger traveled to Sweden to talk with Thunberg herself. Reisinger filmed their encounter. He found Thunberg to be timid and hesitant, far different from the strident, confident persona she presents in speeches. Reisinger called her “fearful, uncomfortable. . . .” When the young girl was quickly whisked away before she could provide specific answers, Reisinger reported, “Unlike the young demonstrators in Brussels, Greta did not answer any questions. I found myself facing a little girl, lost, without passion, manipulated by disturbing people. . . . Strange that a climate leader does not accept being asked a question about the climate.” Another Frenchman, commentator Emmanuel Aumonier, said, “The strategy is to pretend to save the planet so that they can continue to make a profit. And in the role of the useful idiot is the young Greta Thunberg.”

The exploitation of children for political ends is hardly something new. What is new is the blanket reverence the mainstream media and politicians extend to the Thunbergs of the world. The proclamations of immature minds are perfect fodder for modern-day, emotion-driven politics. Thunberg feels so passionately about this issue. How can we not listen to her? Give up your hot baths and your air conditioning. Listen to the celebrity who flew in on his private jet to admonish you about leaving too big a carbon footprint. Don’t you care about the children? ★

# Is Trump's Nationalism Truly Unpopular?

• Think tank's survey claims Americans are deserting Trump's America-first policies

The Chicago Council on Global Affairs (CCGA) has released its 2019 public survey, "Rejecting Retreat," which claims that Americans are increasingly parting ways with President Donald Trump's nationalistic foreign policy. Trump expounded on this at his recent United Nations speech (his third), saying that national self-interest benefits all nations and the world as well. But a careful look at the new CCGA survey's language and data raises doubts about its overall accuracy and intent.

The survey's very first question exemplifies the subtly misleading language common in reports by Deep State think tanks like the CCGA, which is the former Chicago Council on Foreign Relations. The question is: "Do you think it will be best for the future of the country if we take an active part in world affairs or if we stay out of world affairs?"

That implies that the only alternative to taking an "active part" in world affairs is to bluntly "stay out," when there are varying degrees of world engagement that could be pursued by the U.S.—a reality the survey ignores. At the CCGA's first-ever release of a survey on Trump's foreign policy in 2017 in Chicago, Notre Dame Political Science Professor Michael Desch countered the CCGA party line by noting that Trump is neither a full-blown interventionist nor a total isolationist.

Desch argued that Trump is instead a "Jack-

sonian," who chooses his world-engagement policies carefully without retreating from the world altogether. This suggests that the CCGA survey's premise of Trump being an outright "isolationist" is untrue.

Such misleading wording and false premises in the survey—which cannot help but skew the results—also popped up in the area of trade. The trade question is worded: "Overall, do you think that international trade is good or bad for the economy?" While the survey's results show that 87% said "good" and just 13% said "bad," the problem is that people are simply asked whether they like "international trade."

One problem with this wording is that virtually all trade is "international." The real question is

whether a nation is engaged in free trade or fair trade, which most often are mutually exclusive. Wholly free trade, which, for example, disallows or strictly limits a nation's ability to enact tariffs, or prevents balanced trade and locks a nation in a prison of constant trade deficits (a situation that has hurt the U.S., versus China, for decades) is inherently unfair. Trump's call at the UN and elsewhere for "fighting unfair trade" puts the matter in a more specific context, which, if it were to be included in such a survey, would result in answers that collide with the CCGA party line.

Although the survey admits that Americans generally are tired of endless interventionism abroad, it tempers that admission by claiming that Americans harbor numerous exceptions to their skep-

criticism when it comes to helping “allies.” For instance, under the “U.S. Security Alliances” heading regarding the volatile Middle East, the survey is structured in a manner which suggests that an impressive number of respondents believe U.S. alliances with other individual nations “benefit both” nations (50% of those surveyed said “benefit both” in the 2019 survey, up from 42% in the 2017 survey).

However, because the survey tallies the answers to “benefit neither” and “benefit allies” separately, one gets the impression that U.S. alliances are a strong reason to maintain a globally engaged foreign policy. But when you take the 2019 result for “benefit neither” (18%) and add it to “benefit allies” (22%), it turns out that 40% of respondents see the U.S. getting scarce benefit from its Middle East alliances.

And so it goes with a survey that, despite its pretense of objectivity, is arguably flawed and serves as a species of misdirection to discredit the president, who’s been described as a threat to the elite world order even by Council on Foreign Relations President Richard Haass and others of his privileged ilk—including Trilateral Commission member Richard Fontaine, a former aide for the late hyper-interventionist Sen. John McCain (R-Ariz.). Fontaine took part in the release of the CCGA’s 2019 survey in Washington. So, while Trump needs to be held to account to make sure his best nationalistic ideas become reality, no other president has invited so much scrutiny from those representing the “power behind the throne.” Evidently, he’s doing something right. ★

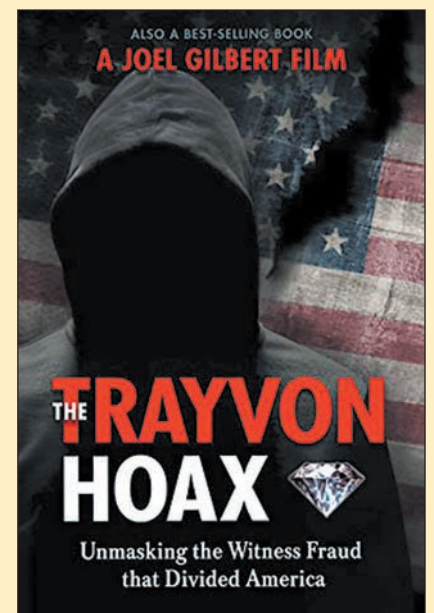

# Anti-Gun Bills Pile Up

While most of America has been distracted by Democrat-led efforts to impeach President Donald Trump, gun control bills have been piling up in Congress. Two of the measures have already been passed by the House, while five others were reported out of committee. The main two legislative items to closely monitor are the “Extreme Risk Protection Order Act of 2019” (H.R. 1236) and the equally Orwellian “Disarm Hate Act” (H.R. 2708). Neither bill had made it to the full House for a floor vote at press time, but AFP readers are urged to stay especially vigilant.

H.R. 1236, introduced in February by Rep. Salud Carbajal (D-Calif.), with 206 cosponsors, was approved 22-16 by the House Judiciary Committee with an amendment to include H.R. 3076, which is similar legislation put forth by Rep. Lucy McBath (D-Ga.).

A Judiciary Committee news release says that H.R. 1236 “provides incentives through grants for states to adopt laws providing for Extreme Risk Protection Orders to prevent those deemed a risk to themselves or others from accessing firearms.”

What the news release from the Democrat-controlled House fails to specify, however, is that, if passed, the bill would usher in America’s first-ever national red flag law—a particularly invasive measure that gets the mental health community, police, and the general public involved in identifying and assessing individuals whose behavior may indicate they’re prone to violence. On that basis, such individuals could be denied the right to purchase a firearm or even to keep any firearms they may already own.

Of course, anyone in a feud with another who has a score to settle, or anyone who might want to remove competitors in the fields of business,

love, politics etc., need only report that their rival appears “unstable” in order to get the law involved in settling personal vendettas and targeting the Second Amendment rights of individuals on the basis of hearsay and highly subjective judgments—especially when the myopic mass media cartel labors to create an anti-gun mentality among a broad cross-section of Americans.

How are red flag laws working out at the state level? Consider Anne Arundel County, Md. On Nov. 5, 2018—well before the latest spate of “mass shootings” occurred and “red flag” proposals became commonplace—61-year-old Gary J. Willis was shot dead at his front door “by an officer trying to enforce Maryland’s new ‘red flag’ law in Ferndale [Md.],” CBS 13 affiliate WJZ of Baltimore reported. “Anne Arundel County Police contend the man answered his front door at 5 a.m. holding a pistol. He became incensed when police tried to serve him and seize his firearms. A fight broke out, and Willis fired his handgun, prompting police to return fire. According to reports, there were no other witnesses present to dispute the statement by the officers involved.”

In other words, official guns carried by police can be fired at will to kill—while rousing a citizen out of bed at the crack of dawn in a classical “old-Soviet” fashion for maximum harassment, confusion, and shock value, and local media simply take the police’s word regarding the events.

WJZ noted that during just the first month of Maryland’s red flag law, 114 “requests for removing guns” were issued.

Proponents of the red flag laws contend such laws may occasionally tag an individual planning a serious crime with guns. Existing laws, however, already can be enforced when a serious crime is in the works, whether or not firearms are involved.

This situation drives home the urgency for AFP readers to call their representatives and their senators to make doubly sure H.R. 1236 never becomes law to make such a nightmare a national fixture.



As for the Disarm Hate Act (Senate companion bill, S. 1462), the bill was approved 23-15 by the House Judiciary Committee to clear the path for a full House vote. The Senate version, at press time, had not yet seen any action in the Senate Judiciary Committee and has only 16 cosponsors. H.R. 2708 is intended to “prevent a person who has been convicted of a misdemeanor hate crime or received an enhanced sentence for a misdemeanor because of hate or bias in its commission, from obtaining a firearm,” official sources say.

But given the fact that the charge of “hate crimes” is highly subjective, basing the denial of Second Amendment rights on such charges is fraught with peril to Americans’ civil liberties.

Other bills that need attention include the “Bipartisan Background Checks Act of 2019” (H.R. 8) and the “Enhanced Background Checks Act of 2019” (H.R. 1112). Those two bills already passed the full House and have been pending in the Senate since March.

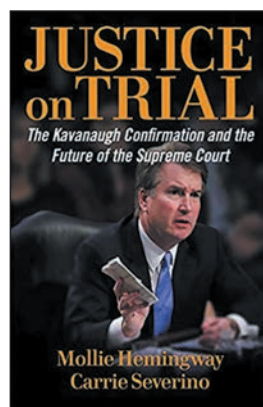
Another relevant piece of legislation, also introduced in February and reported out of committee but not yet voted on by the full House at press time, is the “Keep Americans Safe Act” (H.R. 1186). The Senate version, S. 447, was referred to the Judiciary Committee in February where it remains without action.

# A Long Road Back from 'Alienstock'

• Secret military site researchers think "Storm Area 51" has set back efforts

**S**torming Area 51 was a comical idea from the outset—and it was meant to be. What began as a playful event created by college student Matty Roberts gained viral traction in a way that can only happen in the age of social media. Before Roberts knew it, he had a real event on his hands. Rightly surprised by his newfound status as a community organizer of the paranormal set, Roberts did what any clear-thinking college student would do: He planned a party.

"Let's see them aliens," Roberts wrote on the invitation to his Storm Area 51 event, which was scheduled for Sept. 20, and millions RSVP'd to his invitation.

But, as Sept. 20 came and went, the mood around Rachel, Nev., the tiny, dusty hamlet closest to Area 51, was, in the words of police and emergency workers a few miles down the road, "mellow." Even the party was a bit of a bust, as most over-hyped college bashes can be. The crowd totaled in the hundreds rather than the millions.

It's easy to call the event a failure, despite attendees reporting widely that they enjoyed the scenery and the company. The crowds were low, security was high, and no one stormed any classified military base, which would have been difficult anyway, since the air base within which Area 51 is located is literally the size of Connecticut.

Opinions regarding the long-term effects of Storm Area 51 differ. Researchers of secret sites believe the hubbub created by Roberts has hurt serious research. Any time the alien question is turned

into an event for jugglers with oversized alien masks, honest research has lost. Others believe that the event has, for some, revived an interest in Area 51 and, for others, has ignited one. Now that they have drank, laughed, and danced in Rachel, they will be more apt to pursue the serious research

when they return home. Yet, many longtime researchers and enthusiasts believe any attention given to Area 51 is wasted energy, when more serious concerns surround secret sites like the "closed" military compound in the mountains of North Carolina.

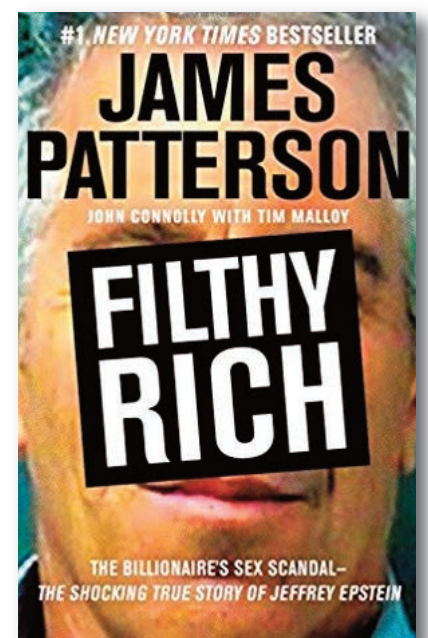
Residents of Chatham County, N.C. have long been concerned about unusual activity occurring around a once-secret military facility popularly called "The Big Hole." The site spans 191 acres with its base being a 13-story underground skyscraper built as a communications center in preparation for a nuclear strike. If a nuclear attack struck Washington, D.C., this was built to be one of the locations to house an independent global communications network. It was also built to withstand nuclear blasts, having a superstructure suspension apparatus above it and a gravel and coil shock-absorbing foundation below. AT&T owns the property and refuses to comment about any aspect of the site to this day.

The Big Hole was officially deactivated in 1996, years after the Cold War had been deemed finished by the government and establishment historians. In 2000, Wayne Jackson, communications director for AT&T's Government Markets division, responded tersely to a request for information. "This is what we call a 'central facility' and we do not discuss it," Jackson said. "You'll have no comment out of me, and I speak for AT&T in this situation."

Yet, activity exists around the site today. It is still protected by 10-foot-high chain link and barbed wire fences. Former employees that staffed the base have stories that are shared with local residents and independent researchers. Twenty-two years after its official closure, interest in the Big Hole is still very much alive. ★
