## In surprise move, Democrats okay trade deal negotiated by the Trump administration

**W**hile Democrats hunkered down in the basement of the U.S. Capitol building, twisting recent events to make a case for impeaching the president, Donald Trump took a victory lap as news broke on Dec. 11 that congressional leaders would accept his renegotiation of the North American Free Trade Agreement (NAFTA).

Called the United States-Mexico-Canada Agreement (USMCA), Trump took to the Internet to celebrate, declaring with his usual bravado that the USMCA “will be the best and most important trade deal ever made by the USA.” He added that NAFTA, which was embraced by both Republicans and Democrats, will go down in history as “our country’s worst trade deal.”

Trump’s new deal is a significant upgrade from the free-trading NAFTA, which made immigration worse for the country and sped up the de-industrialization of the United States as companies flocked to Mexico in search of cheap labor and fewer regulations.

A Trump administration report pro-



jected that the new deal would create 76,000 auto jobs in the United States over the course of the next five years. That translates into a more than 7% increase in employment over the current 990,000 U.S. auto workers.

It also bumps up the current rule requiring a percentage of a vehicle’s parts to be made in one of the three countries from the current 62.5% to 72% in order to remain free from tariffs when

moving between the three countries.

The deal will also force Mexico to treat its workers better. AFL-CIO President Richard Trumka issued a statement in support of the deal, noting: “For the first time, there truly will be enforceable labor standards—including a process that allows for the inspections of factories and facilities that are not living up to their obligations.”

In order to enforce this, a new federal committee will be set up to make sure Mexico sticks to its agreed-upon labor reforms and obligations and a set of benchmarks will be implemented for Mexico to meet in implementing the reforms.

Farmers are going to benefit from the USMCA as well. Canada and Mexico are already the two biggest export markets for U.S. farmers and ranchers. The USMCA will keep tariff rates at zero but will force open the Canadian market to U.S. dairy, poultry, and eggs. In return, the United States will allow more Canadian dairy, peanuts, and peanut products, as well as sugar, to cross the border.

In all, the International Trade Commission, a federal government agency, reports that the USMCA is expected to create 176,000 jobs over the next six years, including vital manufacturing jobs, and increase the gross domestic product by nearly a half percent—no small feat considering the U.S. has been losing jobs and was hit by a major recession less than a decade ago.

With the USMCA, Trump has much to celebrate. As the U.S. economy continues to grow and even the broadest category of unemployment shrinks, it’s proving to be a very merry Christmas for everyone in the White House, who negotiated this new deal. ★

## Setting the Record Straight on Russia, Ukraine

It's been a very busy two weeks for us here in the news business. We're talking about the past two weeks of crazy congressional impeachment hearings, the House's introduction of articles of impeachment, and the release of Justice Department Inspector General Michael Horowitz's damning report on FBI spying on the Trump campaign.

If all you read were the big media, you'd be woefully ignorant about what's really going on. The simple truth is, the mainstream media and many liberals hate President Donald Trump so much that they will exaggerate mundane events, cherry pick facts, ignore inconvenient truths, and even lie right to the American people because they're terrified Trump will win a second term—a prospect that's looking increasingly likely as the Democratic primary drags on.

There are a rare few liberals, like *Nation* magazine's Aaron Mate, *Rolling Stone's* Matt Taibbi, and funnyman Jimmy Dore, who have been providing honest coverage of the past few weeks' insanity, but their voices have mostly been drowned out by the liars and frauds, who suffer from Trump derangement syndrome and will say anything just to see this president gone.

On social media, Mate and Taibbi have been hammering away at the big media's claims that Trump's impeachment is a slam dunk.

A day after Democratic House leaders introduced articles of impeachment, Mate posted to his Twitter page: "Article 1 of impeachment says that Trump 'compromised the national security of the United States.' Democrats should be asked to explain what they mean. Did Obama compromise U.S. national security when he (rightly, I think) refused to send that same military funding to Ukraine?"

Mate is referring to Trump withholding military aid to Ukraine last summer, which Trump did out of concern for corruption in that country not be-

cause he was insisting that the former Vice President Joe Biden and his son, Hunter, be investigated. In 2014, Obama withheld similar lethal military aid appropriated by Congress because, at the time, he was rightfully worried that it would increase tensions with Russia. No one claims Obama compromised U.S. national security with this prudent move, so why is Trump being assailed now—especially since we know there was never any quid pro quo?

Taibbi went into great detail about big media misdeeds, sharing a lengthy report on how *The Washington Post* among others has been willfully misreporting facts surrounding Horowitz's report. He followed that up with a lengthy piece for *Rolling Stone*, writing, "Going through the Horowitz report, the portions on [MI6 spy] Christopher Steele especially were worse than expected. How a tale with 'zero' corroboration, from a conversation 'over beers' and made in 'jest,' turned into the dominant news story in America."

As for Dore, who's been mocking the Democrat's impeachment process on YouTube, the comedian took things up a notch, explaining on his daily comedy and news show how a whistleblower with the Organization for the Prohibition of Chemical Weapons debunked the West's claim about the Syrian military gassing its own people—an important story that received no coverage in the big media. AFP detailed this in our last issue on our front page.

It remains puzzling why the big media has been so intent on whitewashing the FBI's and Department of Justice's spying operation on the Trump campaign. Were it any other president than Trump, talking heads would be falling over themselves to attack our country's cops, but, instead, they're downplaying the report, noting only that Horowitz claims the FBI operated without bias and was not part of a planned coup of an elected president.


To get the real story we had to turn to inde-

To put that in perspective, former Trump aides Mike Flynn and George Papadopoulos were convicted of making single false statements to the bureau. One went to jail already, and the other awaits sentencing. The FBI made nine false statements to the court."

# News You May Have Missed

## Beat the Border Crisis

It looks like President Donald Trump's tough policies on the U.S. border with Mexico are sending a strong message to would-be law-breakers. According to a new report by *The Wall Street Journal*, arrests of people crossing the southwestern border have plummeted by 75% since May, marking one of the most dramatic drops in recent history. "This is a direct result due to this president's strategies to address the historic flood of Central Americans, families, illegally crossing the border," acting Customs and Border Protection Commissioner Mark Morgan told reporters during a press conference on Dec. 9. "The network of initiatives have worked and continues to work." The most effective policy change comes out of the "Remain in Mexico" initiative, which has deterred illegal immigrants due to knowledge that they are likely to be stranded in Mexico for months while their cases are decided.

## Good News

According to public relations firm Firehouse Strategies, the battleground states of Michigan, Pennsylvania, and Wisconsin all consistently showed that Donald Trump was losing to former Vice President Joe Biden in a match-up, but recently, polling from Firehouse shows the reverse: Biden's now falling short of beating Trump by six points—and it's all thanks to the nutty impeachment push on the part of the Democrats. As the race currently stands, Trump is in the lead in Michigan, Pennsylvania, and Wisconsin in hypothetical match-ups against Biden, Sen. Elizabeth Warren (Mass.), Sen. Bernie Sanders (Vt.), Mayor Pete Buttigieg (Ind.), and former Mayor Michael Bloomberg (N.Y.).

## Transparency in Hospital Costs

While the Democrats wasted Congress's time on silly weeks of impeachment hearings, President Donald Trump scored another win for the American people. On Nov. 15, the White House announced new federal regulations that, beginning in 2021, will require all hospitals to make public all the prices they negotiate with insurers and health plans. Currently, hospitals only list their standard prices, which, according to experts, almost no one pays. Under the new regulations, hospitals, which account for about one-third of all healthcare costs, will have to list the actual rates that are paid by insurers.

## Out of Control Debt

The U.S. government deficit rose by 12% in the first two months of the 2020 fiscal year, hitting \$342 billion, according to new estimates from the Congressional Budget Office. The deficit is on track to surpass \$1 trillion in the

2020 fiscal year, which began on Oct. 1, which will bring Trump's deficit totals to over \$3 trillion since he took office. U.S. government deficits totaled more than \$7 trillion over the course of President Barack Obama's two terms and \$3.3 trillion during President George W. Bush's two terms.

## Fake News

Devin Nunes (R-Calif.) is suing CNN for defamation, accusing the cable network of publishing a "demonstrably false hit piece" about him amid his high-profile opposition to the Trump impeachment inquiry. According to report, the lawsuit, filed in the U.S. District Court for the Eastern District of Virginia, charges that the liberal network published "numerous egregiously false and defamatory" statements about Nunes on Nov. 22, 2019 when journalist Vicky Ward reported claims that Nunes met with Ukrainian prosecutor, Viktor Shokin, in Vienna in 2018 to "dig up dirt" on Joe Biden and his son, Hunter. "CNN is the mother of fake news," notes the lawsuit. "It is the least trusted name. CNN is eroding the fabric of America, proselytizing, sowing distrust and disharmony. It must be held accountable." Nunes is seeking \$435 million.

## Not "All-Female"

In the Nov. 18 and 25 issue of AFP, Paul Craig Roberts wrote "As the traitorous all-female government of Sweden has opened Sweden's borders and invited in rapists of Swedish women, there is no government protection of Swedish women." # Beware Big Charities That Do Very Little With Your Donations

**M**argaret Sanger, still a darling of the left despite her record of promoting eugenics, once defined organized charity as “the symptom of a malignant social disease.” Most Americans who give to well-established charities out of the goodness of their heart, imagining that their money will go toward a worthy cause, have no idea of how rarely it does.

The United Way scandal of 1992, which exposed massive executive salaries and bonuses for the first time, doesn’t appear to have impacted the way many of these charities operate. The biggest charities still routinely pay their CEOs an obscene hundreds of thousands in annual compensation, as well as funnel huge chunks of public contributions toward advertising.

The worst of these is former U-2 front man Bono’s ONE Foundation, which was revealed in 2010 to be giving a shockingly paltry 1.2% of contributions to actual causes.

As of 2010, the CEO of the American Red Cross was being paid over a million dollars yearly.

Charities with over \$500 million in total expenses pay their CEOs an average of over \$422,000 every year. As of 2013, nine charities were reported to be paying their CEOs over \$1 million annually. These salaries don’t include benefit plans or deferred compensation.

Goodwill Industries is especially shameful in this regard. In 2014, just one of their CEOs, Frank McGree of Goodwill Omaha, pulled in \$933,444 in compensation. Steven Lufburrow, CEO of Houston’s Goodwill, topped him with over \$1.3 million.

Another of Goodwill’s executives was paid more than \$1 million as well, and 23 of their CEOs raked in more than \$400,000. That’s a lot of money that could have been channeled into actually helping those in need. Things are very much the same in the United Kingdom.

*Forbes* recently reported that “so-called ‘non-profit’ hospitals and their CEOs are getting richer while the American people are getting healthcare poorer.” Their research found that “these hospitals add billions of dollars annually to their bottom line, lavishly compensate their CEOs, and spend millions of dollars, which are generated by patient fees, lobbying government to defend the status quo. Last year, patients spent one out of every seven U.S. healthcare dollars within these powerful networks. Many are household names like Mayo Clinic in Rochester, Minn. . . .”

Some 13 of these healthcare “non-profits” featured a top compensation package between \$5 million and \$21.6 million, while 61 paid their CEOs at least \$1 million. Ascension paid their CEO an incredible \$59.1 million, while the CEO of Kaiser made \$29.8 million. All this was in addition to *Forbes* discovering that over \$200 billion was going toward these “non-profits” bank accounts, assets, and investments. Much as it is with conventional charities, such huge amounts channeled toward salaries and investments leave less for research and improvements in patient care. Healthcare costs have soared to an astounding 20% of our gross national product. Statistics like these, as well as the outrageous compensation earned by insurance and pharmaceutical executives, are a large part of the reason why.

One well-known charity that does direct funds toward good causes is the Salvation Army. At last report, their CEO was only being paid a nominal

\$13,000 per year. The Salvation Army is an international organization, with a message based on the Bible and motivated by the love of God. The group states that “its mission is to preach the gospel of Jesus Christ and to meet human needs in His name without discrimination.” Most Americans have seen their volunteers standing outside stores with donation buckets, ringing bells. Much of their work, especially with the homeless, goes unrecognized.

The Salvation Army’s philosophy was best expressed by Gen. Eva Burrows, who said, “I had the privilege once in Calcutta to meet Mother Teresa at one of her feeding centers for the poor and outcast of that teeming city. When I asked her how she coped with all the fame and adulation she receives, she replied: ‘It means nothing to me. But one thing I have done which I believe is important. I have helped people to talk to the poor and not just about the poor.’ That is a simple but very significant statement which indicates ‘the poor’ are not just some conglomerate group which can be dismissed as an economically, non-productive sector of society that we are unfortunately stuck with. They are fellow human beings—real people, individuals—for whom we have concern and responsibility.” Burrows went on to say, “You may have seen the poor, but have you ever imagined how it must feel not to be able to provide food for your hungry children; not to have a shirt on your back. . . .”

Choose your charities carefully. Besides the Salvation Army, other good charities include the Make a Wish Foundation, St. Jude’s Hospital, and Catholic Relief Services. ★

# Democrats Squander House Majority

• Despite majority in House, Democrats fail to do anything for Americans

In a relentless attempt to impeach President Donald Trump that's more about cutting into his 2020 voter support than it is about the rather distant possibility of removing him from office, the House members from today's Democratic Party—which is largely a menagerie of hard-left extremist misfits whose only principle is that they have no principles—have barely budged in carrying out their main 2018 campaign promises of passing healthcare and education reform legislation, according to key Republican Congress members as well as some Democratic-liberal figures and news outlets.

“When Democrats took control of the House, they promised new leadership. They claimed they would work to accomplish the work and will of the American people. That's proven untrue, and instead, they continue beating the dead horse of impeachment,” said Rep. Matt Gaetz (R-Fla.) in a recent news release.

Gaetz, who made headlines for teaming up with 50 GOP House members at a press conference in October to protest Rep. Adam Schiff's (D-Calif.) closed-door intelligence committee meetings held

to explore the impeachment of Trump, also recalled the Democrats' entire failed Russia-collusion probe against Trump.

Calling the matter pure theater, he noted: “For the American people, the ticket was non-refundable. Democrats wasted 22 months, spent \$32 million of taxpayer money, and inflamed an already politically divided nation. . . . Democrats will pay for their charade at the ballot boxes in 2020.”

However, Gaetz, who's a member of the House Judiciary Committee, noted, “Time squandered on faux impeachment proceedings . . . and other

time-wasting exercises do nothing to create jobs, reform immigration laws, fix our healthcare system, or put more money in American families' pockets. . . . The exchange between President Trump and President Zelensky of Ukraine demonstrates no impeachable conduct, but ascertaining the truth has never been Democrats' goal. . . . At a time [when] we could—and should—be passing trade deals, lessening the opioid crisis, securing our southern border, and keeping our economy roaring, Democrats are instead blinded by partisan hatred.”

Even some liberal voices have scolded the House majority for failing to make progress on the party's “core issues.”

Former San Francisco mayor and prominent black Democrat Willie Brown, in an early-November *San Francisco Chronicle* op-ed, wrote: “Remember healthcare, the issue that won so many elections for Democrats in 2018? You might, but they don't seem to. Someone like Sen. # It's a Schiff Show on Capitol Hill

• Establishment attack dog fails to make convincing impeachment case

It's fitting that the man overseeing the impeachment charade against Donald Trump—Rep. Adam Schiff—bears the last name of one of the largest banking families in the world. It's unclear if he is related to Moses Schiff and his son Jacob, who were associated with Rothschild International banking cartel, as some claim.

Donald Trump Jr. was among those who insisted that Schiff's sister Melissa had been married to the son of George Soros until 2015, a claim which has subsequently been denied by Snopes and other establishment sources. Soros did unquestionably financially assist Schiff's congressional campaigns through his MoveOn.org outfit. Schiff was awarded the Toll Fellowship, which is sponsored by the Council of State Governments, and largely financed by Soros's Open Society Foundations. Ironically, the man Soros helped Schiff defeat, Jim Rogan, was one of 13 House managers in the 1998 impeachment case of Bill Clinton.

Schiff, like Bill Nye the non-scientist guy, is a frustrated entertainer; being the author of several rejected screenplays. The recently released Schiff-produced report on the Trump impeachment inquiry states, "President Trump's scheme subverted U.S. foreign policy toward Ukraine and undermined our national security in favor of two politically motivated investigations that would help his presidential reelection campaign. . . . The inquiry uncovered a months-long effort by President Trump to use the powers of his office to solicit foreign interference on his behalf in the 2020 election."

Schiff is now attempting to draw Rep. Devin Nunes into his deluded conspiracy theory, telling reporters, "It is deeply concerning that at a time when the president of the United States was using the power of his office to dig up dirt on a political rival, that there may be evidence that there were members of Congress complicit in that activity."

It is unknown how Schiff obtained them, but civil libertarians are appalled that the telephone records of House Intelligence Committee ranking member Nunes, Nunes's aide Derek Harvey, President Trump's personal attorney, Rudy Giuliani, and investigative reporter John Solomon, were included in the report. Judicial Watch President Tom Fitton charged that including the phone records was "a remarkable abuse of President Trump's constitutional rights."

Many would argue that it's a violation of all of their constitutional rights.

This is an especially glaring contradiction to the

Democrats' outrage at the mere mention of CIA "whistleblower" Eric Ciaramella's name.

As *The Wall Street Journal* reported,

Adam Schiff's 300-page House Intelligence impeachment report doesn't include much new about Mr. Trump's Ukrainian interventions. But it does disclose details of telephone calls between ranking Intelligence Republican Devin Nunes, Trump attorneys Rudy Giuliani and Jay Sekulow, reporter John Solomon, former Giuliani associate Lev Parnas, the White House, and others. The details are 'metadata' about the numbers and length of the calls, not the content. The impeachment press is playing this as if the calls are a new part of the scandal, but the real outrage here is Mr. Schiff's snooping on political opponents. The Democrat's motive appears to be an attempt to portray Mr. Nunes, a presidential defender and Mr. Schiff's leading antagonist in Congress, as part of a conspiracy to commit impeachable offenses.

Their depiction of Ukraine as a saintly damsel-in-distress flies in the face of the fact that the United States, in 2014, backed the overthrow of Ukraine's democratically elected president, who was thought to be too close to Russia and unwilling to advocate for his country's entrance into NATO. As former CIA analyst Ray McGovern pointed out, the "Russiagate" nonsense, with its propaganda promoting Putin as the latest in what H.L. Mencken once referred to as "an endless series of hobgoblins," reflects the interests of the military-intelligence-industrial complex.

White House Press Secretary Stephanie Grisham declared that Schiff's report "reads like the ramblings of a basement blogger straining to prove something when there is evidence of nothing. . . . At the end of a one-sided sham process, Chairman Schiff and the Democrats utterly failed to produce any evidence of wrongdoing by President Trump. This report reflects nothing more than their frustrations." ★

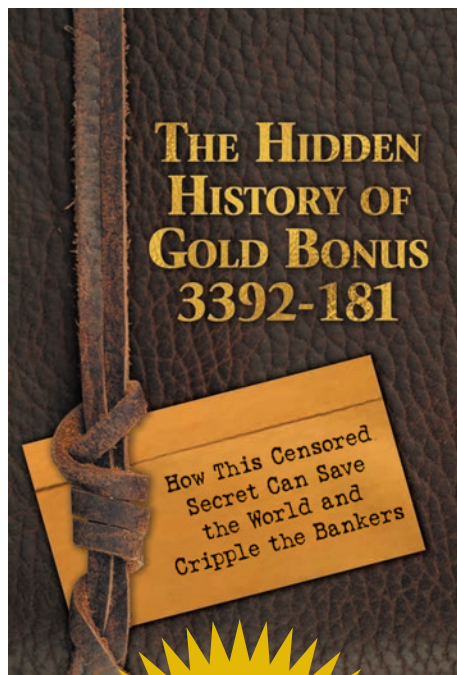

# Reuters Caught Rigging a Trump Impeachment Poll

**F**ake News cannot always be classified as stories that are created from nothing. Quite often, there are facts from which the story is generated. More often, those same facts have been manipulated to create the story the journalist or media organization wanted to tell. In the case of coverage of an early December Reuters/Ipsos poll, the kneejerk headline was “Support for Impeachment Increasing.” The more telling story behind the headline is Reuters’s own methodology, however.

According to Reuters, “The result, combined with Reuters/Ipsos polling over the past several weeks, showed that the number of Americans who want to impeach the president increasingly outnumbers those who do not.”

In the competitive 24-hour news cycle, there is a tendency to push headlines to air. With ratings and billions of dollars of advertising revenues on the line, there is little time to read entire reports. When a new poll is released, no one is reading the explanation of method. Push the headline. That’s what the pollsters want (Gallup, Zogby, Reuters, *et al.* all get their names on the air, thus legitimizing them) and that’s what the news outlets want. In this case, what was lost was the fine print at the bottom of the report explaining the politically disproportionate pool of responders.

“The Reuters/Ipsos poll was conducted online, in English, throughout the United States,” the report explained. “It gathered responses from 1,118 adults, including 528 Democrats, 394 Republicans and 111 independents. It has a credibility interval, a measure of precision, of 3 percentage points.”

A quick summation of the math tells us that Reuters polled more Democrats than Republi-

cans and Independents combined. A further explanation showed that the results are very much even, with nearly eight out of 10 Democrats supporting impeachment, while eight out of 10 Republicans oppose it. A few other recent polls have shown that support for impeachment has slightly decreased. It appears that Reuters was used as a corrector to an idea that cannot be allowed in the mainstream media—that impeachment is not wildly popular.

There is some reason to believe Reuters was a witting partner in this attempt to sway popular opinion. In 2016, Reuters was one of the news and polling organizations oversampling Democrats to show that Hillary Clinton had a considerable lead over Donald Trump. Reuters had oversampled Democrats 44% to 33%, which doesn’t sound like a large number. Yet, consider that in presidential polling, anything above 3% is considered outside the margin of error. Therefore, an oversampling of 11% is significant.

There’s something wrong with polling, as the election of 2016 clearly showed. Some pollsters explained the severe errors (lack of accuracy) in 2016 polls by explaining that they didn’t weight the polls enough based upon the level of education of respondents. What the elitist pollsters are saying is that they hadn’t counted on all the uneducated people coming out to vote for Trump. It’s a typical take from a group of pollsters who surround themselves with the D.C. Beltway to protect them from the ills of the “flyover states.”

In a rare moment of clarity, CNBC and *Wired* magazine proposed that there are two other reasons the 2016 polling was so inaccurate compared to the final results.

“One theory is that a large majority of undecided voters decided to vote for Trump at the last minute,” wrote Jake Novak at “CNBC.com.” “Another is that Trump was and is supported by dis-



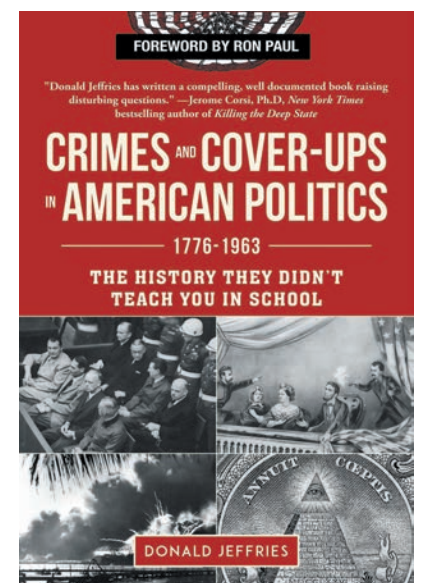

affected Americans who are very unlikely to respond to pollsters at all.” Novak calls these explanations “hard to fix or even prove.” Republicans can often be tricky like that. Sometimes, voters do not vote for the media’s chosen candidate, which always leaves pundits and analysts with their hands raised and palms up, screaming “How?” Those they feel are “uneducated” could easily explain it to them in a way that even the MSM would understand. When you’re deemed a “deplorable” who “clings to their God and guns,” the average American typically does not support those candidates, their ideologies, or their pollsters.

Reuters will continue to join the other mega-pollsters and news organizations pushing the narrative that Trump is increasingly unpopular and losing his grip on whatever power he had within the party and country. They’ll have the numbers to prove it, no matter how they have to manipulate the method to “prove” their position. They cannot possibly fathom that any other narrative could be true. ★

# U.S.-Israel Defense Pact Dangerous

**M**ilitary alliances can benefit weak nations through the connection with a great power, and the strong nation also benefits by having allies should it have to go to war. But the downside is, of course, that the alliance itself will automatically escalate a minor conflict into something much greater.

Two world wars began because of unconditional pledges made by one country to come to the assistance of another. On July 5, 1914, Kaiser Wilhelm II of Germany pledged his country's complete support for whatever response Austria-Hungary would choose to make against Serbia after the June 28 assassination of Archduke Franz Ferdinand of Austria by a Serbian nationalist during an official visit to Sarajevo, Bosnia. This fatal error went down in history as Germany's *carte blanche*, or "blank check," assurance to Austria that led directly to WWI.

In September 1939, World War II began when Great Britain and France came to the assistance of Poland after the German army invaded, fulfilling a "guarantee" made in March of that year. What was a regional war, and one that might have been resolved through diplomacy, became global.

More recently, concerns about the expansion and very existence of the North Atlantic Treaty Organization military alliance have surfaced, with critics both in the United States and Europe questioning the inclusion of countries like Montenegro, which would have to be defended under Article 5 of the NATO pact if it should somehow go to war with a neighbor. And within the pact itself there are neighbors who hate each other, notably Turkey and Greece, while further expansion into Eastern Europe will undoubtedly produce a strong response from Russia.

One would think that after such commitments were assessed by historians as the immediate

causes of two world wars, no one would ever consider going down that road again. But that would be reckoning without Sen. Lindsey Graham (R-S.C.), who has been calling for a "defense treaty" with Israel since last April. Graham announced late in July that he was seeking bipartisan support for providing "blank check" assurances to Israeli Prime Minister Benjamin Netanyahu and is hoping to be able to push a complete defense treaty through the Senate by early 2020.

In making his several announcements on the subject, Graham had been acting as a front man for both Netanyahu and also for the Jewish Institute for the National Security of America (JINSA), which wrote the basic document that is being used to promote the treaty and then enlisted Graham to obtain

congressional support.

Speaking to the press on a JINSA conference call, Graham said the proposed agreement would be a treaty that would protect Israel in case of an attack that constituted an "existential threat." Citing Iran as an example, Graham said the pact would be an attempt to deter hostile neighbors like the Iranians, who might use weapons of mass destruction against Israel. JINSA President Michael Makovsky elaborated on this, saying, "A mutual defense pact has a value in not only deterring but might also mitigate a retaliatory strike by an adversary of Israel, so it might mitigate an Iranian response to an attack on its nuclear facilities."

JINSA director of foreign policy Jonathan Ruhe added, "An Israeli strike on Iran's nuclear program would not activate this pact, but a major Iranian retaliation might. . . . An Israeli unilateral attack is not what the treaty covers, but rather massive Iranian retaliation is what we are addressing."

It is by no means clear whether Graham and Ruhe seriously thought they could pull together a one-sided agreement whereby the United States would effectively issue a free pass for Israel to attack its enemies, but the idea of some kind of mutual defense military arrangement has clearly become a leading issue for Secretary of State Mike Pompeo and Netanyahu, who is under indictment for corruption. In early December the two men met for nearly two hours in Lisbon to discuss the details of what might well develop into a formal U.S.-Israel defense pact. Netanyahu, for his part, is clearly looking for a lifeline to re-election and is hoping that a deal with Washington that would guarantee Israel's security would appeal to voters and enable him to stay in power.

Though details of such an agreement are as of now unknown, it is being sold in outline in the Israeli media as a blanket commitment by the United States to defend Israel while also in no way restricting Israel's ability to continue its unilateral attacks on targets in Syria and Iraq. Interestingly, Netanyahu also asserted after the meeting that his

country has a “full right” to annex the Jordan River Valley “if we choose to do so.” The valley runs along the international border with Jordan, which clearly was not consulted by either the United States or Israel on the matter even though its relationship with both countries is friendly. The valley itself on its western side currently notionally belongs to the Palestinians, who were also not consulted, as Israel believes itself to have a free hand when it comes to stealing other peoples’ land.

To be sure, it is expected that both Jordan and the Palestinians will object to any annexation, particularly as it would mean that the remaining *ban-tustans* on the Palestinian West Bank would be completely surrounded by Israel. Some Israeli officials believe that Jordan will act decisively and are concerned that a cooperative relationship with an Arab state will turn sour, making the occupation itself less than desirable and hard to sustain.

It is expected that Pompeo and President Donald Trump will go along with whatever Netanyahu decides to do. Israel has long been reluctant to enter into any actual treaty arrangement with the United States because it might limit its options and restrain its aggressive pattern of military incursions, but the willingness of the White House to rubber stamp any such action backed up by a security pact guarantees that Washington will not seek to limit Netanyahu’s “options.” And, even though the treaty is reciprocal, there is no chance that Israel will ever be called upon to do anything to defend the United States, so it is as one-sided as most arrangements with the Jewish state tend to be.

As any defense agreement between the two countries would be legally a treaty that has to be ratified by the Senate, it would be much more difficult to scrap by subsequent administrations than was the Iran nuclear deal, which was an executive action by President Barack Obama. And clearly a defense pact could serve as a green light for an Israeli attack on Iran, should they opt to do so, while also serving as a red light to Tehran vis-à-vis an ironclad U.S. commitment to “defend” Israel that would serve to discourage any serious Iranian retaliation. Given that dynamic, the treaty would be little more than a one-way security guarantee for Israel.

And there are other issues arising from a “defense treaty.” Defense means just that, and treaties are generally designed to protect a country within its own borders. Israel has no defined borders, as it is both expansionistic and illegally occupying Palestinian land, so the United States would in effect be obligated to defend space that Israel defines as its own. That could mean almost anything. Israel is currently bombing Syria almost daily even though it is not at war with Damascus. If Syria were to strike back, and a defense treaty were in place, Washington would technically be obligated to come to Israel’s assistance. A similar situation prevails with Lebanon and there have also been reports that Israel is bombing alleged Iranian supply lines in Iraq, where the U.S. has 5,000 troops stationed.

The real problem is that the Trump administration is obsessed with regime change in Iran, but it has so far been unable to provoke Iran into starting a conflict. A defense pact with Israel just might be part of a White House plan to end-run Congress and public opinion by enabling Israel to start the desired war, whereupon the U.S. would quickly follow in to “defend Israel,” obliged by treaty to do so. What could possibly go wrong? The correct answer is “everything.” ★

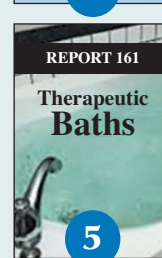

# Palestinian Suffering Continues; Netanyahu Contemplates Prison

Israel is facing a political crisis and the man at the center of it is Prime Minister Benjamin Netanyahu, who was recently indicted for bribery and fraud. Former Secretary of State Rex Tillerson famously said of Netanyahu that he lied and “played” President Donald J. Trump to persuade him to adopt a tougher line on Iran.

Throughout his political career Netanyahu had been willing to deceive to get his way by demonizing the Palestinians to maintain control of the hard right in Israeli politics. His legacy is such that, no matter who rules Israel in decades to come, he may have expanded illegal Jewish settlement in the West Bank to such a degree that the future prospects for the creation of a Palestinian state will be slim if not out of reach. That was clear with the announcement by the Trump administration that it would no longer abide by international law that has for 40 years deemed Israeli West Bank settlements illegal structures under international law.

Netanyahu is nowadays in political limbo, given he and his main opponent, former Gen. Benny Gantz, have been unable to form a government in the wake of two elections this year in which neither emerged victorious. Netanyahu is desperate to remain in power because he knows that, if he fails, he will be unable to delay a trial that could see him go to jail for years, perhaps from five to 10.

He would not be the first Israeli prime minister to end up in a cell. His predecessor, Ehud Olmert was released from jail in 2017, after serving a 16-months jail term for crimes similar to those Netanyahu is believed to have committed. When Olmert was released, he blamed Netanyahu for his incarceration and suggested that Netanyahu’s crimes were worse than his. He also

leveled criticism at former Israeli Prime Minister Ehud Barak, whose name surfaced in the many investigations into the late Jeffrey Epstein, the millionaire pedophile. Since Epstein’s mysterious death in a detention cell in Manhattan, it has transpired that Barak spent time on Epstein’s planes and had started a tech business with him.

Netanyahu’s alleged crimes include taking money and gifts from Hollywood producer Arnon Milchan and Australian billionaire James Packer. Netanyahu is also charged with negotiating a fraudulent deal with the owner of Israel’s biggest newspaper, *Yedioth Ahronoth*, to get special coverage.

Lately, Netanyahu, or Bibi as he liked to be known, has reverted to playing his extremist card to garner support among Israel’s radical electorate, first by attacking the Palestinians and by heightening tensions with his neighbors, especially Iran and Syria. He knows that any effort to accuse Iran of wrongdoing, whether or not it is based on fact, creates paranoia in Washington and bolsters his Zionist base in Congress.

Since Trump’s arrival in the White House, pro-Zionist elements in Congress have dominated Middle East policy, including moving the U.S. embassy from Tel Aviv to Jerusalem. Trump has also appointed his leading Jewish financial backers to senior roles in developing strategies favored by Netanyahu. One of those backers is Sheldon Adelson, the casino mogul who has been a crucial figure in representing Israel’s interests within the White House.

A policy driven by Adelson that clearly illustrated how Israel was calling the shots in Washington was a declaration by Trump that the Israeli-occupied Golan Heights belonged to Israel; in total contravention of international law that has consistently recognized Golan as Syrian land.

What has been clear about Netanyahu’s cynical leadership is that he has consistently used his military to launch attacks on Gaza, leading to deaths of many innocent Palestinians, often with

the aim of improving his political standing. That is a view held by many of his critics, and it has been evidenced by increasing attacks on Gaza.

For its part, the U.S. mainstream media has consistently refused to reflect the plight of Palestinians under Israeli occupation; an occupation that has been condemned by many UN resolutions. A 2019 world report by Human Rights Watch exposed the fact that between March and November 2018, Israeli soldiers killed 189 Palestinian demonstrators. Of those, 31 were children and three were medial staff. Live fire also wounded over 5,000 more.

Netanyahu becomes incensed when groups globally accuse Israel of converting Gaza into an apartheid state. It is a comparison with the South African state of the 1970s.

Pro-Zionists in Washington are angered any time Gaza is described as the world’s largest open-air prison, but in both instances it is hard to deny the facts.

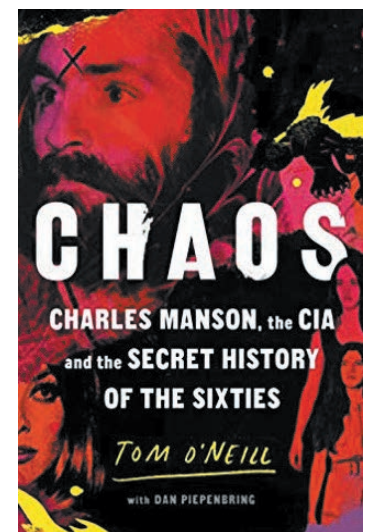
Should Netanyahu be reelected in a third Israeli national election, the Middle East will descend further into conflict. ★

# New Seton Hall Report Exposes Details of Bush Torture Program

• Victims reveal barbarity of U.S. “enhanced interrogations”

A recently published report highlights in graphic detail the barbarous “enhanced interrogation” techniques developed and administered by the CIA against various detainees under President George W. Bush in the aftermath of the Sept. 11 terrorist attacks and the initiation of the Global War on Terror.

The report, authored in part by Seton Hall University School of Law Professor Mark Denbeaux, is entitled, “How America Tortures,” and features never before seen illustrations drawn by Abu Zubaydah, depicting the brutal interrogation techniques utilized against him while in custody at CIA “black sites” shortly after his capture and arrest in March 2002.

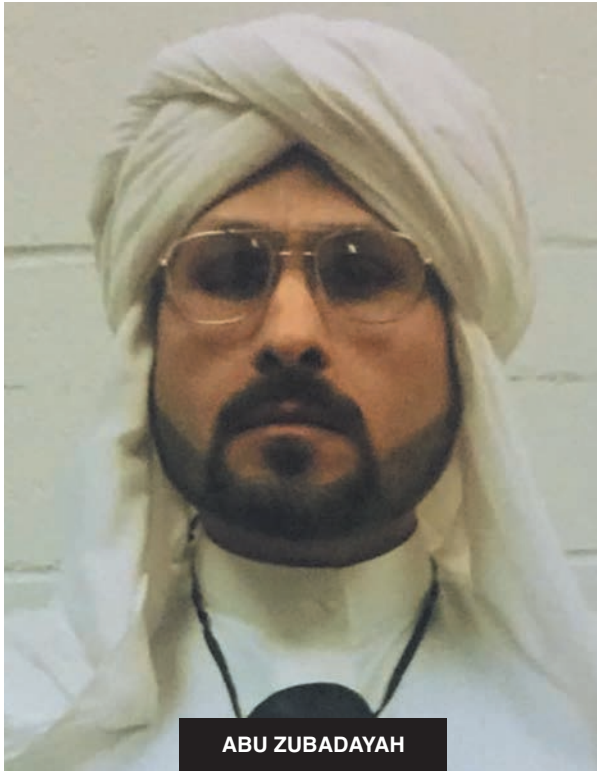
Zubaydah, a Palestinian-born man whose given name is Zayn al-Abidin Muhammad Husayn, was wounded and captured in late March 2002 in Pakistan. He has long been alleged to be a high profile al-Qaeda operative and was described by Bush following his capture as “one of the top operatives plotting and planning death and destruction on the United States.” Subsequent investigations have discovered that these allegations were false, yet Zubaydah remains indefinitely detained at Guantanamo Bay prison in Cuba.

The report analyzes the so-called torture memos developed by the CIA outlining the specific techniques that were to be utilized against Zubaydah and other detainees in the Global War on Terror. The report also relies on descriptions of the torture techniques provided by Zubaydah, including illustrations drawn by him depicting his torture, as well as internal CIA documents, the Senate Select Committee on Intelligence Report, and other government documents.

The so-called torture memos, which were prepared by the CIA in 2002, outline a now-outlawed interrogation program that utilized violence, extreme isolation, and sleep deprivation on detainees in order to extract information and confessions.

One of the recently released illustrations drawn by Zubaydah shows the man strapped down naked on a table with a hood covering his head. Water is then poured over his hooded head, simulating a drowning scenario. This “enhanced interrogation” technique, often referred to as waterboarding, was later described by the Senate Intelligence Committee’s study as “brutal and far worse than the CIA represented.” According to the latest reports, Zubaydah was subjected to this torture technique over 80 times while in CIA custody.

“They kept pouring water and concentrating on



my nose and my mouth until I really felt I was drowning and my chest was just about to explode from the lack of oxygen,” Zubaydah explained to his lawyer in a declassified report.

Zubaydah was also subjected to a variety of other brutal torture techniques, including prolonged periods of sleep deprivation, having his head slammed repeatedly into a wall, and being confined and isolated in boxes, including in a coffin-shaped box, restricting his movement. Zubaydah recounted that he had been kept awake at one point for “maybe two or three weeks or even more.”

“It felt like an eternity,” he stated, “to the point that I found myself falling asleep despite the water being thrown at me by the guard.”

The CIA’s interrogation team videotaped many of the torture sessions, only to destroy them all in 2005 at the behest of Jose Rodriguez, then the head of the CIA’s clandestine service.

Incredibly, Zubaydah has not been officially charged or tried for any of his alleged crimes, and remains in federal custody indefinitely.

Zubaydah’s legal team has brought cases before the European Court of Human Rights, whose member countries, including Poland and Lithuania, were at least partially complicit in the extraordinary rendition program that transported detainees such as Zubaydah to CIA black sites for these torture sessions.

The latest report demonstrates conclusively once again how far America has strayed from her principles as a result of the prosecution of the Orwellian Global War on Terror. ★

# Once Again, Iraq Descends Into Complete & Utter Chaos

It is exactly two years since ISIS was defeated in its Iraqi stronghold of Mosul, but that good news has since been eclipsed by street violence that has sent Iraq plummeting into chaos.

Since October, over 400 protesters have been killed, and as many as 10,000 injured, on the streets of the country's major centers, mostly the capital, Baghdad where 20 died on Dec. 6. Many of the dead and injured have been young people protesting against the excesses of country's elites and their corruption that has led to garbage in the streets, electricity blackouts, and massive unemployment.

Iraq is not alone facing corruption or protests. The same has been happening across the region, especially in Lebanon and Algeria, but it is in Iraq where the outcomes could have the greatest impact on the whole region and on U.S. foreign policy. In Washington there are some who still believe in the pottery barn rule that if you break it, you own it, and the wars in Iraq mean that the U.S. has a responsibility for that country's plight.

The mass media has paid little attention to Iraq and to the growing protests across the Middle East, or the fact that there is considerable potential for the re-emergence of a strengthened ISIS and al Qaeda. The killings of protesters in Iraq have been carried out by the Iraqi military, militias considered loyal to Iran, and unknown elements. The role of the military came under verbal attack from the nation's most powerful Shia cleric, Grand Ayatollah Ali al-Sistani. The intervention of the ayatollah led to the immediate announcement by the country's prime minister that he was resigning, but his resignation may not come into effect for months.

The ayatollah said he wanted a new prime minister elected without foreign interference. One of

his acolytes, Moqtada al-Sadr, has also returned to prominence, using unarmed members of his militia to protect protesters.

To add to the chaos, there was a drone attack on al-Sadr's Baghdad compound, but no one claimed responsibility.

There were also Katyusha rocket attacks on an Iraqi military facility close to a U.S. consulate, on a building used by Iraqi units trained by U.S. special forces, and on Iranian diplomatic sites. Again, it was not possible to identify the perpetrators.

It was notable, however, that the attacks on Iranian targets mirrored claims by some protesters that the Iraqi elites owed their allegiance to Iran, and that Iran should stop messing in Iraqi politics.

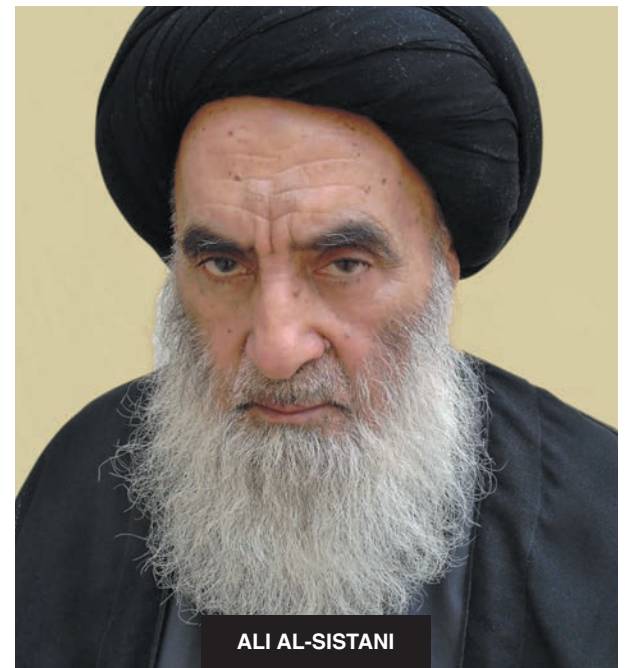
In Najaf, mobs burned the Iranian consulate to the ground. Elsewhere, journalists, photographers and social activists have been abducted by armed men in SUVs. In one case, the tortured body of a 19-year-old female, who was a well-known protester, was dumped outside her family home.

The chaos begs the question what and who is behind most of it?

To answer that, one has to accept that there are multiple competing internal and external elements involved in deliberate efforts to destabilize Iraq, Iraq, Lebanon, and Syria.

While there is an authentic protest movement seeking to redress genuine grievances in some of these countries, there are other factors at play.

The Israelis, the Saudis, and elements in Washington with a neoconservative agenda, have reason to promote instability in Iraq, Syria, and Lebanon to thwart what they see as Iranian influence. And while Benjamin Netanyahu remains in power in Israel, he will continue to seek to undermine Iran and its allies. He has been bombing Syria at will and has tried to draw Hezbollah and Iran into a shooting war. His foreign minister, Israel Katz, recently announced that Israel, the U.S., the Saudis and the UAE were ready to launch

hundreds of cruise missiles at Tehran. While so much instability carpets the region, this kind of rhetoric is both dangerous and irresponsible.

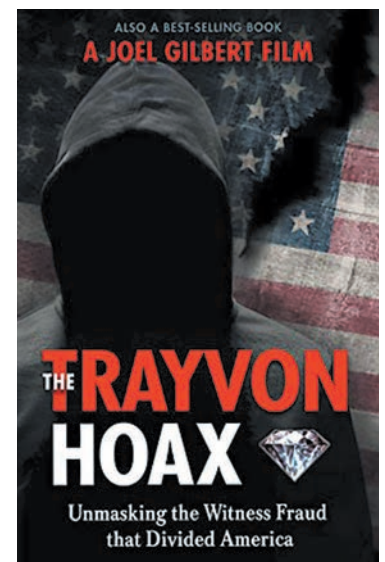
Iraq post Saddam Hussein's reign has been far from stable, though the defeat of ISIS in Mosul in 2017 was seen by many to be the catalyst for a new beginning. Unfortunately, while the terror threat was eliminated, the elites who have held the reins of political power with the backing of either Washington or Tehran have been milking the system, and have dealt harshly with anyone questioning their authority, using the military to do so.

The dilemma facing the Trump administration and NATO is what role they could adopt if Iraq descended into a civil war in which Iran felt it had a right to intervene on behalf of the majority Shias.

The fact is that, in a tribal nation like Iraq where Sunnis and Shias have slaughtered each other, there is an innate tendency for some to exploit divisions to offset and deflect from the reality. In that scenario, all sides, including the Trump administration might be inclined to reevaluate their options. ★

# U.S. Workers the Victims

• 800,000 Indians working jobs in America today

Few Americans have heard of the Optional Practical Training program (OPT). Under this insidious program, the Justice Department gives companies an astounding \$2 billion in tax breaks, rewarding them for hiring approximately 300,000 foreign workers instead of their American counterparts, most of whom invested a great deal of money (often incurring student loan debt in the process) to earn their college degrees. The program is merely a logical extension of laws that already permit foreign students to attend American universities.

India, where the majority of the foreign workers under this program come from, strongly supports it. OPT funnels some 50,000 of recent Indian graduates into prestigious American jobs and is beneficial to all the Indian recruiters who assist in the process. The program is also a major feeder of the H-1B visa program, which ensures that an alarming 750,000 Indian graduates attain American jobs, which has devastated the information technology industry. Like chain migration has helped swell immigration numbers even further, the U.S.-India outsourcing economy hands even more jobs to those in India.

In November, the U.S.-India Strategic Partnership Forum (USISPF), a powerful spinoff of the U.S. Chamber of Commerce, declared, "USISPF's Workforce Mobility Committee will . . . continue to make the case for the free flow of skilled labor in both countries." In other words, low-paid workers in India take jobs from Americans, thereby lowering the wages of all jobs in that industry. USISPF is run by current and former CEOs of huge corporations like Cisco, Boeing, Adobe, Dell, Caterpillar, FedEx, Marriott, and PepsiCo, among others.

"That's just a fancy way of saying unlimited immigration . . . [and] is a recipe for a political explosion," countered Mark Krikorian, director of the Center for Immigration Studies. "U.S. computer careers would become completely foreignized . . . [and] the middle class could well experience the kind of displacement that much of the [Midwest industrial] working class has felt, potentially with similar consequences, like opioid epidemics."

USISPF includes such veteran Deep State globalists as Henry Kissinger, former Sen. and Secretary of Defense William Cohen, and former Secretary of State Condoleezza Rice. According to its leader, John Chambers, "USISPF aims to further [the] interests of both nations by engaging with Democrats and Republicans in the House and Senate along with the parliamentarians in India. USISPF believes that our shared democratic values lie at the heart of the

growing U.S.-India Strategic Partnership and will lead through dynamic exchanges on the legislative side."

The group, like much of corporate America, utilizes the demonstrably false mantra that their companies desperately need foreign workers, due to a lack of "skilled" people in this country. The group is also pushing for more Indian doctors, nurses, and therapists, under the guise of lowering healthcare costs. It will certainly lower their overhead, because foreign labor always comes significantly cheaper.

India presently has 10 million slaves. There is no public outcry about this from the social justice warriors, no call for an embargo or any other punitive measure. Of the 170 million Indians enrolled in university courses in their homeland, the quality of education is uneven, and both cheating and nepotism are accepted as normal. The 800,000 Americans with skilled degrees from domestic universities are a drop in the bucket compared to this potential pool of cheap foreign labor. This matches exactly the number of 800,000 Indians working in American jobs. All the visa work programs combined permit roughly 1.5 million foreign graduates to take jobs that could be open to debt-burdened American

peers. The Senate is presently trying to pass S.386, a bill that would further encourage and reward Indians displacing American citizens from white-collar positions. Other nonsensical programs provide work permits for blue-collar jobs to another 1 million foreigners every year.

Under President Donald Trump, who has predictably flip-flopped on this issue, the

inflow of H-1B visa workers has decreased moderately, without him making any significant changes or eliminating the program, as he promised during his campaign. This still amounts to the largest increase in H-1B denials since the institution of the program, which began under President George H.W. Bush in 1990. Technology giants like Apple, Google, and Facebook continue to lobby for more foreign workers, and, in fact, rejection rates in the largest technology firms remain unchanged. Corporate titans and their investors understand the relationship between payroll costs and stock market gains. According to the Department of Labor, more than half of H-1B visa holders are paid less than industry averages.

Congress did not create or authorize counterproductive programs like OPT. The Department of Homeland Security has been given the legal authority to redefine what "education" is, extending it to mean that foreign graduates are still being educated by American companies. The S.386 bill is being sponsored by Sen. Mike Lee (R-Ariz.). To most Democrats, the legislation doesn't do enough to favor foreign workers. ★

The Senate wants to pass a bill that would further hurt U.S. workers and benefit foreigners.

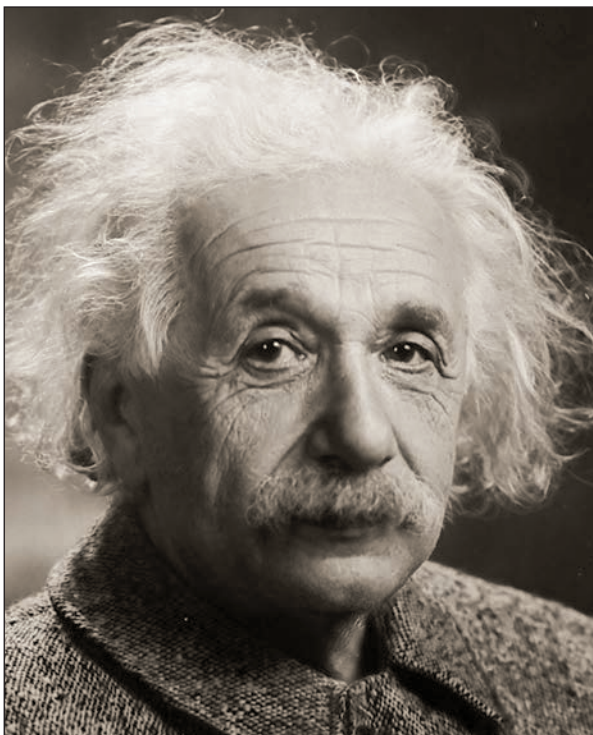

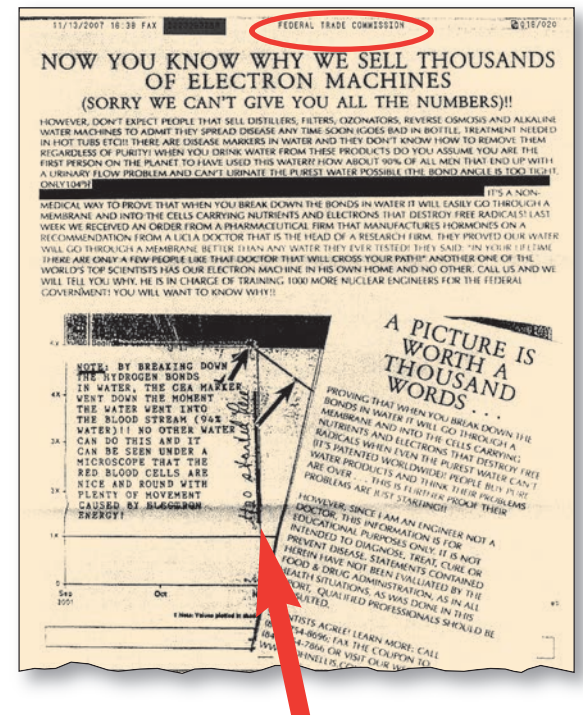

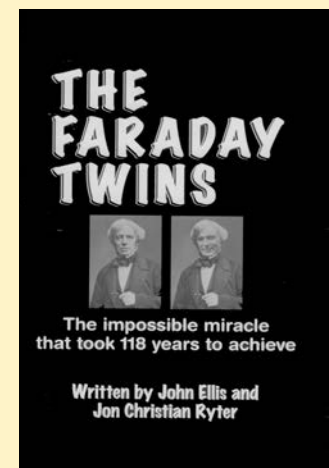

While Americans have been fixated on the carefully orchestrated impeachment drama that continues to monopolize headlines, Congress passed and President Donald Trump signed into law legislation extending three key provisions of the USA Patriot Act, which had been set to expire on Dec. 15.

Once again, to no one's surprise, the bureaucrats on both sides of the aisle—Democrats and Republicans alike—prioritized political grandstanding over their oath of office to protect and defend the Constitution.

As journalist Norman Solomon writes for *Salon*, “The cave-in was another bow to normalizing the U.S. government’s mass surveillance powers.”

That, right there, is the key to all of this: normalizing the U.S. government’s mass surveillance powers.

In the 18 years since the USA Patriot Act—a massive 342-page wish list of expanded powers for the FBI and CIA—was rammed through Congress in the wake of the so-called 9/11 terror attacks, it has snowballed into the eradication of every vital safeguard against government overreach, corruption, and abuse.

The Patriot Act drove a stake through the heart

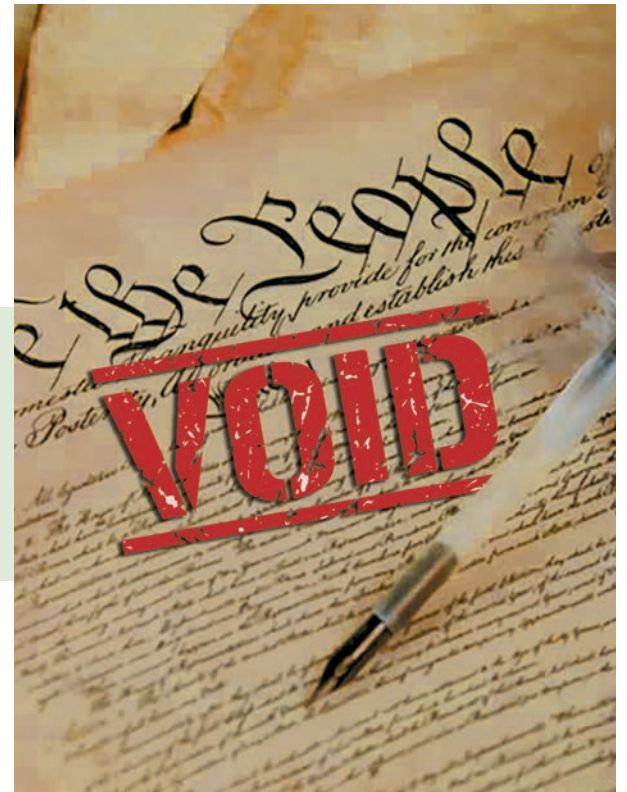

of the Bill of Rights, violating at least six of the 10 original amendments—the First, Fourth, Fifth, Sixth, Seventh, and Eighth Amendments—and possibly the Thirteenth and Fourteenth Amendments, as well.

The Patriot Act also redefined terrorism so broadly that many non-terrorist political activities such as protest marches, demonstrations, and civil disobedience are now considered potential terrorist acts, thereby rendering anyone desiring to engage in protected First Amendment expressive activities as suspects of the surveillance state.

The Patriot Act justified broader domestic surveillance, the logic being that if government agents knew more about each American, they could distinguish the terrorists from law-abiding citizens—no doubt a reflexive impulse shared by small-town police and federal agents alike.

According to *Washington Post* reporter Robert O’Harrow Jr., this was a fantasy that “had been brewing in the law enforcement world for a long



time.” And 9/11 provided the government with the perfect excuse for conducting far-reaching surveillance and collecting mountains of information on even the most law-abiding citizen.

Federal agents and police officers are now authorized to conduct covert black-bag “sneak-and-peak” searches of homes and offices while you are away and confiscate your personal property without first notifying you of their intent or their presence.

The law also granted the FBI the right to come to your place of employment, demand your personal records, and question your supervisors and fellow employees, all without notifying you. It allowed the government access to your medical records, school records, and practically every personal record about you. It allowed the government to secretly demand to see records of books or magazines you’ve checked out in any public library and internet sites you’ve visited (at least 545 libraries received such demands in the first year following passage of the Patriot Act).

In the name of fighting terrorism, government officials are now permitted to monitor religious and political institutions with no suspicion of criminal wrongdoing, prosecute librarians or keepers of any other records if they tell anyone that the government has subpoenaed information related to a terror investigation, monitor conversations between attorneys and clients, search and seize Americans’ papers and effects without showing probable cause, and jail Americans indefinitely without a trial, among other things.

The federal government also made liberal use of its new powers, especially through the use (and abuse) of the nefarious national security letters, which allow the FBI to demand personal customer records from internet service providers, financial

institutions, and credit companies at the mere say-so of the government agent in charge of a local FBI office and without prior court approval.

In fact, since 9/11, we've been spied on by surveillance cameras, eavesdropped on by government agents, had our belongings searched, our phones tapped, our mail opened, our email monitored, our opinions questioned, our purchases scrutinized (under the USA Patriot Act, banks are required to analyze your transactions for any patterns that raise suspicion and to see if you are connected to any objectionable people), and our activities watched.

We're also being subjected to invasive pat-downs and whole-body scans of our persons and seizures of our electronic devices in the nation's airports. We can't even purchase certain cold medicines at the pharmacy anymore without it being reported to the government and our names being placed on a watch list.

Largely due to the continuous noise from television news' talking heads, most Americans have been lulled into thinking that the pressing issues are voting in the next election, but the real issue is simply this: The freedoms in the Bill of Rights are being eviscerated.

We can pretend that the Constitution, which was written to hold the government accountable, is still our governing document. However, the reality we must come to terms with is that in the America we live in today, the government does whatever it wants, freedom be damned.

What once were considered inalienable, fundamental "rights" are now mere privileges to be taken away on a government bureaucrat's say-so.

To those who have been paying attention, this should come as no real surprise.

As I make clear in my book *Battlefield America: The War on the American People*\*, the Constitution has been on life support for some time now and is drawing its final breaths.

The American government, never a staunch advocate of civil liberties, has been writing its own orders for some time now. Indeed, as the McCarthy era and the wiretapping of Martin Luther King Jr. and others illustrates, the government's amassing of power, especially in relation to its ability to spy on Americans, predates the passage of the Patriot Act in 2001.

What the Patriot Act and its subsequent incarcerations did was legitimize what had previously been covert and frowned upon as a violation of Americans' long-cherished privacy rights.

As long as government agencies are allowed to make a mockery of the very laws intended to limit their reach, curtail their activities, and guard against the very abuses to which we are being subjected on a daily basis, our individual freedoms will continue to be eviscerated so that the government's powers can be expanded, the Constitution be damned. ★

convictions on those three charges. A federal district court overturned the convictions on First Amendment grounds and I was released in April 2011. In 2012, the prosecution appealed the decision and my unending saga of incarceration began.

With your help, I have not only challenged the U.S. legal system on several important fronts, I have also learned quite a bit about the law, finding that I can, in many cases, research case law myself rather than paying attorneys to do it. Of course, I cannot do it ALL without dedicated, professional legal help, and this is what costs money—sometime lots of it.

**Without your help, all of these small but accumulating victories would have been impossible.**

Your cards and letters are also a great comfort to me and have gotten me through some very rough times. If you care to correspond with me about my ongoing legal cases, feel free to write to the address below.

# Deep State Doesn't Like Exposure

• Media coverage of “deep state” has puppetmasters scurrying for shadows

The author of *The Shadows of Power: The Council on Foreign Relations and the American Decline*, says the Deep State itself has become concerned that the widespread popularization of the words “Deep State” could get out of hand and wake up an uncomfortably large cross section of the U.S. to the reality of a power behind the throne that runs deeper than the government itself.

“The ‘Deep State’ is probably the most commonly used phrase for what we used to call the establishment, the insiders, the global elite, the powers that be,” James Perloff told this AFP writer Dec. 8.

Perloff has over the last 30-plus years penned briskly selling books to expose various facets of the Deep State. His 1988 book *The Shadows of Power* is considered a foundational work for understanding the Council on Foreign Relations (CFR) a major deep-state instrument legendary for supplying personnel steeped in the ideology of internationalism and world government for high-level government positions, while helping craft government policy behind the scenes that’s been largely detrimental to the American constitutional republic model of government.

Yet such shadowy influence is still unknown among most Americans. In the Trump era, however, where the president has been challenging media domination via his bully pulpit and his Twitter account, phrases like “fake news” and “Deep State” have become household terms—something that could give the central banking-connected trans-nationalist ruling clique a case of the jitters. Thus, a little damage control is in order.

Enter academic Margaret O’Mara. This professor of history at the University of Washington-Seattle was doing damage control when she wrote



an Oct. 26 *New York Times* op-ed column in which she claims that the Deep State is limited to the federal bureaucracy, a.k.a., the civil service and the careerists who’ve worked there for decades while those elected to office come and go.

O’Mara noted, accurately enough, that the money and demands of 19th-century robber barons, in the post-Civil War years, corrupted the federal government and infested it with cronyism until a merit system was created on Teddy Roosevelt’s watch. What she failed to mention, however, is that the Morgan, Carnegie, and Rockefeller money that helped foster that cronyism was shifted to creating the CFR and similar outlets with which to influence the government covertly rather than overtly. Thus, the Deep State

is more than just the government bureaucracy itself, vast though it may be.

Perloff agreed that O’Mara is trying to reframe the meaning of “Deep State,” so as to mask its true dimensions and make it sound like it’s just a sluggish bureaucracy prone to common corruptions and blunders, as opposed to something that involves certain tax-exempt foundations (Carnegie, Rockefeller), organizations like the CFR, Trilateral Commission, and Bilderberg, and various other groupings involving people who served in high government posts like President Jimmy Carter (documented Trilateral influence) and Henry Kissinger (undeniable CFR and Bilderberg influence).

“And [we] used to have some relative independence from some of the newspapers,” Perloff continued. “Back in 1983 there were 50 corporations controlling media—now it’s down to five.” Asked if he believed the media is part of the Deep State, Perloff replied: “The media? Absolutely. You can see it in terms of the media ownership, which is vital for getting people to think what you want them to, to get them to fight wars.”

Of course, Perloff didn’t overlook the sheer irony of the big media—which claims to “speak truth to power” in order to quell corruption, right wrongs, and expose the power of the secretive state—actually being a part of the Deep State. Perloff has taken note over the decades of key media people like Dan Rather, Tom Brokaw, Barbara Walters, Hedley Donovan (*Time* magazine) and longtime *Washington Post* madame Katherine Graham, among many others, having belonged to the CFR and/or related organizations and in many cases mingled and spoke at the events of these tax-exempt institutions with painfully little publicity on their remarks and specific activities.

Summarizing, Perloff noted of the Deep State: “Essentially it’s private but as Ferdinand Lundberg [a late author who chronicled the exploits of the “super rich,” including the Rockefellers] said, ‘they’ operate ‘behind the façade of democracy.’ And the Deep State is also a Luciferian thing; no doubt in mind about that, either. Secret societies—such as the Illuminati—they’re private, but to control the people you must control the government. You’ve got to have people in the state and defense departments to make things happen. There’s also been speculation that there are two CIAs or, more likely, two tiers of it—one, the regular wing, and another whose loyalty is not to America but to the Deep State.”

On a more hopeful note about alternative media ultimately triumphing over this colossus of power, Perloff added: “I think ‘they’ underestimated the power of social media to inform people; I think they thought the internet would enable them to spy on us and we’d just shop at Amazon.” ★

# ‘Drag Queens’ Bypassing Parents to Indoctrinate Children Directly

**A** Willis, Texas high school believes that parents should not have the final say when it comes to raising a child. “I believe that raising a child is the responsibility of the community and that parents should not have the final say,” English teacher Anthony Lane said. “Let’s be honest; some of you don’t know what is best for your kids.”

The cosmetology faculty at Willis High School had invited a man who dresses in women’s clothes—also known as a “drag queen”—named “Miss Lynn Adonis” to their school to discuss makeup application. By all accounts, the guest stayed on topic and did not discuss lifestyle choices or his own experiences as a drag queen. Yet the furor over the visit led to some revealing comments made by faculty and staff. It is in the wake of this visit that the social engineering of the left has come to light even more, and even in the conservative Lone Star State.

While parents were not specifically notified of the drag queen’s visit to the school, “Drag Queen/Makeup Class” had been on the school’s Facebook calendar. Yet, because he goes only by his stage name, there are questions about whether his actual name is registered with the school district. After 9/11 and in response to school shootings, most schools have, at minimum, a sign-in process and, at most, require background checks for all visiting speakers.

Dale Inman, a Conroe Independent School District trustee, echoed the concerns parents expressed to the district.

“I put numerous calls in to the administrator’s office, which, of course, made it abundantly clear they will not talk about it,” Inman said. “I’ve got a

problem when somebody with a false name enters a school and has advertised himself as an adult exotic dancer for men. . . . Nobody would be allowed in a school under those circumstances. As a parent, I have a right to know who’s in that school building.”

The vocal faculty closed ranks after the incident occurred in Willis. Lane went overboard, saying that raising the child is the responsibility of the community and that parents should not have the final say, but that wasn’t his sole comment, blasted into the public under the heat of a questioning media. On Facebook, he also wrote (in a now-deleted post), “Parents believe they should be able to storm the school in the name of political and religious beliefs if something happens in the school that they are morally opposed to. They forget that we make a promise to prepare their children to live in a diverse world. We are not required to protect the misguided, bigoted views of their parents.”

Not only does this high school English teacher believe parents are not ultimately responsible for their children; he also believes that parents who do not want their kids taught for a day by a drag queen are bigots.

There is a video on YouTube entitled “Houston Gaymers Fall Drag Show—Lynn Adonis.” In it, the same drag queen is seen dancing around the room, taking dollars from patrons in the same way that would be done in a strip bar. While the clothes do stay on, there are absolute parallels, and it is clear this is an exotic, adult routine.

While the appropriateness of guest speakers has to be discussed by the district leaders, this controversy is really about control. Schools, administrators, and teachers increasingly think they have a kind of autonomous power to save the children from parenting, especially when the parenting is conservative and steeped in a traditional American faith.

The problem with the leftist view of diversity in

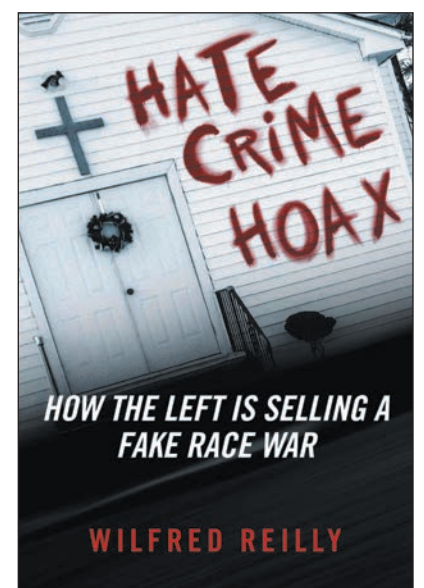
academia is that they desire everyone look different, while demanding that they think the same. Anyone who strays beyond the accepted borders of “diversity education” risks their career, their reputation, and their freedom of speech. When you disagree with the moral and cultural dictates of the education seminars, you risk being branded a “transphobe,” “racist,” or “Nazi.” Equally disgusting for a teacher, you risk being branded as ignorant, no matter your degree, level of experience, or capacity of mind.

This is indeed a culture war, and the battlefield is the arena of education. Homeschooling numbers are up, and it’s not a surprise. Parents increasingly are choosing to take their families back. ★

# Globalists Using Teen to Pitch Radical Climate, Eco Policies

In November, radical Swedish climate activist teenager Greta Thunberg was ferried from Virginia to Madrid, Spain for the UN Climate Change Conference (COP 25) on a million-dollar Outremer 45 catamaran owned by YouTubers Elayna Carausu and Riley Whitelum. Prior to that trip, she was transported last year on an elite racing yacht, the *Malizia II*, by Pierre Casiraghi, the youngest grandson of Princess Grace Kelly of Monaco and a member of the ruling Grimaldi family.

The 16-year-old Thunberg has sidled up to the millionaire set as she has continued to preach (and scream) that the middle class should make enormous sacrifices in the name of fighting climate change.

The Cult of Greta has grown worldwide. In Swedish schools, Greta (now a one-name celebrity the likes of Madonna and Cher) is now a part of the curriculum labeled “religious knowledge.” She is taught as an “alarm clock,” with one student commenting that she’s “practically painted as a saint.” One assignment has students tasked with finding a picture that best illustrates the phrase, “One simply doesn’t mess with Greta.” Sweden has been ground zero for the worship of their favorite hero-child. Last year, the Church of Sweden bestowed the title of “Jesus’s Successor” to Thunberg, while, believe it or not, other churches countrywide ring bells in her honor.

An ominous mural has been constructed in her honor in San Francisco, a face-focused rendering creepily akin to Big Brother in George Orwell’s *1984*. Another mural exists in Edmonton, Alberta, Canada.

This is not the first time the eyes of Americans and the world have turned supportively to a teenage girl.

On Oct. 10, 1990, a sympathetic young Middle Eastern girl named Nayirah sat before the Congressional Human Rights Caucus. She was there to testify about the atrocities the Iraqi military had forced upon her fellow Kuwaitis. She cried as she described her time spent as a volunteer at an al-Addan hospital. She claimed that Iraqi soldiers had invaded her hospital, taken babies from incubators, and had inhumanely left them “on the cold floor to die.”

President George H.W. Bush referred to the incubator story on at least five documented occasions over the next five weeks. He said he was happy to have the atrocities highlighted on CNN, who gladly highlighted them. The media had all but ignored

global reports of Saddam’s atrocities against the Kurds and his opponents throughout the 1980s when he was at war with Iran, then an enemy of the United States after the hostage crisis. Now, it was 1990, and the media suddenly and curiously cared about his atrocities in Kuwait.

Supporters of U.S. intervention began commonly using the phrase “baby killer” to describe Saddam. And, after all, what compassionate American wouldn’t want to do all he or she could do to stop a “baby killer”? The association of demonized figures to the potential harming of children is a successful strategy often used by those wanting to move the emotional pendulum of American sympathy toward a cause—gun control, tracking devices, vaccinations, pharmaceuticals, wars that will kill children, and yes, global warming (“Do it for the children!”).

Americans did just what their emotional strings were tugged to do—supported the effort to thwart the “baby killer,” who was also now the media-friendly “Butcher of Baghdad.” On Jan. 16, 1991, the air offensive of Operation Desert Storm began, and there was war in the Persian Gulf. The American effort was propped up by a fervent populace fully supportive of its president. Yellow ribbons were wrapped around trees

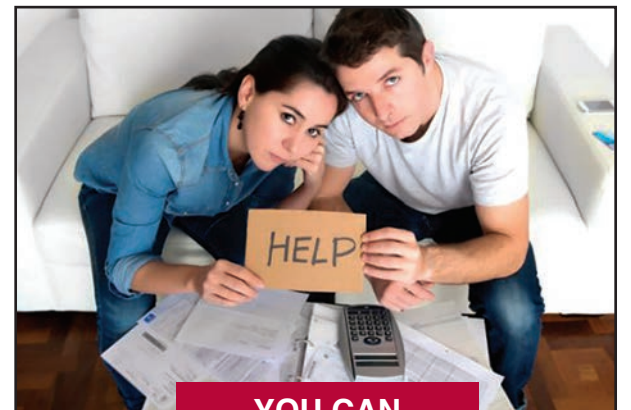
in Middle America and flag poles adorned every white-picketed lawn from sea to shining sea.

Nayirah’s story had been the turning point of public opinion toward the defense of Kuwait. It was dramatic. It was moving. It was powerful. But it was also fiction.

Nayirah, as it turned out, was the daughter of Saud Nasir al-Sabah, the Kuwaiti ambassador to the United States, the same royal and ruling family of Kuwait, the al-Sabah family, that had paid for American public relations firm Hill & Knowlton’s multimillion-dollar services. Hill & Knowlton had one goal: turn American opinion toward supporting the “liberation” of Kuwait. Hill & Knowlton had used Nayirah to tell a fictional story that would produce a desired result. And it did.

Important in the current political superstorm, it was one of multiple situations where the bidding of the global elite, with billions of dollars on the line, was done by a teenage girl whose heart and mind seemed to be in all the right places. Americans loved her heart, her intelligence, and her passion to make right what had been a great wrong. They loved the issue for which she stood and testified to a political body with global ramifications and influence. It just wasn’t real, it wasn’t genuine, the results favored only the billion-dollar elite, and the teenager was used to further means that destroyed liberty and negatively impacted the lives of the middle and lower classes. ★

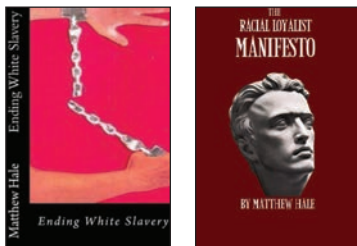

# Not Much Diversity in Democrat Field

• Party talks a good game, but likely presidential candidate will have a pale face

The “Our diversity is our strength!” Party is starting to look rather monochromatic in its upper echelons these days. The four leading candidates for its presidential nomination—Joe Biden, Elizabeth Warren, Bernie Sanders, and Pete Buttigieg—are all white. The six candidates who have qualified for the Dec. 19 debate—the front four, plus Amy Klobuchar and Tom Steyer—are all white. Speaker Nancy Pelosi and House Democratic Majority Leader Steny Hoyer are both white, as are Senate Minority Leader Chuck Schumer and Whip Dick Durbin.

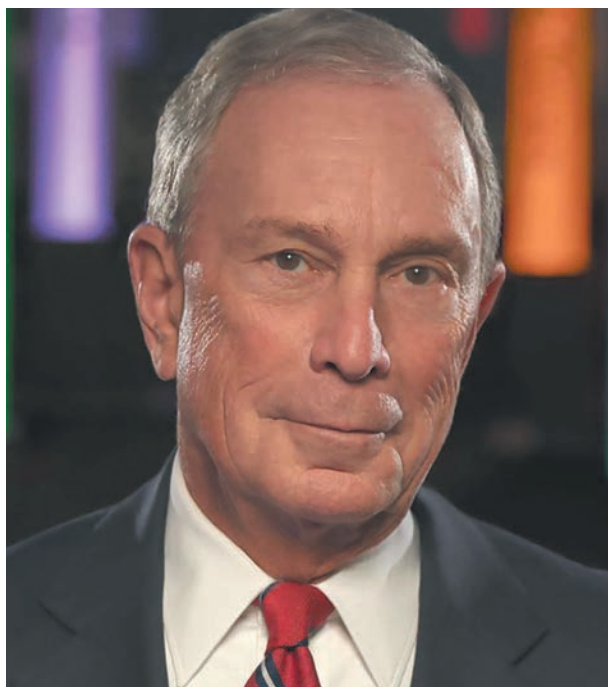
The chairs of the House Intelligence and Judiciary Committees managing impeachment, Adam Schiff and Jerry Nadler, are both white. And, as Rep. Al Green railed Wednesday, all three experts Nadler invited to make the Democrats’ case for impeachment were white law professors. How come?

Absent affirmative action by the Democratic National Committee (DNC), neither Cory Booker, the leading black candidate for the nomination, nor Julian Castro, the leading Hispanic, will be on the stage Dec. 19.

But though there is zero racial diversity among the top six Democrats in the presidential field, there is gender, ethnic, and ideological diversity.

Warren would be the first woman president; Sanders, the first Jewish nominee; and Buttigieg would be the first gay nominee.

Yet the lack of racial diversity across the party

hierarchy is going to put immense pressure on Biden, should he win the nomination. If he hopes to reunite the Obama coalition, a woman and/or person of color as his running mate would seem an absolute imperative.

And before Biden gets there, he has other problems. His “No Malarkey” bus tour across Iowa is all about his fear that, if he loses Iowa on Feb. 3 and New Hampshire on Feb. 11, he may not survive to reach his South Carolina firewall on Feb. 25.

Though he leads in the national polls, Iowa and New Hampshire polls have Biden running as low as fourth. Never has a candidate contested and lost both those states and then gone on to win the nomination. Nor are these Joe’s only problems.

Call them what you will—gaffes, mental lapses—his repeated verbal miscues, some of which have caused debate rivals to laugh out loud at Joe, are a cause of alarm among Democrats who fear a Biden-Trump TV debate could produce a debacle for their man. Nor are the other front-runners without problems.

African-Americans are a bedrock constituency of the Democratic Party. In recent presidential elections, they have voted 90% for the party’s nominee, and even higher for Barack Obama. How is Mayor Pete doing with this constituency? While running first in some polls in Iowa, his share of the African-American vote in South Carolina, in a recent poll, was zero. Buttigieg had no black support in a state where African-Americans constitute more than 60% of the Democratic vote.

Sanders, an unapologetic socialist who went to the Soviet Union, Reagan’s “Evil Empire,” for his honeymoon, is holding on to half of the loyal base from his impressive 2016 race against Hillary Clin-

ton. The other half of Bernie’s base, however, has been captured by Warren. In October, she took the lead in national polls, only to lose that lead when she could not explain how, without major new taxes on the middle class, she could abolish private health insurance and put the entire country on the Medicare rolls. And, like Bernie, she is weak with black Democrats, who will decide South Carolina one week before Super Tuesday, when 40% of all the Democratic delegates will be chosen.

How did Democrats arrive at this pass?

As the 2019-2020 campaign began, the party divided into two camps. There is first the moderate-centrist-pragmatic wing, whose goal is the removal of Trump, and who will go with the Democrat who is the most certain to deliver that. Biden, who spent four decades in the Senate and as vice president, who was liked by many and offended few, who was first in the polls, was their natural choice.

Then there is the ideological left of the party that wants not only to win but also to remake America. It was to this huge slice of the party that Warren and Bernie have made their radical appeals. The promise of victory offered by Biden and the ideological agenda offered by Sanders and Warren trumped the ethnic appeal of Booker, Castro, and Kamala Harris.

Now, with the arrival of moneybags Mike Bloomberg and his tens of millions of dollars in ads, almost certain to reach hundreds of millions before Super Tuesday, there is the possibility that four or five candidates will survive to the convention, with no one having a majority of delegates. And the horse-trading will begin.

My view: Super Tuesday will cut the field to two or three. And the nominee will be one of the six pale-faces on the stage Dec. 19. ★

• Host of U.S. companies take advantage of tax breaks to replace Americans

Udo Ulfkotte's amazing book, *Gekaufte Journalisten (Bought Journalism)* was published by Kopp Verlag in 2014. The book was a sensation and sold 1.5 million copies in Germany, but no major U.S. publisher would bring out an English translation. Finally, last month a small publisher, Progressive Press, published an English language edition titled *Presstitutes: Embedded in the Pay of the CIA*.

Ulfkotte's book destroys the illusion/delusion that there is anywhere in the Western world an independent press. Ulfkotte describes in detail the cognitive appropriation of journalists by elites. Journalists serve as propagandists and public relations agents for intelligence agencies, businesses, lobbying organizations, politicians, and U.S. foreign policy. The function of journalism is to deliver to the people the explanations that serve the interests of elites and Washington's foreign policy. This message was so effectively delivered to the German people that readership of the main German newspapers collapsed.

Ulfkotte describes how journalists are recruited when they are still students and find themselves indebted to and dependent on serving other interests than the truth. All from the lowest reporter to the highest editor to the own-

ers of the news organization are caught up in enabling the elites to control the explanations. Incestuous relationships between journalists, intelligence agencies, businesses, politicians, and U.S. foreign policy aims are so pervasive that no one thinks anything of it. The only ones who get in trouble are those who don't go along.

Ulfkotte's book is written for Germans. Americans might find the German detail boring, but in the detail is the picture of how the subtle process of turning journalists into functionaries of intelligence services, politicians, and businesses is accomplished. The book starts off slowly. Ulfkotte knows that he would face readers' disbelief if he jumped right into the horror story, so he begins with the perks and rewards of accommodating "sources" and censoring real news, such as the use of German poison gas by Iraq against Iran.

One interesting story is how the German press handled the wave of migrants from Bulgaria and Romania into Germany. The German government favored this further watering down of ethnic Germans by enlisting the press to describe the migrants as the hardworking, never-unemployed "Prussians of the Balkans." False claims were

made, such as the unemployment rate of Bulgarian and Romanian migrants was less than that of Germans. The false story was repeated endlessly without verification. Once the migrants were incorporated into Germany, the facts came out: The number of immigrants on welfare continues "to rise significantly" and has "increased 60% over the previous year." The experts, who had warned that this would be the case, were demonized as "nationalists" and "Nazis." Thus, the media served to keep the facts out and fake news in.

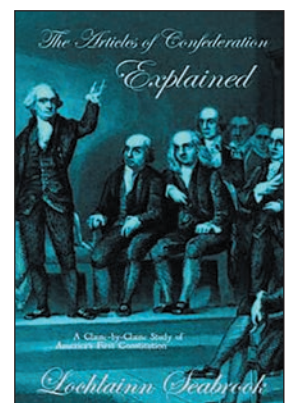

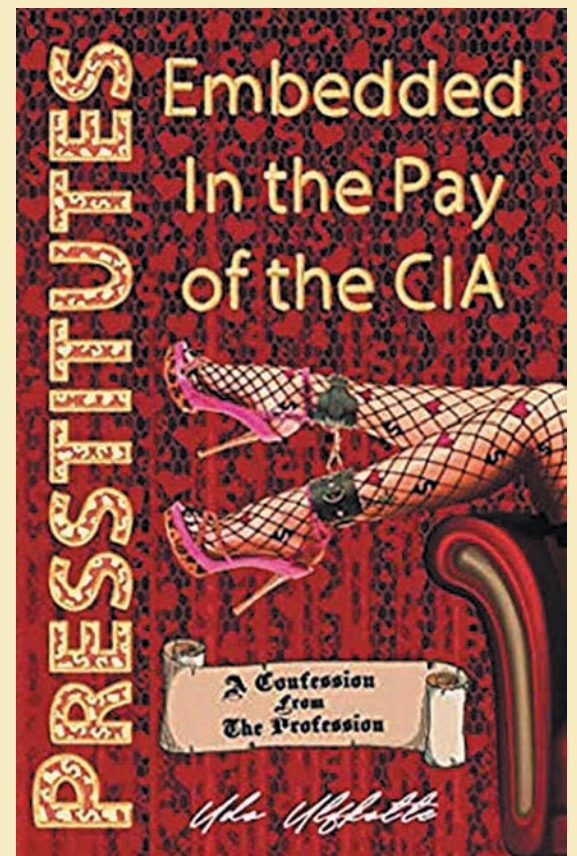

# 'It's Okay To Be White' Is Hate? Is Everybody Okay With That?

In 1976, at age 17, I moved into Witte Hall, a high-rise dormitory at the University of Wisconsin-Madison. I lived on the ninth floor, on the male wing. There were two genders in those days.

To the best of my recollection, there were no Asians, Hispanics, or African-Americans on my wing. The only two ethnicities I recall were "rural white boy" and "New York Jew."

Most of the rural white boys were from Wisconsin. Redneck Dave, as he liked to be called, grew up on a pig farm outside Prairie Du Chien. Tim was from up north somewhere. John was a hillbilly—a smart, savvy, longhaired hillbilly—from West Virginia. Harold was from some hick town in New Hampshire. I was the least rural of the white guys, being from the then-small-town, now semi-suburb, of Pewaukee, Wisc.

My assigned roommate was Jon, one of the New York Jews. But he apparently didn't feel comfortable rooming with a non-Jew, immediately putting in a request to switch rooms and move in with Eric, a fellow tribesman. I was disappointed—Jon knew a lot about music, and generally seemed more interesting than Harold, his replacement. As the year progressed, I discovered that the New York Jews had quite a superiority complex, looking down their proverbial noses at us white-boy hicks. Though slightly annoying, such arrogance was forgivable, I concluded, since they did generally seem hipper and funnier than, say, my replacement roommate Harold.

Today, if I wandered into Witte Hall, I would

still be ethnically unwelcome. According to news reports, students there have been told "don't bring too many white people around." The resulting commotion has featured outbursts of anti-white rhetoric that would be considered unacceptable if any other group were so targeted.

What would happen if I protested in front of Witte Hall holding a sign saying "It's OK to be white"? I'm not sure I want to find out. Today, on at least one American campus, "It's OK to Be White" is considered hate speech reportable to the FBI. Last month the *Hartford Courant* ran a story headlined "Police, FBI investigating 'hate-filled flyers' found on Western Connecticut State University campus." The "hate-filled flyers" actually consisted of two seemingly innocuous messages: "It's OK to be white" and "Islam is right about women." Similar prank flyers have also triggered politically correct administrations at other universities to reveal their unconscious biases.

Today, white people are considered "not okay" according to the dominant ideology in many American universities. Working-class whites have experienced an unprecedented collapse in life expectancy across much of the American heartland. And demographic projections predict whites will lose their majority status in the U.S. by 2050. No wonder there is a growing white nationalist backlash.

The commissars of political correctness tell us European-Americans still enjoy "white privilege." That may be true in certain instances. We are unlikely to be pulled over and possibly shot dead for "driving while white." Such things do happen to black people more often. I did however manage to become a victim of police brutality once despite my pale skin, thanks to a pair of cops who might



be described as "equal opportunity thugs."

But there are plenty of other instances in which being white is not an advantage. Take college admissions. Non-Jewish whites are the most discriminated-against group in admission to Ivy League schools, while Jews are the most over-represented. At any given level of ability, you are nine times more likely to gain admission if you are Jewish than if you are a white gentile. For details, read Ron Unz's article "The Myth of American Meritocracy." And if you are a working-class white person, you are a member of the group that is suffering the most from America's deindustrialization, according to all available statistics.

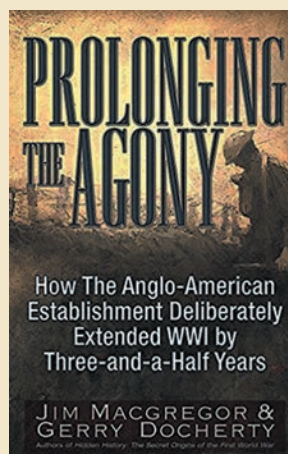
White privilege sure ain't what it used to be, if it ever was. ★

# EO Bans Criticism of Israel on Campus

According to the White House, President Donald Trump will sign an executive order cracking down on “anti-Semitism” on college campuses, *The New York Times* reported earlier this week. The presidential decree will recognize Judaism as not only a religious identity but also as a national identity, allowing the federal government and Department of Education to punish colleges and universities that fail to take action against anti-Israel rhetoric and bias, which has largely been equated with anti-Semitism in recent years. The order will treat Jewish people as a protected minority and will “prompt a federal law penalizing colleges and universities deemed to be shirking their responsibility to foster an open climate for minority students,” according to the *Times*.

The *Jewish Telegraph Agency* reported that the signing of the executive order would take place during a Hanukkah party hosted by the White House.

Congress has introduced similar bipartisan legislation that seeks to combat perceived anti-Semitism, anti-Israel biases, and the Boycott, Divestment and Sanctions (B.D.S.) movement on college campuses. Various local and state governments, including the state of Florida, have also introduced and passed such legislation, which essentially targets individuals and companies that criticize Israel and Zionism more generally or refuse to do business with Israeli companies.

The executive order adopts the working definition of anti-Semitism endorsed by the State Department, which was formulated by the International Holocaust Remembrance Alliance (IHRA) in May 2016. Part of the working definition includes “denying the Jewish people their right to

self-determination, e.g. by claiming that the existence of a state of Israel is a racist endeavor” as a manifestation of anti-Semitism. Critics have long argued that such broad interpretations of anti-Semitism amount to any criticism of Israel and its treatment of the Muslim and Christian populations in the region.

“Israeli apartheid is a very hard product to sell in America, especially in progressive spaces,” Yousef Munayyer, the executive director of the U.S. Campaign for Palestinian Rights, told the *Times* in response to the announcement of the executive order. “Realizing this, many Israeli apartheid apologists, Trump included, are looking to silence a debate they know they can’t win.”

Roughly one week prior to news breaking of

Trump’s executive order, France’s lower house of Parliament voted to adopt the IHRA’s working definition of anti-Semitism and to equate “hatred” of Israel as a modern manifestation of anti-Semitism. The resolution has long been lobbied for by the pro-Israel community in both France and the U.S., as well as by Israeli officials in Jerusalem, demonstrating the incredible reach and influence of the pro-Israel lobby worldwide. Other European countries have adopted similar resolutions in recent years.

According to *The Times of Israel*, the French National Assembly’s resolution “believes that the operational definition used by the International Holocaust Remembrance Alliance allows for the most precise designation of what contemporary anti-Semitism is.” The National Assembly considers the IHRA definition “an effective instrument for combating anti-Semitism in its modern and renewed form, in that it encompasses manifestations of hatred toward the state of Israel justified solely by the perception of the latter as a Jewish collective.”

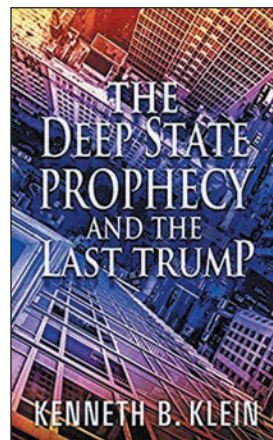
The organized Jewish community praised Trump’s executive order as well as the recently adopted resolution in France as important steps in combating the alleged rise in “anti-Semitism” around the world.

While Trump has struggled to accomplish many of the America first policies he campaigned on, his administration has tellingly implemented a number of initiatives important to the pro-Israel lobby, including recognizing Jerusalem as the capital of Israel, relocating the U.S. embassy there and, most recently, recognizing Israeli settlements on Palestinian territory. ★

# What About Donald Trump's Real Abuse of Power?

**I**magine if President Donald Trump spent his phone call with the Ukrainian president threatening to withhold military aid unless the Ukrainian government agreed to use the money to purchase weapons from a U.S. manufacturer. Does anyone seriously think that foreign service professionals and Deep State operatives would be so shocked and offended by Trump's request that they would launch efforts to impeach him? Would Congress view this as "high crimes and misdemeanors" or applaud Trump for carrying out one of modern presidents' supposedly most important jobs—acting as salesmen for the American military-industrial complex?

This hypothetical shows that impeachment is not about President Trump's abuse of power. Instead, it is an attempt to make sure President Trump, and all future presidents, confine their abuses of power to items that advance the agenda of the political establishment.

Trump's most consequential abuses of power have been met with the full approval of the majority in Congress, the mainstream media, and the Deep State. For example, when Trump launched

military action in Syria without obtaining a congressional declaration of war there were no calls for his impeachment. Instead, most members of Congress were perfectly happy to let stand unchallenged Trump's claim that the 2001 authorization for use of military force—a limited grant of authority to act against those responsible for the Sept. 11, 2001 attacks—gave him the authority to launch military action against a government that had nothing to do with the Sept. 11 attacks. The only times Congress rebukes Trump's foreign policy is when he speaks favorably about pursuing peaceful relations with Russia or ending U.S. involvement in no-win military conflicts.

This hypocrisy extends beyond foreign policy. Many Democrats who claim that Trump is both a fascist and mentally unhinged are eager to ensure Trump can continue to conduct warrantless surveillance on every American by reauthorizing Section 215 of the Patriot Act.

Trump-opposing progressives in Congress are also eager to give Trump new authority to violate the Second Amendment. Even those progressives who say they believe Trump is a deranged fascist did not object when he endorsed "red flag" laws that give the feds power to, as Trump put it, "take the guns first, go through due process second."

Perhaps the most sickening example of

Trump's congressional opponents' hypocrisy is how many of those fretting about the safety of the Ukrainegate "whistleblower" are silent about, or supportive of, the Trump administration's complicity in the inhumane treatment of WikiLeaks founder Julian Assange. They are also silent about the U.S. government throwing Chelsea Manning back into jail because Manning refuses to help the U.S. prosecution of Assange.

All modern presidents have exceeded constitutional limitations on their power and thus could have, and maybe should have, been impeached. The reason they were not impeached is that a majority of Congress members support allowing presidents to wage war abroad and destroy liberty at home without being "hamstrung" by Congress. The only real dispute is which party will wield power.

Restoring constitutional limits on government power and thus protecting liberty depend on spreading ideas and building a movement. Our lost freedom will only be restored when presidents and members of Congress fear being "impeached" at the ballot box for committing high crimes and misdemeanors against peace, prosperity, and liberty. ★
