GUN RALLY NEGATES LEFTIST PROPAGANDA

• Tens of thousands rally in Richmond for gun rights —and not a single person was gunned down by a “racist”

On Monday, Jan. 20, tens of thousands of peaceful pro-Second Amendment activists descended on the state capitol in Richmond, Va. in a powerful statement directed at Democrat Gov. Ralph “Nutjob” Northam, who had months earlier threatened the law-abiding citizens of Virginia with a door-to-door gun confiscation using National Guard troops. And here’s the shocker (at least to leftists anyway): Not a single shot was fired and not one person was gunned down by a crazed white supremacist.

This must have infuriated the new Democratic government of the Old Dominion and Virginia’s Viceroy of Victimhood, as Northam had declared a state of emergency after “credible threats” emerged that one “neo-Nazi” group, “The Base,” planned to attack and kill any antifa members it came across. All of this was nothing but pathetic propaganda. Turns out the group had already been infiltrated by the FBI weeks earlier—and the minute we hear that, we smell a setup. In sharp contrast to the hooliganism of antifa—in which shop windows are routinely smashed, businesses vandalized, cars set ablaze, and innocent civil-

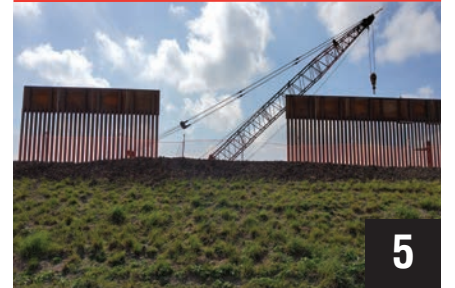

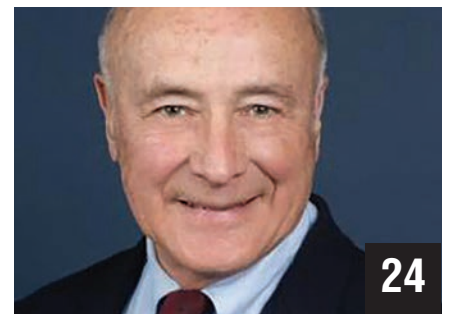

Peaceful Rally in Richmond Exposes Leftist Lies

When it comes to the big media and many on the left, we'll never win the propaganda battle. We're talking about the Virginia Citizens Defense League's annual Lobby Day rally in Richmond, Va., which took place on Jan. 20, Martin Luther King Day. Whatever happened, leftist commentators and pundits were going to attack and smear the participants. And that is exactly what went down. In the leadup to the event, the big media and the Democrat-led government in Virginia called it a "white supremacist" event despite the fact that Americans of all races and creeds showed up to attend. They wanted the gun rights rally to fail. They wanted violence. They wanted to be able to say, "See, we told you so. These types of Americans are really the violent deplorables we say they are, and we have to take away their rights."

But guess what? Thousands of Americans, a majority of whom were heavily armed, gathered together peacefully for the sole purpose of expressing their First Amendment right "peaceably to assemble, and to petition the government for a redress of grievances" in support of the Second Amendment—and not a soul was hurt. In fact, by some accounts, the protesters left the demonstration site cleaner than it was before they arrived, going out of their way to pick up trash that littered the streets.

At this point in the debate over the Second Amendment, you'd have to be willfully ignorant of not just firearms but also of U.S. laws to claim that the country is the Wild, Wild West when it comes to guns. For those who close their eyes, cover their ears, and repeat nonsense out loud just so they don't have to hear facts, however, we'll take a moment to repeat ourselves and give you the facts.

For anyone who claims that the U.S. needs even more restrictive gun laws, the United States already has thousands of laws on the books. At one time, in fact, some claimed there were as many as 20,000 different laws regulating guns and gun ownership in the U.S., but that has changed over the years as laws have been struck down as unconstitutional and others

have been streamlined.

When it comes to mass shootings, illegal handguns are used in the majority of cases (56%) not so-called assault weapons. Rifles only account for about 13% of shootings that involved four or more victims.

Mass shootings account for less than one-tenth of 1% of total homicides. Most murders are related to crime and domestic violence.

According to the Heritage Foundation, "Few mass public shooters have used high-capacity magazines, and there is no evidence that the lethality of such attacks would have been affected by delays of two to four seconds to switch magazines. In fact, some of the largest mass shootings in U.S. history were carried out with low-capacity weapons [such as shotguns and pistols]."

Most people who want to ban firearms like AR-15s and other semi-automatic rifles don't understand the basics of how firearms even work.

Between 2000 and 2014—the latest figures available—mass public shootings accounted for only one-tenth of 1% of the total firearm-related mortality. And, despite an uptick in gun suicides, 99.95% of deaths in the U.S. do not involve a gun.

The U.S. population is just under 5% of the world's population, but only 1.43% of mass public shootings happened in America. Spain, Britain, Germany, and even China have all suffered from terrible mass killings in the past decade—and these countries have the most restrictive gun

laws in the world.

When it comes to school shootings, a child has a far better chance of being killed by lightning in a given year (a one in 700,000 chance) versus being the victim of a random school shooter (anywhere from a one in 1 million to a one in 2 million chance). To put that in perspective, Americans have a one in 100 chance of dying in a car accident and a one in 10 chance of dying due to a medical mistake.

We could go on, but the facts are out there for anyone who wants to look at this issue objectively.

Americans have a lot to be worried about, but, for the majority of people, gun violence is just not enough of a threat to require more drastic laws.

The bottom line is, violence in the U.S. is at historic lows, and the overwhelming majority of Americans will most likely die of natural causes in their old age—unless you are involved in violent criminal activity, of course. Throughout all of history, men and women in the Western world have never been safer than they are today. More importantly, as it has been shown in Europe, no laws will ever be able to prevent criminals or deranged people intent on murdering people from obtaining a gun illegally and using it. ★

News You May Have Missed

Tired of Winning Yet?

On Jan. 16, the Senate overwhelmingly passed, by a vote of 89-10, a bill ratifying President Donald Trump's U.S.-Mexico-Canada Agreement (USMCA). Trump signed the bill that same day, marking another milestone for the president just one day after he cemented the first round of trade deals with China.

Booming Economy

A little-noted success achieved under President Donald Trump is that the number of Americans on food stamps has been consistently declining over the past three years. According to the latest figures issued by the Department of Agriculture (USDA), which manages the food stamps program, in 2016, just prior to Trump taking office, enrollment in the program was 44.22 million people. That went down to 42.23 million in 2017, 39.81 million in 2018, and 34.47 million in 2019. That most recent year saw a drop of over 5 million in the single year—a 12.5% annual decline. While some liberals would argue that this is because the Trump administration is kicking people off of welfare, there is no evidence to support that. The USDA reports that the decline is more the result of a booming economy with more available jobs than anything else.

Common Sense Laws

A judge has sided with the administration of Donald Trump when it comes to allowing Border Patrol officials to make decisions about separating children from adults at the U.S. border. U.S. District Judge Dana Sabraw's ruling rejected the American Civil Liberties Union's (ACLU) claims that the administration was returning to the previously condemned policies of widespread child separation by using minor criminal history as criteria to separate families. The Associated Press reported that, in his ruling, the judge was uncomfortable questioning the administration's choices to separate children if the parents were designated as "unfit or dangerous or based on other factors like criminal history, communicable diseases, and doubts about parentage."

Corrupt Bidens

In his new book *Profiles in Corruption: Abuse of Power by America's Progressive Elite*, author Peter Schweizer writes that five members of Joe Biden's family "cashed in while he was vice president." Schweizer contends that Biden's son, Hunter, as well as his son-in-law Howard, his brothers James and Frank, and his

sister Valerie also cashed in on the vice presidency. Political elites have used their positions of power to enrich themselves, their families, and their friends for a long time, writes Schweizer, but Biden "emerges as the king of the sweetheart deal, with no less than five family members benefiting from his largesse, favorable access, and powerful position for commercial gain." Obama's Solar Legacy Fizzles

Another massive solar startup has gone under, this time leaving U.S. taxpayers on the hook for nearly \$1 billion in loan guarantees. Reports Bloomberg News: "In 2011 the \$1 billion [Crescent Dunes] project was to be the biggest solar plant of its kind, and it looked like the future of renewable power. . . . Steven Chu, the energy

secretary [under President Barack Obama], offered the company [\$737 million in] government loan guarantees. . . . By the time the plant opened in 2015, the increased efficiency of cheap solar panels had already surpassed its technology, and today it's obsolete. . . . The plant's technology was designed to generate enough power night and day to supply a city the size of nearby Sparks, Nev. (population 100,000), but it never came close. Its power cost Nevada about \$135 per megawatt hour, compared with less than \$30 per megawatt hour today at a new Nevada photovoltaic solar farm.

Breakaway County

Responding to the changing demographics of the state of Virginia, which turned it Democrat-majority, the West Virginia state Senate passed a resolution introduced by state Sen. Charles S. Trump IV (R-Morgan), which invites neighboring Frederick County, Va., to become part of West Virginia. According to ABC News, Trump argued that there is a great deal of history between the two regions, with a number of West

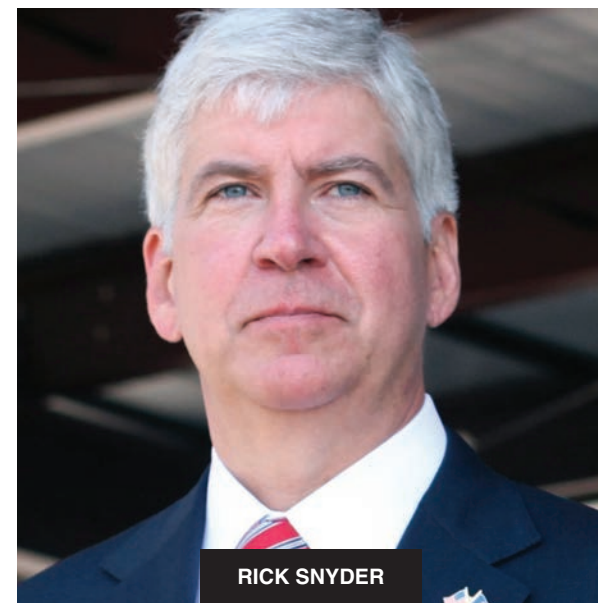
Virginia counties having originally been part of Virginia until they broke off in the mid-19th century. "In addition to the historical connections between Frederick County and the seven counties of our Eastern Panhandle, there are strong bonds and ties of every kind among the citizens—family, business, education, culture, and commerce. We share common values," said Trump.

Gender Laws

South Dakota state Representative Fred Deutsch (R-Florence) introduced a bill on Jan. 14 to prosecute doctors and other medical professionals who push children with gender dysphoria into transitioning to a different sex from the one they were born with. According to reports, the "Vulnerable Child Protection Act" is an attempt to deal with activists who have been pushing medical professionals to encourage surgeries and hormones for children—practices that are almost always permanent for kids. In 2016, Deutsch sponsored a bill that limited bathrooms and locker rooms in schools to the biological sex children were born with, but that was vetoed by then-Gov. Dennis Daugaard.

Wasted Money

Four years ago, then-Michigan Gov. Rick Snyder declared an emergency in Flint, Mich., which allowed the state to tap into \$390 million in taxpayer money to solve the toxic water problem there. According to a new budget tally, almost half of that money, which was supposed to be used to fix old, broken pipes, among other things, was spent on activities not really related to lead in water. About \$130 million was used for "economic" and "social" development, such as bringing back a youth baseball league and providing free daycare for kids under the age of three.

Finally, Even Leftists Admit That CNN Is a Poisonous Organization

Supporters of Democratic presidential candidate Sen. Bernie Sanders have expressed disgust at the media coverage by Cable News Network (CNN) and other corporate-controlled outlets. Ironically, the same people who either fail to recognize the biased reporting on Donald Trump, or enthusiastically approve of it, are outraged now that Sanders is the victim.

Earlier this month, *Rolling Stone's* Matt Taibbi tweeted, "This is an unusually vile performance by CNN."

Elie Mystal of *The Nation* declared, "I hate these biased questions from the moderators. 'How would you keep your plan from bankrupting the country?' Just ask the Koch brothers to moderate next time!"

The *New Republic's* Libby Watson complained, "CNN is truly a terrible influence on this country."

The anti-Sanders coverage brought back memories of former CNN contributor Donna Brazile giving Hillary Clinton advance copies of debate questions during the 2016 primaries. Democratic National Committee emails memorably documented the party's effort to steal the nomination away from Sanders, in order to nominate Deep State queen Hillary Clinton. Despite overt voting fraud during the Democratic Party primaries, especially in delegate-rich California, Sanders refused to lodge any protests, and ultimately supported Clinton. Sanders even bought into the ridiculous "Russiagate" fantasy, whereby email evidence of DNC fraud benefitting Clinton was magically converted into "Russian" subversion of the political process, in order to deny Clinton the presidency.

Recently, a seeming feud between "progressive" Sen. Elizabeth Warren and "socialist" Sen. Sanders has been making headlines. After the

last Democratic Party presidential debate, Sanders attempted to shake Warren's hand, but she refused. A brief exchange could be heard on a hot microphone, as Warren whinged, "I think you called me a liar on national TV." Sanders replied by claiming it was Warren who called him a liar. The friction between the two was ignited when Warren claimed, a few days before the debate, that Sanders had told her during a 2018 private meeting that a woman could not win the presidency.

It's hard not to relish the infighting between rabid proponents of identity politics. Warren takes a back seat to no one in this area. She has claimed to be part Native American in the past, which was seemingly disproved by DNA analysis. She has recently carried political correctness to heights that simply cannot be satirized, when she bemoaned the alleged difficulties faced by "transgender women of color." She even vowed to read the names of victims of violence from this miniscule fragment of the population aloud in the White House Rose Garden every year.

Warren, like most other Democratic Party presidential candidates, genuflected before former crack dealer turned FBI informant Al Sharpton last year, and enthusiastically endorsed reparations for black Americans. The logistics behind such a reparations program (factoring in multi-racial persons, those who immigrated here long after slavery ended, how some would be taxed and not others, who would be eligible etc.) is never broached by anyone in the political world, or any "journalist" in our state-controlled media.

A recent undercover video release from James O'Keefe's Project Veritas revealed a Sanders campaign organizer angrily ranting about cities burning if he didn't get the party's presidential nomination. Threat of violence is another ugly aspect of authoritarian social justice warriors, as is often a shockingly quick resort to physical assault against those they disagree with, as so many online videos from demonstrations and protests have revealed. Today's left is faithfully devoted to the politics of emotion and has left all reason behind.

When varying, politically correct interest groups collide, such as in recent years when black athletes expressed openly anti-gay sentiments, the Deep State struggles to respond. Open-Borders Think Tank Finagling in Texas

McALLEN, Texas—In the Rio Grande Valley (RGV) of Texas—where it's estimated that more people and drugs are trafficked from Mexico into the U.S. than in any other area along the 1,900-mile southern border—the populous border city of McAllen has been collaborating with a key Washington, D.C. think tank, the Woodrow Wilson Center, in the pursuit of perpetually open borders.

This collaboration includes several visits by a McAllen municipal delegation to the Wilson Center's programs in Washington—which helps explain why the RGV can't seem to shake the influence of open-borders advocates, amid a constant stream of area congressional representatives who espouse liberal-internationalist policies.

McAllen Mayor Jim Darling revealed these municipal trips Jan. 16 when he introduced the Wilson Center's Duncan Wood as the keynote speaker at a business luncheon at the McAllen Performing Arts Center.

"We go up to Washington every year, take all our people and listen to what a great job the Wilson Center does," Darling told the audience.

Accordingly, Wood, director of the Wilson Center's Mexico Institute, spoke in McAllen under

the "platinum" sponsorship of the City of McAllen itself. The three other platinum sponsors included *The Monitor*, which is the largest RGV daily newspaper. The newspaper's tame report on Wood's remarks neglected to note that the newspaper is playing an active role by bringing in a speaker from a pro-open-borders think tank to south Texas, as opposed to staying out of the sponsorship loop and reporting objectively.

The other two platinum sponsors were IBC Bank and the aforementioned performing arts center. The other municipalities backing Wood's globalist message as "gold sponsors" were the

Cities of Donna and Pharr—near where new border-fence sections are being built by the federal government—as well as Texas Regional Bank, Rio Bank, Frost Bank, Plains Capital Bank, the Pharr International Bridge (the governing entity of an actual port of entry to and from Mexico), the Economic Development Corp. of McAllen, and five other entities.

Wood's speech centered on the rise of the new presumably "populist" Mexican president, Lopez Obrador, mainly to explore whether Obrador will revive the Mexican economy in a way that would improve border commerce, avoid further impoverishing the Mexican people, and honor the decisions of "investors" who supposedly are waiting in the wings to boost Mexico.

But a larger issue that concerns McAllen area religious and business leaders, some of whom spoke to this AFP writer on condition of anonymity, is the strong tendency of RGV politicians and the business community to value their place in the geo-political power structure (both within and beyond the confines of south Texas) more than commonsense border-security measures.

All things considered, the new fencing going up in the Donna area is needed, since less than 50 miles of fence stands in the 270-plus mile stretch of the border in the Border Patrol's RGV sector. And Texas, overall, has far less border fencing than New Mexico, Arizona, and California. ★

Making Sense of Impeachment Charges

Prior to the impeachment of President Donald Trump—not by Congress as presstitutes report but by self-interested House Democrats—during the entirety of U.S. history there have been only two real attempts to impeach a president, Andrew Johnson in 1868 and 130 years later Bill Clinton in 1998.

Clinton was impeached by House Republicans when he clearly lied under oath by denying his sexual affair with Monica Lewinsky, a White House intern. The Senate refused to convict him. Enough senators had enough sense to know that lying about a sexual affair, even under oath, did not rise to a “high crime.” Moreover, senators understood that few men would be inclined to embarrass their wife and daughter, or few women their husband and daughter, by admitting publicly to a sexual affair.

Johnson, a Tennessee Democrat, stood with the Republican Union of Abe Lincoln. Lincoln thus chose Johnson as his vice president in his 1864 reelection campaign. When Lincoln was assassinated, Johnson became president.

Johnson, as president, took to heart Lincoln’s emphasis on restoring comity between the North and the South. Consequently, Johnson opposed the harsh, exploitative, and demeaning policies of the Republican Congress during Reconstruction. He didn’t see how the Union could be restored on the basis of dispossession of Southerners, rape of Southern women, and the infliction of humiliation on a conquered people.

The fanatical Republican Congress, however, was set on punishment and humiliation of the South. By blocking some of the most extreme Reconstruction measures, Johnson aroused the same enmity against himself as the Republicans had toward the South. A series of disputes between the president and the Republican Congress led to a resolution of impeachment drafted by the Congressional Joint Committee on Re-



construction.

The charges against Johnson were contrived, a product of emotion, like the ones against Trump, and Johnson’s conviction failed by one vote in the Senate. After his term ended in 1869, Johnson ran for the Senate and won.

Clinton is the only one of the three to be impeached by the House for cause, but enough senators realized that the cause was not a high crime and refused to convict.

The three presidents who have been impeached are much less guilty of impeachable offenses than many who have not been impeached.

For example, George W. Bush took America to war based on lies—for example, Saddam Hussein’s weapons of mass destruction. These lies are much more serious than Clinton’s denial of a sexual affair. Bush failed to uphold his duties and violated the Constitution by suspending habeas corpus and detaining citizens indefinitely

without evidence and due process of law. Barack Obama intended to invade Syria on the basis of a lie, for example, Assad’s use of chemical weapons, but was prevented by Russia.

Obama, as president, escalated Bush’s attack on constitutionally protected civil liberty by declaring his right to execute U.S. citizens without due process of law.

Franklin D. Roosevelt kept knowledge of the Japanese attack on Pearl Harbor from the U.S. Navy in order to have an infamous event that would allow him to enter the war against Germany. Even Lincoln was guilty of destroying states’ rights set out in the Constitution and launching a war of aggression in order to preserve the empire.

There are more examples. It is paradoxical that real crimes provide less inclination for impeachment than orchestrated fake crimes.

There were 11 contrived articles of impeachment against Johnson. Against Trump there are two. One is that he abused his power as president by asking the president of Ukraine to reopen the investigation of the energy company, on which Vice President Joe Biden had placed his son as a very highly paid director. Biden had forced the previous president of Ukraine to shut down the investigation by firing the prosecutor or otherwise forfeit \$1 billion in U.S. aid.

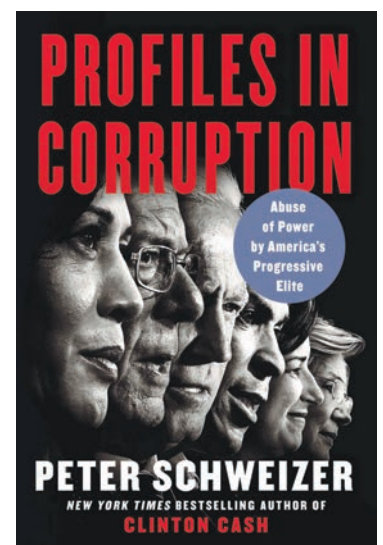
The Democrats have no evidence that Trump offered the Ukrainian president U.S. aid in exchange for political dirt against Biden, and the president of Ukraine said there was no such offer. What would be the point of Trump asking for dirt against Biden when Biden himself boasted before the Council on Foreign Relations that he had forced the Ukrainian president to fire the prosecutor or forfeit \$1 billion. This is common knowledge. Why should Trump have to pay Ukraine for it?

Biden’s clear, open admission that he did what Democrats falsely accuse Trump of doing is total proof of the utter corruption of the Democratic Party.

monplace the charge against Trump would be even if true. The United States government, historically, has always and is forever telling foreign governments to do this or that or you won't get any money. This is the commonplace behavior of the United States in its foreign policy, which is not based on normal diplomacy but on bribes, sanctions, threats, and, if the country does not comply, bombings and invasions.

Trump did not tell Ukraine that he was going to sanction, bomb, or invade if Ukraine did not reopen an investigation that was closed entirely on the basis of Biden's threat to withhold U.S. aid money. If anyone should be facing a charge, it is Biden.

The second charge in Trump's impeachment is "obstruction of Congress." The Constitution gives the president the power to obstruct Congress. Every time a president vetoes a bill, he obstructs Congress. The idea that obstructing Congress is an impeachable offense is insane nonsense. It works only because Americans are ignorant. They do not know what the Constitution says or anything about the balance of powers the Constitution establishes between executive, legislature, and judiciary.

Similarly, Congress has the power to obstruct a president by refusing to ratify his treaties, by rejecting his budget and spending priorities, and by refusing to confirm his appointees in office.

What is the real basis of the obstruction charge? I will tell you. It means that the House Democrats could not find anything on Trump, so they charge that Trump obstructed them by hiding the evidence and not letting executive branch officials testify who would have ratted him out. That is all the charge means. The charge is that the exercise of executive privilege, which every president has used, is an obstruction of Congress. That is all the charge means. How did such an absurd charge become an impeachable offense?

In the Senate, the fight over "the rules" is a fight over whether Democrats will be able to reproduce in the Senate, in place of what is supposed to be a trial based on the evidence that led to the House's impeachment charge, a continuation of the House circus with more witnesses, more charges, more orchestrated "evidence." In other words, the Democrats intend to use the trial as a continuation of the soap opera hoping to extend it long enough that some of the mud will stick to Trump and defeat his reelection.

We must ask ourselves how American politics has degenerated to such a comical level. How can the U.S. be taken seriously as a world leader when for the entirety of a presidential term one of the two political parties has done nothing but to try to destroy the president of the other political party? Is the U.S. going to have its own genocide?

This question is unrelated to whether or not we approve of Trump or think that he is a good president. An unapproved president is simply not reelected. He does not need to be impeached. Obviously, it is Trump's reelection that Democrats fear, and they are using impeachment to try to prevent Trump's reelection. This is not the function of a political party.

A political party is supposed to represent the interests of its constituents. At one time, the Democrats' constituents were the working class. The Republicans represented business interests. There was countervailing power between the two. Sometimes business interests got the upper hand. Sometimes the working class got the upper hand. But the system worked and served both parties. Who does the system serve today? ★

I was arrested a week later on other charges, tortured and convicted of speech crimes that I did not commit.

Fifteen years after the murders, the CD is long gone, but the FBI has finally solved the crime. The voice on the recording had Ross's unique speech impediment, and the floorplan I received was a copy of a construction blueprint which the FBI found in Ross's home after his suicide. The man who talked to me was telling the truth. The FBI wants to indict six men for conspiracy in the Lefkow murder but, since I am the only one who knows about the crimes who was not involved in them, they cannot do it without my testimony. Since 2016, I have been subjected to an unending stream of federal informants urging me to cooperate. Earlier this year, in fact, they even had an informant tell me that they did not want me to testify to the truth—a truth which would make them look like they bungled the murder investigation—but that they wanted to "give me a script," "make it plausible" and "sell" it to a jury.

I've had enough experience with the DOJ and the FBI to know that the American justice system is completely and hopelessly corrupt. Perjury is the norm, and the torture of prisoners who refuse to plea bargain is routine. I've told the DOJ that as long as I stand convicted of crimes that I did not commit, I cannot and will not provide them with any assistance. And, it turns out that the killers, four of which are still free, have spent the past 15 years on websites like 8chan directing other high profile murders. Well, they should have thought of that before they framed me. It's not that I don't have compassion for the Lefkow family, it's just that I have as much compassion as the federal government has for my family, which they destroyed.

So, instead of assisting the FBI, I am seeking relief under the Supreme Court's *Elonis* and *Davis* decisions and hoping that the courts will declare me actually innocent. If you can respect my stand, please consider supporting my legal defense fund.

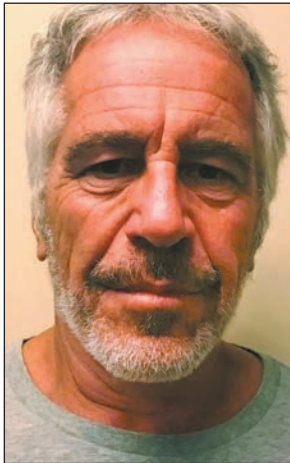
Claim: 'Epstein Worked for Israel'

• Pedophile, spy's daughter were blackmailing public figures for Mossad

The saga of pedophile procurer to the rich and famous Jeffrey Epstein continues to enthrall, even if the Department of Justice appears to have no interest in learning the details of what appears to be a major Israeli spy operation. There have been a number of new developments in the past several weeks, confirming that Epstein had been a longtime Israeli intelligence asset targeting prominent Americans while also suggesting that he was murdered in his prison cell in New York rather than a suicide.

Of interest to many following the story with the apparent exception of the FBI, a former Israeli intelligence officer has written a book describing how Epstein and his partner in crime Ghislaine Maxwell were blackmailing prominent politicians on behalf of Israel's foreign intelligence service Mossad. According to Ari Ben-Menashe, the two had been working directly for the Israeli government since the 1980s and their operation, which was funded by Mossad and also by prominent American Jews, was a classic "honey-trap" which used underage girls as bait to attract well-known politicians from around the world, a list that included Prince Andrew and Bill Clinton. The politicians would then be photographed and video recorded when they were in



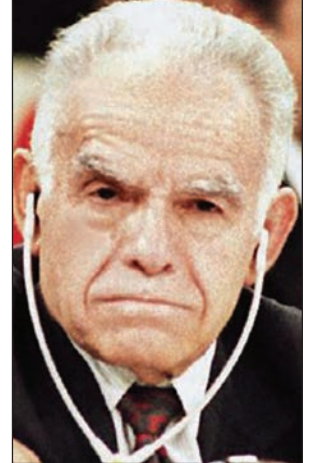

bed with the girls.

Ben-Menashe's soon-to-be-released book *Epstein: Dead Men Tell No Tales* describes how Epstein was introduced to Maxwell originally by her father, Robert, a Czech-born British media tycoon, who was also a long-term Israeli agent. After his death, he was given a state funeral by Israel in which six serving and former heads of Israeli intelligence listened while Prime Minister Yitzhak Shamir eulogized: "He has done more for Israel than can today be said."

Ben-Menashe was Robert Maxwell's agent handler, meaning that he was the government in-

telligence officer who actually met with the high-level spy. Through Maxwell, Epstein also met prominent Israelis, including Ehud Barak, prime minister from 1999-2001, who had a business relationship with the American financier and occasionally visited the Epstein mansion in New York City.

To be sure Ben-Menashe, has something of a peculiar personal history due to his Mossad connection and he wants to sell his book, but no one has stated that he is wrong on his facts, even though his claims are largely unsubstantiated. And one might also add that last year's hidden

camera undercover exposés of Israeli agents working clandestinely to bring down unfriendly politicians and government officials in both Britain and the United States suggests that Israel is particularly aggressive in its influence operations.

One would have thought that the alleged ongoing investigation of Epstein would include a questioning of possible victims of the blackmail, to include Clinton, but there is no suggestion from anyone that that has actually taken place. And what about Ghislaine Maxwell, who was certainly complicit in the crimes against the girls who were used as well as regarding those who were later blackmailed?

Ghislaine, like Clinton, has never been asked to answer any questions about what she and Epstein were up to, though there is a Reuters report that she is being “investigated.” She has meanwhile been spotted in Los Angeles sipping a coffee at an open-air café. Most recently, the *Jewish Telegraph Agency* reports that “Ghislaine Maxwell, a British socialite who has been accused of helping late sex offender Jeffrey Epstein, is reportedly hiding out in Israel.”

A *New York Post* article confirms that Ghislaine sometimes travels to Britain on her UK passport but that she is currently in Israel “where her powerful contacts have provided her with safe houses and protection. . . . They would trade information about the powerful people caught in his net—

caught at Epstein’s house.” Apart from her status as a Mossad asset and the protection it provides, generally speaking, Israel will not extradite any Jew who has been charged with a crime in another country, which is why so many Russian-Jewish organized crime figures have taken Israeli citizenship. So Ghislaine is unlikely ever to appear in an American courtroom.

And then there is the increased uncertainty about how Epstein died in jail. The authorities continue to claim it was suicide but one has to wonder how he managed to kill himself, if that is indeed the case, as he was reportedly on suicide watch at the prison and he should have been stripped of any clothing or cell furnishings that would have been usable to that end. So he is dead, but did he do it himself or was he helped? There are many prominent individuals and powerful government agencies that will be very pleased that he is gone, as most of his secrets will have gone to the grave with him.

There was certainly a warning that something might happen. Two weeks before his death, he was reportedly found unconscious in his jail cell with marks around his neck. It was suggested that he might have tried to kill himself or, alternatively, had been beaten up by another inmate. There was also considerable speculation that some aggrieved part of the Deep State was trying to assassinate him to silence him.

The recent release of a post-mortem in the jail as well as autopsy photos of Epstein on “60

Minutes” combined with the revelation that procedures in the prison were irregular have reopened the controversy over exactly how the convicted pedophile died with at least one more prominent pathologist saying that the images indicate that he was murdered, not a suicide.

The photos were reviewed by Dr. Michael Baden, a forensic pathologist and a former New York City medical examiner, who claimed that the evidence indicates that Epstein didn’t take his own life. Baden had been a witness at the original four-hour autopsy, and it was his judgment that the photos confirm that the fractures sustained by Epstein don’t suggest suicide. He also observed that the noose made from a bed sheet included in the photos of the autopsy report doesn’t appear to match the wound on Epstein’s throat because it would have created a wider “frown mark.”

Baden also said, “There were fractures of the left, the right, thyroid cartilage and the left hyoid bone. I have never seen three fractures like this in a suicidal hanging. Sometimes there’s a fracture of the hyoid bone or a fracture of the thyroid cartilage. And going over a thousand jail hangings, suicides in the New York City state prisons over the past 40-50 years, no one had three fractures.”

Per *Newsweek’s* reporting of Dr. Baden’s analysis. “He also wondered why Epstein would fashion a noose out of bed linen when his cell contained a long electrical cord attached to a sleep apnea ma-

chine, [saying] “There were other wires and cords present that it would’ve been easy to use to hang oneself within a few minutes. . . . The forensic evidence released so far, including autopsy, point much more to murder and strangulation than the suicide and suicidal hanging.”

And then there is always the big question which remains unanswered or even unasked. Conclusive evidence that Epstein was an Israeli intelligence agent might well be derived from the former U.S. Attorney in Miami Alexander Acosta’s comments when being later cleared by the Trump transition team. He was asked, “Is the Epstein case going to cause a problem [for confirmation hearings]? . . . Acosta testified that he’d had just one meeting on the Epstein case. He’d cut the non-prosecution deal with one of Epstein’s attorneys because he had ‘been told’ to back off, that Epstein was above his pay grade. ‘I was told Epstein belonged to intelligence and to leave it alone.’”

And then there is also the continuing mystery around Epstein’s possession of a genuine Austrian passport. How did he get it? Austrian passports are highly desirable in intelligence circles because the country is neutral and its holders can travel just about everywhere without a visa. ★

• *Post, Times* say they will now respect Trump supporters

“I don’t want to be dismissive of people who support the president. I think they’re owed our respect, and they certainly have mine. They feel that the so-called elites in Washington have not paid attention to them, that they don’t understand their lives. . . . They feel that the president is actually listening to them and addressing their concerns, and so they tend to believe him.”

That statement wasn’t made by someone who has outwardly aligned with the Republican Party or the Trump administration. Rather, it was an admission from *Washington Post* Executive Editor Marty Baron.

Baron was joined on the panel by *New York Times* Executive Editor Dan Baquet, who said the mainstream media has failed to cover Trump supporters fairly. The media “can’t just dismiss” those who support the president. “We have to do a better job understanding why some people support Donald Trump,” Baquet said. “I agree with Marty; we can’t dismiss everybody that supports Donald Trump. I think we have to get out in America much more than we do and talk to people. I think we cannot dismiss everybody who supported Donald Trump. . . . First off, that’s not journalistically moral. It’s journalistically moral to reach out, understand the world, and to be read—that’s our job.”

It was a concession, or maybe even an admis-

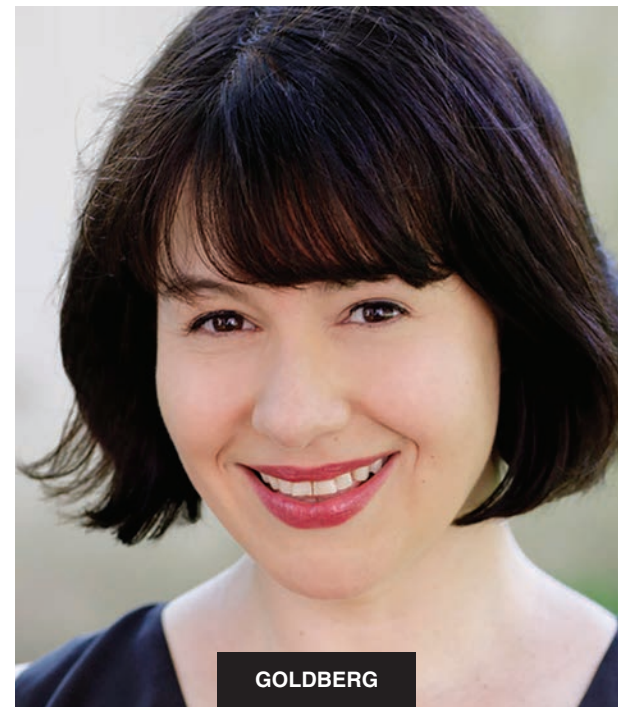
sion, that Trump supporters had been unfairly ridiculed, at worst, or ignored, at best, by the stalwarts of the MSM. As executive editors, this could have been taken as a new, refreshing policy, from the papers of record on D.C. politics. Yet, that assessment may be going too far, too soon.

Just recently, *Washington Post* columnist Jennifer Rubin appeared on MSNBC’s “AM Joy” to plea for the decimation of the Republican Party. “It’s not only that Trump has to lose, but that all his enablers have to lose—we have to collectively, in essence, burn down the Republican Party,” Rubin said. “We have to level them because if there are survivors—if there are people who weather this storm, they will do it again. . . . Shaming these people is a statement of moral indignation that these people are not fit for polite society.”

That doesn’t sound like a grand editorial wave of fairness and understanding is forthcoming from *The Washington Post*.

The “Meet the Press” concession also occurred shortly after *New York Times* columnist Michelle Goldberg penned a column entitled “Maybe They’re Just Bad People.”

Goldberg wrote: “Trump is unique as a magnet for grifters, climbers, and self-promoters, in part because decent people won’t associate with him. With the exception of national security professionals sticking around to stop Trump from blowing up the world, there are two kinds of people in the president’s orbit—the immoral and the amoral.” In other words, if you support Trump for any reason, it’s a tell-tale sign of your extremely

limited character.

Even in their public admission that maybe their newspapers should do more to understand rather than ridicule Trump supporters, there is a certain quasi-scientific distance implied in the statements. It’s as if the MSM consists of Ivy-League-educated scientists growing Trump supporters in their petri dishes, or that they are the top-secret scientists in a 1950s sci-fi film and Trump supporters are the alien life form. The scientists are urging the good, smart, well-intended people to have patience with their study and understanding of these seemingly strange beasts.

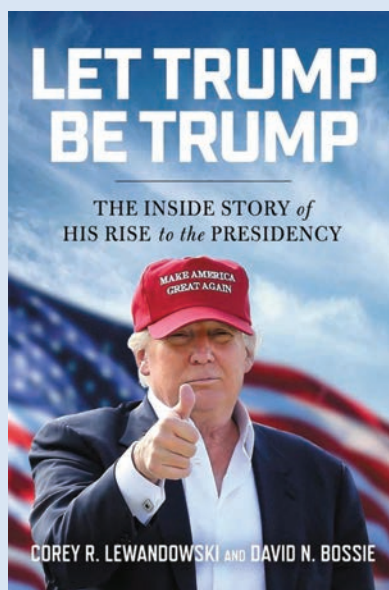
This elitist, attitudinal distance highlights one of the reasons Trump supporters enthusiastically back the president in such throngs throughout rural America. There is a strong feeling (and with the above examples, it’s safe to say a legitimate feeling) that they are being demeaned on a grand scale by the narrative constructors of the MSM. There is a wonder why and how it became so one-sided. If the two most influential newspapers in America couldn’t grasp from day one the concept of fairness and understanding regarding half of the electorate, we have to wonder if they ever wanted to do so at all.

The mainstream newspaper industry has been in a downward spiral since the first day a college student did a search for news on a web browser. If it continues to dismiss half of America over ideology or support for a particular politician, then it will continue to slowly dig its own financial grave. ★

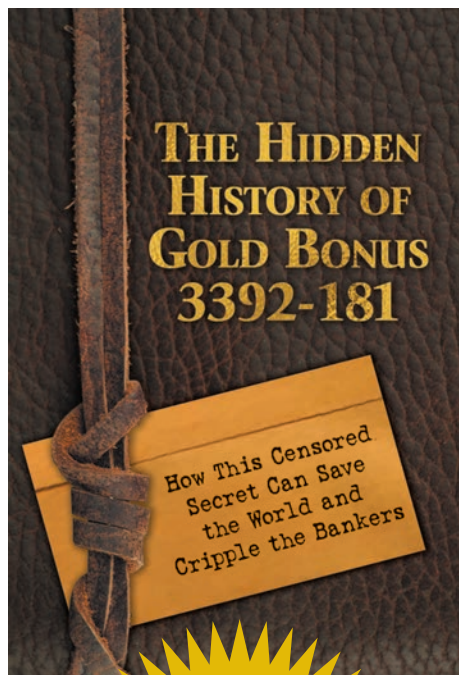

UConn Arrests Students Who Yelled Undirected Racial Slur

College campuses continue to be at the epicenter of the raging debate over free speech in America, with recent examples testing the bounds of freedom of expression, a bedrock of the American political tradition.

Two students at the University of Connecticut have filed a lawsuit against the university, arguing their First Amendment rights were violated when they were arrested and charged in October for shouting “racial slurs” while walking through an off-campus parking lot. A short video was captured of the group of young male students, showing two of them shouting. According to the police report, the students were simply joking around rather than maliciously using the racial slurs, which were not directed at anyone in particular.

The seemingly harmless incident, which occurred on Oct. 11, 2019, made national headlines at the time following a typically hysterical left-wing reaction. After the video was posted online, various leftist groups and civil rights organizations, including the University of Connecticut’s NAACP chapter, pressured the university to investigate and punish the students. Two of them, later identified as Ryan Mucaj and Jarred Karal, both 21, were eventually arrested under a Con-

necticut statute that makes it a crime to “ridicule” a person based on a protected class.

UConn President Thomas Katsouleas praised the arrests at the time.

“It is supportive of our core values to pursue accountability, through due process, for an egregious assault on our community that has caused considerable harm,” Katsouleas stated. “I’m grateful for the university’s collective effort in responding to this incident, especially the hard work of the UConn Police Department, which has been investigating the case since it was reported.”

What “harm” was caused by two students jokingly yelling a racial slur has yet to be explained.

Mucaj and Karal filed a lawsuit earlier in January against the university in the U.S. District Court for the District of Connecticut, alleging their First Amendment rights were violated.

“This is a civil rights action to remedy deprivation of First Amendment rights concerning retaliation by the University of Connecticut against the plaintiffs,” the suit contends. “The retaliation impermissibly discriminates as to speech content and viewpoint.”

Free speech activists and organizations, including the Foundation for Individual Rights in Education (FIRE), a non-profit organization dedicated to protecting free speech on college campuses, welcomed the lawsuit.

“Public institutions may not punish protected expression without facing consequences,” FIRE wrote in a statement. “As the Supreme Court explained long ago, ‘the state has no right to cleanse public debate to the point where it is grammatically palatable to the most squeamish among us’—by penalizing the use of particular words directed at nobody in particular.”

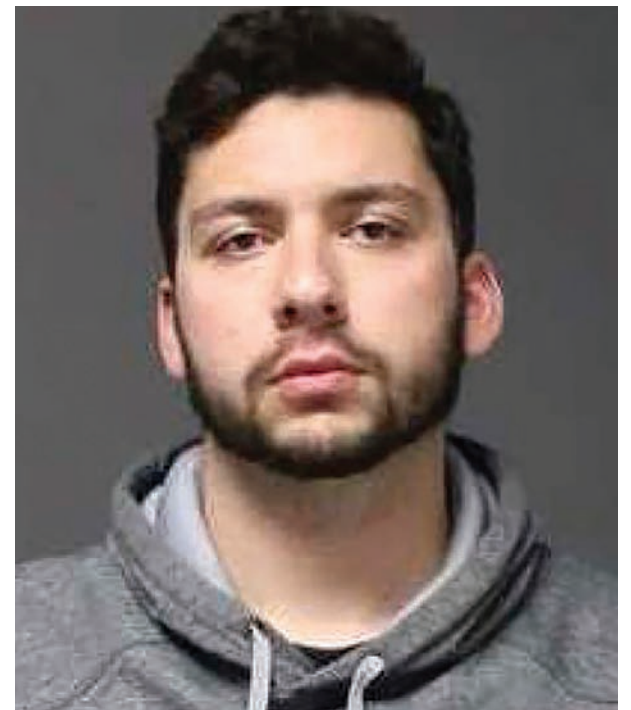
The Connecticut case follows on the heels of several cases around the U.S. whereby college students’ free speech rights are being limited by radical activists.

According to a new report from FIRE, a half-million students at the top 471 colleges in the United States are now required to use designated “free speech zones” to exercise their First Amendment right to freedom of expression.

Researchers at FIRE, in their study titled “Spotlight on Speech Codes 2020: The State of Free Speech on Our Nation’s Campuses,” looked at the policies of 471 top colleges and universities in the U.S. The group found that 89% “maintain policies that restrict—or could too easily be applied to restrict—student expression.”

The study is critical, according to FIRE, because young Americans who grow up and are educated in these anti-free speech conditions learn to accept them without question. This explains why polls show that most young people today are perfectly fine with laws that undermine free speech such as those that criminalize “hate speech,” whatever that is.

The majority of the U.S. colleges and universities studied fell in the middle, with some 64% get-

ting what was called a “yellow light” ranking, meaning their policies were worrisome but not grossly in violation of free speech laws. Some 25% of schools received a “red light” rating. Only 11% of the institutions received a “green light” for their policies.

Interestingly, schools in Texas were considered to be the most anti-free speech, with the University of Houston, the University of North Texas, the University of Texas at Austin, and the University of Texas at Dallas topping the worst of the worst list. The only Texas school to get a green light was Texas A&M University.

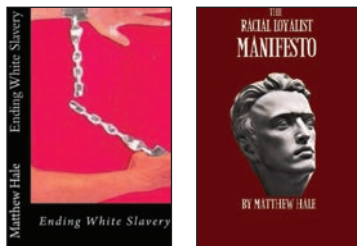
“Many college administrators are scrubbing the most egregious policies from the books, but they’re increasingly crafting subtler policies that still limit student expression,” said FIRE senior program officer Laura Beltz, the lead author of the study. “Yellow light policies aren’t good enough—they still restrict protected speech. Colleges must go green or go back to the drawing board.”

The good news is, Texas politicians have taken the study to heart and are acting on it.

State Sen. Joan Huffman (R-Houston) has already introduced S.B. 18, which mandates that state universities must allow free speech activities on campus and creates punishments for students who interfere with the free speech activities of others.

Texas Gov. Greg Abbott in June signed legislation that safeguards free speech on college campuses. The bill was enacted on Sept. 1, 2019.

“Some colleges are banning free speech on college campuses,” Abbott said on a video of him signing the bill, which he posted online. “Well, no more because I’m about to sign a law that protects free speech on college campuses in Texas. I shouldn’t have to do it,” he said. “The First Amendment guarantees it. Now it’s law in Texas.” ★

Crushing Freedom of Speech: A Truly Bipartisan Endeavor

Both left-wing and right-wing “free speech squelchers,” to quote conservative commentator Michelle Malkin, caused her November 2019 appearance at Boston’s small Bentley University to be cancelled. Those on the right often face censorship on college campuses, due to pressure from leftist social justice warriors. The issue of Malkin’s speech was immigration, something near and dear to the hearts of virtue signalers swearing allegiance to political correctness and enterprising young capitalist fans of the cheapest labor possible.

As Malkin herself explained, “A group of conservative students at the University of Maine, a publicly funded school, invited me to bring my nationalist message about who’s funding the destruction of America to their campus. This prompted the College Republicans’ [CR] faculty adviser, political science professor Amy Fried, to resign in protest. That led to the de-chartering of the CR group. Why? Because I refused to disavow other young students who have asked trenchant, pesky questions at Young America’s Foundation and Turning Point USA lectures about the GOP elites’ support of wage-suppressing, job-outsourcing, Democrat voter-importing policies that put American students, workers, and families last.”

When Malkin asked Fried about this, Fried replied, “I never did that. Didn’t happen. Whoever told you I did is incorrect.”

Maine Republican congressional candidate Adrienne Bennett commented: “Free speech is the cornerstone of a free democracy. We are hearing reports that administrators from the University of Maine pressured a private Maine hotel to cancel an appearance by conservative speaker Michelle Malkin. If true, this is a disturbing development from Maine’s public, land-grant university,” she blasted. “All universities—but especially those that receive public funds—have an obligation to foster free speech and free inquiry . . . I am disturbed that academic elites would interfere to block this speech. For those who disagree with Malkin’s views, the answer is debate and discourse, not censorship.”

Malkin reported that six organizations have now banned her from speaking at their events. Incredibly, one of these was Donald Trump’s fabled Mar-a-Lago, which predictably caved under pressure from—believe it or not—the Southern Poverty Law Center. Another was the New Jersey Right to Life Committee, not exactly an outfit known for social identity politics.

Clearly, the Republican establishment, now relatively comfortable with Trump, is unopposed of hardliners on issues like immigration, such as Malkin or Ann Coulter.

As Malkin put it, “Popular, peacefully expressed ideas that threaten establishment empires in both parties must be stopped. The pretense of free inquiry and association must be propped up by the tolerance hypocrites on the left and the culture warrior poseurs on the right. The illusion of ‘free speech’ must be maintained by the keepers of the gate. Lying is lucrative.”

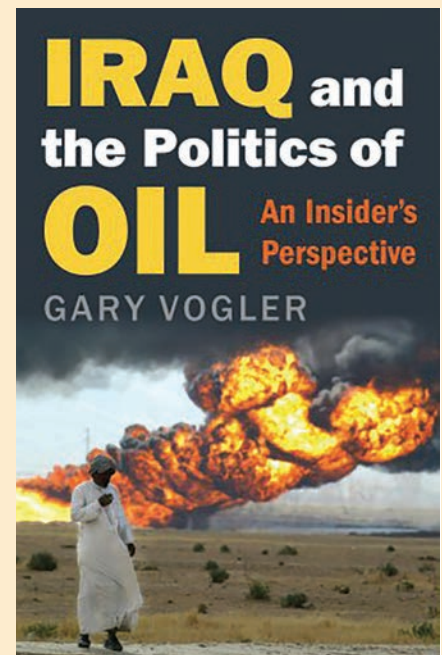
Earlier this week, the Republican National Committee officially condemned Nazis, the Ku Klux Klan, and white supremacists. Just what constitutes a “Nazi” or a “white supremacist” is left for anti-free speech outfits like the Southern Poverty Law Center and the Anti-Defamation League to determine. College Republicans are supposedly “worried” about strident young nationalists like 20-year-old podcaster Nick Fuentes, who has a huge audience online. The state chapter of College Republicans denounced an “Affirmative Action Bake Sale” hosted last May at the University of Washington by a group also calling themselves College Republicans. The sale attempted to satirize affirmative action policies by basing the price of baked goods upon the race of those who purchased them. They also incurred the wrath of mainstream conservatives on campus, and in the state, by inviting controversial “straight pride” advocate Milo Yiannopoulos, who is actually gay himself, to speak there in 2017.

Republican National Committee spokeswoman Mandi Merritt expressed the conventional party view: “When it comes to issues college students care about, like securing a job after graduation, the choice is clear: a booming economy under President Trump or a government takeover of every aspect of their lives under Democrat leadership.” Republicans chant the mantra of a “booming economy” constantly, even though all the employment figures are dishonestly reported, as candidate Trump astutely pointed out during his 2016 presidential campaign.

Twenty-one-year-old Juan Romero, chair of the New Mexico Federation of College Republicans, stated, “Things like the Milo event, where you have someone on stage that says inflammatory things that are in my opinion not even conservative, it not only drives people away, but it also ignites the wrong kind of people.” Romero expressed the goal of carrying on the “conservatism of (Ronald) Reagan.” The real Reagan legacy, of course, is open borders, a bloated military-industrial complex, and tax breaks for only the wealthy.

The San Diego State chapter of College Republicans has even come under fire for using Trump’s noted campaign slogan, “America First.” The University of Maine group elicited controversy from simply defending Columbus. In America 2.0, free speech isn’t popular. ★

Why We Need Dissidents

Aligning with a political party in America is by nature a limiting decision. Only two parties are viewed as “legitimate,” which to many means only that they have a realistic chance at winning the presidency. If you are someone who then wants to work for change—true change—you are forced by this aged political system to work from within. Then, what is one to do if they work for change from within and are shut down by the well-oiled machines that continue to control the Republican and Democratic Parties at the national level? This is a concern of popular Fox News host and author Tucker Carlson.

On a recent radio show appearance, Carlson turned his criticism toward think tanks, PACs, and foundations that support only rigid lines of thinking. Carlson understands this all too well. He has recently been a target of neoconservative institutions for questioning the official narrative in Syria that Bashar al-Assad is an enemy who gasses his own people. For this, Carlson has become a “questionable conservative.”

“There’s nobody protecting dissident voices and I can’t get past it. I’m focused on it and I don’t really know what the answer is,” Carlson said. “It makes me very upset with the institutions that purport to be conservative in our country and consume hundreds of millions, billions over time, in contributions—they’re doing nothing to protect these people. In fact, they’re the first to abandon them.”

Carlson applied this to both parties, mainly discussing the Republicans but also mentioning the “sincere left” who “actually care about the society and where it’s going.” The 2000s have seen both parties struggle with energetic populists. From the right, it was Rep. Ron Paul (R-Texas), and from the left, we are now seeing the DNC’s fear and loathing of Rep. Tulsi Gabbard (D-

Hawaii). Paul and Gabbard have much in common, with strong beliefs in free speech and strong stances against war. In both cases, they have experienced their parties’ best attempts at driving them from debate stages and national polls.

Dissidents have long been a part of the stoic two-party system. Rep. Jannette Rankin (D-Mont.) was the first woman to hold federal office in the U.S., winning a seat in the House of Representatives in 1916. When two Democratic presidents, Woodrow Wilson and Franklin D. Roosevelt, took America headlong into World Wars I and II, respectively, Rankin voted no. In 1941, Rankin was the only member of Congress to vote against the declaration of war against Japan that followed Pearl Harbor. Believing this had effectively ended her career, she did not run again in 1942. When asked later in life if she regretted not running again in 1942, she said, “Never. If you’re against war, you’re against war regardless of what happens. It’s a wrong method of trying to settle a dispute.”

Paul was a throwback to the days when isolationist Robert Taft controlled the Republican Party, days before the New World Order that conquered and divided the world among the superpowers after the world wars took effect. Paul served as a true fiscal conservative, a true anti-war conservative, and someone who strongly believed in the First Amendment as an absolutist. Paul is a noninterventionist, supports withdrawing from the United Nations and NATO, opposed the Iraq War, opposed the Patriot Act, opposes torture, opposes a national ID card, strongly supports private property over massive government ownership of land, and supports the idea of secession as a “deeply American principle.”

In both 2008 and 2012 Paul refused to endorse the Republican nominee for president. They were “no different than Obama,” Paul said. While Paul has never changed, his lifetime has seen the rise and control of the neoconservatives, to the point that many now consider Paul a libertarian. He has not changed; the Republican Party has.

Even this mainstream pundit is catching on. He now realizes that there is nobody out there protecting dissident voices calling for meaningful change in America’s corrupt two-party political monopoly.

There have been other candidates that have a more toned-down dissident spirit while still working within the party, whether it be the anti-Vietnam War candidacy of Sen. Eugene McCarthy (D-Minn.) in 1968 or Pat Buchanan’s Republican primary campaigns of 1992 and 1996. Both men attempted to work within the party and were not ostracized in the way that Paul and now Gabbard have been. Carlson has a nightly stage on the biggest cable news network in America. With that, he is calling for someone to protect that dissident spirit that, he believes, can positively affect both parties.

“If you are not with the program, if you dissent even a little bit,” Carlson pondered, “they can’t increasingly live freely in our society, and my question is, who is standing up for them? Who is protecting them?” ★

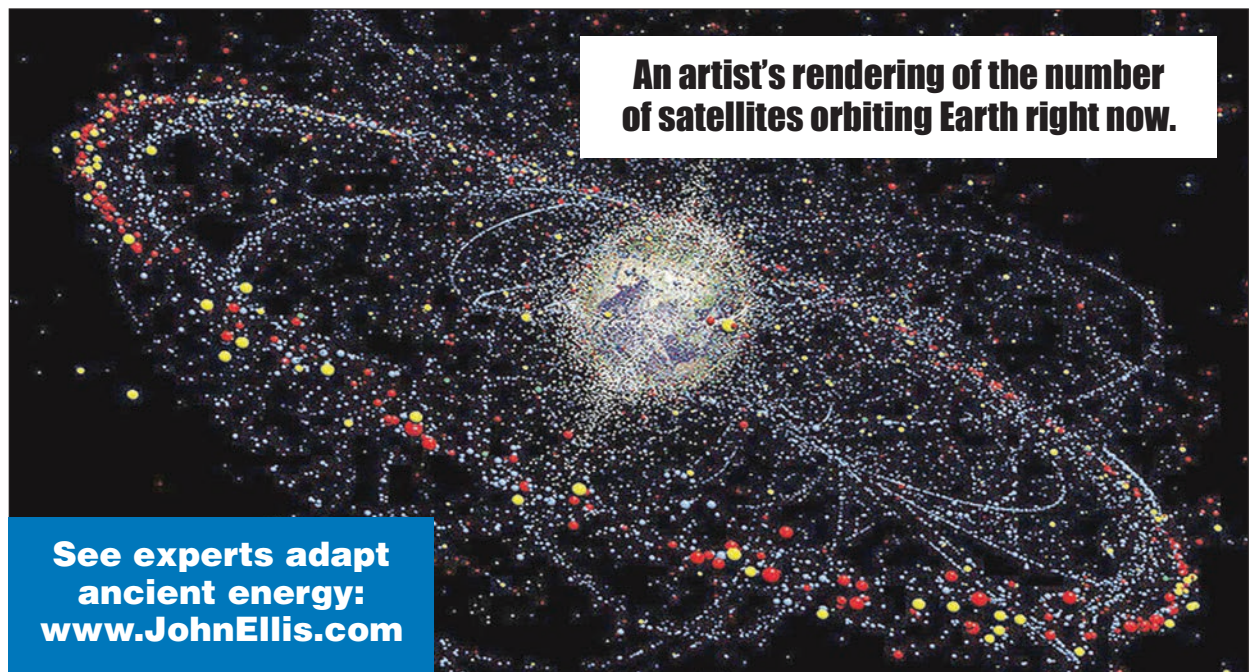

Peaceful Rally Sends Strong Message

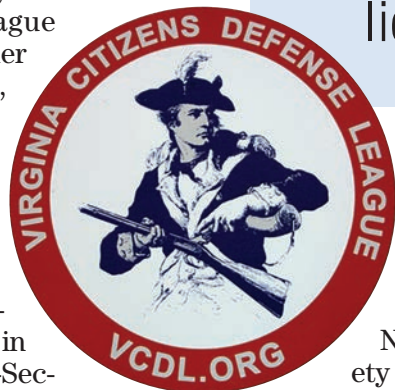
• Americans of all walks of life gather in droves—peacefully—for 2nd Amendment rights

Despite the hysterical headlines emanating from some of the leading purveyors of fake news and fear mongering from local, state, and national political leaders, the pro-Second Amendment rally in Richmond, Va. on Jan. 20 at the state's capitol grounds was an amazing success.

A rally originally organized by the Virginia Citizens Defense League (VCDL) morphed into a broader pro-Second Amendment event, drawing over 20,000 people from the state and around the country, according to many on-the-ground observers. The VCDL scheduled its annual Lobby Day on Jan. 20, which coincided with the federal Martin Luther King Jr. Day holiday, in an effort to protest recent anti-Second Amendment initiatives by the Democrat-led Virginia legislature and Democratic Gov. Ralph Northam. According to the VCDL, the 2020 Legislative Session in the state “represents the greatest threat to gun rights Virginians have faced in modern times.”

The VCDL's annual Lobby Day encourages its supporters to show up at the state's General As-

sembly building to lobby state lawmakers in an effort to advance pro-Second Amendment legislation and to voice their concerns with pending anti-Second Amendment legislation. In November of last year, Northam vowed to reintroduce a variety of gun control measures after Democrats took control of both the state House and Senate, drawing the ire of pro-gun groups like the National Rifle Association (NRA) and the VCDL.

“Getting rid of bump stocks, high volume magazines, red flag laws,” Northam explained to CNN in an interview last year, “these are commonsense pieces of legislation. I will introduce

those again in January. And I'm convinced, with the majority now in the House and the Senate, they'll become law and because of that, Virginia will be safer.”

Democratic leaders have also suggested passing legislation requiring stronger background checks on prospective gun owners and restrictions on various firearms and firearm modifications, such as noise suppressors and modified triggers.

The anti-gun initiatives and proposed legislation generated much controversy, with pro-Second Amendment groups in the state and around the country vowing to protest Northam and the state's Democrat-controlled legislature. Leading up to the rally, various media outlets and the governor himself warned of potential violence, billing the rally as a “white supremacist” event.

Northam declared a state of emergency on Jan. 17, days before the rally, suggesting “that tens of thousands of advocates plan to converge on Capitol Square for events culminating on Jan. 20.” Northam's executive order went on to ominously suggest that “a substantial number of these demonstrators are expected to come from outside the commonwealth, may be armed, and have as their purpose not peaceful assembly but violence, rioting, and insurrection,” which turned out to be entirely false. The governor banned guns from the state capitol grounds leading up to the rally as well.

Following an unsuccessful challenge to his executive order, Northam doubled down on his

predictions, arguing that “the news has confirmed that this rally is attracting extreme individuals and groups—including national hate, neo-Nazi, and white supremacist groups—who are threatening violence and looking to advance a violent agenda.” News of federal law enforcement officials arresting suspected “white supremacists” dovetailed nicely with Northam’s fear mongering, as did mainstream news outlets, such as NBC, who described the pro-Second Amendment event as a “white nationalist rally.”

Despite the warnings and accusations, the rally turned out to be an extremely peaceful and orderly event that had nothing at all to do with so-called “white nationalist” groups. In fact, many leading pro-white and dissident commentators warned their supporters and readers to avoid the rally, with many fearing that either some sort of “false-flag” provocation would occur or violence would break out.

Several independent journalists and media outlets that covered the event and conducted interviews with attendees discovered that individuals of all races and backgrounds participated in the rally.

“I do not in any way, shape, or form support Governor Northam’s and the Democrats’ gun control,” a black American participant explained to Breitbart News during the rally. “What I also don’t support is the fact that every news piece you’ve seen on this, this weekend, they’ve always brought up the issue of race, as though it’s nothing but white rednecks and hillbillies out here who care for the Second Amendment when, actually, black Americans, Asian Americans, Hispanic Americans, Americans in general care about the Second Amendment.”

Julio Rosas, a former U.S. Marine and current journalist with “TownHall.com,” covered the

rally, and explained his experience on the “Tucker Carlson Tonight” show, demolishing the mainstream media’s pre-scripted narrative about the rally.

“This event was advertised as this supposedly ‘white supremacist, Nazi’ rally,” Rosas noted. “And me, being of Mexican heritage, I had zero issues with anybody coming up to me.”

He contrasted his experience at the “entirely peaceful” rally in Richmond with his previous

coverage of antifa protests, where he has been repeatedly physically threatened and verbally accosted.

“It was a night-and-day difference,” he explained. “In Portland, I was called a race traitor.”

He also noted the number of minorities present for the rally and scoffed at the notion that the event was in any way connected to “white supremacist” groups or organizations.

Several Virginia sheriff’s deputies even attended the rally in a demonstration of support for the Second Amendment. One deputy was interviewed by a reporter with the “Washington Examiner,” and explicitly stated that many of the proposed bills being debated and considered in the Virginia legislature were unconstitutional and represented clear violations of the Second Amendment.

“If the bills go through as proposed, they will not be enforced,” the deputy explained. “They are unconstitutional. We swore to uphold the Constitution of the United States and the Constitution of Virginia, and that’s what we’ll do.”

Northam released a statement following the peaceful rally, expressing thanks that the event “passed without incident.”

“Thousands of people came to Richmond to make their voices heard,” Northam declared. “Today showed that when people disagree, they can do so peacefully. The issues before us evoke strong emotions, and progress is often difficult.”

If anything, the recent rally proves once again how dishonest the fake news media truly is. ★

Americans Have a Proud History of Resistance to Immoral Tyranny

On the holiday set aside in 2020 to honor Martin Luther King Jr., the premier advocate of nonviolent Gandhian civil disobedience, thousands of gun owners gathered in Richmond to petition peacefully for their rights. King had preached that there was a higher law that justified breaking existing laws that mandated racial segregation.

When Rosa Parks refused to give up her seat in the front of the bus in Montgomery, when Freedom Riders integrated bus terminals, when black students sat at segregated lunch counters in North Carolina, they challenged state law in the name of what they said was a higher law.

And Virginia gun owners believe their moral obligation to protect families, friends, and themselves in a violent society justifies their right to keep and carry firearms, no matter what the Virginia legislature says.

Americans have a long history of breaching laws in the name of a higher law or God-given rights.

The patriots of Boston gathered at an arsenal at

Concord in defiance of the British. To protest a tea tax imposed by Parliament, they dressed as American Indians and threw shiploads of imported tea into Boston Harbor.

Shays' Rebellion in Massachusetts, to protest debt collections in 1786-87, and the 1794 Whiskey Rebellion in western Pennsylvania, to protest a tax, both had to be crushed with force.

Abolitionists supported the violation of fugitive slave laws, the enforcement of which Abraham Lincoln endorsed in his first inaugural as a national necessity to restore and preserve the Union.

A constitutional prohibition on the sale of beer, wine, and liquor in the U.S., following the enactment of the 18th Amendment, led to massive civil disobedience in the Roaring '20s, before it was repealed in 1933 by the 21st Amendment.

During Vietnam, burning draft cards was a regular feature of anti-war rallies.

Historians may describe the racial riots of the 1960s—Harlem, Watts, Newark, Detroit, and 100 U.S. cities including Washington, D.C., after King's assassination—as popular uprisings, but many required National Guard and federal troops to stop the looting, shooting, and arson.

By the late 1960s, LBJ, who had passed the Civil Rights Act of 1964 and the Voting Rights Act of 1965, could not visit a college campus without a violent demonstration.

In mid-January, Washington hosted the 46th annual March for Life to commemorate the 60 million unborn killed in the abortion mills of America since *Roe v. Wade* in 1973.

In conservative states, restrictions imposed on abortion facilities have put some out of business. The legislators and governors who have done so believe the right to life trumps the Warren court ruling in *Roe v. Wade*.

Perhaps the greatest manifestation of civil disobedience today is the illegal presence of between 12 million and 20 million immigrants who broke into our country or are breaking the law by being here after their visas expired. Their collaborators are the business owners who hire them and the public officials who refuse to treat them as law-breakers.

"Sanctuary cities" have been created where local and state authorities refuse to cooperate with immigration enforcement.

Now, towns, cities, and counties are creating "Second Amendment sanctuaries," where laws restricting gun rights will not be enforced.

If state and local police, themselves gun owners, stand with those who defy the new state laws on guns, who enforces the new laws?

The Virginia Senate has begun to move bills requiring background checks for gun purchasers including red flag laws to disarm individuals deemed at risk to themselves or others, and bills granting permission for locales to restrict the carrying of arms in government buildings and confining the purchases of handguns to one a month.

There are other restrictions the Democratic legislature in Richmond and governor are ready to

move, including restricting the number of bullets in clips and magazines and halting sales of rifles like the AR-15.

Gun owners see these as the onset of an all-out assault on gun rights.

For a republic to endure, there has to be a common consent on the rule of law and what constitutes a good society. But these seem to be at issue again in America.

Is abortion the killing of an innocent human being?

Do Americans have a constitutional and human right to keep and carry firearms to protect themselves and their loved ones?

Who is and who is not a rightful resident of our national home?

Do illegal migrants have a right to come here and stay here? Or do their numbers imperil our national identity and existence as "one nation and one people"?

Violent crime was greater in America in the early 1990s. Urban riots were far more common in the 1960s. And there is nothing today comparable to the bloodletting of the 1861-65 War Between the States.

Still, Americans seem to disagree with each other more and to dislike each other more than they have in the lifetime of most of us.

One wonders: How does it all stay together? And for how long? ★

China: Another Trump Trade Win

• President has renegotiated yet another major trade agreement in America's favor

National Economic Council Director Larry Kudlow says that phase one of the new U.S.-China trade deal, signed as planned on Jan. 15, is a virtual cornucopia of benefits for both sides. It also provides several measures to put a check on China's notoriously underhanded trade practices, including chronic intellectual property theft.

"For both teams, for both sides, this is a pro-growth deal," Kudlow told CNBC Jan. 15. "In fact, we think it's going to add to the growth of our economy by at least half a percentage point in 2020 and 2021. Chinese state [media] organs are putting out that Chinese consumers want American imports. . . . Between the two great nations, nothing like this has ever happened before. It shows cooperation is possible; it shows a more balanced trading relationship is possible."

Responding to a CNBC anchor's statement that the height of Chinese purchases of U.S. goods was \$186 billion in 2017 and that the new deal requires China to increase purchases by \$200 billion over the next two years, Kudlow said that China will likely meet those benchmarks depending largely "on what the market bears." Ludlow added that the Chinese also believe "their economy both needs, and can absorb, those kinds of increases."

Breaking down the numbers, Kudlow explained that U.S. agricultural exports will go up between \$40 billion and \$50 billion per year.

Manufacturing will see a \$75 billion increase. "That is a very large number . . . there's been a little 'softening' in U.S. manufacturing, so that's going to be a good thing," Ludlow said.

Overall services will increase \$40 billion.

U.S. energy will see an increase of \$50 billion.

"Not enough attention has been paid to [energy]," even while "America has become an energy power . . . independent and number one in the world," Ludlow continued.

Another CNBC commentator, who remarked

that "tariffs worked" and "didn't produce any [price] inflation," wondered whether Ludlow was surprised that tariffs were so effective.

Ludlow agreed that tariffs played a key role in prodding China to come to the negotiating table, but he was careful to characterize tariffs as a temporary measure that were mainly a means to an end.

"I think President Trump has shown all of us that you have a policy [enacting tariffs] to defend the American economy and the American worker, and that China had generated a very unbalanced trading relationship, breaking rules left and right, whether it was IP theft, whether it was forced tech-transfer, whether it was market closings, and so forth."

Interestingly, and contrary to the assumptions of some of those in Trump's core voter base, Ludlow added that he understands Trump to be a "free-trader" who wants to lower trade barriers and enhance exports. "[That's] the best way to get your trade deficit down. . . . He has shown that tariffs are part of tough negotiating in pursuit of market openings. More balance. Stop the unfairness. Stop the theft."

A White House article further emphasized the benefits of the agreement:

For the first time in any trade agreement, China agreed to end its practice of forcing foreign companies to transfer their technology to Chinese companies in order to gain market access. China will address numerous longstanding intellectual property concerns in the areas of trade secrets, trademarks, enforcement against pirated and counterfeit goods, and more. China agreed to strong commitments on currency practices regarding currency devaluations and exchange rates. The agreement addresses a wide range of trade and investment barriers that have prevented American financial services companies from being able to compete in China.

It is worth noting that U.S. tariffs would not be entirely revoked. The duty of 25% on \$250 billion worth of Chinese goods evidently will remain in place, providing the U.S. with leverage for a second phase of negotiations next year, according to the Office of the U.S. Trade Representative (USTR). Going into the Jan. 15 signing, the U.S. had suspended planned 15% tariffs on nearly \$160 billion worth of Chinese goods, including cell phones, laptop computers, toys, and clothing. China canceled its retaliatory tariffs, including a 25% tariff on U.S.-made autos. The USTR said it would halve the tariff rate it imposed on Sept. 1 on a \$120 billion list of Chinese goods, down to 7.5%. ★

In 1976, President Gerald Ford signed Executive Order 11905, which prohibited any member of the United States government from engaging or conspiring to engage in a political assassination anywhere in the world. Ford was pressured into doing so, due to disclosures from the Senate committee chaired by Sen. Frank Church (D-Idaho), which exposed CIA plots to kill Fidel Castro and other foreign leaders. At the time, public opinion polls showed that a majority of Americans were morally opposed to assassinating even foreign leaders such as Adolf Hitler or Benito Mussolini.

The recent assassination of Iranian Gen. Qassem Soleimani was the latest example of just how far American leadership, and public opinion, has drifted on this issue. President Donald Trump didn't quite sink to the level he did after U.S. forces assassinated the alleged leader of ISIS, al-Baghdadi, last October, when he chided him for "dying like a dog" and "dying a coward." But he did tell a cheering rally recently that the Soleimani assassination was an act of "American justice." While 55% of Americans polled after the Soleimani assassination said it had made the United States less safe, this was undoubtedly skewed by the fact the mainstream media is so biased against anything Trump does.

A better barometer of modern public opinion came from the polls taken after President Barack Obama assassinated American citizen Anwar al-Awlaki with a drone in 2011. At that time, 56% of the public favored the use of drones in such assassinations. Obama memorably bragged about killing al-Awlaki, and then murdered his 16-year-

old son the next month for good measure. Less publicized were the deaths by drone strikes of three other U.S. citizens, two in Yemen and one in Pakistan. Noticeably missing from the poll questions was any reference to the morality behind assassination. In fact, only 31% of Americans even expressed concern with the legal aspects of drone killings.

Obama, who bragged behind the scenes to his aides about being "really good at killing people," also assassinated Libyan leader Muammar Qaddafi in 2011. Another high-profile "liberal," then-Secretary of State Hillary Clinton, gleefully celebrated the Qaddafi killing during an interview with CBS News, boasting laughingly, "We

came, we saw, he died." Obama announced that "the shadow of tyranny over Libya has been lifted."

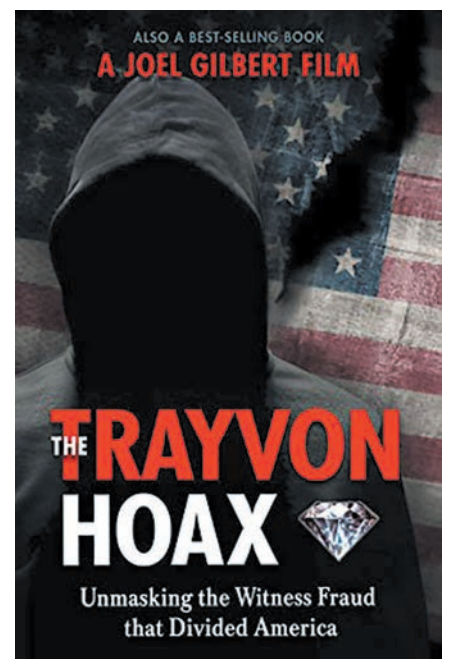
While some leading figures such as Ralph Nader, Dennis Kucinich, and Ron Paul were appalled by the government's actions in Libya, tried-and-true shills for the war state like John McCain, John Kerry, Nancy Pelosi, and others were in full support.

Neocon Senator Marco Rubio (R-Fla.) notably tweeted what was a clear warning to Venezuelan leader Nicolas Maduro last February, by contrasting before and after photos of Qaddafi. Like all the leaders in both U.S. "opposing" political parties, Rubio would unquestionably support the assassination of Maduro.

In 2011, Rubio celebrated Obama's assassination of Qaddafi, but felt he hadn't gone far enough. How much further one can go beyond assassination is something only bloodthirsty chicken hawks can explain. "If you're an enemy of the United States and we have a chance to take a shot at you in a way that doesn't hurt us, and has a chance of being successful, we're probably going to take it," Rubio declared at the time. "There's a price to pay for being an enemy of the United States." Affirming their continued support for neocon principles, Rubio, like Lindsay Graham and other high-profile neocons, was critical of Trump when he met with Vladimir Putin and attempted a dialogue with North Korean

leader Kim Jong Un.

At the time, Obama issued what was widely considered a veiled threat to leaders of countries like Syria, Yemen, and Iran with his comment, "For the region, today's events prove once more that the rule of an iron fist inevitably comes to an end."

War hawks in both parties celebrated Qaddafi's death along with Obama and Clinton. Mitt Romney declared, "The world is a better place with Gaddafi gone."

"The death of Muammar Qaddafi marks an end to the first phase of the Libyan revolution," intoned Sen. John McCain (R-Ariz.).

Sen. Carl Levin (D-Mich.) praised, "The success of the Libyan people in rising up to overthrow a tyrant is a blow against dictatorship everywhere." Except it wasn't the "Libyan people" who assassinated Qaddafi.

2011 was a busy year for American assassins. Osama bin Laden was also allegedly killed that year by U.S. forces during a raid on his compound in Pakistan, a sovereign nation. The official narrative of his death was dubious, to say the least, but celebrations took place all over the country, including loud chants of "USA! USA!" at a nationally televised Major League Baseball game. George W. Bush said, "This momentous achievement marks a victory for America," and Bill Clinton proclaimed it was "a profoundly important moment for people all over the world."

Consider, a mere 40 years earlier, most Americans would have opposed assassinating Hitler, a foreign leader who himself refused to consider assassinating foreign leaders. ★

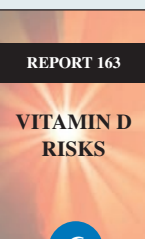
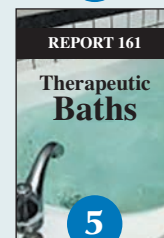

Trilateral Veteran Views Trump as a Threat to New World Order

On Jan. 14, former Trilateral Commission (TC) North American Director Joseph S. Nye Jr. addressed the Chicago Council of Global Affairs (CCGA). His speech was entitled, “Do Morals Matter? Presidents and Foreign Policy from FDR to Trump.”

While the CCGA hosted Nye and promoted his new book on the topic of his speech, the organization curiously didn’t mention his TC pedigree, just as it was mum about *Economist* editor-in-chief Zanny Minton Beddoes’s Bilderberg Steering Committee membership when she addressed the council about Brexit last October.

“The conventional wisdom is that only national interests matter. I’ve long believed that’s incorrect, and I’ve had so much ‘help’ from Donald Trump,” Nye, a Harvard Kennedy School of Government international relations scholar quipped at the Chicago program, moderated by Northwestern law professor Juliet Sorensen.

Sorensen asked Nye whether America should try to “make the world a better place.” He answered, “As long as we understand the limits of our power,” and added that, in his view, a president shouldn’t “have to give up” on his country but

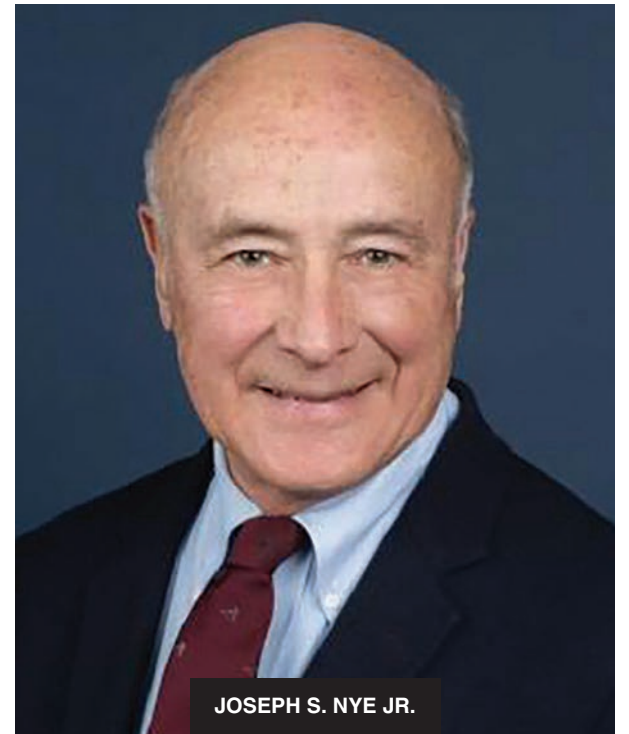
still should “look further” and take other countries, especially allies, into account.

Nye then wondered aloud: Should the U.S. “narrowly” and “myopically” focus on immediate transactional matters largely in its own direct interests in a Trump-like fashion, or should it “look broadly for a stable world order?” While noting the policies of FDR and other presidents, Nye answered that there really isn’t much of a dichotomy because, through institutions like the United Nations, a lot can be done to encompass both national interests and the interests of other nations.

Giving a glimpse into the mindset of globalism, Nye, referring to his new book, defined presidents FDR, Harry Truman, and Dwight Eisenhower as “the founders” of the still-reigning but evidently weakening world order. That is a clear-cut example of how today’s globalists reorient the nation’s thinking away from Washington, Jefferson, and Madison and toward a different trio of “founding fathers,” who presided over the undoing of much of what the real founders established. However, the weakening of the new order under Trump, and the TC’s deep-seated concerns that Trump is out-foxing the Deep State in several respects, is apparently what’s really behind Nye’s Chicago appearance—calculated to diminish Trump’s standing compared to other presidents.

“Obama placed much more emphasis on allies and institutions and multilateralism, and Trump is much more of a unilateralist—go it alone,” Nye stated. “He’s noted for his phrase ‘America first’; it’s not that America first is so important; it’s the way he defines it very narrowly as American interests and not much the interests of others. Obama was also a believer in American exceptionalism but believed you could accomplish that with other countries and with international institutions; so that’s the big difference between them.” Nye added in a separate CCGA video online.

In his main talk, Nye remarked that his three “founders” were “very much interested in promoting America’s national interests, but they de-

finied it so that it encompassed the interests of others”—a statement that, just one day later, collided with the Trump administration’s engineering of a phase-one trade deal with China that is said to be highly beneficial to both nations and reportedly lays the groundwork for China to end its abusive trade practices.

While recalling that approximately 70% of the American people were “isolationist” in FDR’s day—a figure that’s around 33% today, according to the CCGA’s recent annual public surveys on foreign affairs that date back to 1974—Nye conceded that the globalist vision of a one-world society still faces rather formidable challenges in terms of convincing Americans to keep paying the new world order’s bills while Trump busily pursues a more nationalistic course, prompting some Americans to reexamine the tenets of globalization.

In a world of “rootless cosmopolitans and hardcore nationalists, we all have multiple loyalties,” Nye reflected. He then underscored the internationalist credo of the TC, the CCGA, the Council on Foreign Relations, the Atlantic Council, the Wilson Institute, the Brookings Institution, the Bilderberg Meetings, and similar well-linked groups by stating, “To pretend it all stops at the water’s edge is nonsense. . . .”

The positive takeaway from Nye’s speech, however, is the realization that the global elite labor relentlessly to track and control public opinion because they still fear a truly informed populace that just might find the right blend of populism and raw courage with which to defeat our world rulers for good. ★

Globalists Formulate Plan to Stem the Rise of Nationalism, Populism

The Trilateral Commission (TC), created in 1973 by two now-deceased kingpins of coerced world consolidation—David Rockefeller and Zbigniew Brzezinski—is recreating itself after 45 years. This involves keeping nationalism, populism, and protectionism on the TC’s “radar.” It must subdue such “isms” and preserve what the TC calls “democracy” under the “international order” that grew out of the June 1944 Bretton Woods conference—spurring the creation of the World Bank, the International Monetary Fund, and the foundation of the World Trade Organization.

This is all explained in the TC’s Summer 2019 blueprint, entitled “Democracies Under Stress: Recreating the Trilateral Commission to Revitalize Our Democracies to Uphold the Rules-Based International Order.”

The paper contemplates 2020 as a pivotal year and implies that the Trump era has presented roadblocks to further globalization. It states:

The drive toward deeper integration and greater globalization seemed irreversible until just a few years ago. Yet in recent times, the unintended consequences of these trends—from inequality to cultural alienation—have fueled new forms of discontent, spurring a rise in populism and nationalism in the most advanced economies and democracies in the world. Today’s institutions—both global and domestic—seem ill-equipped to face these trends down and ensure the maintenance of the rules-based international order.

The paper fingers “social media” for “transforming and degrading politics by reinforcing bias, spreading falsehoods, and segmenting people into more insulated groups.” That could be interpreted as meaning that citizens and citizen journalists, along with many in the alternative media, have a growing audience while the mass media cartel’s audience declines, subjecting the TC and similar shadow-government groups to more exposure than they’re accustomed to. The paper continues:

Prospects for maintaining the open global trading system, stemming nuclear proliferation, and adequately addressing climate change are

slim as long as advanced democracies are compromised by internal divisions and governed by institutions that are no longer well-suited to the realities of the day. As developed democracies turn inward, the corresponding attrition of alliances, shared interests, and joint capabilities across North America, Europe, and Asia paves the way for a more unstable and less prosperous world.

A translation of this mealy “globalese” is helpful. Are we to believe that the TC—in concert with its globalist brethren in the Council on Foreign Relations (CFR) and other one-world institutes—had no idea that unlimited migration would cause “cultural alienation”? What else should we expect when Third World people flood into European countries and the United States in large numbers over short time periods with little in the way of assimilation? And if the host domestic population sees its taxes go up for related public services, sees crime increase, or sees wages bid downward in the labor market—causing the very “discontent” the TC mentions—can that really be dismissed as purely “unintended?”

The paper concludes with 13 action items that, among other things, will produce studies to explore the ways democracies are “under stress” (read: not sold on globalization) and to create “connective tissue between elites and non-elites in the United States” and wherever else populism—a worldview that avoids the left-right divide and enables the people to obtain actual democratic control by shedding elitism—is gumming up the globalists’ works. ★

The Iran Hostage Crisis: 40 Years Later

• CIA dirty tricks against Iranian democracy led to Islamic fundamentalist revolution

“Do you believe in miracles?!” Al Michaels screamed as the rag-tag team of amateur American hockey players defeated the dominant Russians 4-3 at the 1980 Winter Olympics in Lake Placid, N.Y. The Russians hadn’t lost a game in Olympic play since 1968. *Sports Illustrated* named the “Miracle on Ice,” the top sports moment of the 20th century. In isolation, the Cold War-soaked victory was a symbolic moment of great exuberance for Americans. We were that “shining city upon a hill.” Yet, like any other historical benchmark, there is context. Even as the national anthem played and the Americans received their medals on home ice after an anti-climactic gold medal win over Finland, halfway around the globe existed a stark reminder that the world is a much more nuanced place.

Feb. 22, 1980, the evening of the Miracle on Ice, had marked 110 days since 52 American diplomats and citizens had been taken hostage in Tehran. Iranian college students representing the Ayatollah Khomeini’s Iranian Revolution had overtaken the U.S. embassy in Iran’s capital city. While President Jimmy Carter called it “an act of blackmail” and described the hostages as victims of “terrorism and anarchy,” the students believed they were rightly responding to decades of undue influence into Iranian politics by Western intelligence agencies.

In 1953, the CIA and its British allies overthrew Prime Minister Mohammad Mossadeq in a coup supported by Iranian royalists and Western petroleum companies.* Mossadeq had led a general strike on behalf of Iran’s poorest citizens and the country’s parliament, demanding a percentage of Britain’s Anglo-Iranian Oil Company revenues in Iran. The British and the Americans supported Mohammad Reza Pahlavi, who became the last shah (emperor) of Iran. Quickly, the



The United States and Britain have for decades been meddling in the internal affairs of Iran. This included installing Mohammad Reza Pahlavi as “shah.” After years of torture and repression of human rights, the Iranian people rose up and stormed the U.S. embassy in Tehran, taking 52 diplomats and citizens hostage as the shah was in America seeking medical treatment for lymphoma. Islamic fundamentalist Ayatollah Khomeini became Iran’s supreme leader.

Shah appointed himself the absolute monarch of Iran and ruled with a bloody, iron fist until he was overthrown in 1979.

The U.S. had reason to believe they could work with Khomeini, who had returned to Iran from exile in France. Carter tried a minor amount of diplomacy, a sticky venture lacking legitimacy since the Americans had propped up the Shah for three decades. It was all for naught when Carter allowed the Shah to enter the New York Hospital-Cornell Medical Center for treatment of lymphoma.

Carter’s State Department had discouraged the Shah from even making the request to the administration, but pressure mounted from all political persuasions. Henry Kissinger threatened Carter to allow the Shah in or he would not publicly support the SALT (Strategic Arms Limitation

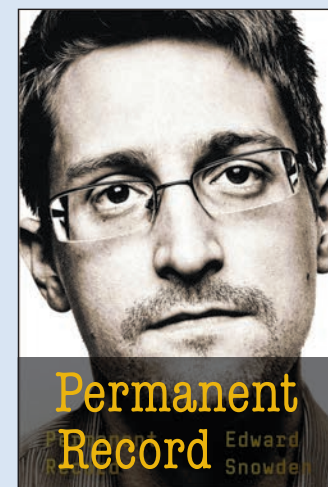
Treaty) talks. Council on Foreign Relations founder David Rockefeller also pressured Carter, though surely through his Trilateral Commission cofounder, Carter’s national security advisor Zbigniew Brzezinski.

Carter relented and allowed the Shah to seek treatment in New York on Oct. 22, 1979. Protests intensified in Iran, as students believed the Americans would attempt another coup aimed at reinstalling the Shah to power, and students took the embassy and the hostages on Nov. 4, 1979.

Nine days after the hostages were taken, former California Gov. Ronald Reagan took to national television to announce that he would seek the presidency in 1980. Anathema to his hyper-positive “Morning in America” campaign in 1984, Reagan in 1980 said that America had been “naïve, sometimes wrong” in its policies. When

speaking of Canada and Mexico, he said, "It is time we stopped thinking of our nearest neighbors as foreigners." While Americans would soon realize what the Reagan campaign would be, on this night there was a reasonable level of uncertainty, and these were troubled times.

In January 1980, CBS newsman Walter Cronkite began opening each episode of his nightly news program by counting how many days the Americans had been in captivity. Carter engaged in multiple rounds of secret negotiations, but Khomeini nixed each of them after the president had agreed to minor concessions. The pressure to do something weighed heavily on the White House, resulting in a failed rescue attempt in April 1980, a helicopter crash that killed eight servicemen and injured others.

The Shah died on Feb. 20, 1980 as tension over the crisis continued to be the dominant topic during the entirety of the 1980 campaign for president. The Iranian Hostage Crisis lasted 444 days and ended when the Algiers Declaration was signed—on Jan. 20, 1981, Reagan's inauguration day. Though elated with the result, skeptical observers commented on the convenience of the timing of Reagan's first great policy victory. Rumors of an "October Surprise" abound. Did the Reagan team covertly secure and then delay the release of the hostages until Inauguration Day? Researchers Robert Parry, Barbara Honegger, and Gary Sick all believed so, though they disagreed about the level of involvement at the highest levels.

The hostage crisis was the historical dagger to the heart of the Carter presidency. He had accurately assessed the country was in a "malaise," but failed to recognize his role in its creation. On Feb. 20, 1980, he announced that the Russians had not met a demand to withdraw all troops from Afghanistan, and, therefore, the U.S. would not be sending its athletes to the 1980 Summer Olympics in Moscow. Americans could have used a temporary lift that summer, but there would be no more Olympic miracles as the calendar kept turning for American hostages, captive in a strange land, and for a president bound by a situation he couldn't resolve. ★

Israel Violates Sovereignty of Neighbors

• Zionist aggression a key factor in rise of tensions between United States and Iran

Israel's standard tactic in the Middle East is to bomb its neighbors by invading their airspace without permission, using aircraft and armed drones, and then to remain completely silent about it.

The targeting of Iraq, Lebanon, and Syria in particular has continued for years with Israel refusing in most cases to acknowledge it was the culprit, all the time acting as if its unlawful activities were greenlit by Washington, which in many instances was true.

Israeli Prime Minister Benjamin Netanyahu has made it clear publicly that President Donald Trump has his back, but the reality is that Israeli leaders live by a code which has the mandate of "Israel first." In other words, Israel should do whatever it considers necessary, irrespective of whether it compromises a friend or ally. Israel will always cover its tracks when it is convenient.

A classic case of that syndrome and strategy was Netanyahu's response to the assassination of Iranian Gen. Qassem Soleimani, whom Israel had always refused to kill, believing it was not in its interests because such a killing would spark a widespread period of tit-for-tat assassinations for years into the future. When Trump told the world that he had personally ordered a missile strike to kill Soleimani, one might have expected cheering from the sidelines by Netanyahu. Instead, he



quickly pointed out that Israel had no part in the operation, yet Israel knew about it well in advance, and normally would applaud the killing of any senior Hezbollah or Iranian figure. In fact, there are some security experts who suspect that Israel may have helped the CIA with surveillance of Soleimani.

Fox News International carried a report by news and commentary website "Axios" that Netanyahu told his cabinet the Soleimani killing was a U.S. affair and that Israel should stay out of it and not respond to the media about the attack.

Israel, however, used the subsequent retaliatory missile attack by Iran against U.S. bases in Iraq to launch its own attack on an airport in Syria, but made no claim of responsibility, leaving some to speculate that the U.S. was responsible. That is another tactic Israel employs, namely hit-

ting targets and refusing to admit guilt thus leaving people to mostly speculate that America was the aggressor.

In a sign of his displeasure with Israel after the Syria bombing, Russian President Vladimir Putin chose to land at the bombed airport two days later to meet Syria's President Bashar al-Assad. It was only Putin's second visit to Syria.

the Middle East, showing a total disregard for international law and the territorial integrity and airspace of its neighbors. Since the arrival in the White House of Trump and his son-in-law, Jared Kushner, who regards Netanyahu as a family friend, Israel has consistently bombed Russia's ally, Syria, as well as Iraq, making the thousands of U.S. military personnel stationed there potential targets for retaliation.

Throughout his tenure as prime minister of Israel, Netanyahu has tried to force a war with Iran and Hezbollah. Every time he strikes Iranian militias in Syria and Iraq, he hopes they will respond. His cynicism has no bounds. With the connivance of Kushner, he has established covert links with the Saudis and other Arab states in the region with the aim of running joint covert operations against Shiite militias. This has had the approval of Washington, but the strategy's long-term goals do not suit an American public tired of foreign wars, especially in the Middle East.

Netanyahu's strategy undermines the promises made by Trump before he was elected president that he would end foreign wars and pull troops out of the Middle East. Instead, he has increased the numbers of troops there, boasting that the Saudis pay well for our military assistance—to the tune of \$1 billion. While his claim of \$1 billion was discredited—the Pentagon issued a statement saying the Saudis still owed the U.S. \$181 million for fuel related to operations in Yemen—it called into question whether we should be renting the U.S. military to any Arab state, especially the Saudis, who gave us al Qaeda, funded groups like the al-Nusra Front and ISIS, and continue to slaughter women and children in Yemen.

The reality is that Congress has never paid enough attention to the U.S. role in the Middle East, and both parties on the Hill have been willing to follow an Israeli script about how we should act and who we should bomb. European nations, too, have been reluctant to scrutinize Netanyahu for his belligerence. Washington has even ignored Israel's activities in Azerbaijan in the Caucasus, next door to Iran, yet it has been obvious to Moscow and Ankara what Israel is up to strategically. Azerbaijan could be used to launch attacks into Iran, and that would represent an expansion of conflict into the backyard of Russia and Turkey.

Washington, however, has been happy to ignore the issue, confirming yet again that Israel can do what it wants, but as Netanyahu showed after the Soleimani assassination, when the chips are down, he will travel his own road. ★

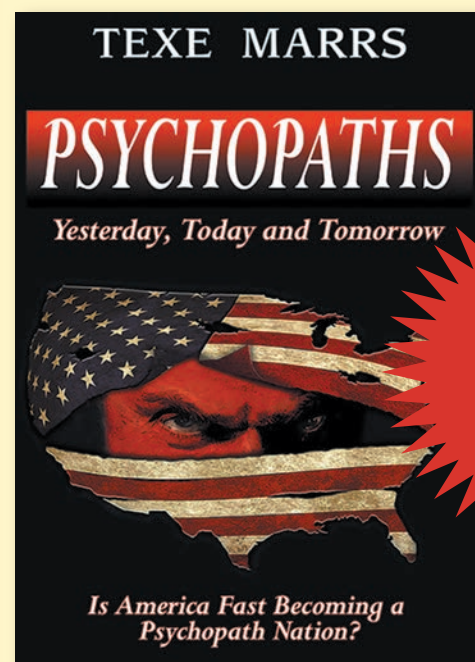

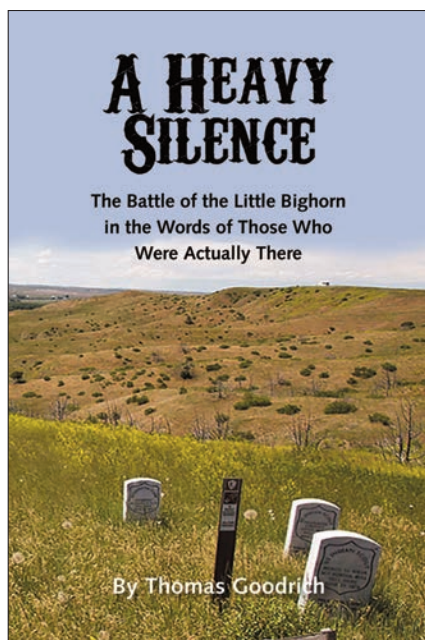
