## Imagine a World With Nothing But Fake News . . .

It's hard to believe that, in wrapping up this week's issue, we're just about halfway through 2019. So far, it's actually been a pretty great year for the United States. The economy is buzzing along, unemployment is at a record low, and it seems like we have a president who, despite being repeatedly undermined by Democrats as well as many of his fellow Republicans, actually cares about the American people.

In this edition, we cover some of the most important issues facing America today, including the growing trade war with China. Roving editor Mark Anderson and syndicated columnist Pat Buchanan provide a much-needed look at the other side of the story on tariffs. We have to say that it's about time someone in Washington is willing to do something about China's unfair trade practices that have been slowly strangling American manufacturing. Had this been done a decade ago, the medicine wouldn't be anywhere near as bad as it is now, but, as Mark and Pat both note, a levy at the water's edge helps in two ways. A tariff not only raises revenue for the government, but also protects domestic industry against unscrupulous foreign actors who care more for profits than the wellbeing of their own people.

While there is renewed hope for us here, we do have some bad news that needs to be addressed, and that is the slow death of real news in America today.

Earlier this month, *The Wall Street Journal* reported on a new study from Harvard that predicts by 2021 more than 50% of the remaining newspapers in the United States will go out of business. It's a huge story that has received almost no press, except for the *Journal* and a brief mention on the news and commentary

website Axios.com.

Among other things, when Harvard researchers analyzed print media in the U.S., they discovered that, between 2004 and 2018, around 1,800 newspapers closed, leaving 200 counties in the United States with no newspaper at all and about half the counties in the U.S. with only one. They found that mid-sized papers with circulations between 100,000 and 200,000 were hit the hardest, mostly because they couldn't keep up with rising publishing costs and declining print ads. Finally, they reported that mid-sized and smaller newspapers have faced a wave of consolidations like never before with companies like Gannett gobbling up everything in sight, leaving no independently owned newspapers in the U.S. anymore.

The bottom line is, as more and more Americans get their news from large corporations and the Internet, independent print publications are being pushed out. We do have to say that we're not sorry to see many big publications that have been lying to their readers for years close their doors, but the conclusions of the study will impact regular Americans unless something is done.

It's worth noting that we at AMERICAN FREE PRESS have not been immune to this trend. We have been able to avoid taking on debt and have run as tight a ship as possible, making tough decisions to ensure we can keep delivering the news. Nonetheless, we're facing three problems: The number of dedicated print readers is declining, the cost of doing business is going up, and most people on the Internet these days want everything for free.

It doesn't make it any easier that the entire financial establishment has been weaponized against conservative viewpoints today. Regu-

lar readers are aware of our struggles with credit card processing and how we were blacklisted by Wells Fargo two years ago simply because of our reporting. That still haunts us to this day.

To make matters worse, it has become so expensive bringing in new subscribers, that, unless we had millions of dollars to throw at the problem, we will never see the numbers we want to see.


These are all big problems, but they are by no means insurmountable.

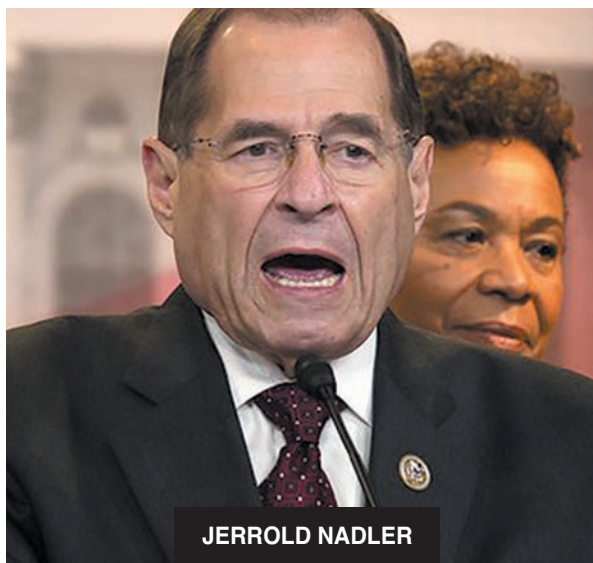

# News You May Have Missed

## Playing Politics

Liberal activists and some Democrats have been whining that they need to see the unredacted report on allegations that the Trump campaign colluded with Russia that was produced by special counsel Robert Mueller. The truth is, key Democrats are lying, as they have, for the most part, already seen it. The version of the Mueller report provided to select members of Congress is almost entirely unredacted, according to the Justice Department (DOJ), and the portions that are redacted—such as grand

jury testimony—are confidential by law. The Justice Department noted this in a letter that was sent to Rep. Jerry Nadler (D-N.Y.), who chairs the House Judiciary Committee. Needless to say, the mainstream media failed to report this. According to the DOJ, only 1.5%—about seven pages—of the version of the Mueller report made available to Nadler and other congressional leaders is redacted.

## Far to the Left

Do you ever feel like something has changed in the past few years in terms of politics, but you can't quite put your finger on it? Polling firm Pew Research Center nailed down this feeling with a new study that shows Democrats in the past few decades have moved to the extreme left while most Republicans have shifted only slightly. "In rural America today, farmers can't even repair their own tractors or other equipment because of the greed of companies like John Deere," his plan notes. "When we are in the White House, we will pass a national right-to-repair law that gives every farmer in America full rights over the machinery they buy."

## Intelligence of a Sea Sponge?

Remember how Rep. Alexandria Ocasio-Cortez (D-N.Y.) introduced Green New Deal legislation that called for killing fossil fuels and driving up prices of energy for regular people so much so that only the rich would be able to afford to travel or eat? Well, guess what? Her dire predictions about the world ending in 12 years were, apparently, just a joke. On May 12, Cortez posted to Twitter, "This is a technique of the GOP, to take dry humor and sarcasm literally and 'fact check' it. Like the 'world ending in 12 years' thing, you'd have to have the social intelligence of a sea sponge to think it's literal."

## Far Left Insanity

According to multiple reports, the University of Georgia will likely expel a teaching assistant and graduate student, whose comments on the Internet went viral earlier this year after saying that "some white people might have to die" in order to achieve racial justice, among other racially charged statements. According to *The Atlanta Journal-Constitution*, the school is claiming that they are more concerned that Irami Osei-Frimpong lied on his admissions form by purposefully omitting a 2011 trespassing arrest. Whatever the university decides to do, it should surprise no one that, despite his history of violent comments, Osei-Frimpong has not been banned from social media.

## More Far-Left Insanity

On April 18, self-proclaimed "fat sex therapist" Sonalee Rashatwar gave a talk at St. Olaf College in Minnesota (average tuition per year: \$44,180) on the topic of "radical fat liberation." Here are some excerpts from her speech: "Tonight we're gonna start by talking about how to politicize our definition of body image, because oftentimes we actually get stuck thinking of it from a white supremacist lens. . . . We should be critical of the use of science and the production of knowledge to continue promoting this idea that certain bodies are fit, able, and desirable. . . . Is it my fatness that causes my high blood pressure, or is it my experience of weight stigma?" She ended her speech by concluding, "I do not think it's surprising that the man who shot up Christchurch, New Zealand was also a fitness instructor." After making this claim, she added that the shooting is "a clear communication that there's still an idealized body. Nazis really love this idea of an idealized body, and so it makes a lot of sense to me that a fitness instructor. . . might also think about an idealized body in this thin white supremacist way."

## Oops . . . They Forgot to Mention

According to local press reports, the young student who allegedly shot up a Colorado school recently was the transgender, liberal, anti-Christian daughter of an illegal immigrant. Sixteen-year-old Maya "Alec" McKinney's father is also a felon, who has been charged with domestic abuse. McKinney was identified as one of two suspects in the STEM Highlands Ranch shooting, which left one dead and eight wounded. Her father once served over a year in jail after being convicted of domestic violence against McKinney's mother and was arrested multiple times in Colorado between 2008 and 2017.

## Here Come the Robots

Looks like the construction industry will soon be facing an influx of robots that could very soon replace humans. In a new report, titled "Construction & Demolition Robotics," market research firm Tractica announced 7,000 construction robots are expected to be deployed in the next year as robotic assistants used on construction sites, as well as infrastructure robots, structure robots, and finishing robots. As a result of rising demand, the company said revenue for robot makers in this field will be up from \$22.7 million in 2018 to the \$226 million figure by 2025.

# Several States Fight Online Censorship

• President Trump concerned by recent mass bannings of conservative voices

The recent de-platforming of conservative commentators Alex Jones and Laura Loomer, minister Louis Farakhan, and others illustrates how serious the authoritarian clampdown on free speech is becoming. The fact that so much of the public seems to support this blatant censorship is even more troubling.

President Donald Trump took to Twitter recently, to say, “I am continuing to monitor the censorship of American citizens on social media platforms. This is the United States of America—and we have what’s known as freedom of speech! We are monitoring and watching, closely!”

Trump specifically mentioned Paul Joseph Watson, who was kicked off of Facebook, and actor James Woods, who was banned from Twitter.

Evidently, Trump’s recent White House meeting with Twitter CEO Jack Dorsey, where they discussed censorship of conservatives and others on social media, had little impact.

*The New York Times* continued its proud tradition of opposing a free exchange of ideas with a May 6 article headlined, “Trump is Confused About Social Media. He’s Not Alone.” The article informed its dwindling readership that “The First Amendment doesn’t say you can tweet whatever you want.” Leaving aside the fact that neither Twitter nor even the concept of instantaneous global electronic communication existed at the time the Constitution was written, it should be noted that the phrase “hate speech” doesn’t appear anywhere in the document. The article spewed out the typical slurs about “loudmouths and bullies” not having any right to spew their

inate based on content.”

All of the big social media platforms have been blatantly biased and inconsistent in how punishment and bans are meted out. While James Woods, for instance, has been banned by Twitter, fellow actor Peter Fonda, who tweeted last year that Trump’s 10-year-old son Barron should be put into a cage with pedophiles, something far more offensive than anything Woods has ever posted, remains a member in good standing. While most of the “liberal” establishment has applauded the de-platforming of Jones and other right-leaning sources, both NPR and the ACLU strongly opposed it. The ACLU called the latest bans “an authoritarian power move.”

Facebook referred to Jones, conservative commentator Milo Yiannopoulos, and others recently de-platformed as “dangerous individuals” who were promulgating “hate speech.” At the exact moment Mark Zuckerberg’s company was bringing the hammer down on “hate,” the Occupy Democrats Facebook page was allowed to post a “joke” about Sarah Huckabee Sanders telling Trump that she’d “had a dream that you finally got the parade you’ve wanted,” with “millions of people lining the streets waving and cheering as you passed by in a large, black limo.” When Trump asks, “Was I smiling?” Sanders replies, “I don’t know, sir, the lid on the casket was closed.” The post, which accrued 37,000 likes and 17,000

thoughts to potentially millions of people.

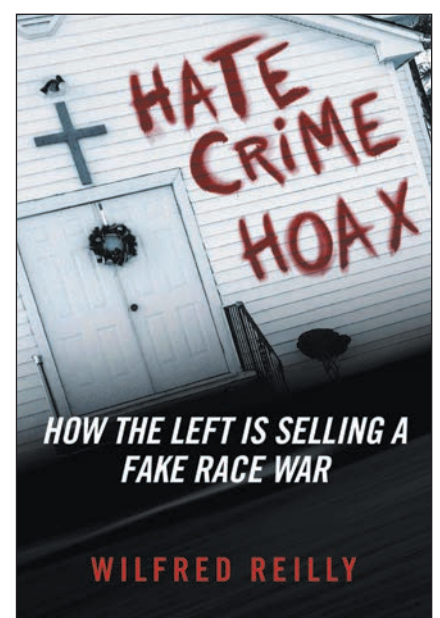
Not everyone is taking all this sitting down, nor satisfied with Trump’s “monitoring” things at Twitter. The Texas Senate recently passed a bill that would prevent social media platforms like Facebook, YouTube, and Twitter from censoring users based on their views.

Deep State apologists cite a federal law that permits social media platforms to control and regulate their own content. Republican Sen. Bryan Hughes, the sponsor of the bill that is now headed to the Texas House, declared, “Senate Bill 2373 tries to prevent those companies that control these new public spaces, this new public square, from picking winners and losers based on content. . . . If the company represents, ‘We’re an open forum and we don’t discriminate based on content,’ then they shouldn’t be able to discrim-

shares, remained up on Facebook, apparently not guilty of violating their policy against “hate” or “objectionable material.” The previous month, on the other hand, Facebook-owned Instagram had deleted a photo of Donald Trump Jr. with U.S. Army veteran Omar Avila for an unspecified “violation.” Avila was understandably baffled, stating, “Again, I don’t know why; it had nothing on it that was political or that said anything derogatory.”

Facebook has dug in its heels and is clearly committed to an establishment “left,” social justice warrior agenda. The social media giant has recently blocked objective information about abortion from the American Pregnancy Association’s website.

YouTube, which is owned by Alphabet Inc., the parent company of Google, has cracked down aggressively on “conspiracy theory” videos, which in reality means anything questioning the establishment and their unconvincing official narratives. Almost every leading alternative media figure has reported being demonetized, censored, or banned on YouTube since this campaign began in earnest. They also manipulate their algorithms, in order to suppress “conspiracy-friendly” videos from online search results and suggested items.

Facebook is now banning any mention of Alex Jones’s Infowars unless it is negative in connotation.

But there is some hope on the horizon. In addition to the bill in Texas, Republicans in Florida and Rhode Island have introduced the Stop Social Media Censorship Act.

Without a free exchange of ideas, we don’t have a free country. ★

# Patriot Activists Unite to Kill Plan to Privatize Public Roads in Texas

**T**exas House Bill (H.B.) 1951 was just defeated, due to the hard work of the vigilant citizens who comprise Texans United for Reform and Freedom (TURF) and other activist groups.

With its defeat, a monstrous bullet was dodged, although other efforts by the Spanish infrastructure company Cintra, among other global interests, to engineer toll deals with politicians are making commuting in the greater Dallas area, for example, prohibitively expensive.

H.B. 1951 was unique, in that “it would have opened the door to public-private partnership toll road deals, two per year, forever,” Terri Hall, a longtime activist and TURF leader who opposes the tolling and privatization of the state’s public highways, told AFP May 14. “There was no expiration date. This would literally have handed the Texas highway system over to global companies.”

The contracts for such deals are often called Comprehensive Development Agreements, she said, adding: “At the end of the day, these [CDAs] are part and parcel of the Trans-Texas Corridor; it’s eminent domain [land acquisition

by government for public use] to hand over our public arteries for daily living to foreign entities that couldn’t care less about Texas.”

She continued: “Literally within a day or two of us defeating that bill, the Fort Worth Star Telegram had a major article about the complaints people are having in the Dallas-Fort Worth area, on one of the projects that Cintra gained back when Rick Perry was governor of Texas, and [motorists] are literally paying \$15 to go five miles. Anytime you give taxation over to a private corporation that we can’t hold accountable, this is what’s going to happen.”

How expensive can it get? KXAN News of Austin reported last August that area resident Mela Louviere received a toll bill showing she owed \$5,750 in administrative fees for only \$412.85 in toll usage.

“Louviere isn’t alone,” KXAN noted. “This year [2018] more than 2.2 million Texas toll accounts had a bill sent to the [law firm] Perdue Brandon Fielder Collins & Mott, who added nearly \$1 billion in fees to drivers’ accounts.”

Others have been told they owe in excess of \$20,000. And some drivers have had their cars impounded, meaning that these tolls—where private entities wield government taxation power under 50-year toll road contracts—are even becoming confiscatory. ★

# ‘White Rights’ Get Radio Host Fired

• Georgia “Peach” gets boot after acknowledging “white genocide” is for real

In yet another indication that political correctness is stifling free speech and the First Amendment in America, an outspoken conservative local talk radio host was terminated recently as a direct result of her controversial political views.

Georgia “Peach” was one of the most popular hosts on KSCO, a local conservative-leaning AM radio station headquartered in Santa Cruz, Calif., one of the most liberal cities in one of the most liberal states in America. Georgia, who had hosted a live two-hour open-phones program twice per week on KSCO for years, was recently fired by the station owner. Georgia was known for her politically incorrect views and passionate defense of whites in America and around the world, who she views as under attack culturally and demographically.

“My firing had all to do with my speaking up for white Europeans,” Georgia explained to this reporter in a recent interview. “The minute that started, I became a target.”

Georgia highlighted some of the issues she was most concerned with during the interview.

“The issues I am most passionate about are my pride in what our people have created, not just for America, but for Western Civilization,” Georgia stated. “I want us to have the right to continue to exist. I am deeply concerned about our losing our civil rights. Whites no longer have civil rights in their own homeland. We no longer have a homeland of our own. We have a two-tiered justice system—one for us and one for non-whites. I am passionate about preserving our history. I am passionate about setting the record straight about our history.”

Georgia also became increasingly focused on what she describes as white genocide, a topic she elaborated on during the interview with this re-

porter. “White genocide is very real,” she noted. “When I first used those words on AM radio, people were shocked and confused. I spoke about the Kalergi Plan. I explained about the slow ethno-cleansing of our people, which would lead to the genocide of us. People started to catch on and get it. They started using those words, which meant my message was effective.”

Georgia had always been a conservative-leaning presenter on KSCO, which features local broadcasters from the Santa Cruz area with a wide range of political views and interests, along with more mainstream nationally syndicated talk show hosts, such as Rush Limbaugh and George Noory, who hosts the popular Coast to Coast program focusing on paranormal activity and other controversial topics.

Over time, however, Georgia became more fo-

cused on what she describes as white genocide and the systematic discrimination against white Americans, and she was not afraid to speak out in opposition to it. As she gained more and more popularity—and notoriety in her critic’s eyes—she became a target of radical left-wing journalists and antifa activists, ultimately resulting in her recent termination by station management.

“The official explanation was they wanted to go in a different direction—in other words, no real talk radio, but moderate pabulum talk to keep everyone dumbed-down and asleep,” Georgia explained. “As long as I stayed on mainstream conservative talking points, without touching the real issues behind the destruction of our country, of our people, I was okay. There were no complaints or attacks. However, as I became more and more vocal, my audience began to grow, and

I explained about the slow ethno-cleansing of our people, which would lead to the genocide of us.

they began to speak up. I had given them a safe platform to do so. That is when the witch hunt and the agenda to find a way to get rid of their most popular show on KSCO began.”

Local journalists began targeting her for focusing on the topic of white genocide and other racial issues, which she became increasingly passionate about.

“There were all kinds of attacks, campaigns, petitions to pressure the station to fire me,” Georgia said. “It was ongoing with many newspaper articles. It was an all-out attack with only one purpose, which was to silence me.”

Ultimately, the pressure proved to be successful, and Georgia is no longer with the station, although she was one of the most popular hosts on the entire network. Her show host page on the KSCO website was removed along with all of her archived programs. She had even helped the station raise money to fund the network, only to be fired after having successfully raised roughly \$8,000, according to Georgia.

“The owner of the station did an editorial asking people to donate to my show,” Georgia noted. “He took the money and killed my show.”

Despite the setbacks, Georgia is determined to continue speaking out on these and other controversial topics. She recently appeared as a guest on “The Jeff Rense Program,” one of the most popular and longest running alternative media programs in America. No doubt Georgia will be back on the air soon, more focused and determined than ever. “As for my future, who knows?” Georgia concluded. “One door closes, another one opens.” ★

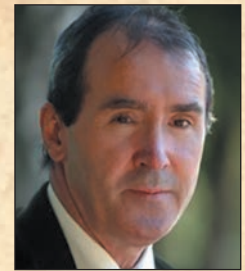

# Smear'd Teen's Legal Team Adds NBC to Massive Lawsuit

**L**awyers for Nicholas Sandmann, the courageous Covington, Ky. teenager who was smear'd so unfairly a few months back by mainstream media and reckless celebrities, have filed another lawsuit. In early May, Sandmann's attorneys sued NBC/Universal and MSNBC for \$275 million. "Washington Post, CNN, and now NBC/MSNBC. The journey for justice for Nicholas Sandmann and for media accountability continues," lead attorney L. Lin Wood tweeted. "More to follow. False accusers should not rest easy."

In addition to filing earlier lawsuits against *The Washington Post* and CNN, Sandmann's legal team has sent out dozens of letters to national media outlets and public figures, requesting that evidence such as internal emails be preserved for their potential value.

"In short, the false and defamatory gist of NBCUniversal's collective reporting conveyed to its viewers and readers that Nicholas was the face of an unruly hate mob of hundreds of white racist high school students who physically assaulted, harassed, and taunted two different minority groups engaged in peaceful demonstrations, preaching, song, and prayer," a complaint provided to the press by Sandmann's attorneys stated. Wood's associate, attorney Todd McMurtry, tweeted "The facts of the suit show the anti-Trump narrative NBC pushed so hard."

Attorneys for Nicholas Sandmann have added the National Broadcasting Company to his \$275 million lawsuit against those media outlets who smear'd him and his family. More media outlets will be added, says Sandmann's legal team.

"NBCUniversal created a false narrative by portraying the 'confrontation' as a 'hate crime' committed by Nicholas," the newest lawsuit reads, and refers to Sandmann as "an easy target for NBCUniversal to advance its anti-Trump agenda because he was a 16-year-old white, Catholic student who had attended the Right to Life March that day and was wearing a MAGA cap at the time of the incident, which he had purchased earlier in the day as a souvenir."

McMurtry has hinted that the Associated Press and HBO could be the next to be sued.

Last month, *The Washington Post* filed to dismiss the Sandmanns' \$250 million lawsuit lodged against them. CNN was hardly contrite in its re-

ism,' and demanding \$250 million in damages—a number chosen, the complaint explains, because it is the price Jeff Bezos paid for the *Post* in 2013? The inflammatory rhetoric of the Complaint . . . suggests one motive: to strike a blow against the *Post's* allegedly 'biased agenda against President Donald J. Trump.' "

The new lawsuit against NBC continues: "NBCUniversal's attacks on Nicholas included at least fifteen (15) defamatory television broadcasts, six (6) defamatory online articles, and many tweets falsely accusing Nicholas and his Covington Catholic High School ('CovCath') classmates of racist acts. NBCUniversal continued to promote its false narrative that Nicholas had instigated a racist confrontation with Phillips long after Phillips was exposed as a fraud whose version of events was not entitled to any credibility by responsible members of the media."

The lawsuit adds: "Between Jan. 19 and Jan. 27, NBCUniversal unleashed its vast corporate wealth, influence, and power against Nicholas to falsely attack him despite the fact that, at the time, he was a 16-year-old high-school student. Throughout its coverage, NBCUniversal refused to admit the truth that incontrovertible video evidence established that Nicholas, a minor child, did nothing wrong and was instead the victim of two separate groups of adult political activists before becoming the victim of NBCUniversal and the mainstream media."

NBC recently promoted this demonstrably false narrative again, on an episode of "Law & Order: Special Victims Unit," casting some Covington-style teens as bad guys, and a politician clearly based on Rep. Ilhan Omar (D-Minn.) in a heroic role.

These lawsuits come at an especially germane moment, given the alarming increase in online censorship, especially on social media. If Sandmann is able to win under our legal system, it would strike a powerful blow against the irresponsible propaganda being issued incessantly by virtually every organ in the mainstream media, as well as its clueless sycophants in the celebrity world. ★

sponse to being sued.

Attorney Lin Wood tweeted, "CNN does not apologize to Nicholas Sandmann, does not acknowledge its violations of journalistic standards, does not admit its sources lied, and does not acknowledge its bias. Much more is required to begin to right the wrong."

In one of its first stories about the incident, *The Washington Post* quoted native American Nathan Phillips as saying that he felt "threatened by the teens," that they "swarmed around him," and one of them "blocked my way and wouldn't allow me to retreat." The paper stood by its coverage, and its lawyers stated, "Newspapers are often unable to publish a complete account of events when they first come to light. Stories often develop over time, as more witnesses emerge." Laughably, they went on to claim, "Indeed, the *Post's* overall coverage—including the articles that the complaint fails to mention—was not only accurate; it was ultimately favorable to him. Why . . . bring this lawsuit accusing the *Post* of engaging in 'a modern-day form of McCarthy-



# Crisis on Southern Border Getting Worse, Say Experts

• Border Patrol can't handle any more illegal immigrants

**D**ONNA, Texas—The U.S. Border Patrol now says that the newly built Donna, Texas “tent” facility, which is actually a semi-permanent structure south of that Hidalgo County town near the international bridge, has already exceeded its estimated 500-person capacity even though it was erected only one month ago.

If you read various newspapers from around the state and consult the Border Patrol, you find that, in this “non-crisis,” unauthorized border crossings have volcanically surged since 2019 began. The Border Patrol made 98,977 apprehensions for illegal border crossings in April, including 58,474 adults and children traveling together,—nearly 100,000 people overall.

In the Rio Grande Valley sector, the four-county border area about which AMERICAN FREE PRESS reported in-depth in our previous edition, the Border Patrol apprehends about 1,600 people daily. A year ago, arrests totaled one-third of that number on most days, and even that would be a rather high influx.

The Border Patrol, as of this writing, had gotten to the point where it has more than 8,000 illegal immigrants in detention in this busiest of border sectors. That is more than double the Border Patrol's current overall detention capacity in the 316-mile-wide sector, including the current Donna facility and at the Border Patrol's own stations.

Rodolfo Karisch, a Rio Grande Valley Border Patrol spokesman, stated that the agency's resources “are beyond a breaking point and has put border security at risk.”

As Border Patrol official Hector Escamilla stated at a McAllen speech covered in our previous edition, people from well over 40 nations, in-

cluding from the Middle East, Africa, Asia, and Eastern Europe, are storming the border, adding considerable guesswork, time, and expense in determining who is coming to the U.S. and why—right when the Rio Grande Valley sector's 3,100 Border Patrol agents constitute roughly half of the manpower needed to police the border in the current “non-crisis.”

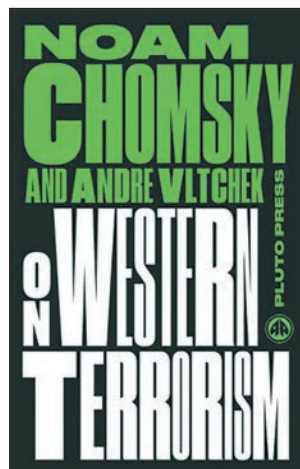
Yet all the media does is quote people like John-Michael Torres, a spokesman for the group La Unión Del Pueblo Entero, who told the *Texarkana Gazette* that when the first “tents” were erected in Donna, and 796 miles to the west in El Paso, Trump was merely “using children and other vulnerable people to manufacture a crisis at the southern border.”

“The president cannot detain away the real humanitarian need of parents seeking safe ground and a future for their children,” moaned Torres. The activist is evidently just as clueless or manipulative as the media, neglecting to consider the root causes of this real crisis, in order to face the reality that open borders augmented with catch-and-release policies incentivize drug and human traffickers to continue uprooting the people of Central American countries, leading to a breakdown of those nations and the depletion of the core of their labor forces over time. Simply put, driving everyone to the U.S. is not humanitarianism.

AFP readers would do well to call their state and federal representatives and tell them of the Border Patrol's announced goal of having some of its agents trained to process asylum claims right at the border to process people faster, reduce catch-and-release numbers, and speed up and increase deportations. From there, more immigration judges, much better border wall progress, and a far stricter policy in dealing with Mexico's apparent complicity in this crisis, all are sorely needed right away. ★

# Hillary Still Touting Debunked Russian Collusion Conspiracy

**T**wo-and-a-half years have passed and the Russiagate narrative now has the word “hoax” permanently affixed to it. The publishing world has to be wondering how many drink coasters can be made of the many Russiagate books that still line the shelves of bookstores. Still yet, despite an exorbitant array of facts stating otherwise, some things have not and will not change. Hillary Clinton still believes “Russia did it.”

Clinton recently appeared on MSNBC’s “The Rachel Maddow Show” to discuss all things political. One of the major themes of the conversation was that Clinton has warned the 2020 Democratic field of presidential candidates that they, too, will most likely be derailed by Russian interference.

The 9/11 Commission can historically stand beside the Warren Commission and the Senate Watergate Committee in the long line of failed government inquiries. If such a committee or commission would have investigated the Russiagate narrative, it would have simply obfuscated the important witnesses, links, and information in favor of maintaining a safe, simple, government-endorsed conclusion (e.g., Oswald acted alone, it was all Nixon, and those evil Arabs). At least independent investigators such as Robert Mueller, Lawrence Walsh (Iran-Contra), and Kenneth Starr (Whitewater) unearth some useful facts amidst their intentionally murky final reports. Clinton is grasping for straws at this point, hoping to find one morsel of a misdeed upon which she can hang her embarrassing loss.

In a segment of the interview that seemed somewhat unhinged, Clinton and Maddow both half-jokingly suggested that the Chinese should enter the election of 2020 on the side of the Democratic Party.

While both Clinton and Maddow played the Chinese suggestion as a parody of what they still see as absolute metaphysical certitude that the Russians are in bed with the GOP, ideas are sometimes birthed as whispers or chuckles. In truth, it would not be the first time international financiers backed leading Democrats in presi-



dential contests.

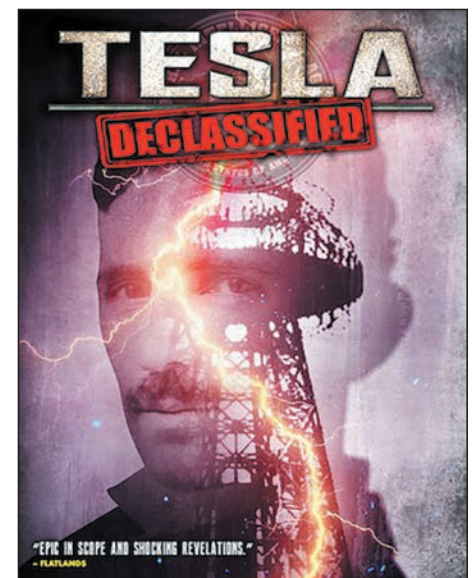
In 2001, James Riady, an Indonesian “Friend of Bill (Clinton),” plead to conspiracy charges which resulted from illegal campaign contributions in 1996. # Washington Resurrects Racial Quotas

• 73% of Americans oppose “blatantly racist” college admissions laws

Showing the usual disdain for those they supposedly represent, Washington state legislators have passed a measure that could take effect in one year. The new law proposes to repeal a ban on colleges considering race and ethnicity in the admissions process. The fierce opposition includes a new petition that states, “I-1000 [the measure passed by the legislature] can be summed up in one sentence: It would abolish the standard of equality for all, regardless of race, as required by I-200, and replace it with a system that uses different rules for people of different races.”

Ana Mari Cauce, president of the University of Washington, epitomizes the ironclad social justice warrior mindset evident in virtually all of our institutions of higher learning.

“I-200 puts the University of Washington at a competitive disadvantage when seeking to hire the best faculty and staff to lead our university,” she said. “It also hampers our ability to attract and enroll the strongest students from underrepresented backgrounds, who are so highly sought after by other universities because having a diverse student body creates a richer learning environment for all students.”

Cauce recently complained: “As one of our nation’s top research universities, we compete with institutions like Stanford, Texas, Wisconsin, and UNC Chapel Hill when trying to attract the most talented faculty to teach and lead cutting-edge research with our students. To those top faculty and staff that we wish to recruit, I-200 sends the message that the UW, and Washington state as a whole, does not welcome or value diversity, and when we lose out on attracting these desirable teachers, researchers, innovators, and administrators, it is our students and our state that pay the price.”

College Republicans at the University of Washington held a bake sale to protest the new measure, as they have done in the past over Affirmative Action in general. The group cleverly based the prices for their baked goods exclusively upon race, explaining, “Our bake sale prices are based

on affirmative action, which as of last week is a legal policy in the state of Washington. I-1000 allows for race to be a factor in college admissions. This is a policy that has historically discriminated against Asian-American students and blatantly allows the government to discriminate based on race. We are against this blatantly racist law, and we hope to see it repealed.”

Cauce, predictably enough, was not amused. While acknowledging that it was appropriate to have “difficult conversations about affirmative action,” she stated that the bake sale did not encourage such conversations. Again sounding more like a parody than a professional educator, Cauce went on to denigrate the bake sale, which “appears to mock not so much just a policy, but individuals who belong to racial, ethnic, and gender groups that have historically been marginalized and that have often experienced very real prejudice, discrimination, and oppression. Indeed, the way that the poster advertising this event juxtaposes race and price is reminiscent of a time when persons in some of these groups were literally bought and sold. Regardless of its intent, this sale humiliates and dehumanizes oth-

ers. It is no surprise that so many on our campus and in our community are deeply offended by it.”

This controversial new law comes at the same time that a lawsuit against Harvard University over Affirmative Action may be appealed to the Supreme Court. If that happens, it could have a huge impact on colleges nationwide. Eight states, including Washington state, have banned the consideration of race in university admissions, and the Supreme Court outlawed strict racial quotas in 1978. However, a large number of colleges circumvent this with what they’ve dubbed “racial preferences.” In a March 2019 Pew poll, some 73% of Americans said that race or ethnicity should not be a factor in college admissions. This included solid majorities among all racial groups, including blacks and Hispanics. Even a majority of Democrats opposed such race-based factors.

Edward Blum, the primary organizer behind the lawsuit against Harvard, wasn’t surprised by the Pew poll results. He declared that his view remained unchanged from what he said in response to the last poll, which showed a slightly smaller but still solid majority opposed to race-based admissions: “Racial classifications and preferences are deeply unpopular with a significant majority of all Americans. It is to be hoped that the courts will soon end these divisive and unfair practices.”

Such race-based policies, whether they are called Affirmative Action, quotas, or racial preferences, fly in the face of the kind of meritocracy Thomas Jefferson once dreamed of. Carried to its logical extreme, identity politics will not be satisfied until transgenders of all kinds and those “identifying” as animals or perhaps inanimate objects are granted “equal access” to everything our society has to offer. ★

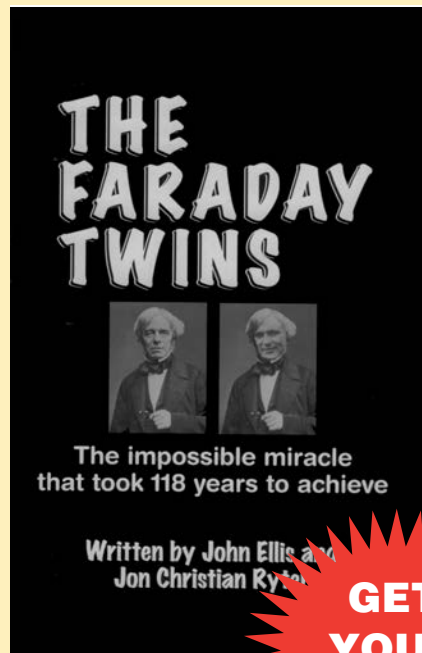

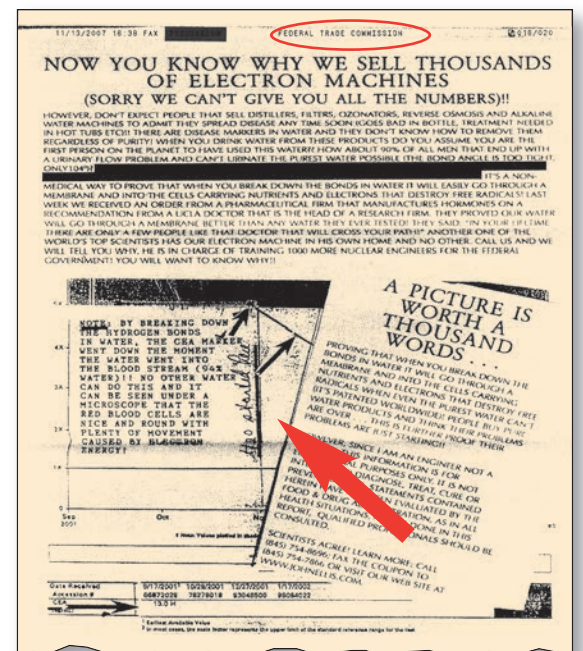

# Finally a President With the Guts to Take on Unfair China Trade

By Mark Anderson

What the big-box media calls a “trade war” between the U.S. and China is, in reality, hard-nosed but vitally necessary negotiations in which the Trump administration is showing some fortitude in pursuing long-overdue adjustments to begin reducing China’s notoriously lopsided, long-term trade surplus with the U.S.

President Donald Trump’s key tool in this process is the application of tariffs against Chinese imports over the last few months—largely for the purpose of improving America’s industrial sector by spurring domestic production.

Tariffs, while they’re not a cure-all across the board, serve an important dual function—to bring about an increase in tax revenue at the water’s edge to help the U.S. balance its books and resist the urge to raise domestic taxes, and to protect the economy from excessive Chinese imports and thereby spur an increase in domestic production. This production boost would translate into more buying power to purchase the productive output amid a gradually reduced reliance on imports.

But this upside to tariffs gets lost in the reports issued by a mass media cartel that puts undermining Trump ahead of all else. Helping set the record straight, the non-partisan Coalition for a Prosperous America (CPA) announced May 9 that

a Department of Commerce report showed “that the monthly U.S. goods deficit with China fell to just \$20.7 billion in March. That’s the smallest monthly deficit with China since March 2014.”

“In the face of continuing pressure from multinational interests and the import lobby, President Trump has stayed the course on China tariffs,” CPA Chairman Dan DiMicco remarked. “To the president’s credit, the tariffs are working. America’s manufacturers and workers are now seeing gains as manufacturing employment rises and China’s hold on the U.S. market shrinks.”

Michael Stumo, CEO of the CPA, added: “This is exactly what we were hoping to see when the president applied tariffs [to aid] important industries that have been facing heavily subsidized competition from China’s state-owned enterprises. We expect the next round of tariffs to have a positive effect to improve the U.S. economy and address Beijing’s continuing economic aggression.”

CPA Chief Economist Jeff Ferry, having examined the new Commerce Department data, found that the improvement in America’s goods deficit with China “has come largely through a reduction in imports.”

He added: “While U.S. exports to China were \$10.4 billion in March [2019]—a figure \$1.9 billion lower than in March 2018—total imports reached only \$31.2 billion, a full \$7 billion less than the March total for 2018,” which was the lowest monthly China import level in five years. Furthermore, while 2018 imports from China averaged \$44.9 billion a month, so far in 2019 they’re averaging just \$35 billion—and are falling each month, according to the CPA.

“The United States economy continued to thrive in April,” the White House announced, “with the unemployment rate dropping to 3.6%—the lowest unemployment rate since December 1969, according to the Bureau of Labor Statistics’ (BLS) household survey. April also marks the 14th con-

secutive month of the unemployment rate being at or below 4%. The U-6 unemployment rate, a broader measure of unemployment that includes those who are unemployed, marginally attached to the labor force, and working part-time . . . remained at 7.3% in April, matching the lowest U-6 rate since December 2000.”

While the White House concedes that recent job gains “were predominantly concentrated in professional and business services (76,000 new jobs), education and health services (62,000 new jobs), and leisure and hospitality (34,000 new jobs),” and while “the construction sector added 33,000 new jobs in April and has added 669,000 jobs since the 2016 election,” it’ll be interesting to see what happens when tariffs to limit Chinese imports and produce more goods domestically sink in and have time to adjust the economic dials. ★

# Tariffs: The Taxes That Made America Great

- Before globalism became law of the land, tariffs protected, enriched the American people

As his limo carried him to work at the White House Monday, Larry Kudlow could not have been pleased with the headline in *The Washington Post*: “Kudlow Contradicts Trump on Tariffs.” The story began: “National Economic Council Director Lawrence Kudlow acknowledged Sunday that American consumers end up paying for the administration’s tariffs on Chinese imports, contradicting President Trump’s repeated inaccurate claim that the Chinese foot the bill.”

A free-trade evangelical, Kudlow had conceded on “Fox News” that consumers pay the tariffs on products made abroad that they purchase here in the U.S. Yet that is by no means the whole story.

A tariff may be described as a sales or consumption tax the consumer pays, but tariffs are also a discretionary and an optional tax. If you choose not to purchase Chinese goods and instead buy comparable goods made in other nations or the USA, then you do not pay the tariff.

China loses the sale. This is why Beijing, which runs \$350 billion to \$400 billion in annual trade surpluses at our expense, is howling loudest. Should Donald Trump impose that 25% tariff on all \$500 billion in Chinese exports to the U.S., it would cripple China’s economy. Factories seeking assured access to the U.S. market would flee in panic from the Middle Kingdom.

Tariffs were the taxes that made America great. They were the taxes relied upon by the first and greatest of our early statesmen, before the coming of the globalists Woodrow Wilson and FDR.

Tariffs, to protect manufacturers and jobs, were the Republican Party’s path to power and prosperity in the 19th and 20th centuries, before the rise of the Rockefeller Eastern liberal establishment and its embrace of the British-bred heresy of unfettered free trade.

The Tariff Act of 1789 was enacted with the declared purpose, “the encouragement and protection of manufactures.” It was the second act passed by the first Congress led by Speaker James Madison. It was crafted by Alexander Hamilton and signed by President George Washington.

After the War of 1812, President Madison, backed by Henry Clay, John Calhoun, and ex-Presidents Thomas Jefferson and John Adams, enacted the Tariff of 1816 to price British textiles out of competition so that Americans would build the new factories and capture the booming U.S. market. It worked.

Tariffs financed Abraham Lincoln’s war. The Tariff of 1890 bears the name of Ohio Rep. and future President William McKinley, who said that a foreign manufacturer “has no right or claim to equality with our own. . . . He pays no taxes. He

that used by U.S. colleges and universities that charge foreign students higher tuition than their American counterparts.

What patriot would consign the economic independence of his country to the “invisible hand” of Adam Smith in a system crafted by intellectuals whose allegiance is to an ideology, not a people?

What great nation did free traders ever build?

Free trade is the policy of fading and failing powers, past their prime. In the half-century following passage of the Corn Laws, the British showed the folly of free trade.

They began the second half of the 19th century with an economy twice that of the U.S. and ended it with an economy half of ours, and equaled by a Germany, which had, under Bismarck, adopted what was known as the American system.

Of the nations that have risen to economic preeminence in recent centuries—the British before 1850, the United States between 1789 and 1914, post-war Japan, China in recent decades—how many did so through free trade? None. All practiced economic nationalism.

The problem for President Donald Trump?

Once a nation is hooked on the cheap goods that are the narcotic free trade provides, it is rarely able to break free. The loss of its economic independence is followed by the loss of its political independence, the loss of its greatness, and, ultimately, the loss of its national identity.

Brexit was the strangled cry of a British people that had lost its independence and desperately wanted it back. ★

performs no civil duties.”

That is economic patriotism, putting America and Americans first.

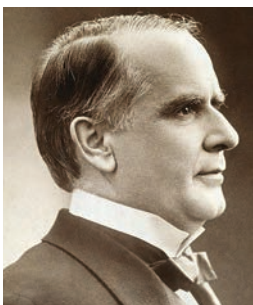

# Arpaio Still Swinging

## • 57-year veteran lawman has choice words for leftists, FBI

**On May 8, AMERICAN FREE PRESS writer Dave Gahary had the rare opportunity to catch up with former Arizona Sheriff Joe Arpaio to discuss, among other things, his run for Maricopa County sheriff, his support for President Donald Trump, the smear campaign that targeted him, and his belief that the FBI spied on the former lawman as he campaigned around the Copper State. Here is Sheriff Joe in his own words.**

**AFP:** It's great to talk to you, Sheriff. Let's start at the beginning. Can you tell us about yourself, for those who don't know you already?

**Sheriff Joe:** I was born on Flag Day, June 14, same day as President Trump. Not the same year, 1932, so you can figure out that I'm a senior citizen [chuckles]. I was born in Springfield, Mass. My mother gave her life for me. She refused an abortion and died in childbirth. So I bounced around from one Italian family to another. My mother and father came from Italy, legally, and I worked in the grocery store. I played all the sports in high school. I joined the U.S. Army when the Korean War broke out and I turned 18 and I graduated from high school, all within one month. I did my three years and came home. I always wanted to be a cop. I went to Vegas for a short time as a police officer. I actually locked up Elvis Presley, since I took him to the police station. But I did let him go.

Then I started my other big career—it was the DEA: federal Drug Enforcement Administration. In 1957, I was sworn in, in Chicago, and was involved in a lot of investigations and a lot of arrests. So they sent me to Turkey, the only agent in that area to stop the French Connection and all the drugs that were being run out of there.

I then went to San Antonio. I held a lot of top positions, especially [related to work in and around] Mexico, South America, Central America, Turkey, the Middle East, and also Texas and Arizona, fighting the drug problem.

So when you add up my 57 years in law enforcement, you'd have to say I have 35 years as a high official or a top official with the DEA in Mexico, on that side of the border, where I lived, and also on this side. I retired in 1982 as head of the DEA in Arizona, joined my wife in the travel business, and then I decided to run for sheriff in 1992. And I guess the rest is history.

**AFP:** Can you talk a bit about your time as a sheriff in Arizona?

**Sheriff Joe:** For 24 years I was a sheriff, which is the longest-serving sheriff in the history of Maricopa County, which I'm pretty proud of because I've been able to survive 24 years. Sometimes I wonder how I did it. I was re-elected six times. I lost the election in 2016. I just could not win the battles for the contempt of court charges, where the courts went after me. Pres-

ident Donald Trump pardoned me on that charge, which nobody even really knew what it was about. Now I find out it's not even a crime.

I didn't survive the smear campaign, because you may recall that [President Barack] Obama's prosecutors in the contempt of court trial said they were going to get me for contempt of court and [they] wanted me to do six months in prison. They were saying that when the people were voting. Then I had [George] Soros come after me with that law firm Perkins Coie. [Soros] pumped \$3 million into the general election, and I'm still wondering—a lot of people are wondering—how I lost to a liberal police sergeant. [Now we know.]

**AFP:** What can you tell us about your time with the president?

**Sheriff Joe:** I was with President Trump from day one, when I introduced him in July at his first rally, here in Phoenix. I was the only one who would stand next to him. I introduced him and made a few predictions. I said he would be our next president, and I was right. So, I have a lot of respect for our president. I do know that NBC asked me last year if John McCain was my hero. I paused and I said, "No." I woke up one morning, about four months prior to my declaration, and I said, "I finally found a hero," after all my [86] years in life, everywhere in the world, and that was President Trump. I'm proud of that. I don't back down. I'm not a flip-flopper that will say I am now President Trump's ally because he was doing good in the polls. I've been with him from day one, and I'll be with him till the end. I don't care if people like it or not.

I'm 86 years old. I work 14 hours a day. What's really tough . . . [is that] nobody knows my background. I could never, never get it out. They only know me as the sheriff, but I have a lot of interesting experiences fighting drug trafficking around the world. They called me a racist. I'm suing *The New York Times* about [that] situation. But I am also suing CNN, *The Huffington Post* and *Rolling Stone*, for calling me a convicted criminal. So they're gonna have a little problem with me. Those are the same people going after President Trump.

**AFP:** What can you tell us about your work on Barack Obama's purported birth certificate?

**Sheriff Joe:** I went after Obama on his birth certificate, and, being in law enforcement all

those years, I'm not stupid [about the law]. I agreed to launch that investigation because the tea party came to me in 2011 and said, "You're an elected sheriff. You're the only one who will touch it." And they won't touch it. Nobody in the universe will even look at my investigation. I'm a law-enforcement guy, and I [discover] probable cause on a fake government document, and all they do is blast me and say that I'm crazy. So that makes me a little frustrated. But I'm not giving up on that. Maybe somebody will look at what we have. But I'm convinced, 100% [that the birth certificate in a compiled phony], and I have the evidence of forensic people that I had to go to Italy to find, plus all the rest from our investigation.

Someone has to answer the question: Why doesn't any law enforcement agency—it really should be federal—look into what we have on a person who has a fake government document that happens to be a birth certificate? So that's a question that I will never forget. I'll go to my grave and always wonder why nobody will look at the evidence we have.

When I launched this, I went public and I said I don't care where Obama was born. I don't care about anything regarding that. I'm going after a person who has a fake birth certificate. That's it. And if it was you, you'd be in jail tomorrow. Is that fair?

I just talked to three Republican groups around the country. They all loved the fight against the birth certificate, but politically you're not supposed to talk about it. Why not? Is Obama someone special?

Just before I left office, we got a lucky hit, and we found a birth certificate [that was issued at the] same time as Obama was born. And it was very simple: They took parts of that birth certificate and transplanted it on this phony one. My Italian forensics experts showed that.

The irony of all this, if I'm still living in 10 years from now—which I probably won't be—is the fact that I'm the guy with the reputation of being the top guy fighting illegal immigration. We arrested more illegals than anybody. Now, the irony would be if [former President Obama] was here illegally—that's an immigration issue. I never talked about him being here illegally or from somewhere else. I said I'm investigating a fake Hawaiian government official document. And I can't get anywhere with this. If it wasn't him, I'm sure somebody would come to me and investigate it.

**AFP:** Can you talk about how the media has portrayed you in the past few years?

**Sheriff Joe:** They call me a racist—everybody in the media, every day. [But] even the judge who went after me never said that I racially profiled. He said that I used race as a

At the same time, the mainstream media launched a vicious smear campaign against him, undermining his support.

[criterion]. When I signed the contract with the ICE [Immigration and Customs Enforcement] director, that was one of their criteria, that you could use race. So they got me on that, on the contempt of court, that I didn't obey the judge.

That's one reason I don't get on TV. You notice that Fox, in a whole year, has blocked me out? I've been on Fox for 24 years. Why don't they call me anymore? They put all these other guys on to talk about the border. I have more experience than all of them put together, on fighting drug trafficking and illegal immigration. I think they're afraid that I might talk about the birth certificate.

I don't care. I've got my Facebook with a million followers. I go through social media. I go through people like [AFP], your paper that has the guts to speak out. So, I have all the means to get my story across.

**AFP:** Recently you said the FBI was spying on you. Can you talk about that?

**Sheriff Joe:** Actually, I had this information last year and nobody printed it, and now I see what's happening here in Washington. This happened [to me] years ago. You talk about the FBI today, infiltrating the president and his campaign, and I'm saying, "Wait a minute. I remember when that happened to me."

I have information that two or three FBI agents found out that I was going to be mentioned in a candidate's forum at a police union hall. So two FBI agents go in there posing as journalists, of course, to get information about me. That's a no-no. First of all, you shouldn't be posing as reporters, and you should not be going into these forums to gather information on someone who's involved in politics.

Now, let me say this: [AFP] is the only one to call me about this, and I sent this information to 300 news outlets. In fact, I sent something like

this out last year. So why is this is not a story?

I sent a 26-page report to the former attorney general of the United States, asking for an investigation over this contempt of court and everything revolving around it. I heard back from them finally when [former Attorney General Jeff] Sessions left. They had sent it to their Office of Inspector General or somebody. Being an ex-federal guy, I'm a little disappointed that this type of situation is occurring. I do have a lot more sensitive information I'm not ready to talk about, and I think that may scare some people. But I don't care. I've had a lot of threats from [drug] cartels and that doesn't bother me. I've been around a long time. I don't go around making allegations unless I can back them up. I have the evidence that it happened.

**AFP:** Can you explain the contempt of court issue?

**Sheriff Joe:** Here I am, in my waning years, sitting at a criminal defense table . . . for six days, with a stacked deck, on a contempt of court charge, where the judge—they wouldn't even give me a jury trial—charged me with the wrong charge, over a contempt charge, because I was doing my job. I had the authority to do it under the feds, because I had 100 of my deputies sworn in, trained for six months as immigration officers. They went after me because I was very active. When I do something in my life, maybe I do it one step more than normal, but it's not illegal.

**AFP:** Can you elaborate on the presidential pardon you received?

**Sheriff Joe:** You know, another thing about the border—I'm not criticizing the president on his selections. I feel sorry for him, and I think he'll admit it, too: There's a lot of garbage out there. A lot of people say they like him. They like

him because they're making money. But where is their heart? There's a difference, being a bureaucrat. Another difference is, does it come from your heart? My support of him comes from my heart. It has nothing to do with a big position. I don't do anything to get a job. Now, if he ever calls me, I would probably have to help him out, because I love the guy, and if he needs me, I'll have to do it.

He pardoned me before I even went to court to be sentenced. But you know what? He did the right thing. I didn't ask for it, but he did the right thing. It had nothing to do with politics.

**AFP:** Would you like to see President Trump elected again?

**Sheriff Joe:** If we don't get the current president reelected, we're gonna be in deep trouble. We're in a little trouble now, but just think if the Democrats come back in, with all their stupid policies. You wouldn't mind if you got a really good guy, a patriot, that type of person, to run on the Democratic side, but we don't have that. We don't have that now, and if they win the election, this country is going to be in poor shape.

By the way, I love [how the president uses] Twitter. I hope he tweets forever and gets the word out his way. He's not afraid to speak out. He's maybe different, but, boy, he's the one we need today. When he gets reelected, I guarantee you he'll be a little different. He'll be tougher, when he's reelected. So we only have another, what, five-and-a-half years to straighten this country out.

**AFP:** You read the newspaper, AMERICAN FREE PRESS, right?

**Sheriff Joe:** Yeah, I love your paper.

**AFP:** And of course, like you, all the things they call us—racist, anti-Semitic—it's just how the left (and groups like the Southern Poverty Law Center) smears patriotic conservatives these days who have the courage to speak the truth about important topics.

Thanks for having the courage to speak with us, Sheriff. We hope we've helped you get the word out.

**Sheriff Joe:** Thank you. ★

# American People Need a 'Bailout'

• How come bankers get debt forgiveness but not students, farmers, and homeowners?

As schoolchildren, my friends and I were very interested in archaeology and ancient civilizations. We read all the available books. My best friend intended to become an archaeologist and to explore ancient ruins about which we imagined more than we actually knew.

As far as I can discern, these days no one in the general population has any thoughts of Sumer, Babylonia, Assyria or Ur. For the American young, the 1940s, not 2,500 B.C., is the ancient past.

A time so long ago that it predates the Old Testament by 2,000 years is probably imagined as a brutal and politically incorrect time of inhumanity and human sacrifice—in short, a script for a horror fantasy movie or a video game. In actual fact, these civilizations were more advanced and more humanitarian than our own. They were more advanced because the rulers were focused on ensuring the society's longevity by maintaining a livable balance between debtors and creditors. It has all been downhill ever since.

The rulers maintained social balance and, thereby, the life of the society by periodically cancelling debts. The rulers understood that compound interest resulted in debt growing faster than the economy. The consequence would be foreclosures on agricultural land, which

would shift riches and power into a small oligarchy of creditors. The ruler and the society would be deprived of a self-supporting population on the land, which provided tax revenues, soldiers for the military, and unpaid labor to maintain public infrastructure. Disaster would follow. A grasping oligarchy could overthrow the

In America, the only groups that receive such "bailouts" are corrupt bankers and financial institutions.

ruler or the dispossessed population could flee to a potential invader offering their military services in exchange for debt forgiveness.

To protect their societies from dissolution by unpayable debts, rulers periodically cancelled agrarian debts owed by the citizenry at large, but not mercantile debts among businessmen.

The reason for debt forgiveness was stability, not egalitarianism.

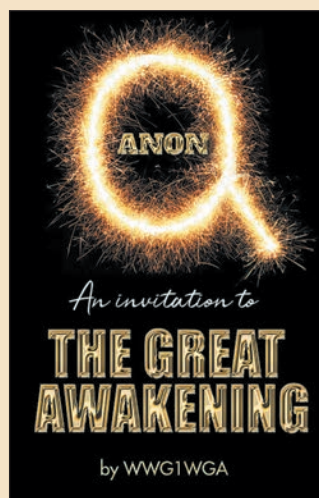
We know this fascinating story of the Bronze Age's successful economic policy because economist Michael Hudson spent 30 years as a research fellow at Harvard University's Peabody Museum working with scholars of the ancient world. government debt, and business debt—but policymakers have reserved forgiveness only for the debt associated with the bad and irresponsible investments of the big banks and financial institutions. The Federal Reserve printed \$4 trillion to buy up the banks’ bad debt while permitting 10 million homeowners to be foreclosed. Student loan debt prevents university graduates from forming independent households. Mortgage and credit card debt prevents households from having discretionary income with which to drive retail sales, but modern-day economics has no prescription for preventing our society from failing from debt overload.

America long ago lost its independent farmers to debt overload. All it took was a drought, or a dustbowl, or the Fed driving up interest rates on loans, and farmers were foreclosed and the farm properties passed to corporate farming. Today, the same thing is happening to dairy producers. Canada’s response to President Donald Trump’s tariffs is to place tariffs on U.S. dairy products. The earnings drop leaves American dairy farmers overburdened with debt service. This business, too, seems destined to be concentrated in a few hands. Economic independence is being driven out of American society.

The problems of monopoly, monopsony, and oligopoly are real.

Monopsony refers to a system in which a single buyer controls the market as the major purchaser of goods and services, while an oligopoly

is a system where there is limited competition and the market is shared by a small number of producers or sellers.

This is especially so when indebted Americans have their high productivity, high value-added jobs offshored and then face robotics displacing the lower-paid domestic service jobs that are their current employment. The profit-maximizing activities of corporations reduce Americans’ incomes but not their debts. Thus, debt service becomes more difficult.

In the U.S. today, we have a situation in which the New York banks control Federal Reserve policy and financial legislation—the deregulation of the banking system and its subsequent bailout, for example. We have a situation in which monopolies, monopsonies, and oligopolies are stronger than the central government, which is unable to rein them in or act against them in any way. Corporations dispossess citizens of their jobs by offshoring the jobs. Creditor demands prevent university graduates from forming households. Debt service preempts retail demand except by further debt expansion.

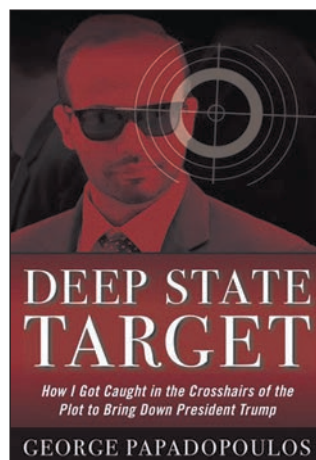

# 9/11 Truth Group Meets in San Diego

**F**ew 9/11 Truth groups in the country are as active, passionate, and dedicated as the group of citizen activists comprising the San Diegans for 9/11 Truth group based in America's finest city.

Founded in 2005, the group is dedicated to "uncovering the truth behind the wrongful deaths that took place on Sept. 11, 2001," according to the group's official website. This reporter has been involved with the group since the fall of 2009 after attending one of their monthly meetings, which always takes place on the second Sunday of each month. The group rents the Joyce Beers Community Center, a modest city-owned facility in Hillcrest, a neighborhood in the heart of San Diego, the second largest city in California. A dedicated core group of activists regularly attend the monthly meetings, as well as other interested persons from across Southern California.

The monthly meetings oftentimes feature a special guest speaker or presenter, who is first introduced by a member of the San Diegans for 9/11 Truth group. In recent years, the SD 9/11 Truth group has featured a number of top 9/11 researchers and activists, including Barbara Honegger, Dylan Avery, and Christopher Bollyn, among many others.

9/11 Truth documentaries are also often screened

at monthly meetings, and an open discussion or question and answer session follows, which is always lively. Members of the SD 9/11 Truth group are extremely knowledgeable about the events of 9/11, as well as other political and historical topics, making the open discussion period a fast-moving and informative experience.

Franklin Stiles, a key organizer and activist for the SD 9/11 Truth group and a subscriber to this newspaper, spoke with this reporter about the importance of 9/11 Truth and the work the local group does.

"There are many reasons 9/11 is still important and relevant, even now after almost 20 years," Stiles explained. "This manufactured, uninvestigated, unsolved, heinous crime serves as the pretext and the catalyst for the global war on terror and the control of humanity. them to set up a booth with information about 9/11. The group also attends other public events, such as the Martin Luther King Jr. Day parade, and regularly conducts outreach efforts near the USS *Midway*, a major tourist attraction in the heart of downtown San Diego.

"We in the SD 9/11 Truth group feel that since this event was a major push to install the next level of the New World Order, we are a critical component in the defense of the U.S. Constitution and Bill of Rights," Baldwin noted. "We are committed to continue our efforts in exposing the crimes of our government and associated NWO players. If not us, who else is going to raise awareness of these issues?"

"My style of public outreach is to try and remain non-confrontational, plant some seeds, so to

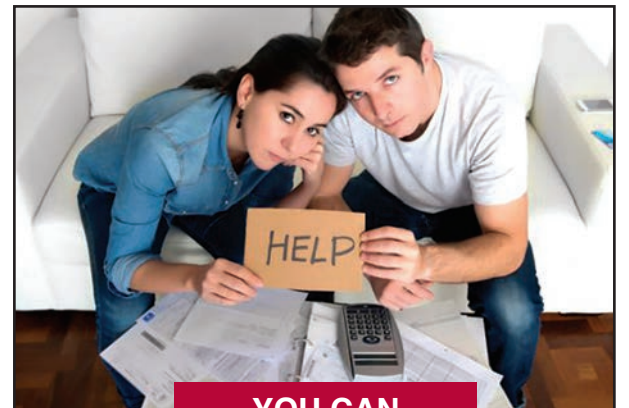
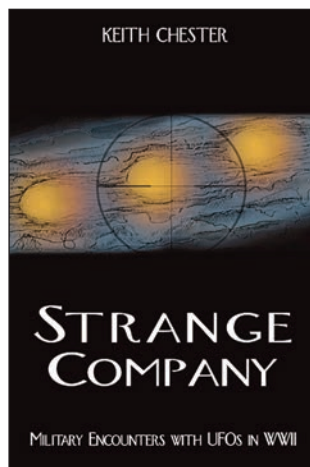

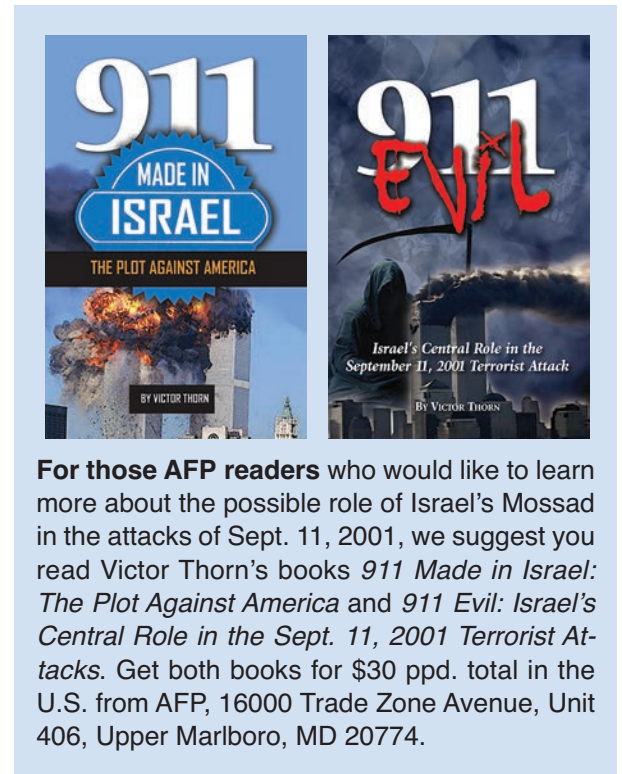

Many readers of this newspaper will remember Fox News’s four-part series that aired a few months after 9/11, in which Carl Cameron reported that “some 60 Israeli nationals had been detained in the anti-terrorism/immigrant sweeps in the weeks after Sept. 11, and at least 140 Israelis identified as ‘art students’ had been detained or arrested in the prior months.” Cameron “reported that federal agents were investigating the ‘art student’ phenomenon as a possible arm of Israeli espionage operations tracking al-Qaeda operatives in the United States,” where the Israelis “may have known about the preparations for the Sept. 11 attacks but failed to share this knowledge with U.S.

intelligence.” Rather than expanding its investigation of Israeli involvement in 9/11, Fox executives took the unprecedented step of scrubbing the entire video report from its website.

Following Fox’s report, the only major U.S. media outlet to address the “art student” revelations was *The Washington Times*, whose reporting quoted a senior Department of Justice official as stating, “We think there is something quite sinister here but are unable at this time to put our finger on it,” essentially giving the Israelis a “Get Out of Jail Free” card, and ending the *Times*’s journalistic coverage of this topic.

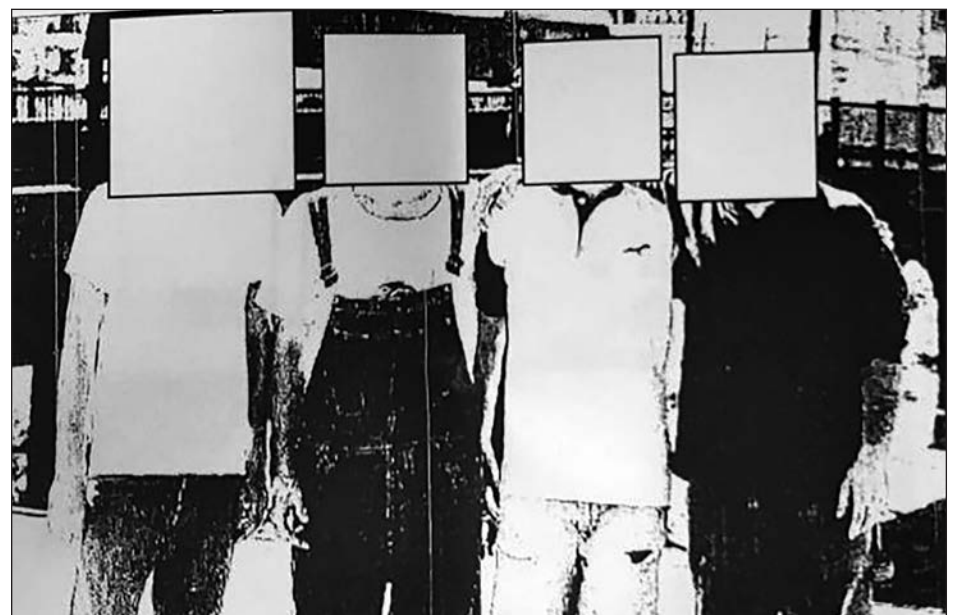

as well as the “Dancing Israelis,” has been imploring those interested in 9/11 truth to continue their long history of submitting FOIA requests, which he is unable to do because of his Asian residence.

Although it’s been thoroughly documented that the “Dancing Israelis” were “hugging and high-fiving and flicking lighters and posing for photos,” explained Dawson, this vital piece of the 9/11 puzzle remains shrouded.

“Even though we have the FBI admitting it,” Dawson explained, “even though [the ‘Dancing Israelis’] were in jail for 72 days, until someone sees the picture, a lot of people don’t have the ability to understand something to be true until they see it.” ★

# Regime Change in Iran: Been There, Done That

• Don't forget CIA's disastrous overthrow of Iranian Prime Minister Mossadeq in 1953

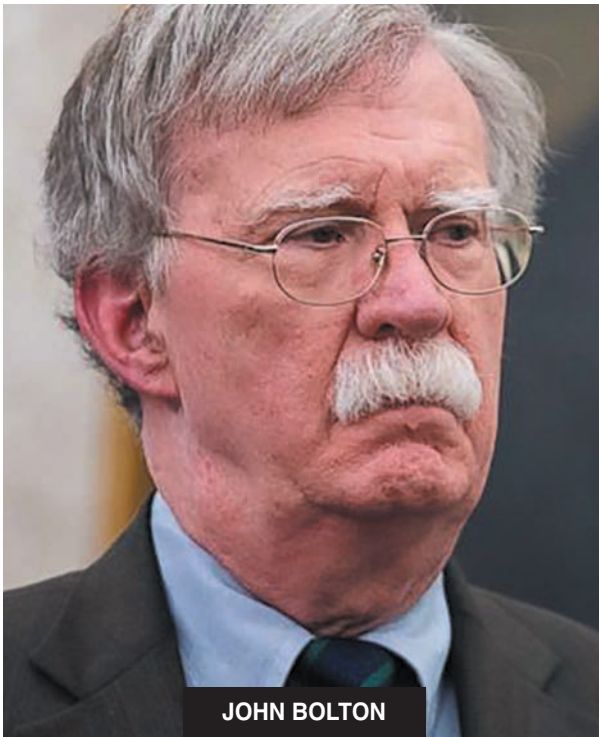
The failed coup attempt in Caracas in early May brings to mind the techniques used by the Central Intelligence Agency (CIA) and British intelligence in Iran in 1953 to overthrow the Mohammad Mossadeq government. It is quite astonishing how that regime-change long-ago operation parallels what is currently taking place in Venezuela and also with regards to Iran yet again.

Mossadeq was the democratically elected prime minister of Iran beginning in 1951, serving in a government in which the Shah with limited authority was the head of state presiding over a parliamentary system. Iran was nominally independent at the time, but it was heavily influenced by the neighboring Soviet Union, which retained control over several Iranian provinces after the Second World War ended, and Great Britain, which exploited the country's oil resources through the mechanism of the Anglo-Iranian Oil Company (AIOC), which was owned by the British government. When Mossadeq, frustrated by lack of progress in negotiations with the British over sharing of oil revenues, eventually declared that he would nationalize the AIOC, London and Washington conspired to remove him.

The new National Iranian Oil Company was immediately attacked by the British, who used the Royal Navy to block export of oil from Iran's Abadan refinery. Ships carrying Iranian oil were stopped and boarded with their shipments confiscated as "stolen property" in light of the British government's former ownership claim on the AIOC.

By mid-1952, Britain's blockade of Iranian oil exports had badly hurt the Iranian economy, which eventually led to government bankruptcy. Meanwhile, the American CIA, which was initially ambivalent about what the proper role in the Anglo-Iranian conflict might be, joined British agents in supporting groups inside Iran that were hostile to Mossadeq. In the Majlis parliamentary election in the spring of 1952, Mossadeq faced serious opposition funded by the Anglo-Americans, and the election eventually was suspended. By early 1953, pro-communist and pro-Shah mobs supported and coordinated by the U.S. and Britain roamed the streets, sometimes fighting each other. Fearing a communist takeover and also under pressure from London, which was threatening to withdraw from the Korean War as a quid pro quo, President Dwight D. Eisenhower agreed to carry out a joint coup d'état.

Losing popular support due to a sinking economy, as early as August 1952 a struggling Mossadeq began ruling by emergency powers and started to jail opponents, which only aggravated the crisis. A rigged referendum to dissolve parliament and grant Mossadeq authority to govern by decree passed with 99.9% approval but led to

currently being used against Venezuela and Iran were there back in 1953 to bring down Mossadeq and also appear in a detailed 2018 Pentagon plan describing how to bring about a coup in Caracas. Wrecking the countries' economies through sanctions and exclusion from the global banking network creates a crisis where one need not have existed. Meanwhile, a sustained campaign of vilification by Western political leaders and the media establishes the narrative that the benevolent intention is to block extremism and restore democracy while also eliminating a threat to the United States. And, as a last resort, the threat or actual use of force to stop the export of commodities to further wreck the economy becomes a clearly stated policy option, currently also employing secondary sanctions for anyone who dares to trade with the designated victim.

Recently, America's unilaterally imposed global ban on the export and sale of Iranian oil began. Venezuela's oil sales are also being blocked and even its electricity grid is being attacked in an attempt to starve the Venezuelan people into rebelling against their government.

But you also have to have spies, secret agents, to get the ball rolling, just as was true in 1953. One assumes that the CIA has been active in recruiting the agents of influence inside Venezuelan political opposition as well as military circles who will bring out increasingly larger mobs as the situation continues to deteriorate. How successful they have been is difficult to determine, but Venezuelan opposition leader Juan Guaido failed the first time around, reportedly because the Venezuelan government was aware of what was happening and the contacts that CIA was relying on to bring out the army were in fact double agents.

The suffering Iranian and Venezuelan people have yet to rise up in revolt. No matter. It took more than one try to bring down Mossadeq, and National Security Advisor John Bolton has recently warned Iran that its government won't have any more anniversaries to celebrate if it continues with its "threats." The Trump administration is also reported to be preparing military options for dealing with Venezuela.

Bolton has even warned the Russians, who are assisting Venezuela's government: "This is our hemisphere. It's not where the Russians ought to be interfering. This is a mistake on their part."

He is seemingly unaware of the irony, that the Russians might make the same claim about Eurasia and the Iranians regarding the Persian Gulf, where Bolton and his neocon friends in Washington have been the source of nearly continuous conflict. ★

accusations that the prime minister was seeking "total and dictatorial power." *The New York Times* reported, "A plebiscite more fantastic and farcical than any ever held under Hitler or Stalin is now being staged in Iran by Premier Mossadeq in an effort to make himself unchallenged dictator of the country." The move by Mossadeq also led to the first coup attempt, which was organized by the CIA.

On Aug. 15, 1953, Col. Nematollah Nassiri, the commander of the Shah's Imperial Guard, delivered to Mossadeq a decree from the Shah dismissing him. Mossadeq, who had been warned of the plot, had Nassiri arrested, and the Shah and his family fled into exile in Italy. The first coup thus ended with a whimper, but it was lessons learned for the second, better organized successful attempt which followed a few days later, Operation Ajax, coordinated by Kermit Roosevelt of the CIA.

Exploiting pro-Shah sentiment in the military, the CIA and the British turned to their stables of recruited army officers while also exploiting agents infiltrated into the communist party Tudeh, which rose to the occasion by launching mass demonstrations, to include looting and arson, which quickly alienated the public and also provided a pretext for Western support of the coup as it could be promoted as "anti-communist." Efforts were also made to turn influential clerics against Mossadeq. The Iranian people blamed the government for all their woes and rioting soon led to the calling out of the army to restore order. The army did so and then had Mossadeq arrested. He was condemned to death, but his sentence was later commuted to three years in solitary confinement followed by house arrest. He died in 1967.

End of story, but not quite. All the elements

# Trump Fooled by Advisors on Iran?

• Zionist neocons Bolton and Pompeo using faulty Israeli intelligence to con president

**N**ot for the first time, two of the most hawkish members of the Trump administration have been using slanted Israeli intelligence to argue for military action against Iran, a move that would surely lead to a full-blown war across the Middle East.

National Security Advisor John Bolton and Secretary of State Mike Pompeo have been ratcheting up their calls for striking Iran by announcing the dispatch of the USS *Abraham Lincoln* Carrier Group and a bomber task group to the region. Both men claimed they had intelligence confirming that Iran was planning attacks on U.S. troops and assets. No one else seemed to know where that intel had originated, and security officials in Europe dismissed it as a deliberate effort to stoke tensions and justify actions that would lead to war with Iran.

On May 12, two Saudi Arabian oil tankers were damaged at the mouth of the Persian Gulf. The Saudis were quick to blame Iran for the attacks on the two ships, which were delivering oil to the U.S. forces in the Middle East, but Iranian Foreign Minister Mohammad Javad Zarif said on May 14 that the Iranians were not responsible and blamed the “false-flag attack” on the United States.

“We discussed the regional issues and dangers that the policies of extremist individuals in the U.S. administration are trying to impose on the region, as well as worries about the actions and suspicious sabotage in the region,” Zarif said to reporters.

“We had earlier predicted that they will adopt such measures to provoke tensions,” he added.

Diplomatic and security sources this writer spoke to in London and in Moscow all agreed that the intelligence Bolton and Pompeo touted was likely provided by Israeli Prime Minister Benjamin Netanyahu, who has been a champion for demanding a war to force regime change in Iran.

Pompeo has not been shy about using bogus

intelligence to make a case against Iran. In May 2018, he accused the Iranian Quds force of assassinations within Europe when there was no evidence to support his claim.

Security experts suspect that once again he has been spoon-fed fake information by the Israelis. In Washington and in European capitals, his warning was met with skepticism and silence.

Somewhat ironically, Bolton and Pompeo are not averse to feeding questionable information back to Netanyahu. Security correspondent Joe Cirincione pointed out in online security source “Defense One” that Bolton had “zero evidence” for telling Netanyahu, “We have no doubt that Iran’s leadership is committed to achieving deliverable nuclear weapons.” One can reasonably conclude that, by hyping a potential nuclear threat from Iran, Bolton’s intent was to encourage Israel to consider bombing Iranian nuclear facilities.

As Cirincione put it: “I have found zero evidence to support Bolton’s claim. It is unclear who ‘we’ means, but it certainly does not include the American intelligence community. They have found exactly the opposite.”

All of this raises the question of how Trump views the risk of a new Middle East conflict. It appears from his latest statements that he is not on the Pompeo-Bolton track and is not an Iran hawk. He now says that he would like to talk directly with Iran’s leaders. That leads one to wonder if until now he had been so consumed with defending his presidency that he has allowed hawkish figures like Bolton and Pompeo to exploit the space created by his preoccupation with Washington issues.

Similarly, reports have surfaced lately that he was angry that Bolton misled him that Venezuela’s leader, Nicolas Maduro, was about to

concede defeat. Whatever the truth, there is undoubtedly room for Trump to negotiate a deal with Iran, but it would be opposed by the Israelis, the Saudis, neocons, and pro-Netanyahu elements in Congress.

The neocon view that Iran poses an existential threat to the U.S. and its interests is dismissed by most experts. In *The New Republic*, Jefferson Morley makes the interesting observation that Sunni Arabs have posed a more serious threat to America than Iranian Shiites. Most Americans know that is true because many attacks carried out by groups like al Qaeda and ISIS originated within the Arab world, financed in the main by Saudi Arabia and the Mossad. While it would be wrong to say Iran has not been involved in terror, it would be incorrect to exaggerate the threat it poses to America.

Most foreign policy observers tend to believe that there is no guaranteed outcome of regime change resulting from war with Iran. On the contrary, if one looks closely at the chaos in other Middle Eastern nations, especially Libya, such a

war would engulf Iraq, Lebanon, and other countries, possibly drawing in Russia, Iran's ally. The Russian and Chinese foreign ministers have already warned Washington against increasing tensions. Both those nations still favor the international Iran nuclear agreement, which is fraying at the edges as the Trump administration strangles Iran's economy and threatens to do likewise to any country that does business with Iranian energy companies.

One of the sources this writer spoke to pointed to the fact that Pompeo and Bolton, as well as members of the Trump inner circle like Rudy Giuliani, are closely aligned with MEK, the Mujahideen-e-Khalq, a shady Iranian exiles group that was on the U.S. terrorist list from 1997 to 2011. It has been used by the Israelis and the Saudis to carry out terror operations inside Iran.

The Trump family is also linked to the former Shah of Iran's son, Mohammed Reza Pahlavi, who wants to return to Iran as its monarch and has the support of the Saudi royals and some prominent figures in Israel. ★

# Florida Lawmakers Vote to Arm Teachers

• Unfortunately, largest counties opt out of program designed to protect kids

In an expansion of a program that was launched in the wake of the Parkland, Fla. high school shooting in February 2018, both houses of the Florida state legislature have passed a law allowing full-time teachers to carry a firearm in Florida schools. A teacher will be allowed to carry a firearm on school grounds after they have successfully completed a 144-hour course on firearm operation and safety.

The “Guardian” program originated with an attempt by the legislature to ensure that all schools will have at least one armed staff member or law enforcement officer on campus during hours of operation. To pacify anti-gun activists, the legislature also installed a minimum three-day waiting period to purchase a firearm, as well as raising the legal age to purchase a rifle or shotgun from 18 to 21.

As expected, there are major disagreements about the practicalities of the new law. Supporters argue that on-site protection is needed, as law enforcement cannot properly respond to school shootings in time to stop the shooters and limit the number of victims. Detractors of the new law claim that accidental firings and stress-related incidents will be the unintended consequences, resulting in more injured students and employees than the firearms will save.

State Rep. Shevrin Jones (D) of Broward County at times screamed into the microphone during the heated debate on the Florida House



floor. He imagined a real situation in a classroom where a teacher feels overwhelmed by an increasingly rowdy, crowded classroom. “What happens when that teacher feels threatened?” Jones asked. Jones also emphasized the ways in which he believes teachers of one race view students of another race. He then stated that teachers needed to be trained to address their own racial prejudices before arming themselves.

“There’s a reality that some of us have, that

some of you in the front row couldn’t care less about,” Jones said, looking directly at the House Republican leadership. “I asked for implicit bias training because we’re talking about black boys and girls that are getting murdered by police officers! . . . There are bad police officers and there are bad teachers.”

Jones needs a reality check. Even *The Wall Street Journal* has reported that the supposed science behind claims of implicit bias where people are just unconsciously prejudiced is fake news.

Dan Eagle, the House Republican leader, said of teachers who wish to take the course, “These are the individuals who want to protect you and others if they need to do so. When law enforcement can’t get there to save others, I hope there’s someone in that room who is able.”

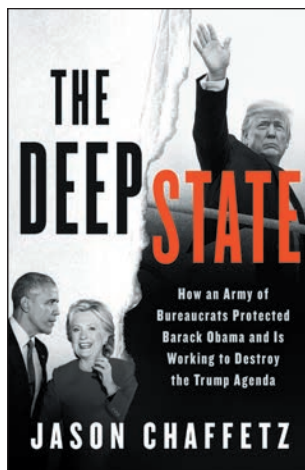
Eagle pointed out the wide range of school safety provisions covered by the law, which also provides for increased mental health services, improved risk assessment, and a streamlined process for reporting incidents. Eagle called the Guardian program “a pathway” for teachers who want to be trained and armed, while pointing out that the bill is a wholistic one and not a way to arm every teacher in Florida.

Fedrick Ingram, president of the Florida Education Association, pointed out valid questions that school districts should answer in the process of adapting the law to their schools: “Will teachers wear guns, or how will firearms be stored? Will parents and students be told if the teacher in any given classroom is armed? Can parents opt their kids out of a class where the teacher is carrying?” These are questions that will have to be answered so that students feel safe in Florida classrooms.

The Guardian program ensures that all schools will have at least one armed staff member or law enforcement officer on campus.

According to a spokesman for Florida's speaker of the House, educators in 40 of Florida's 67 school districts have already enrolled or plan to enroll in the course. Districts will have the choice of opting out of the program altogether. Miami-Dade County and Broward County (Ft. Lauderdale), Florida's two most populated counties, have already chosen to opt out. The next three most populated counties—Hillsborough County (Tampa), Orange County (Orlando), and Palm Beach County—have also opted out, although Palm Beach has voted to use \$10 million in state money to further arm and increase law enforcement within its schools, while also improving access to mental health services.

Since the Guardian program passed, more school districts are either locked in a superintendent versus sheriff struggle or opting out altogether. It isn't until you get to the 27th most populated county, Bay County, that you find a superintendent, sheriff, and safety officer publicly supportive of the program.

Mike Jones, the school safety and security chief of Bay County, told reporters, "We're excited about it. I'm 100% in favor. It's a chance to put more armed people on our campuses to combat these guys." ★

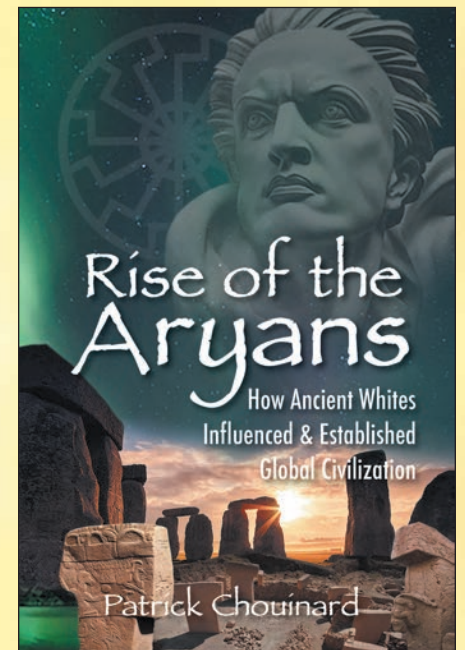

# Are All the World's Problems Ours?

• Other powers better equipped to deal with flashpoints in their own backyards

In 2003, George W. Bush took us to war to liberate Iraq from the despotism of Saddam Hussein and convert that nation into a beacon of freedom and prosperity in the Middle East.

Recently, Mike Pompeo flew clandestinely into Baghdad, met with the prime minister, and flew out in four hours. The visit was kept secret to prevent an attack on the Americans or the secretary of state.

Query: How successful was Operation Iraqi Freedom, which cost 4,500 U.S. lives, 40,000 wounded, and \$1 trillion, if, 15 years after our victory, our secretary of state must, for his own security, sneak into the Iraqi capital?

Topic of discussion between Pompeo and the prime minister: In the event of a U.S. war with Iran, Iraqis would ensure the protection of the 5,000 U.S. troops in country, from the scores of thousands of Iranian-trained and Iranian-armed Shiite militia.

That prospect, of war between the U.S. and Iran, had been raised by Pompeo and John Bolton, when the USS *Abraham Lincoln* carrier task force and a squadron of U.S. bombers were ordered into the Middle East after we received reports Iran was about to attack U.S. forces.



The United States is trying to manage too many regional powderkegs. For instance, if the U.S. cannot come to some agreement with North Korean leader Kim Jong Un (left), political analyst Pat Buchanan believes we should let China handle the problem of multiple emerging nuclear powers on its borders.

The attack did not happen. But in early May, Tehran gave 60 days' notice that if it does not get relief from severe U.S. sanctions, it may walk out of the nuclear deal it signed in 2015 and start enriching uranium again to a level closer to weapons grade.

The countdown to a June confrontation with Iran has begun.

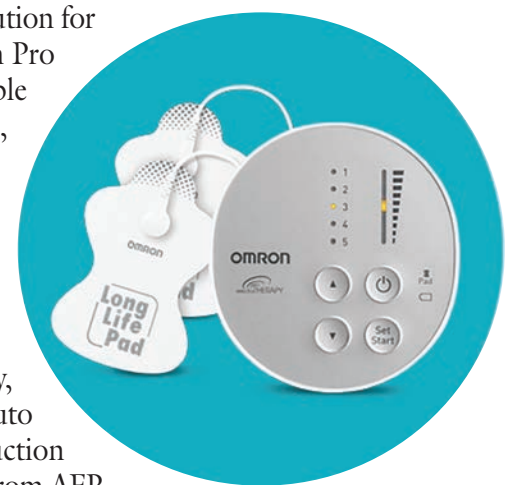
Around that same time, North Korea's Kim Jong Un, for the second time in a week, test-fired two missiles, 260 miles into the Sea of Japan. Purpose: to signal to Washington that Kim's patience is running out.

Kim rejects the U.S. demand that he surrender all nuclear weapons and dismantle the facilities that produce them before any sanctions are lifted. He wants sanctions relief to go hand-in-hand with disposal of his arsenal. Few believe Kim will surrender all of his nukes or his ability to replicate them.

The clash with Kim comes days after the failed U.S.-backed coup in Venezuela, which was followed by Pompeo-Bolton threats of military intervention in Venezuela, a country 100 times the size of Puerto Rico with 10 times the population and a large, well-equipped army.

Joint Chiefs of Staff Chairman Gen. Joe Dunford told Congress recently that the U.S. will have to keep counter-terrorism forces in Afghanistan “until there is no insurgency left in the country.” Which sounds like forever, as in “forever war.”

Before flying to Baghdad, Pompeo was in Finland. There, he warned the eight-nation Arctic Council about Russian aggression in the region, suggested China’s claim to be a “near-Arctic” nation was absurd, and told Canada its claim to the Northwest Passage was “illegitimate.”

Our Canadian friends were stunned. “Those waterways are part of the internal waters of Canada,” said the government in Ottawa.

After an exhausting two weeks, one is tempted to ask: How many quarrels, clashes, and conflicts can even a superpower manage at one time? And is it not time for the United States, preoccupied with so many crises, to begin asking, “Why is this our problem?”

Perhaps the most serious issue is North Korea’s quest for nuclear-armed missiles that can reach the United States. But the reason Kim is developing missiles that can strike Seattle or LA is that 28,000 U.S. troops are in South Korea, committed to attack the North should war break out. That treaty commitment dates to a Korean War that ended in an armed truce 66 years ago.

If we cannot persuade Pyongyang to give up its nuclear weapons in return for a lifting of sanctions, perhaps we should pull U.S. forces off the peninsula and let China deal with the possible acquisition of their own nuclear weapons by Japan, South Korea, and Taiwan.

Iran has no nukes or ICBMs. It wants no war with us. It does not threaten us. Why is Iran then our problem to solve rather than a problem for Saudi Arabia, the Gulf States, and the Sunni Arabs?

Nor does Russia’s annexation of Crimea threaten us. When Ronald Reagan strolled through Red Square with Mikhail Gorbachev in 1988, all of Ukraine was ruled by Moscow.

The Venezuelan regime of Nicolas Maduro was established decades ago by his mentor, Hugo Chavez. When did that regime become so grave a threat that the U.S. should consider an invasion to remove it?

During the uprising in Caracas, Bolton cited the Monroe Doctrine of 1823. But according to President James Monroe, and Pompeo’s predecessor John Quincy Adams, who wrote the message to Congress, under the doctrine, while European powers were to keep their hands off our hemisphere—we would reciprocate and stay out of Europe’s quarrels and wars.

Wise folks, those Founding Fathers. ★

# Who Wants a Nuclear War Over Venezuela?

- Hopefully Vladimir Putin was able to talk some sense into Trump about Venezuela

Is President Donald Trump about to invade Venezuela? His advisors keep telling us in ever-stronger terms that “all options are on the table” and that U.S. military intervention to restore Venezuela’s constitution “may be necessary.”

Secretary of State Mike Pompeo was on news programs to claim that Trump could launch a military attack against Venezuela without Congress’s approval.

Pompeo said that, “[t]he president has his full range of Article II authorities and I’m very confident that any action we took in Venezuela would be lawful.”

The president has no constitutional authority to start a war with Venezuela or any other country that has not attacked or credibly threatened the United States without congressional approval. It is that simple.

How ironic that Pompeo and the rest of the neocons in the Trump administration are ready to attack Venezuela to “restore their constitution” but they could not care less about our own Constitution.

While Washington has been paralyzed for two years over disproven claims that the Russians meddled in our elections to elect Trump, how hypocritical that Washington does not even hesitate to endorse the actual overturning of elections overseas.

Without congressional authority, U.S. military action of any kind against Venezuela would be an illegal and likely an impeachable offense. Of course, those Democrats who talk endlessly of



impeaching Trump would never dream of impeaching of him over starting an illegal war. Democrats and Republicans both love illegal U.S. wars.

Unfortunately, Washington is so addicted to war that Trump would likely have little difficulty getting authority from Congress to invade Venezuela if he bothered to ask. Just as with the disastrous U.S. invasion of Iraq in 2003, the mainstream media is nothing but non-stop war propa-

Certainly the U.S., perhaps together with the Russians, could help facilitate discussions between the government and the opposition, but the neocon road to war will surely end up like all the other neocon wars: total disaster.

The media is furious that Trump dared to speak to Putin as the two countries increasingly face off over Venezuela. The Democrats and neocons are pushing for a direct confrontation that may even involve Russia. Republicans agree. Do they really prefer nuclear war over Venezuela? ★

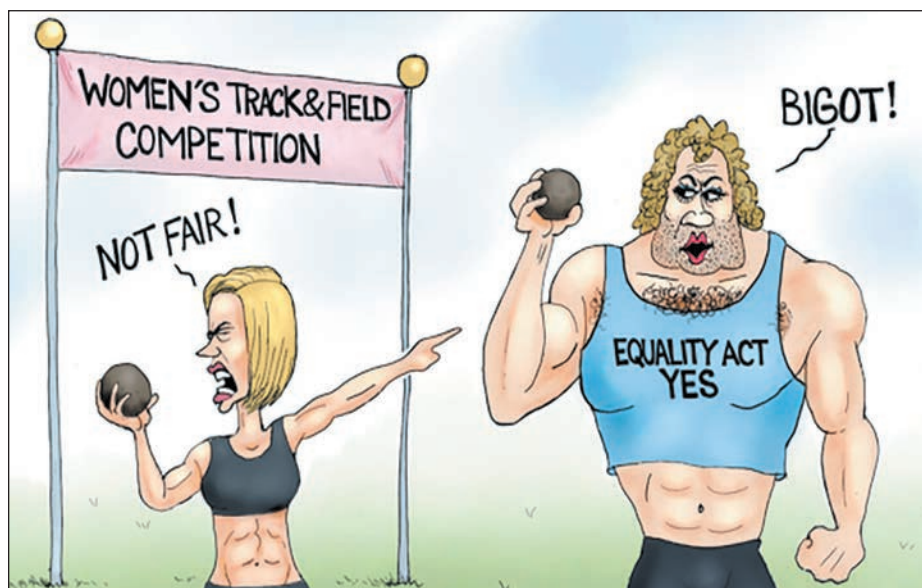
