MORRIS DEES SACKED

SPLC SLEAZEBALL SENT PACKING

Morris Dees, the disreputable hate-peddler who has for many years posed as the arch-enemy of hate, was fired from his position as head of the infamous Southern Poverty Law Center (SPLC) in Montgomery, Ala.

The SPLC is reviled among thinking Americans as an anti-free speech, anti-Christian, anti-conservative pressure group that has accused everyone from President Donald Trump to this newspaper—and many publications, organizations, and individuals in between—of being aligned with dangerous extremism.

The firing of Dees, now 82—who co-founded the SPLC in 1971—was effective March 13. SPLC President Richard Cohen was tight-lipped about the specifics, but he did say it had to do with "misconduct" of an unspecified nature.

"As a civil rights organization, the SPLC is committed to ensuring that the conduct of our staff reflects the mission of the organization and the

Conservatives Not Responsible for Mosque Massacre

On March 15, in the quiet city of Christchurch, New Zealand, a 28-year-old man opened fire inside two mosques in the span of about 20 minutes, murdering 50 people and injuring another 50. According to reports, he had intentionally timed his attacks so that they took place during afternoon prayers so he could ensure that the maximum number of victims—innocent men, women, and children—would be present. Unlike in many previous mass shootings, however, this time the police were able to catch the crazed killer, an Australian by the name of Brenton Tarrant. He is currently cooling his heels behind bars, has been slapped with multiple murder charges, and will likely spend the rest of his life in prison.

This terrible incident should have been reported as a horrible tragedy carried out by a violent, crazy person, but that's not what's been happening. Instead, the mainstream media and far-left-wing activists have been cynically misrepresenting what happened to point an accusatory finger at conservatives, critics of immigration, President Donald Trump, and, of course, white people in general—all because the lunatic shooter was a white male.

For the most part, the already brainwashed masses have bought into this narrative, accepting without question the claim that “white extremism” is on the rise around the world and that, now, anyone who has ever spoken out or called for limiting immigration at some point in time bears responsibility for this heinous act.

In reality, though, the truth is very far from what you may have read in the big media. How do we know this? For one thing, the suspect who has been arrested for carrying out this heinous crime took the time to post to the In-

ternet a 16,000-word, 74-page manifesto explaining why he did it. It's worth pausing for a second to note that Tarrant's screed is utter garbage. A better way to characterize it would be as a poorly written, babbling, virtually incomprehensible, self-important rant presented in an awkward question-and-answer format often referred to on the Internet as an FAQ, or “frequently asked questions.” Though social media outlets and governments have tried to scrub Tarrant's lengthy screed, it's still widely available under the name “The Great Replacement,” and anyone anywhere in the world can read it in its entirety if they're so inclined.

Even a quick glance at Tarrant's writings reveals that the man is, to put it mildly, nuts.

While the media has painted Tarrant as a far-right “white nationalist,” the truth is evident, when one reads his manifesto, that it's impossible to really know what the guy is talking about, given the fact that he bizarrely characterizes himself as both an “ethno-nationalist” and an “eco-fascist,” whatever that is. He follows that up by trying to clarify his outlook, to wit, “Ethnic autonomy for all peoples with a focus on the preservation of nature, [sic] and the natural order.” Then he adds, “The nation with the closest political and social values to my own is the People's Republic of China.”

He then asks himself, “Were/are you right wing?” He responds, “Depending on the definition, sure.” Following that, he asks, “Were/are you left wing?” to which he answers the same way: “Depending on the definition, sure.”

And while he does invoke Trump, it is ironically the media's caricature of Trump that Tarrant really clings to, asking himself, “Were/are you a supporter of Donald Trump?” His response: “As a symbol of renewed white identity


and common purpose? Sure. As a policy maker and leader? Dear God no.”

A few lines later, Tarrant pulls the veil back to show his kookiness, saying he expects that eventually he will be awarded the Nobel Peace Prize, “as [it] was awarded to the terrorist Nelson Mandela once his own people achieved victory and took power.” And if he is caught, he adds, “I expect to be freed in 27 years from my incarceration, the same number of years as Mandela, for the same crime.”

Perhaps most ridiculous of all is that, when he asks himself who out there has “radicalized” him and made him the insane killer that he is today, he cites Candace Owens—a 29-year-old black woman, who has grown in popularity on the Internet in the past few years, because she's a rational, reasonable conservative.

To any objective observer, the whole thing just reads like one sick, twisted joke. It's a huge waste of time to pore over it, but, sadly, it needs to be done because so many people out there are cherry-picking parts of it for the purpose of reinforcing the sad, tired accusation that white people—especially conservative white people—are really the biggest threat in the world today.

The good news is that there appears to be pushback against this from many free thinkers out there, like all of us here at AMERICAN FREE PRESS, who refuse to be cowed by those who shamelessly exploit a tragedy to win political points. ★

News You May Have Missed

Crisis on the Border

The mainstream media has repeatedly attacked President Donald Trump for remarking that illegal immigration has reached crisis levels on the U.S. border with Mexico. Major media outlets claim that Trump's statement is untrue. According to a new report by the *Los Angeles Times*, the Border Patrol is near its breaking point and has been forced to release illegal immigrants into the United States because they simply do not have any more room in detention facilities. The *Times* reported that in February alone, the Border Patrol caught 66,450 migrants, a 38% increase from January and one of the highest monthly totals of the last decade. "It is a crisis," a Border Patrol agent told the *Times*. "It's not a self-proclaimed crisis."

Vendettas Against Trump

Former news anchorman Ted Koppel has joined the growing chorus of current and former newsmen and women calling out their employers for carrying out vendettas against President Donald Trump. "When you talk about *The New York Times* [or] *The Washington Post* these days, we're not talking about the *Times* [or the *Post*] of 50 years ago," Koppel told a recent gathering at the Carnegie Endowment for International Peace. "We're talking about organizations that I believe have, in fact, decided as organizations that Donald J. Trump is bad for the United States." In February, respected journalist Lara Logan called out the U.S. media for its liberal bias. Hopefully more mainstream reporters and anchors will do the same.

Another Sanctuary State for Guns

In response to moves to seize and limit firearms in the United States in violation of the Second Amendment, 10 counties in Colorado have declared "Second Amendment Sanctuary" status against a gun confiscation law being pushed by gun-grabbing Democrats at the state level.

Welfare and Immigration

A new study by the Center for Immigration Studies (CIS) has found that households in the United States that are headed by foreign noncitizens, including legal and illegal aliens, use nearly twice as much welfare as native-born Americans. According to CIS, 63% of noncitizen households—those who live legally and illegally in the U.S.—use some form of public welfare, while only about 35% of native-born American households use welfare. In addition, an estimated 50% of naturalized citizens, or people who legally immigrated to the United States and became citizens, use taxpayer-funded welfare.

Brainwashed on Socialism

According to a February Harris Poll of 2,035 adults, the youngest of the 2020 voters—Generation Z and Millennials—have a more positive view of the word "socialism" than previous generations. These two groups are projected to account for 37% of the electorate in 2020. Their acceptance of socialistic policy, espoused by politicians like Sen. Bernie Sanders (I-Vt.) and Rep. Alexandria Ocasio-Cortez (D-N.Y.), will undoubtedly have an impact on the election. Top issues for younger voters include racial equality, global warming, mass shootings, and immigration policy/treatment of immigrants. Generation X and baby boomers still consider terrorism, national security, national debt, and access to healthcare as top concerns.

Not That Great a Partner

According to a new survey of 1,503 American adults by polling company Pew, only 12% believe that Israel is a top foreign policy partner. An estimated 37% of Americans believe the UK would be the most valuable partner and after that China with 26% support. More Republicans (25%) think that Israel is a good partner in comparison to 5% of Democrats. As for Israeli leader Benjamin Netanyahu, 52% of Republicans compared to only 18% of Democrats have a favorable impression of the prime minister.

'Frankenfish' Concerns

In an upsetting move, the Food and Drug Administration (FDA) has rescinded regulations that previously prohibited genetically engineered salmon from entering the U.S. food market. AquaAdvantage Salmon, aptly dubbed "Frankenfish," is the product of DNA splicing, which forces the new species to grow bigger, faster. Sen. Lisa Murkowski (R-Alaska) expressed her concern regarding the import of these genetically modified fish and calls the move by FDA Commissioner Scott Gottlieb "shortsighted and wrong-headed." Gottlieb says the FDA "no longer has the authority to issue labeling guidance" and therefore the administration is satisfied that AquaAdvantage products are safe for import.

Censorship

Social media behemoth Facebook blocked its users from viewing and posting articles from alternative finance and politics website "Zero Hedge" in early March but later reversed itself, calling the blacklisting a "mistake." "Zero Hedge" regularly publishes articles that are critical of the establishment, including massive tech companies. Facebook has repeatedly been the focus of Zero Hedge's reporting, largely for its invasion of

its users' privacy, leading many people to believe Facebook intentionally shut down "Zero Hedge" to quash valid criticism of it.

Slavery Reparations

Democratic presidential contenders Sens. Bernie Sanders (Vt.), Kamala Harris (Calif.), and Elizabeth Warren (Mass.) have all come out publicly in favor of paying "reparations" to black Americans despite the fact that slavery in the U.S. was outlawed over 150 years ago. Reparations is the euphemism for taking dollars from American

taxpayers, who have never been involved in slavery, and handing it out to blacks in America, who have never been affected by slavery. None of these politicians have been specific about what entails reparations. Only Sanders has ruled out writing checks to individuals.

Watchdog group 4thWaveNow recently released screenshots from a private Facebook group called "Parents of Transgender Children." Parents of children "questioning their gender" are seen discussing the gear, garb, and medical procedures being used to transition children as young as five years old from their biological gender to another of their choosing. Excerpts show that parents are using prosthetic penises, "tuck away" underwear, and chest binders to facilitate and even encourage their child's very early transition. Some parents appear to urge their child into use of this bizarre gender-bending equipment. Thankfully, 4thWaveNow aims to raise awareness to the "ever-accelerating medical and media fascination with the phenomenon of 'transgender children.'"

Left-Wing Censorship Group Slapped

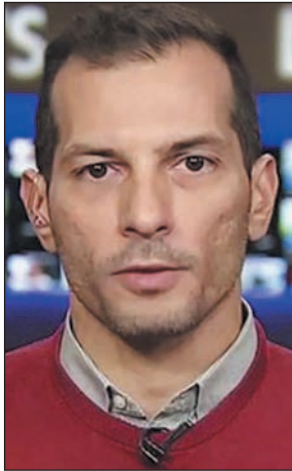
• Popular talk show host gives thought police a taste of their own medicine

Television talk show host Tucker Carlson, one of the most popular cable news commentators on air today and a strong critic of globalism, mass immigration, forced multiculturalism, and other key tenets of the prevailing liberal, politically correct social order, has been targeted by radical left-wing groups and activists for months now.

As this newspaper has previously reported, radical antifa activists targeted the outspoken America-first populist's home in the Washington, D.C. area in November of last year. Several members of Smash Racism DC, a radical left-wing antifa-affiliated group, posted Carlson's home address online and organized a protest outside his residence to denounce his alleged "racism" and "bigotry." Others have organized boycotts of his program and have attempted to entice advertisers on both Fox News and Carlson's flagship nightly news program, "Tucker Carlson Tonight," to end their business relationship with the network.

Media Matters, a highly partisan and far left-wing organization that regularly targets and attacks conservatives, has been and continues to be one of the primary organizations operating both behind the scenes and publicly to sabotage Carlson's nightly news program and tarnish his reputation. The activist organization recently published and highlighted a number of controversial statements Carlson made years ago relating to women, minorities, and other topics in a dishonest effort to distort what Carlson actually meant and further tarnish his reputation.

Carlson commendably did not back down in the face of such a dishonest and highly partisan smear campaign.

"Media Matters caught me saying something naughty on a radio show more than a decade ago," Carlson said in response to the Media Matters hit piece. "Rather than express the usual ritual contrition, how about this: I'm on television every weeknight live for an hour. If you want to know what I think, you can watch. Anyone who disagrees with my views is welcome to come on and explain why."

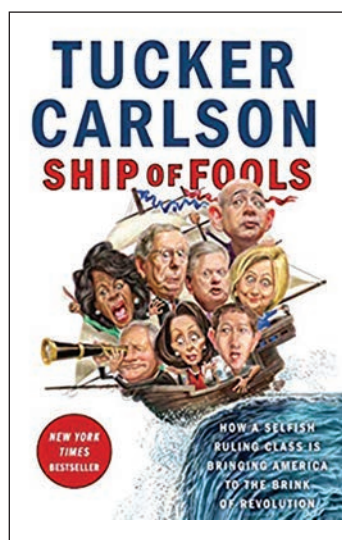
Indeed, in response to the attacks, Carlson has used his platform to launch his own investigation into the dishonest left-wing groups and individuals that have so brazenly attacked him and Fox News in an effort to de-platform them and sabotage their reputations. In recent episodes of his nightly news program, Carlson has aired segments

exposing the groups working tirelessly to end his career, including Media Matters, the Southern Poverty Law Center, and CNN, among others.

Carlson recently revealed that the current president of Media Matters, Angelo Carusone, has a history of making derogatory and disparaging comments. Unsurprisingly, Carusone's controversial statements have garnered little attention—or outrage—among Media Matters's liberal supporters.

On his now-defunct blog, Carusone used a number of slurs to characterize transvestites and minorities, including Jews. According to a report from "The Daily Caller," which dug up Carusone's old blog using the Internet Archive's "Wayback Machine," Carusone has referred to transvestites as "trannies" and Japanese people as "Japs," long considered an ethnic slur. Carusone, who is homosexual, even invoked classic anti-Semitic tropes when describing his Jewish boyfriend's political convictions, writing that his boyfriend was conservative as a result of possessing "several bags of Jewish gold."

Typically, these statements would have leftists worked up into a lather, working overtime to get the individual fired. The mainstream media would have reported heavily on the politically incorrect verbiage, interviewing top officials at the SPLC and other organizations, who would have condemned the speaker in no uncertain terms. A look at media reports reveals that only Fox News picked up the story, and Carusone remains the president of Media Matters.

TUCKER CARLSON

Conservative talk show host Tucker Carlson is turning the tables on his left-wing critics at Media Matters for America. Carlson recently revealed that Media Matters's president is a homophobic, anti-Semitic bigot.

Countless conservatives and principled supporters of Carlson have rallied to his defense, expressing outrage at the increasingly tyrannical and dishonest tactics used by the radical left to silence and shut down their political rivals.

"The anti-Tucker outrage mob is so clearly acting hypocritically and in bad faith for purely partisan political reasons," Donald Trump Jr. recently stated. Ned Ryun, the CEO of American Majority, correctly noted that Media Matters exists solely to "take out conservatives in media and politics."

"They're a partisan hit squad trying to delegitimize and de-platform conservatives [. . .] Serious-minded people should understand this is political warfare and tell Media Matters to go pound sand," Ryun stated.

"What makes [Carlson] more dangerous to the left than any other single thing is that he understands their long game," Cantwell stated. "Those who apologize today will be paralyzed tomorrow, because the goal of the mob is not redemption, but submission. One who can be made to bow to their whims will invariably be conscripted into their service, and Tucker simply will not permit this to happen to him under any circumstances."

For now, Carlson and Fox News are not only holding out and refusing to bend to the pressure being brought by these dishonest outfits, they are actively fighting back against the left-wing outrage mob. ★

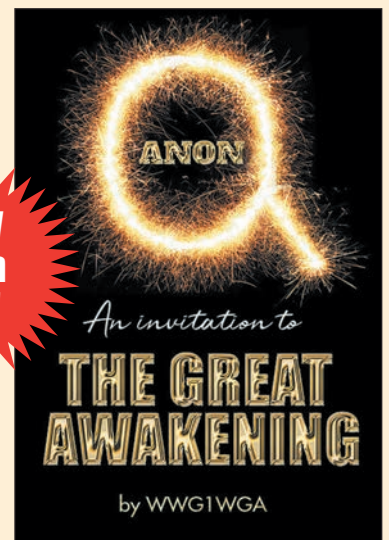

The 40-foot-tall Bladensburg Peace Cross—located less than 15 miles from this newspaper’s headquarters—was built in 1925 to honor local military men who died in World War I. Now, it is under attack by some strange birds from Bladensburg, Md. supported by the American Humanist Association (AHA), a U.S. non-profit whose main mission seems to be removing any and all references to religion and God from the public square.

Founded in 1941, the AHA lawyers-up those whose “constitutional rights” are allegedly breached, actively lobbies Congress on the mythologized concept of “church-state separation,” and does a whole lot of other things that poison our constitutional republic.

The mothers of these 49 Maryland soldiers who paid the ultimate price for their country over 100 years ago “designed the memorial to mirror the crosses that mark graves in American cemeteries overseas.” A plaque reads, “This Memorial Cross Dedicated to the Heroes of Prince George’s County who gave their lives in the great war for the liberty of the world” and lists the names of the dead, a sweet piece of history obviously lost on Fred Edwords and Steven Lowe, who are particularly offended by the memorial. Never mind that almost all of the boys (and girls) who served and continue to serve in the U.S. Armed Forces are Christians.

In 1961, after a highway was built around it, the Peace Cross was deeded to the Maryland-National Capital Park and Planning Commission and stood there without controversy until 51 years later, when the aforementioned ill-advised snowflakes sued, “arguing that they are offended by the government’s endorsement of religion and the fact that the cross is maintained with taxpayer money.” A district court ruled for the cross at that time, but five years later, the Richmond, Va.-based U.S. Court of Appeals for the Fourth Circuit reversed the decision, ruling that “the government had excessively entangled itself with religion.”

Of course, the enemies of the republic are using the document meant to amend the newly created U.S. Constitution, the so-called Bill of Rights, in particular the first 16 words from Amendment 1: “Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.”

Although the “Free Exercise Clause” and the “Establishment Clause” are still debated by constitutional scholars, there is no question that God

and religion were central in the lives of our founding fathers, so much so that James Madison Jr., the fourth U.S. president (1809-1817), known as the “Father of the Constitution,” “wrote near the end of his life that belief in God was ‘essential to the moral order of the world.’”

As Mark R. Levin explained in *Men in Black: How the Supreme Court Is Destroying America* (2005), “At the time of the ratification of the Constitution, America was an extremely religious nation.” “The framers,” he wrote, “never envisioned a time where the mention of God in the public square would be controversial, let alone illegal in certain circumstances.” In fact, said Levin, “The historical record is filled with examples of officials of the federal government invoking God during the same period that the Bill of Rights was ratified.”

So how did we get to the point that the mere mention of God in the same sentence as the word government causes many to cringe?

It all began at the turn of the 19th century, when the Danbury [Conn.] Baptist Association sent a letter on Oct. 7, 1801 to President Thomas Jefferson, “expressing concern over the lack in their state constitution of explicit protection of religious liberty, and against a government es-

tablishment of religion.” Jefferson wrote back on Jan. 1, 1802, saying in part:

Believing with you that religion is a matter which lies solely between Man & his God, that he owes account to none other for his faith or his worship, that the legitimate powers of government reach actions only & not opinions, I contemplate with sovereign reverence that act of the whole American people which declared that their legislature should “make no law respecting an establishment of religion, or prohibiting free exercise thereof,” thus building a wall of separation between Church & State.

Fast-forward to the middle of the 20th century, when in 1947 U.S. Supreme Court (SCOTUS) Justice Hugo Black, a Ku Klux Klan member and “longtime admirer of Jefferson, revived a previously obscure metaphor from Jefferson’s writings,” and “upended the long-standing balance between the government and religion in . . . *Everson v. Board of Education*.”

In his 1802 letter, Jefferson was merely explaining why he didn’t support “national days of fasting and thanksgiving, as George Washington and John Adams, his predecessors in office, had done,” not defining any wall of separation.

Despite this, wrote Levin, “the ‘wall’ is part of the lexicon of many Supreme Court cases that involve religion and it has led to an inconsistent and illogical series of decisions,” like 1962’s *Engel v. Vitale*, “a controversial and dubious decision that was at odds with American history,” which outlawed state-sponsored prayer, 1992’s *Lee v. Weisman*, which ruled that schools can’t sponsor clerics to conduct any type of prayer, or 2004’s *Elk Grove Unified School District v. Newdow*, where the U.S. Court of Appeals for the Ninth Circuit ruled the Pledge of Allegiance ran afoul of the Establishment Clause.

Of course, as Levin explains in his fine book, this clause “was never intended to ban the invocation of God in public forums or the voluntary participation in ‘ceremonies or rites that recognize God.’ In other words, it was never intended to create a strict wall of separation between church and state,” a term that, of course, appears nowhere in the U.S. Constitution.

Significantly, SCOTUS’s decision “could impact similar memorials in towns across the country and even Arlington National Cemetery,” states a Feb. 26 CNN article. The national cemetery holds two crosses, one a “13-foot-tall Latin cross called the Argonne Cross, dedicated in 1923 to the ‘memory of our men in France,’” and a 24-foot-tall Canadian Cross of Sacrifice, “donated by the Canadian government to honor Americans who died in war.”

While the Trump administration has voiced support for the Peace Cross, SCOTUS justices typically pay little mind to political preferences. SCOTUS heard oral arguments on Feb. 27, and we can expect a decision by late June. ★

Whistleblower Jailed Yet Again

• Former Army intelligence analyst who released 730,000 damning documents arrested

In a country that relishes every opportunity to tout its First Amendment freedoms to the rest of the world, no American had ever spent more than three years in jail for exposing government secrets to the public. That was before Chelsea Manning spent seven years imprisoned for doing just that—exercising what Manning believes to be First Amendment freedoms of speech and the press in an effort to inform average Americans of what was really happening within their government’s perpetual war state. Today, Manning is behind bars once again for refusing to testify against WikiLeaks founder Julian Assange before a grand jury.

In 2009, Manning was assigned as an intelligence analyst to an Army unit in Iraq. A year later, Manning released classified videos and documents to WikiLeaks. In total, more than 251,000 diplomatic cables and 482,000 Army reports (“The Iraq War Logs”) were released. Manning was arrested and prosecuted after threat analyst and hacker Adrian Lamo, a “friend” of Manning’s, reported the releases to the Army’s Criminal Investigation Command. Manning was acquitted of “aiding the enemy,” which could have brought a death sentence, but was still sentenced to 35 years in prison at the maximum-security facility at Fort Leavenworth in Kansas. In January 2017, President Barack Obama commuted Manning’s sentence to seven years dating back to the May 2010 arrest.

Manning has remained a controversial figure,

both in the media and on college campuses. In September 2017, Manning was named a visiting fellow at Harvard University’s Kennedy School of Government. After complaints were levied by former acting director of the CIA Michael Morell and then-CIA Director Mike Pompeo, Harvard rescinded its offer to Manning.

“I’m not ashamed of being disinvented. I view that just as much of an honored distinction as the fellowship itself,” Manning said. “This is military intelligence, and it is a police state in which we can no longer engage in actual political discourse in our institutions.”

After refusing to testify against Assange in early March, U.S. District Judge Claude Hilton ordered that Manning be imprisoned for contempt of court. There was a brief hearing in which Manning re-emphasized a refusal to testify. Then Manning bravely told the judge, “I will accept whatever you bring upon me.”

Manning has logical objections for refusing to testify before the grand jury. Manning objects to the secretive process of grand juries and has already revealed everything at a court-martial hearing. Second, the grand jury process has often been used to “entrap and persecute activists for protected political speech.” Third, because prosecutors granted Manning immunity for testimony at the court-martial hearing, Manning’s ability to invoke the Fifth Amendment right against self-incrimination no longer applies, thus eliminating any constitutional protections.

With every case that comes to court hereafter, being called to testify means once again opening Manning to new charges. It’s a twisted, legal way of continually persecuting someone for actions

stemming from the same offense.

Manning will be in jail now until the grand jury has finished its investigation.

While the military and media establishment could have controlled the Manning story 40 to 50 years ago (pre-Internet), the rise of the alternative media means that different perspectives of each story can be aired unedited. No longer can someone be so easily labeled a traitor. Whistleblowers exist in the vacuum where the mainstream media has failed. Whistleblowers like Manning, Assange, former NSA contractor Edward Snowden, and former FBI agent Coleen Rowley now inform the public more in one courageous action than CNN, Fox News, MSNBC, and the major networks do in a year.

Writing for Consortium News, former British Ambassador to Uzbekistan Craig Murray supported Manning’s decision not to testify.

“I am in awe of Chelsea’s courage in refusing to testify, and shocked at a system that imprisons somebody for contempt of court for maintaining dignified silence,” Murray wrote. “Chelsea has also done a great service in finally stripping away the last vestige of excuse from the figures who refuse to support Julian Assange, pretending that they do not believe he faces extradition to the United States, and that the legal issue is not about WikiLeaks’s right to publish.”

Prosecutors have said that the Assange grand jury has no link to the investigation of Robert Mueller, though both would have a shared interest in seeing Assange prosecuted. ★

Amazon Bans More Books by Respected Scholars

- Author suggests putting Jeff Bezos on trial for treason

The First Amendment to the Constitution of the United States of America—and American tradition—enshrines freedom of speech and freedom of the press. Nowhere is this more evident than in the book publishing industry. Historically, few books have been banned or restricted in America for any reason other than obscenity or indecency, and even those restrictions have largely collapsed. Since the mid-1960s, a book can only be banned if a reasonable person would consider it prurient, in violation of contemporary community standards, and completely devoid of literary, artistic, political, or scientific value.

But since 2017 our tradition of freedom from book censorship has been annihilated. We are living through the worst-ever assault on the Bill of Rights. This crime is being committed by a monopoly in service to an organized crime syndicate. Amazon, under pressure from the Anti-Defamation League (ADL) and allied groups, has “kindled” the biggest book-burning bonfire ever. On March 11, Amazon—which holds an effec-

As a result, we cannot offer this book for sale.”

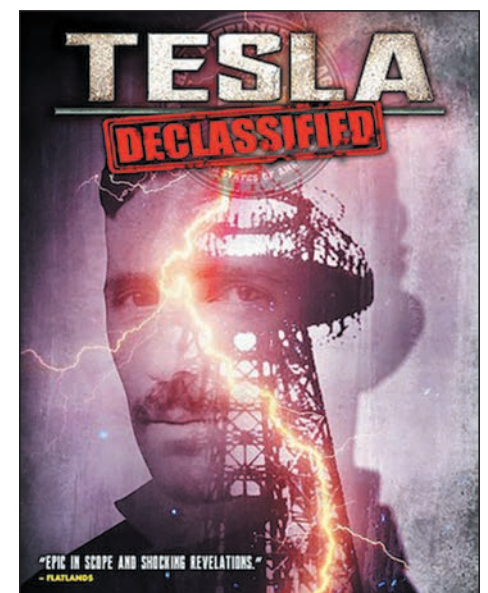

In his article “American Pravda: Amazon Book Censorship: Banning Black Historiography During Black History Month” Ron Unz discusses Amazon’s scandalous banning of the NOI Research Group’s multi-volume series *The Secret Relationship Between Blacks and Jews*. Volume 3 of that series convincingly exposes the ADL as an organized crime syndicate founded to protect the Jewish rapist and murderer Leo Frank.

The Internet is seen as a savior that will take over the function of honest reporting and free speech now that the print and TV media serve as the Ministry of Propaganda. If Jeff Bezos keeps spitting on our Constitution, we must nationalize Amazon—and try Bezos for treason.

for the person, who still has to be careful to express the current opinion of the moment and not yesterday's version or the one an hour ago.

The result is an unsupporting milieu for truth. In the 21st-century Western world, it is impossible to tell the truth and not be demonized. Demonization of truth scares away those who have been taught that they cannot have an opinion of their own.

If the American people, indeed the Western world, are to have a future, it will be due to websites that promote unfettered debate.

House Passes 'Intolerance' Resolution

• Comments by Muslim legislator spur Congress to violate spirit of First Amendment

On March 7, just after AFP went to press, the House of Representatives overwhelmingly passed a resolution condemning “anti-Semitism,” anti-Muslim discrimination, and bigotry against minorities “as hateful expressions of intolerance that are contrary to the values and aspirations of the United States.”

The resolution, the second such resolution approved by the House in the past two months that explicitly denounces “anti-Semitism,” came in response to comments made by Rep. Ilhan Omar (D-Minn.), a Somali-born freshman congresswoman who has been critical of the pro-Israel lobby and the potential dual loyalty members of Congress hold in relation to Israel. Omar’s statements have been widely condemned by government officials, congressional representatives, media pundits, and political commentators across the political spectrum as “anti-Semitic” in nature, despite the entirely legitimate points she has raised.

It is important to note that Omar never once mentioned “Jew” or “Jewish” in either of her purportedly controversial statements.

Omar first ran afoul of the pro-Israel lobby and its supporters in Washington when she said support for Israel and its powerful lobby was “all about the Benjamins” [i.e., Benjamin Franklin as he is pictured on a \$100 bill] meaning the huge donations legislators receive from the pro-Israel community.

On March 3, Omar again ran into trouble when she took to Twitter in response to comments made by Rep. Nita Lowey (D-N.Y.) that Omar had

“mischaracterized support for Israel.” Omar tweeted: “I should not be expected to have allegiance/pledge support to a foreign country in order to serve my country in Congress or serve on committee.”

The recently passed resolution expressly condemns the so-called “anti-Semitic trope” regarding “dual loyalties,” arguing that such accusations “generally have an insidious and pernicious history.”

“Whether from the political right, center, or left, bigotry, discrimination, oppression, racism,

and imputations of dual loyalty threaten American democracy and have no place in American political discourse,” the resolution declares.

It goes on to explicitly denounce white supremacists, citing the Unite the Right rally as an alleged violent manifestation of white supremacy, the mass shooting at the Emanuel African Methodist Episcopal Church in Charleston, S.C. in June 2015 carried out by a young man with white nationalist views, and the more recent mass shooting at the Tree of Life Synagogue in Pittsburgh carried out by a radicalized man who reportedly stated he “wanted all Jews to die.” The resolutions describes “anti-Semitism” as a “centuries-old bigotry and form of racism faced by Jews simply because they are Jews,” and states that “it is a foreign policy priority of the United States to monitor and combat anti-Semitism abroad.”

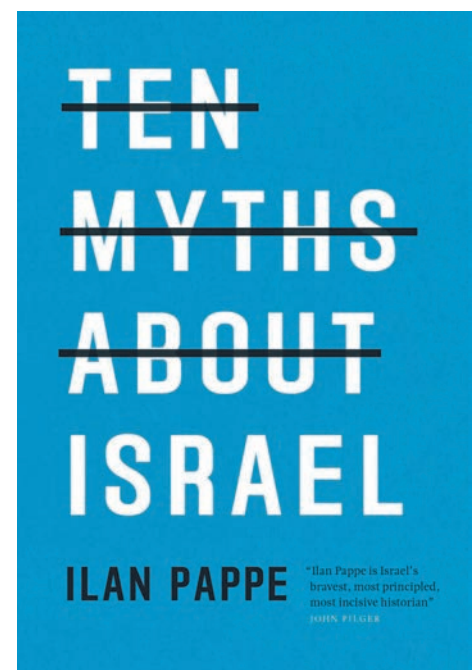
Earlier this year, President Donald Trump appointed Elan Carr, a Jewish former prosecutor based in Los Angeles, to serve as the special envoy for monitoring and combating anti-Semitism, an official position in the State Department which “was created by law and designed to protect the Jewish people throughout the world,” according to Carr. The position had been left unfilled by the Trump administration for the previous two years.

The House resolution passed by a vote of 407 to

23, with Rep. Steve King (R-Iowa) simply voting present. The 23 “No” votes came exclusively from Republicans, including notable figures such as Liz Cheney (R-Wyo.), Mo Brooks (R-N.Y.), Mike Conway (R-Texas), and Lee Zeldin (R-N.Y.), among others.

The resolution was initially designed to exclusively denounce “anti-Semitism” and to call Omar out by name as trafficking in “anti-Semitic tropes” that are “contrary to American values.” After push-back from a number of progressive Democratic allies of Omar, the resolution evolved into a broader denunciation of multiple forms of bigotry and discrimination, including “anti-Semitism,” Islamophobia, and other forms of discrimination against minorities, prompting the “No” votes from Republicans.

The pro-Israel community also expressed mixed emotions to the resolution, with some organizations and leaders praising the bill and others more critical. The Anti-Defamation League praised the resolution. ADL CEO Jonathan Green-

blatt—whose organization pressured House Speaker Nancy Pelosi to take action—announced his organization was pleased that the House “took a firm stance against anti-Semitism, including making an explicit statement rejecting the pernicious myth of dual loyalty and other vile slurs that have been used to persecute Jews for centuries,” according to a press release issued by the organization. The Simon Wiesenthal Center, on the other hand, was critical of the resolution.

“While we commend Speaker Nancy Pelosi’s decision to bring to the floor the issue of anti-Semitism within its ranks, the politically expedient resolution failed to call out Representative Omar by name and failed to take into account the historically unique dimensions of the anti-Semitic themes trafficked by Rep. Omar,” the organization said in a statement. ★

Israeli Accountability Begins Now

• Spying for the Israeli government has turned into a “get-out-of-jail-free card”

Recently returning to the U.S. on a flight from Venice, too-bored-to-read syndrome drove me to watch a movie. I chose *Bohemian Rhapsody*, which recently won an Academy Award for lead actor Rami Malek, who truly did turn in a memorable performance in a film that was otherwise plodding and predictable. As the credits were rolling, I noticed that the movie’s executive producer was none other than Arnon Milchan, an Israeli media billionaire who has spent most of his career in Hollywood. My immediate thought was, “Why is this scumbag still making movies in Hollywood? Why isn’t he in jail?”

Milchan earned my opprobrium the easy way, by spying for Israel to the detriment of the country that has made him rich and relatively famous, which is the United States of America. The Milchan tale is just one part of the successful effort by Israel to obtain the technology and raw materials for its secret nuclear arsenal. Preventing nuclear proliferation was a major objective of the U.S. government when in the early 1960s President John F. Kennedy learned from a CIA report that Tel Aviv was developing a nuclear weapon. He told the Israelis to terminate their program or risk losing American political and economic support but was killed before any steps were taken to end the project.

Israel always features prominently in the annual FBI report called “Foreign Economic Collection and Industrial Espionage.” The 2005 report stated that, “Israel has an active program to gather proprietary information within the United States. These collection activities are primarily directed at obtaining information on military systems and advanced computing applications that can be used in Israel’s sizable armaments industry.”

The Mossad frequently uses so-called *sayanim*

in its espionage, which means diaspora Jews that it recruits on the basis of a shared religion or concern for the security of Israel. The threat coming from Israeli embassy operatives inside the United States is such that the Department of Defense once warned that Jewish Americans would likely be the targets of intelligence approaches.

Israel accelerated its nuclear program after the death of Kennedy. By 1965, it had obtained the raw material for a bomb consisting of U.S. government-owned highly enriched weapons-grade uranium obtained from a company in Pennsylvania called NUMEC, which was founded in 1956 and owned by Zalman Mordecai Shapiro, head of the Pittsburgh chapter of the Zionist Or-

ganization of America. NUMEC was a supplier of enriched uranium for government projects but it was also from the start a front for the Israeli nuclear program, with its chief funder David Lowenthal, a leading Zionist, traveling to Israel at least once a month where he would meet with an old friend, Meir Amit, who headed Israeli intelligence. NUMEC covered the shipment of enriched uranium to Israel by claiming the metal was “lost,” losses that totaled nearly 600 pounds, enough to produce dozens of weapons. Such was the importance of the operation that in 1968 NUMEC even received a private incognito visit from spymaster Rafi Eitan.

Also, there was physical evidence relating to the diversion of the uranium. Refined uranium has a technical signature that permits identification of its source. Traces of uranium from NUMEC were identified by Department of Energy inspectors in Israel in 1978. The Central Intelligence Agency has also looked into the diversion of enriched uranium from the NUMEC plant and has concluded that it was part of a broader program to obtain the technology and raw materials for a nuclear device for Israel.

With the uranium in hand, the stealing of the advanced technology needed to make a nuclear weapon is where Milchan comes into the story. Milchan was born in Israel but moved to the United States and eventually wound up as the founder-owner of a major movie production company, New Regency Films. In a Nov. 25, 2013 interview on Israeli television Milchan admitted that he had spent his many years in Hollywood as an agent for Israeli intelligence, helping obtain embargoed technologies and materials that enabled Israel to develop a nuclear weapon. He worked for Israel’s Bureau of Science and Liaison Acquisition division of Mossad, referred to as the LAKAM spy agency.

Milchan, a long-time resident of the United States who clearly still has significant business interests in this country as evidenced by “Bo-

hemian Rhapsody,” explained in his interview, “I did it for my country, and I’m proud of it.” He also said that “other big Hollywood names were connected to [his] covert affairs.” Among other successes, he obtained through his company Heli Trading 800 krytons, the sophisticated triggers for nuclear weapons. The devices were acquired from the California top-secret defense contractor MILCO International. Milchan personally recruited MILCO’s president Richard Kelly Smyth as an agent before turning him over to another Heli Trading employee Benjamin Netanyahu for handling. Smyth was eventually arrested in 1985 and cooperated in his interrogation by the FBI before being sentenced to prison, which means that the federal government knew all about both Milchan and Netanyahu at that time but did not even seek to interview them and ultimately did nothing about them.

I would like to think that the next time Milchan arrives at Los Angeles International Airport on business he will be met by federal marshals and FBI agents before being whisked off to some nice, quiet place for a chat. But don’t bet on it. Milchan is possibly no longer traveling regularly to the U.S., though he retains a residence in California, and his “confession” suggests that he believes himself to be bulletproof. He has also recently been involved in a bit of controversy in Israel itself, where the police have recommended that he be charged with bribery connected with the ongoing investigation of corruption by Prime Minister Benjamin Netanyahu. Milchan, it seems, spent one million shekels (\$250,000) on luxury items that he gave to Bibi as a reported *quid pro quo* to exempt his substantial income from taxes when he returned to Israel to live in 2013.

In an interesting additional element to that story, the police investigation determined that in 2014 Netanyahu approached then-Secretary of State John Kerry to intervene and arrange for a long-term American visa for Milchan, who was at the time dealing with difficulties relating to his U.S. status, possibly due to the 2013 admission that he had been spying. In any event, the visa was granted and Milchan continued to make

more movies, and money, in Los Angeles.

The tragedy is that spying for Israel appears to be regarded as something like a victimless crime, but in the case of Milchan it was dead serious, involving as it did nuclear proliferation on behalf of a nation that might generously be described as aggressively paranoid. And note that Netanyahu, the very “statesman” who received 29 standing ovations from Congress, was also involved in the major Mossad operation to steal from the United States. In fact, even though the Israelis

continue to rob America blind, it is extremely difficult to be punished for doing so.

Prosecutions for Israeli spying are so few because the Department of Justice is unwilling to pursue them, according to a retired FBI agent who claimed that hundreds of potential prosecutions were rejected for political reasons. The actual convictions involve crimes so egregious that they cannot be ignored or covered up, like conversations overheard at lunch, as when Pentagon analyst Larry Franklin provided intelligence on Iran to American Israel Public Affairs Committee staffers Keith Weissman and Steve Rosen, as well as to officials in the Israeli embassy. Franklin went briefly to jail and was recently reported to be waiting tables in West Virginia. U.S. Navy analyst Jonathan Pollard, America’s most damaging spy of all time, stole enough top-secret codeword material to fill a room before he was arrested and convicted. He obtained Israeli citizenship while in prison and is now free on parole, living in New York City. Apart from that, *nada!*

Time to change all that. Milchan and others are not friends of the United States but quite the contrary, and deserve to be treated like any other spy. The American people should demand that the government begin to recognize that fact and act accordingly. Telling Hollywood that it is not good PR to keep allowing Israeli spy Milchan to make millions is a possibility, but sanctioning him to put him out of business would be an even better place to start. ★

Civil Rights Award Yanked Over 'Anti-Semitic' Remarks

• But leftists OK with Davis's terrorist background

Angela Davis has led a career and a life that has attracted controversies, criticisms, and bans. The most recent was a rescinding of the Fred Shuttlesworth Human Rights Award given by the Birmingham Civil Rights Institute (BCRI). Citing that Davis's opinions and remarks do not "meet all of the criteria on which the award is based," Birmingham Mayor Randall Woodfin decided against the October decision to present the award to Davis.

BCRI's decision comes at a time in the nation's history when political correctness and the wildly shifting levels of "acceptable speech" reach a new, more disturbing apex on what appears on a weekly basis. Davis's new crime of opinion—or "thought crime," in the words of 1984 author George Orwell—was that she has been a long-time vocal supporter of Palestinian rights and the Boycott, Divestment, and Sanctions (BDS) campaign against Israel.

BCRI's decision to rescind the award is surprising, as Davis's views on Israeli state policy and the ideology of Zionism are not new. In his 1992 book *Chutzpah*, attorney Alan Dershowitz famously described Davis's response when he asked her for a public statement in support of a list of political prisoners being held in the USSR.

Davis told Dershowitz that none of the people on his list were political prisoners. "They are all

Former Black Panther member Angela Davis was getting ready to receive a civil rights award for her efforts to get lawmakers to address the issue of prison reform in the U.S., until it was discovered that she had made a disparaging remark about Zionists years ago.

Zionist fascists and opponents of socialism," Davis explained.

Davis, an icon of the 1960s Black Panther Party, has also referred to the Israeli "occupation" of Palestine and has compared the Israeli treatment of Palestinians to American police shootings of African-Americans. She comes from a larger-than-life era where slogans, key words, and political posters ruled the day. She, like many others from that same era, speaks in anecdotes and analogies.

In 1969, Gov. Ronald Reagan (R-Calif.) attempted to have Davis banned from teaching at California universities because of her affiliation with the Communist Party USA (CPUSA). She was twice a candidate for vice president on the CPUSA ticket in the 1980s when Reagan was president. She left the CPUSA when it supported the Soviets' 1991 "August Coup" attempt. The coup was led by communist hardliners attempting to wrest control from Mikhail Gorbachev.

In the new millennium, Davis has worked largely in support of the prison abolition movement. She co-founded Critical Resistance (CR) to build a groundswell of grassroots supporters dedicated to working against the "prison-industrial



complex." CR's efforts are focused on building "engaged communities" that can educate and heal people rather than caging them.

There has been a reflexive reaction by conservatives to support the rescinding of the award. In a parallel story, there has also been conservative (and some liberal) support to admonish Rep. Ilhan Omar (D-Minn.) for her comments explaining both the definition of an Israeli lobby and her criticism of politicians who, for financial reasons, would adhere to the demands of a foreign lobby. President Donald Trump ridiculously called for Omar's resignation. (See related story, pp. 12-13.)

Criticizing Davis and Omar is certainly within the bounds of free speech in a constitutional republic. The danger comes in the quick, negative labeling of people and politicians. When Republicans are irrationally labeled as "racist," "sexist," "homophobic," or "jingoistic," they rightly balk and demand retractions. So, is the quick labeling of Davis and Omar as "anti-Semitic" a tit-for-tat for Republicans wanting to turn the linguistic tables? If it is, it's a petty lesson that will not be learned, no matter how many times it is taught. Instead, mouthpieces from both parties should realize how unconstructive it is to promote labels over arguments and verbal stings over vast solutions.

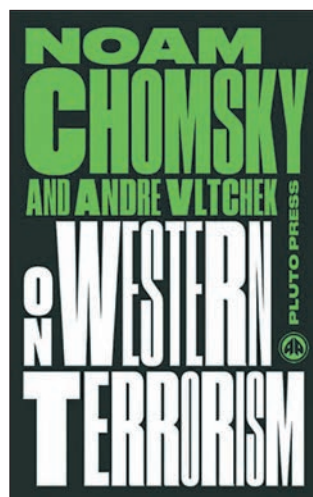
The rescinding of Davis's award was a sloppy public relations *faux pas* by local politicians who believed they were doing the politically correct thing for the sake of political correctness, to maintain their wholly unoffensive PC cred. Who's After Golan Heights Riches?

• Prominent American neocons, state of Israel have eyes on Syrian energy reserves

A planned push by U.S. senators to recognize Israel's claim to the Golan Heights hides an effort by rich, powerful neocons and their Israeli backers to seize energy riches from what international law declares is part of Syria.

Sen. Lindsey Graham (R-S.C.) toured the Golan Heights on March 11 with Israeli Prime Minister Benjamin Netanyahu and declared that the Golan Heights had a rich Jewish history and was part of the state of Israel. Had he checked history books and a map of the region he would have learned that the Golan Heights are situated in southeastern Syria, bordering the Sea of Galilee, Israel's main source of drinking water. In 1894, efforts to colonize the Golan Heights by Jewish banker Edmond de Rothschild were thwarted by Arabs and Ottoman Empire laws restricting foreigners from settling the area.

None of this seems to matter to Graham and Sens. Ted Cruz (R-Texas), and Marco Rubio (R-Fla.), the trio at the forefront of arguing that Congress should pass legislation giving Israel the Golan irrespective of international law. In tandem

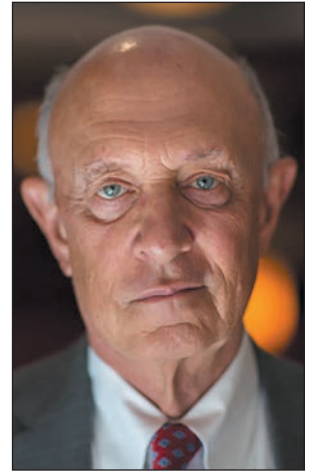

with their effort, the U.S. State Department has stopped referring to the area as Israeli-occupied territory and instead calls it Israeli "controlled territory"

Netanyahu, facing criminal prosecution and an upcoming election, would love nothing better than a U.S. declaration that the Golan Heights is now Israel's. His friends in Washington, including President Donald Trump's son-in-law advisor Jared Kushner and Secretary of State Mike Pompeo, appear ready to give him that gift. But there is a sinister motive for a sudden gifting of the Golan Heights to Israel, and it has its genesis in plans that took shape years before Trump entered the White House. It concerns a neocon strategy, ongoing now for almost a decade, to access oil and gas riches under the Golan Heights.

It began with powerful neocons and their friends in Israel deciding that the best way to get full control of the Golan Heights was to call for regime change in Syria so that there would be no Syrian leadership around to continue petitioning the UN on the issue. Despite many UN resolutions telling Israel to give back the territory, it has refused to do so, with Washington's backing on the Security Council. In recent years, Netanyahu has done everything possible to take down the Assad regime in Syria, even training and arming al-Nusra terrorists. He also ordered hundreds of bombing runs against targets in Syria, arguing that he was eliminating Iranian and Hezbollah forces there.

His security issue was a ruse. In 2011, a little-known American company called Genie Energy, based in New Jersey, was granted rights to illegally explore 153 square miles of the Golan Heights for oil and gas. It was part of the IDT Corporation until it was registered as a separate entity on the New York Stock Exchange.

The membership of Genie Energy's Strategic Advisory Board testified to its neocon lineage. Prominent on the board were Dick Cheney, media mogul Rupert Murdoch, former CIA director James Woolsey, senior partner in Genie Energy

Jacob Lord Rothschild, billionaire hedge funder and member of the Washington-based Foundation for the Defense of Democracies Michael Steinhardt, Bill Clinton's energy secretary Bill Richardson, and Larry Summers, Treasury secretary under Bill Clinton. The Israeli subsidiary of Genie is now run by former Israeli Gen. "Effie" Eitam, a close buddy of Netanyahu who lives in one of the large Jewish settlements on the Golan Heights. Eitam is an extreme religious figure who has recommended removing all Israeli Arabs from Israel.

By 2013, as the war in Syria raged and the U.S. pushed for regime change with Israel's backing, Netanyahu and Genie Energy knew from surveys of the Golan Heights that it held massive energy reserves. It was confirmed by a geologist with Afek Oil & Gas, Genie Energy's Israeli subsidiary.

With Trump in the White House, there has been a renewed push by Genie Energy and its Israeli backers to convince members of the Senate to change policy on the Golan Heights to favor Israel, claiming it is really Jewish territory and is therefore strategic to the defense of the state of Israel. Missing from the storyline is the massive wealth waiting to be snapped up.

Ryan Zinke, Trump's former interior secretary, who is under federal investigation, knew about the energy potential in the Golan Heights when he visited the region in 2017. He met with Eitam, who was then a politician running Afek. Eitam said their meeting had been arranged by a friend in Montana, and that they never discussed energy issues, a story few believed.

It's unlikely the back story of Genie Energy will dissuade anyone in the Senate or the White House from doing Netanyahu's bidding, especially after Graham declared that the Golan Heights was already part of the state of Israel and had a rich Jewish history. He deliberately ignored the fact that it is illegally occupied territory with a rich Syrian Arab history. ★

'Green Energy' Badly Failed Recent 'Polar Vortex Test'

• Wind turbines actually consumed power in Arctic blast

The polar vortex of extremely cold weather this winter severely tested the newly proposed Green New Deal policies, and we now know that these policies failed miserably.

Many Democrats, including U.S. Rep. Alexandria Ocasio-Cortez (D-N.Y.) and several presidential candidates, support a Green New Deal, which would phase out the use of all coal, natural gas, and oil and replace them with green energy. Proving just how wrongheaded those policies are, solar and wind power performed very poorly during the storm while coal, natural gas, and nuclear power helped keep the lights and heat on for the vast majority of people.

Just how bad was green energy's performance during the storm?

In an area stretching from Minnesota to Iowa, wind turbines went from supplying about half of the electricity one day to providing less than 3% the next—at a time when people needed energy the most. What caused this dramatic swing in energy output? Most turbines automatically shut down once temperatures reach -20° F. Even worse, not only did the turbines stop producing power, they actually started to consume power for heat to avoid damage.

Solar energy production also collapsed. Due to snow cover, Xcel Energy's solar panels only produced 8% to 10% of their potential output.

In addition to the massive problems with green energy production, there were also some

problems with natural gas. Natural gas-powered plants were hampered in their efforts to generate more electricity due, in part, to freeze-offs. Freeze-offs occur in cold weather when water and other liquids freeze at natural gas wells, and they can cause natural gas shortages and price spikes. Freeze-offs are just one more reason why more pipelines are needed, but the left still opposes them.

Because of the energy production problems, businesses and consumers were asked to reduce their energy use. This is called demand response. For example, Xcel Energy asked some Minnesota residents to turn down their thermostats to 55° F. Other Minnesotans were asked to turn down their heat to 63° F. The Michigan governor asked most state residents to turn down their thermostats to 65° F. In response to requests like these, GM shuttered 13 facilities. Fiat Chrysler closed two plants. Ford cut back production at three facilities.

Environmentalists seem to think that demand response is a perfectly fine way to deal with extremely cold weather. Of course, this overlooks the fact that workers at shut-down businesses might need their missing wages and that some people, including many of the elderly, get cold easily so turning their heat down is more than a minor inconvenience.

The goal should be to build a robust electric grid that is capable of meeting demand on the hottest summer days and the coldest winter nights, with additional reserves to cover contingencies. Just planning to have sufficient power to handle normal circumstances and then urging people to muddle through harsh weather

in the northern U.S. is not acceptable.

To deal with the intermittent supply of solar and wind power, some green energy supporters want to connect regional grids into a national grid. By connecting the regional grids, grid operators would have more options for avoiding outages and dealing with excess energy. While a national grid may or may not be a good idea, environmentalists often oppose the high-voltage lines that would likely be used to connect the regional grids.

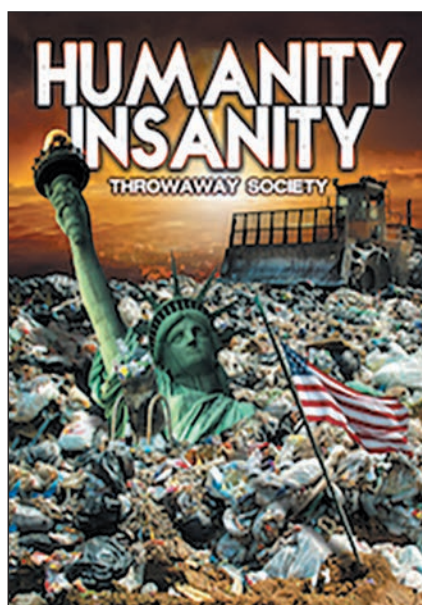
The facts are clear from the polar vortex. Even in the worst of conditions, coal and nuclear power are reliable. Natural gas is less so, but it is still fairly reliable. On the other hand, green energy is still unreliable, and depending upon it is foolish and dangerous.

Of course, liberals will learn nothing from this storm and will continue to push for the costly Green New Deal. To protect lives and our economy, these policies must be defeated. ★

values we hope to instill in the world,” Cohen said in a statement.

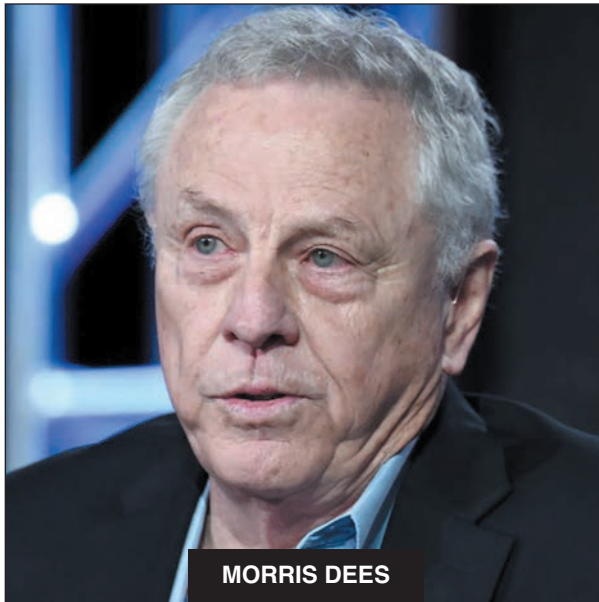
In the *Montgomery Advertiser*, Dees was quoted as saying: “I refuse to say anything negative about the center or its employees. I’ll let my life’s work and reputation speak for itself.”

His life’s work speaks for itself, indeed. In 1994, Dees was accused of mistreating the organization’s minority employees who said they “felt threatened and banded together,” as local media reported at the time, even while the SPLC has preached nonstop that the slightest alleged misstep against minorities is on par with a KKK lynching.

Worst of all, Dees molded the SPLC into a rogue agency, which, armed with its “Hatewatch” list and map of alleged “hate groups,” has routinely black-listed scores of individuals and organizations while acting as a dominant source of information for media, law enforcement, and many large corporations.

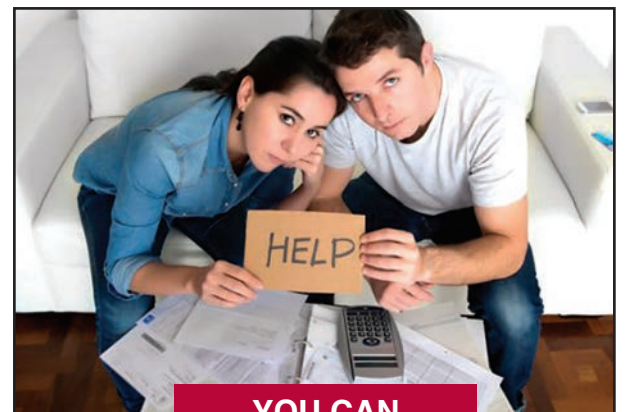

Do We Know What Spawned the Christchurch Massacre?

On March 15, in Christchurch, New Zealand, one of the more civilized places on Earth, 28-year-old Brenton Tarrant, an Australian, turned on his cellphone camera and set out to livestream his massacre of as many innocent Muslim worshippers as he could kill.

Using a semi-automatic rifle, he murdered more than 40 men, women, and children at one mosque, drove three miles to another, and there killed more, 50 in all. Dozens are still wounded, suffering, and dying. An atrocity and act of pure evil by a man with a dead soul. Yet, predictably, within 48 hours, the president of the United States was being publicly indicted as a moral accomplice.

Donald Trump, it was said, used a word, “invasion,” to describe the 76,000 migrants caught illegally crossing the U.S. border in February. At the same time, the killer used that word to describe the Muslim migration into the West. The killer also mentioned Trump in his 74-page manifesto.

What further need have we of proof? Trump also failed to express America’s revulsion and his country’s condolences to Muslims everywhere, and failed to denounce the “white nationalist” ideology that motivated the killer.

From there, it was a short jump to declare that we Americans have too long ignored this growing menace. Charlottesville, where a woman protester was run over by a neo-Nazi, was trotted out again and again.

But does the vision of America as a country where white racism is rampant and an unleashed white nationalism is a scourge that is running amok correspond with reality?

America’s elites are familiar with the Acela Ex-

press, the train that runs from D.C.’s Union Station to Penn Station in New York.

In which of the five Eastern Seaboard cities at which the Acela stops to take on and discharge passengers—Washington, Baltimore, Philadelphia, Newark, New York—are white nationalists responsible for a significant share of the assaults, robberies, rapes, and shootings?

Chicago may lead the nation in total gun deaths. But the murder rate was highest in 2018 in St. Louis, Baltimore, Detroit, New Orleans, and Kansas City. In how many of these cities are Klansmen and neo-Nazis regularly hauled in for violent crimes?

As for the mass murders of our new century, the racist right has perpetrated its share. Dylann Roof’s killing of the black women and men at the Charleston church qualifies, as does the massacre of Jews at the Tree of Life synagogue in Pittsburgh. Yet a Muslim major, Nidal Hasan, fatally shot 13 soldiers at Fort Hood. In the 2015 San Bernardino massacre, Syed Farook and Tashfeen Malik carried out that attack that left 14 dead and 22 wounded.

According to *Forbes*, of the 18,814 deaths caused by terrorists around the world in 2017, well over half were due to the actions of four groups: Islamic State, the Taliban, Al-Shabab, and Boko Haram. All are Sunni Muslim; none are alt-right.

Undeniably, atrocities that exceed in bloodshed the St. Valentine’s Day Massacre by Al Capone’s gang, where seven men were stood against a wall in a Chicago garage and executed, have become all too common. But the atrocities seized upon by the left as most representative are those that conform to vision, a narrative, a pre-existing script. This preconceived idea is that America is a hotbed of white nationalism where the worst crimes are committed by white racists. And

this is a myth.

Now, there are no excuses, or defenses, for what happened in Christchurch. But there is an explanation. All peoples to some degree resent and resist the movement of outsiders into their space. Some migrants are more difficult than others to assimilate into Western societies. European nations that had not known mass migrations for centuries were especially susceptible to a virulent reaction, a backlash. Americans, after all, reacted viscerally to the Irish migration of 1845-1849, and, again, to the Great Migration from Central and Eastern Europe from 1890 to 1920. Inter-ethnic violence was not uncommon.

Our leaders in the 1920s understood this and took steps to halt the migrations until those who had come could be assimilated, and, in a word, Americanized. It worked. By 1960, we were a united people. Then, without the people’s consent, the great experiment began:

America’s doors were thrown open to peoples of every religion, race, culture, and creed, to create a different nation that mirrored all mankind in its diversity, in author and commentator Ben Wattenberg’s phrase, a universal nation. The problem: A universal nation is a contradiction in terms. A nation of all races, religions, and tribes had never before existed.

The liberal democracies that embraced this ideology, this idea, are at war with human nature, and are losing this war to tribalism and authoritarianism.

As for Christchurch, unfortunately, such horrors appear to have become the new normal. But Brenton Tarrant alone is responsible for what he did. And it was not Trump but the New World Order globalists who fertilized the soil that spawned him. ★

'Take the Guns First, Worry About Due Process Later,' Says Trump

• Bipartisan attacks against Second Amendment are troubling

The U.S. House of Representatives recently passed legislation that would expand the national background check system to require almost everyone selling firearms, including private collectors who supplement their incomes by selling firearms at gun shows, to perform background checks on potential buyers. The bill has a section purporting to bar creation of a national firearms registry; however, the expanded background check system will require the government to compile lists of those buying and selling guns. In other words, it creates a *de facto* national gun registry.

Similar to the experience with other types of prohibition, making it more difficult to legally buy a gun will enhance the firearms black market. Criminals, terrorists, and even deranged mass shooters will thus have no problem obtaining firearms.

It is no coincidence that the majority of mass shootings take place in "gun-free zones," where shooters know their targets will be unarmed. This shows that any law making it more difficult for Americans to own and carry firearms makes us less safe. If Congress really wanted to reduce the incidence of gun violence, it would repeal the Gun-Free School Zones Act. This law leaves children easy prey for mass shooters by mandating that public schools be "gun-free zones."

A nationwide system of gun registration could be a step toward national gun confiscation. However, antigun bureaucrats need not go that far to use the expanded background check system to abuse the rights of gun owners. Gun owners could find themselves subject to surveillance and even harassment, such as more intensive screening by the Transportation Security Administration, because they own "too many" firearms.

Republican control of the White House and the Senate does not mean our gun rights are safe. Republicans have a long history of supporting gun control. After the 1999 Columbine shooting, many Republicans, including many who campaigned as being pro-Second Amendment, eagerly cooperated with then-President Bill Clinton on gun control. Some supposedly pro-gun Republicans also tried to pass "compromise" gun control legislation after the Sandy Hook shooting.

Neoconservative Sen. Marco Rubio (R-Fla.) has introduced legislation that uses tax dollars to bribe states to adopt red-flag laws. Red-flag laws allow government to violate an individual's Second Amendment rights based on nothing more than a report that the individual could become violent. Red-flag laws can allow an individual's guns to be taken away without due process simply because an estranged spouse, angry neighbor, or

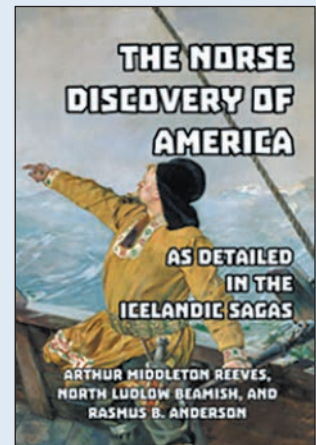

disgruntled coworker tells police the individual threatened him or otherwise made him feel unsafe.

President Donald Trump has joined Rubio in wanting the government to, in Trump's words, "take the guns first, go through due process second." During his confirmation hearing, Trump's new Attorney General William Barr expressed support for red-flag laws. Leading gun-control advocate Sen. Dianne Feinstein (D-Calif.) has expressed interest in working with Barr to deprive gun owners of due process. It would not be surprising to see left-wing authoritarians like Feinstein work with right-wing authoritarians like Barr and Rubio on "compromise" legislation containing both a national red-flag law and expanded background checks.

My years in Congress taught me that few politicians can be counted on to protect our liberties. Most politicians must be pressured to stand up for freedom by informed and involved pro-liberty citizens. That is why those of us who understand the benefits of liberty must remain vigilant against any attempt to erode respect for our rights, especially the right to defend ourselves against private crime and public tyranny. ★

Dali's 'Crucifixion'

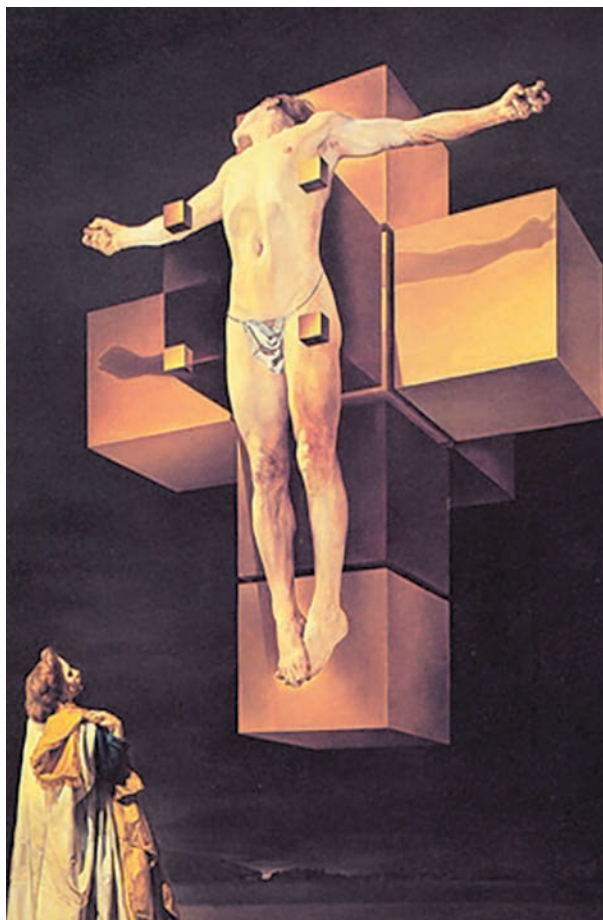
drew rave reviews at museums everywhere, including the Metropolitan Museum of Art, where Ayn Rand contemplated this gripping painting for hours!

Photographer Howell Conant (Grace Kelly's favorite) hired me for *Sports Illustrated* and newspaper magazine ads for Janzen bathing suits. Three body shots and my large hands revealed I was the Dali model... resulting in half-time football ads for cars and Viceroy with Don Ameche's nephew Alan (Baltimore Colts). Later, American Cancer Society founder Elmer Bobst came to my home with Beth Walker (Coca Cola model) and Otto von Bolschwing (helped Allen Dulles/CIA bring 1,000 German scientists to the U.S. after WWII). By the way, UFO's are real, with a viewing only 50 feet over my home! After WWII, as a double agent, Otto became a US citizen employed by Elmer Bobst (Warner Lambert/Pfizer).

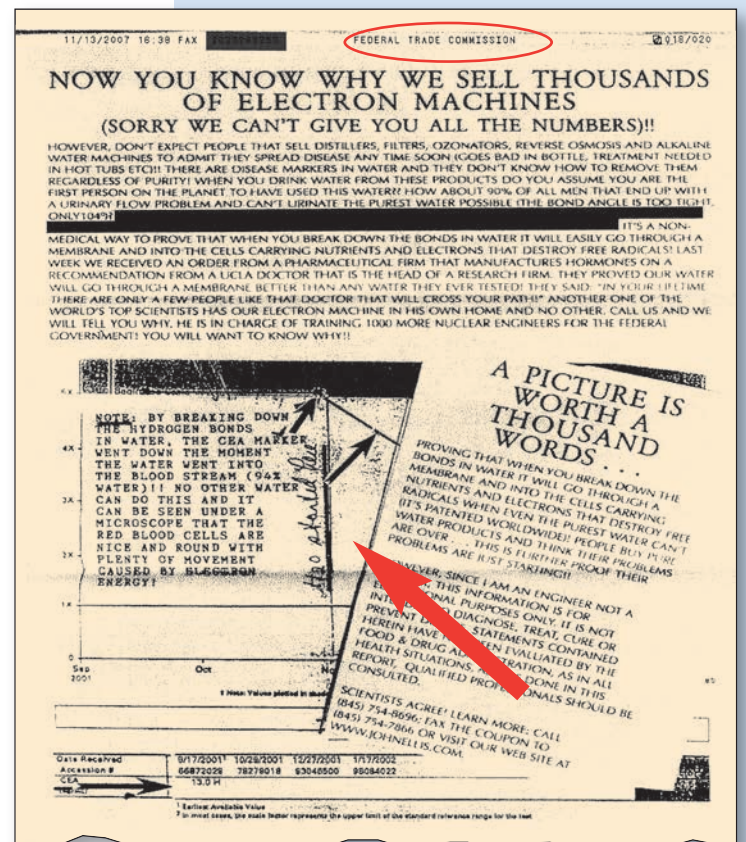

Trump's Bloated Budget: The Good, the Bad & the Ugly

The \$4.7 trillion 2020 budget request released March 11 by the White House entitled “A Budget for a Better America: Promises Kept, Taxpayers First” seeks to fulfill several of President Donald Trump’s campaign pledges such as strengthening border defense and immigration policy, spending more for veterans’ healthcare, and boosting military spending.

Interestingly, the spending plan also would require universities receiving federal funds to bear part of the burden servicing student loans. And, among other things, the plan—which still must go through Congress and applies to the fiscal year which begins Oct. 1—would curb wasteful spending while predicting a balanced budget by 2034, based on a projected \$2.7 trillion in spending cuts, “higher than any other administration in history,” the White House claims.

Regarding the border, a White House press release on the budget notes:

The Federal Government must employ all lawful means to enforce the immigration laws of the United States and reduce the flow of illegal aliens and illegal drugs into the country. The budget requests the resources necessary to continue constructing physical barriers on the border [and] increases the manpower of [Im-

migration and Customs Enforcement] and [Customs and Border Protection].

The plan seeks \$5 billion from the Homeland Security budget and \$3.6 billion from military construction funds for the border wall's continuation and another \$3.6 billion for military construction to replace money Trump intends to shift this year to border-wall construction.

In a related matter, the budget request “proposes policy changes to end sanctuary cities,” the press release added. This poses a challenge to ultra-liberal mayors in some of the nation’s largest cities who’ve helped illegal immigrants, including those suspected of serious crimes, avoid capture.

As for veterans’ care—although ending America’s interventionist military policy altogether would stem the flow of maimed and mentally unstable veterans—the White House did announce:

The President’s Budget invests over \$80 billion to ensure our veterans receive world class healthcare; a nearly a 10% increase from FY 2019 levels. In addition, the . . . budget makes significant investments in veteran rehabilitation services, education and employment assistance, and suicide prevention.

Student loan debt, which cannot be nullified under bankruptcy laws, has entangled college-educated Americans with large, long-term payments and heavy interest charges, forcing many adults to move back home with their parents and work multiple jobs that often are well below the pay grade for which they’re educated.

And while allowing financially strapped college attendees more leeway to challenge the validity and terms of student loans would be ideal, the budget plan does take some initial positive steps. “The budget proposes to hold institutions of higher education accountable for results by requiring colleges and universities to share a portion of the financial responsibility associated with federal student loans to encourage them to improve performance,” it notes.

Other budget features include:

- A “one-time, mandatory investment of \$1 billion for a competitive fund aimed at supporting under-served populations and stimulating employer investments in child care for working families”;

- Paid leave for working parents;
- Investments in “prevention, treatment, research, and recovery” to combat the opioid epidemic;
- Cuts in some mandatory programs. Medicaid would be partly transformed into a grant program, crop-insurance supports would be cut and \$200 billion would be saved via the student loan changes.
- Rooting out Medicare waste, netting \$456 billion over 10 years.

The budget also calls for spending \$750 billion on the military with increased funding for space-based weapons and artificial intelligence.

Trump’s budget letter also informed Congress that the White House seeks to fund what are known as the “National Security Strategy” and “National Defense Strategy.”

The 35-page “National Security Strategy” of 2002, published by the State Department, notes: “We will actively work to bring the hope of democracy, development, free markets, and free trade to every corner of the world,” softly but clearly confirming that a George W. Bush-era neoconservative posture of exporting democracy, even from the end of a gun, remains in place. ★

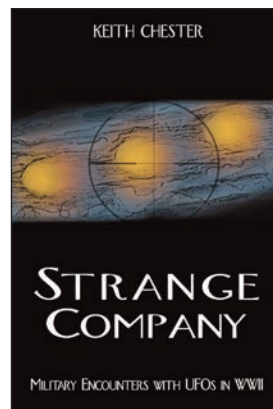

Insider Reveals More Clinton Corruption

• Transcripts of Lisa Page testimony released: Hillary incompetent, Obama crooked

Ranking member of the House Judiciary Committee Rep. Doug Collins (R-Ga.) on March 12 made public the official transcript of former FBI lawyer Lisa Page's July 2018 closed-door testimony before Congress. It included the bombshell revelation that the Obama Justice Department had ordered the FBI to not charge Hillary Clinton with "gross negligence" in her mishandling of classified information. Page described "multiple conversations" led by Attorney General Loretta Lynch about the subject but testified that the department felt it could not "sustain a charge" against the former secretary of state.

As might be anticipated, President Donald Trump quickly took to Twitter, responding, "The just-revealed FBI Agent Lisa Page transcripts make the Obama Justice Department look exactly like it was, a broken and corrupt machine. Hopefully, justice will finally be served. Much more to come!"

Page is hardly a Trump zealot. She was one of those tasked with investigating the fanciful connections between the Russians and Trump.

Anti-Trump text messages between Page and fellow FBI agent Peter Strzok were, in fact, publicized and caused the bureau great embarrassment. The texts were sent on government phones, and in the midst of both Page and Strzok supposedly independently investigating "collusion," and also while they engaged in an extramarital love affair.



Peter Strzok, a top FBI agent involved in the investigation of Hillary's emails, told his lover—fellow FBI agent Lisa Page (above)—in 2016 that the FBI would "stop" Donald Trump from becoming president, according to the Justice Department.

A May 19, 2017 text from Strzok to Page said, "You and I both know the odds are nothing. If I thought it was likely, I'd be there no question..."

There's no big there, there," and was sent only two days after Deputy Attorney General Rod Rosenstein appointed special counsel Robert Mueller. Page admitted, in the same private congressional testimony, that this text was in reference to the supposed Russian "collusion" case. In another text, Strzok raised the subject of impeachment. Page quickly reigned him in, texting back, "We should stop having this conversation here."

Page also expressed her clear fear of Hillary Clinton in an earlier February 2016 text to Strzok, warning him, "She might be our next president. The last thing you need is us going in there loaded for bear. You think she's going to remember or care that it was more DOJ than FBI?"

The animosity both FBI agents held toward Trump was best reflected in a desperate 2016 text from Page, figuratively screaming that Trump was "not ever going to become president, right? Right?!" Strzok confidently responded, "No. No, he won't. We'll stop it."

Strzok would later be fired by the FBI and Page would resign. Their anti-Trump bias is significant, not only because of their work on Russian "collusion," but because they both also worked on the FBI's woeful investigation into Hillary Clinton's missing emails.

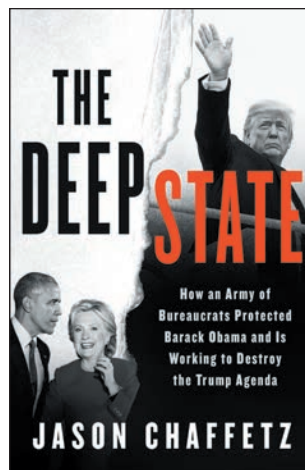
Collins explained to reporters why he released the transcript of Page's testimony: "The president has been unfairly attacked from the moment he was elected in November 2016 on many fronts, and now we're beginning just to see the vast scope of what most of us knew, that Mrs. Clinton was treated completely differently than what we ended up seeing Trump being treated, and that's just wrong. . . . This just shows that there is a two-tiered system."

Lynch had memorably met with Bill Clinton privately on an airport tarmac only five days before the FBI interviewed Hillary Clinton about the emails. Laughably, Lynch attributed the discussion to "a great deal about grandchildren, it was primarily social. . . . There was no discussion on any matter pending before the Department . . . no discussion of State Department emails."

Further details from Page’s closed-door testimony are illuminating as well. Representatives like South Carolina’s Trey Gowdy were very interested in Strzok’s August 2016 text to Page, in which he stated, “I want to believe the path you threw out in Andy’s [McCabe’s] office—that there’s no way he gets elected—but I’m afraid we can’t take the risk. It’s like an insurance policy in the unlikely event you die before you’re 40.” McCabe would respond by saying he didn’t recall discussing such an “insurance policy” with Strzok and Page. Page also expressed the bureau’s belief that Trump would never be elected, testifying, “So this reflects: Let’s be reasonable, let’s not, you know, throw the kitchen sink at this because he’s probably not going to be elected, and so then we don’t have quite as horrific a national security threat than if we do if he gets elected.”

Some conservative outlets, such as the *Washington Examiner*, declared that Page’s testimony might result in the Department of Justice reopening an investigation into Hillary Clinton. While Roger Stone was subjected to a pre-dawn SWAT team raid at his home, Jerome Corsi remains subject to possible prosecution, and Paul Manafort has been sentenced to seven years in prison, Hillary Clinton, Lynch, and other swamp creatures remain free.

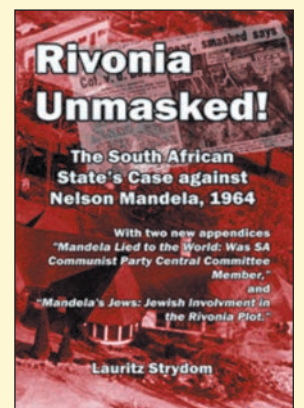

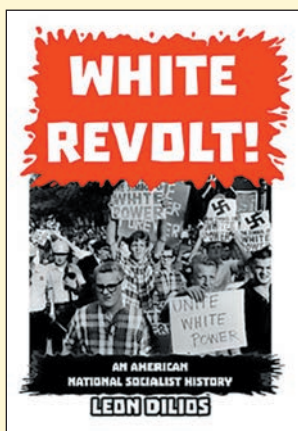

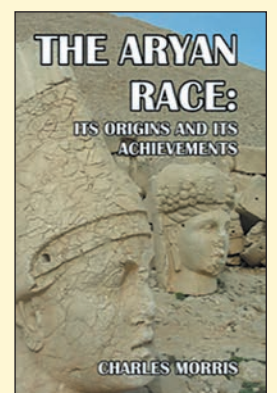
White Revolt! An American National Socialist History

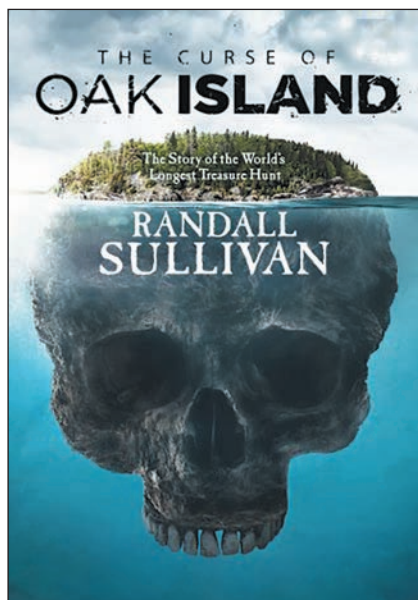

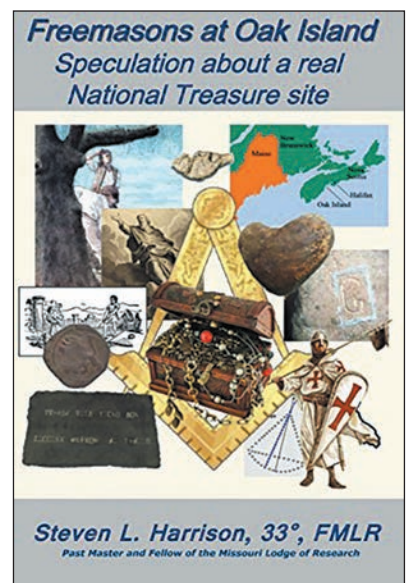

Former Nevada Senator Urges Feds to Do More UFO Research

• Reid says it's time for people to know what government knows

Located due north of Las Vegas, Lincoln County is one of Nevada's largest and most sparsely populated counties. With a population barely surpassing 5,000, Lincoln County, the seventh-largest county in America in land area, does not seem like a bustling metropolis of activity. There are no colleges, no professional sports franchises, no Walmart stores, and few gas stations. A common sight along Route 93 that traverses the county is a faded blue sign that reads "Next Gas 91 Miles." But for close to 30 years now, Lincoln County has been the international hub for UFO enthusiasts as Groom Dry Lake (popularly known as Area 51) is located in the heart of this desert county.

Former Senate Majority Leader Harry Reid (D-Nev.) is among the Silver State's most widely known politicians. As the majority leader through much of the Obama years, Reid was privy to the high-level security concerns of America's post-9/11 society. Now, as reported by KLAS-TV's George Knapp, Reid is calling for formal congressional hearings to study the government's investigations into UFOs.

"I personally don't know if there exists little green men other places. I kind of doubt that, but I do believe that the information we have indicates we should do a lot more study," Nevada's most well-known Democrat said. "We have hundreds and hundreds of people that have seen the same thing—something in the sky; it moves a certain way."

Many will question Reid's qualifications and his sanity, despite the fact that, until 2012, he led a secret Pentagon study of UFOs that was based in Las Vegas. In December 2017, *The New York Times* reported on the AATIP program that had been created to study the UFO phenomena. The AATIP, the Advanced Aerospace Threat Identifi-

cation Program, was the brainchild of Reid and two colleagues in the Senate. It spawned an offshoot, the Advanced Aerospace Weapons Systems Application Program (AAWSAP). Neither discusses UFOs openly, or even by name, but Reid admits that it would take some naivete to just blindly ignore the accumulation of existing stories reported by highly qualified aerospace and aviation professionals. Regarding the origin of whatever unidentified flying objects have been reported, Reid is leery about venturing a guess about something still unknown.

"We do not know," Reid said. "What I have learned is, you can't just hide your head in the sand and say these things are not happening. We have military installations where hundreds and hundreds of people who are there see these things."

Another senator highly interested in the research was Sen. John McCain (R-Ariz.). As the chairman of the Armed Services Committee, McCain had requested all available materials from AATIP.

"Sure, John knew what I was doing," Reid said of the late McCain. "He didn't hide the fact that he was interested, also."

Reid's former deputy, Sen. Richard Durbin (D-Ill.) is now the ranking member of the Defense Appropriations Committee. The defense committee's interest has been piqued, and Reid has his most formidable contacts within those industries.

While scientists and the typically cranky mainstream media have derided using government funds to research "fringe science," Reid appears dedicated to the value of the work still being done at the various levels of government.

One of the more mysterious and fascinating publications undertaken by AATIP concerned research into the invisibility cloaking of aircraft. The Pentagon seems very interested in the possibility of producing aircraft completely invisible to radar; but that, however, has been a project on-

going for 50-plus years. The Pentagon, the released files show us now, is also very interested in the possibility that aircraft can be made literally invisible.

There are certainly practical effects of these studies. Any study into hypersonic speed, aerotracking, and cloaking can also be applied to tracking missiles, for example.

How important has this field of research become for Reid? By law, U.S. senators are barred from lobbying the legislative branch for two years after leaving office. That probationary period ended for Reid in January. Since then, he has been lobbying key Washington, D.C. insiders about UFOs and projects that have to date been shrouded in mystery.

The danger for the American people—and, really, the world—is that this is, in itself, a shrouded program. And if it is, who would be surprised? Just six months after the *Times* released news of the program, President Donald Trump announced Space Force and called upon its establishment as the sixth military branch.

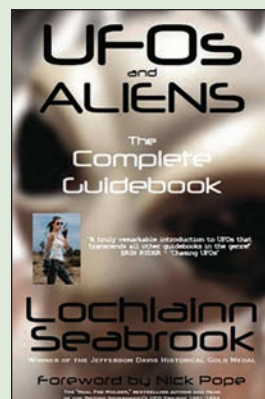
The most systematically skeptical demographic on the political scene are those who read and watch alternative media. On its face, the idea is one amiable to even the most hardcore skeptics who have long wished for some acknowledgment of "disclosure" regarding UFOs.

The skepticism and care that needs to be maintained with Reid's work concerns further militarizing space and using this research and Space Force to do just that. In essence, there is the possibility that the UFO question is the Hollywoodization of what may be a much more sinister program.

There is hope that the Reid revelations are a step in the right direction in the field of UFOlogy. If the program is solely for military purposes, it will not discredit the UFO sightings that have been logged by aerospace and aviation professionals. But if the program is a genuine acceptance of a more open policy regarding UFOs, then we may just find out that the truth is out there, after all. ★

'QAnon' Book Exposes Deep State Agenda

• Powers That Be want Americans divided so we won't unite against them

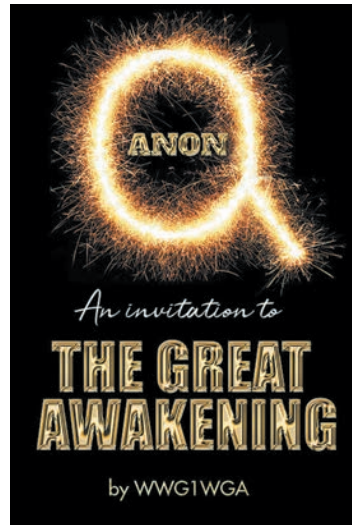
The book *QAnon: An Invitation to the Great Awakening*, written by a group under the collective pseudonym "WWG1WGA," (short for "Q"'s credo "Where We Go One We Go All," was released on Feb. 26. To say that it has shocked the world of publishing would be a severe understatement. It has already garnered an astounding 463 reviews and soared as high as number four overall in Amazon's sales rankings. This was in spite of the fact that "Q" supporters such as podcast radio host Jenny Hatch charged, "Purchasers are being denied the ability to leave both video and text reviews. I purchased the book this morning and tried three times to leave a review and was not allowed. I also uploaded a three-minute video that was rejected by Amazon."

The book quickly caught the attention of the mainstream media, who attacked it with headlines like "'QAnon' book claiming Democrats eat children is climbing the Amazon charts." NBC News echoed this with a March 4 story that bemoaned how the book was currently one slot ahead of Ray Bradbury's *Fahrenheit 451* in sales ranking, declaring that, "The book claims without evidence a variety of outlandish claims including that prominent Democrats murder and eat children and that the U.S. government created both AIDS and the movie 'Monsters Inc.'" The story also emphatically stated, "Adherents of the QAnon conspiracy theory falsely believe that the world is run by a satanic cabal helmed by former presidential candidate Hillary Clinton, and that President Donald Trump and special counsel Robert Mueller are secretly working in tandem to eliminate the cabal."

Vox explained that the book's astonishing success "rewards quick purchases and fervent reviews not quality content." Outlets like *The Hill* grilled Amazon, which declined to comment, regarding the controversial book's placement on its bestseller list.

The QAnon phenomenon has divided most of the alternative right, with an impressive number of hardcore believers on one side, and an equal number of skeptics on the other. *QAnon: An Invitation to the Great Awakening*, in the words of one Amazon reviewer of the book, provides "a gentle way for uninformed 'normies' to find out what is really going on within the political class that have been ruling over us for decades."

Some adherents believe that "Q" is, in fact, John F. Kennedy Jr., who faked his death and has gone on to work behind the scenes with his old friend Donald Trump, with a shared goal of draining the swamp. Promoters of "Q" often dismiss doubters with the standard advice to,

"Trust the plan."

Those who think "Q" is some kind of hoax point out the litany of predictions about mass arrests and the like that didn't transpire on the dates predicted. And, of course, some point out Trump's perfect record of selecting nothing but swamp creatures for his administration and his backtracking and inconsistency on issues like immigration and ending U.S. involvement in other countries.

QAnon was a hot topic on the popular website "Reddit," but they banned a discussion board related to QAnon titled "Great Awakening" in September 2018. Reddit also banned 17 other QAnon-focused communities, allegedly because of unspecified threats of violence from "Q" proponents.

Popular YouTube channel host Dustin Nemos is one of those involved with putting *The Great Awakening* book together. Nemos told this writer, "I'm simply stunned by the tremendous outpouring of love and patriotism surrounding this book. It shows that the time is ready for the truth to win out over the fake news. I'm humbled to have been part of this collaboration."

The synopsis for the book provided by the authors explains, "*QAnon: An Invitation to The*

Great Awakening tells the history of an anonymous poster on the free-speech websites '4Chan' and then '8Chan' and how he (or perhaps they) built a following of millions of viewers worldwide. With an insider's knowledge of the battle plan, and "Q" level military intelligence clearance, QAnon's communications are often cryptic and coded. QAnon is a master of the Socratic method, asking questions and imploring followers to do their own research, to be logical and to think for themselves."

However one views QAnon, no reasonable person can disagree

with the sentiments expressed in an Oct. 5, 2018 "Q drop," which advised, "They want you divided. Divided by race. Divided by religion. Divided by culture. Divided by class. Divided by political affiliation. Divided you are weak. Together you are strong. This movement challenges their 'forced' narrative. This movement challenges people to not simply trust what is being reported. Research for yourself. Think for yourself. Trust yourself. This movement is not about one person or a group of people. WE, the people. Save the Republic!" ★

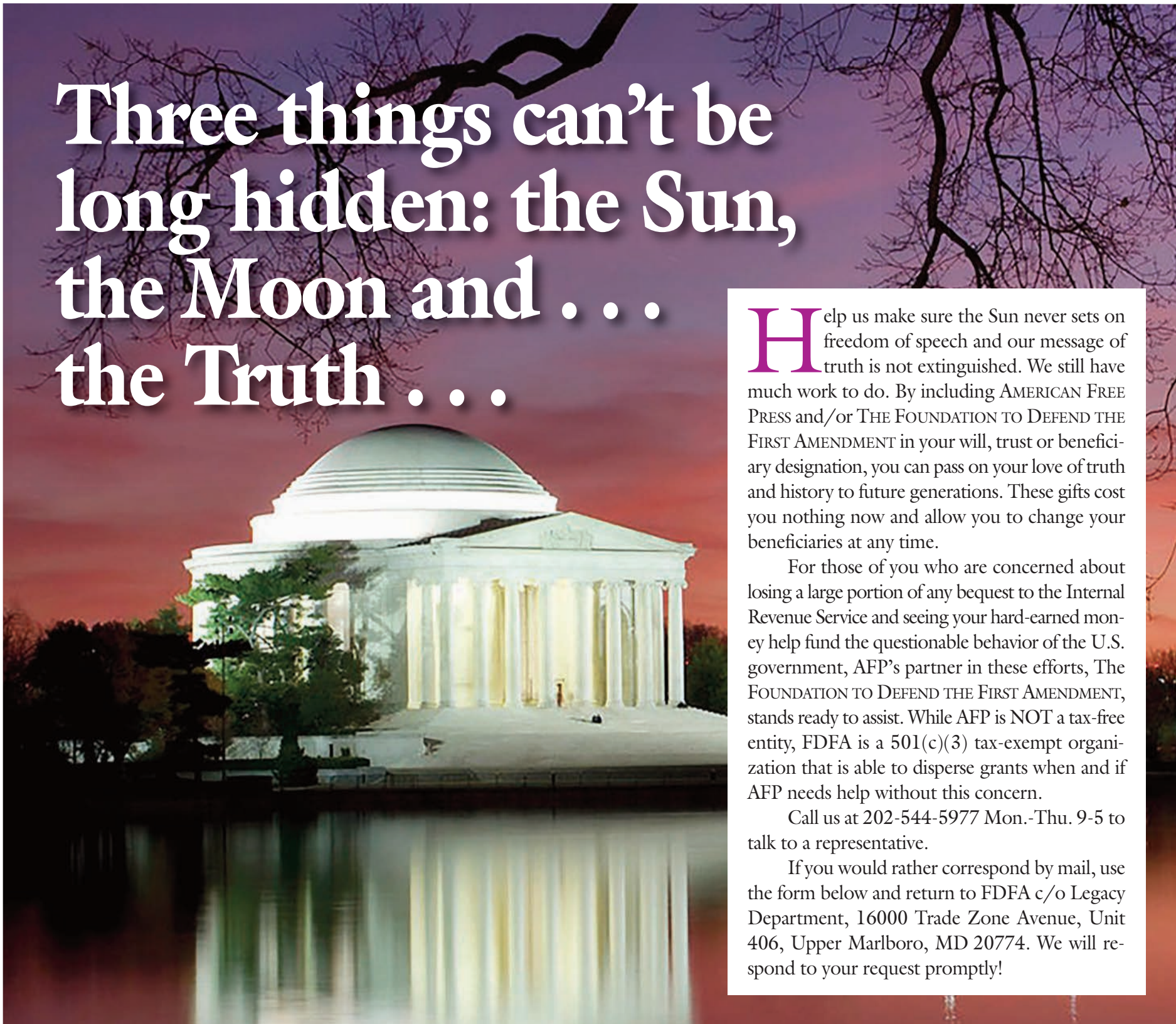
