

News You May Have Missed

Criminal Illegal Aliens

In a three-year period, U.S. Immigration and Customs Enforcement (ICE) has released more than 86,000 criminal illegal aliens into the U.S. streets. These are people who are here illegally, got caught committing a crime, were convicted of the crime. and then, instead of being deported, were put back into the American public to commit more crimes, said Government Reform Committee Chairman Rep. Jason Chaffetz (R-Utah). All told, there were more than 231,000 crimes they were convicted of. In 2015, 196 of these illegals were convicted of homicide yet ICE released them into the public rather than deporting them.

So Much for Free Speech

Pamela Taylor, the director of the nonprofit Clay County Development Corp., was fired from her job recently after she took to her private Facebook page to celebrate the incoming first lady Melania Trump and call Michelle Obama an "ape in heels." According to The Washington Post, Robert Roswall, the commissioner for the West Virginia Bureau of Senior Services, the state agency that funds the nonprofit, denied that Ms. Taylor was fired for her comments. Instead, he claimed she was let go after the nonprofit, which helps senior citizens, came under intense scrutiny when so-called social justice warriors and others began digging into the development company in an effort to make it look bad. Roswall said the investigators found some rules were not being followed, which gave nonprofit executives the excuse to let her go. The mayor of the town was also forced to resign his position in the company after he joked about Ms. Taylor's private Internet post.

Sanctions on Russia

Despite the fact that there is no evidence the Russian government was involved with hacking into top Democrats' private email accounts or electoral boards in the U.S., the Obama administration is still moving ahead with plans to impose sanctions on Russia, reports *The Hill*. The good news is President-elect Donald Trump has said he will seek to improve relations with Russia and would likely kill any aggressive moves directed at Moscow.

Merchant of Death

The United States has the dubious distinction of selling the lion's share of the world's weapons purchased in 2015—no less than \$40 billion worth. Of this vast panoply of armaments, tiny Qatar bought nearly half. Egypt and Saudi Arabia bought \$12 and \$8 billion worth, respectively.

Solar Power

According to the World Economic Forum, solar power was the same price or cheaper than "new fossil fuel capacity in more than 30 countries" in 2016, and the price is expected to continue to drop thanks to new solar cell and battery technology coming to market next year, reports the news and commentary website Quartz.com.

Banning Drilling

According to *Time* magazine, Obama will permanently ban offshore drilling in most of the U.S. Arctic and Atlantic seaboards—which will cramp Donald Trump's ability to deliver on a promise to boost the petroleum industry. The pretext for the ban is an effort to conserve marine wildlife by protecting against oil spills—but if so, why didn't Obama make this move years ago, rather than weeks before Trump's inauguration?

Totally Corrupt

A months-long inquiry into Israeli Prime Minister Benjamin Netanyahu's affairs recently took a new, bizarre twist, with police convinced that they will be able to open a full-blown criminal investigation against him. An Israeli television news station is reporting that police recently received new documents as part of a secret inquiry that began almost a year ago. The report reveals the suspected offenses include bribe-taking and aggravated fraud. If convicted, Netanyahu will follow on the heels of other Israeli officials who have gone to jail for crimes, such as Israel's former President Moshe Katssav, who was sentenced to seven years in prison for rape and indecent acts, as well as former Prime Minister Ehud Olmert, who was sent to prison for 18 months for bribery.

Hutzpah

Their hutzpah is incredible. Israeli officials are reportedly throwing a fit on a global scale all because the countries in the UN voted to condemn Israel's building of settlements for extremist Jewish groups on land stolen from Palestinians. The U.S. did not veto the measure but it did abstain from the vote, thus it passed.

Suspicious Death

Multiple websites are reporting exbanker Yves Chandelon, NATO's auditor general, was found dead of a gunshot to the head on Christmas Day, in Andenne, Belgium, over 60 miles from his home. Local media reported it a suicide, but his family is not buying it. An unregistered weapon was reportedly found in his right hand, although Chandelon owned three registered guns—and was left-handed. Chandelon, who was investigating terrorism financing, had reported disturbing calls and threats shortly before his death.

After Aleppo: U.S. Needs a New Syria Policy

• Non-intervention in the internal affairs of other nations is the only sane course of action

ver the past few weeks, eastern Aleppo was completely brought back under control of the Syrian government. The population began to return to its homes, many of which were abandoned when al Qaeda-linked rebels took over in 2012. As far as I know, the Western mainstream media did not have a single reporter on the ground in Aleppo, but relied on "activists" to inform us that the Syrian army was massacring the civilian population. It hardly makes sense for an army to fight and defeat armed rebels just so it can go in and murder unarmed civilians, but then again not much mainstream reporting on the tragedy in Syria has made sense.

We cannot be sure what exactly is happening in Aleppo, but we do know a few things about what happened in Syria over the past five years. This was no popular uprising to overthrow a dictator and bring in democracy.

From the moment President Barack Obama declared, "Assad must go" and approved sending in weapons, it was obvious this was a foreignsponsored regime-change operation that used foreign fighters against Syrian government forces. Journalist in Syria Says Media Is Lying

• Gutsy independent reporter and human rights activist reveals truth on ground in Syria

ne thing certainly can be said about Eva Bartlett, and that is that she does not hesitate to go where other Western reporters fear to tread. The young, independent Canadian journalist has made repeated trips to Syria—including those areas, like Aleppo, wracked by war in order to find out the truth that the mainstream media myrmidons promoting the New World Order refuse to tell.

On Dec. 9, Ms. Bartlett took part in a press conference at the United Nations, at which she skewered the bought-and-paid-for corporate media that toady to Zionist and American warmongers.

Ms. Bartlett has focused much of her career on getting the inside, first-hand stories of oppression and destruction in both Syria and Gaza—the sort of information neoconservatives and the militaryindustrial-banking complex do not want the average individual to know; the sort that exposes too many Western governments and the state of Israel as the corrupt murderers they really are.

The Syrian Mission to the United Nations organized the December press conference, at which Ms. Bartlett participated following her November expedition to Aleppo and other parts of Syria. She had already been to that country in July and August 2016 and was interested to see "what might have changed following the liberation of still more areas by the SAA [Syrian Arab Army—the nation's military]."

At the press conference, she gave a statement of what she had witnessed and went on to declare that Western media were deliberately reporting falsely about events in the Middle Eastern country—a claim that did not go unchallenged.

During her November tour of Aleppo and other areas, Ms. Bartlett learned that Syrians were unable to flee from insurgent-held parts of the city—despite repeated humanitarian pauses in fighting by Syria and Russia—because U.S.backed "moderate rebels" were using the defenseless civilians as human shields. The journalist was also shown an underground prison, including solitary confinement cells, operated by insurgents in the "Free Syrian Army."

Ms. Bartlett spoke additionally with Syrian Member of Parliament Fares Shehabi, who had arranged for journalists to visit war-torn areas. He stated that massive burglaries of many Syrian factories had been perpetrated by the terrorist insurgents. Entire factory production lines—heavy equipment—had been stolen and shipped to Turkey. Aleppo was formerly Syria's most pros-

perous city, with over 70,000 businesses, and is now a shell of itself.

In previous reports, Ms. Bartlett has pointed out that over 100 countries are involved in trying to bring down the democratically elected government of Syria, and that one of the motivations is the desire of Israel, Turkey, and certain Arab nations to build oil and gas pipelines through Syrian territory.

The independent reporter's accounts find frequent support from diverse sources. Amnesty International called attention last July to the "abductions, torture, and summary killings" and other war crimes perpetrated by opponents of the Assad government in Aleppo and Idlib.

Others have reported the efforts of Western governments to purchase the services of journalists for propaganda purposes, and that U.S. support for the terrorists in Syria has at least indirectly resulted in the murder of journalists, who try to report honestly from insurgent-held areas.

Most explosive, however, were Ms. Bartlett's Dec. 9 assertions that Western mainstream media presstitutes are not only misrepresenting but even falsifying the news they present about Syria to suit Zio-Anglo-American propaganda purposes—something AMERICAN FREE PRESS has been saying all along.

A Norwegian journalist, Christopher Rothen-

berg, challenged her: "How can you justify calling all of us liars?"

Ms. Bartlett responded in force, stating that, while some honest journalists exist, there was not a single human rights organization on the ground in eastern Aleppo, as an example.

Rather, she said: "These [mainstream media] organizations are relying on the Syrian Observatory for Human Rights, which is based in Coventry, UK, which is one man. They're relying on compromised groups like the White Helmets. Let's talk about the White Helmets: They were founded in 2013 by a British ex-military officer. They have been funded to the tune of \$100 million by the U.S., UK, Europe, and other states."

The White Helmets are also underwritten substantially by peripatetic regime-changer George Soros.

Ms. Bartlett continued: "[I]f they had told the truth about Syria from the beginning, we wouldn't be here now. We wouldn't have seen so many people killed." She gave the example of the Western media falsely claiming the Syrian government had destroyed a hospital, but then months later reporting the same hospital was treating victims of gas attacks. In fact, the hospital never had been harmed.

Happily, Syria and its allies were able to report on Dec. 22 that Aleppo had been completely liberated, as the few remaining terrorists and their families were provided safe passage to insurgentheld areas.

But the deadly troubles are far from over and find their origin in the desire of Israeli and Western governments—at the behest of those nations' military-industrial-banking and Big Oil interests—to destroy the sovereign nation of Syria and its people for crass commercial gain and—dare we say it?—an infernal bloodlust which seems to take pleasure in destroying the homes and lives of innocent civilians. These Western-sponsored genocides must stop. Tell Congress and the president now.



The Real Saboteurs of a New Foreign Policy

• Will Trump's attempts to work with Russia be sabotaged from both sides of the aisle?

he never-Trumpers are never going to surrender the myth that Russian President Vladimir Putin ordered the hacking of Hillary Clinton campaign chairman John Podesta and the Democratic National Committee to defeat Clinton and elect Donald Trump. Their investment in the myth is just too huge.

For Mrs. Clinton and her campaign, it is the only way to explain how they booted away a presidential election even Trump thought he had lost in November. To the mainstream media, this is the smoking gun in their conspiracy to delegitimize Trump's presidency.

Incoming Senate Minority Leader Chuck Schumer (D-N.Y.) sees Russian hacking as a way to put a cloud over the administration before it begins. But it is the uber-hawks hereabouts who are after the really big game.

They seek to demonize Putin as the saboteur of democracy—someone who corrupted an American presidential election to bring about victory for a "useful idiot" whom Mrs. Clinton called Putin's "puppet."

If the war party can convert this "fake story" into the real story of 2016, then they can scuttle any Trump effort to attain the rapprochement with Russia that Trump promised to try to achieve.

If they can stigmatize Trump as "Putin's president" and Putin as America's implacable enemy, then the Russophobes are back in business.

Nor is the war party disguising its goal.


Over the weekend, Sen. John McCain (R-Ariz.) called for a congressional select committee to investigate Russian hacking into the Clinton campaign. The purpose of the investigations, said Sen. Lindsey Graham (R-S.C.), "is to put on President Trump's desk crippling sanctions against Russia." "They need to pay a price," Graham chortled on Twitter.

Crippling sanctions would abort any modus vivendi, any deal with Russia, before Trump could negotiate one. Trump would have to refuse to impose them-and face the firestorm to follow. The war party is out to dynamite any detente with Russia before it begins.

Among the reasons Trump won is that he promised to end U.S. involvement in the costly, bloody and interminable wars in the Middle East the Bushites and President Barack Obama brought us-and the neocons relish-and to reach a new understanding with Russia and Putin.

But to some in Washington, beating up on Russia is a conditioned reflex dating to the Cold War.

For others in the media and the front groups called think tanks, Russophobia is in their DNA.

Though Julian Assange says WikiLeaks did not get the emails from Russia, this has to be investigated. Did Russia hack the DNC's email system and Podesta's email account? Did Putin direct that the emails be provided to WikiLeaks to disrupt democracy or defeat Mrs. Clinton?

Mrs. Clinton says Putin has had it in for her because he believes she was behind the anti-Putin demonstrations in Moscow in 2011.

But if there is to be an investigation of clandestine interference in the politics and elections of foreign nations, let's get it all out onto the table.

The CIA director and his deputies should be made to testify under oath, not only as to what they know about Russia's role in the WikiLeaks email dumps but also about who inside the agency is behind the leaks to The Washington Post designed to put a cloud over the Trump presidency before it begins.

Agents and operatives of the CIA should be sub-

jected to lie detector tests to learn who is leaking to the anti-Trump press.

Before any congressional investigation, President-elect Trump should call in his new director of the CIA, Rep. Mike Pompeo, and tell him to run down and remove, for criminal misconduct, any CIA agents or operatives leaking secrets to discredit his election.

Putin, after all, is not an American. The CIA saboteurs of the Trump presidency are. Will the media investigate the leakers? Not likely, for they are the beneficiaries of the leaks and co-conspirators of the leakers.

The top officials of the CIA and Carl Gershman, president of the National Endowment for Democracy (NED), should be called to testify under oath. Were they behind anti-Putin demonstrations during the Russian elections of 2011?

Did the CIA or NED have a role in the "colorcoded" revolutions to dump over pro-Russian governments in Moscow's "near abroad"?

If Russia did intrude in our election, was it payback for our intrusions to bring about regime change in its neighborhood?

What role did the CIA, the NED, and McCain play in the overthrow of the democratically elected government of Ukraine in 2014? McCain was seen cheering on the crowds in Independence Square in Kiev.

Trump has promised a more hopeful foreign policy than that of the Republicans he denounced and is succeeding. No more wars where vital interests are not imperiled. No more U.S. troops arriving as first responders for freeloading allies.

The real saboteurs of his new foreign policy may not be inside the Ring Road in Moscow; rather, they may be inside the Beltway around D.C.

'I May Know Who Hacked the DNC'

• Owner of servers used to hack sensitive DNC emails says U.S. not interested in truth

The mainstream media argues with no real evidence that the Russian government has been behind computer hacking targeting top Democrats and U.S. elections systems. However, the man who runs some of the computer servers that were exploited to carry out the crime told AFP that no U.S. law enforcement or intelligence agency is interested in speaking with him to gather real evidence on the perpetrators.


Rest and the server server company that has been alleged to have been involved in hacking the Democratic National Committee (DNC) and computerized election systems in both Arizona and Illinois, recently spoke to AMERICAN FREE PRESS in an effort to demystify the controversy surrounding his company and cyberattacks purportedly carried out at the behest of the Russian government.

In addition to the United States, hackers, who broke into King Servers, have also been alleged to have targeted other foreign countries, including Germany, Turkey, and Ukraine, in an attempt to undermine democratic processes.

When WikiLeaks began releasing hacked data from the DNC late this summer, media reports and the Clinton campaign almost immediately began blaming the Russian government with virtually no solid evidence to support such conclusions. In August, the FBI released eight IP addresses used in targeting the computerized voting systems in major U.S. states, while ThreatConnect, a private company that aggregates and analyzes cyberthreats, identified six of the eight IPs as being directly connected to Fomenko's web-hosting company, King Servers. The hackers apparently used the servers they rented from Fomenko to hack the voting systems without his knowledge, he explained to AFP.

IP addresses refer to unique strings of numbers that identify each computer using the Internet and tell where it is located. While IP addresses can be used to track people on the Internet, computer hackers have figured out ways to "spoof" their IP addresses that hide their true identity and location.

"The criminals partially used our servers behind our back," Fomenko told AFP. "The FBI claims that the attacks were made from eight address-

es, [however, we found that] part of them apparently belong to other European companies."

After learning about the criminal activity, Fomenko immediately shut down the servers and investigated the situation to the best of his ability. He contends he is willing to cooperate with law enforcement officials.

"Web hosting is a legal enterprise that is regulated by law," Fomenko explained. "King Servers works in Russia, the U.S., and the Netherlands and complies with the laws of these countries."

Once he learned that clients were using his servers to hack into computer systems, Fomenko said he looked into it himself.

"We pursued an investigation without delay and found some tracks leading to Europe," said Fomenko. "The criminals had European IPs. We offered assistance to law enforcement but we haven't received any responses.

He added: "I believe the information we have would help to find the criminals, if law enforcement were interested in it. Much time has been wasted, and it is probably too late to look for the criminals now. But we are still ready to assist." Revealingly, no law enforcement officials have contacted Fomenko.

"No U.S. law enforcement agency has contacted us at this time. Neither the FBI nor any other U.S., Russian, or Dutch intelligence agency has contacted us," Fomenko explained.

Fomenko has his own ideas about why this happened.

"After addressing the situation comprehensively, I came to the conclusion: Did the attacks take place or was it a part of a plan of unknown public relations persons?" he asked. "If the agencies were willing to know who was behind all of this, they could get the necessary server information by contacting the Dutch police. They could do that if they needed facts, but there is a problem with facts and evidence in this story."

Politics and the presidential election obviously played a major role in all of this, Fomenko contends. The Clinton campaign, Democrat leaders, anti-Trump partisans, and the fake news media have baselessly blamed the Russian government for the hacks in an attempt to undermine American democracy and help get Trump into the White House.

Citing Fomenko's Russian-based company as the entity that at least partially facilitated the attacks was merely a dishonest way of implicating the entire Russian government in a criminal conspiracy, without providing legitimate evidence or proof.

Fomenko doubts Russia, or any other world power for that matter, would risk engaging in this type of obvious criminal activity.

"Russia has one of the best schools for programmers," Fomenko noted. "Do you think if Russia were behind the attacks, hackers working for the Russian government wouldn't cover their tracks?"

Russian officials have strongly denied any involvement in the hacks, with one Kremlin spokesman, Dmitry Peskov, calling them "so absurd it borders on total stupidity," according to Russia Today.

Russian President Vladimir Putin, one of the most hysterically maligned world leaders today, has repeatedly stated that blaming Russia for the attacks is a crass way of directing public attention away from the outrageous corruption and criminality exposed by the leaks.

Fomenko argues that hackers are criminals who lack a nationality and that the threat they pose must be countered through cooperation and honest investigations on an international level. Jumping to conclusions for political purposes has not helped the situation, Fomenko contends. \star

Europe in Crosshairs of Terror Inc?

• Open borders policies allow millions of potential terrorists into European nations

urope is in the crosshairs of radical Muslim groups, and defeating them in Iraq and Syria will not lessen the threat because they are already deeply embedded in European cities.

Estimates from intelligence sources this writer has spoken to put the figures for extremist Muslims in Europe in the tens of thousands, many of them having been trained in terror tactics by ISIS, al Qaeda, and al-Nusra in camps across the Middle East, from Syria to Iraq, Libya, Yemen, and Somalia. Others have been trained and are still being funded by the United States and other Western and Islamic nations.

Al-Nusra, it should be noted, is al Qaeda by another name. It conveniently acquired the al-Nusra label so it could receive support that included funding and weapons from the West, Israel, and the Saudis to help ISIS overthrow the government of Bashar al-Assad in Syria.

Intelligence agencies throughout Europe lack the manpower to keep tabs on every terror suspect, especially in cases when it is vital to use manto-man surveillance tactics to track a suspect in order to learn his or her routines, means of communication, and identities of associates. To track one suspect over weeks or months can require as many as 40 well-trained operatives.

When one understands that there are thousands of extremists in Britain, and tens of thousands across the European continent, one gets a real sense of the sheer numbers of operatives needed to watch them. Sadly, the reality is that it is an impossible task to keep eyes on a significant number of them or to intercept their communications, which are often cloaked by encryption and the use of throwaway burner phones.

Pro-surveillance state pundits claim that national laws too severely limit their ability to arrest, detain, and interrogate dangerous individuals believed to be plotting attacks. A few more attacks like the ones that took place in European nations in 2016 could change that, however.

As a British counterterror chief told this writer off the record, "We simply lack the manpower and tougher laws to give us the flexibility to deal with the problems facing us. The public doesn't really know the level of threat, and we can't tell them the truth because it would scare the hell out of them. We have so many ongoing investigations it blows my mind. We are facing 'Terror Inc.'"

Britain has more experience handling terror than its European counterparts, but even it is overwhelmed by the scale of a terror threat from rad-

icalized Muslims in its cities and towns and from jihadists returning from the Middle East.

As another counterterror officer chief said, "Europe is a whole other problem," because of the massive influx of immigrants in the past 18 months, the open-borders system, and the sheer lack of cooperation between intelligence agencies.

Additionally, the laws of many countries limit the ability of agencies to detain or deport suspects. The latest Christmas market attack in Berlin exposed that country's flawed legal system. Anis Amri, an illegal Tunisian immigrant, had been on a terror watch list for months and had served a prison sentence in Italy. Three days after the Berlin attack, having managed to elude capture in three countries, he was cornered by police in Milan and shot dead.

The irony is that, for months, German authorities had been unable to detain and deport him because he lacked a valid ID. They had requested a passport for him from the Tunisian government, but it only arrived in the mail 24 hours after he had used a hijacked truck to kill a dozen shoppers and wound dozens more.

Four weeks before the Berlin tragedy, the French arrested seven suspects who were planning to attack Christmas markets in Strasbourg and Marseilles. And, days after the Berlin attack, British counterterror squads seized suspects they claim were planning a spectacular event in that country.

If that is a wake-up call about the threat level, which is the highest it has been for years, there is another frightening trend emerging. Terrorists are recruiting children and teenagers through social media and mosques. In November, a 12-yearold boy in Germany built a small explosive device, using a glass jar loaded with fireworks. The outside of the jar had nails and screws taped to it. He tried to set it off at a market, and when he failed, he tried again weeks later but that time was arrested. While it is likely the device would not have caused fatalities, his recruitment by ISIS online exposed a trend already familiar to intelligence agencies.

According to some reports, hundreds of refugees in Germany have been approached by radical preachers, and minors were among them. Minors are now thought to represent a growing percentage of jihadists. Over the past year, teenagers have been implicated in planning attacks in Europe and their role is being attributed to the fact that ISIS has been strikingly successful at using social media to attract them. It has also devised low-tech strategies for lone-wolf terrorists to use trucks to kill as many innocent people as they would with a bomb. But the truck attacks in Berlin and Nice are only part of an overarching terror strategy. But are terror cells already in place in Europe seeking to cause much more carnage than would ever be possible with a hijacked truck?

Of course, there is another fear: that hostile foreign intelligence agencies will take this opportunity to stage false-flag terrorist events knowing the public at large is becoming ever-more willing to surrender personal rights for perceived safety. \star


A Dedication to Health & Human Rights

f you Google: Nursing Sisters Port Dover, you'll see a book by Harry B. Barrett. In that book are pictures of my grandmother and her heroic nursing sisters during WWI, including one sister who was mentioned in wartime dispatches for her heroism along with a certificate presented to her by King George V. (In spite of her "valor in the face of the enemy," a woman was ineligible to receive the Victoria Cross!)

There are hundreds of letters and pictures, including one of the ambulances my grandmother donated (before we entered WWII) encouraged by her friend, suffragist CARRIE CHAPMAN CATT, who moved around the corner from my grandmother in New Rochelle, N.Y. As a youngster, I remember all the sewing machines and their many friends at my grandmother's house sewing thousands of pre-die cut clothes together to keep children warm during the brutally cold English winters. Carrie Chapman Catt also founded

the League of Woman Voters and is most famous for her Congressional speech resulting in the 19th Constitutional Amendment that gave woman the right to vote in 1920!

All this took place after Susan B. Anthony died in 1906 in Rochester, N.Y. where my grandfather baked his first loaf of BOND BREAD in 1915, resulting in 50 factories producing over1.5 million loaves of bread a day... a Horatio Alger success story which enabled my grandmother to help further woman's rights. She was inculcated with a sense of moral responsibility by her family who emigrated here in 1720 and then moved to Canada because they were Loyalists to the King and the Church of England.

BESET WITH MODERN AILMENTS



The budget-busting \$611 billion 2017 National Defense Authorization Act (NDAA) has hidden deep within its pages a proviso known by various euphemisms such as the Countering Foreign Propaganda and Disinformation Act of 2016 (H.R. 5181) or the Countering Information Warfare Act of 2016 (S. 2692).

Long before the flap about so-called "fake news"—meaning anything (such as the truth) not conforming to the government/mainstream media narratives—was drummed up, the writers of this anti-First Amendment legislation were planning to task the secretary of state with coordinating with the secretary of defense, the director of national intelligence, and the Broadcasting Board of Governors to "establish a Center for Information Analysis and Response," whose ostensible purpose is to "develop and disseminate" what are claimed to be "fact-based narratives" to counter the pesky truthers who have the effrontery to point out anomalies and holes in the establishment narratives.

Notably unanswered is the question of who determines what is "fact" and how they determine this. For example, for President George W. Bush it was a "fact" that Saddam Hussein had

weapons of mass destruction. In the end, it was clear to everyone the true facts were the opposite of the pres-

facts were the opposite of the president's "facts"—but by then the damage had been done.

The free speech-chilling rider was first introduced by Reps. Adam Kinzinger (R-III.) and Ted Lieu (D-Cal.) and back in March by RINO Sen. Rob Portman (R-Ohio) and Chris Murphy (D-Conn.). Kinzinger is noted for saying he cannot support Donald Trump.

Portman complained: "Surprisingly, there is currently no single U.S. governmental agency or department charged with the national-level development, integration, and synchronization of whole-of-government strategies to counter foreign propaganda and disinformation."

The Center will develop, integrate, and synchronize whole-of-government initiatives to expose and counter foreign disinformation operations by our enemies and proactively advance fact-based narratives that support U.S. allies and interests."

it into law in the evening of Dec. 23—practically on Christmas Eve.

The bill also creates a grant program to give away taxpayer dollars to "NGOs, think tanks, civil society [whatever that means] and other experts outside government who are engaged in counterpropaganda-related work."

In what is effectively a return to the Cold War, Obama and these solons claim "foreign disinformation and manipulation" threaten the world's "security and stability."

This legislation "does not bode well for independent media and has massive potential to be abused for political purposes," commented the news and commentary website "21stCentury-Wire.com."

Germany's boss, Angela Merkel, joined with Obama in calling for more censorship and news control.

is for the American police state. A police state "is characterized by bureaucracy, secrecy, perpetual wars, a nation of suspects, militarization, surveillance, widespread police presence, and a citizenry with little recourse against police actions."

B is for our battered Bill of Rights. In the cop culture that is America today, where you can be kicked, punched, tasered, shot, intimidated, harassed, stripped, searched, brutalized, terrorized, wrongfully arrested, and even killed by a police officer, and that officer is rarely held accountable for

violating your rights, the Bill of Rights doesn't amount to much.

Cis for civil asset forfeiture. The latest governmental scheme to deprive Americans of their liberties—namely, the right to property—is being carried out under the guise of civil asset forfeiture, a government practice wherein government agents (usually the police) seize private property they "suspect" may be connected to criminal activity. Then, whether or not any crime is actually proven to have taken place, the government keeps the citizen's property.

Dis for drones. It is estimated that at least 30,000 drones will be airborne in American airspace by 2020, part of an \$80 billion industry. Although some drones will be used for benevolent purposes, many will also be equipped with lasers, tasers, and scanning devices, among other weapons—all aimed at "we the people."

Eis for electronic concentration camp. In the electronic concentration camp, as I have dubbed the surveillance state, all aspects of a person's life are policed by government agents and all citizens are suspects, their activities monitored and regulated, their movements tracked, their communications spied upon, and their lives, liberties, and pursuit of happiness dependent on the government's say-so.

is for fusion centers. Fusion centers, data collecting agencies spread throughout the country and aided by the National Security Agency, serve as a clearinghouse for information shared between state, local, and federal agencies. These fusion centers constantly monitor our communications, everything from our Internet activity and web searches to text messages, phone calls, and emails. This data is then fed to government agencies, which are now interconnected: the CIA to the FBI, the FBI to local police.

G is for grenade launchers and global police. The federal government has distributed more than \$18 billion worth of battlefield-appropriate military weapons, vehicles, and equipment such as drones, tanks, and grenade launchers to domestic police departments across the country. As a result, most small-town police forces now have enough firepower to render any citizen resistance futile. Now take those small-town police forces, train them to look and act like the military, and then enlist them to be part of the United Nations' Strong Cities Network program, and you not only have a standing army that operates beyond the reach of the Constitution but one that is part of a global police force.

is for hollow-point bullets. The government's efforts to militarize and weaponize its agencies and employees is reaching epic proportions, with federal agencies as varied as the Department of Homeland Security and the Social Security Administration stockpiling millions of lethal hollowpoint bullets, which violate international law. Ironically, while the government continues to push for stricter gun laws for the general populace, the U.S. military's arsenal of weapons makes the average American's handgun look like a tinker toy.

is for the Internet of things, in which Internetconnected "things" will monitor your home, your health and your habits in order to keep your pantry stocked, your utilities regulated and your life under control and relatively worry-free. The key word here, however, is control. This "connected" industry propels us closer to a future where police agencies apprehend virtually anyone if the government "thinks" they may commit a crime, driverless cars populate the highways, and a person's biometrics are constantly scanned and used to track their movements, target them for advertising, and keep them under perpetual surveillance.

J is for jailing for profit. Having outsourced their inmate population to private prisons run by private corporations, this profit-driven form of mass punishment has given rise to a \$70 billion private prison industry that relies on the complicity of state governments to keep their privately run prisons full by jailing large numbers of Americans for inane crimes.

is for *Kentucky v. King.* In an 8-1 ruling, the Supreme Court ruled that police officers can break into homes without a warrant even if it's the wrong home as long as they think they have a reason to do so. Despite the fact that the police in question ended up pursuing the wrong suspect, invaded the wrong apartment, and violated just about every tenet that stands between us and a police state, the court sanctioned the warrantless raid, leaving Americans with little real protection in the face of all manner of abuses by law enforcement officials.


Les for license plate readers, which enable law enforcement and private agencies to track the whereabouts of vehicles, and their occupants, all across the country. This data collected on tens of thousands of innocent people is also being shared between police agencies, as well as with fusion centers and private companies. This puts Big Brother in the driver's seat.

Mis for "Main Core." Since the 1980s, the U.S. government has acquired and maintained, without warrant or court order, a database of names and information on Americans considered to be threats to the nation. As *Salon* reports,

this database, reportedly dubbed Main Core, is to be used by the Army and FEMA in times of national emergency or under martial law to locate and round up Americans seen as threats to national security. As of 2008, there were some 8 million Americans in the Main Core database.

N is for no-knock raids. Owing to the militarization of the nation's police forces, SWAT teams are now increasingly being deployed for routine police matters. In fact, more than 80,000 of these paramilitary raids are carried out every year. That translates to more than 200 SWAT team raids every day in which police crash through doors, damage private property, terrorize adults and children alike, kill family pets, assault or shoot anyone that is perceived as threatening—and all in the pursuit of someone merely suspected of a crime, usually possession of some small amount of drugs.


• is for overcriminalization. Thanks to an overabundance of 4,500-plus federal crimes and 400,000-plus rules and regulations, it's estimated that the average American actually commits three felonies a day without knowing it. police, mistreated, and then jailed in profit-driven private prisons if we dare step out of line, we are no longer operating under a constitutional republic. Instead, what we are experiencing is a pathocracy: tyranny at the hands of a psychopathic government, which operates against the interests of its own people except for favoring certain groups. Couple that with the government's burgeoning precrime programs—which will use fusion centers, data collection agencies, behavioral scientists, corporations, social media, and community organizers-and by relying on cutting-edge technology for surveillance, facial recognition, predictive policing, biometrics, and behavioral analysis, our government claims it will be able to identify and deter socalled potential "extremists," dissidents or rabblerousers. is for "qualified immunity." Qualified immunity allows officers to walk away without paying a dime for their wrongdoing. Conveniently, those deciding whether a police officer should be immune from having to personally pay for misbehavior on the job all belong to the same system, all cronies with a vested interest in protecting the police and their infamous code of silence: city and county attorneys, police commissioners, city councils and judges.

R is for roadside strip searches and blood draws. The courts have increasingly erred on the side of giving government officials—especially the police—vast discretion in carrying out strip searches, blood draws, and even anal probes for a broad range of violations, no matter how minor the offense. In the past, strip searches were resorted to only in exceptional circumstances where police were confident that a serious crime was in progress. In recent years, however, strip searches have become routine operating procedures in which everyone is rendered a suspect and, as such, is subjected to treatment once reserved for only the most serious of criminals.

S is for the surveillance state. On any given day, the average American going about his daily business will be monitored, surveilled, spied on, and tracked in more than 20 different ways, by both government and corporate eyes and ears. A byproduct of this new age in which we live, whether you're walking through a store, driving your car, checking email, or talking to friends and family on the phone, you can be sure that some government agency, whether the NSA or some other entity, is listening in and tracking your behavior. This doesn't even begin to touch on the corporate trackers that monitor your purchases, web browsing, Facebook posts, and other activities taking place in the cyber sphere.

T is for tasers. Nonlethal weapons such as tasers, stun guns, rubber pellets, and the like have been used by police as weapons of compliance more often and with less restraint—even against women and children—and in some instances, even causing death. These "nonlethal" weapons also enable police to aggress with the

So-called "soft target" security inspections, carried out by roving VIPR task forces, comprised of federal air marshals, surface transportation security inspectors, transportation security officers, behavior detection officers and explosive detection canine teams, are taking place whenever and wherever the government deems appropriate, at random times and places, and without needing the justification of a particular threat.

W is for whole-body scanners. Using either xray radiation or radio waves, scanning devices and government mobile units are being used not only to "see" through your clothes but to spy on you within the privacy of your home. While these mobile scanners are being sold to the American public as necessary security and safety measures, we can ill afford to forget that such systems are rife with the potential for abuse, not only by government bureaucrats but by the technicians employed to operate them.

More Fake Hate Crimes Exposed

• In aftermath of election of Donald Trump, rash of orchestrated hate crimes debunked

n the wake of Donald Trump's presidential victory, fake "hate crimes" are spreading like wildfire. Three recent examples offer insight into the increasing polarization of the country, as minorities and their leftist, anti-white allies resort to hoaxes in an effort to demonize the president-elect and his supporters.

On Nov. 1, exactly one week before the 2016 elections were held, Hopewell Missionary Baptist Church in Greenville, Miss. was vandalized with graffiti reading "Vote Trump" before the church was set ablaze, resulting in the near-total destruction of the building. The congregation of Hopewell Missionary, founded in 1905, is made up almost exclusively of black members.

Following the vandalism and arson of the church, mainstream news outlets speculated that the attack may have been carried out by Trump supporters and "white supremacists" with the intent of intimidating blacks and other minorities. Greenville Mayor Errick D. Simmons, a black man, encouraged federal authorities to investigate the arson as a potential "hate crime."

Now, an investigation has determined that Andrew McClinton, a 45-year-old black man from Leland, Miss. with an extensive criminal history, spray-painted the graffiti and set the church on fire. According to Clarence Green, a bishop at Hopewell Missionary, McClinton was a member of the church.

Incredibly, Mike Chaney, the state of Mississippi's insurance commissioner and fire marshal, has denied the political nature of McClinton's criminal acts.

"We do not believe it was politically motivated,"


Chaney told the Associated Press. "There may have been some efforts to make it appear politically motivated."

How a black man spray-painting the words "Vote Trump" on a majority-black church prior to setting the building on fire could be construed as anything other than a politically motivated act is beyond this reporter's comprehension.

Meanwhile, in Plainview, N.Y., a student from India was recently arraigned on 12 counts of aggravated harassment, according to News 12 Long Island, a local television news channel covering Long Island. Prosecutors allege Jasskirta Saini, a 20-year-old student at Nassau Community College,

drew over 100 messages featuring so-called racist symbols and messages, including swastikas, KKK, and Hitler, in various buildings and on walls and handrails on the college campus.

According to police, Saini claimed he was being harassed by the Jewish community in his hometown of Plainview, which triggered the young man to deface his college campus with "anti-Semitic" graffiti.

"This wasn't one or two times. This was 12 different times," the judge overseeing the case is quoted as stating. "With society the way it is, it's like putting a match to gasoline. It could have had a dangerous effect. We've had enough violence in society this year. We don't need more."

Finally, a young Muslim woman who told police she had been harassed and bullied by three drunken white men on a New York City subway was recently charged with filing a false police report for fabricating the entire story.

Yasmin Seweid, an 18-year-old student who was born in Brooklyn to Egyptian parents, originally told police she had been harassed and verbally assaulted by three men who called her a terrorist, attempted to rip off her hijab, and shouted "Donald Trump!" while on a late-night subway in New York City. Ms. Seweid told police she was making her way home after a college event when she was confronted by the men, who also demanded she go back to her country of origin.

Ms. Seweid took to Facebook to recount her purported "attack" the following day, writing in part: "I was harassed on the subway last night. And

it was just so dehumanizing I can't speak about it without getting emotional."

Following the alleged incident, Ms. Seweid told local New York media outlets she felt "heartbroken" no one stood up for her or tried to help her during the altercation.

"People were looking at me and looking at what was happening and no one said a thing," she stated. "They just looked away."

In reality, New York police determined Ms. Seweid made up the entire story because she broke her curfew after being out drinking alcohol with friends.

"She had numerous opportunities to admit nothing happened and she kept sticking by her story," a New York police source told media outlets. "We dedicated a lot of resources to this—and don't get me wrong, this is what we do-but we had guys going back and forth, looking for video and witnesses. And we couldn't find anything."

After police continued questioning Ms. Seweid and began noticing major inconsistencies in her story, she finally broke down and admitted she made up the entire story to avoid being punished by her father.

While minorities and their anti-Trump allies continue to invent and fabricate alleged "hate crimes," Trump supporters across the nation face physical attack, loss of employment, and harassment on a daily basis.

One young female college student at Bryn Mawr College, an all-female liberal arts college in Pennsylvania, was harassed by her peers for expressing her support for Trump to such an extent that she recently dropped out of the prestigious college.

President, Congress Have Thrown Billions at a Healthcare System That Is Killing Us

• 21st Century Cures Act the wrong answer for problems faced by health industry


he 21st Century Cures Act—or the Cures Act for short—rings familiar to the tale of Nero's fiddle-playing while Rome was burning to the ground. Congress and President Barack Obama, buoyed by a sycophantic media, authorized \$6.3 billion to fund "healthcare" that includes lowering safety regulations, building a DNA database, and fighting opioid addiction—all while American healthcare is killing us.

Most of the money, \$4.8 billion, will go to the National Institutes of Health (NIH), which was lauded by many health professionals who claim it doesn't get enough funding.

The House passed its version by a vote of 392 to 26 and the Senate by a vote of 94 to five. President Obama signed the Cures Act on Dec. 13.

Yet American healthcare costs are still high, and, to make matters worse, healthwise, Americans rank well below countries that pay much less. According to a 2014 Commonwealth Fund survey, the U.S. ranks last among 11 wealthy nations in terms of "efficiency, equity, and outcomes."

There's also the personal financial sting. A whopping 20% of Americans with credit

records, roughly 42.9 million people, have the credit stain of unpaid medical debts, according to the Consumer Financial Protection Bureau, a federal agency charged with protecting consumers against creditor abuse. As many as 62.1% of all bankruptcy filings had a medical cause, according to a 2008 study published in *The American Journal of Medicine*.

Even Obamacare supporters acknowledge that being broke because of medical bills remains a problem, according to a *New York Times* and Kaiser Family Foundation survey, reported on Jan. 5. The gist of the *Times* and Kaiser study was, don't get sick.

In the midst of this health and environmental nightmare of epic proportions, the Cures Act was portrayed as the finest hour for an otherwise partisan Congress, because the legislation is aimed to help fund cures for "rare" diseases—as if the most significant killers and cripplers have been wiped out.

But a study by Princeton economist Ann Case published Dec. 8 concluded that U.S. life expectancy is in decline for the first time since 1993 because of "major diseases" such as heart disease. Ms. Case told *The Washington Post*: "I think we should be very concerned. This is singular. This doesn't happen."

While Case's study showed that life expectancy fell by one-tenth of a year, it's too soon to see if this is a dark trend downward or an anomaly. Either way, it's absurd to think that the "big" diseases, such as heart disease and cancer, are under control.

The Cures Act also lessens some of the restrictions on drug approval that pharmaceutical companies face, such as making more use of biomarkers instead of waiting for final results from patient trials. Companies will also be allowed to use smaller trials of patients and to use summaries of data.

Believers in the drug approval process are concerned that safety measures will be compromised, but those who study the current system know FDA approval is a highly politicized process whereby popular drugs, such as Vioxx, are removed from the market only after whistle-blowers or litigation reveal top executives knew of dangerous side effects yet hid them during the approval process. Many other dangerous drugs are not withdrawn, but are required to include "black box" warnings on their packaging to alert users to serious or life-threatening side effects.

Dr. John Virapen's classic book titled Side Ef-

*fects: Death** exposed the dirty secrets of Big Pharma and the promotion of Prozac.

The New York Times wrote on Dec. 7, after cheerleading the bipartisan love-fest that led to the bill's passage, "One major winner—and a donor to both parties—was the pharmaceutical industry." No kidding.

The *Times* quoted Kim Monk of Capital Alpha Partners, a policy research firm for investors, as saying the Cures Act is a "holiday win for much of the health sector."

The Cures Act includes no restraints on drug prices, though in light of the widely reported EpiPen price gouging—where the price of this lifesaving drug increased from \$100 to \$600 nearly overnight back in September—one would think Congress could have at least included a provision they never intended to have enforced.

With the escalation of deadly allergies facing children, likely brought on by the onslaught of GMOs, vaccinations, pesticides, and other environmental assaults, many parents, particularly those who are part of the working class, have suffered a great loss by needing to have one or two sets of EpiPens per child.

Some claim the technology behind the EpiPen forbearer was barely patentable to begin with, because inventors George Calkins and Stanley Sarnoff "acknowledged their ideas were improvements upon work commissioned for the U.S. and UK military emergency needs in the 1960s," according to CNBC.

The same critics note sales of EpiPen were driven by the U.S. government as its principal buyer, so "the U.S. government has march-in rights to use the technology at a reasonable commercial royalty rate it can set." Indeed, another drug company sells the same anaphylaxis injectable pen technology to the U.S. government for \$50 per unit rather than the \$600-plus the public must pay.

We can expect more of this sort of cronyism in the prescription drug racket under the Cures Act, given the long history of collaboration between a bought government and monopolistic medical cartel.

At the turn of the 20th century, the allopathic school of medicine was instituted in medical schools by the Rockefeller family. It eventually became law that only allopathic treatments would be legal, let alone reimbursable by insurance companies, in another action tied to the powers-thatbe. Only the deluded believe America has a "freemarket" healthcare system. This is not to suggest that a single-payer system would be better, only less costly.

Short of massive deregulation and full adoption of so-called "alternative therapies," which would be allowed to compete against allopathic medicine, we are now over-paying for deadly medicine.

Imagine an America where natural substances could openly compete in the market against big pharma, and you'd see a thriving marketplace driven by those actually seeking to cure disease. Costs would drop and health would improve, but that is not to be.

As for the adulation of the Cures Act funding the NIH, keep this in mind: The mainstream media never told the truth about how the NIH's Office of Alternative Medicine beat down promising "alternative" therapies.

Dr. Nicholas Gonzales, who successfully treated patients using Dr. William Donald Kelley's cancer protocol, was initially excited to have NIH examine his treatment. Regrettably, Gonzales wrote, "the study degenerated into a morass of mismanagement, meaningless and manipulated data, the welfare of patients put at risk, and sadly, cover-up of the mismanagement right into the office of Dr. Elias Zerhouni, former NIH director. Repeatedly now we've seen the meaningless data of a mismanaged study used in the effort to 'prove' my treatment worthless, and undermine my 28 years of hard, determined research."

Cancer research under the Cures Act calls for a DNA database, where it's hoped that more than a million people will provide DNA for "research." Given the establishment's record of not finding cures, one can imagine how such information, if used for nefarious purposes, could be used against the populace.

The Cures Act and all legislation like it sustain a flawed system that stifles competition, rewards miscreants, and keeps a bloated bureaucracy at work. Nero would be proud. ★



Scholars Gather in Arizona to Discuss Man-Made Global Warming Theory

EMPE, Ariz.—Man-made "global warming" is a fantastic fable that needs to be debunked, according to scientists, academics, journalists, and other researchers who convened for the third congress of Freedom Force International (FFI), which was held in December at the Marriot Tempe "on the Buttes" resort hotel near Phoenix. The event was named "Global Warming: An Inconvenient Lie."

FFI, led by widely respected Federal Reserve investigator-author G. Edward Griffin, welcomed an array of speakers. They explored global warming from several angles, including the mainstream media's intensely biased stance, as well as the role played by K-12 education, the scientific community, general academia, governments, the United Nations etc.

Griffin told AFP that those running the scientific-political oligarchy behind global warming know deep down they're peddling lies but they use the "fear porn" associated with assumed climate catastrophe to control the masses.

More specifically, they recite an anti-human narrative that people are a blight who are arrogantly warming the Earth through the routine release of carbon dioxide (CO_2) and other "greenhouse gases" via industrial, agricultural, and other emissions.

We're constantly told that, lest we mend our ways very quickly, we're all supposedly in mortal peril from this warming of the globe, augmented by claims of melting ice sheets, rising ocean waters, droughts, flooding, food riots, water

wars, and worse.

The FFI conference offered credible evidence to the contrary-including even the topics of geoengineering and weather modification-thereby adding a new, compelling dimension to the climate issue.

FFI members and guests felt their conference was successful in adding much-needed balance to the debate, via realistic perspectives showing that what little warming may exist is not caused by man-made industrial and agricultural emissions, but instead is caused by solar variation and other factors.

Mathematician Lord Christopher Monckton of the UK told American Free Press that flawed math is being used in conjunction with computerbased climate models. That, he said, results in exaggerated predictions of global temperature increases.

Expounding on the outlook of the establishment scientific community that insists without apparent dissent that man-made global warming is real, Monckton noted, "They've exaggerated the amount of warming" but they've also "exaggerated the degree of consensus."


That remark on the level of consensus among scientists relates to what Monckton and several other FFI conference participants pinpointed as a vulnerable linchpin to the whole global warming claim: The allegation, peddled as immovable fact by establishment scientists and conventional media, that "97%" of scientists believe global warming is caused by humankind's automotive, industrial, and farm emissions-as well as other emissions, including cattle flatulence.


The reason the "97%" claim is highly misleading, noted Monckton and other FFI partici-

pants, is that it's based on fewer than 100 of nearly 12,000 peer-reviewed scientific papers on climate change.

Monckton added that there also has been exaggeration of the economics regarding global warming, referring to the supposed need to increase taxes and regulations to mitigate the effects of burning fossil fuels.

"But particularly," Monckton continued, "they have made a mistake on the physics and the math," which, he said, results in inflated forecasts of temperature increases "of up to 12 degrees Celsius per doubling of CO_2 ."

However, if the flawed math is corrected, he explained, "We can say that it won't be more than 2.7 degrees Celsius per doubling of CO₂, and that's the high end."

He further clarified that an increase of 1.6 degrees Celsius, or even an increase of 0.7 degrees Celsius per CO_2 doubling, is more realistic in terms of possible warming, when the correct math is applied.

An outgrowth of all this is that nearly all media reports call CO_2 "pollution" when, in reality, "Human emissions are less than 1% of all greenhouse gases in the atmosphere," and $\rm CO_2$ is but one component of those gases.


Also, Canadian professor Tim Ball announced to FFI that he was soon to meet with Presidentelect Donald Trump's people to discuss the climate change issue and pursue more realistic policies. This news was well received and fits into Griffin's mission to have FFI be a true, active "force" for constructive policy changes.

And among other compelling speakers, independent researcher Jim Lee awed many when, backed by memoranda, news clippings, and declassified documents, he showed there's been 100 years of earnest efforts to manipulate the weather, though not always for nefarious reasons. His "ClimateViewer.com" website covers considerable ground in documenting and explaining the established know-how to create, intensify, and influence the path of rain storms and much more powerful storm movements.

'U.S. Got It So Wrong About Saddam'

• 10 years later: CIA analyst who interrogated Saddam divulges agency's Iraq blunders, lies

xactly 10 years after the execution by the U.S. military of then-President of Iraq Saddam Hussein, a revealing new book has been published about the second-largest manhunt of recent times—the years-long search for Osama bin Laden being the first. In *Debriefing the President: The Interrogation of Saddam Hussein*, former Central Intelligence Agency (CIA) analyst John Nixon discloses what it was like to be the man who provided positive identification of the Iraqi leader and divulges the incredible intelligence failures that preceded a pointless, deadly, and destructive war against an imaginary enemy.

The book was scheduled for release on Dec. 29, the anniversary of Hussein's execution. And while Nixon was subjected to CIA censorship, *Debriefing the President* nevertheless provides an array of refreshingly truthful surprises, not only confirming what AMERICAN FREE PRESS has told readers for years about the insanity of the war against Iraq, but also exposing the disturbing bureaucratic bungling and incompetence of "the Company," as the CIA is often called, under three presidents as well as the adolescent behavior of former President George W. Bush.

Indeed, Nixon's revelations prompted the perpetually pro-war *New York Times* to admit, "These details will likely appall Americans who have watched their nation's blood and treasure wasted in Iraq ever since."

In an article written for the United Kingdom's *Daily Mail*, Nixon writes of the fateful night of Dec. 13, 2003: "I had been up for 27 hours and was flat-out exhausted, but the news sent jolts of adrenaline through me like I'd never experienced before. A Special Forces team hunting the man we called High Value Target No. 1 had pulled someone from a hole in the ground.... Could this burly, unkempt man truly be Saddam Hussein, the ruthless dictator of Iraq? The most wanted man in the world?"

Nixon had spent several years studying Iraq, Iran, and Saddam Hussein in particular, and his CIA superiors determined that this made him the man capable of providing positive identification of the Iraqi leader, before the capture was reported to the White House. He was also the first American to engage in a prolonged interrogation of Hussein.

In 2003, Nixon was still a "true believer" in the rightness of a war to overthrow the Iraqi government and in the—as it later turned out—phony intelligence alleging Hussein had weapons of mass destruction (WMD). But Nixon's conversations with the imprisoned ruler caused him to realize

that the U.S. had made a number of major intelligence blunders—some of which had determined the course of action toward war.

"At the start of the debriefings, I felt I knew Saddam," said Nixon. "But in the ensuing weeks, I learned that the United States had vastly misunderstood both him and his role as a determined foe of radical currents in the Islamic world, including Sunni extremism."

In following years, the senior leadership intelligence analyst would conclude that the war itself was misbegotten: "[I]n hindsight, the thought of having Saddam Hussein in power seems almost comforting in comparison with the awful events and wasted effort of America's brave young men and women in uniform, not to mention the \$3 trillion and still counting we have spent to build a new Iraq."

Indeed, CIA intelligence errors were not confined to seemingly innocuous points, like whether Hussein still ate meat or had a back injury. The Iraqi president had, in fact, long ceased to take an active role in running his country and was writing novels.

Most significant was the spy agency's belief that Hussein had WMDs and was prepared to use them—a notion the latter ridiculed: "Iraq is not a terrorist nation.... We did not have a relationship with [Osama] bin Laden, and did not have weapons of mass destruction... and were not a threat to our neighbors." Hussein continued: "We never thought about using weapons of mass destruction. It was not discussed. Use chemical weapons against the world? Is there anyone with full faculties who would do this? Who would use these weapons when they had not been used against us?"

Nixon also excoriates the CIA as having become a massive, self-perpetuating bureaucracy, intent on increasing its budget and power at the expense of genuine intelligence work and "outside-the-box" thinking. He rightly considers such failures to have contributed significantly to America's decades of pointless, destructive, unsuccessful wars.

But Nixon also stops short of the full truth. Perhaps he does not know it. Perhaps he dares not write it, if he does. As AFP has reported time and again, the real purpose of the war in Iraq, as of the current war against Syria, has been on one hand to maintain U.S. oil hegemony.

On the other hand—and far more significantly it has been to do the bidding of the terrorist state of Israel, which, along with American neoconservatives and the Israel lobby in America, has been working through propaganda, black-ops, and bloody wars carried out by a sycophantic U.S. to destabilize the Middle East and establish "Greater Israel" throughout the region. It is this which led to the war against Saddam Hussein. ★



Europe's Future: Angela Merkel or Marine Le Pen?



• Liberal ideology crippling most European leaders

nis Amri, the terrorist who hijacked a truck in Berlin and ran over and killed a dozen people, maiming and wounding dozens more, in that massacre in the Christmas market, has done more damage than he could imagine. If the perpetrator is the jihadist from Tunisia who had no right to be in Germany and had been under surveillance, the bell could begin to toll not only for German Prime Minister Angela Merkel but for the European Union.

[Amri was killed in Milan, Italy, on Dec. 23 by police there. Video has surfaced of him pledging allegiance to Islamic radicals. He was in Europe despite the fact that German and Italian officials said they had sought to deport him but no one ever did anything about it.—Ed.]

That German lassitude and the naiveté behind it, which allowed this outrage, validates the grim verdict of geostrategist James Burnham, who said: "Liberalism is the ideology of Western suicide."

Both the transnational elite and populist right sense the stakes involved here. As news of the barbarous atrocity spread across Europe, the reactions were instantaneous and predictable.

Marine Le Pen of France's National Front, leading candidate for the presidency in 2017, declaimed, "How many more people must die at the hands of Islamic extremists before our governments close our porous borders and stop taking in thousands of illegal immigrants?"

Geert Wilders, the Party for Freedom frontrunner for prime minister of Holland, echoed Ms. Le Pen: "They hate and kill us. And nobody protects us. Our leaders betray us. We need a political revolution. "Islamic immigration is an invasion," he went on, "an existential problem that will replace our people, erase our culture."

"These are Merkel's dead," tweeted Marcus Pretzell of the far-right Alternative for Germany about the victims in the Christmas mart.

Nigel Farage, who led the campaign for British secession from the EU, called the Christmas massacre "the Merkel legacy."

Europe's populist right is laying this act of Is-

lamist savagery at the feet of Merkel for her having opened Germany in 2015 to a million migrants and refugees from Syria and the Middle East wars.

Before Berlin, she was already on the defensive after mobs of migrants went about molesting and raping German girls in Cologne last New Year's Eve. Even admirers who share her belief in a Europe of open borders, that welcomes immigrants and refugees from Third World wars and despotisms, sense the gravity of Ms. Merkel's crisis.

"Germans should not let the attack on a Christmas market in Berlin undermine liberal values," ran the headline on *The Washington Post* editorial Dec. 22.

Alarmed, the *Post* went on: "What Germany cannot and must not do is . . . succumb to the siren song of the anti-foreigner right-wing, which has

been gaining strength across Europe and moved immediately to exploit the attack ahead of the September 2017 national elections."

The New York Times delivered its customary castigation of the European populist right but, in a note of near-desperation, if not of despair, implored Europe's liberals not to lose faith.

"With each new attack, whether on a Christmas market or a mosque, the challenge to Europe to defend tolerance, inclusion, equality, and reason grows more daunting," opined the *Times*. "If Europe is to survive as a beacon of democratic hope in a world rent by violent divisions, it must not cede those values." But less and less does Europe appear to be listening.

Indeed, as Europe has been picking up its dead and wounded for over a decade, from terrorist at-



tacks in Madrid, London, Paris, Berlin, and Brussels, the peoples of Europe seem less interested in hearing recitals of liberal values than in learning what their governments are going to do to keep the Islamist killers out and make them safe.

Salus populi suprema lex.

Liberals may admonish us that all races, creeds, cultures are equal, that anyone from any continent, country or civilization can come to the West and assimilate. That discrimination against one group of immigrants in favor of another—preferring, say, Lebanese Christians to Syrian Muslims—is illiberal and undemocratic.

But people don't believe that. Europe and America have moved beyond the verities of 20thcentury liberalism.

The cruel experiences of the recent past, and common sense, dictate that open borders are Eurail passes for Islamist terrorists, who are anxious to come and kill us in the West. We have to deal with the world as it is, not as we would wish it to be.

In our time, there has taken place an Islamic awakening. Of 1.6 billion Muslims worldwide, hundreds of millions accept strict sharia law about how to deal with apostasy and infidels.

The American Nightmare?

• Dream that our children will do better than us is fast disappearing

December study by scholars at the departments of economics and sociology at Stanford, Harvard, and UC-Berkeley universities have put the fork in the American dream: It's done, as in cooked.

The 53-page study, entitled "The Fading American Dream: Trends in Absolute Income Mobility Since 1940," funded by Stanford, Harvard, the Bill and Melinda Gates Foundation, and the Robert Wood Johnson Foundation, differs and complements other studies that had attempted to gauge whether or not the "American dream" still existed, or if it ever did.

The American Dream, with roots in the values expressed in the Declaration of Independence that "all men are created equal" with the right to "life, liberty and the pursuit of happiness"—was the guiding ideal that characterized this once-great nation. All children, through hard work, would be able to achieve more than the previous generation had, regardless of class, religion, race, or ethnicity.

Although Benjamin Franklin, Mark Twain, and F. Scott Fitzgerald made mention of the American dream in their writings, the phrase "American dream" was popularized in the 1931 book *Epic of America*, which proclaimed:

But there has been also the American dream, that dream of a land in which life should be better and richer and fuller for every man, with opportunity for each according to his ability or achievement. The American dream, that has lured tens of millions of all nations to our shores in the past century, has not been a dream of merely material plenty, though that has doubtlessly counted heavily. It has been much more than that. It has been a dream of being able to grow to fullest development as man and woman, unhampered by the barriers which had slowly been erected in the older civilizations, unrepressed by social orders which had developed for the benefit of classes rather than for the simple human being of any and every class

Ample evidence exists that the American dream wasn't all it was made out to be. As recently as 2013, a study detailed that, of the world's top 13 wealthiest nations, the U.S. offered the least economic mobility.

"By international standards, the United States has an unusually low level of intergenerational mobility: Our parents' income is highly predictive of our incomes as adults," noted that study.



THE AMERICAN DREAM

The highly vaunted American dream of a steady job, a solid income, and a nice house has been slipping away for average Americans, according to a new report by top universities. Gone are the days when most kids could expect to earn a better living than their parents. In its place, most young people can look forward to minimum-wage jobs in an unstable economy thanks largely to decades of exporting American industry to third world nations.

In fact, because the American dream is better realized in Denmark, economist Joseph Stiglitz proclaimed, "Maybe we should be calling the American dream the Scandinavian dream."

"The Fading American Dream" uses the concept of "absolute income mobility" to show that the dream is dead. Absolute mobility measures by what percentage children have higher incomes than their parents, as compared to relative mobility, which measures "how likely children are to move from their parents' place in the social hierarchy."

According to the study, "We measure absolute mobility by comparing children's household incomes at age 30 (adjusted for inflation using the Consumer Price Index) with their parents' household incomes at age 30."

The study's results are shocking, and point to more pain ahead for America's beleaguered middle class: "We find that rates of absolute mobility have fallen from approximately 90% for children born in 1940 to 50% for children born in the 1980s. Absolute income mobility has fallen across the entire income distribution, with the largest declines for families in the middle class."

The study shows that the entire country is affected.

"Absolute mobility fell in all 50 states, although the rate of decline varied, with the largest declines concentrated in states in the industrial Midwest, such as Michigan and Illinois. The decline in absolute mobility is especially steep—from 95% for children born in 1940 to 41% for children born in 1984—when we compare the sons' earnings to their fathers' earnings," noted the report.

The culprit: Gross domestic product, or, stated more colloquially, "It's the economy, stupid."

The study authors explain: "Why have rates of upward income mobility fallen so sharply over the past half century? There have been two important trends that have affected the incomes of children born in the 1980s relative to those born in the 1940s and 1950s: lower gross domestic product (GDP) growth rates and greater inequality in the distribution of growth."

The study offers a sobering conclusion, and a warning to the president-elect if he thinks "making America great again" will be a walk in the park.

[W]e would need real GDP growth rates above 6% per year to return to rates of absolute mobility in the 1940s. We conclude that absolute mobility has declined sharply in America over the past halfcentury primarily because of the growth in inequality. If one wants to revive the American dream of high rates of absolute mobility, one must have an interest in growth that is shared more broadly across the income distribution. ★

Abolish the Federal Reserve

Rep. Ron Paul wants to "abolish the Fed" because it can print money, but during emergency conditions it may be necessary to print money. The government can print money; however, Fed printing is a much more expensive process. If the government spends \$10 billion, because tax revenue and Treasury sales fail to cover the deficit, the Fed prints the money and receives \$10 billion in U.S. treasuries.
