## Wiki-Leaker Unmasked?

**N**ew evidence and public testimony is being offered to further substantiate claims that Seth Rich, the Democratic National Committee (DNC) staffer who was mysteriously murdered in Washington, D.C. late last year, provided damaging information to WikiLeaks—not Russia—in an effort to expose corruption in the Democratic Party during the 2016 presidential campaign.

The WikiLeaks dumps, released late last year during the heated 2016 election, revealed high-level corruption in the DNC designed to sabotage then-Democratic candidate Bernie Sanders in favor of Hillary Clinton.

Following the information released by WikiLeaks, Debbie Wasserman Schultz was forced to resign as chairwoman of the DNC, and Mrs. Clinton's reputation was sullied even further. Clinton supporters, many mainstream media outlets, and virtually all federal intelligence and law enforcement agencies have baselessly alleged Russian agents working at the be-

hest of Russian President Vladimir Putin were responsible for hacking the DNC and transferring the damaging information to WikiLeaks in an attempt to undermine American democracy and ensure Donald Trump's presidential victory. Russia has denied these allegations, as has WikiLeaks founder Julian Assange, and no legitimate evidence has been presented by any federal agency or media outlet to demonstrate the theory Russia was the source of the WikiLeaks dumps.

Now, Rod Wheeler, a retired D.C.-based homicide detective and Fox News contributor, who has been contracted

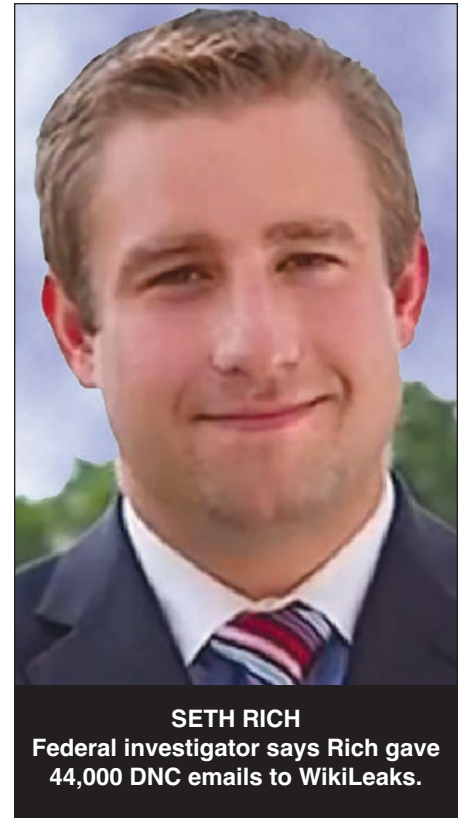
by the Rich family to investigate their son's mysterious death, has alleged that Rich may be the source of the WikiLeaks dumps.

"My investigation up to this point shows there was some degree of email exchange between Seth Rich and WikiLeaks," Wheeler recently declared in an interview with Fox News. "I do believe that the answers to who murdered Seth Rich sit on his computer on a shelf at the D.C. police or FBI headquarters."

Thus far, D.C. police have virtually no leads into Rich's death and have offered little information about his murder. They have offered a \$25,000 reward for information about Rich's death, and WikiLeaks has offered a \$20,000 reward.

An anonymous federal investigator who has been in contact with both Wheeler and Fox News has also backed up Wheeler's allegations. The federal investigator has claimed that an FBI forensic report on Rich's computer, which was conducted shortly after his death, revealed that Rich made contact with WikiLeaks through Gavin MacFadyen, who is now also dead. MacFadyen was a director at

WikiLeaks and a long-time reporter and documentary filmmaker.

"I have seen and read the emails between Seth Rich and WikiLeaks," the federal official told Fox News. He believes the emails are in the FBI's possession, but have not been publicly released for political reasons.

According to the federal investigator, "44,053 emails and 17,761 attachments between Democratic National Committee leaders, spanning from January 2015 through late May 2016, were transferred from Rich to MacFadyen," Fox News reported. The damaging WikiLeaks dumps were published on July 22 of last year, a mere 12 days after Rich was murdered.

Rich's family has downplayed the recent allegations by both Wheeler and the anonymous federal investigator, describing Wheeler's claims that Rich was WikiLeaks' source as "unsubstantiated." ★

## A PERSONAL MESSAGE FROM THE EXECUTIVE EDITOR

*All the Fake News That's Unfit to Print*

**T**his week, while the mockingbird mainstream media was breathlessly chasing wild, unsourced conspiracy theories based on hearsay and anonymous tips, the journalists and editors at AMERICAN FREE PRESS were hard at work researching and reporting real news.

Let's start with our front-page article this week. In this edition, John Friend follows up on AFP's previous reports about Seth Rich, the young Democratic National Committee staffer found shot twice in the back at 4 a.m. on July 10, 2016, in a relatively safe neighborhood in Washington, D.C. To this day, police have no leads on who killed Rich.

All we know is that his wristwatch was slightly damaged and that he still had his wallet, cash and phone on him by the time officers showed up.

Less than a month after Rich was found killed, AFP reported on the story in the Aug. 15 & 22, 2016 edition, providing a possible motive for his murder: "On Aug. 9, WikiLeaks founder Julian Assange may have blown the lid off the killing by announcing that his organization would pay \$20,000 for information on Rich's murder. Assange also suggested that Rich was the Democratic Party staffer who leaked the now infamous emails proving that top executives were undermining Sen. Bernie Sanders's presidential bid and that the fix was in for Hillary Clinton."

Given the explosive new details in our front-page article, you would think that this story would be all over the news media, but it's not. Let's take a look at what actually has topped the news in the first half of May.

President Donald Trump fired FBI Director James Comey on Friday, May 9. Over the course



of that weekend, news agencies in Washington went into a collective meltdown over his termination, wildly speculating that Trump's move was intended to undermine the FBI's probe into collusion between Russia and Trump.

It necessitates repeating over the never-ending choir of allegations that, so far, there is no evidence whatsoever that Trump's campaign staff or administration officials ever conspired with Russian intelligence to undermine Hillary Clinton and promote Trump. But don't just take our word for it. When asked on CNN in May if she has "evidence that there was collusion between Trump associates and Russia during the campaign," Sen. Dianne Feinstein (D-Calif.), who sits

on the Senate intelligence committee, responded flatly: "Not at this time."

Later that week, unsourced reports surfaced that Trump had broken the law by discussing top-secret information when he met with Russian Foreign Minister Sergey Lavrov in the White House. To this day, no one knows specifically what that conversation entailed—or even if any secret information was shared—yet these reports quickly pushed news of Comey's dismissal to the backburner.

Finally, there was an unsourced claim that Comey had logged a conversation with Trump wherein Trump supposedly asked him to "let go" of the investigation into whether Gen. Michael Flynn colluded with the Russian government when he spoke on the phone to Russian Ambassador Sergey Kislyak. No one knows what Flynn discussed with Kislyak, yet the wild speculation continues as to whether Flynn will ever be charged with anything.

This is what passes for news among the big media today: innuendoes, anonymous tips, absurd assumptions, and unsourced gossip.

Meanwhile, they continue to miss the biggest stories simply because they don't fit the narrative that Russia coopted the U.S. election to put Trump in the White House.

Americans need to just forget about the fake news and support AMERICAN FREE PRESS, the last real newspaper in this country. ★

# News You May Have Missed

## Budget Surplus

It looks like President Donald Trump's cuts to the U.S. budget are working. According to the latest financial report, the U.S. government had a \$182 billion budget surplus in April—a surprising turn, as most analysts expected a deficit.

## Boom Time Again

*The New York Times* reports that it's looking like boom time again for the steel industry. Following President Donald Trump's vow to protect American manufacturers against cheaper imports and invest as much as \$1 trillion in infrastructure over the next decade, stock prices and spirits have been on the rise for this struggling American industry.

## Wild Conspiracy Theories

In a bizarre example of the increasingly common reliance on questionable sources for information, an aide in the office of Sen. Edward Markey (D-Mass.) revealed the senator has been getting his information from "left-wing conspiracy blogs"—specifically, Louise Mensch's website and the "Palmer Report." Markey said in a CNN interview that, "Subpoenas have now been issued in Northern Virginia in regard to General Flynn [and] a grand jury has been empaneled up in New York." Markey's spokeswoman later tried to clean up, stating: "This morning Sen. Markey erroneously reported that a grand jury has been empaneled in New York related to the wider inquiry of possible Trump campaign and administration ties to Russia. Senator Markey does not have direct intelligence. . . . Senator Markey apologizes for the confusion."

## Good News, Bad News

Apple CEO Tim Cook announced that his company will invest \$1 billion in a fund for "advanced manufacturing" companies. Unfortunately, what this term means is robots. And the 7 million manufacturing jobs that have been lost

since 1979 will not come back. They will stay in China, Mexico or wherever, and eventually will disappear even there. Automation—robots—will wipe them out.

## FBI Director Chuck Norris?

Recently in Utah, 77-year-old Chuck Norris never wilted as he engaged in small talk with fans who showed up on a hot day at a Maverik gas station to meet the star of the television show, "Walker, Texas Ranger." But the truly interesting part came when Norris, on hand to promote his new CForce bottled water brand, heard that some of his fans want him to be

the new FBI director. Enthused one fan, "I think he's the man for the job." But would Norris want the gig? Perhaps not. But, "If someone has to clean it up, and it has to be me," Norris told *The Salt Lake Tribune*, "I'll take the job."

## IRS Bias

U.S. District Judge Michael Barrett recently ruled that there was a "strong showing" of bias on the part of the IRS when it came to evaluating the nonprofit status of conservative tea party groups. However, the specifics of the lawsuit brought by several organizations against the IRS could remain secret because current and former agency officials, who have had to testify in the lawsuit, claim that their lives would be in danger if their testimony was released to the public. Lawyers for the tea party groups that are suing the IRS say the argument for keeping the case secret doesn't hold up, and they want

the IRS officials' testimony to be released so that the American public can know just how biased the IRS was under the Obama administration.

## In Memoriam

Stephen Zarlenga, a longtime monetary reformer and author of *The Lost Science of Money*, passed away April 25 at his Palatine, Ill. residence after battling cancer, according to an announcement from the American Monetary Institute, an organization he founded and directed. AMI holds an annual Chicago conference, at which Zarlenga and other monetary reformers have explained that a gold standard is unnecessary and that sovereign states with the backing of the people should simply deny private banks their undeserved money-creation racket and its interest-bearing debt, and instead issue money interest-free via infrastructure renewal, better healthcare, and through some direct dividends to the people.

## Republicans Cave to Illegals

# Leftist ‘Hate Lawyers’ Reprimanded

• Confidential letter reveals Obama’s DoJ dressed down left-wing attorneys

The Immigration Reform Law Institute (IRLI) reported some good news on May 8. The U.S. Department of Justice (DOJ), during the Obama administration, officially reprimanded lawyers representing left-wing groups promoting the illegal-alien invasion. The March 28, 2016, letter had been kept confidential at the government’s request but now has been revealed by IRLI. The censure was issued by Disciplinary Counsel Jennifer J. Barnes in the Executive Office for Immigration Review (EOIR) of DOJ’s Office of the General Counsel.

Four lawyers representing eight organizations were criticized harshly for their unprofessional conduct in two immigration review cases, *Matter of J-S-* and *Matter of Cristoval Silva-Trevino*, following their amicus curiae interventions. Christopher Strawn and Matt Adams of Northwest Immigrant Rights Project (NWRP), Elizabeth Brodyaga of Refugio del Rio Grande Incorporated Law Office, and Eunice Hyunhye Cho of the infamous Southern Poverty Law Center, Inc. (SPLC) came under fire for their vicious and defamatory personal attacks on IRLI, the Federation for American Immigration Reform (FAIR), and their staffs, who have been leaders in efforts to close porous U.S. borders and restore a sound and sane immigration policy. IRLI is the legal affiliate of FAIR.

IRLI stated: “In recognition of its expertise in the field of immigration law, the Board of Immigration Appeals (BIA), DOJ’s highest immigration court, has for decades asked FAIR to submit friend-of-the-court briefs in difficult and complex immigration cases.”

According to IRLI’s report, the SPLC and other organizations asked to intervene in the two immigration cases, not to provide legal assistance to the BIA, but “solely to ask the BIA to terminate its relationship with FAIR, attacking and defaming the decades-old advocacy group. . . .”

The SPLC, along with the Anti-Defamation League (ADL), is one of the most strident groups of culture destroyers in the U.S., long seeking to undermine traditional moral values and American national identity. It maintains a “hate watch” on organizations and individuals with which it disagrees and is, disturbingly, a frequent collaborator and consultant with federal law enforcement and other federal agencies.

The SPLC’s calumnious, hate-filled “hate map” and associated articles are full of lies and distortions about the persons and groups they defame, yet the DOJ, media pressstitutes, and others willingly believe and act on the SPLC’s typically baseless accusations, with no independent investigation. The SPLC has

unjustly excoriated AMERICAN FREE PRESS as “anti-Semitic,” while its colleagues at THE BARNES REVIEW (TBR), have earned an entire article of virulent invective from the lobbyists, because TBR tells the truth about history and culture. Our late, patriotic founder, Willis A. Carto, continues to be vilified even after death by the cultural communists at the SPLC.

The lawyers for the SPLC who attacked IRLI and FAIR were dressed down severely by the DOJ for their reprehensible behavior. The former falsely and baselessly accused the latter of being a “hate group,” “anti-immigrant,” “white supremacist,” “eugenicist,” “anti-Semitic,” and “anti-Catholic,” according to Ms. Barnes’s letter.

Unfortunately, Ms. Barnes decided against a formal disciplinary process, but the written reprimand reproved the four lawyers’ misconduct as a “lack of professionalism,” which included “frivolous behavior” and “derogatory name-calling.” She stated that their hate-filled “language is not appropriate in a filing before the board (or any judicial tribunal), because it . . . does not aid the administration of justice.”

This incident is hardly unique, however, and is stock-in-trade for the SPLC. Its disgusting “hate map” also has been a motivating factor in at least

one violent hate crime and likely others unknown. In August 2012, Floyd Lee Corkins II purchased a pistol and went to the Washington, D.C. headquarters of the Family Research Council, where he wounded the security guard and intended to kill as many employees as possible. Corkins was given a 25-year sentence for terrorism, but the SPLC, whose inflammatory language helped drive Corkins to bloody violence, remains at large.

Far from being chastened by the DOJ’s reprimand letter, the SPLC has used the cover of its confidentiality to increase the attacks on IRLI and FAIR. As a consequence, IRLI felt compelled to release the letter in self-defense.

The SPLC’s unrepentant haters continue to employ the same tactics against all those with whom it disagrees. Kansas Secretary of State Kris Kobach was named recently by President Donald Trump to help investigate voting fraud in the United States, but the SPLC is trying to obstruct the investigation through crazed rhetoric and calumnious charges that Kobach is “a longtime lawyer for far-right extremist groups with ties to white nationalists and is a leader in the movement to suppress the votes of minorities.”

The SPLC also recently filed a lawsuit against white nationalist Andrew Anglin of the “Daily Stormer,” deliberately misrepresenting facts in doing so. To the SPLC, anyone disagreeing publicly with its perverse ideas becomes an object of hatred to be ruined or sued into bankruptcy. There is no “free speech” in SPLC-land.

Far from climbing into political bed with the SPLC or similar hate groups like the ADL, the FBI should be investigating them for RICO violations, due to their constant attempts to defame and financially ruin patriotic Americans, and for aiding and abetting terrorism. ★

# New Movie Exposes Bilderberg

• Researcher Danny Estulin risks own money to make film on secretive gang

**N**EW ORLEANS, La.—Noted Bilderberg author-researcher Daniel Estulin will soon be screening for the first time in North America his documentary, *Bilderberg, the Movie*, to bring the background and meaning of the Bilderberg group's highly secretive annual meetings to the greater public.

The Bilderberg meetings consist of 140 (chiefly European and North American) central bankers, finance ministers, former and current legislators, former and current prime ministers, corporate titans, and media moguls and editors who attend but agree not to report on the proceedings. European royalty, NATO and other military brass, select think-tank fellows from the Brookings Institution and other noted institutes, and high-tech gurus like Google founder Eric Schmidt, who represent some of the “fresh blood” among Bilderberg's aging old guard, are also usually present.

They are held at only the most posh hotels and resorts, which are totally cut off from the public during the three days of meetings.

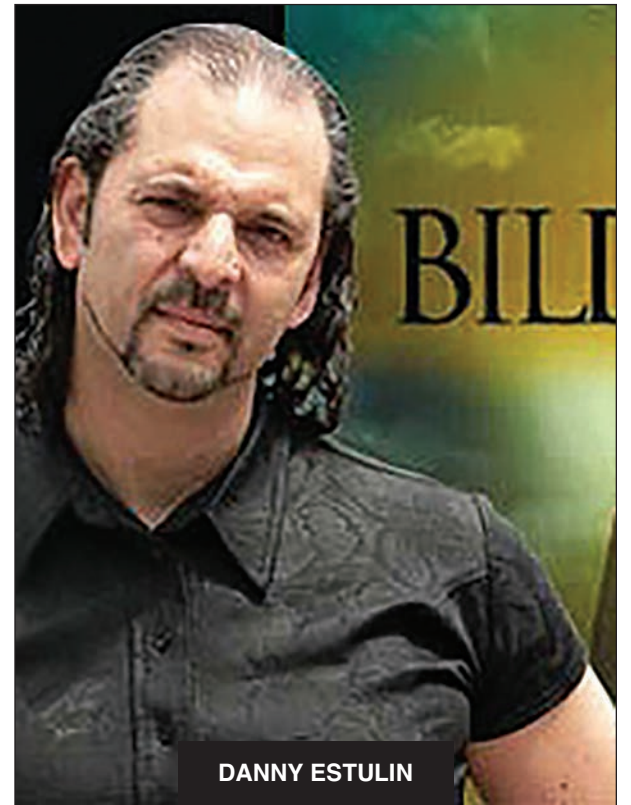
The last U.S.-based meeting was held back in 2012 in Chantilly, Va., meaning the group is overdue to return to North America.

Estulin spoke to AFP in advance of the May 24 showing of the 62-minute film at the Prytania Theater in New Orleans, La. He told this AFP writer about the considerable challenges and intrigue he encountered in making the movie.

“I started working on this film in 2011-2012 when a . . . Spanish producer, who's a great fan of my work, approached me about making a documentary,” Estulin explained. “We signed a deal. . . . [But] six months later he was ruined. If you believe in conspiracy or coincidence theories, three banks called in his loans at the same time. He basically went bankrupt.”

A year went by, and another group decided to make a Bilderberg film, with Estulin as co-producer. That film was essentially done by the late summer of 2015.

“Then one day my co-producer comes to me and says that he sold his 50% stake in the film to Baker & Taylor—that's a subsidiary of the Carlyle Group,” he added. “So I basically knew . . . that there would be no way to get the film out. It was sabotaged . . . . The Carlyles are the Bushes, the bin Ladens, the Bakers. . . .”

Macron recently beat conservative populist Marine Le Pen in a hotly contested election to become the president of France. The mainstream media claims that Macron rose out of nowhere to become a French sensation, but the truth is Macron has been rubbing shoulders with globalists for years. Estulin had to reshoot the film to make sure it was 100% his creation, going to 13 cities in 11 countries in the process and spending about \$200,000 of his own money.

To give would-be viewers a taste of the movie's content, Estulin said that two phases of world control—carried out via a Bilderberg-nurtured monopoly-capitalist approach, based on breakneck economic growth for its own sake—have failed. So, when Bilderberg meets this year, he understands the group will be struggling to redefine itself and in the process come up with a model for a third phase of economic-political control.

The main problem with the “Bilderberg outlook,” summarized Estulin, is that it's based on economic speculation and seeks to overturn the nation-state itself. Instead, it seeks to rely on the formation of regional economic blocs created by merging individual countries into larger entities. It's no accident that Bilderberg's early meetings nurtured the creation of ever-larger economic-political blocs, leading to today's shaky European Union of 28 formerly independent countries—shaky enough to prompt Brits into voting last June to exit the dictatorial superstate.

In contrast, noted Estulin, President Donald Trump's approach is rooted in a longstanding competing system that at least keeps countries more or less intact and focuses on tangible, commonsense goals like rebuilding infrastructure. ★

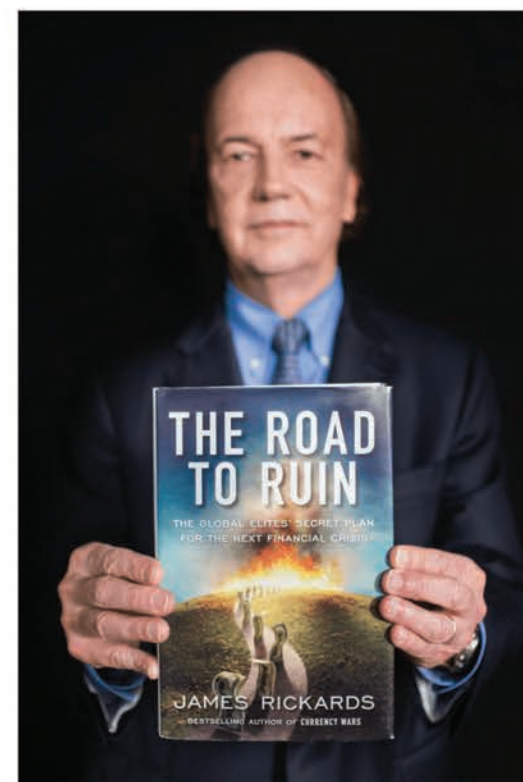

# 120 Judgeships Need to Be Filled

• Here is our chance to radically improve the corrupt, overly liberal judiciary

Justice Neil Gorsuch has a chance to change the face of the Supreme Court, as the perfect replacement to the late Justice Antonin Scalia. That is, if he lives up to President Donald Trump's vow to reaffirm constitutional principles to our judicial system. But Gorsuch is just the beginning. Currently there are more than 120 vacancies in federal district and appeals courts around the country, and Trump's conservative appointments could change the next generation of our court system.

Recently Trump announced his third wave of federal judicial nominations, a round of eight notably conservative legal professionals as well as two intended nominations, according to a White House press release.

One of these nominees, Amy Coney Barrett, was even a former law clerk under Scalia and, if confirmed, will serve as a circuit judge on the U.S. Court of Appeals for the Seventh Circuit. With Senate rules now preventing a filibuster on judicial nominees, Trump's other nominees should be confirmed with little pushback.

While the Republicans have a majority in the Senate, Trump must begin pushing appointments forward. As is, he will need to push at least two appointments a month to fill the court vacancies in a single four-year term.

Liberals have reason to be worried. Trump still has over 100 vacancies to fill, and that does not include judges who could be ending their careers in the next four years.

With 148 current judges on federal benches turning 67 or older this year, the likelihood of retirement or death increases as time goes on.

Trump could not only shift the balance of the Supreme Court, as he did in April, but the entire federal court system.

At the moment, about 55% of judges in the federal system were appointed by Democrats. But by filling 120 or so currently vacant positions, Trump would flip the courts, with Republican-nominated judges filling more than 50% of the federal court positions. If given two terms in office, he could go even further.

The far-left advocacy group Think Progress writes nervously: "[Trump's] influence will have the greatest effect at the circuit court level. While the Supreme Court only hears about 75 cases a year, the court of appeals decides tens of thousands. Which means that often the lower courts have the final say on the rule of law, creating a far-reaching sphere of influence over the daily lives of Americans."



It is perhaps one of the biggest stories of the decade, but most in the media ignore it. With over 120 vacancies in federal court, President Donald Trump has the opportunity to recast the entire federal legal system so it reflects conservative values.

President Trump could change the next generation of the court system for the better by appointing good conservatives.

Issues such as Trump's travel ban and sanctuary cities, which are currently being held up in district and appeals courts, could eventually be placed in the hands of conservative justices as Trump continues the nomination process.

California federal Judge William Orrick is the exact reason Trump needs to make haste with these nominations, as it has become clear they will determine if his policies live or fail.

Orrick ruled against Trump's sanctuary city executive order, not based on the legislation itself but instead on a series of public statements by Trump, White House Press Secretary Sean Spicer, and Attorney General Jeff Sessions, claiming these political statements were evidence the federal

government intended to abuse the order. Ignoring decades of precedent, liberal judges are striking blows at policy they disagree with and, as federal judges, effectively legislating from the bench.

Trump's judicial nomination power could be a game-changer for him. In the 9th Circuit alone, which encompasses much of California, Arizona, and other critical border states, there are currently 20 court vacancies. If Trump can nominate conservatives to the court that has consistently challenged his policies, he can tilt the bias away from Democrats once more.

While liberals squeal at this possibility, it is truly no more than what they have done throughout history as well. The courts' liberal bias today can be accredited to the nearly 250 federal judges appointed under the Carter administration. Now it is simply Trump's turn to change the tide.

With only a simple majority needed to confirm judges, it is likely Trump's nominees will pass with flying colors—for now. New elections occur every two years.

Now, Trump's focus should be on getting judges nominated. Over the next four years, Trump can instill a generation of conservative court leaders, allowing him to implement the policy he was elected to execute. ★

In spite of her “valor in the face of the enemy,” after throwing caution to the wind because the love of her life had been killed in action, a woman was ineligible to receive the Victoria Cross! Heartbroken, this beautiful lady never married.

There are hundreds of letters and pictures, including one of the ambulances my grandmother donated (before we entered WWII) encouraged by her friend, suffragist CARRIE CHAPMAN CATT, who moved around the corner from my grandmother in New Rochelle, N.Y. As a youngster, I remember all the sewing machines and their many friends at my grandmother’s house sewing thousands of pre-die cut

clothes together to keep children warm during the brutally cold English winters. Carrie Chapman Catt also founded the League of Woman Voters and is most famous for her Congressional speech resulting in the 19th Constitutional Amendment that gave woman the right to vote in 1920!

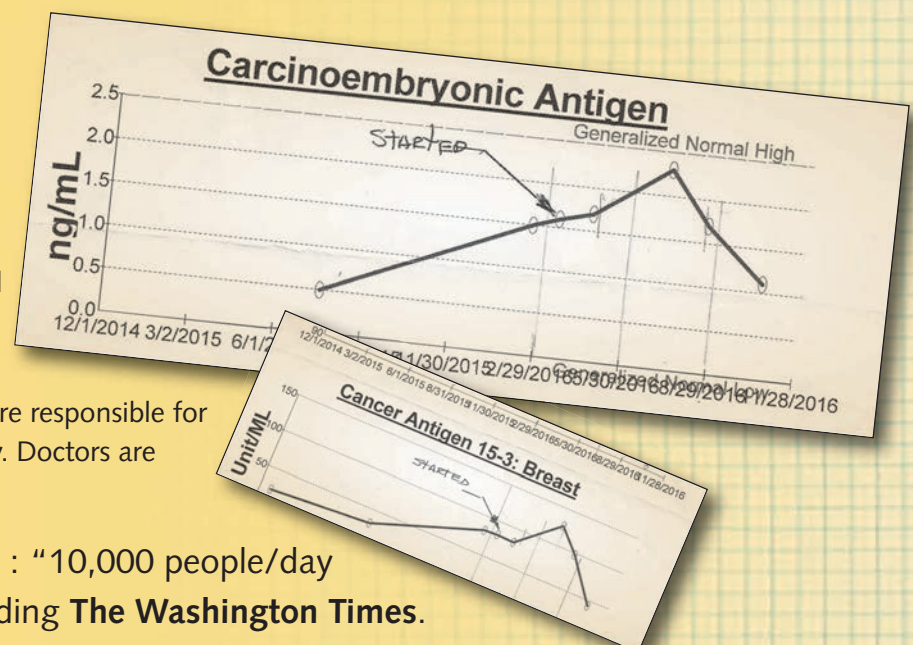

# Feds Warn Against Israeli Scammers

• Commodity Futures Trading Commission blasts “binary options” and “forex”

According to the politicians, the apartheid, terrorist, genocidal, rogue nuclear state of Israel is America’s “indispensable ally.” Nearly every rational foreign and domestic policy is sacrificed when Israelis or their lobbyists in the U.S. demand it. This, as documented by French author Hervé Ryssen, despite Israel’s being the epicenter of international human trafficking, a burgeoning pornography industry, and numerous scams swindling and even impoverishing countless unsuspecting individuals. But a U.S. federal commission has begun warning against one particularly heinous type of securities fraud based primarily in Tel Aviv.

“Binary options” and “forex” trading, although often considered the same, are two means employed by unscrupulous Israelis to separate what are likely hundreds of thousands and perhaps millions of individuals from their money. Still, there is a great deal of similarity, so the terms are used interchangeably.

Binary options “investments” involve securities or commodities, while forex, like legitimate foreign exchange trading, speculates on currency rates. In both cases, the “investor” essentially makes a bet on whether a given security or currency will go up or down in price. If he is right, he potentially obtains a 30%-80% profit. The lure of quick cash is powerful. The “brokerage” also profits. If he is wrong, however, the person almost always loses everything invested on the “trade.”

According to an investor alert issued by the U.S. Commodity Futures Trading Commission (CFTC), it and the Securities and Exchange Commission “have received numerous complaints of fraud associated with websites that offer an opportunity to

buy or trade binary options through Internet-based trading platforms. The complaints fall into at least three categories: refusal to credit customer accounts or reimburse funds to customers, identity theft, and manipulation of software to generate losing trades.”

The CFTC adds, “Unlike other types of options, a binary option does not give the holder the right to purchase or sell the underlying asset.” Even “assuming a 50/50 chance of winning, the payout structure has been designed in such a way that the ex-

pected return on investment is actually *negative*, resulting in a *net loss* to the customer.” [Emphasis in original.] Over time, the odds of total loss of investment funds approach 100%. For the scammers, it is truly “heads, we win; tails, you lose.”

The corrupt business of binary and forex options has grown into an arguably multi-billion-dollar industry, centered primarily in Israel. Moshe Aviv Tower, Israel’s tallest building, owned by Ramat Gan, houses many binary options companies. Growing

numbers in Israel had already approached a hundred in 2015, according to IVC Research Center.

"Brokers" use high-pressure, deceptive sales tactics and early "wins" to lure customers. When a client wants his money back, typically because of growing losses, numerous restrictions suddenly prevent it—or the options company just stops answering calls. Countless individuals and families have been ruined by these predatory businesses.

The fraudulent schemes have reached such massive proportions that, in a March 23, 2016, exposé, *The Times of Israel* bluntly admitted: "An industry turning over hundreds of millions of dollars, employing thousands of people, is cynically cheating naive would-be investors worldwide via a range of corrupt practices. It is doing terrible harm to its victims, and it risks doing the same to Israel's reputation."

The industry is largely unregulated and often skirts what few regulations may exist. A few countries, like the U.S. and Israel, prohibit binary and forex options sales in their own countries, but these unscrupulous companies, while not selling to Israelis in Israel, still avoid other restrictions worldwide by employing Internet trading platforms. They use complex combinations of shell companies, foreign registration, and fraudulent identities established by both employees and owners, in order to evade prosecution. Europe—where the sales are inexplicably legal—is a favorite target.

Even the most "reputable," which may be registered in a country like Cyprus, where some minimal regulatory oversight exists, nevertheless run a rigged game resulting in almost certain loss for investors. Known owners and many employees display a shockingly amoral attitude, feeling no compunction for their behavior.

Despite Jewish fretting about "Israel's reputation," the Knesset seems singularly unconcerned and has only forbidden sales within Israel. A whistleblower's letter to the Israeli parliament was ignored. Still, unwelcome publicity has some companies preparing to relocate to Ukraine, Bulgaria, and elsewhere.

According to an April 25 CFTC press release, 71 binary and forex options companies have been added to their RED (registration deficient) list since last year, nearly tripling the number, now over 110, of such scams illegally targeting Americans. An estimated 40% or more operate from Israel. Because they are foreign-based, prosecution is impossible.

That Israel allows the existence of this criminal business, which employs thousands of Israelis, is alone reason to end all U.S. aid to its government. Although America provides funding sufficient to make every Israeli a millionaire every year, too many Israelis must seek employment in binary options and other dirty enterprises. But, considering Israel's international human trafficking of children and adults as sex slaves, its pornography industry, and genocide of Palestinians, it is well past time to end relations with Israel. Tell President Donald Trump and Congress now. ★

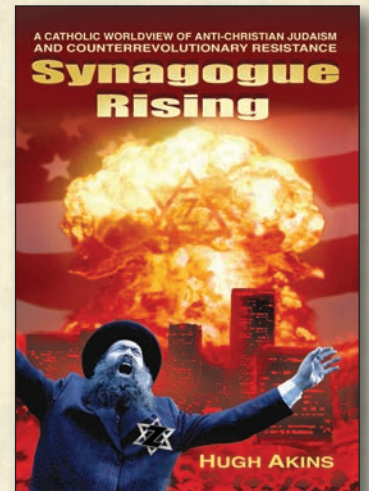

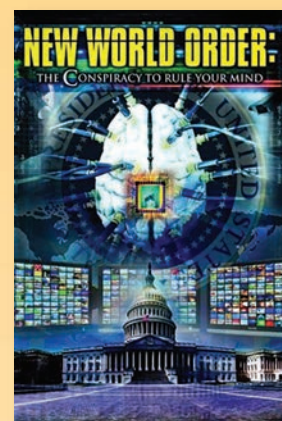
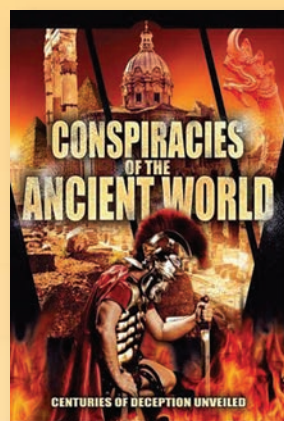

# Big Brother *Still* Watching

• Don't be fooled by the National Security Agency's latest ploy

"You had to live—did live, from habit that became instinct—in the assumption that every sound you made was overheard, and, except in darkness, every movement scrutinized."

Supposedly the National Security Agency (NSA) is going to stop collecting certain Internet communications that merely mention a foreign intelligence target. Privacy advocates are hailing it as a major victory for Americans whose communications have been caught in the NSA's dragnet. If this is a victory, it's a hollow victory.

Here's why.

Since its creation in 1952, when President Harry S. Truman issued a secret executive order establishing the NSA as the hub of the government's foreign intelligence activities, the agency has been covertly spying on Americans, listening in on their phone calls, reading their mail, and monitoring their communications.

For instance, under Project SHAMROCK, the NSA spied on telegrams to and from the U.S., as well as the correspondence of American citizens. Moreover, as the *Saturday Evening Post* reports, "Under Project MINARET, the NSA monitored the communications of civil rights leaders and opponents of the Vietnam War, including targets such as Martin Luther King Jr., Mohammed Ali, Jane Fonda, and two active U.S. senators. The NSA had launched this program in 1967 to monitor suspected terrorists and drug traffickers, but successive presidents used it to track all manner of political dissidents."

Not even the passage of the Foreign Intelligence Surveillance Act (FISA) and the creation of the FISA Court, which was supposed to oversee and correct how intelligence information is collected and collated, managed to curtail the NSA's illegal activities.

In the wake of the 9/11 attacks, George W. Bush secretly authorized the NSA to conduct warrantless surveillance on Americans' phone calls and emails.

Nothing changed under Barack Obama. In fact, the violations worsened, with the NSA authorized to secretly collect Internet and telephone data on millions of Americans, as well as on foreign governments. It was only after whistleblower Edward Snowden's revelations in 2013 that the American people fully understood the extent to which they had been betrayed once again.

What this brief history makes clear is that the NSA cannot be reformed.

## UNCONSTITUTIONAL

The NSA is an agency whose very existence—unaccountable and lacking any degree of transparency—flies in the face of the Constitution.

Despite the fact that its data snooping has been shown to be ineffective at detecting, let alone stopping, any actual terror attacks, the NSA has continued to operate largely in secret, carrying out warrantless mass surveillance on hundreds of millions of Americans' phone calls, emails, text messages, and the like, beyond the scrutiny of most of Congress and the taxpayers who are forced to fund its multi-billion dollar secret black ops budget.

As long as the government is allowed to make a mockery of the law—be it the Constitution, the FISA law, or any other law intended to limit its reach and curtail its activities—and is permitted to operate behind closed doors, relying on secret courts, secret budgets and secret interpretations of the laws of the land, there will be no reform.

Presidents, politicians, and court rulings have come and gone over the course of the NSA's 60-year history, but none of them has done much to put an end to the NSA's "technotyranny."

The beast has outgrown its chains. It will not be restrained.

Moreover, even if the NSA could be reformed, the problem of government surveillance goes far beyond the criminal activities of this one agency.

Whistleblower Edward Snowden helped expose the level to which we are being spied upon.

In fact, long before the NSA became the agency we loved to hate, the Justice Department, the FBI, and the Drug Enforcement Administration were carrying out their own secret mass surveillance on an unsuspecting populace. Just about every branch of the government—from the U.S. Postal Service to the Treasury Department and every agency in between—now has its own surveillance sector, authorized to spy on the American people.

## DATA MINING ON A MASSIVE SCALE

Then there are the fusion and counterterrorism centers that gather all of the data from the smaller government spies—the police, public health officials, transportation, etc.—and make it accessible for all those in power. And, of course, that doesn't even begin to touch on the complicity of the corporate sector, which buys and sells us from cradle to grave, until we have no more data left to mine.

Consider that on any given day, the average American going about his daily business will be monitored, surveilled, spied on, and tracked in more than 20 different ways, by both government and corporate eyes and ears. A byproduct of this new age in which we live, whether you're walking through a store, driving your car, checking email, or talking to friends and family on the phone, you can be sure that some government agency, whether the NSA or some other entity, is listening in and tracking your behavior.

Corporate trackers monitor your purchases, web browsing, Facebook posts, and other activities taking place in the cybersphere. For example, every time you use a loyalty card at the grocery store or elsewhere, your purchases are being monitored, mined for data, and sold to the highest bidder. Every time you use your credit or debit card, or your digital "wallet," your transactions are being tracked. Uber's ride service app knows where you are even when you are not actively using the service. Even store mannequins are being used to monitor and identify shoppers with facial recognition software.

## “SMART” CITIES

Major cities are being transformed into “Smart Cities” filled with sensors in everything from pavement to lamp posts, and all of that data is being linked together to monitor the day-to-day lives of everyone in them. In some cities, even the sewage is being monitored and could potentially be used to find out what drugs a household may have used.

All of your medical data in the near future will be constantly monitored, and while the data is supposed to only be shared with your doctor, in practice it will be accessible by any number of government and private actors. Microchips in “smart pills” that can communicate with tablet devices to ensure the elderly take their medications already exist. A transponder injected into the skin that contains a person’s entire medical history has been approved by the FDA. Wearable health-monitoring devices likewise can be used to monitor you, and the information collected can be used in a court of law. Smart toothbrushes can monitor your brushing habits and communicate them to your dentist, or anyone else. Smart alarm clocks can monitor your sleep habits.

Like all other devices relying on the Internet of Things (IoT) to communicate, these can be hacked into by government and private corporations.

The “Internet of things” (IoT) refers to the growing number of “smart” appliances and electronic devices now connected to the Internet and capable of interacting with each other and being controlled remotely. These range from thermostats and coffee makers to cars and TVs.



While a “smart city” hardwired to the Internet may sound appealing to some, the dangers inherent with it were exposed recently when malicious software used by U.S. intelligence was unleashed on the world. Hospitals and banks were forced to shut down, as the “malware” infected computers and prevented anyone from conducting business.

## A PRICE TO PAY

Of course, there’s a price to pay for such easy control and access. That price amounts to relinquishing control of and access to your home to the

government and its corporate partners. For example, while Samsung’s Smart TVs are capable of “listening” to what you say, thereby allowing users to control the TV using voice commands, it also records everything you say and relays it to a third party. Same goes for Amazon’s Echo.

“Smart houses” filled with IoT-capable devices are just starting to come into play, but by 2020 Samsung pledges that all of its devices, including its household appliances, will be IoT capable. Such products include ovens, microwaves, vacuums (including robot vacuums), refrigerators, dishwashers, washing machines, and dryers, as well as smart hubs which coordinate everything. Coffee makers and toasters are also being made IoT compatible.

Smart TVs seemingly out of Orwell’s *1984* will also collect data and spy on you. Modern gaming consoles have Internet connections, and those with cameras can be used to spy like any smartphone or computer. Smart power outlets can turn your lights on and off remotely, and smart thermostats work similarly.

All of them monitor when you’re at home or not, as can smart home security systems. Wi-Fi routers can even monitor the inside of your home and distinguish between different individuals in the house, while reading their lips to “hear” what they say. Other forms of home monitoring systems for the elderly can be hacked and used by anyone.

Already the web-enabled “Hello Barbie” doll has been the center of a hacking controversy, in which security experts disclosed a number of significant security flaws with the toy.

Other smart objects include smart golf clubs, which monitor the speed, acceleration, and swing plane of your golf swing, and smart shoes which track your location and can guide you on where to go. Tostitos has even unveiled a promotional smart bag of chips which can tell you if you’ve been drinking too much.

## EVEN MORE WAYS TO MONITOR YOU

That doesn’t even begin to touch on all of the government’s many methods of spying on its citizens. For instance, police have been using Stingray devices mounted on their cruisers to intercept cell phone calls and text messages without court-issued

Exactly which data it gathers on your family's viewing habits, conversations, and movements, and to whom that data is being sent and sold, is not known, but it's assuredly more than you wanted anyone outside your immediate family to know.

search warrants.

Doppler radar devices, which can detect human breathing and movement within a home, are already being employed by the police to peer inside a suspect's home.

License plate readers, yet another law enforcement spying device made possible through funding by the Department of Homeland Security, can record up to 1,800 license plates per minute. These surveillance devices can also photograph those inside a moving car. Recent reports indicate that the DEA has been using license plate readers in conjunction with facial recognition software to build a "vehicle surveillance database" of the nation's cars, drivers and passengers.

Sidewalk and "public space" cameras, sold to gullible communities as a sure-fire means of fighting crime, is yet another DHS program that is blanketing small and large towns alike with government-funded and monitored surveillance cameras. It's all part of a public-private partnership that gives government officials access to all manner of surveillance cameras, on sidewalks, on buildings, on buses, even those installed on private property.

Couple these surveillance cameras with facial recognition and behavior-sensing technology and you have the makings of "pre-crime" cameras, which scan your mannerisms, compare you to pre-set parameters for "normal" behavior, and alert the police if you trigger any computerized alarms as being "suspicious."

## DNA DATABASES

Capitalizing on a series of notorious abductions of college-aged students, several states are pushing to expand their biometric and DNA databases by requiring that anyone accused of a misdemeanor have their DNA collected and catalogued. Technology is already available that allows the government to collect biometrics such as fingerprints from a distance, without a person's cooperation or

knowledge. One system can actually scan and identify a fingerprint from nearly 20 feet away.

Radar guns have long been the speed cop's best friend, allowing him to hide out by the side of the road, identify speeding cars, and then radio ahead to a police car, which does the dirty work of pulling the driver over and issuing a ticket. Now, developers are hard at work on a radar gun that can actually show if you or someone in your car is texting. No word yet on whether the technology will also be able to detect the contents of that text message.

It's a sure bet that anything the government welcomes (and funds) too enthusiastically is bound to be a Trojan horse full of nasty surprises. Case in point: police body cameras. Hailed as the easy fix solution to police abuses, these body cameras—made possible by funding from the Department of Justice—are turning police officers into roving surveillance cameras. Of course, if you try to request access to that footage, you'll find yourself being led on a merry and costly chase through miles of red tape, bureaucratic footmen, and unhelpful courts.

And the FBI can remotely activate the microphone

on your cellphone and record your conversations. The FBI can also do the same thing to laptop computers without the owner knowing any better.

Government surveillance of social media such as Twitter and Facebook is also on the rise. # Liberal Establishment Can Derail Trump

- More than one conservative president has been brought down by leftist elite

History repeats itself, first as tragedy, then as farce, said Karl Marx. On publication day of my memoir of Richard Nixon's White House, President Trump fired FBI Director James Comey. Instantly, the media cried "Nixonian," comparing it to the 1973 Saturday Night Massacre.

Yet, the differences are stark.

The resignations of Attorney General Elliot Richardson and Deputy Attorney General Bill Ruckelshaus and the firing of Special Prosecutor Archibald Cox came in the middle of an East-West crisis.

On Oct. 6, 1973, the high holy day of Yom Kippur, in a surprise attack, Egyptian troops crossed the Suez Canal and breached Israel's Bar Lev Line. Syria attacked on the Golan Heights.

Within days, 1,000 Israeli soldiers were dead, hundreds of tanks destroyed, dozens of planes downed by Soviet surface-to-air missiles. As Egypt's army broke through in the Sinai, there came reports that Moshe Dayan was arming Israeli F-4s with nuclear weapons. "This is the end of the Third Temple," Dayan was quoted.

Nixon ordered every U.S. transport that could fly to deliver tanks and planes to Israel. Gen. Ariel Sharon crossed the Suez Canal to the west and rolled north to cut off and kill the Egyptian 3rd army in Sinai. The Gulf Arabs declared an oil embargo of the United States.

We got reports that nuclear-capable Russian ships were moving through the Dardanelles and



Soviet airborne divisions were moving to airfields. U.S. nuclear forces were put on heightened alert.

On Oct. 10, another blow had befallen Nixon's White House. Vice President Agnew pleaded nolo contendere to tax evasion and resigned. Nixon immediately named Gerald Ford to replace him.

It was in this environment, with Henry Kissinger in Moscow trying to negotiate a ceasefire in the Mideast, that Cox refused to accept a compromise deal that would give him verified summaries of Nixon's tapes, but not actual tapes.

Democrat Senators Sam Ervin and John Stennis had accepted this compromise, as had Richard-

son, or so we believed.

Nixon had no choice. As he told me, he could not, in this Cold War crisis, have Soviet Premier Leonid Brezhnev see him back down in the face of defiance by one of his own Cabinet appointees.

If he had to, Nixon told me, he would reach down to a GS-7 at Justice to fire Cox: "We can't have that viper sleeping in the bed with us."

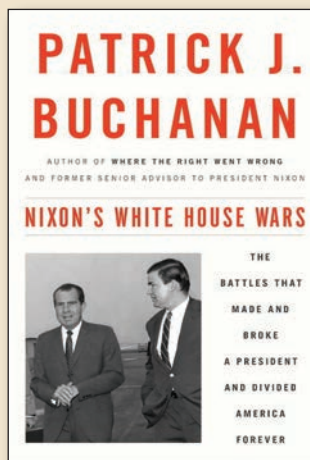
That Saturday night, I told friends, next week will bring resolutions of impeachment in the House. And so it did.

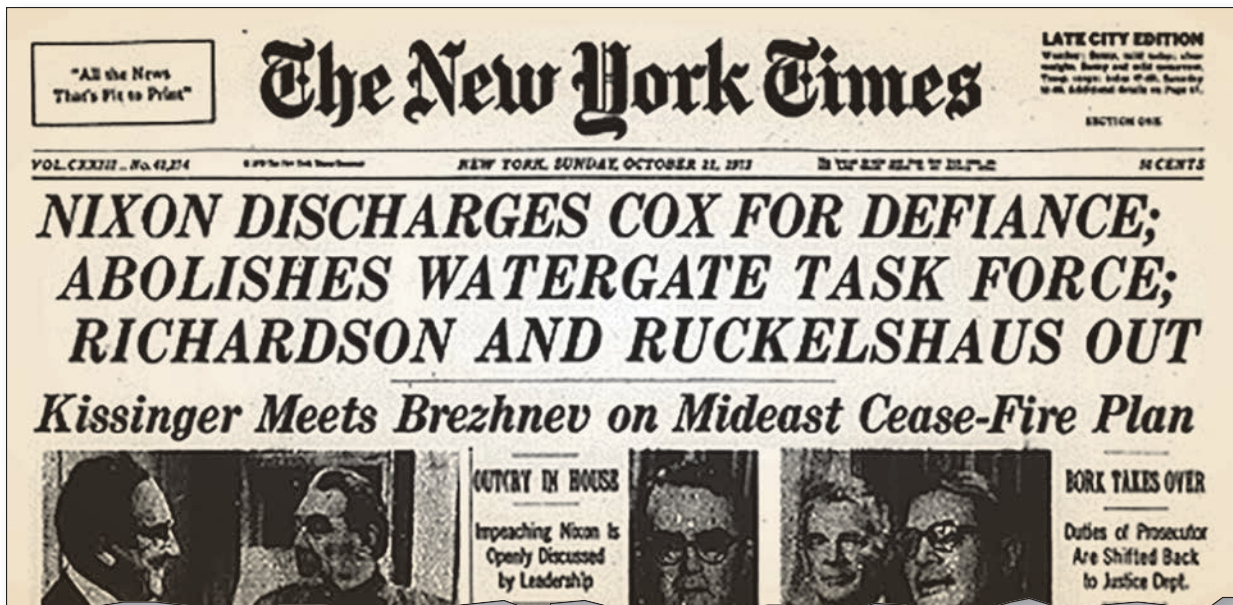

ment and shut down the special prosecutor's office, Trump simply fired an FBI director who agreed that Trump had every right to do so.

By October 1973, with two dozen Nixon White House, Cabinet and campaign officers convicted or facing indictment and trial, we were steeped in the worst political scandal in U.S. history. Nothing comparable exists today.

But if Trump is enraged, he has every right to be. Since July, the FBI has been investigating alleged Trump campaign collusion with Putin's Russia to hack the DNC and John Podesta's email accounts—and produced zilch. As of January, ex-CIA Director Mike Morell and ex-National Intelligence Director James Clapper said no collusion was found.

Yet every day we hear Democrats and the media bray about a Putin-Trump connection and Russian “control” of the president.

In the early 1950s, they had a term for this. It was called McCarthyism, and its greatest practitioners invariably turned out to be those who had invented the term. “Justice delayed is justice denied!” applies to presidents, too.

Trump has been under a cloud of a “Russian connection” to him and his campaign for nearly a year. Yet no hard evidence of Trump-Russia collusion in the election has been produced. Is not the endless airing of unproven allegations inherently un-American?

In 1973, NBC's John Chancellor suggested the ouster of Richardson, Ruckelshaus, and Cox was the "most serious constitutional crisis" in U.S. history, passing over the secession of 11 Southern states and a Civil War that cost 620,000 lives. One London reporter said that "the whiff of the Gestapo was in the clear October air." We see a similar hysteria rising today. Yet that was not a constitutional crisis then, and the mandated early retirement of Jim Comey is not a constitutional crisis now.

And that the mainstream media are equating “Russia-gate” and Watergate tells you what is afoot. Trump is hated by this city, which gave him 4% of its votes, as much as Nixon was. And the deep-state determination to bring him down is as great as it was with Nixon.

By 1968, the liberal establishment had lost the mandate it had held since 1933, but not lost its ability to wound and kill presidents.

Though Nixon won 49 states, that establishment took him down. Though Ronald Reagan won 49 states, that establishment almost took him down in the Iran-Contra affair. And that is the end they have in mind for President Trump. ★

# Afghanistan, Iraq, Libya, Syria, Yemen, Kurdistan: U.S. Military Expanding Wars Across Middle East

**T**he mainstream media's singular focus on questionable conspiracies orbiting Donald Trump has ensured the American public is being kept in the dark about deepening U.S. military overseas commitments.

For example, there has been scant coverage of a decision to provide Syria's Kurds with heavy weapons or of recommendations to send thousands more troops to Afghanistan. There has been no reporting on the Pentagon secretly reviewing whether it should commit more personnel and materiel to the Saudi war in Yemen and to the defeat of ISIS in Libya.

There are real dangers arising from the media ignoring major foreign policy developments. Primarily, the American public is effectively removed from having its voice heard and of providing an oversight role of planned projections of U.S. military power. It also means less scrutiny of a growing trend by the White House to outsource critical military decisions to the Pentagon, thereby diluting civilian control of the decision-making process.

The announcement by Trump to send the Syrian Kurds additional heavy weapons has placed Washington at odds with Turkey. Nevertheless, the Pentagon believes the only way to defeat ISIS in Syria is by using the Kurds to liberate the town of Raqqa. Having Kurdish forces, numbering over 15,000, do most of the fighting and dying in that battle would lessen the need for Washington to put more U.S. boots on the ground. However, the promise of heavy weapons to the Kurds came about in response to several troubling events for the Washington-Kurdish military alliance.

On April 23, Turkish planes attacked Syrian Kurd positions, killing more than 20 fighters, 10 of them women. The Kurds responded by warning the Pentagon that if Turkey did not stop bombing them they would stand down, leaving U.S. Special Forces to fight the battle alone.

Ankara sees the Kurds as more of an enemy than ISIS. There are 15 million Kurds in Turkey and tens of millions more in Syria, Iran, and northern Iraq. Some Kurds, demanding a homeland, have been at war with Turkey for decades. Turkey is determined the Kurds should not be permitted to establish autonomous zones in Syria and Iraq close to the Turkish border.

When news reached Trump that Turkey had bombed the Kurds, he told Ankara to stop. He followed with a promise to the Kurds of big weapons shipments, a move applauded by Russia that sees the Kurds as essential to the defeat of ISIS in Syria.

The Kurds had to give Washington an agreement

that they would return the U.S. weapons after the liberation of Raqqa. Observers believe such a promise is laughable, because it will not be kept. Some see it as a ploy by Washington to allay the fears of Turks who oppose arming the Kurds.

Missing from coverage of the Washington-Kurdish alliance is any analysis of Pentagon strategic objectives.

According to several European sources AFP consulted, who requested anonymity, neocons in Congress would like to see the U.S. have a role in the future shape of Syria and northern Iraq. By backing the Kurds, Washington might eventually seek to establish a military component within future autonomous Kurdish regions of Syria and northern Iraq. It is a prospect that appears to concern Ankara and Tehran more than Moscow.

Aside from deepening U.S. involvement in Syr-

ia, Trump has announced his intention to defeat the Taliban in Afghanistan, an objective most military strategists regard as fanciful. While there have been reports the president might send an additional 3,000 troops to Afghanistan, there have also been claims, denied by Moscow, that Russia has been arming the Taliban to fight ISIS in Afghanistan. That could be bogus reporting aimed at discrediting Moscow, because the Taliban is already heavily armed and would not need additional weapons to defeat a much inferior foe like ISIS.

If the Pentagon is preparing for a campaign to defeat the Taliban, an additional 3,000 troops could be the start of mission creep. While there has been little to no American media reaction to the prospect of an increased military commitment to Afghanistan, the British public has expressed unease with its government's decision to send a mere 100 troops to join the 550 British troops already there.

Libya meanwhile has stayed off the media radar despite the fact that ISIS has been building a foothold in the country. Russia has been trying to persuade Washington to commit greater military resources to Libya. A similar plea has been made by Egypt, but there have been confusing signals from within the Trump administration about how to respond.

A British diplomat, who spoke on condition of anonymity, told AFP that 10 Downing Street was confident Washington would send more men and materiel to Libya, but would not necessarily agree to any suggested partitioning of the country. ★

# Russians Think U.S. Is Ready to Strike

• But who really holds advantage if America actually nuked Russia or China?

**O**n April 26, Lt. Gen. Viktor Poznihir, deputy chief of the Main Operations Directorate of the Russian Armed Forces, declared at the Moscow International Security Conference that the Russian General Staff has concluded that the United States is preparing a first-strike nuclear attack on Russia.

“Russian military experts believe that the U.S. hopes to gain the capability to strike any region of the world, including Russia and China, with nuclear-tipped missiles with impunity,” he said.

Poznihir argued that Washington’s strategy is to strike first, then use its missile shield to keep a counter-attack at bay.

U.S. missile defense bases now erected in Europe, the movement of naval vessels armed with nuclear warheads near Russia, and the building of a new shield system support this thesis. Why would the U.S. do this? The answer is simple: It’s about money. The U.S. and its Western allies are deeply in debt, and the only war they can afford is a total nuclear war.

Poznihir said that the European NATO bases are using a ground-based radar system alongside a maritime missile defense system. These can use a wide variety of missiles to shoot down Russian counter-attacking ICBMs.

The logic behind this is that the neoconservatives

believe Washington’s first strike will so badly harm the Russian and Chinese retaliatory capability that both states will cave in rather than launch a response, or so opines Paul Craig Roberts.

“The Russian and Chinese leaderships would conclude that their diminished forces leave little chance that many of their ICBMs will be able to get past Washington’s ABM shield, leaving the U.S. largely intact,” wrote Roberts recently. “A feeble retaliation by Russia and China would simply invite a second-wave U.S. nuclear attack that would obliterate Russian and Chinese cities, killing millions and leaving both countries in ruins.”

This is pure speculation.

Any war with Russia and China is a war against the Shanghai Cooperation Organization (SCO) and its members, China, Kazakhstan, Kyrgyzstan, Russia, Tajikistan, Uzbekistan, Iran, Pakistan, and India. This is a formidable force now under a defense pact looser than NATO’s, but no less binding. The United States has few allies willing to risk it all for American business interests.

Starting in 2005, Russia and China, along with Kazakhstan, have engaged in large-scale war games. In 2006, a meeting of the SCO member states defense ministers agreed on a defense pact. Russian long-range bombers, stationed in China, would be engaged in regular patrols for the first time since the 1980s, according to a 2007 pact of the SCO. This is exclusively due to American saber-rattling, as neither nation has an interest in destroying itself.

More recently, Turkey has applied for mem-

bership in the SCO, all but formally severing its ties with NATO. This would be a disaster for the Western military alliance, since Turkey has a large army and is the southern anchor for Mideast operations. This occurred just a few years after the United States set up its defense shield aimed at Iran, but was, in fact, aimed at Russia.

The same for North Korea. The Chinese are well aware that the North Korean “threat” has more to do with China than Pyongyang. As this writer wrote recently in AMERICAN FREE PRESS, the stories of China’s threats against North Korea are fake news. The truth is that Peking sees U.S. attacks on North Korea as a direct attack on China.

While politicians are speaking of “first-strike” strategies against either Russia or China, *Newsweek* mocks their pretensions, claiming convincingly that Russia has a nuclear arsenal that is superior to the West’s. Russia has spent billions in improving its arsenal while the American stock has deteriorated. Once President George W. Bush withdrew from the ballistics missile treaty, Russia had little choice but to improve its capacity.

Thus, the United States is engaging in saber-rattling with a poor nuclear arsenal. However, American neocons are convinced the United States can win a nuclear war against the entire combined militaries of the SCO. ★

# Herald Calls for Boston Massacre

• Mainstream rag says “lying about vaccines” is a “hanging offense”

**T**he vaccine hysteria rhetoric is heating up so much that *The Boston Herald* editorial board on May 10 wrote that “lying” to people about vaccines should be a “hanging offense.”

The *Herald*'s call to death was made in light of the widely reported story about the children of Somali refugees in Minnesota, who experienced an “outbreak” of measles. Apparently, some Somali parents have opted their children out of the MMR (measles, mumps, and rubella) vaccine, enraging the establishment vaccine lobby.

The word outbreak connotes something massive, but, in real numbers, we're talking about 46 children, 41 of whom are Somali. None of these children is seriously ill, as of this writing.

The *Herald*'s full statement concluding the editorial reads: “These are the facts: Vaccines don't cause autism. Measles can kill. And lying to vulnerable people about the health and safety of their children ought to be a hanging offense.”

If the *Herald* took the effort to do even a minimal job of investigation, free of bias, they would issue an apology and investigate the many layers of vaccination, from theory to practice, instead of calling for lynching those who question vaccine dogma. Of course, that won't happen, and the fact that vaccine critics are educating the public in alternative media outlets is irritating the establishment to the extent that a noted media organ calls for death.

While this writer is solidly against mandatory vaccination of any kind, for reasons of personal liberty and science, one would think the push to vaccinate would actually have a profound basis, given the hyperbolic call for death.

Measles deaths were in dramatic decline for decades before the introduction of the measles vaccine in the U.S. in 1963 and even before the proliferation of penicillin in 1944.

While a significant number of people died from measles in the 1800s, by the early 20th century, measles became manageable with knowledge of the importance of nutrition, not vaccination or pharmaceuticals.

In 1960, the official number of deaths from measles was recorded as 380 in the United States, in a population of 180,671,000 people. Compared to other causes of death, measles ranked extremely low. Even in 1963, deaths from asthma were 56 times higher than measles, from accidents were 935 times higher (motor vehicles 323 times higher), and heart disease 9,560 times higher, according to Dr. Suzanne Humphries and Roman Bystryanyk in their book titled, *Dissolving Illusions*.

Why, then, did the establishment in 1963 foist the

measles vaccine on the public when measles already wiped itself out, without a vaccine, antibiotics or other wonder drug?

If you are conspiratorially minded, the question may answer itself. Rockefeller-inspired allopathic medicine claimed that measles needed to be “wiped out” entirely.

Wiping out a disease that is already virtually nonexistent doesn't make sense to anyone with common sense.

The irony is that it was already well known among medical professionals that in most cases, measles was a benign disease from which most recovered and, as a result, actually received the benefit of immunity against a subsequent occurrence.

Dr. Humphries and Bystryanyk wrote how important vitamin A is to preventing measles from overtaking the body and that this was known in the early 1900s: “It was known that certain vitamins had a significant impact on measles outcomes. Vitamin A stops the measles virus from rapidly multiplying inside cells by up-regulating the innate immune system in uninfected cells, which helps to prevent the virus from infecting new cells.”

It's a fact that well-nourished children didn't die or suffer damage from a case of the measles, and

that use of cod liver oil in the 1930s resulted in helping those affected. Studies in the 1990s confirmed that by using vitamin A, measles deaths could be reduced up to 90% in developing countries where children often are severely malnourished.

Better nutrition made children in America and most of the advanced world healthier, because advances in transportation brought vitamin-rich fruits and vegetables to more people. Dr. Humphries and Bystryanyk drove this point home by tracking the incidence of scurvy and measles, both of which plummeted due to better nutrition.

The measles vaccine has a checkered history, from inception of its use in 1963 to today's version, in spite of assurances of safety and efficacy from big pharma and its lapdog media.

The first measles vaccine introduced in America in 1963, known as the KMV (killed measles virus), contained “killed” virus (which) was an aluminum-precipitated vaccine produced from formaldehyde-inactivated monkey kidney cell cultures,” according to Dr. Humphries and Bystryanyk.

KMV was a disaster, causing pneumonia and encephalopathy (brain swelling) in some cases, which brought the establishment to recommend it be discontinued, as early as 1967.

Not learning from this mistake, big pharma thought it a good idea to use a live vaccine instead, and recommended that all who had received KMV get the new vaccine as well.

As Dr. Humphries and Bystryanyk wrote, “Those who encountered wild measles or live vaccine measles, after having the killed vaccine, had a tendency to develop a more severe disease, atypical measles” because the immune system in those vaccinated wrongly programmed the immune system.

The modified live vaccine brought rashes to nearly half of those injected and fevers up to 106 degrees in up to 83% of those who received it. Don't fear, though, because the geniuses at big pharma injected a “measles-specific antibody,” which did keep excessive rash and fever under control, but brought about other health maladies in those who received it, including neurological problems. Ironically, atypical measles could appear up to 16 years after injection of the modified measles vaccine. The measles vaccine did cause neurological damage in some reported cases and, interestingly, did not contain mercury as an adjuvant—driving home the point that mercury, alone, should not be singled out as the “problem” with vaccines.

Many have heard the names of Dr. Andrew Wakefield and Dr. William Thompson in news reports. Wakefield has been wrongly attacked as a fraud when all he did was have published in the journal *Lancet* in 1998 a link between regressive autism and a gastrointestinal malady named ilea nodular enterocolitis in children given the MMR vaccine. Wakefield's paper was retracted by the General Medical

Council 12 years later in what is best described as politics.

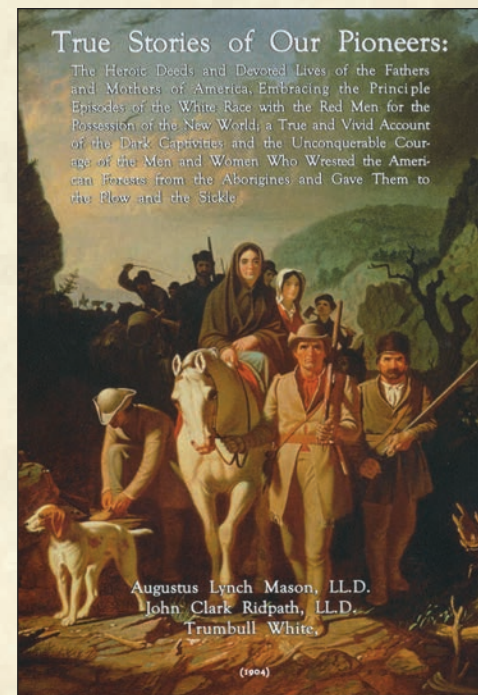
Thompson, a former Centers for Disease Control (CDC) scientist, who invoked federal whistleblower protection in 2014, reported that the CDC committed fraud regarding the link between vaccines and autism. He wrote in a letter to the CDC: "I regret that my coauthors and I omitted statistically significant information in our 2004 article published in the journal *Pediatrics*. The omitted data suggested that African-American males who received the MMR vaccine before age 36 months were at increased risk for autism. Decisions were made regarding which findings to report after the data were collected, and I believe that the final study protocol was not followed."

Given the history of measles and vaccination in the United States, is it any wonder reasonable parents object to vaccination?

*The Boston Herald* and the medical establishment have failed abysmally when one considers the burden of proof is on them to show that injecting viruses with various chemical adjuvants into the bodies of children should not only be safe, but should also be warranted to prevent serious, life-threatening diseases. ★

# Medicrats *Wrong* About Fats

• As health of Americans continues to decline, debate about dietary fats heats up

There's a war going on inside this country. However, this one doesn't involve militarized police kicking down doors and shooting innocent people or even the propaganda war that's being waged to control your thoughts. This fight is over your health—more specifically, what you're being told is good to eat in order to ensure optimal health.

Her new book, titled *Nourishing Fats: Why We Need Animal Fats for Health and Happiness*, makes just this case, arguing cogently that fat-free margarines and certain vegetable oils are not just making people fat and unhealthy, they're actually killing us.

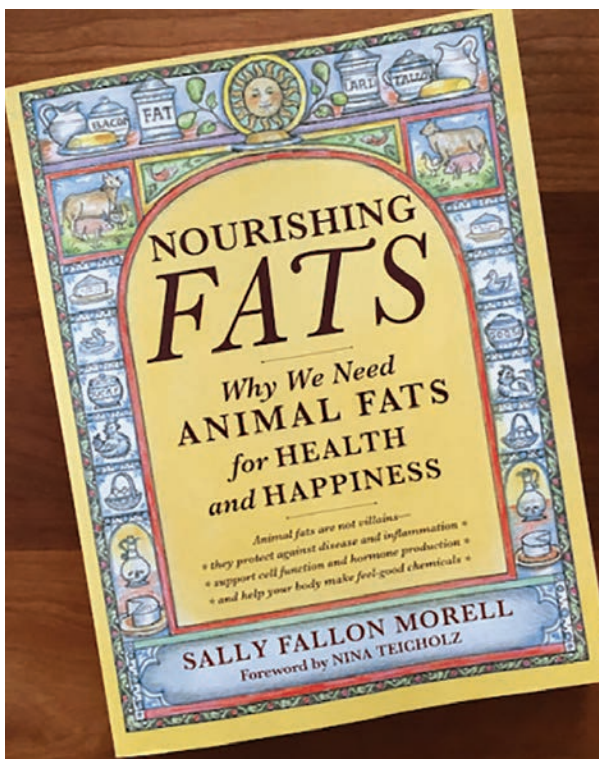
The premise of the book is laid out right on the cover of the book: "Animal fats are not villains."

Over the years, Americans have been inundated with bad advice on how to eat healthy that's not just inconsistent, but schizophrenic. One day, it's "Don't eat any fats—they're all bad for you." The next day it's, "Okay, you can eat some fats from fish and avocados." Then, the next day, they tell us, "Well, eggs and meat aren't that bad for you after all."

Now, an editorial published in *The British Journal of Sports Medicine* by several leading cardiologists states: "It is time to shift the public health message in the prevention and treatment of coronary artery disease away from measuring serum lipids [cholesterol] and reducing dietary saturated fat. Coronary artery disease is a chronic inflammatory disease, and it can be reduced effectively by walking 22 minutes a day and eating real food." The real food they're referring to consists of full-fat milk and other once-maligned foods that your parents and grandparents ate.

It's no wonder the average person is totally confused by this. It's also no wonder obesity rates are through the roof.

Mrs. Morell's farm is only a few miles up the road from this editor's house. She sat down with me recently to discuss her book as well as her tireless work to educate Americans on healthy living.



Her views are devastating to the medical and dietary establishment, arguing that animal fats are not just not bad for you—they actually are vital for the human body to function.

"Animal fats are essential for us," Mrs. Morell told AFP. "One thing that the mainstream media and the establishment has never budged on is that saturated fats are the enemy. They're bad. They'll clog your arteries. And this is where we've gone wrong. Saturated fats are critical for our health, and, of

course, we get saturated fats mostly from animal fats."

Mrs. Morell told AFP, "What's in the animal fats are nutrients we can't get anywhere else—vitamins A, D, and K—that are absolutely critical for our health." Her book contains nearly 30 pages of footnotes that cite scientific research studies and books proving that animal fats are healthy for the human body.

# Pacifist Historian Denied U.S. Entry

• Ernst Zuendel cannot come home after serving sentence for “thought crimes”

**E**rnst Zuendel, the internationally renowned historical revisionist and activist who has been persecuted by a number of Western governments for his political activism and historical research, has been denied entry to the United States after seeking to rejoin his wife in Tennessee, it was recently revealed.

Zuendel, 78, who has served jail time in Germany and Canada for questioning the official “Holocaust” narrative, had been attempting to obtain an immigrant visa to travel to the United States and live with his American wife, Ingrid Zuendel.

Under normal circumstances, a foreign national seeking an immigration visa to join an American spouse would find little difficulty in obtaining the visa. However, due to Zuendel’s views and imprisonment for thought crimes, he was deemed “inadmissible” by Ron Rosenberg, the chief of the Administrative Appeals Office of the U.S. Department of Homeland Security (DHS), which decided Zuendel’s fate.

In its ruling, the Administrative Appeals Office cited Zuendel’s 2007 conviction in Germany of 14 counts of “incitement to hatred” and one count of “violating the memory of the dead,” Orwellian thought crimes institutionalized in Germany and many other Western nations following World War II in an effort to criminalize political dissent and historical inquiry, particularly as it relates to the official narrative explaining WWII and the Jewish “Holocaust.” Zuendel served five years in prison in Germany after facing legal challenges in both Canada and the United States.

The DHS’s ruling also noted that Zuendel is “a historical revisionist and denier of the Holocaust, distributing writings, books, tapes, videos, and broadcasts to promote his views” and contends that he has a “long history of inciting racial, ethnic, and religious hatred” while agitating “for aggressive behavior against Jews.” Zuendel “has been a leader in these activities for decades and has shown no regret or remorse for his actions,” the ruling stated in an attempt to justify its decision to ban the historian from rejoining his elderly wife in America.

Of course, Zuendel’s previous political, historical, and educational activities—hysterically demonized and twisted by the Administrative Appeals Office’s characterization in its ruling—are not in any way illegal in the United States. Whatever one believes about WWII history, Zuendel, who is a pacifist, went to great lengths to document the controversial statements and perspectives he was publicly offering in a scholarly fashion.



**Revisionist historian, activist, and pacifist Ernst Zuendel** was recently denied entry into the United States because he had been imprisoned in Germany for thought crimes. Despite the fact that what Zuendel was jailed for is not illegal in the U.S., immigration officials still chose to deny him a visa to be with his wife, who is an American citizen.

“Ernest Zuendel has been punished enough. Let this brave man come home. He poses no threat.”

Ingrid Zuendel, Ernst’s American wife who has long been involved with his political and historical activism, denied the U.S. federal government’s characterization of her husband as an inciter of hatred and instigator of aggressive behavior toward Jewish people.

“Canada has had a ‘hate law’ statute on its books for decades,” Ingrid explained to this newspaper in a recent interview. “If Ernst had been guilty of ‘racial hatred,’ he would have been charged decades ago. Ernst was never charged, much less convicted, of any hatred, much less racial hatred.”

Ingrid also disputed the notion that her husband ever advocated “aggressive behavior” toward Jews—or anyone else for that matter.

“Ernst has never been charged with ‘aggressive behavior,’ much less convicted for having acted

aggressively against anyone. He is a pacifist with a sterling record of lifelong Ghandi-like conduct. We have FBI and other police reports that say so,” Ingrid told AFP. “Not only has Ernst never acted ‘aggressively,’ he has always counseled his supporters to conduct themselves peacefully, as a matter of moral principle as well as for tactical reasons.”

The latest legal setback for the Zuendels came as no surprise to Ingrid. They have been struggling for years now in the judicial system, only to be stymied at every opportunity.

“We were not surprised by the ruling of the DHS’s Administrative Appeals Office,” Ingrid explained to this reporter. “The courts are no longer the means of last resort to get justice in America. The courts have been co-opted and are corrupted to the core. Justice can no longer be had from the bench.”

She continued: “That doesn’t mean that we are giving up. There are other means than courts to win this most important battle in the courts of public opinion. The struggle for historical truth has never been just about what happened to Ernst Zuendel. It was and is about revealing false flags and self-serving lies as tools of control by the powers-that-be. It was and is about revealing historical lies as weapons of war wielded brutally by what is now referred to as the ‘deep state’ or the ‘shadow government.’” ★

Whatever good Donald Trump may do for America, prior to taking the high office of president, it's unlikely that he ever murdered another human being in his 70-plus years.

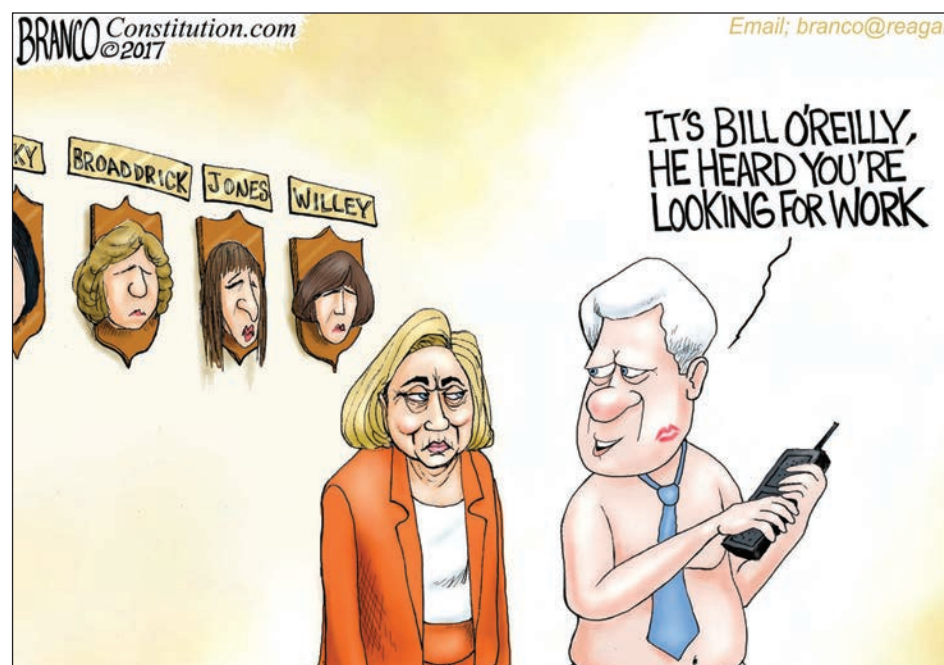
But now he has innocent blood on his hands and, by all standards, must be regarded as just another mass murderer using his political office as an excuse to carry out heinous crimes against the innocent.
