## COP SUES RADICALS

### Says Black Lives Matter rhetoric spurred mass shooting

A former Louisiana cop is suing the radical black activist group Black Lives Matter, after one of the group's followers ambushed and shot multiple police officers in 2016 in a shocking domestic terror attack that received widespread condemnation around the U.S.

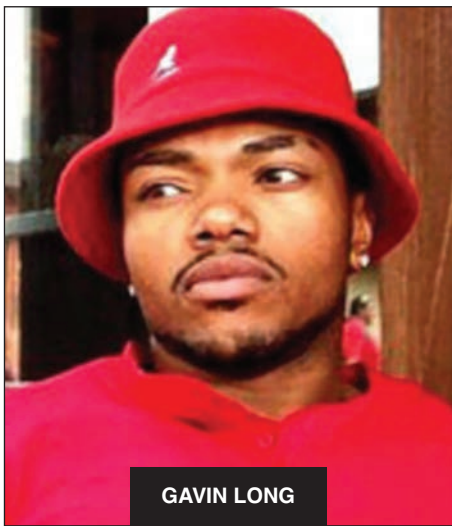
On July 17, 2016, Gavin Long, a former U.S. Marine sergeant who was motivated by the violent rhetoric of the Black Lives Matter movement, ambushed police officers in Baton Rouge, La., killing three officers and injuring three more. Long was eventually shot by a SWAT team sniper from 100 yards away, and died at the scene.

In a suicide note, Long lamented that he would be "vilified by the media and police" for his actions.

"Unfortunately," Long wrote, "I see my actions as a necessary evil that I do not wish to partake in, nor do I enjoy partaking in. But must partake in, in order to create substantial change within America's police force and judicial system." He also noted that he must "bring destruction" upon "bad cops as well as good cops in hopes that the good cops (which are the majority) will be able to stand together to enact justice and punishment

against bad cops."

The horrific ambush came less than two weeks after a Baton Rouge police officer shot and killed Alton Sterling, a 37-year-old black man whose killing sparked outrage in the black community and amongst those who believe police routinely use excessive force against citizens, and Sterling in this particular case. Sterling was killed outside a local convenience store after he physically struggled with officers and refused to obey their commands. Philando Castile, another black man, was shot and killed by a police officer in a suburb of Minneapolis a day later.

The controversial police shootings sparked a number of protests across the country, many of which were instigated, organized, and led by the Black Lives Matter movement. A major protest in Dallas turned violent when Micah Johnson, a black Army veteran who was upset over the police shootings in Baton Rouge and Minneapolis, ambushed local law en-

Under normal circumstances, our “Personal from the Editor” column features news articles or promotions that we want to highlight for readers. This week, however, we have some very sad news to report and felt it was just too important to bury on another page with the weekly news. On Aug. 5, AMERICAN FREE PRESS suffered another great loss when managing editor Julia Foster passed away quietly at her home after battling cancer for seven years.

Anyone who has ever attended one of our conferences, visited us, or even just called the office would have met Julia. In fact, many readers knew her quite well and asked for her by name because they enjoyed speaking with her. Few people, however, knew she had been very sick for a number of years. Julia was the type of person who almost always came to work and rarely if ever took a sick day. And even when she felt poorly, she never complained about it. For over 35 years in this business, Julia was a rock, the consummate voice of professionalism, reason, and common sense. No matter what was going on—whether it was some breaking news, a lawsuit, or just a particularly tough day—she never failed to be courteous and helpful to staff and subscribers alike, offering to go above and beyond what was necessary to make sure we got the newspaper out the door and in the mail, week in, week out.

This past June marked my 20th year in this business, and it was Julia to whom I owe it all. At the behest of a friend in the summer of 1997, I showed up for an interview with Julia, who at the time was head of the circulation department

at *The Spotlight* newspaper on Capitol Hill in Washington, D.C. She offered me a starting position doing some second-class mailings and helping to manage distributor accounts. After a few years, I moved out of circulation and into the editorial department as an assistant to the editor, and very slowly started climbing my way up, along the way working with some amazing editors, journalists, authors, radio show hosts, and political activists. Throughout my whole career, Julia has been ever-present in all aspects of the business, lending her knowledge and expertise whether the discussions involved business matters or were about editorial content.

When *The Spotlight* closed its doors in 2001 after a lengthy and bruising legal battle, Julia was out in front helping us pick up the pieces and start AMERICAN FREE PRESS. And for the next 16 years, she willingly took on multiple roles,

handling everything from navigating us through the morass of the Postal Service to making sure customers received the books they ordered to keeping up on our book inventory to lending a hand in the editorial department.

Considering all of these professional accomplishments, one would tend to think that Julia neglected her home life. In reality, though, family was the most important thing in her life. It speaks loudly of Julia's character that throughout it all she was most proud of her extended and quite large family, telling anyone and everyone about her children, her grandchildren, and her great-grandchildren. After all, to Julia that is what mattered most—the next generations she had a hand in raising, who would carry on her legacy long after she was gone.

For over three decades, Julia worked for the good of this country, rarely if ever saying a thing about the pain she endured. Even in her last few weeks, she often called the office to check in with us, providing sound advice on everything from handling our ongoing problems with the post office to more mundane, everyday affairs.

I know I speak for everyone at AMERICAN FREE PRESS—staff and subscribers alike—when I say that Julia will be missed terribly, but if anyone on this great Earth ever deserved some peace, it is she.

# News You May Have Missed

## America Fixes Elections?

With all the hullabaloo about Russia allegedly meddling in a U.S. election, one naturally gets to wondering how many times Uncle Sam has meddled in the elections of other lands. Shockingly, Washington has meddled in foreign elections at least 81 times (just as many under Republican as Democratic administrations), as counted in a study by Dr. Dov Levin of the Institute for Politics and Strategy at Carnegie-Melon. Forty-seven countries have been victimized, according to the review, including Russia.

## Victory for Palestinians

Grassroots Palestinians, both Christian and Muslim, came together recently in a people's movement to keep the Al-Aqsa compound—Jerusalem's most holy site—in the hands of Palestinians. The compound's fate is considered key to the fate of all Jerusalem and even all of Palestine. If it is lost to the people, then everything is lost. Ordinary people occupied the site, with massive crowds of thousands of people standing, sitting, praying or running among Israeli bullets, sound bombs, and tear gas canisters. Against all rational odds, they won, and the Zionist army removed its cameras and metal detectors—pushing the apartheid state to the brink of a political crisis.

## Fake News Selloff

No state could be more restrictive than the federal government under his proposed legislation, H.R. 3576, introduced July 31. It would ban state and local governments from regulating rifles or shotguns more restrictively than federal regulations.

## Targeting Conservatives

Google recently fired an employee who'd written a scathing internal memo attacking the company's so-called diversity policies. In telling reporters of his dismissal, email author James Damore, a Google engineer, said he was fired for "perpetuating gender stereotypes" in his 10-page letter that describes how Google regularly silences conservative political opinions while ignoring scientific studies proving that biological differences between males and females exist. Google's ideological bias was highlighted at a recent shareholder meeting when a shareholder asked executives from the company whether conservatives would feel welcome there. Arguing everyone is welcome there, Alphabet Executive Chairman Eric Schmidt said, "The company was founded under the principles of freedom of expression, diversity, inclusiveness, and science-based thinking." In truth, there is a host of evidence that proves otherwise. It was Google that abruptly canceled AFP's online advertising account six months ago with no explanation, costing AFP thousands of dollars in annual revenue. The assumption is the Internet giant dumped AFP because it doesn't like AFP's conservative outlook.

## Up to No Good

They're at it again. Planned Parenthood, the nation's biggest provider of abortions, is pushing perversion with a new set of guidelines to teach children about gender identity. According to this Bolshevik screed, your private parts do

not determine whether you are a boy or a girl, and homosexuality is as normal as heterosexuality. 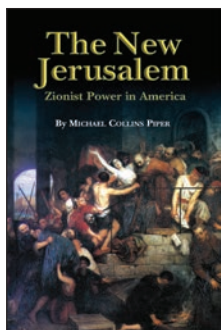
## Behind Opioid Epidemic

# Judge Says Sheriff Joe Violated Law

• Strange behavior by Judge Susan Bolton grounds for appeal, says Arpaio's lawyer

**P**HOENIX, Ariz.—On July 31, former Maricopa County, Arizona Sheriff Joe Arpaio was found guilty of misdemeanor criminal contempt. The government had claimed he willfully disregarded a 2011 federal injunction, issued to bar him from rounding up illegal aliens during his time as sheriff of a county close to the border, which is often overrun by the mass migration of illegal aliens.

This federal district court verdict came down sooner than defense attorneys expected, amid other twists and turns in this case. However, there's a story behind the story that few media outlets are discussing: According to the defense, the verdict was announced in a manner that's unconstitutional and against important legal precedent.

Arpaio plans to appeal this decision of Judge Susan Bolton, who issued her verdict after a brief non-jury trial that ran four days in late June and concluded July 6. Arpaio had unsuccessfully sought a jury trial.

When this AFP writer asked one of the defense attorneys, Mark Goldman, if “ruled from the chamber” would be a better description of Judge Bolton's decisionmaking process, Goldman agreed that was a perfect way to define such a back-room manner of carrying out “justice.”

A July 31 press release from the defense clarified: “Judge . . . Bolton violated the U.S. Constitution by issuing her verdict without reading it to the defendant in public court. Her verdict is contrary to what every single witness said in the case. Arpaio believes that a jury would have found in his favor, and that it will.”

Goldman, who's been an attorney for 29 years, told AFP: “We expected more time because it's improper for her to just send it [her decision] out [via the Internet] without a court hearing. I've never seen anything like it before. There's a [previous] court of appeals case where the defendant has the right to be present during sentencing.”

What's especially interesting is that the first indication to the defense that the judge had ruled at all—since her decision was expected to come later—came when reporters called the defense seeking comment, before the team had even learned of the verdict. Goldman explained that a July 31 court-issued “internal electronic communication” addressed to the defense, time-stamped 11:08 a.m. Mountain Standard Time, arrived after those media calls.

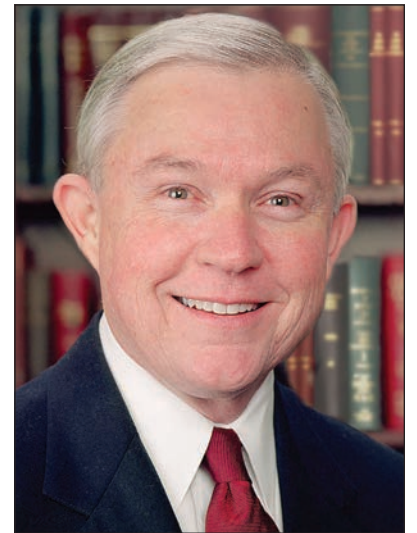
“The media was tipped off,” he said, adding that the ruling establishment that excuses the virtually unrestrained entry of illegal aliens into the U.S., many of whom commit additional crimes some of which are serious, has “won the battle but not the war.”

Judge Bolton omitted any testimony that was at odds with her own ridiculous narrative.”

The official record of Judge Bolton's ruling is larded with inappropriate remarks. This included one that noted Mexican nationals, Central Americans, and others entering the U.S. illegally, by itself, does not meet the threshold at which Maricopa sheriff's deputies under Arpaio should've been allowed to arrest illegal aliens and turn them over to federal authorities, as was done.

Judge Bolton scolded the sheriff's department for not limiting its roundups to those who had committed crimes above and beyond illegal entry.

AFP asked why the Department of Justice (DOJ) under Attorney General Jeff Sessions did not intervene in *United States of America v. Joseph M. Arpaio*, where the defendant is well respected by President Donald Trump but was targeted under the Obama White House. Goldman said DOJ lawyers who initiated this case are the same ones who continued to prosecute it, even after the new attorney general had taken office.

“It's hard to walk into the DOJ and reverse the course of public prosecutions,” he said, adding that he had written to Sessions to inform him that Arpaio was being sued under “the wrong statute,” even while Sessions disagrees with sanctuary cities and believes local police should aid in appre-

hending illegal aliens and hold them for federal custody. Sessions, however, didn't help Arpaio in return for having been a good lawman and carrying out apprehensions.

While Judge Bolton's written ruling, at face value, makes it sound like Arpaio willfully defied the 2011 injunction, including snippets of his comments quoted in various news reports, Goldman said the judge's “findings of fact are not supported by the record, including trial testimony and documentary evidence.”

Furthermore, the judge is seen as having omitted most or all testimony that mitigated against her narrative that Arpaio defied the injunction, including the testimony of Tim Casey, an outside lawyer retained by Arpaio's sheriff's department who received free rein from the department to communicate with all its employees on injunction compliance. The Human Smuggling Unit within the department had unfettered access to Casey. Arpaio, from this vantage point, simply entrusted injunction compliance to others and carried out his duties as he saw fit, not having been advised to do otherwise.

However, Casey allegedly had reasons in court to protect himself even more than Arpaio did. When called to the stand by the prosecution, Casey admitted during cross-examination by the defense that the injunction was ambiguous and not clear and definitive. According to defense attorneys, the catch, however, is that Judge Bolton omitted Casey's testimony and that of just about everyone else who countered the “defiant Joe” theme.

While Arpaio is expected to get six months behind bars—if sentencing proceedings take place Oct. 5 as planned—the defense, while appealing the case, is asking for the sentencing date to be postponed. ★

# Predetermined Verdict in Nevada?

• Alcoholic cripple gets 68-year sentence, \$1.5 million for scaring armed federal agents

**L**AS VEGAS, Nevada—When U.S. District Court of Nevada Judge Gloria Navarro meted out an extremely severe sentence on July 26 to Bundy trial defendant Gregory Burleson, who’s become blind and is apparently destitute, did she not “get” the utter injustice of her decision?

Other than Burleson himself—a former informant for the FBI—who’s now wheelchair-bound and suffers from seizures, few in the courtroom seemed to flinch when she imposed a 68-year prison sentence and a \$1.5 million fine on the 53-year-old Arizonan for the “suffering” he supposedly brought upon “fear-ridden” heavily armed federal agents, and to help offset the costs of mobilizing federal assets, in the spring 2014 “Bundy standoff” in southern Nevada near Bunkerville.

There was no hint of irony in the *Las Vegas Review-Journal* reporting that, on the one hand, “Navarro took into account Burleson’s physical impairment and his alcoholism in reaching her decision” but nevertheless sentenced him to a term that “exceeds the sentence requested by defense lawyer Terrence Jackson, who asked for a sentence lower than the mandatory minimum of 57 years.”

Burleson, convicted on eight counts, including assault, threats, extortion, obstruction of justice, and multiple gun charges, is one of six defendants in the first of three trials in what has become a grueling case. He and 49-year-old Todd Engel, a fellow supporter of Cliven Bundy—the Bunkerville rancher emblematic of the ongoing opposition against tyrannical federal land-control—were found guilty of numerous charges, many of them decidedly vague, as the first trial concluded in late April.

With the jury unable to convict the other four, Judge Navarro declared a mistrial.

The overall trial has become little more than a pre-conviction “pulpit of punishment” for the defendants in the courtroom, as the government callously and needlessly re-tries the other four defendants from the first trial rather than accepting some defeat and moving on.

Consequently, the second, highly anticipated trial, which will involve Cliven Bundy, his sons Ammon and Ryan, Ryan Payne, and Internet radio host Pete Santilli, has been once again delayed, raising *habeas corpus* concerns of unlawful detention and lack of a fair and speedy trial. Of course, that also extends to the six defendants in the third trial: Mel and Dave Bundy (also Cliven’s sons), Brian Cavalier, Jason Woods, Micah McGuire, and Joseph O’Shaughnessy, who also remain imprisoned.

Roger Roots, the legal expert who has been attending the trial, had dire news to report Aug. 2 after observing several days of the retrial of the first

four defendants, Scott Drexler, Eric Parker, Richard Lovelien, and Steven Stewart.

One would expect the trial to consist of thorough presentations of facts from both sides, including about the bizarre and threatening behavior of Bureau of Land Management (BLM) agents as they mobilized and camped out in the days leading up to April 12, 2014. This was the day BLM agents tried to seize Bundy’s cattle in response to Bundy’s purported non-payment of cattle-grazing fees on federal lands while Cliven Bundy, his sons, and supporters, some of them armed in an open-carry state, gathered to protest the BLM and its policies.

Roots reports that, instead, Judge Navarro and the prosecutors appear to be working as a tag-team to proscribe the proceedings in such a way as to tightly confine the defendants’ testimony to strictly the events of April 12, 2014, the day of the contentious standoff.

In comparison, the prosecution’s witnesses, including BLM agents involved in the affair, are being allowed to talk about events in any timeframe or manner they wish so as to portray themselves as frightened would-be “victims” in the standoff.

Importantly, though not stressed in the proceedings, not a single shot was fired in the whole affair. If there had been injuries, they would have happened when Ammon Bundy was tasered or when a pregnant woman was forced to the ground, among other assaults reportedly carried out by BLM agents during the run-up to the standoff.

This apparent rigging of the trial narrative precludes the defense from getting testimony on the record about such shocking behavior of federal agents, which also included agents setting their laser

gun-sights on bystanders and on the protestors who showed up to back the elder Bundy against BLM land policies—a foundational issue to this saga.

Any time a witness has testified on anything about the behavior of federal agents, the federal attorneys simply bellow, “Objection,” and the judge sustains it, even while agents can tell their sob stories on the stand. If the defendants take the stand, they’ll receive sufficient latitude to testify—but at the risk of giving up their Fifth Amendment protection.

Brianna Bundy, wife of defendant Mel Bundy (one of Cliven’s sons), recalled during a recent interview on KSDZ-FM in western Nebraska that:

- Federal agents prevented alternative media from getting their message out;
- Agents pointed their guns at alternative journalists;
- The court has been vilifying first-trial defendant Eric Parker for numerous things he’s read or written on Facebook, including his views on the OKC bombing and other issues totally unrelated to the Nevada affair, to paint him as a “troublemaker”;
- Judge Navarro will not allow defendants or anyone to carry a pocket Constitution within eye-shot of the jury;

• Pictures of BLM agents sometimes pointing their guns at the public are not being shown to the jury with courtroom videos edited to blot out or skip over such images; and,

• The government is estimated to have spent \$100 million on this case so far, and, according to Mrs. Bundy, the Department of Justice under Attorney General Jeff Sessions has been contacted but has been silent.

As AFP goes to press and the prosecution rests in the retrial of the four remaining defendants, the defense gets its turn in court. A key question arises: How many times can the government re-try the same four defendants before the Fifth Amendment assurance that no person may “be subject for the same offense to be twice put in jeopardy of life or limb” (double jeopardy) comes into play?

This question becomes important amid tentative indications that if the prosecution again fails to convict the four, it may re-try them a third time.

Mrs. Bundy noted there will be no trial date for the second group (Cliven Bundy, et al.) until a verdict is reached on these remaining four. There would be at least 30 days between the verdict and pretrial hearings for the second group. Meanwhile, the jailed men, behind bars for well over a year, reportedly are in good spirits overall, despite missing their family and friends.

If the judge and prosecution maintain their apparent “tag-team” approach, the jury will be reduced to a group of mere observers—denied the opportunity to reach a decision after being presented with the full story. Could we call it a “jury trial in name only,” AFP asked? Roots replied, “That describes it perfectly.” ★







# Fake News a U.S. Media Specialty

Do you remember that Obama and Hillary sent ISIS to do the job that U.S. troops were prevented from doing? Do you remember Gen. Michael Flynn revealing on TV that it was a “willful decision” of the criminal Obama regime to send ISIS to Syria over his objection as director of the Defense Intelligence Agency? This bit of told truth is why Flynn is hated by the Washington criminals who forced him out as Trump’s national security adviser.

Do you remember the U.S. coup in Ukraine against the democratically elected government and its replacement with a neo-nazi regime? Do you remember that Washington’s crime against Ukrainian democracy was quickly hidden behind false charges of “Russian invasion”?

of millions of people and saved seven countries from destruction in whole or part. But the prostitutes cheered on the gratuitous and criminal destruction of countries and peoples. Every one of the prostitutes is a war criminal under the standards set by Supreme Court Justice Robert Jackson at the Nuremberg trials.

We cannot even get a truthful jobs report. On Aug. 4, the Bureau of Labor Statistics (BLS) reported 205,000 new private-sector jobs in July and a drop in the unemployment rate to 4.3%. This is fake news.

The Associated Press’s Christopher Rugaber rahs the fake news, adding that many economists think “robust hiring could continue for many more months, or even years.” Let’s think about that for a moment. Generally speaking, economists regard full employment to be a 5% rate of unemployment. There can never be a zero rate of unemployment because of frictions in the job market. For example, there are people between jobs who have lost or quit a job and are looking for a new one, and there are people who have dropped out of the work force, perhaps to spend more time parenting or to care for an aged and ill parent, and have re-entered the work force. Economists also believe that employment cannot go too low without pushing up inflation.

Assuming economists have not suddenly changed their minds about what rate of unemployment is full employment, if the unemployment rate is currently 4.3%, it is already below the full employment rate. How can the rate continue to fall for years when the economy is already at full employment?

Of course, the 4.3% unemployment rate is fake news. It does not include millions of discouraged workers. When these workers who have not looked for jobs within the last four weeks are included, the unemployment rate jumps to 22-23%.

Consider the alleged 205,000 July new jobs. Half of these jobs are due to the add-ons from the birth-death model, and the other half from manipulations of seasonal adjustments. Let’s assume the jobs are really there. Where does the BLS tell us the jobs are?

Eighty-nine percent of the jobs are in services, essentially domestic non-tradable services. Professional and business services account for 49,000 of the jobs, of which 30,000 are in administrative

and waste services (garbage collection) and 14,700 are in temporary-help services; 54,000 of the jobs are in education and health services, of which ambulatory healthcare services, home healthcare services, and social assistance account for 46,900 of the jobs; and 62,000 of the jobs are in leisure and hospitality, of which waitresses and bartenders account for 53,100 of the jobs, and amusements, gambling, and recreation account for 5,900 jobs.

This picture of American employment has been holding for about two decades. It is a portrait of a Third-World labor force. The jobs are in lowly paid, often part-time domestic services. The jobs do not produce incomes that provide discretionary spending to drive up business profits.

So why did the stock market hit new highs? The answer is that corporate executives are taking advantage of the Federal Reserve’s zero interest rates to borrow money to buy back their companies’ shares in order to drive up their bonuses.

But these undeniable facts about employment did not prevent Christopher Rugaber and the other financial prostitutes or newspaper headline writers or “many economists” from asking in *The Atlanta Journal-Constitution* front page article on Aug. 5, “How much better can it get?”

It is not only seven Muslim countries that Washington and its prostitutes have destroyed in whole or part with lies. Washington’s lies have also destroyed the American economy and the American work force. ★

# Trump Wants Immigration Cut

- RAISE Act would diminish the number of legal aliens allowed in U.S.

In yet another effort to fulfill his campaign promises, President Donald Trump recently announced a major new immigration proposal designed to significantly reduce the number of legal immigrants entering the U.S. each year. The president has been and remains a vocal critic of illegal immigration and has taken serious and commendable measures to crack down on it. However, legal immigration is arguably an even more urgent problem that needs to be addressed, as over 1 million legal immigrants enter the U.S. each year, and this proposal aims to tackle this issue head-on.

The bill is known as the RAISE Act, which stands for Reforming American Immigration for a Strong Economy Act. It seeks to transform the current immigration paradigm to incentivize highly skilled immigrants by creating a merit-based system for prospective migrants, a stark departure from the previous immigration model that allowed family members and relatives of immigrants already settled in America to gain residency regardless of their skills, education, and economic prospects upon entering the U.S.

The Trump administration has been working closely with two key GOP lawmakers—Sens. Tom Cotton (R-Ark.) and David Perdue (R-Ga.)—to craft the legislation and announced their proposal last week during a White House ceremony.

Trump explained to reporters that the proposed legislation “would represent the most sig-

nificant reform to our immigration system in a half a century.”

During the presidential campaign, then-candidate Trump regularly criticized America’s broken immigration system, which he correctly argued has harmed America’s economy and its workers, jeopardized American national security, and facilitated the resettlement of millions of largely unskilled, uneducated immigrants who have little to offer the U.S. economy.

“As a candidate, I campaigned on creating a merit-based immigration system that protects U.S. workers and taxpayers, and that’s why we are here today,” Trump told reporters during the White House ceremony announcing the legislation.

The bill’s proponents argue that it will “spur economic growth and help raise working Americans’ wages” by “ending chain migration, giving priority to the most highly skilled immigrants from around the world, and reducing overall immigration by half,” according to a fact sheet released by Cotton and Perdue.

“Only 1 out of every 15 U.S. immigrants come here because of their skills, and we do not prioritize the ultra high-skilled immigrants who spur innovation, create jobs, and make America more competitive,” the fact sheet contends. “At the same time, the United States accepts 1 million immigrants annually—the equivalent of adding the entire state of Montana each year—and most are low- or unskilled.

Over the next couple of years, the embedded mockingbird media perversely pinned the killings of civilians on Syria’s Bashar al-Assad. Only Russia’s UN veto spared Syria. Still, the sheikhs kept on fi-



nancing the “rebels”—and the U.S. pretended to fight them—until they grew into the ISIS terror army.

Today, in spite of Russian military intervention, ISIS and its backers are not giving up. Even Fox News is saying the U.S. coalition against ISIS is a myth. That was shown quite clearly when the Russian military hit more ISIS targets in a week than the U.S. and its allies did in two years. A generation-long influx of low-skilled immigrant labor has put downward pressure on the wages of working Americans, with recent immigrants' wages hardest hit."

The bill seeks to upend America's disastrous immigration policy by tackling these issues head-on.

The RAISE Act would establish a skills-based points system that prioritizes visa applicants based on a number of important factors, including their education, English-speaking ability, job offers, and overall economic prospects. It would also outright eliminate granting visa preference for the extended family members and relatives of immigrants already settled in the United States, and would eliminate the State Department's so-called "Diversity Visa Lottery," which the bill's authors argue is "plagued with fraud" and "advances no economic or humanitarian interest." Finally, the bill would limit the total number of refugees seeking permanent residency each year to 50,000.

"Immigrants coming here on skills-based visas will be better educated, more skilled, more fluent in English, have more working-age years ahead of them, and have a stronger entrepreneurial spirit," proponents of the bill contend. "They will have a greater shot at becoming successful Americans, which will work to the benefit of all Americans in the form of an expanded and more competitive economy."

The legislation has been praised by a number of conservative groups and leaders as well as a variety of immigration think tanks that favor more restrictions on immigration, such as the Center for Immigration Studies, NumbersUSA, and the Federation for American Immigration Reform, while Democrats, the radical left, and a variety of ethnic lobbying organizations such as the Anti-Defamation League (ADL) have hysterically condemned the proposed legislation.

"This proposed legislation is cruel, anti-family, and un-American," Jonathan Greenblatt, the CEO of the ADL, stated in response to the RAISE Act. "These are the types of policy markers that exacerbate immigrant bashing and nativist attitudes in this country. Diversity is our country's strength and immigration has made America great." Greenblatt and other opponents of the bill have pledged to "work hard against this cruel legislation."

A number of prominent Republicans have also voiced their suspicion and outright hostility toward the RAISE Act, complicating matters for the president. Passing the legislation will no doubt prove to be a challenge, as has virtually everything else Trump has attempted to accomplish. ★

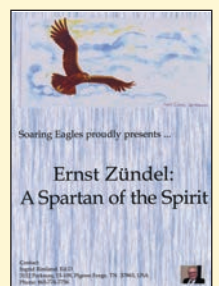
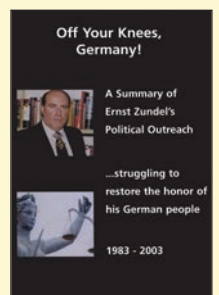
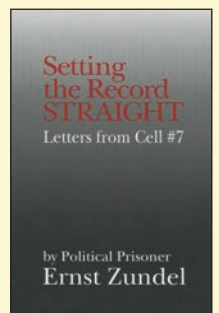

# Police Officer Blames BLM

forcement officers there, killing five officers and injuring seven others.

Long had traveled from Kansas City, Mo. to Baton Rouge roughly 10 days after the Dallas ambush with the direct intention of violently confronting officers there.

One of those injured officers in Baton Rouge is suing the Black Lives Matter movement and its most prominent leaders, accusing them of not only inciting violence against law enforcement officers across the country, but actually encouraging and justifying it.

The East Baton Rouge Parish deputy, who is not identified in the lawsuit, is a 42-year-old father of two children who had over 18 years of experience working in law enforcement. During the ambush, he was shot in his abdomen, his left shoulder, and the left side of his head, and as a result is permanently disabled. His intestines are permanently damaged, and he now has to wear a colostomy bag. The officer has had multiple surgeries, has suffered extensive brain damage, has reoccurring infections, and is constantly struggling for his life, according to the lawsuit.

The lawsuit charges Black Lives Matter and some of its most prominent spokespersons with inciting and encouraging the sort of violence that resulted in the ambushes in both Dallas and Baton Rouge. The violence committed against the officer, the lawsuit alleges, was “caused or contributed to” by the leaders of Black Lives Matter, a “militant anti-police national organization.” DeRay McKesson, Johnetta Elzie, Alicia Garza, Patrisse Cullors, and Opal Tometi are specifically named in the lawsuit as representing and leading the Black Lives Matter movement, who used their organization, social me-

dia platforms, and public media appearances to instigate and incite violence against police officers, the lawsuit contends.

“At least 11 police [officers] have been shot dead and at least nine more wounded by Black Lives Matter protesters, activists, and/or supporters,” the lawsuit argues. “The leaders of Black Lives Matter and defendants not only incited the violence against police in retaliation for the death of black men shot by police but also did nothing to dissuade the ongoing violence and injury to police. In fact, they justified the violence as necessary to the movement and war.”

The lawsuit outlines the history of the Black Lives Matter movement, names its leaders and their subversive, radical actions, and documents the violence, destruction, and mayhem caused since the movement’s inception. Black Lives Matter and its leaders must be held responsible for the officer’s injuries because they encouraged “disdain, hatred, and violence against police” at the various protests and demonstrations organized by Black Lives Matter across the country, as well as on social media and in media appearances, according to the lawsuit.

The lawsuit was filed by attorneys, including Don-

na Grodner, who previously filed a separate lawsuit against McKesson on behalf of yet another Baton Rouge police officer who sustained injuries during protests that took place in that city in the aftermath of Sterling’s death. Grodner was contacted by AMERICAN FREE PRESS but refused to comment on the case at this time.

The lawsuit is requesting \$75,000 in damages to be paid out to the injured officer and his family, which seems a pittance compared to the injuries he received, which will plague him for the rest of his life. ★

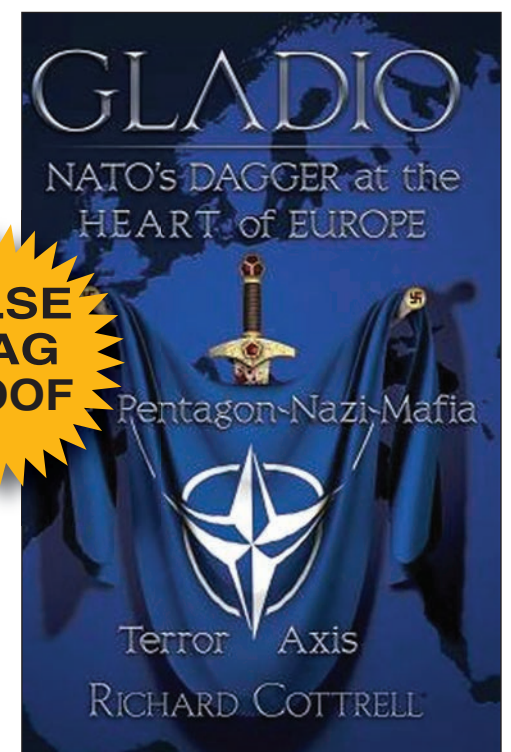

# Civil Asset Theft Has Become a Multibillion-Dollar Enterprise

- 24 states have passed laws against legalized police thievery

Attorney General Jeff Sessions recently ordered the Justice Department to increase the use of civil asset forfeiture, thus once again endorsing an unconstitutional, authoritarian, and increasingly unpopular policy.

Civil asset forfeiture, which should be called civil asset theft, is the practice of seizing property believed to be involved in a crime. The government keeps the property even if it never convicts, or even charges, the owner of the property.

Police can even use civil asset theft to steal from people whose property was used in criminal activity without the owner's knowledge. Some have even lost their homes because a renter or houseguest was dealing drugs on the premises behind the owners' backs.

Civil asset theft is a multibillion-dollar-a-year moneymaker for all levels of government. Police and prosecutors receive more than their "fair share" of the loot. According to a 2016 study by the Institute for Justice, 43 states allow police and prosecutors to keep at least half of the loot they get from civil asset theft.

Obviously, this gives police an incentive to aggressively use civil asset theft, even against those who are not even tangentially involved in a crime. For example, police in Tenaha, Texas literally engaged in highway robbery—seizing cash and other items from innocent motorists—while police in Detroit once seized every car in an art institute's parking lot. The official justification for that seizure was that the cars belonged to attendees at an event for which the institute had failed to get a liquor license.

The Tenaha police are not the only ones targeting those carrying large sums of cash. Anyone traveling with "too much" cash runs the risk of having

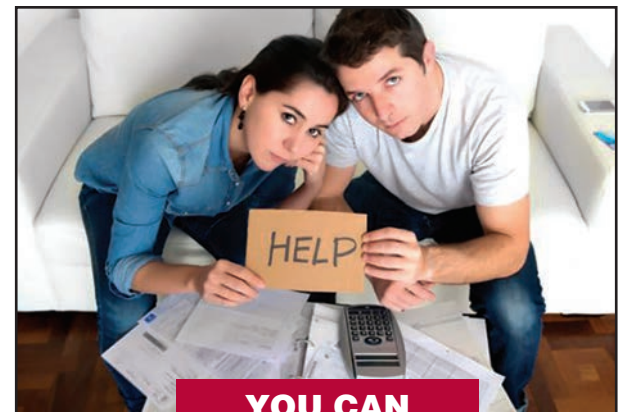
it stolen by a police officer, since carrying large amounts of cash is treated as evidence of involvement in criminal activity.

Civil asset theft also provides an easy way for the IRS to squeeze more money from the American taxpayer. As the growing federal debt increases the pressure to increase tax collections without raising tax rates, the IRS will likely ramp up its use of civil asset forfeiture.

Growing opposition to the legalized theft called civil asset forfeiture has led 24 states to pass laws limiting its use.

President Donald Trump could do the American people a favor by naming a new attorney general, who opposes police-state policies like the drug war and police-state tactics like civil asset theft. ★

• Court rulings seem to favor Amazon, Google in battle over Internet censorship

As readers and supporters of AMERICAN FREE PRESS and its sister publication THE BARNES REVIEW are well aware, books and videos considered to be verboten by the reigning tech giants have been removed for sale or distribution from these companies' bookstores and websites.

"In early March, to the shock and dismay of free speech advocates around the world, Internet retail giant Amazon caved to pressure from special interest groups and mainstream news outlets and quietly pulled at least 100 political and historical books from its website," wrote Paul Angel recently in AFP.

Prior to this mass book banning, YouTube, the video-sharing website created by three former PayPal employees in 2005 and bought by Google in 2006 for \$1.65 billion, has come down hard on videos on AFP's website, by sending a shot across our bow:

\*\*\*

"As you may know, our Community Guidelines describe which content we allow—and don't allow—on YouTube. Your video 'Jewish Groups Shut Down Canadian Newspaper' was flagged for review. Upon review, we've determined that it violates our guidelines. We've removed it from YouTube and assigned a Community Guidelines

strike, or temporary penalty, to your account.

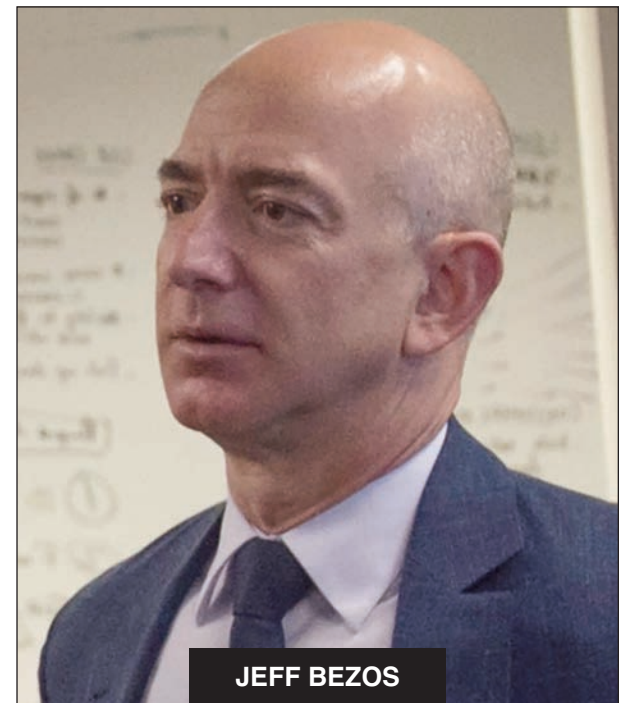
"We encourage free speech and defend everyone's right to express their points of view, even if unpopular. However, YouTube doesn't allow hate speech. Sometimes there's a fine line between what is and isn't considered hate speech. If you're not sure whether or not your content crosses the line, we ask that you don't post it.

"This is the first strike applied to your account. We understand that users seldom intend to violate our policies. That's why strikes don't last forever—this strike will expire in three months. However, it's important to remember that additional strikes could prevent you from posting content to YouTube or even lead to your account being terminated."

\*\*\*

The video cited, "Jewish Groups Shut Down Canadian Newspaper," was simply an audio interview this reporter conducted with Dr. James Sears, editor-in-chief of *Your Ward News*, a quarterly local newspaper distributed in Toronto, discussing the fact that Jewish groups had complained to Canadian politicians about Sears's newspaper. In response, Minister of Public Services and Procurement Canada Judy Foote ordered Canada Post to stop the distribution of the paper, which was called "anti-Semitic" and "racist" by its critics.

Naturally, Foote would not make such a move unless someone complained, and that someone, as is clearly documented, was Jewish groups. So there was nothing "hateful" about the interview. Sears was

just explaining what happened.

YouTube attacked some other videos as well, claiming they were not "advertiser friendly." This is quite odd, as the videos merely discussed a very hot topic: the 2012 Sandy Hook school shooting. These videos, which were merely audio interviews adapted to video format, can garner income, depending upon how many views or listens they accumulate. YouTube would have none of that with this video:

## NO RECOURSE

Do booksellers and content creators have any recourse if Amazon and YouTube remove content they deem to be “offensive”?

The short answer is “no,” as this newspaper discovered via an email exchange with one of the nation’s top Internet law professors.

Eric Goldman is a professor at Santa Clara University School of Law in California, where he teaches and publishes in the areas of Internet law, intellectual property, and advertising and marketing law.

This reporter became acquainted with Goldman via an article he wrote for *Forbes* entitled “Can YouTube ‘Remove and Relocate’ User Videos Capriciously?” The article makes reference to Section 230 of the Communications Decency Act, which is central to understanding why these tech giants can do as they wish.

The act was part of the Telecommunications Act of 1996, which amended or repealed sections of the Communications Act of 1934 and was the first major overhaul of U.S. telecommunications policy in nearly 62 years. It allows Internet service providers (ISPs) and other service providers to restrict customers’ actions without worrying about being found legally liable. Specifically, the act states: “No provider or user of an interactive computer service shall be treated as the publisher or speaker of any information provided by another information content provider.”

Section 230 had its beginnings in protecting children, and was passed in part in reaction to 1995’s *Stratton Oakmont, Inc. v. Prodigy Services Co.*, “which suggested that service providers who assumed an editorial role with regard to customer content, thus became publishers, and legally responsible for libel and other torts committed by customers.” Section 230 was passed to allow service providers to delete and monitor content without becoming publishers.

The court stated in another lawsuit, *Zeran v. America Online, Inc.*, (where the plaintiff, Kenneth M. Zeran’s phone number was posted on an Internet bulletin board that glorified the bombing of the Alfred P. Murrah Federal Building, which Zeran had no connection to or involvement with) that:

\*\*\*

“Congress enacted § 230 to remove the disincentives to self-regulation created by the *Stratton Oakmont* decision. Under that court’s holding, computer service providers who regulated the dissemination of offensive material on their services

risked subjecting themselves to liability, because such regulation cast the service provider in the role of a publisher.

“Fearing that the specter of liability would therefore deter service providers from blocking and screening offensive material, Congress enacted § 230’s broad immunity ‘to remove disincentives for the development and utilization of blocking and filtering technologies that empower parents to restrict their children’s access to objectionable or inappropriate online material,’ and ‘the amount of information communicated via interactive computer services is . . . staggering.’ The specter of tort liability in an area of such prolific speech would have an obviously chilling effect. It would be impossible for service providers to screen each of their millions of postings for possible problems.

“Faced with potential liability for each message republished by their services, interactive computer service providers might choose to severely restrict the number and type of messages posted. Congress considered the weight of the speech interests implicated and chose to immunize service providers to avoid any such restrictive effect.”

\*\*\*

AFP asked Goldman about the significance of Section 230. “Section 230(c)(2) is directly relevant by providing websites with a safe harbor for removing content they consider objectionable,” he explained. “The website’s terms of service are also highly relevant, such as where the sites say they can terminate accounts or delete content at their discretion.”

Since Section 230 allows these companies to censor any material they wish, AFP asked if it is foolish for someone “to piggyback on the audience aggregated by third party intermediary publishers,” like YouTube, since “the cloud service provider’s

policies and practices can easily moot those investments with little recourse, judicial or otherwise.”

“I don’t think it’s foolish at all,” Goldman said. “Usually, content producers must rely on third party intermediaries for ‘distribution,’ i.e., to reach a broader audience. However, if the distributor has the contractual and legal right to pull the rug out from under the content producer at any time, then the content producer either needs to accept that contingency or bargain for a better deal.”

AFP asked what would be an example of “the contractual and legal right to pull the rug out from under the content producer at any time.”

“A clause like, ‘We can terminate your account or delete your content at any time in our sole discretion,’” he explained.

It’s worth emphasizing that Goldman inexplicably disagrees with the argument that Amazon and Google, which operate as virtual monopolies when it comes to book sales and advertising on the Internet, should not censor media companies, given that even Eric Schmidt, the chairman of Google’s parent company, Alphabet Inc., conceded to *Business Insider* recently, “[Google] was founded under the principles of freedom of expression, diversity, inclusiveness and science-based thinking.”

AFP finally asked Goldman about Amazon’s book banning binge and if Section 230 allows Amazon to get away with this.

“Probably, but we may not need to get that far,” he said. “Retailers are not required to put any particular item on their shelves.” ★

# Are You a Thought Terrorist?

• Top lawyer for Google says alternative opinions constitute “terrorism”

**A**MERICAN FREE PRESS readers are well aware of the rapidly increasing efforts by the New World Order (NWO) to exterminate free speech for all who might disagree with their worldview. That juggernaut made a radical move forward on Aug. 1, when Google-owned YouTube announced several steps it is taking to eliminate “violent extremism and terrorism-related content” from its Internet video platform. First, Google, YouTube, Facebook, and a host of other Internet monopolies are longtime, entrenched “partners” with the Deep State—the corrupt international “intelligence community,” which spends

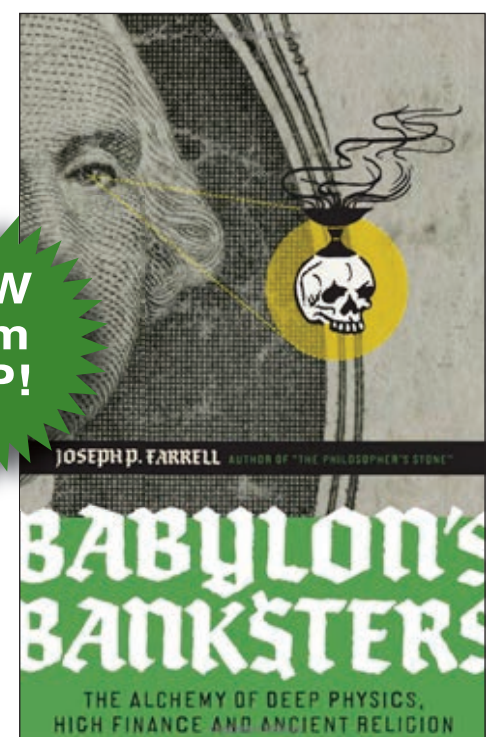
In YouTube’s realm—and wherever the shadow controllers of society lurk—“extremism” and “hate” mean the same thing as they do for the likes

of the Anti-Defamation League (ADL) and the Southern Poverty Law Center. Those who oppose the normalization of sexual perversions of the vilest sort, emotional illnesses like “transgenderism,” racial replacement of Caucasians—i.e., white genocide—or the inexorable march of Zionist supremacists toward world control will all find themselves lumped into the “hate” category and censored by YouTube, based on no published standards of judgment and without means of appeal to an unbiased, independent tribunal.

YouTube is increasing its automated censorship of videos, to make it faster and more “accurate.” An algorithm can now ban a video. Worse, continues YouTube’s blog: “We’ll soon be applying tougher treatment to videos that aren’t illegal but have been flagged by users as potential violations of our policies on hate speech and violent extremism. camp. Imagine seekers of traditional Catholic moral teachings being redirected to a video promoting sodomy for children. One such video has been viewed 11.8 million times on YouTube and has not been banned.

YouTube will continue to use human “experts” to censor content, too. Over 200 individuals, organizations, and NGOs have been made “Trusted Flaggers,” including the Council of Europe’s No Hate Speech Movement and the UK Metropolitan Police Counter-Terrorism Internet Referral Unit.

That elitist group now also adds the ADL, an unregistered foreign agent for Israel, which demands practically unlimited “immigration” and miscegenation in white countries—equivalent to white genocide—but defends Israel’s Jewish supremacism

and racial purity laws more stringent than those of 1930s Germany. The ADL also promotes sodomy and transgenderism in America and the West.

# Alt-Right Movement Continues to Grow

• American Renaissance conference in Tennessee draws 300 enthusiastic attendees

**N**ASHVILLE, Tenn.—On July 28, hundreds of concerned Americans and members of the alternative right converged on the Montgomery Bell State Park in Nashville, Tenn. to network, share ideas, and discuss the current direction and future of our nation. The weekend-spanning meeting of minds marked the 12th annual national conference sponsored and hosted by one of the right's premier think tanks, American Renaissance, and featured a roster of speakers of both long-established and recently gained renown.

The idyllic and somewhat secluded venue of the state park provided a fitting backdrop for the no-nonsense tone of the event, in poetic contrast to the raging controversies addressed by the numerous luminaries speaking out and which pervaded the countless animated discussions between and after their speeches by attendees.

AFP sat down with Jared Taylor, founder of the think tank and chief editor of its website, to discuss the event's relevance and impetus.

"It's a great opportunity for whites to get together and discuss their interests," Taylor stated.

Antifa, the loose-knit group of leftist anti-fascists, has in the past taken no small amount of interest in this annual confab, and succeeded in causing the cancellation of two prior events—a contingency that members of the right have had to plan for with growing frequency since the election of President Donald Trump. In the most dramatic example of this, a Hilton Hotel venue at which an American Renaissance conference had been scheduled can-

celed the group's event in response to receiving bomb threats from individuals claiming affiliation with the militant, far-left organization.

Taylor and his staffers quickly adapted to such methodologies of the opposition in subsequent years by moving the venue to the Montgomery Bell State Park, since Antifa's customary terrorist tactics are practically impossible to implement on government property as opposed to private property. Though park staffers had posted signs prominently outside emphasizing that the state does not endorse the conference and merely affirms the First Amendment rights of the group and the attendees, the organization has maintained a relationship of mutual respect with the park evidenced by this fifth successful conference since first moving to that location in 2012.

Taylor informed AFP that this year's event was marked by a record high turnout. Three hundred people were present, allowing for standing room only. He expressed regret that in order to abide by state fire codes, about 150 others had to be turned away from the event, meaning that had the facili-

ty been large enough to accommodate such a crowd, attendees would have numbered nearly 500.

Early in the day, members of Antifa gathered outside the conference center in protest. Suit-and-tie-clad attendees of the conference quietly looked on as an opposing crowd of 60 or more bull-horned the building, waved flags, and held signs with slogans such as "No hate in our state." Many of them wore masks and were heavily tattooed, while others in their ranks were in women's clothes. It is difficult to ascertain the ratio of men to women from the androgynous appearance of many in their ranks, which rendered them wholly devoid of any distinctive aspects in their comportment. Nearly a dozen park rangers patrolled the premises but declined to comment on the spectacle when asked by this reporter.

During the event, attendees were strongly discouraged from engaging the protesters on any level. "They could not be a worse advertisement for their point of view if we paid them to," said Taylor. "They could not be exposing their true nature in more flamboyant a fashion. They are doing more to drive concerned white Americans into our arms than 25 years of work by American Renaissance."

## SPEAKER LINE-UP

The line-up of speakers was impressive by any standard, to say the least.

Helmuth Nyborg led off the event with a talk on environmental factors and their relationship to the development of high civilization.

John Derbyshire followed up with a comparative analysis of race realism and race denialism—past, present, and future.

Martin Lichtmesz, a leader of growing notoriety in Germany, spoke on the rise of new nationalist

movements in both that country and in Austria.

Jared Taylor gave an optimistic yet introspective speech called “Has the White Man Turned the Corner?”

That was followed by a sobering talk on the immigration debacle faced by Europeans, which this paper has covered throughout the years, by Serge Trifkovic, entitled “Islam and the Third Invasion of Europe.”

Peter Brimelow, editor of the immigration webzine “VDare,” spoke on how those concerned with the immigration issue could grade Trump’s performance thus far.

As evening began, attendees were treated to a banquet during which young, up-and-coming author Julian Langness spoke on the dramatic increase in right-wing Millennials and the inspiring portent for the West of that development.

The energy and enthusiasm of all gathered was palpable, as an audience that could readily be observed to be hanging on every word of the speakers never missed a single one of the well-timed witticisms or punchlines that punctuated their discourses and provided refreshing bursts of levity to the otherwise very sobering realities being articulated.

The audience clearly regarded the speakers as both engaging and compelling. Question-and-answer sessions held after each speech in which dozens of audience members would participate in every instance added many layers of depth to the addresses given, as each speaker deftly fielded the numerous thoughtful questions directed at them.

The final day of the event featured “reports from the field” from numerous prominent activists, including Daniel Friberg, president of the right-wing publishing house Arktos, Nathan Damigo, founder of Identity Europa, and Richard Spencer, founder of the National Policy Institute and the “Radix Journal” webzine. The reports offered attendees a brief rundown on current focal points of their endeavors and their most recent projects. Simon Roche, a leader of a South African organization, the Suidlanders, which is raising funds to help them prepare for the civil war to be waged against whites ominously promised by African leaders like Julius Malema, delivered an impassioned speech on the need of Westerners to take full advantage of

the freedom of speech the West still enjoys. He stated the worst fears of many racial realists about deteriorating race relations in the U.S. and Europe are already a reality in South Africa.

The closing benediction was spoken by Sam Dickson, who has been a fixture of every American Renaissance conference going back to the very beginning and has never failed in his decades of activism to impart a small portion of his fatherly wisdom to those in attendance, in a manner as effortlessly amusing as it is piercingly insightful. His speech, which was entitled “Through a Glass Darkly,” admonished all present with the timely reminder that for all the excellent reasons for hope and optimism we have, the future is, as it always has been, an unknown quantity—and that the importance of remaining as vigilant in our greatest moments of triumph as we are in the face of our most horrific adversity cannot be overstated.

Even a casual observer could conclude from this event that this conference is evidence that the regressive left is experiencing blowback on a grand scale for their unabashed anti-white agenda. A poll taken during the conference revealed that, of the 300 in attendance, over half were both first-time attendees and under the age of 35. This is certainly indicative of the fast-growing counterculture spoken of by Langness that is “characterized by a youthful contingent of traditionalists of unprecedented proportions.”

Taylor himself echoed this sentiment when he told AFP, “I believe this to be typical of the type of growth our movement is experiencing.”

Perhaps agreement and solidarity with the stand American Renaissance has been taking since its founding is indeed more pronounced and outspoken than ever. Few statements made by the speakers were met with such exuberant applause from an already highly energetic crowd as Taylor’s assertion that, “Only we can be us. We have a right to be us, and our ancestors built this country for us—not for strangers. . . . We don’t have certainty of victory. We have a fighting chance. But I believe that fighting chance to be greater than ever, and that the growing movement represented at this conference is a testament to that.” ★

# Monsanto Caught Red Handed

• Internal emails reveal that company knew popular herbicide was carcinogenic

**T**he evidence against Monsanto's Roundup and other herbicides containing glyphosate may not get any clearer, even to the thickest-headed believers of Roundup's safety.

As reported by this writer earlier this year in AMERICAN FREE PRESS, Monsanto is being sued by individuals in federal court in San Francisco, on the basis that its herbicide Roundup brought on non-Hodgkins lymphoma in individuals.

Documents released by one of Monsanto's law firms cast a dark shadow on the company's knowledge of the danger of Roundup and its main ingredient, glyphosate. Monsanto claims that the documents were released against attorney-client confidentiality. The law firm countered that Monsanto did not properly protect the documents in question.

The documents have now been made public, irrespective of the quibbling of lawyers.

Monsanto fought releasing these and many other documents, but now that they're out, Scott Partridge, vice president of global strategy for Monsanto, argues that they include "some cherry-picked things that can be made to look bad," which don't affect "the substance and science," reported *The New York Times* on Aug. 1.

One can judge the seriousness of Partridge's assurances of safety versus the mother lode of admission made in following emails.

The *Times* notes a Monsanto scientist wrote in

a 2001 email, "If somebody came to me and said they wanted to test Roundup I know how I would react—with serious concern."

The story also quotes a 2002 email in which a Monsanto executive wrote, "What I've been hearing from you is that this continues to be the case with these studies—Glyphosate is O.K. but the formulated product (and thus the surfactant) does the damage."

This 2002 snippet corroborates this writer's Dec. 9, 2016 AMERICAN FREE PRESS story that quoted Dr. Robin Mesnage, a cancer expert with the Department of Medical and Molecular Genetics at King College in London, who provided evidence for the statement that adjuvants make glyphosate 1,000 times more toxic than glyphosate alone.

Also, in the Sept. 18, 2015 issue of AMERICAN FREE PRESS the fact that adjuvants make glyphosate worse was explained by this writer, quoting professor Robert Belle who stated "it would be necessary to look more closely at the numerous additives that go into [Roundup] and their interaction," in light of the fact that glyphosate, not Roundup, was registered in Europe. Roundup, again, includes adjuvants that make glyphosate more dangerous.

Another gem of a snippet, written by a different Monsanto executive in a 2003 email, is included in the *Times's* Aug. 1 story: "You cannot say that Roundup is not a carcinogen . . . we have not done the necessary testing on the formulation to make that statement." Yet the same executive added, "we can make that statement about glyphosate and can infer that there is no reason to believe that Roundup would cause cancer."

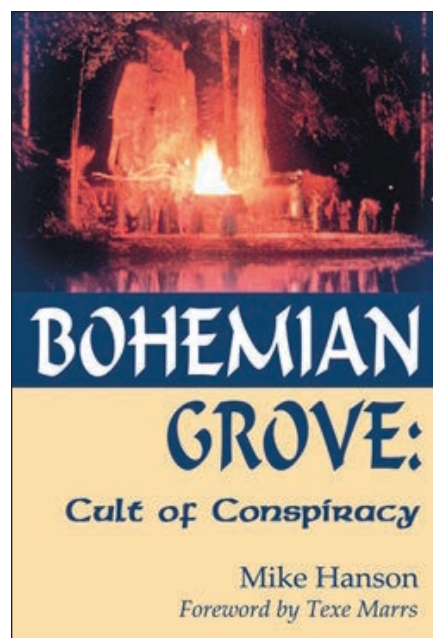

cancer flies in the face of data released as early as 1981 suggesting that glyphosate does cause cancer, according to information leaked by the Environmental Protection Agency.

Is there enough evidence to initiate a criminal investigation in light of these emails?

Mike Papantonio, a noted American trial lawyer, author, and host of “America’s Lawyer” on RT, believes so, saying the Department of Justice has these facts and can issue subpoenas and indictments.

“But you watch,” Papantonio told Thomm Hartmann on RT’s “The Big Picture” on Aug. 4. “They won’t do it,” suggesting that corporations of Monsanto’s stature will at worst get a “slap on the wrist” via fines.

Both the Republican and Democratic parties have evidently been completely bought by Monsanto and other substantial corporations that, not so ironically, are closely tied to the six corporations that run the media.

The alternative media has reported extensively on the vast dangers of glyphosate, particularly how it disrupts gut-bacteria and how its introduction and proliferation correlates to numerous disease states, such as autism and many other conditions, as reported by Dr. Stephanie Seneff and Anthony Samsel.

# America's Broken Promises

• In the case of nuclear deal, Iran is keeping its word and the United States isn't

The U.S. government's promises aren't worth the paper they're printed on. Case in point: the Iran nuclear deal. Iran is holding up its end. The U.S. isn't. Instead, Uncle Sam is switching his rationale for sanctions from "nuclear technology" to "rocket science and support for Hezbollah." Rather than ending the sanctions as solemnly promised in return for Iran's rolling back its nuclear program, the U.S. is maintaining them.

The nuclear deal says nothing about rockets or Hezbollah. Iran has every right to develop its space program and support the Palestinian resistance. Nothing in the nuclear treaty says otherwise.

Bottom line: Iran is keeping its word. The United States isn't.

Such arrogant lying, deceit, and subterfuge is typical of the way the U.S. does business. The only nation on Earth that's worse is America's master, Israel, which owns Congress and is the real force behind America's otherwise nonexistent "problem" with Iran.

Failure to keep one's word is not a good long-term success strategy. Whatever short-term gains accrue from lying and promise-breaking will be erased in the medium and long terms, as word gets around that "this is not a good person to deal with."

Why would any country trust the United States?

Consider just a few examples from the long list of American betrayals and broken promises:

- Endless promises to Native Americans enshrined in solemn treaties that were torn up whenever it was convenient.

- The promise to Gorbachev that if he ended the Cold War and pulled out of Eastern Europe, NATO

would not move into any of the former Russian East Bloc satellites.

- The promise to Libyan leader Muammar Qaddafi that if he handed over his weapons of mass destruction program the U.S. would normalize relations and consider him a "good guy" instead of a "bad guy."

When the United States breaks its word, it loses credibility with the rest of the world and its own citizens.

In all of these cases and many more, America broke its promises. What did the Indians get for laying down their arrows? They got shafted. What did the Russians get for freeing the East Bloc? They were surrounded by NATO first-strike nuclear systems. What did Qaddafi get for handing over his nuclear and chemical programs to the U.S.? He got sodomized to death by an American-sponsored al Qaeda foot soldier.

No wonder North Korea says, "Forget about the United States. We're going to build nuclear weapons capable of incinerating Washington, D.C. or die in the attempt."

North Koreans remember how the U.S. exterminated millions of their people and destroyed every single one of their cities, all without batting an eyelash or feeling an ounce of pity for the victims. The U.S. even blanketed North Korea with biological weapons, as Dave Chaddock explains in *This Must Be the Place: How the U.S. Waged Germ Warfare in the Korean War and Denied It Ever Since*.

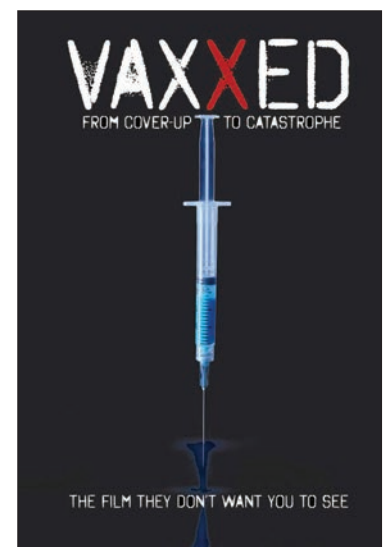

implicit promises to its own citizens. For example, the Bill of Rights is a solemn promise to respect freedom of speech, religion, *habeas corpus*, no searches without a warrant, and more. Yet the government singles out some religious groups, such as Muslims and Christian patriots, for persecution, while giving others special privileges. It imprisons people for their political views and unconstitutionally spies on everyone on Earth, while routinely kidnapping, torturing, and murdering people without even charging them with any crime.

Neoconservative Zionists like Michael Ledeen routinely quote Machiavelli's dictum, "It is better to be feared than loved." But a prince who tyrannizes others while routinely breaking promises, in his lame attempts to incite fear, may end up eliciting disgust, disdain, contempt, and desire for vengeance from his subjects.

There have been times when America's word meant something.

For much of our history, the Bill of Rights has been taken seriously. George Washington's promise that America would not meddle in foreign quarrels commanded almost unanimous respect until the banker-driven world wars of the 20th century. JFK's 1962 promise to the Russians to pull U.S. Jupiter nuclear missiles out of Turkey in return for the Russians pulling theirs out of Cuba, was respected, saving the world from nuclear holocaust. And the U.S. dollar was "good as gold" until Nixon broke that promise in 1973.

But in recent decades, especially since 9/11, the U.S. has become a mendocracy—a government of lies. It's as if the Israeli Mossad motto, "By way of deception thou shalt do war," has become the new American national slogan. The Israeli coup d'état on Sept. 11, 2001, may be partly responsible for this trend.

Was President Donald Trump's promise to "make America great again" sincere? If so, Trump should expose and roll back the 9/11 coup . . . and start speaking truth, honoring commitments, and restoring America's squandered credibility. ★

# Iran Back in Zionists' Crosshairs

• Pro-Israel Washington politicians, lobbyists still pushing for war on Persia

So why is more pressure being put on Iran at this time by the Trump administration? The answer is twofold. First, President Donald Trump, his son-in-law Jared Kushner, and a Congress heavily influenced by pro-Israel lobbying groups like the American Israel Public Affairs Committee (AIPAC) and the Foundation for the Defense of Democracies are doing the bidding of Israel's Prime Minister Benjamin Netanyahu and Mohammed bin Salman, the Saudi leader who is charged with directing the kingdom's military adventures.

Bin Salman has been described by German intelligence as an impulsive personality, which is shorthand in the intel world for saying he is dangerous. He has established close ties to Trump and Kushner and has had secret meetings with Ne-

tanyahu. Like Netanyahu, he would like nothing more than to draw the U.S. into a war with Iran. He has financed ISIS and other militias in Syria and has run the war in Yemen that has slaughtered thousands of innocent people.

The second and more obvious reason Washington is putting more pressure on Iran is because anti-Iran neocons have been plotting regime change in Iran for decades. The hatred of Iran is so deep it has transformed Congress.

Consider this: Iran has been subjected to terror attacks by groups financed and trained by Washington, Tel Aviv, and Riyadh. The terrorist groups include Jundullah, which has links to Pakistan intelligence, and the Mujahideen-e Khalq.

President Barack Obama and Netanyahu plotted massive cybersecurity attacks against Iran's nuclear industry and backed the assassination of Iranian scientists. If any other modern Muslim nation that holds democratic elections was subjected to this kind of campaign of violence and military intimidation, politicians in Washington would be screaming from the rooftops. Instead, the White House has gotten into bed economically and politically with the Israelis, unhinged elements in Saudi Arabia, al Qaeda, ISIS, and the al-Nusra Front.

It has been said by many observers of the Washington scene that if a politician wants to appeal to the Israeli lobby groups it is important to first of all express outright hatred of Iran and the view that it is a threat to world peace. This drumbeat of anti-Iran opposition has been morally indefensible and is likely to lead to war in the Middle East. Presently, over 40 U.S. military bases and upwards of 15,000 U.S. military personnel, including mercenaries, surround Iran.

Trump has already shown that he backs this Iran strategy. In February, *The Wall Street Journal* revealed that the White House was in talks with Arab allies to form an anti-Iran alliance that would share intelligence about Iran, presumably with Israel. This has all taken place against a backdrop of an Iran that has, unlike Saudi Arabia, held elections and has shown no desire for conflict with the United States or with nuclear-armed Israel.

Nevertheless, the White House and its Arab and

Israeli allies have plans to isolate Iran, damage it economically, and, if push comes to shove, go to war against it.

Currently, the only thing standing in the way of all of this is Russia. The Kremlin had made it clear to Trump, as it did to his predecessor, that it will not stand idly by if Iran is attacked. Moscow not only regards Iran as an ally and has had good relations with the Muslim nation since the 1930s, but the Russians also do not want a war in their backyard. It is sometimes forgotten that Iran and Russia share the Caspian Sea and are only separated by Azerbaijan. Interestingly, Israel has been trying to build relations with Azerbaijan by selling it weapons.

This writer spoke to a Kremlin source about Russia's Iran policy. While he requested anonymity, he was nevertheless insistent that Moscow would not allow Iran to be attacked militarily.

"President Putin will not allow the map of the Middle East to be redrawn to suit an Israeli-Arab agenda," he said. "He is confident the world is aware that the hatred of Iran is deliberately manufactured to produce an outcome that would benefit corporate interests in the West and some political players in the Mideast."

A war with Iran would have devastating consequences across the region. That would not necessarily worry Israel, which has always thrived on a policy that chaos degrades the military potential of its neighbors. ★

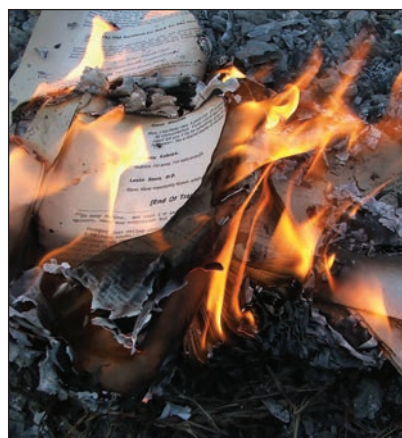

# Trump's Russia Policy Being Hijacked

• One of the reasons people voted for Trump was the chance of normalizing Russian relations

In crafting the platform in Cleveland on which Donald Trump would run, America Firsters inflicted a major defeat on the War Party. The platform committee rejected a plank to pull us deeper into Ukraine, by successfully opposing new U.S. arms transfers to Kiev.

Improved relations with Russia were what candidate Trump had promised, and what Americans would vote for in November. Yet, this week, *The Wall Street Journal* reports:

"The U.S. Pentagon and State Department have devised plans to supply Ukraine with antitank missiles and other weaponry and are seeking White House approval . . . as Kiev battles Russia-backed separatists. . . . Defense Secretary Mattis has endorsed the plan."

As pro-Russia rebels in East Ukraine have armored vehicles, Kiev wants U.S. tank-killing Javelin missiles, as well as anti-aircraft weapons. State and Defense want Trump to send the lethal weapons.

This is a formula for a renewed war, with far higher casualties in Ukraine than the 10,000 dead already suffered on both sides. And it is a war Vladimir Putin will not likely allow Kiev to win.

If Ukraine's army, bolstered by U.S. weaponry, re-engages in the east, it could face a Moscow-backed counterattack and be routed, and the Russian army could take permanent control of the Donbass. Indeed, if Trump approves this State-Defense escalation plan, we could be looking at a re-run of the Russia-Georgia war of August 2008.

Then, to recapture its lost province of South Ossetia, which had seceded in 1992, after Georgia seceded from Russia, Georgia invaded. Putin sent his army in, threw the Georgians out, and recognized South Ossetia, as John McCain impotently declaimed, "We are all Georgians now!" Wisely, George W. Bush ignored Sen. McCain and did nothing. But about this new arms deal questions arise.

As the rebels have no aircraft, whose planes are the U.S. anti-aircraft missiles to shoot down? And if the Russian army just over the border can enter and crush the Ukrainian army, why would we want to restart a civil war, the only certain result of which is more dead Ukrainians on both sides?

The *Journal's* answer: Our goal is to bleed Russia. "The point of lethal aid is to raise the price Mr. Putin pays for his imperialism until he withdraws or agrees to peace. . . . The Russians don't want dead soldiers arriving home before next year's presidential election."

Also going neocon is Mike Pence. In Georgia this week, noting that Russian tanks are still in South Ossetia, the vice president not only declared, "We stand with you," he told Georgians the U.S. stands by its 2008 commitment to bring them into NATO.

This would mean, under Article 5 of the NATO

treaty, that in a future Russia-Georgia clash the U.S. could find itself in a shooting war with Russia in the South Caucasus. Russia's security interests there seem clear. What are ours?

Along with Trump's signing of the new sanctions bill imposed by Congress, which strips him of his authority to lift those sanctions without Hill approval, these developments raise larger questions.

Is Trump losing control of Russia policy? Has he capitulated to the neocons? These are not academic questions. For consider the architect of the new arms package, Kurt Volker, the new U.S. special representative for Ukraine negotiations.

A former CIA agent, member of the National Security Council, and envoy to NATO, Volker believes Russian troops in Transnistria, Abkhazia, South Ossetia, Crimea, Donetsk, and Luhansk are all there illegally—and U.S. policy should be to push them out. A former staffer of Sen. McCain, Volker was, until July, executive director of the neocon McCain

Institute. He has called for the imposition of personal sanctions on Putin and his family and European travel restrictions on the Russian president.

In the *Journal* this week, "officials" described his strategy: "Volker believes . . . that a change in Ukraine can be brought only by raising the costs for Moscow for continued intervention in Ukraine. In public comments, he has played down the notion that supplying weapons to Ukraine would escalate the conflict with Russia."

In short, Volker believes giving antitank and anti-aircraft missiles to Ukraine will bring Putin to the negotiating table, as he fears the prospect of dead Russian soldiers coming home in caskets before his 2018 election.

As for concerns that Putin might send his army into Ukraine, such worries are unwarranted.

Volker envisions a deepening U.S. involvement in a Ukrainian civil war that can bleed and break Russia's Ukrainian allies and convince Putin to back down and accept what we regard as a just settlement. Does Trump believe this? Does Trump believe that confronting Putin with rising casualties among his army and allies in Ukraine is the way to force the Russian president to back down and withdraw from Crimea, Luhansk, and Donetsk, as Nikita Khrushchev did from Cuba in 1962?

What if Putin refuses to back down, and chooses to confront? ★

# Famed Revisionist Dies in Germany

The world lost a true legend last weekend, as Ernst Zundel, the heroic German-born historian, activist, and artist known for his controversial publishing and intellectual activities challenging the officially sanctioned narrative explaining WWII and the “Holocaust,” passed away at his home in the Black Forest region of Germany at the age of 78.

According to Ingrid Zundel, the long-time wife of Ernst who lives in Tennessee and has closely collaborated with her husband over the years, the legendary and courageous activist died as a result of a heart attack. Ernst’s sister, Sigrid, found him unconscious and called an ambulance. He was pronounced dead shortly thereafter.

Zundel’s death comes just months after he was denied entry to the United States by the U.S. federal government in an attempt to rejoin his wife in Tennessee. As this newspaper reported at the time, the Department of Homeland Security rejected his visa application, deeming him “inadmissible” due to his publicly pronounced views of the official Holocaust narrative as well as his past persecution and imprisonment for “thought crimes” in both Canada and Germany.

Zundel, born on April 24, 1939, immigrated to and lived in Canada beginning in 1958, where he worked as a graphic artist and photographer. He began publishing leaflets and books challenging the alleged Holocaust narrative, gaining worldwide notoriety and opprobrium.

Zundel remained a leading figure in the revisionist



community his entire life, and his work and activism did perhaps more than any other single revisionist to inspire others to think critically about the “Holocaust” and WWII more generally.

Zundel and his wife produced a number of important documentaries over the years highlighting and exposing the trials and tribulations he experienced as a result of his publishing and intellectual activities challenging the official Holocaust narrative, in addition to publishing countless articles, pamphlets, and other literature critically investigating controversial aspects of WWII.

“Zundel was the face of the revisionist commu-

nity worldwide—he was the most identifiable member of the movement,” prominent revisionist, podcast host, and writer Carolyn Yeager explained to this reporter. “He was both incredibly intelligent and incredibly personable; he effortlessly presented a positive image of the harmless, friendly German. I think the Holocaust industry feared and hated him more than any other and punished him most severely, only to create an eternal martyr for our anti-Holocaust pantheon.”

A fierce champion of German culture and history, Zundel struggled to bring truth and sanity to the world, offering a scholarly and objective account of both WWII and the Holocaust, which resulted in his legal persecution first in Canada and then in both the United States and Germany.

Zundel was persecuted and jailed several times over the course of his life, including most recently in Germany after he was deported to his home country to face trial for “inciting racial hatred,” an Orwellian description for his “thought crimes” that challenged the officially sanctioned “Holocaust” narrative. He was released in 2010, but faced numerous legal and logistical challenges reuniting with his wife and family, which undoubtedly impacted his health and wellbeing.

Zundel leaves behind a tremendous legacy and will continue to inspire and invigorate critical thinkers and scholars searching for the truth.

“God bless and tremendous thanks to a true hero, Ernst Zundel. His work was complete,” Ms. Yeager stated. “His work was done, there was nothing left for him to do, so it was right and good that he should cast off his mortal coil and move into the greater freedom. I’m grateful for his amazing life that will now be even better appreciated.” ★

"These dogs act just like the Republicans in Congress," I said to myself. "When any old Democrat waves his hands and makes a noise at them they either run away or look for a handout."

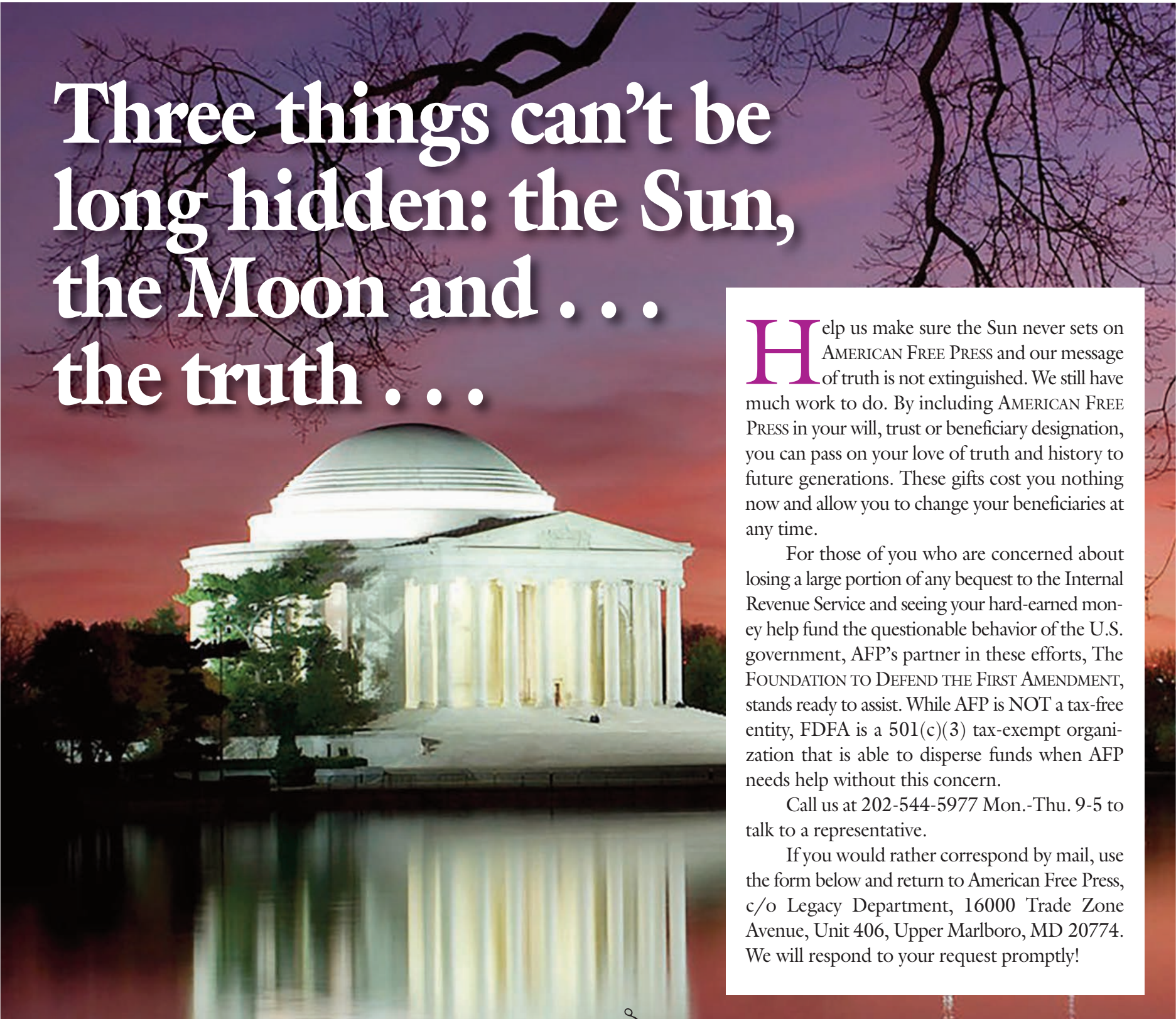
