BUILD THAT WALL

● PRESIDENT MOVING FORWARD WITH BORDER SECURITY PLANS

At a mid-September southern California press conference, U.S. Customs and Border Protection (CBP) Acting Deputy Commissioner Ron Vitiello announced that procedures are under way to design and construct a physical wall along the southern border—using suitable technology and materials to achieve complete border control.

The move is part of the Department of Homeland Security's plan to implement President Donald Trump's Executive Order 13767 of Jan. 25, 2017. That order requires border security and immigration-enforcement improvements, toward the ultimate goal of building a full-fledged border wall.

NBC affiliate KVOA Channel 4 in Tucson, Ariz. reported: "The Department of Homeland Security has issued [an order] to waive certain laws, regulations, and other legal requirements to ensure the expeditious construction of barriers in the vicinity of the international border near Calexico, Calif. The waiver was published in



the *Federal Register*." Calexico, near Baja California, is an area of particularly high illegal entries, hence the current focus on that area.

The U.S. border with Mexico, which is some 1,980 miles long, from the Pacific Ocean to the Gulf of Mexico, spans six Mexican states and four U.S. states: California, Arizona, New Mex-

ico, and Texas. It's the mostly frequently crossed international boundary in the world, with estimated legal crossings pegged at 350 million annually. It has 48 border-crossing points. While some 12 million people are estimated to be living in the United States illegally, that's about the same number of people living in all the counties and municipalities that hug the border from one end to the other.

There are eight companies now involved in the wall project. Notably, an Israeli firm is among them.

According to "Israel National News," "Elta North America, an Israeli-owned defense manufacturer with U.S. headquarters in Maryland, was one of four companies chosen to build a prototype for the border wall between the United

States and Mexico. The company is a subsidiary of Israel Aerospace Industries. Some 200 companies vied for the tenders, which will provide a \$300,000 to \$500,000 grant to develop a model. . . In total, eight companies are building prototypes for the nearly [2,000-mile-long] wall. Four will be concrete and four will have see-through or 'smart' walls. Elta was chosen to work on the see-through walls project. The final project could cost up to \$25 billion."

Having toured and photographed south-Texas points at Donna, Progreso, Pharr, and Mission, while also checking the border-fence status near Brownsville, this writer found the current fencing includes scattered incomplete sections, some of which are rusting. Several are surprisingly far removed from the actual border zone.

This odd configuration, of which many Americans are unaware, creates major gaps through which immigrants illegally enter the country. Installing new fence sections often requires court actions to secure easements so affected private property owners are compensated for construction. The process can be messy.

Yet, while these and other challenges cannot be denied, the Trump White House seems much more focused than its predecessors in wanting to complete a border wall in tandem with reworking the NAFTA trade scheme.

If this process were to help Mexico's economy, then the incentives for Mexicans to enter the United States in the first place would be reduced. ★

In addition, the writer went after AFP for selling a book by James



That would be a hugely expensive proposition, though—especially considering groups like the SPLC have the backing of trillion-dollar corporations like Wells Fargo, Chase, Google, Apple and brainwashed Hollywood stars like George Clooney.

In reality, the best way to get back at the self-appointed PC police is to be successful, and the only way to do that is to continue to grow our presence and effectiveness both in print and online. News You May Have Missed

VMI Stands Tall

In the aftermath of August's violent protests initiated by radical leftist groups in Charlottesville, leaders of Virginia Military Institute announced Sept. 12 that they will be standing their ground and will not take down any Confederate statues. In a statement to students, parents, and staff, administrators said they will not be going anywhere, but they will likely add "historical context" to the monuments. The school has cut other vestiges of the school's Confederate ties, however, such as battle flags, the playing of "Dixie," and cadet salutes to a statue of Confederate Gen. Stonewall Jackson.

Founding Fathers Targeted

Dallas Independent School District (DISD) has included schools named after three of America's founding fathers on a list of schools that the district is exploring renaming. The DISD has already recommended renaming four schools named after Confederate generals, including Robert E. Lee and Stonewall Jackson. The list of schools, according to DISD board member Dustin Marshall, includes schools named after Ben Franklin, Thomas Jefferson, and James Madison.

It Never Ends

The University of Virginia (UVA) recently had to remove a black shroud that protesters had used to cover up a statue of Thomas Jefferson during a demonstration on campus. Local news outlet, *The Daily Progress*, reported that a group of about 100 people, including students, faculty, and Charlottesville residents, gathered Sept. 12 to protest the university's response to white nationalist rallies in Charlottesville this summer. The group then covered the statue of Jefferson, the third president of the United States and UVA's founder, and put up signs that called him a "rapist" and "racist."

It Never Ends II

Harvard University plans to delete the reference to the Puritans from its alma mater because it is not "inclusive." The final verse of "Fair Har-

vard" goes: "Let no moss-covered error moor thee at its side/As the world on truth's current glides by/Be the herald of light and the bearer of love/Til the stock of the Puritans die." According to the school's Presidential Task Force on Inclusion and Belonging, the anthem suggests the commitment to truth is a special province of only the Puritans. They want the Puritans out, and to find a phrase that is universally accepted. Moreover, they would like to replace the dignified tune with various interpretations, including hip-hop and rap presentations of the alma mater.

Letting Non-Citizens Vote

The city council in College Park, Md. approved a measure that would allow city residents who are not U.S. citizens to vote in municipal elections. The vote has been rescinded and will be revisited at the next meeting, as city charter amendments require seven "yes" votes while this received only four. Ten other Maryland towns also allow any residents to vote in municipal elections.

Ryan Attacks Trump Wall

Speaker of the House Paul Ryan (R-Wisc.), no friend to President Donald Trump or millions of American people, has claimed recently that congressional support for a border wall between the U.S. and Mexico "is nonexistent" and "only one member" supports the White House in this endeavor. In truth, quite a few politicians wish to save the country from the illegal invasion. Says Rep. Tom Tancredo (R-Colo.): "Of course he means only one person in his entourage. . . . I know several people in Congress who want a wall."

Gang Members Are Offended

The Portland, Ore. Police Bureau will delete its gang-member database after community members complained it disproportionately affects minorities and harms those who have changed their ways. Mayor Ted Wheeler, the city's police commissioner, announced the database will be eliminated in October after Danielle Outlaw is appointed police chief. Since the gang-member list consists disproportionately of mi-



norities, the PC police complained that it is racist and harms young people by labeling them as "gang members." Critics of the move argued that the list had alerted officers and social workers when dealing with a known, possibly armed and dangerous, gang member, but now it is going away.

Enabling Hillary

Hillary Clinton recently published her memoirs, a long, whiny diatribe against everyone but herself for causing her to lose the presidential election. NewsBusters reports that Amazon.com, which carries customer reviews that rate books with one to five stars, decided to give Hillary a boost by simply deleting hundreds of one-star reviews of her tome, *What Happened*. None of the five-, four-, three- or two-star reviews were deleted, bringing the book's average rating up to a perfect five stars.

Free Weapons for Israel

Buried in the mammoth \$700 billion bipartisan military authorization bill that recently passed Congress is over \$700 million in gifts of armaments for Israel. The handouts were \$558 million more than President Donald Trump had requested.

U.S. Collusion With ISIS

Operatives working for the Iranian military say they have managed to infiltrate U.S. military command centers and obtain documents proving collusion between Washington and ISIS terrorists in the region, according to statements by a top Iranian mil-

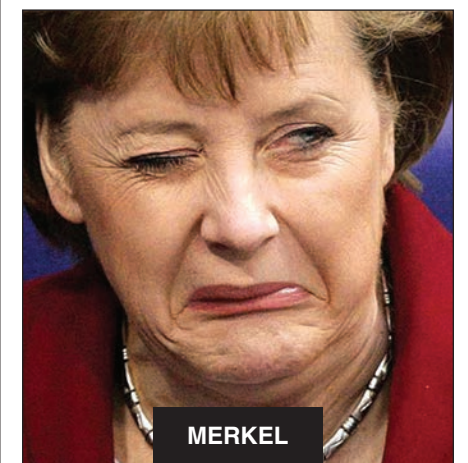
itary commander. The claim was made by IRGC Aerospace Force Commander Brig. Gen. Amir Ali Hajizadeh during a TV interview.

North Korea Willing to Talk

The mainstream media has so far failed to report on recent statements by North Korea's ambassador to the UN that the isolated country would be willing to negotiate with the West on their missile and nuclear program so long as they get an iron-clad assurance that they will not be attacked by Western powers.

North Korea Provocations

Former President Jimmy Carter recently blasted U.S. provocation against North Korea, saying, "The first thing I would do is treat the North Koreans with respect. . . . I know what the North Koreans want. What they want is a firm treaty guaranteeing North Korea that the U.S. will not attack them or hurt them in any way, unless they attack one of their neighbors." But the United States has refused to do that. Carter said he is willing to visit North Korea to negotiate.



Poles Stand Tall

Poland is fed up with German ruler Angela Merkel, who seems to think herself the self-appointed boss of the European Union (EU). Along with Hungary and the Czech Republic, Poland is voicing concern that the EU is a trap and a bully. Polish officials refuse to adopt open borders—and to top it off they are demanding about \$1 trillion they say is due Poland from Germany in reparations for WWII. Interestingly, they aren't demanding reparations from Russia.

Against All Odds, Trump Presses On

• Assailed by the left and right, president continues to unravel Obama's mischief

President Donald J. Trump, under attack from the entire country—except for his core group of supporters—and most of the world, is in the unenviable position of being the only nationally elected representative of the United States, with its interests at heart. Most people who voted for Trump trust the man and feel he is trying to do the right thing for the country, but it seems he is being hamstrung by all those who don't support the America-first president's mandate. History is clear: There has never been a U.S. president so universally opposed. Not only is “the honeymoon over” for Trump, he never had one—somewhat fitting for the first person in the White House's 227-year existence who lacked both political and military experience.

The apparent visceral hatred for the man and his pro-American policies reached a fever pitch last week when Congress unanimously passed a resolution forcing Trump to condemn the folks who showed up in Charlottesville with a permit to legally and peacefully protest the removal of a Robert E. Lee statue—until they were set up by the governor of Virginia and the mayor of Charlottesville and were attacked by leftist thugs known as Antifa. Congress forced Trump's hand by introducing the measure as a joint resolution, which requires the president's signature, rather than a concurrent resolution, which does not.

So one-sided and polarized has the elite presented the country as through its corrupt media that the president was demonized for suggesting that both sides bore some blame in Charlottesville, an incredible phenomenon by any means.

The joint resolution, put forth by both houses of Congress, begins with a lie. The Virginia State Police officers who died in the faulty helicopter had left the protest area some time before it crashed. They were not “victims” of the Charlottesville chaos. In addition, the measure classifies white nationalists as a hate group (it is not acceptable to be proud of one's white heritage), and ends with no mention of the leftist agitators (Antifa and Black Lives Matter, although almost all in the streets were white) who threw feces and urine at the peaceful protestors as well as attacked them physically.

S.J.Res.49 states in full:

A joint resolution condemning the violence and domestic terrorist attack that took place during events between Aug. 11 and Aug. 12, 2017, in Charlottesville, Va., recognizing the first responders who lost their lives while monitoring the events, offering deepest condolences to the families and friends of those individuals who were killed and deepest sympathies and support to those individuals who were injured by the violence, expressing support for the Charlottesville

community, rejecting white nationalists, white supremacists, the Ku Klux Klan, neo-Nazis, and other hate groups, and urging the president and the president's cabinet to use all available resources to address the threats posed by those groups.

Although forced to sign the ridiculous resolution, Trump struck a tone of defiance.

While speaking to reporters on Air Force One about his meeting with South Carolina Sen. Timothy Eugene Scott, the only black Republican in the Senate, Trump said: “We had a great talk yesterday. I think especially in light of the advent of Antifa . . . you have some pretty bad dudes on the other side also. Now, because of what's happened . . . since Charlottesville, a lot of people are saying—in fact, a lot of people have actually written—‘Gee, Trump might have a point.’”

Although the man is being constantly attacked from almost all sides, he has still made some remarkable progress, a testament to the billionaire's fortitude. No, he hasn't yet repealed Obamacare, reformed the country's tax code, repaired the failing infrastructure, or secured funding for a wall on the Mexican border, but he has successfully dismantled—in his first eight months in office—Barack Obama's “executive action legacy,” a feat not lost on America's first black president, who commented on the issue on social media.

As the late AFP reporter Victor Thorn wrote in August 2012, although executive orders (EOs) were “[o]nce used as a way to establish schedules for executive office employees or to help agencies under the White House carry out their duties,” they “are increasingly being used as a means to bypass the due process of proper legislation.”

Wrote Thorn:

President Barack Obama is following on the heels of previous presidents such as Bill Clinton and George W. Bush, whose disdain for constitutional checks and balance was often evident in the flurry of executive orders and presidential decision directives signed in an effort to get around Congress. Through these, Obama is . . . bypassing the legislative process and instead relying on making up the rules himself through various governmental agencies and hand-selected czars. And while Obama, who has issued 134 EOs, does not hold a candle to past presidents like FDR, who issued an incredible 3,522 EOs, or Woodrow Wilson, who signed 1,807 EOs, his use is pushing the bounds for which they were originally intended. By comparison, George Washington issued eight EOs, and Thomas Jefferson signed only four.

Trump's most recent target was DACA, the Deferred Action for Childhood Arrivals, which Obama implemented in 2012.

“President Obama bypassed Congress to give work permits, social security numbers, and federal benefits to approximately 800,000 illegal immigrants currently between the ages of 15 and 36,” said a Sept. 5 White House statement. “Only by the reliable enforcement of immigration law can we produce safe communities, a robust middle class, and economic fairness for all Americans.”

(Disappointingly, Trump seems to be backing off his initial tough stance against DACA.)

As the president promised while campaigning in Virginia in 2015, “We're going to be unsigning a lot of executive orders, especially [Obama's] order that basically lets anybody they want just pour into our country.”

In July, Trump took aim at Obama's decision that allowed transgender individuals to serve in the U.S. military. The president wants those unsure of their sex out of the U.S. armed forces by March.

That same month, Trump also announced America's withdrawal from the Paris Agreement, known also as the Paris climate accord or Paris climate agreement, “the environmental pact Obama joined through an executive order.”

A few days after taking office, Trump gave the go-ahead for the Keystone XL and Dakota Access oil pipelines, followed by his March executive order—symbolically announced at the headquarters of the Environmental Protection Agency—calling for a review of Obama's Clean Power Plan, “which would have closed hundreds of coal-fired power plants, frozen construction of new plants and replaced them with vast new wind and solar farms.” “C'mon, fellas,” said Trump to the coal miners present for the signing. “You know what this is? You know what this says? You're going back to work.”

It sure feels nice to have a president who cares about all Americans. ★

Who's Behind Canadian Smear Job?

• Alberta professor suspended after “anti-Semitic” posts were placed on his social media site

In late August 2016, an offensive, illegal image was planted—by a person or persons unknown—on Professor Anthony Hall’s Facebook page. The image portrayed a “white” man assaulting a “Jewish” man, alongside text reading: “There never was a ‘Holocaust,’ but there should have been, and, rest assured, there will be.” The rest of the text is too vile to print here.

The unsuspecting Hall, traveling at the time, never saw the post. But B’nai Brith did. B’nai Brith is the Canadian equivalent of America’s Anti-Defamation League. They were monitoring Hall’s Facebook page far more closely than Hall himself was. The Israeli front group issued a flurry of statements vilifying the professor and implying that he was responsible for the planted image. Canadian mainstream media outlets echoed B’nai Brith’s libelous charges.

B’nai Brith’s allies then unleashed a torrent of defamation against Hall. On Sept. 1, 2016 the president of the Canadian Jewish Civil Rights Association wrote to the University of Lethbridge, where Hall is a professor, falsely asserting that the horrendous words from the planted “kill all Jews” Facebook image came directly “from the lips” of Hall. Another letter to the president of the University of Lethbridge, copied to the premier of Alberta and the Alberta justice minister, called Hall an “advocate for the murder of Jews.”

University of Lethbridge President Mike Mahon suspended Hall without pay and prohibited him from setting foot on campus. There were no hearings, no due process, no investigation, just a unilateral assertion by Mahon, unsupported by any evidence, that Hall might have violated the Alberta Human Rights Act.

Mahon himself, purporting to speak for the university, later filed a Human Rights Complaint against Hall. Mahon argued that Hall might be guilty of a human rights violation because “Hall’s Facebook page had been used for virulent anti-Semitic comments.” Mahon failed to mention that the virulent comments had been planted, unbeknownst to Hall, most likely by Hall’s enemies.

Mahon also charged Hall with “inferring that Israelis, and hence Jewish individuals, were responsible for the terrorist attacks on the World Trade Center on Sept. 11, 2001.” But why is that any more bigoted than inferring that Saudis, and hence Muslims, were responsible for the terrorist attacks on the World Trade Center on Sept. 11, 2001, as the mainstream media does?

In fact, 34 million Muslims have been murdered, according to Dr. Gideon Polya, due to the 9/11-fueled Islamophobia that drives the 9/11 wars. Yet the Human Rights Complaint against Hall asserts

that anyone who rejects this genocidal Islamophobia, and the 9/11 official conspiracy theory behind it, is a bigot. The complaint insists that “acts of terrorism between 2001 to the present . . . were in fact committed and financed by Islamic terrorists.” By questioning that dubious proposition, the complainants assert, Hall somehow violated the Alberta Human Rights Act.

In fact, the individuals who called for the murder of all Jews were those who manufactured and planted the offending image on Hall’s Facebook page. According to an investigation by Ben Garrison, a Jewish-Zionist named Joshua Goldberg created the image. Unknown Internet hackers then planted it to frame Hall.

Goldberg and the hackers should be charged with incitement to murder and incitement to genocide. The hackers should also be charged with conspiracy to commit defamation of character, obstruction of justice, and providing of false evidence. Likewise, B’nai Brith and the Canadian Jewish Civil Rights Association should be charged with

defamation of character. All of these individuals and groups should wind up paying Hall tens of millions of dollars in civil damages on top of their prison sentences.

Unfortunately, it is far from certain that justice will prevail. Certain groups seem to have a license to commit frame-ups with impunity. After all, virtually every major “radical Muslim terror attack” since the first World Trade Center bombing in 1993 has featured one or more apparent frame-ups. In almost all cases, passports or ID cards have been planted at the scene of the crime to inculcate the designated Muslim patsies.

On 9/11, the only thing left of the planes that supposedly crashed in New York and Shanksville were “hijackers’ passports” that miraculously turned up to identify the supposed perpetrators. Subsequent “Islamic terror attacks” including the killing of writers and artists at the French magazine, *Charlie Hebdo*, the follow-up 11/13/15 Paris attacks, and various vehicular homicides in London, Manchester, and elsewhere have all featured throw-down ID documents allowing police to instantly blame the designated scapegoats.

The Tsarnaev brothers were also identified as being behind the Boston bombings, despite photo evidence that cast doubt on their guilt. A Pakistani couple was named as being behind a mass shooting in San Bernardino, Calif., despite witness reports that three large white men in paramilitary outfits did it.

Could the same forces that frame “Muslim terrorists” also be behind the frame-up of Hall? ★

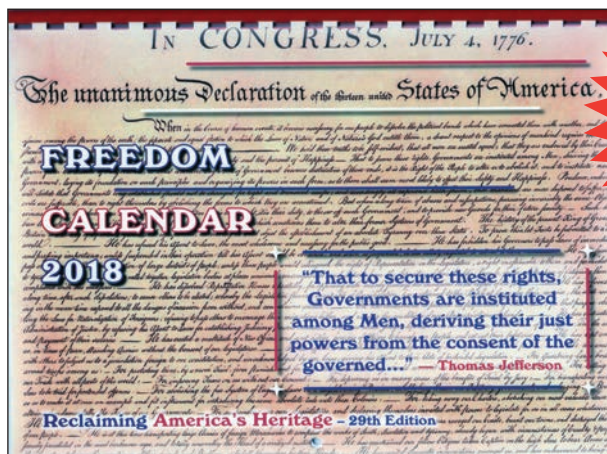

Christian Group Strikes Back Against SPLC ‘Hate Labeling’

- SPLC exec admits he wants to “destroy” good organizations

The Southern Poverty Law Center (SPLC), with some \$353 million in assets, is sinister and hazardous, damaging the reputations of organizations it decides to smear as “hate groups.”

The SPLC’s labels have been used by federal agencies as well as some private organizations to target individuals and groups in the U.S. One information service specializing in reporting on U.S. nonprofit companies, GuideStar, went so far as to post SPLC “hate group” labels alongside some organizations’ entries. It temporarily ceased that practice in response to an uproar on the part of conservative groups, but says it will continue to provide the information upon request.

Recently, a pair of civil lawsuits were filed by Christian ministries against the SPLC and GuideStar.

Liberty Counsel has sued GuideStar, and D. James Kennedy Ministries sued both GuideStar and the SPLC. In both cases, the plaintiffs seek a permanent injunction against the use of the SPLC’s “hate group” label and damages.

Liberty Counsel’s 31-page lawsuit against GuideStar cites the SPLC’s alleged examples of defamation and religious discrimination. Mark Potok, senior fellow at the SPLC, has made their job easy, often repeating the bogus claims multiple times, including on audio files on Internet Archives.

“We see this as a political struggle,” Potok states in an audio file transcription presented to the court. “We’re trying to wreck the groups, and we are very clear in our head, this is—we are trying to destroy them . . . as a political matter, to destroy them.”

He added: “Sometimes the press will describe

[SPLC] as monitoring hate groups and so on. I want to say plainly that our aim is to destroy these groups, to completely destroy them.”

GuideStar’s attorney, the high-priced Washington firm Hunton & Williams, has filed a motion to dismiss, claiming the organization correctly stated the SPLC labeled Liberty Counsel a hate group and no libel was committed. The attorneys also claim the word hate “describes subjective feelings and emotions. The word also admits a broad range of uses and meanings.”

Hunton & Williams lawyers further argue that the labeling on GuideStar’s compilation was not commercial speech.

Fortunately in this case, Liberty Counsel asked for a judge and not a jury. Both Liberty Counsel and the SPLC rely on the generosity of donors. If the Christian group can present supporters who stopped donating or decided not to donate after seeing the SPLC’s label on GuideStar, would that open a “viewpoint of a reasonable reader” question in this case? Liberty Counsel did not make such a claim

in its filing, but it would have been interesting.

On the issue of violence, it is the SPLC—not Liberty Counsel—that has been linked to violent attacks. Attempted mass murderer James Hodgkinson, the man who shot and critically wounded Rep. Steve Scalise (R-La.) and congressional staffers on June 15, had “followed” the SPLC on social media and wanted to murder pro-life and anti-abortion lawmakers, according to federal investigators.

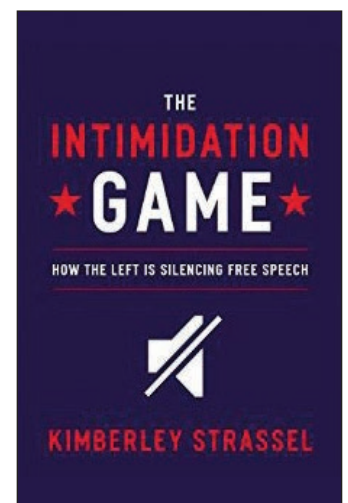
Five years prior to that, Floyd Corkins II attempted to commit mass murder in the Washington, D.C. office of Family Research Council (FRC), another Christian group designated as haters by the SPLC. Corkins said his motivation was based on the SPLC’s designation of FRC as a “hate group” and its “hate map” that provides the addresses of those organizations labeled as “hate groups.” ★

Congress Says White Groups Are Terrorists

• “Lawmakers” condemn peaceful protesters, remain silent about leftist violence

The Senate and House recently passed a joint resolution specifically condemning white nationalists and other so-called “hate groups”—including “neo-Nazis, the Ku Klux Klan and white supremacists”—and urged President Donald Trump to speak out against such groups and devote federal resources toward addressing the purported “threat” posed by them.

The resolution, S.J.Res. 49, was introduced by Sen. Mark Warner (D-Va.) with the support of Sens. Tim Kaine (D-Va.), Corey Gardner (R-Colo.) and others in the wake of the Unite the Right rally in Charlottesville, Va., a rally legally organized by leading members of the so-called alt-right that was sabotaged by a combination of state and local police, state of Virginia political officials, and a violent crowd of radical leftist counter-protesters.

The rally resulted in the death of Heather Heyer, a 32-year-old woman who was among the counter-protestors when she was struck by a vehicle driven into a crowd by a young man who was there to support the alt-right. The circumstances surrounding the car crash and Ms. Heyer’s death remain murky. Some allege that the driver of the vehicle, James Alex Fields Jr., was violently attacked in his vehicle by counter-protesters shortly before he drove into the crowd. Fields allegedly has had a troubled history, having been accused in the past of assaulting his own mother on two occasions, and was reportedly on medication to help manage his outbursts of anger.

The joint resolution, which was approved by the Senate on Sept. 11 and by the House on Sept. 12, condemns “the racist violence and domestic terrorist attack” that took place during the Unite the Right rally, while completely ignoring and dismissing the violence committed by counter-protesters that day. It also offers condolences and support to the Heyer family and families of the state police officers killed when their helicopter crashed as it left the Charlottesville area and specifically rejects “white nationalism, white supremacy, and neo-Nazism as hateful expressions of intolerance that are contradictory to the values that define the people of the United States.”

The resolution goes on to demand that President Donald Trump “speak out against hate groups that espouse racism, extremism, xenophobia, anti-Semitism and white supremacy” and to devote federal resources “to address the growing prevalence of those hate groups in the United States.”

Days after the resolution was adopted, Trump signed and endorsed it, saying he rejected bigotry in all its forms.

“No matter the color of our skin or our ethnic heritage, we all live under the same laws, we all salute

the same great flag, and we are all made by the same almighty God,” Trump declared in a statement following his endorsement of the resolution.

Shortly after signing the joint resolution, during a conference call with a number of prominent Jewish groups, Trump condemned those who spread anti-Semitism. “We forcefully condemn those who seek to incite anti-Semitism or to spread any form of slander and hate—and I will ensure we protect Jewish communities, and all communities, that face threats to their safety,” Trump stated during the call.

The president has come under fire for not denouncing the alt-right rally and its organizers quickly or forcefully enough. Never mind that the rally was legally organized and represented an entirely legitimate expression of the First Amendment. The highly distorted controlled media narrative immediately disseminated during and after the rally portrayed the alt-right rally attendees as unhinged, violent white supremacists, neo-Nazis and Klansmen who were determined to violently confront the leftist counter-protesters who mobilized across the city of Charlottesville in response to the rally.

In reality, the vast majority of the violence was initiated and instigated by the radical leftist counter-protesters themselves, who threw urine and feces not only at alt-right demonstrators but also at media and police officers.

In light of the joint resolution and Trump’s endorsement of it, many Americans are left wondering when a similar resolution will be adopted and endorsed that specifically denounces and rejects the radical left, which has for decades engaged in blatant acts of violence, intimidation and terrorism.

In recent years, various leftist groups—Black Lives Matter, Antifa, radical communists, anti-

capitalists and anarchists—have become increasingly bold and violent, particularly since Trump stepped onto the political scene. Black Lives Matter activists have burned down and looted entire neighborhoods, while Antifa and other radical leftists have attacked Trump supporters, damaged and destroyed private property, and otherwise engaged in violence and mayhem in a variety of cities across the United States.

Efforts are already under way to demand Trump declare Antifa a terrorist organization. So far, though, Trump and other federal officials have not made any decisive moves to condemn and reject the radical left, which truly does pose a threat to the safety and security of Americans. ★

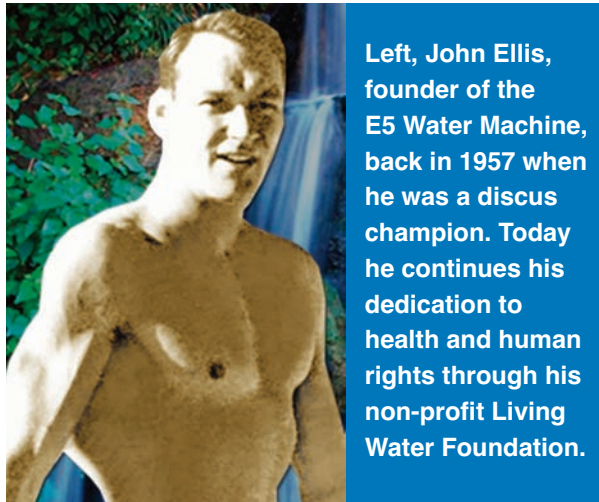

There are hundreds of letters and pictures, including one of the ambulances my grandmother donated (before we entered WWII), encouraged by her friend **CARRIE CHAPMAN CATT**, who moved around the corner from her in New Rochelle. As a youngster, I remember all the sewing machines and their many friends at my grandmother's house sewing thousands of pre-die cut clothes together to keep children warm during the brutally cold English winters.



Controversial Ideas Not Always Welcome

He described the incident in a letter: “Whatever the gun was charged with passed through about three or four inches below the window making a hole large enough [for] a finger to go through—the muzzle must have been very near as the place is black with powder, and the glass of the window is shattered to pieces.”

DAV Execs Not Changing Their Ways

• News that top dog at disabled veterans group makes \$600,000 has vets angry

When this reporter was summarily tossed out of the veterans' charity, the Disabled American Veterans (DAV), in February 2014 for shining a light on the ungodly sums the officers of that 501(c)(4) organization were paying themselves, it seemed beyond reason that their incomes could climb much higher. Last month, however, when the DAV's Internal Revenue Service Form 990 for 2016 was released on the organization's website, the quaint belief that somehow greed could be contained was shown the door.

In five short years, since this newspaper first analyzed DAV's 2011 Form 990, the "leader" of that organization saw his income more than double, from \$263,185 to \$527,292. Incredibly, a portion of his income, \$225,450—over 40%—was classified as "retirement and other deferred compensation," and is not taxed. In other words, while most Americans—especially disabled veterans—are living paycheck to paycheck, DAV's head is paid so much that almost half of that income can be set aside for retirement and is not needed today.

Other highly compensated individuals employed by the charity also saw huge hikes in their pay over

that same time period, though nowhere near what the top dog, Mississippi-born J. Marc Burgess, brought home.

His pay is even more striking given the fact that the charity didn't have such a great year: It brought in around \$2 million less than the year before and still managed to lose around \$12 million, that is, revenues less expenses. Never mind the fact that on any given night, there are tens of thousands of veterans who call the street their home.

The 1.3 million-member DAV, founded in 1920 to help disabled veterans of the U.S. armed forces—returning from World War I—and their families adapt to living with physical and mental disabilities, is chartered by Congress and headquartered in Cold Spring, Ky. Every state in the union has a DAV department, including Washington, D.C. and Puerto Rico, and each of those has chapters associated with it. Currently, there are approximately 1,300 chapters across the country. The primary function of the DAV has been to serve as a veteran's advocate for filing Veterans Administration (VA) disability claims.

AMERICAN FREE PRESS interviewed 75-year-old, 100% disabled American veteran Steven I. Marcus, a former member of the DAV, for his views on the 2016 Form 990.

"I have a lot of friends who are active members of the DAV," he began, "but on the local level, and they do good work in the local community with the veterans. But at the very top of the DAV, to me, they're all bloodsuckers; they're self-serving. They fly an airplane and they get guys like that actor, Danny Aiello, [who] goes on television. When I ran into Danny, because he doesn't live that far from me, I told him, 'You know, Danny, I love you as an actor, but somebody's giving you bad news, because the Disabled American Veterans is a rip-off.'"

Marcus touched on the ongoing scandalous tragedy of veterans dying on VA waiting lists for

healthcare while the DAV feeds at the gilded trough.

"These bloodsuckers take money; they fly a plane all over the country," he bemoaned. "What the hell does that do for the disabled American veterans when guys wait in line and die? I think 20 veterans a day die waiting in line at the VA."

Marcus commented upon the fact that so many veterans are homeless in this once-great nation, while organizations like the DAV never seem to tire of enriching themselves.

"It's totally disgraceful that we do this, really and truly," he said. "These are people, patriots, who served the country honorably. Remember, when we raised our right hand, we swore to uphold the Constitution, and if necessary we would give our life for our country. But at the same time we expected that if we got hurt we'd be taken care of. And they're not being taken care of. It's a disgrace."

Marcus directed his criticism at those who are at the top of the DAV.

"These people are self-serving; all they're interested in is money," Marcus continued. "If you [want to] help veterans, why don't you give back all your money, and give it to the veterans who need the help?"

AFP asked Mr. Marcus to reflect on the fact that Burgess's annual income has not only exceeded that of the president of the United States but should surpass the \$1 million mark in a few years.

"If I sound sarcastic, I am," he said. "If I sound bitter, I am. I don't even want to admit anymore that I belonged to the DAV at one time. As far as I'm concerned, the only thing disabled about them is their ability to take care of the people." ★

Closing of Consular Offices Won't Hinder 'Illegal Spies'

The forced closure of Russian consular facilities in San Francisco, New York, and Washington, D.C. that double as espionage bases like the diplomatic outposts of most major nations will have no effect on Moscow's intelligence war.

That war is heating up on many fronts as Russia begins a new era of intelligence recruitment and information gathering abroad, placing its faith in the GRU, known by its official name the Main Directorate of the General Staff of the Russian Armed Forces. In common parlance, it is Russia's military intelligence body. It has become the go-to organization for Russian leader Vladimir Putin even though his grounding was in the KGB, now called the Federal Security Service (FSB).

Even Russia's other major intelligence outfit the SVR has been made subservient to the GRU. The SVR is in reality the Cold War KGB, which was divided into two parts, resulting in the SVR assuming external spying, previously the purview of the KGB's First Chief Directorate, and internal security being passed to a new body, the FSB.

It was the SVR that ran the spy ring rounded up in the U.S. by the FBI in 2010 leading to tabloid stories about so-called deep-cover agents like Anna Chapman and her seduction techniques. The collapse of the spy ring, which did not appear to have been very successful, generated lots of hyped stories about beautiful spies.

The public became fascinated with celluloid offerings about Russian spies carrying out assassinations on U.S. soil, but missing in all the hype was the fact that Russian and U.S. intelligence services have had an unspoken agreement for decades never to target each other's agents or to run assassination programs on Russian or American soil.

That does not mean a new intelligence war is not under way, however. On the contrary, the Anna Chapman spy ring fiasco and the subsequent success of a covert intelligence campaign mount-

ed by Russia's GRU in Ukraine and Crimea convinced Putin that the GRU alone should have the prime intelligence role in handling what the Russians call the "near abroad" in Europe and Asia and all other global espionage operations.

But lest one imagine that the GRU is all about espionage, it is notable that it has at its disposal the best-trained elements of Russia's special forces, the Spetsnaz. It has used them to effect in Crimea and Ukraine to help local forces maintain order and control.

But it is in the espionage business that the GRU has begun to change tactics and strategies.

Instead of the tried and tested means of using agents under diplomatic cover in residence such as consulates and embassies across the globe, it has moved into a sustained recruitment of "illegals." In the past, the term referred to KGB agents taught to operate in the open in countries like the U.S., using well-crafted fake identities, or to remain in deep cover. While that will continue on a steeper curve than ever before, the focus will now be on recruiting foreigners visiting Russia and targeting European nationals who have the language skills and passports to move freely across international borders. Canada has been identified as ideal recruitment territory to acquire potential spies to operate in the U.S. The GRU made it clear to Putin that the use of "illegals" could be more effective than using spies under diplomatic cover in residences that would be under sustained sur-

veillance from Western internal security bodies like the FBI and British intelligence agency, MI5.

One of the classic arguments the GRU used to stress the need for a more sophisticated "illegals" program was that if Russia was to put its own trained agents into other countries to pose as nationals of those countries it could only do it effectively if it put more resources into that strategy.

In particular, the GRU stressed the growing threat on Russia's borders from Islamic extremism and the need to have spies it could insert into neighboring countries that are harboring or tolerating jihadists. It managed to do that in Syria where it placed spies in groups like al-Nusra and al Qaeda, achieving that goal through the training and recruitment of men and women from Islamic parts of the Caucasus. It also used its special forces to track and assassinate prominent Islamic fighters in both Syria and Iraq.

An intelligence source AFP consulted, who knows the Kremlin well, confirmed that the GRU was heavily invested in a new "illegals" program that would be more advanced than anything the SVR attempted between 2000 and 2010 or that the KGB had built during the Cold War.

The source said Russia's nervousness about the Islamic threat on its borders meant it would cement its alliance with Iran because the Iranians were already supplying the GRU with "illegal" agents capable of blending into Islamic communities in the Caucasus, which have supplied large number of fighters to radical groups like ISIS. ★

North Korea Nuke Threat Is Multifold

• Insider says electromagnetic pulse attacks could kill power grids, devastate U.S., allies

Nearly 25 years of minimizing and ignoring the nuclear threat from North Korea has left the United States with few options to deal with the escalating danger emanating from the East Asian dictatorship, most visibly illustrated by President Donald J. Trump's prepared remarks delivered to the United Nations General Assembly—his first address as president to that body—on Sept. 19.

"The United States has great strength and patience," Trump stated, "but if it is forced to defend itself or its allies, we will have no choice but to totally destroy North Korea."

Such bellicose language delivered to a global institution, whose stated goal is world peace, might seem entirely out-of-place, but when viewed against the failure of a string of U.S. presidents and their administrations to adequately confront North Korean threats, Trump's choice of words may be exactly what's needed to deal with the situation.

On the heels of recent successful satellite launches, North Korea has shocked the world by launching ICBMs and claiming to have detonated a hydrogen bomb on Sept. 2, a thermonuclear weapon with a yield (the amount of energy released) of over 50 kilotons of TNT, over three times more powerful than the atomic bomb dropped on Hiroshima. North Korea claimed its bomb had a yield of 100 kilotons.

Perhaps more alarming than a confrontation with the 2-million-strong Korean People's Army—the world's largest military—is the possibility that the North Korean regime may launch a nuclear-armed satellite for use in an electromagnetic pulse (EMP) attack on the United States. When detonated at a high enough altitude, the nuclear blast creates an electric shock wave—similar to lightning—that can potentially knock out the entire electric grid of North America, and all electronics. The July 9, 1962 high-altitude nuclear test conducted in outer space by the U.S. called Starfish Prime verified the existence and effects of man-made EMPs.

Significantly, North Korea's state news agency boldly stated that this weapon "is a multifunctional thermonuclear nuke with great destructive power which can be detonated even at high altitudes for super-powerful EMP attack."

In order to gain a fuller understanding of this matter, AMERICAN FREE PRESS conducted an exclusive interview with Dr. Peter Vincent Pry, the world's leading expert on EMPs, the executive director of the Congressional Advisory Board's Task Force on National and Homeland Security, and the chief of staff of the Commission to Assess the Threat to the United States from Electromagnetic Pulse Attack, or the Congressional EMP Commission. Pry is also a former

Central Intelligence Agency (CIA) officer and the author of numerous books on national security issues.*

Incredibly, even in the face of North Korea's September threat to launch an EMP attack against the U.S., D.C. has plans to let the EMP Commission's charter expire.

"Only in Washington," said Pry, "would it be possible to have something like this happen, where the EMP threat is looming larger than ever, and Pyongyang is actually threatening EMP attacks against us now, and Washington's response to this is to let the EMP Commission go out of business."

Pry explained why an EMP attack is so dangerous.

"If you took a Hiroshima-type bomb and detonated it in a city," he said, "it might kill 200,000 people, but that same weapon, let's say you used it to black out the Eastern grid, [which] supports most of our population and generates 75% of our electricity. The EMP Commission estimated that we would lose 90% of the population within a year from starvation, disease, and societal collapse. We can't survive as a civilization without the Eastern grid. There'd be no coming back from that. And North Korea only needs one weapon like this in order to destroy our whole society."

Pry explained how we arrived at this point.

"We knew in 1994 when [CIA Director] Jim Woolsey went and testified and told the Senate Armed Services Committee that North Korea had the bomb," Peter explained. "And that created this crisis, so Bill Clinton had to think about abandoning his whole agenda. And so for about six months it was actually contemplated by the Clinton administration about going to war to stop North Korea from getting the bomb."

Pry was on the professional staff at the time, and instead of war, the Clinton administration negotiated an agreed framework with North Korea.

"I was on the North Korea Advisory Group all through the eight years of the Clinton administration," he said, "and they were cheating on that agreed framework, and we knew it."

Pry tried to tell the press, but they weren't interested.

"It's almost like there's a whole cottage industry out there of non-expert people from academia," he said, "who seem to make their living lowballing the North Korean threat. . . . Clinton wanted to kick the North Korean threat down the road so he wouldn't get blamed for it, and that's what he did."

Pry explained that the North Korean nuclear threat has been kicked from the Clinton, Bush, and Obama administrations right to Trump, whose administration is doing the same.

"The reason they're doing it under the Trump administration," Pry explained, "[is that] Trump has not cleaned house. This is still the Obama administration. Most of these people—both in the Department of Defense and in the intelligence community—are Obama analysts and Obamanites who are now deeply embedded in the federal bureaucracy. These people need to be fired or they need to be moved out. He's gotta get his own team in there, and this kind of thing is gonna continue until he replaces these people." ★

At the close of business on Thursday, Sept. 7, according to the Daily Treasury Statement for Friday, the total debt of the federal government was \$19,844,587,000,000 [\$19.84 trillion] and the portion of it subject to the legal limit set by Congress was

\$19,808,747,000. After President Trump signed the legislation suspending the debt limit, the total debt immediately jumped to \$20,162,177,000,000 and the portion of it subject to the limit jumped to \$20,126,392,000,000, according to the Daily Treasury Statement for Sept. 8, 2017.

That means the total debt jumped \$317,590,000,000 on the day it officially topped \$20 trillion for the first time and that the part of the debt subject to the legal limit jumped \$317,645,000,000 on that day.

Likewise, before Trump was elected, the federal government was increasingly and illegally spy-

plained about the Obama Justice Department spying on him? eign countries than the rest of the world's militaries combined.

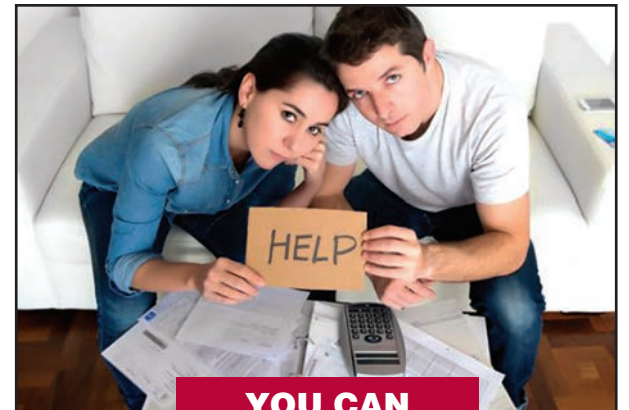

Amnesty for 800,000 Will Be Disastrous

• Trump's capitulation on "Dream Act" will punish struggling American families

"Having cut a deal with Democrats for help with the debt ceiling, will Trump seek a deal with Democrats on amnesty for the 'Dreamers' in return for funding for border security?"

The answer to that question, raised a few weeks ago, is in. In late September, President Donald Trump cut a deal with "Chuck and Nancy" for amnesty for 800,000 recipients of the Deferred Action for Childhood Arrivals program who came here illegally as youngsters, in return for Democratic votes for more money for border security.

According to preening Minority Leader Pelosi, the agreement contains not a dime for Trump's Wall, and the "Dreamers" are to be put on a long glide "path to U.S. citizenship." Trump denies this is amnesty, and says the wall comes later.

Fallout? Among the most enthusiastic of Trump backers, disbelief, disillusionment, and wonderment at where we go from here. Trump's debt-ceiling deal cut the legs out from under the GOP budget hawks. But amnesty would pull the rug out from under all the folks at those rallies who cheered Trump's promise to preserve the country they grew up in from this endless Third World invasion.

For make no mistake. If amnesty is granted for the 800,000, that will be but the first wave.

"There are reasons no country has a rule that if you sneak in as a minor you're a citizen," writes Mickey Kaus, author of the column "The End of Equality" in *The Washington Post*.

He added: "We'd be inviting the world. . . . [An amnesty] would have a knock-on effect. Under 'chain migration' rules established in 1965 . . . new citizens can bring in their siblings and adult children, who can bring in their siblings and in-laws until whole villages have moved to the United States.

"[T]oday's 690,000 dreamers would quickly be-

come millions of newcomers who may well be low-skilled and who would almost certainly include the parents who brought them—the ones who in theory are at fault."

Trump is risking a breach in the dam. If the populists who provided him with decisive margins in Ohio, Wisconsin, Michigan, and Pennsylvania feel betrayed, it's hard to blame them.

Why did Trump do it? Clearly, he relished the cheers he got for the debt ceiling deal and wanted another such victory. And with the rampant accusations of a lack of "compassion" for his cancellation of the temporary Obama administration amnesty, he decided he

had had enough heat. It is not easy to stand up for long to the gale force winds of hostile commentary that blow constantly through this city.

Trump's capitulation, if that is what it turns out to be, calls to mind George H. W. Bush's decision in 1990 to raise the Reagan tax rates in a deal engineered for him by a White House-Hill coalition, that made a mockery of his "Read my lips! No new taxes!" pledge of 1988.

For agreeing to feed the beast of Big Government, rather than cut its rations as Reagan sought to do, Bush was called a statesman. By the fall of 1992, the cheering had stopped.

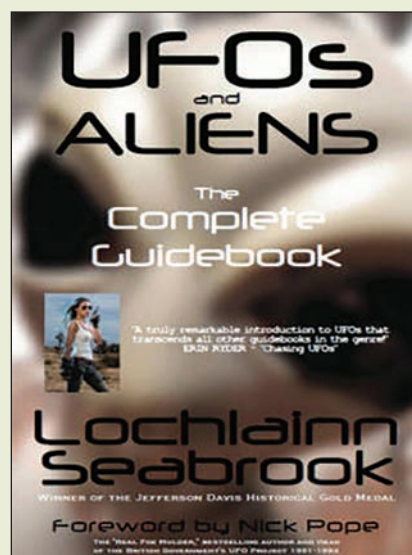

Can Trump not know that those congratulating him for his newfound flexibility will be rejoicing, should Justice Department Special Counsel Robert Mueller indict his family and his friends, and recommend his impeachment down the road?

What makes pre-emptive amnesty particularly disheartening is that the Trump policy of securing the border and returning illegal immigrants to their home countries appears, from a Census Bureau report this week, to be precisely the prescription America needs.

In 2016, paychecks for U.S. households reached an average of \$59,039, up 3.2% from 2015, a year when they had surged. U.S. median household income is now at its highest ever.

Yet there are inequalities. Where the median family income of Asian-Americans is above \$81,400, and more than \$65,000 for white Americans, the median family income of Hispanic families is \$47,675, and that of African-American households far less at \$39,490.

Consider. Though black Americans are predominantly native-born, while high percentages of Hispanics and Asians are immigrants, from the Census numbers, Hispanics earn more and Asians enjoy twice the median family income of blacks, which is below where it was in 2000.

Still, black America remains steadfastly loyal to a party that supports the endless importation of workers who compete directly for jobs with them

and their families.

Writes Kaus, “The median hourly wage (of DACA recipients) is only \$15.34, meaning that many are competing with hard-pressed, lower-skilled Americans.”

Looking closer at the Census Bureau figures, Trumpian economic nationalism would appear to have its greatest appeal to the American working class, a huge slice of which is native-born, black, and Hispanic.

The elements of that policy?

Secure the border. Halt the invasion of low-wage workers, here legally and illegally, from the Third World. Tighten the labor market to force employers to raise wages in our full-employment economy. Provide tax incentives to companies who site factories in the United States. Impose border taxes on the products of companies who move plants abroad.

Put America and American workers first.

Will amnesty for 800,000 undocumented workers and unemployed immigrants do that? ★

One in Nine Congressmen Is ‘Re-Educated’ in Israel

• Pro-Israel lobby pays to wine, dine and indoctrinate

The late Jim Traficant, the populist and courageous former congressman from Ohio and a regular contributor to this newspaper, was a powerful critic of the death grip the pro-Israel lobby and other high-profile and well-funded pro-Israel organizations have over the American government, particularly America’s congressional representatives.

“I believe that Israel has a powerful stranglehold on the American government,” Traficant boldly declared in a 2009 interview with Greta Van Susteren following his release from prison on trumped-up corruption charges. “They control both members of the House . . . and Senate.”

Traficant’s frank assessment of the pro-Israel lobby’s control and influence over the United States Congress has been proven accurate once again, as it was recently reported that more than 50 congressional representatives of both major political parties visited Israel last month. That amounts to just under one-eighth of the 435 congressmen and women currently in Congress.

The trips to Israel were funded in part by the American Israel Education Foundation (AIEF),

a charitable organization associated with AIPAC, America’s most prominent and influential pro-Israel political lobby.

According to its official website, AIEF “funds educational seminars to Israel for members of Congress and other political influentials” in order to “help educate political leaders and influentials about the importance of the U.S.-Israel relationship through firsthand experiences in Israel, briefings by experts on Middle East affairs, and meetings with Israeli political elite.”

U.S. congressmen and women—Democrats and Republicans alike—regularly visit Israel to consult and network with their Israeli counterparts, a long-running tradition in American politics that is largely overlooked by the average American voter.

A report published by the *Jewish News Service* highlighting the August trips to Israel noted the bipartisan nature of the trips, as House Majority Leader Kevin McCarthy (R-Calif.) and Democratic Whip Steny Hoyer (D-Md.) led the groups during their time in the Zionist entity. The American lawmakers met with Israeli Prime Minister Benjamin Netanyahu, were briefed on strategic threats in the region, and met with other Israeli political, security, military, and media officials and representatives during their August visit.

LegiStorm, a top congressional watchdog group that provides analysis and intelligence to D.C. insiders and policymakers, reported that AIEF “spent nearly \$490,000 for a week of travel for 12 freshman, five other Democratic members, Minority Whip Steny Hoyer (Md.) and three of Hoyer’s aides.” Roughly one week later, “AIEF spent \$668,000 to send 31 Republican members to an education seminar in Tel Aviv,” according to the report.

The AIEF-funded trips to Israel are clearly paying off for the pro-Israel lobby, as support for Israel remains a bipartisan consensus on Capitol Hill. The Trump administration and virtually every other prominent political official also constantly voice their unwavering support for Israel.

President Donald Trump recently met with Israeli Prime Minister Netanyahu and reaffirmed “the unbreakable bond between the United States and Israel” and “the unwavering commitment of the United States to Israel’s security,” according to the official White House announcement highlighting the meeting.

The news comes as the United States opened its first permanent military base in Israel earlier this week. The base, located in southern Israel near the city of Beersheba, will “house dozens of U.S. troops and a missile defense system,” according to a report published by *The Hill*. The American taxpayer dishes out billions of dollars annually to Israel, most of which is related to maintaining Israel’s military advantage in the region. ★

Far-Left Candidate Sees Career Ruined

• Politicians scramble to disassociate with anyone who supports sanctions on Israel

The “third rail” of politics was once Social Security—mess with it and one’s political career could be short-circuited. No more. Now, even the slightest departure from unqualified support for the state of Israel—if only to seek fairness and balance—is sure to cripple or torpedo a career at any level of politics.

An interesting example of this came about recently when Rep. Brad Schneider (D-Ill.) withdrew his endorsement of Democratic Illinois gubernatorial candidate Daniel Biss simply because of Biss’s running mate’s position on the U.S. relationship with Israel.

Schneider said he was “surprised” to learn that this running mate, Chicago Ward 35 Alderman Carlos Ramirez-Rosa, supports the pro-Palestinian movement known as Boycott, Divestment, and Sanctions (BDS).

The BDS movement promotes economic, academic, and cultural boycotts against Israel as a non-violent tactic in the struggle against the Israeli occupation of Palestine.

Notably, pro-Israel money formed a major funding stream in Schneider’s 2016 House race. Political watchdog group Open Secrets ranks pro-Israel donors as his third-largest source of money, totaling \$318,749.

AFP’s calls to Schneider’s office to explain his abrupt withdrawal have so far not been returned.

The controversy arose after Ramirez-Rosa attended a gathering called the People’s Summit 2017 where a resolution in support of the BDS movement against Israel was passed.

Ramirez-Rosa’s statements on the Israeli-Palestinian conflict are not even considered extreme.

“For too long the U.S. government has subsidized the oppression of the Palestinian people, and it’s time that that’s stopped,” he told the Real News Network over a year ago. “People stand with Israel, but they also want to make sure that Palestinian people have [justice].”

UNDENIABLE ISRAELI AGGRESSION

Israel officially receives \$3.8 billion in annual U.S. foreign aid, mainly for its military, though often it receives more, thanks to grants and other gifts.

Israel periodically carries out devastating, highly disproportionate military assaults on the Gaza Strip in Palestine, complete with warplanes firing laser-guided bombs that demolish entire blocks of buildings that house hundreds of people. Videos of these vicious attacks, many of which are posted on YouTube, are difficult to watch.

cott, Divestment, and Sanctions.

Kansas and Texas are among the most recent states that have passed or appear to be on the brink of passing anti-BDS laws.

The pro-Israel press has been heavily focused on this matter, arguing that free speech is safe, because individuals and companies can still criticize or boycott Israel as long as they’re not vying for state business.

Jacob Millner, Midwest director with the Israel Project, added that states also should not subsidize or reward such “discriminatory behavior” against Israel. Under a Kansas anti-BDS bill, companies would have to provide written certification that they’re not boycotting Israel before they get a state contract. This litmus test, or something like it, is in place in other anti-BDS states.

In Texas, a member of the Israeli Knesset, or parliament, visited Austin early this year amid debate over the anti-BDS legislation that was signed into law there.

Besides Illinois, Kansas and Texas, states that have passed anti-BDS laws as of June 2017 include Arizona, Colorado, Florida, Georgia, Illinois, Ohio, Indiana, Iowa, Montana, South Carolina, Pennsylvania, New Jersey, Rhode Island, Michigan and Nevada. New York Gov. Andrew Cuomo signed an executive order in June 2016 banning state agencies from investing in companies that support boycotts on Israel. In May, all 50 state governors signed a declaration condemning the BDS movement as “incompatible with the values of our states. . . .”

But the most serious anti-boycott legislation, which could affect freedom of dissent, is at the federal level. There, the Israel Anti-Boycott Act (H.R. 1697) has the bipartisan support of 253 cosponsors, including Rep. Schneider.

Introduced by Illinois Republican Rep. Peter Roskam on March 23, the bill was referred to the Financial Services Committee, where it remains. The bill would, among several other things, prohibit “any U.S. person engaged in interstate or foreign commerce” from supporting “any boycott fostered or imposed by any international governmental organization against Israel, or any request by any international governmental organization to impose such a boycott.” ★

Time for Universal Healthcare?

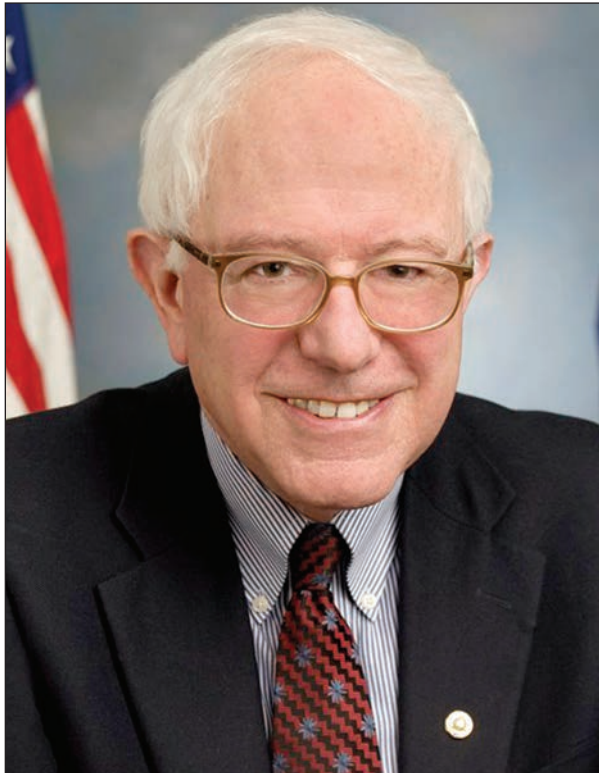
• Populists still searching for real solutions to America's medical care crisis

Populism is a broad concept and offers considerable promise compared to the conventional “left-right” paradigm, which often leads to stalemate. The constant scorn heaped upon populism—with big media and establishment think tanks portraying it nonstop as a chief component of “nationalist extremism” bordering on domestic terrorism—may explain why the dominant political parties, the mainstream media, and other political players skew the issue so much and prod people back into manageable opposing camps.

What the powers-that-be fear is that, under a populist umbrella, political figures and ideas that otherwise seem light-years apart will actually find common ground. Populist-friendly issues around which “conservatives” and “liberals” could unify include, for instance, battling big pharma and big corporate farms whose products harm human health, taking on energy monopolies, adopting a non-interventionist foreign policy, opposing “eminent domain” land-grabbing schemes, and ending the Federal Reserve.

It's in this context that the recent efforts of Sen. Bernie Sanders (I-Vt.) are highlighted. Sanders is a left-wing populist, yet, over the years, AFP has agreed with Sanders at times, such as when he has denounced the rigged free-trade treaties in which the U.S. is currently snared.



Is socialized medicine the best solution to our American healthcare crisis? Vermont's democratic socialist senator, Bernie Sanders, wants to expand the Medicare system to cover everyone. The Medicare for All Act of 2017 is something to ponder. The \$80 billion increase in the military budget alone could have paid for Medicare for all Americans in the ensuing year.

What is notable now is that Sanders has been advancing a bill that would expand Medicare to cover the general population, not just those age 65 and over.

His bill, the Medicare for All Act of 2017, has received considerable publicity and, given the tedious procedures and unfair rules associated with keeping former President Obama's Affordable Care Act intact, “reforming” Obamacare seems out of reach—if not out of the question.

So, what should the government do, if anything? Could a Medicare expansion serve as the solution?

Active-duty military personnel are already covered by the government, and the Veterans Administration addresses military retirees' healthcare. Plus, the millions of employees in the state governments and the federal government are well covered in terms of healthcare. Both federal prisoners and the poor are covered under Medicaid—at least in some states, where adults are able to access Medicaid.

With few exceptions, the only people who don't get healthcare coverage are those who work the hardest and pay the bills—the middle class.

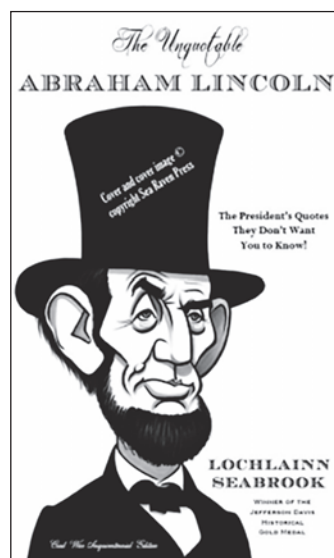
“If President Franklin D. Roosevelt were alive today, he would instantly recognize the Medicare for All Act of 2017 as a crucial next step in the work he began more than three-quarters of a century ago,” wrote Nancy Altman, president of Social Security Works, recently. “He would applaud the legislation which Sen. Bernie Sanders and his co-sponsors [have introduced] but would be shocked that universal healthcare as a right hadn't become the

law of the land decades ago.” She added that FDR and the other Social Security architects felt that “universal, government-sponsored health insurance was right around the corner.”

FDR, she also noted, “had originally planned to include national health insurance in his Social Security legislation, but ultimately decided that it was asking for too much at once. Revealingly, when he signed the Social Security Act into law [in 1935], he explained: ‘This law . . . represents a cornerstone in a structure which is being built but is by no means complete.’”

A few years before World War II, staunch-conservative populist Father Charles Coughlin, the famous “radio priest” of the Church of the Little Flower in Royal Oak, Mich., stood by FDR for a time. Coughlin felt that “social justice” was not the sole possession of progressives and that not all “progressive” views were necessarily wrong.

Coughlin even named his newspaper *Social Justice* and used it to argue for a more equitable social order, to be achieved mainly by sacking the Federal Reserve and restoring to the government its constitutionally based duty of issuing currency and credit interest-free as a sovereign act, instead of borrowing from the banking fraternity and plunging the nation into endless debt and wars. Until he parted ways with FDR due to the president’s treacherous actions that catapulted the U.S. into World War II, Coughlin supported much of the New Deal in hopes that it would help the population in various ways, including their general health and well-being.

Critics of nationalized healthcare systems often resist such a socialist concept and cite long waiting times for surgeries and special treatments and a relative lack of special equipment at times, as has been claimed about Canada, for example. It’s also possible that such a universal system might make the administration of dangerous vaccines even harder to reduce or defeat, along with increasing abortion on demand.

Time will tell exactly how Sanders’s bill might deal with these issues by the time Congress has reviewed and amended it.

While expanded-Medicare costs could go through the roof, one must consider whether the U.S. really needs to spend nearly a trillion dollars annually on its military and pay out billions more in foreign aid. It is estimated that the \$80 billion increase in military spending recently approved by Congress would fund Medicare for all Americans, according to some reports.

In addition, proper monetary reform, involving the interest-free issuance advocated by Coughlin and many others, would enable the government to pay for key projects without inflationary borrowing and debt. Import tariffs could also be advanced as a good source of new revenue, along with cutting some needless regulations and taxes that hamper economic vitality.

Ancient Healers Knew Secrets of This Plant

• Does curcumin—the extract of the turmeric plant—meet the hype it’s getting today?

By Paul T. Angel

People are all abuzz about the hype being generated by an extract of the turmeric plant called curcumin, which has been used for centuries by alternative healers. For once we have to say that the excitement may be warranted.

Turmeric is a rhizomatous perennial herb (*Curcuma longa*) that is a member of the ginger family. Native to Southeast Asia, turmeric is now grown by home gardeners across the world.

More than two dozen published studies have shown that curcumin provides benefits to many different structures and functions of the body, just as medical legend claims.

Curcumin’s gold to orange color root appeared in India as a spice around 2000 B.C., and was documented in Ayurvedic medicine by around 600 B.C. It also has a long history in Chinese medicine, though it was first used as a dye.

The gold-orange color comes from three different compounds: curcumin, demethoxycurcumin, and bisdemethoxy-curcumin, which together are commonly known as “curcumin.”

Sayer Ji, founder of “Greenmedinfo,” made the startling observation that curcumin and its constituents have been the “subject of 5,600 peer reviewed and published biomedical studies.”

• Ji pointed out that curcumin has been studied against popular prescription drugs, and, in many cases, was more effective, but without the dangerous side effects of prescription medication. We print this with caution. While research exists, you should consult with your medical professional before taking curcumin if on any prescription medication. It has anti-clotting properties. So, for people on coumadin, it can be dangerous.*

• Ji cited eight studies where curcumin supported cholesterol health—one bested a statin drug.

• Ji cited 52 abstracts supporting curcumin for inflammation. Normally, steroid medications are prescribed.

• Ji cited five abstracts showing curcumin helped with mood (some besting Prozac).

• Ji cited studies showing that curcumin activates AMPK (involved in blood sugar health), more so than the popular drug Metformin.

Thousands of study references in the scientific literature speak to the value of curcumin. They say it has incredibly powerful biological actions but its actual benefit is severely limited by the fact it is poorly absorbed by the body.

The “absorption” question is a critical point with many natural substances and even pharmaceuticals. When put to the test of whether they will actually work in the body, they may not deliver real and consistent benefits due to poor absorption.

This is where modern technology shines. Some manufacturers are now using non-soy phospho-

lipids as a way to make curcumin biologically active in the body. (This is the same phospholipid technology used in the best available *Boswellia serrata* resin extract).

The highly respected Indena company has been using phospholipids with plant extracts since 1989, but only recently began using lecithin from sunflower instead of soy.

At AFP, we have sided with those who reject soy phospholipids. “Radio Free America” host Tom Valentine was among the first in the U.S. to warn of the negative effect unfermented soy products have on the human body, despite the propaganda that insists soy is a “health food.” Studies have proven that he was correct.

THE IMPORTANCE OF BIOAVAILABILITY

Something that few health writers talk about is bioavailability.

Dr. Paris Kidd, “BrainMD’s” chief science officer, explains why bioavailability is so important: “The data from [a recent study] showed that the curcumins were absorbed at least twice as fast

from the phytosome form, versus curcumin mixtures that are not phytosomes. But, also, far greater amounts were absorbed into the blood. [This method] improved absorption of the total curcumins by about 29 times. Curcumin itself was at least 18 times better absorbed. The other two compounds, demethoxy-curcumin and bis-demethoxy-curcumin, were at least 50 times better absorbed.”

Curcumin is thought of as three distinct compounds. The fact that demethoxy-curcumin has 50 times the bioavailability is especially impressive in light of the fact that this compound is said to be particularly important.

Studies using a highly bioavailable formulation of curcumin reveal that it helps promote healthy functioning of the joints, eyes, circulation, prostate, muscles, and nerves. In one study, this form of curcumin helped improve blood flow in the feet. In a study including 50 people, half receiving two capsules of bioavailable curcumin and the other half

a placebo, the group receiving the curcumin had substantially better oxygen delivery to the capillary matrices of the feet, compared to the placebo control group.

And, in a study using 19 moderately conditioned people, 10 men took 2,000 mg of highly bioavailable curcumin and nine took a placebo, two days prior and two days after an intense workout involving running downhill for 45 minutes on a treadmill after a 10-minute warm-up. The subjects then had magnetic

resonance imaging (MRI) on their thighs to measure muscle integrity. The curcumin group showed positive signs of muscle protection against exercise stress.

Another clinical trial suggests curcumin with high bioavailability helps protect the integrity of nerve tissues as well as musculature by regulating the activity of receptors on cell membranes that are sensitive to brain messengers. The trial also indicated other cell membrane proteins were “down-regulated” to make nerve or muscle fibers less sensitive to substances that may impair their function.

In short, curcumin appears to live up to the hype, but we would recommend that you use a brand that promises to deliver on claims of high bioavailability. Remember, however, we are not doctors, and this column should not be construed as medical advice. ♥

Who Is Imperiling Our Free Society?

- Look around this nation and few of its problems can be tied to “white supremacists”

“**T**he barbarian cannot make . . . he can befo and destroy but . . . he cannot sustain; and of every barbarian in the decline or peril of every civilization exactly that has been true.” Hilaire Belloc’s depiction of the barbarian is recalled to mind as the statues honoring the history and heroes of the republic and of the west continue to be vandalized and smashed.

In late September, the statue of missionary and Catholic Saint Fr. Junipero Serra was beheaded at the Santa Barbara Mission he founded.

The century-old Columbus statue in Central Park was defaced and spray-painted with: “Hate will not be tolerated.”

Baltimore’s monument to Francis Scott Key, who observed the bombardment of Fort McHenry on a British warship late in the War of 1812 and was inspired to write “The Star-Spangled Banner,” was covered in red paint. “Racist anthem” was written across it.

In Berkeley, home of the Free Speech Movement, the university recently had to spend \$600,000 to protect an invited speaker of the college Republicans from being assaulted.

But St. Louis was where the real action was. On Sept. 15, a mob hurled rocks and bottles injuring 11 cops, leaving one with a broken jaw. They smashed windows at the mayor’s residence and marched miles to the Central West End to berate diners on patios of restaurants with the menacing chant: “Off the sidewalk. Into the street.”

The next day, the mob invaded and shut down

a suburban mall and then smashed windows across a nightlife district.

The protestors’ rationale: rage at a not-guilty verdict in the murder trial of ex-cop Jason Stockley in the death of Anthony Lamar Smith—in 2011.

Stockley’s police van had been struck by Smith’s car, who had been nabbed in an alleged drug deal and led police on an 80-mile-an-hour chase, at the end of which Stockley emptied his gun in Smith.

Yet even Attorney General Eric Holder declined to investigate.

On Sept. 16, Black Lives Matter showed up at the

St. Louis police headquarters chanting, “Stop killing us!” But if the killing of black folks is a legitimate grievance, we need to ask: Who is killing them?

Last year, there were 4,300 victims of shootings in Chicago and 762 deaths. How many of those shootings were by cops? How many of those shootings, mostly of blacks, were acts of “terrorism by white supremacists, white nationalists, neo-Nazis, the Ku Klux Klan,” all of whom our ever-heroic Congress demanded that President Donald Trump in a joint resolution after Charlottesville denounce?

Nowhere in the resolution was there any mention of Antifa, the “anti-fascist” fighters on the other side of the Charlottesville brawl, where a protester was run down and killed by a Nazi sympathizer.

What is it in their DNA that causes Republicans reflexively to sign on to a one-sided Democratic denunciation of Trump for the sin of suggesting there were two parties to the Charlottesville brawl?

And are neo-Nazis really a threat to the republic? In 1963, this writer was at Dr. Martin Luther King’s March on Washington, which began on the monument grounds where George Lincoln Rockwell’s Nazis were yelling slurs. On the site where Rockwell’s Nazis stood, there stands today the African-American Museum.

When my father was a 21-year-old Al Smith Democrat in D.C. in the Calvin Coolidge era, scores of thousands of anti-Catholic Klansmen strode up Pennsylvania Avenue, and the national Klan numbered in the millions.

But is the KKK of today a serious threat to civil rights?

Lately, St. Louis and East St. Louis have boasted the highest murder rates in America. Is that the doing of white supremacists?

This morning we read there have been so many

smashed and stolen bicycles that Baltimore is canceling its bike share program. Did David Duke and his Klan friends steal all those bikes?

Who are the ones shouting down speakers?

Who violently disrupts political rallies on campuses and off?

Who engages in mob violence after almost every police shooting of a black suspect?

As for interracial assaults, rapes, and murders, according to FBI crime statistics, these are primarily the work of black criminals against white victims.

Will Congress Ever Take Their War Powers Back?

Recently, Sen. Rand Paul (R-Ky.) reminded Congress that, in matters of war, Congress has the authority and the responsibility to speak for the American people. Most senators were not too happy about the reminder, which came in the form of a forced vote on whether to allow a vote on his amendment to repeal the Afghanistan and Iraq war resolutions of 2001 and 2002.

It wasn't easy. Paul had to jump through hoops just to get a vote on whether to have a vote.

That is how bad it is in Congress. Not only does Congress refuse to rein in presidents who treat constitutional constraints on their war authority as mere suggestions rather than as the law of the land, Congress doesn't even want to be reminded that they alone have war authority.

Congress doesn't even want to vote on whether to vote on war.

In the end, Paul did not back down, and he got his vote. Frankly, I was more than a little surprised that nearly 40% of the Senate voted with Rand to allow a vote on repealing authority for the two longest wars in U.S. history. I expected

less than a dozen "no" votes on tabling the amendment and was very pleasantly surprised at the outcome.

At the time of the vote, Rand said, "I don't think that anyone with an ounce of intellectual honesty believes that these authorizations from 16 years ago and 14 years ago . . . authorized war in seven different countries."

Are more senators starting to see the wars his way? We can only hope so. As polls continue to demonstrate, the American people have grown tired of our interventionist foreign policy, which burns through trillions of dollars while making the world a more dangerous place rather than a safer place.

Some might argue that losing the vote was a defeat. I would disagree. For the first time in years we saw U.S. senators on the Senate floor debating whether the president should have authority to take the U.S. to war anywhere he pleases. Even with just the small number of votes I thought we might have gotten on the matter, that alone would have been a great victory. But getting almost 40% of the Senate to vote our way? I call that a very good start.

The first step toward rebalancing the separation of powers is for Congress to re-assert its authority and responsibility for declaring war. To

this point, Congress has preferred to transfer its war responsibility to the president.

The second step, once Congress understands its obligations, is to convince our representatives that war was not designed to be the first choice in foreign policy, but rather to be the last resort when we are under attack or when a direct attack is imminent.

Just because Congress decides to approve the use of force does not mean that the war is just, justified, or wise. Congress is just as susceptible to war propaganda as the rest of America, and unfortunately it is dominated by the false opinion that if you are not enthusiastic about U.S. military solutions to disputes overseas then you are not being tough enough.

In fact, it takes far more strength to exercise restraint in the face of the constant war propaganda and disinformation coming from the controlled media and the neocons.

We have achieved a small victory in early September, thanks to Rand Paul. But we still have a lot of work to do. We must keep the pressure on and convert more to the cause of peace and prosperity. ★

Scammed on the Monuments

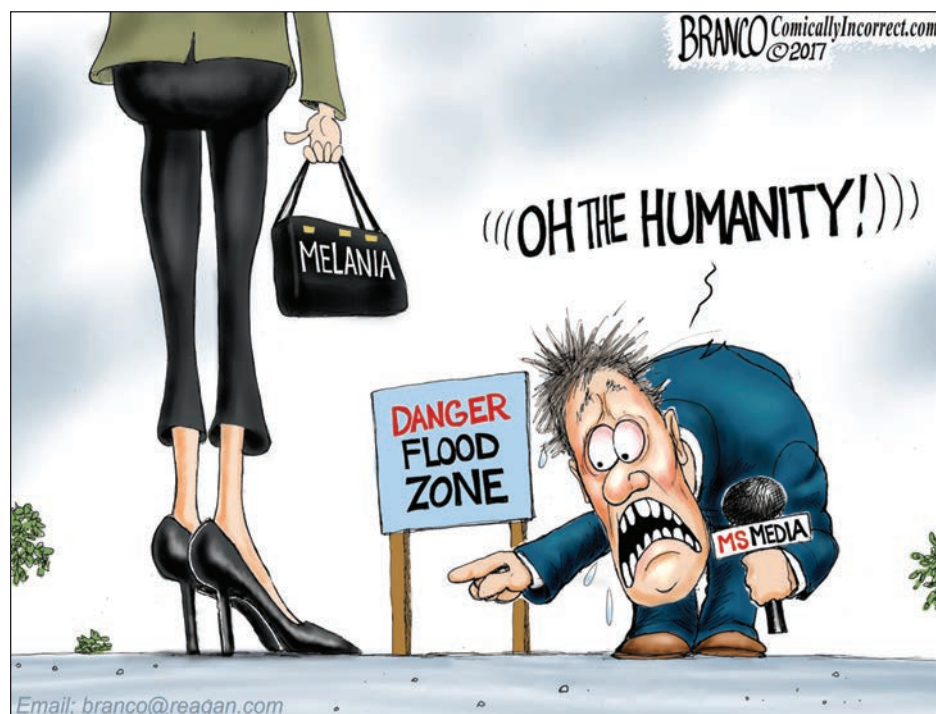
