NO JUSTICE

- Obama judge: Injured cop can't sue Black Lives Matter
- Radical organization protected as "social movement"

In the wake of a string of violent and all too often fatal attacks on police officers across the country last year—attacks that were instigated by radical activists, subversive leftist organizations, and an entirely dishonest mainstream mass media—two separate lawsuits were filed on behalf of American law enforcement officials charging Black Lives Matter (BLM) and its top leaders with inciting, encouraging, and justifying the violence leveled against police.

In late September, however, a federal judge appointed by President Barack Obama shot down one of those suits, claiming that the group and its leaders cannot be sued because they are part of "a social movement" and are, ironically, engaging in free speech that is protected by the Constitution.

As this newspaper recently reported, an unnamed East Baton Rouge Parish sheriff's deputy sued

BLM and its most prominent leaders, including DeRay Mckesson, a national spokesman for the movement known for his incendiary and radical anti-American views, in the aftermath of an ambush on Louisiana police officers following the shooting

death of Alton Sterling, a young black man. The lawsuit alleges that Mckesson and other BLM leaders, along with the overall Black Lives Matter movement, "caused or contributed to" the violence carried out against Baton Rouge law enforcement officers. BLM and its leaders incited and even justified the violence, the lawsuit contends.

Attorney Donna Grodner, who has thus far declined to comment to this reporter, filed the lawsuit on behalf of the sheriff's deputy. Grodner also filed a separate lawsuit on behalf of yet another police officer, charging BLM—funded by George Soros

CENSORSHIP A HALLMARK OF THE 21ST CENTURY

In this week's edition of AMERICAN FREE PRESS, we're covering several important stories that were either missed entirely by the mainstream media or, if they did get a mention, they didn't get anywhere near the attention they deserved.

First, let's take a look at John Friend's front-page article, titled "No Justice." In his lengthy report that jumps from page one to page 22, John provides an update on the two lawsuits brought by sheriff's deputies in Baton Rouge against the organization Black Lives Matter (BLM) and several of the group's leaders.

Significantly, John notes that late last month the judge threw out one of the cases, citing two specific reasons in his ruling.

The first claim made by the judge was that BLM is technically not an organization but some nebulous social movement, and, since it doesn't really exist, he argued, it cannot be sued.

In truth, there are many chapters of BLM all around the country, some of which have even gone through the lengthy process to get nonprofit status from the IRS so that donors can deduct donations on their taxes. And we're not just talking about a little bit of money here. In 2016, an umbrella BLM group that oversees multiple Black Lives Matter chapters secured \$100 million in funding from multiple wealthy corporations, foundations, and billionaires. That was

over and above the earlier \$33 million given to the groups in 2016 by the Democrat-backed Center for American Progress and slash-and-burn speculator George Soros's Open Society Foundations.

Perhaps even more interesting was the second reason the judge cited for throwing out the lawsuit: BLM leaders had a constitutional right to demonstrate and speak out—even when their verbiage was inflammatory. Of course, the irony here is that, had police in Louisiana been suing a pro-Confederate or white nationalist group, the judge would be hammering his gavel while shooting down any First Amendment defense.

That was just one article by John Friend. In his second report in this issue, John revisits the important issue of free speech as it relates to the so-called "fake news" phenomenon going on in this country.

In that report on page 14, John writes how left-wing organizations, which have in the past advocated shutting down conservative news outlets, are now beginning to see how censorship affects everyone in this country—including themselves.


We can't help but chuckle a bit when we see left-wing organizations complaining about being censored. After all, we did warn them. But now, they, too, are reaping what they've sown as only so-called "centrist" and "mainstream" views are being "authorized" by the powers that be.

News You May Have Missed

Russiagate Crumbling

According to Democrats and their allies working for the U.S. government, hackers working with or for the Russian government hacked over 21 states. But beyond mere speculation, no real evidence has been provided that the alleged individuals or groups of hackers have ties to Russia. Now, a Sept. 26 report from the Department of Homeland Security (DHS) made such accusations even more speculative, as it notes whoever did scan Wisconsin's voter registration system was not Russia. DHS told state officials in an email that an agency not involved with elections had indeed been the target of scans by individuals with Russian IP addresses. An IP address, which indicates the location from which a computer has logged into the Internet, can easily be "spoofed" thus cloaking the user's real location by displaying an alternate geographic area. This follows on the heels of the secretary of state of California—one of the 21 states purportedly hacked by Russia—issuing a press release noting that its elections records were not hacked.

Bad Bank

Rep. Maxine Waters (Calif.), the top Democrat on the House Financial Services Committee, is calling for regulators to shut down Wells Fargo because it has abused the trust of millions of its customers. In a scathing 38-page report, Rep. Waters and the committee criticized regulators for their failure in not punishing the bank more severely in response to its recent scandals. In the report, which was prepared by the committee's Democratic staff, Wells Fargo is described as a "repeat offender." It points out the bank opened up to 3.5 million potentially fake accounts and forced as many as 570,000 borrowers into unneeded auto insurance.

Hillary Funding Rioters

Hillary Clinton has been funneling dark money to some bad guys—more than \$800,000 to a super-

PAC, "Onward Together," which is heavily backing establishment extremist groups such as Antifa. You may remember that during her failed run for president, she often condemned just such dark money super-PACs.

Millionaire Scandal

The average net worth of congressmen and women exceeds \$1 million and is tenfold the average net worth of U.S. households—many of which are actually broke. Yet the 535 members of Congress (this includes 100 senators) do not publish their tax returns. Will these 535 individuals have no conflicts of interest when income tax reform comes before Congress?

Widening Gap

A new report from the Federal Reserve says the richest 1% of families in the U.S. controlled a record-high portion of the country's wealth in 2016: 38.6%. That means the remainder of us—the other 99%—now share just 61.4% of America's total wealth.

Cost of Illegal Immigration

The swelling population of illegal immigrants and their kids is costing American taxpayers \$135 billion a year, the highest ever, driven by free medical care, education, and huge law enforcement costs, according to the most authoritative report to date on the costs to Americans of illegal immigration, by the Federation for American Immigration Reform.

Lone Star State a Winner

A liberal federal judge in San Antonio, Texas handed down an injunction of Texas's new law against sanctuary cities for illegal aliens. Well, good news: That liberal order has been overturned by the Fifth Circuit Court, deciding in favor of the Lone Star State's appeal. The populist panel decided Texas has the right to protect the citizens—at least until and unless the law is ruled invalid by the courts. The 2017 statute applies to illegal aliens ar-

rested or otherwise lawfully detained by local law enforcement. No matter what a liberal Texas municipality might say about it, the police under this law are free to: notify federal immigration officials that an illegal alien has been detained, cooperate with the feds, and allow federal immigration officers to enter local jails to conduct investigations of illegal aliens held there.

Nation of Idiots

An Annenberg Public Policy Center (APPC) survey of over 1,000 American adults found an embarrassing lack of knowledge among society when it comes to U.S. politics. The results show that, while 48% were aware that freedom of speech is a right enshrined by the First Amendment, far fewer were able to identify any other First Amendment rights, and 37% were unable to name even a single right endowed by the First Amendment. A pathetic 26%, down 12% just since 2011, were able to name all three branches of the federal government; conservatives were more likely than liberals or moderates to be able to do so. Perhaps worst, a whopping 33% of respondents were unable to name even a single federal branch of government, and that number has sadly not changed in the past five years.

Good Start

The U.S. government sided with Boeing by imposing 220% anti-subsidy duties on Bombardier Aerospace's C Series jets. American-based Boeing filed a complaint alleging Canada is unfairly subsidizing Bombardier and claiming Bombardier sold 75 C Series jets to Delta below cost in a tactic similar to that used by rival Airbus in the 1990s to grab U.S. market share.

Scary News

A new study from the Hebrew University of Jerusalem, published in *Human Reproduction Update* and reported in *Science Daily*, found a 59.3% decline in total sperm count among men from North America, Europe, Australia, and New Zealand. In light of recent ev-

idence linking poor semen quality with higher risk of hospitalization and death, the findings strongly suggest a significant decline in male reproductive health with serious implications beyond fertility and reproduction. Exposure to "chemical castrators," especially from agricultural chemicals like atrazine—which cause "feminization" of males with resultant hormonal disruption and sperm population decline—are widely blamed as the cause. Researchers found the decline, which is accelerating in Western nations including the U.S., could lead to a collapse in human population.

Good News

According to a recent Australian Broadcasting Commission report, scientists have surprisingly found that parts of Australia's Great Barrier Reef, which have been severely bleached over the past two years, are recovering, thus increasing optimism among scientists that the reef is not really dying after all. Australian Institute of Marine Science researchers conducted a survey this month of 14 coral reefs between Cairns and Townsville that had been bleached. Spokesman Neil Cantin said they were surprised to learn the coral had already started to reproduce.

Mysteriously Disappear

Salt Lake City Police and other officials profess themselves baffled by the sudden disappearance of 2,000 people, who had been living on the streets of the Utah city. Many of the homeless were victims of the economy with unemployment rates not reflecting the large numbers of would-be workers who have simply given up on finding a job. Less than one month prior to the disappearance, Utah flooded the area with cops and arrested about 1,200 people on drug charges and promised to find housing and work for the rest of the population. Nine hundred of those arrestees were back on the street a short time later. Some are speculating the missing hundreds may have moved on to some other town or towns or into the suburbs.

Trump Tax Plan Helps Middle Class

• New proposal by president to lower taxes benefits over-taxed workers at every level

In response to President Donald Trump's idea of cutting taxes by \$5.8 trillion over 10 years, the mainstream media is asking, "How do you pay for an estimated \$5.8 trillion tax cut?" The answer is, You don't. You just enjoy the lighter tax burden all the way to the bank.

House Ways and Means Committee Chairman Kevin Brady (R-Texas), representing that chief tax-writing body, recently addressed the Heritage Foundation about tax reform in light of Republicans having just unveiled "their unified framework for tax reform that is focused on delivering more jobs, fairer taxes, and bigger paychecks for the American people," as a committee press release claimed.

Brady believes the framework would help low- and middle-income Americans "by reducing tax rates and allowing them to keep more of their hard-earned paychecks," the release added.

He told Heritage: "Following the lead of President Reagan, we flatten out the tax brackets from seven to three. We lower the taxes at every level and we preserve more of the 'first dollars' that every American earns. All of that is incredibly helpful for families trying to keep more of what they earned—all the rates go down."

Brady continued: "For example, the 15% bracket today goes to 12%, the 10% bracket today goes to 0%, just as President Reagan did. He lowered the 11% bracket and made it 0%. Their next level was a little higher, 15%. Ours is lower, which means those with a modest income—the poor, the middle class—are better off under the tax reform plan we bring forward."

So if tax cuts are enacted, how will the president be able to balance the budget and pay down

the nation's debt?

The easiest solution would be to simply cut the budget, including spending on war, to match tax revenue. But there are other ways, too.

Fresh from a recent American Monetary Institute conference in Chicago covered by AFP, retired financial adviser and monetary-reform author Mark Pash told this writer that, regarding the current tax-reform chatter among members of Congress and the Trump administration, reforming the payroll tax is being overlooked.

He added that the Federal Insurance Contributions Act (FICA), which includes Social Security and Medicare tax withholdings, should be cut by a full percentage point or even more—but

with a catch.

Employers and employees each pay 6.2% for the Social Security part of FICA and 1.45% for the Medicare portion, totaling 15.3%, but the self-employed must pay the full tax.

Common sense says that loosening up more spending money among the self-employed—especially in today's "gig" economy with more people resorting to sporadic, informal work under their own auspices—would provide a lot more purchasing power to the lower and middle classes where self-employment is prevalent.

According to the Center on Budget and Policy Priorities (CBPP), three-quarters of taxpayers pay more in payroll taxes than they do in income taxes.

"The FICA tax is considered a regressive tax on income with no standard deduction or personal exemption deduction," Wikipedia adds.

The Social Security portion of the tax is imposed on only the first \$118,500 (in 2015 and 2016). FICA is not imposed on investment income like interest, rental income, or dividends.

Thus, while Social Security and Medicare try to survive with all those revenue-support options omitted, Pash advocates making those at higher income levels, beyond \$118,500, pay the FICA tax. That way, more money would be paid into the system while those in the lower-income brackets would have more take-home pay and the wealthier would still do fine.

Corroborating the CBPP, Pash remarked, "Well over 50% of the workers of the country pay more on that FICA tax than on the income tax."

Yet, aside from necessary micro-adjustments, late AMI founder Stephen Zarlenga, former Congressman Dennis Kucinich, Pennsylvania activist Mickey Paoletta, and several other trailblazers have worked hard to make the case that fundamental monetary and financial reforms are sorely needed, in a world starving for purchasing power against massive production levels (domestic and imported) that can hardly be bought, and gargantuan public debts that can never be paid.

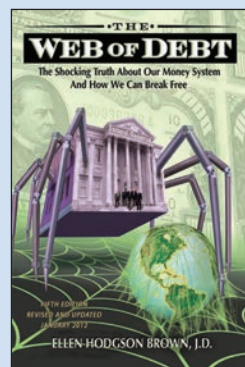
To these men, "tax reform" lies in reviving the creation and democratic distribution of sovereign national money and credit, instead of governments borrowing from the usurious banking consortium. Ideally, this would be done in concert with a serious paring down or dissolution of the money-issuance and property-foreclosure powers of the banks. ★

Mental Health Laws Used to Silence Critic

• Pennsylvania powerbrokers abuse legal system to lock up political opponent

A law on the books in the Keystone State intended to apply to individuals with mental illness is now being used for a more sinister purpose: to involuntarily commit political opponents who pose a threat to the established power structure in the commonwealth's capital.

Andrew J. Ostrowski, a former Pennsylvania civil rights attorney, found himself in the sights of the powers-that-be in Harrisburg, and learned the hard way how the 1976 Mental Health Procedures Act (MHPA) is being used to chill criticism of the power prism.

The MHPA “establishes procedures for the treatment of mentally ill persons” and “set[s] forth the Commonwealth’s policy and procedures regarding the provision of mental health services.” Article III of the act defines the requirements and limitations on involuntary emergency examination, treatment, and hospitalization of individuals who present a “clear and present danger to others.” That key phrase is defined as meaning “within the past 30 days the person has inflicted or attempted to inflict serious bodily harm on another and that there is a reasonable probability that such conduct will be repeated.”

Longtime AMERICAN FREE PRESS subscriber and supporter Dorene Shutz tipped off this reporter to Ostrowski’s recent kidnapping. “He is awake to the corrupt courts,” she explained.

On Aug. 26, this reporter spent most of the day with Ostrowski, Ms. Shutz, and other mild-mannered patriots at *The Nationalist Times* conference, and found all the participants to be scholarly truth-seekers. None who were present that day could ever be considered severely mentally ill and in need of involuntary treatment by even the most incompetent authority, but that says nothing of corrupt authority.

Ostrowski was born and raised in Lancaster, Pa., attended Millersville University, and “was in the first graduating class at Widener University” in Harrisburg.

“I trained for several years in the formal legal law firm environment,” he told AFP.

He soon discovered, however, that his chosen profession as an “officer of the court” wasn’t what he thought it might be.

“I had been a practicing lawyer until 2010 when I ran into disciplinary issues,” he said, “and, as I distanced myself from the formal practice and started to look at these things, I started to see that there really was no basis for the licensing of the practice of law. The licensing of the practice of law really is an impediment to everybody’s access to justice, because your attorney is not free to ad-



vocate without risking his or her own property.”

On Aug. 23, Ostrowski filed a motion, attacking what he saw as a corrupt system.

“I filed what is called a motion for declaratory relief,” he explained, “which is a vehicle that gives you access to have declarations made that certain things are constitutional, not constitutional, lawful, and unlawful. And I did it to challenge the basis of the attorney law license. This . . . is a very significant motion that really would upset the entire judicial structure in this country.”

Sitting at his desk on Sept. 19, Ostrowski found out how significant it really was.

“I posted a notice on Facebook and sent out emails notifying people I was going on Facebook Live and, within 15 minutes of that, the police were at my door.”

Facebook Live allows a user to broadcast live video streams, requiring nothing more than a computer with a video camera and a Facebook account.

“I looked out the front window,” he said, “and there was a cop climbing over my railing to come around back, so I went around to the back door and locked it, and I went on Facebook Live. And then somehow, they got a key and they came in with gloves on and with their tasers pulled, three of them, a female and two males.”

The webcam captured the interaction between Ostrowski and the police, who entered his home without his permission.

In the video, Ostrowski can be seen asking the officers to show him their warrant. Viewers see an officer telling him they have one but then forcin-

gOstrowski from his desk before the video ends.

“They did not have a proper warrant; they didn’t have any paperwork,” Ostrowski said. “I had to kind of—as passively as I could—resist them dragging me into an ambulance and throwing me in without seeing some paperwork.”

The short trip from his house to the ambulance was not without injury.

“I had bruises and a cut on my wrist from the handcuffs,” he said.

AFP asked what happened next.

“I was taken in to the local emergency room where they process you,” he explained, “and then they sent me to [Brooke Glen Behavioral Hospital] down in the Philadelphia suburbs. That was a horrific experience. It was clear that the agenda was, as expressed to me by the doctor, to get me on some kind of pharmaceuticals, and/or, if I refused or resisted, to have me placed long-term, and do it involuntarily. He specifically advocated for that in the hearing on Sept. 22.”

They held him there for seven days, two days longer than Section 302 of the MHPA ostensibly allows.

Eventually a judge signed an order denying any commitment petition. “They basically said I shouldn’t have been there,” explained Ostrowski.

AFP asked if he had any recourse, as the judge’s ruling can’t erase the fact that he had been kept there against his will for all that time.

“Of course, yes,” Ostrowski said. “This is a gross violation of all my fundamental civil rights. There’s not one that you can discount from it, [except] maybe cruel and unusual punishment.”

Alarmingly, this wasn’t the first time they came for Ostrowski, “all directly related,” he believes, “to my advocacy efforts.”

“This is the third time this year,” he explained.

Ostrowski contends that the abuse of this mental health law to truncate people’s due process rights is a clear problem.

“This is why AMERICAN FREE PRESS exists,” he said. “This is why *The Nationalist Times* exists. This is why you guys do what you do, because this stuff happens to real folks.” ★

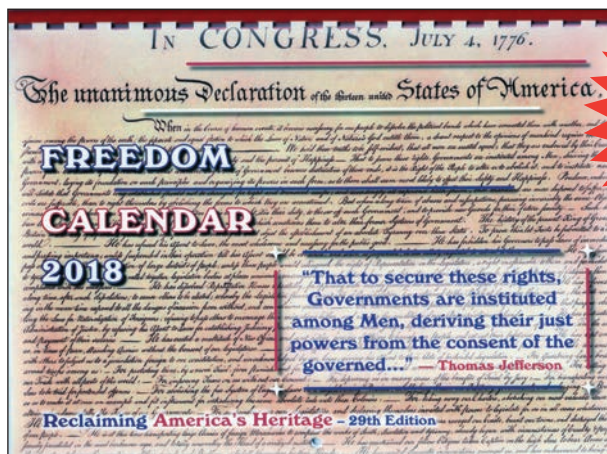

Pivotal Trial in ‘Bundy Case’ Set to Begin Mid-October

As of Oct. 10—the date jury selection is expected to begin for the high-profile Cliven Bundy trial in the U.S. District Court for the District of Nevada—the elder cattleman has just lost his bid to represent himself at trial. The denial of Bundy’s request came after he informed the court that he does not recognize the federal government’s assumed authority over land on which his family’s cattle have grazed near Bunkerville in Clark County, Nev. since the early 1900s.

Bundy’s “unpaid grazing fees”—according to the government’s view of its jurisdiction over southern Nevada—were at the center of the now-legendary April 12, 2014 “standoff” that saw Bundy, some of his sons, and scores of supporters from around the country unite to protest the Bureau of Land Management (BLM) sending armed agents to that tract of grazing land in an attempt to confiscate Bundy’s cattle for repayment of his “debt.”

This exercise of First and Second Amendment rights by members of the Bundy family and their supporters—some of whom carried guns during their protest in the open-carry state—was not about targeting federal agents, as prosecutors allege. Rather, these protestors had their sights set on the heavy-handed federal land policies that have bottled up more than 80% of Nevada and about two-thirds of all land west of the Mississippi River that is under Washington’s control.

After questioning 71-year-old Bundy, U.S. Magistrate Judge Peggy Leen ruled that he could not

fire his attorney, Bret Whipple of Las Vegas, even though Whipple filed court documents in latter September saying he had been dismissed by Bundy.

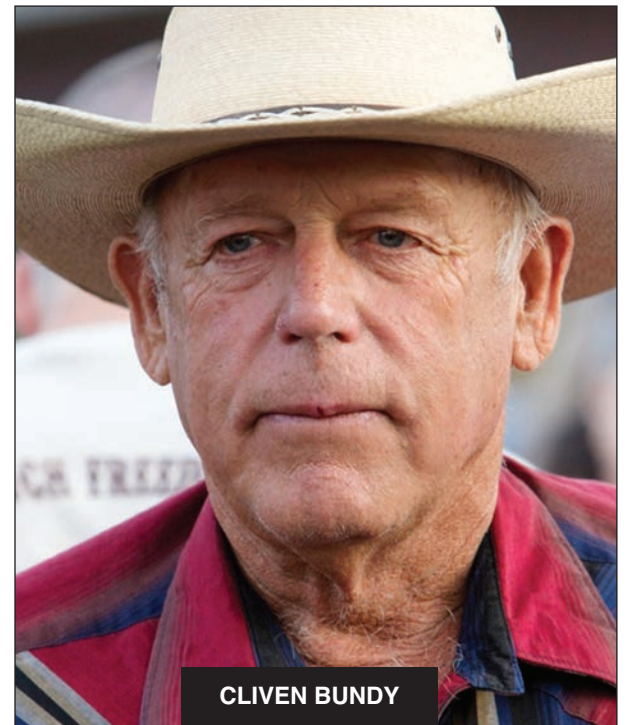
“I’m still on the case. We’re set for trial,” Whipple was quoted as saying by local media outlet “AZcentral.com” after Leen’s decision. “The court would not let him represent himself because he would not accept a court ruling that the land is owned by the federal government.”

However, noting he’s bound by legal ethics and court rules to represent his client’s wishes, Whipple evidently will appeal Leen’s ruling to Chief District Judge Gloria Navarro.

Judge Navarro has presided over the Bundy proceedings so far—which started in early February and has resulted in just two convictions and one sentencing as of this writing. Critics point out that during earlier Bundy-related trials, Judge Navarro has forbidden anyone in the courtroom from carrying pocket copies of the U.S. Constitution within view of the jury, among other acts of bias and arbitrary rulings.

Bundy remains in federal custody even while some defendants have been freed as the government’s case weakens and falters. But what’s really at stake here is the basic property rights of all ranchers. Bundy and company have become emblematic of the countless land-based livelihoods in the American West that are constantly “on trial” due to capricious rules and regulations enforced by the BLM and other agencies.

Bundy, two of his sons, Ammon and Ryan, plus Montanan Ryan Payne and Internet radio host Pete Santilli of Cincinnati, Ohio are the defendants in this upcoming trial, which, according to court observer Roger Roots, will likely require



three days for jury selection alone. The trial itself probably will begin on or around Oct. 16.

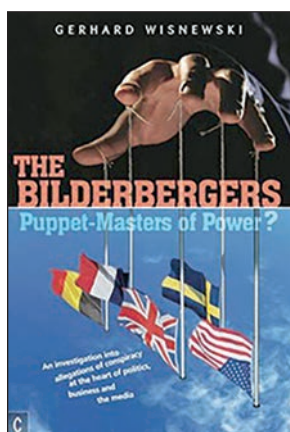
Also on trial in mid-October are two other defendants, O. Scott Drexler and Eric Parker, whose retrial ended this summer with acquittal on most charges. During the upcoming Bundy trial, Drexler and Parker will be re-tried on the remaining charges, which include “assault on federal officers” and firearms counts. These could bring stiff sentences, since the men are accused of “taking up arms” against federal agents.

Though the court has tried to silence testimony about the federal agents’ behavior, they stand accused of deplorable property abuses and of engaging in threatening actions with their weapons against bystanders as well as against the Bundys and their supporters.

Bundy and company successfully resisted the attempted cattle confiscation in the spring of 2014 with no shots fired. Supporters of the Bundys at the time held up a banner reading, “The West Has Now Been Won.” ★

Virginia Bans Electronic Voting Machines

• Other states re-evaluating easily hacked machines, considering paper ballots

Thankfully, the days of those way-too-easily hackable electronic voting machines may soon be coming to an end. For over a decade, AFP has been reporting on how easy it is to hack the computerized voting systems that have spread across the country. Now, two states are moving to ban them, citing charges of vote-stealing, frequent malfunctions, and lack of a verifiable paper trail as the reasons for terminating their programs.

In Virginia, election officials do not need to be convinced that electronic voting machines are upsetting the democratic process.

On Sept. 8, with media coverage largely limited to local and regional outlets, “The Virginia Department of Elections called for the immediate decertification of [electronic] voting equipment in Virginia, and the State Board of Elections approved the request in an effort to increase the security and integrity of Virginia’s voting systems ahead of the November [2017] election,” state election official Andrea Gaines announced in a news release.

Virginia’s decision to decertify electronic voting machines is effective immediately and “means that [electronic voting machines] may no longer be used for elections in Virginia,” Ms. Gaines emphasized. The machines have been used in 22 localities across the commonwealth.

It turns out that Virginia officials decertified

several electronic voting machine models because hackers at a gathering in Las Vegas demonstrated how they could compromise them.

“I understand why the Virginia State Board of Elections made their decision,” Falls Church Director of Elections David Bjerke responded, speaking to local media outlet WTOP.com. “The security that was involved in these, the direct-recording electronic machines, hadn’t been updated since 2004. Obviously, technology has increased since then, and the ability to hack equipment in general has increased.”

In a precinct with 10,000 registered voters, Bjerke went on to say, “I think the paper-based system is good because you do have a tangible ballot that can be used for audits, for recounts. You don’t have to trust the machine . . . Until security on the Internet feels like something the people can trust . . . paper is the future.”

Texas is also rethinking its computerized voting systems. An important lawsuit is challenging the widespread use of these machines because they do not meet requirements set by the state constitution and election code.

An enduring problem in Texas is that, according to Dr. Laura Pressley, a former Austin City Council candidate who is suing the state’s election establishment, the electronic voting machines that have been used so far cannot produce an onscreen ballot that conforms to the definition of a ballot under state law.

She told AFP on Oct. 1 that, to her delight and surprise, state Attorney General Ken Paxton filed an amicus brief in support of her suit in the Texas Supreme Court. Although the high court has not

yet agreed to hear her case, it intends to conduct what’s known as a full briefing in the next 30 to 60 days, in which it will determine whether or not to hear her case.

A key point raised in her lawsuit is that state election law and even the state constitution—in the largest state in the contiguous U.S., which sends 36 people to the U.S. House of Representatives—require that ballots must be numbered sequentially to qualify for use in Texas.

“But the [voting machines] here don’t number,” she said. “Over the last 16 years [since Texas began using electronic voting machines] these machines have not met the constitutional and legal requirement of numbering.”

Another point raised in her suit is the inability of the electronic voting machines to produce a verifiable paper audit trail, she said.

The problems associated with touchscreen electronic voting machines came to a sharp head recently in Hays County, Texas.

In the November 2016 presidential election, a single digital vote-recording card, or “ballot box,” containing votes cast by 1,800 people, was lost.

“It was gone for two months,” Ms. Pressley told AFP. “They found it in February. Eighteen-hundred real pieces of paper would be harder to lose.”

In all, 15 states use electronic voting machines. Besides Virginia and Texas, states that are in the process of re-evaluating their electronic voting machines include Rhode Island, Georgia, and New Jersey. ★

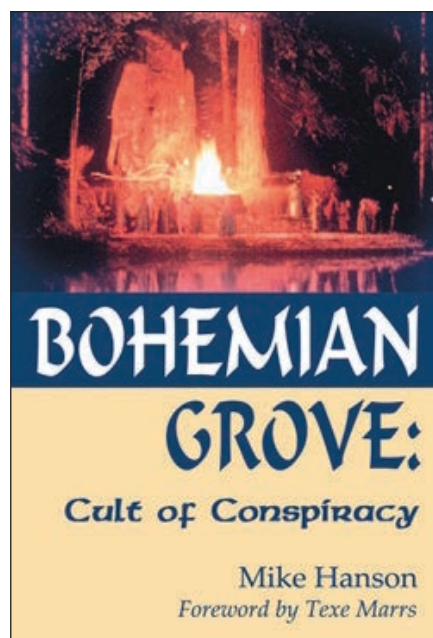

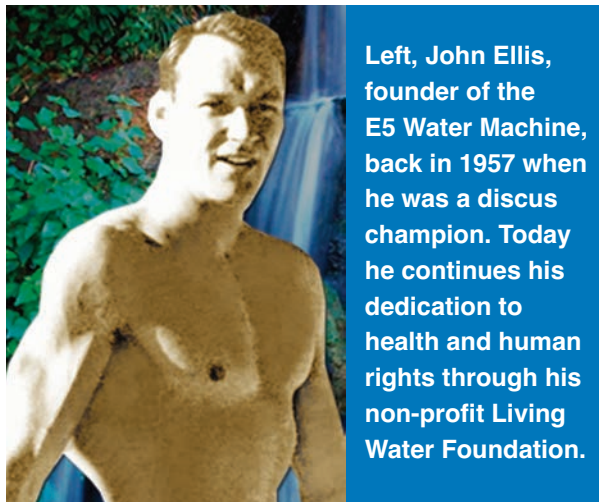

As a youngster, I remember all the sewing machines and their many friends at my grandmother's house sewing thousands of pre-die cut clothes together to keep children warm during the brutally cold English winters.

The rear room on the first floor of Thomas Paine's house (above) in New Rochelle, N.Y. is known as the “Paine Room.” On Christmas Eve 1805, a gun was fired into this room in an attempt on Paine's life. He described the incident in a letter: “Whatever the gun was charged with passed through about three or four inches below the window making a hole large enough [for] a finger to go through—the muzzle must have been very near as the place is black with powder, and the glass of the window is shattered to pieces.”

SPLC Needs to Add Itself to ‘Hate Map’

• America’s “No. 1 hate group” finds itself sued again, at odds with Supreme Court

If the U.S. Supreme Court says you are not a hater or member of a hate group, but the Southern Poverty Law Center (SPLC) says you are, which opinion would you expect the mainstream to accept?

Hint: Mark Potok, SPLC former spokesperson and senior fellow, who retired this year, said in 2007 the “press will describe [the SPLC] as monitoring hate groups. . . . I want to say plainly that our aim is to destroy these groups, to completely destroy them.”

If you answered the court, try again. The establishment unquestioningly accepts the SPLC’s claims about groups and individuals.

This may be changing, though.

The SPLC’s goal is to make money and promote an ultra-left political agenda. If you think raising children with a mother and father is best for the children, you are a hate monger, according to the group. If you think AIDS and homosexuality are linked, you are a hater. If you believe the world is run by a select group of international financiers who control governments, arms, currencies, and communications, the SPLC may have a file on you or an organization of like-minded individuals you belong to.

The good news is, the SPLC’s biased definition of “hate” has landed it in court again.

One target of SPLC bullying is mad as H-E-double toothpicks, and they’re not going to take it anymore.

Coral Ridge Ministries Media Inc., which does business as D. James Kennedy Ministries (DJKM), is suing three mainstream tormenters for defamation and libel.

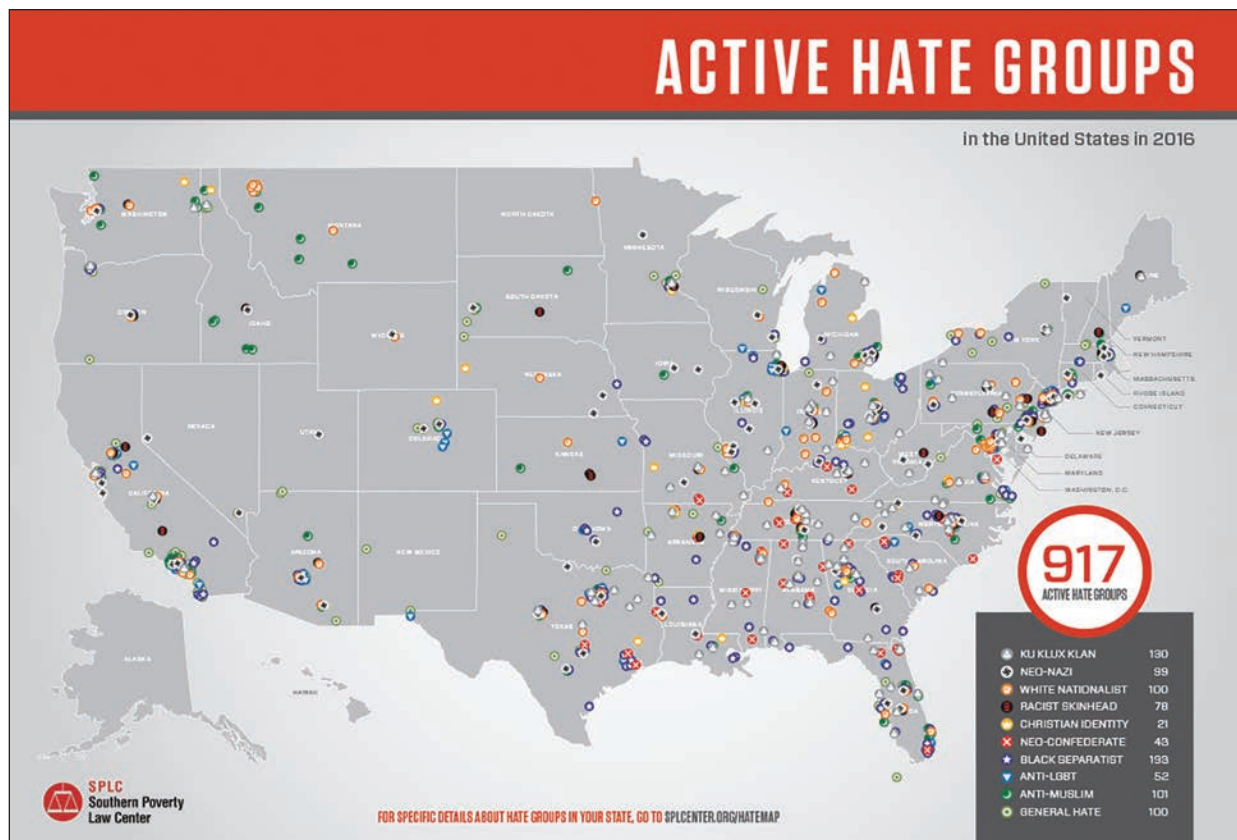
The group filed its civil suit in U.S. District Court in Montgomery, Ala. on Aug. 22. It names the SPLC, Amazon, AmazonSmile Foundation, and GuideStar as defendants.

DJKM is suing under the 1964 Civil Rights Act, which prohibits religious discrimination among other things.

GuideStar provides detailed information on non-profits to those who peruse its website. On June 15 GuideStar began reporting SPLC’s hate group designation on 46 Christian groups including DJKM. AmazonSmile, which makes small donations from a percentage of purchases to the buyers’ requested charity, pulled DJKM in July upon receiving GuideStar’s report.

“The basis for SPLC’s declaration that the ministry is a hate group is that the ministry espouses and supports biblical morals and principles concerning human sexuality,” the lawsuit says. “It was on these biblical principles that this nation was founded and built.”

When the Supreme Court approved same-sex



In 2016, according to the Southern Poverty Law Center’s famed “hate map,” there were 917 dangerous “hate groups” operating in America. The SPLC divides them as such: 190 Ku Klux Klan chapters, 99 neo-Nazi groups, 100 white nationalist groups, 78 racist/skinhead groups, 21 Christian Identity groups, 43 neo-Confederate groups, 193 black separatist groups, 52 anti-LGBT groups, 101 anti-Muslim groups, and 100 “general” hate groups. Of course, most of these are groups that simply espouse political, racial, moral or religious views that are at odds with the SPLC’s radical-left standpoints.

marriage it wrote, “Many who deem same-sex marriage to be wrong reach that conclusion based on decent and honorable religious or philosophical premises, and neither they nor their beliefs are disparaged here.” Apparently, the SPLC disagrees, since its website clearly states that being what the SPLC calls “anti-LGBT” makes you a “hater.”

Thus GuideStar and the SPLC “conspired to publish written information in interstate commerce that subjects the ministry to disgrace, ridicule, odium, and contempt, by declaring the ministry a hate group,” the lawsuit says.

The SPLC’s own definition of a “hate group” includes any group with beliefs or practices that attack or malign an entire class of people—mainly

when the characteristics being maligned are undisputable, according to the SPLC. Ironically, much of what the SPLC does is an act of hate by its own definition, but it does not include itself among its list of hate groups.

According to the SPLC, one does not need to imply or even engage in violence or other criminal activity in order to be a hate group. By the SPLC’s warped view, the fact that James Hodgkinson—the attempted mass murderer, who critically wounded Rep. Steve Scalise (R-La.) and others at a baseball practice in June—was a devotee of the SPLC has nothing to do with his motivation. And never mind that Floyd Corkins II attempted to commit mass murder in the Washington, D.C. offices of the Family Research Council (FRC), another group designated as haters by the SPLC. Corkins said his motivation was based on the SPLC’s designation of the FRC as a “hate group” and used the “hate map” that provides the addresses of those nonprofit organizations labeled as “hate groups.”

By the SPLC’s twisted logic, these two could not be haters and the SPLC would not be a hate group even though the group’s rhetoric led two men to commit acts of violence against innocent Americans. ★

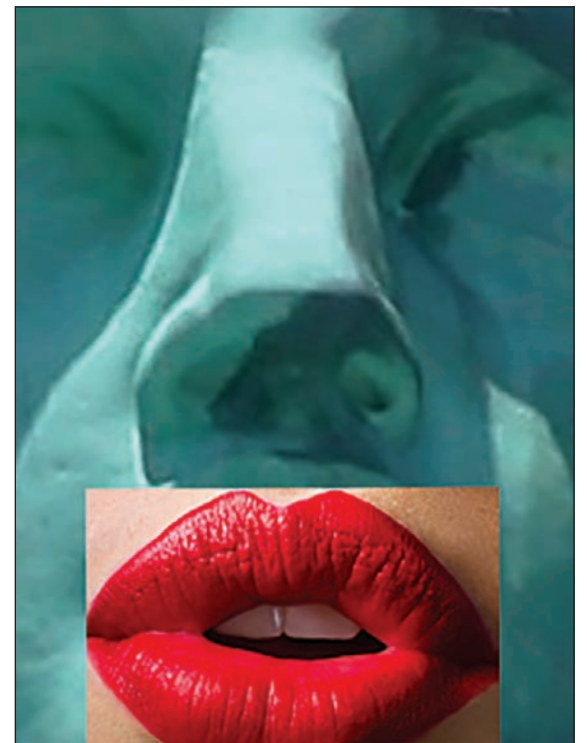

Stranglehold on Free Speech by Internet Giants Tightens

- Google, Facebook monopolies need to be broken up

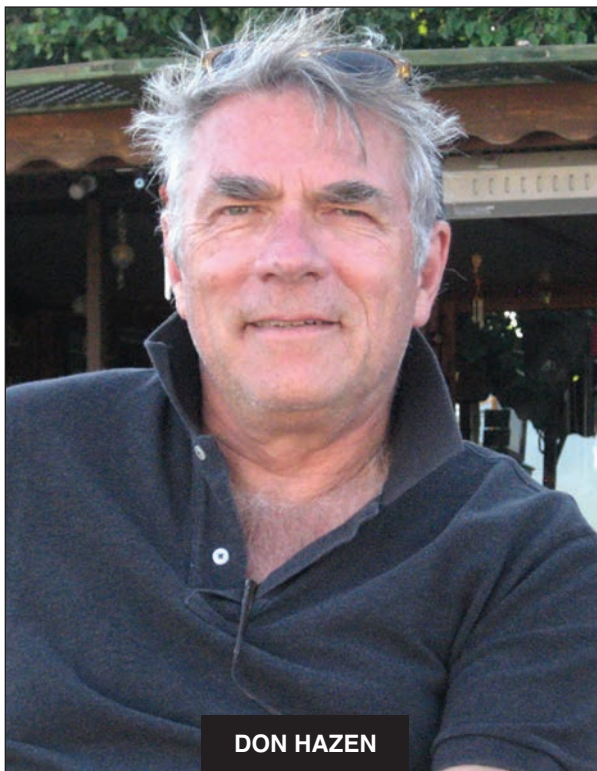
Earlier this year, Google and Facebook, two of the wealthiest and most powerful corporations in modern society, announced they were launching initiatives to combat so-called “fake news.” Google installed a new algorithm as well as feedback tools in its search engine to allow users to flag content deemed “false,” “misleading,” “bigoted,” or “hateful.” Facebook implemented similar measures, and the results have been devastating for some outlets.

Internet giant Google announced in April it would soon implement a new search engine algorithm, as part of the company’s purported goals of combatting “fake news,” blocking access to “offensive” material, and increasing “authoritative content,” said Google’s vice president for engineering, Ben Gomes. A report from the news and commentary website *BusinessInsider* on the announcement pointed out the feedback tools would allow users to help the newly hatched algorithm “learn” to discern so-called truth from fiction and better block “hateful” information.

Conspiracy-oriented websites, independent media platforms, alternative websites, bloggers, and many YouTube channels espousing political and social perspectives that span the left-right spectrum have been targeted. Countless YouTube channels and website platforms have been demonetized and even shut down, particularly following the August Unite the Right rally in Charlottesville, Va.

Some independent journalists and commentators, such as top alt-right website “The Daily Stormer” publisher Andrew Anglin, have essentially been forced off the Internet and moved their operations to the so-called dark web. A number of prominent independent journalists and commentators, such as Luke Rudkowski and Lauren Southern, have had their YouTube videos demonetized and have been purged from Patreon and other crowdsourcing platforms designed to fund independent journalism and content creation. Facebook has begun regularly suspending or deleting the accounts of anyone bucking the tyrannical dictates of political correctness or thinking critically about the narratives promoted by the controlled mass corporate media.

The crackdown and tyrannical censorship by these two Internet giants has caused concern and outrage across the political spectrum. Al-

terNet, a well-established and extremely popular left-leaning news and commentary site “dedicated to fighting white supremacy, misogyny, racism, Donald Trump, and fake news” according to Don Hazen, the site’s executive editor, has experienced the significant effects of Google and Facebook’s recent censorship efforts.

Hazen makes a powerful case that the monopoly over information held by Google—which he calls a “monopoly on steroids”—and Facebook is having a devastating impact on independent media outlets like AlterNet, which has seen a 40% drop in readership since June. AlterNet reports it lost 2.4 million readers since June as compared to readership over the past two-and-a-half years. In addition, it expects to lose \$100,000 in ad revenue.

Hazen explains to readers, “This story impacts you too, in ways you may not fully be aware of—in fact, it affects our whole media system and the future of democracy.” He perfectly summarizes the situation facing society today: “So the reality we face is that two companies, Google and Facebook—which are not media companies, do not have editors or fact-checkers, and do no investigative reporting—are deciding what people should read, based on a failure to understand how media and journalism function.”

These actions don’t affect only U.S.-based Internet users, of course. Across the pond, Britain’s *Press Gazette* has kicked off their “Du-

opoly campaign,” to “stop Google and Facebook from destroying journalism.” It “warns Google and Facebook’s dominance over the \$10 billion UK digital advertising market is squeezing news publishers out of business.” The paper quotes famed British journalist Sir Harold Evans, long-time editor of *The Sunday Times* and one of the International Press Institute’s “World Press Freedom Heroes,” who is backing the Duopoly campaign:

Facebook and Google are the [hurricanes] Harvey and Irma of journalism—and democracy. Whatever else they do, the electronic duopoly deprive millions of information and argument as surely as the series of super storms deprive millions of light, power, home and hearth. ... No one can deny the devastating effect of Facebook and Google on the viability of news organizations to investigate complexity and resist suppression. Check out the news organizations starved to death. Or watch what happens when an autocratic government shuts down independent news from newspapers and radio as Cambodia is doing.

Facebook and Google are platforms, distributors, with none of the attendant standards of the best journalism. They bring a vast carelessness to political news and social responsibility. They are not media companies, with reporters, fact checkers, editors. They don’t send reporters to Syria, don’t investigate corruption. They have no institutional memory.

In this control strategy apparently being implemented by the powers-that-be to manipulate and regulate the information to which we the people have access, the right-left paradigm is clearly of no importance. Both ends of the ideological spectrum and many in between have been hit in a move that affects people worldwide regardless of their political affiliations or philosophical leanings. ★

Bill Making Rounds Would Stifle Criticism of Israel

• Congress readies to unanimously pass Israel Anti-Boycott Act

Half of the Senate has signed on to cosponsor a blatantly unconstitutional bill that would violate Americans' First Amendment rights in the name of protecting Israel.

Over the summer, stuff hit the fan when the American Civil Liberties Union (ACLU) came out against the Israel Anti-Boycott Act (S. 720), which was first drafted and written by the American Israel Public Affairs Committee (AIPAC), the powerful pro-Israel lobbying firm.

Quoting part of the new proposal, the ACLU said the bill would prohibit any U.S. person or corporation, with respect to his activities in the interstate or foreign commerce of the United States, from "support[ing] any boycott fostered or imposed by any international governmental organization against Israel or request to impose any boycott by any international governmental organization against Israel."

The bill, which was introduced by Sen. Ben Cardin (D-Md.) last spring, would make any "support" for a boycott against Israel, such as voicing approval for actions by the European Union or United Nations against the country, punishable by minimum civil penalty of \$250,000 and a maximum criminal penalty of up to \$1 million in fines and up to 20 years in jail.

"A plain-English reading of the law makes clear that the impact is far wider, seeking to silence, deter and punish U.S. persons, like me, for exercising the basic right to free speech in calling for and supporting policies that challenge settlements and occupation," wrote Lara Friedman, president of the Foundation for Middle East Peace.

Friedman is a self-described "liberal Zionist" who says she opposes boycotts, divestment, and sanctions against Israel. However, she is also an American who treasures free speech.

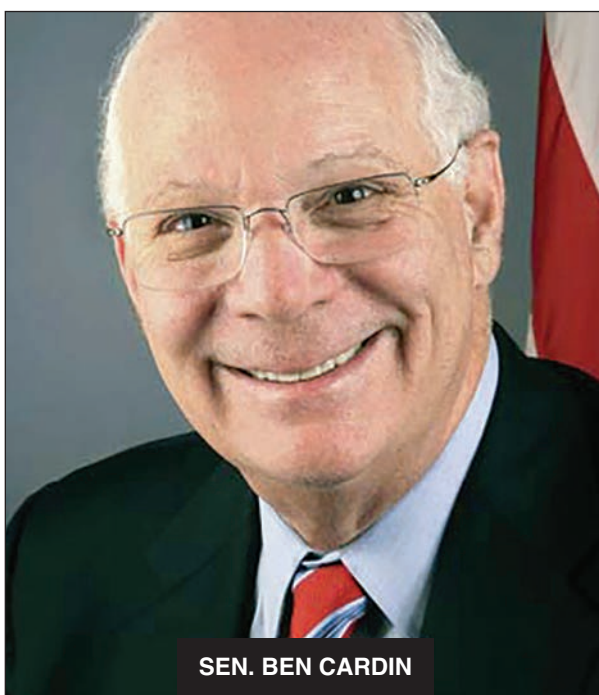
"Boycotts are protected political speech," Ms. Friedman said. Boycotts "are used by Americans—and Israelis—every day to express their beliefs on a wide range of issues."

She blames the Israeli government for practicing the occupation policies. Ms. Friedman wants to see a world in which Israel protects the rights of all peoples living within its borders, including Muslims and Christians.

"I vehemently oppose Israel's now 50-year occupation of the West Bank, Gaza, and East Jerusalem," she said. "For decades I have advocated in favor of actions that support Israel by challenging Israel's ever-expanding settlement enterprise and ever-deepening occupation."

Cardin claims that Americans have nothing to worry about.

"Nothing in the bill restricts constitutionally

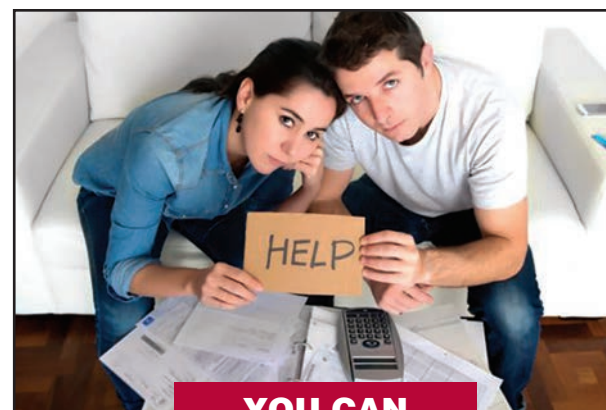
protected free speech or limits criticism of Israel or its policies," said Sens. Cardin and Rob Portman (R-Ohio) in a letter to their colleagues this summer. "Instead, it is narrowly targeted at commercial activity and is based on current law that has been constitutionally upheld."

The quote is on AIPAC's website, but that is not at all what their proposed bill says.

Washington Post contributor Eugene Kontorovich wrote, "The real question is if the statute would ever be applied and interpreted in [the ACLU's] way?" He thinks not. After all, a similar law has been on the books for 40 years, but critics are quick to point out S. 720 changes things. Most importantly it is not designed to protect Israel, it favors settlements in occupied territories. The legislation also targets international bodies, namely the European Union and UN Human Rights Commission.

One senator, Kristin Gillibrand (D-N.Y.), withdrew her support for the bill in the face of criticism after the ACLU set the record straight.

Included on the list of sponsors are Alabama's Luther Strange, who lost a primary and will not return in the next Senate, and Robert Menendez (D-NJ) who is in the midst of a federal corruption case. ★

President Calls for a Return to Sovereignty, Nationalism

If a U.S. president calls an adversary “Rocket Man . . . on a mission to suicide,” and warns his nation may be “totally destroyed,” other ideas in his speech will tend to get lost. That is unfortunate. For buried in Donald Trump’s recent address to the United Nations is a clarion call to reject transnationalism and to re-embrace a world of sovereign nation-states that cherish their independence and unique identities.

Western man has engaged in this great quarrel since Woodrow Wilson declared America would fight in the Great War, not for any selfish interests, but “to make the world safe for democracy.”

Our imperialist allies—Britain, France, Russia, Japan—regarded this as self-righteous claptrap and proceeded to rip apart Germany, Austria, Hungary, and the Ottoman Empire and to feast on their colonies.

After World War II, Jean Monnet, father of the EU, wanted Europe’s nations to yield up their sovereignty and form a federal union like the USA.

Europe’s nations would slowly sink and dissolve in a single polity that would mark a giant leap forward toward world government—Alfred, Lord Tennyson’s “Parliament of man, the Federation of the world.”

Charles De Gaulle led the resistance, calling for “a Europe of nation-states from the Atlantic to the Urals.” For 50 years, the Gaullists were in constant retreat. The Germans especially, given their past, seemed desirous of losing their national identity and disappearing inside the new Europe.

Today, the Gaullist vision is ascendant.

“We do not expect diverse countries to share the same cultures, traditions, or even systems of government,” said Trump at the UN. “Strong sovereign nations let diverse countries with different values, different cultures, and different dreams not just coexist, but work side by side on the basis of mutual respect. . . . In America, we do not seek to impose our way of life on anyone, but rather to let it shine as an example for everyone to watch.”

Translation: We Americans have created some-

thing unique in history. But we do not assert that we should serve as a model for mankind. Among the 190 nations, others have evolved in different ways from diverse cultures, histories, and traditions. We may reject their values but we have no God-given right to impose ours upon them.

It is difficult to reconcile Trump’s belief in self-determination with a National Endowment for Democracy whose reason for being is to interfere in the politics of other nations to make them more like us.

Trump’s idea of patriotism has deep roots in America’s past. After the uprisings of 1848 against the royal houses of Europe failed, Lajos Kossuth came to seek support for the cause of Hungarian democracy. He was wildly welcomed and hailed by Secretary of State Daniel Webster.

But Henry Clay, more true to the principles of Washington’s “Farewell Address,” admonished Kossuth: “Far better is it for ourselves, for Hungary, and for the cause of liberty that, adhering to our wise, pacific system, and avoiding the distant wars of Europe, we should keep our lamp burning brightly on the western shore as a light to all nations, than to hazard its utter extinction amid the ruins of fallen or falling republics in Europe.”

Trump’s UN address echoed Clay: “In foreign affairs, we are renewing this founding principle of sovereignty. Our government’s first duty is to its people . . . to serve their needs, to ensure their safety, to preserve their rights, and to defend their values.”

Trump is saying with John Quincy Adams that

our mission is not to go “abroad in search of monsters to destroy” but to “put America first.” He is repudiating the New World Order of Bush I, the democracy crusades of the neocons of the Bush II era, and the globaloney of Obama.

Trump’s rhetoric implies intent; and action is evident from Rex Tillerson’s directive to his department to rewrite its mission statement—and drop the bit about making the world democratic.

The current statement reads: “The Department’s mission is to shape and sustain a peaceful, prosperous, just, and democratic world.”

Tillerson should stand his ground. For America has no divinely mandated mission to democratize mankind. And the hubristic idea that we do has been a cause of all the wars and disasters that have lately befallen the republic.

If we do not cure ourselves of this interventionist addiction, it will end our republic. When did we dethrone our God and divinize democracy? And are 21st-century American values really universal values?

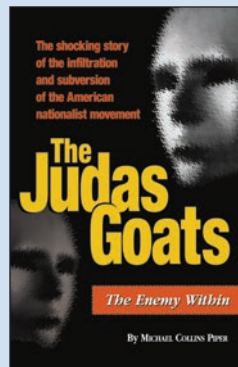
Should all nations embrace same-sex marriage, abortion on demand, and the separation of church and state if that means, as it has come to mean here, the paganization of public education and the public square? If freedom of speech and the press here have produced a popular culture that is an open sewer and a politics of vilification and venom, why would we seek to impose this upon other peoples?

For the State Department to declare America’s mission to be to make all nations look more like us might well be regarded as a uniquely American form of moral imperialism. ★

Europe Should Reject U.S. Warmongering

• Need leaders who will repudiate America's extremely dangerous foreign policy

Despite clear evidence that Washington has chosen the path to conflict with Russia and China, European governments have not objected. Poland, Ukraine, and the Baltics even seem to demand more conflict or a quicker path to conflict. The European peoples themselves have not elected leadership that is willing to repudiate vassalage to Washington and conduct a rational foreign policy toward Russia.

The German election in September was an opportunity for the German electorate to repudiate Washington vassal Angela Merkel and the Christian Democratic Union (CDU), and, to some extent, they did. But you would never know it from the news reporting.

The headlines were Mrs. Merkel wins fourth term. In the U.S., Hillary's folks emphasize that Trump lost the popular vote, but Mrs. Merkel lost it by 70%. Only three Germans out of 10 voted for her. Her party's vote fell from 41.6% in the previous election to just under 33%.

Mrs. Merkel's coalition partner, the Social Democratic Party (SPD), also suffered a vote decline that resulted in the SPD refusing to enter into another coalition government with Mrs. Merkel. This means that Mrs. Merkel has to go to the Free Democratic Party (FDP), which got 10.7% of the vote and to the Greens, which got 8.9% of the vote. That coalition produces 52.6% from which a government can be formed. Mrs. Merkel's "win" was such a defeat that she is perhaps on the way out.

Where did the votes lost by Mrs. Merkel's party and coalition partner (SPD) go? They went to a new party that stands for Germany, and not for Washington, not for the refugees from Washington's wars, and not for conflict with Russia. This party is Alternative for Germany (AfD). It is now Germany's third largest political party with 12.6% of the vote and 94 seats in the German legislature.

As the party is against the massive Muslim immigration supported by Mrs. Merkel and against



Although Angela Merkel won the race for prime minister, she did so with only 30% of the vote. Many of her supporters switched allegiance to the Alternative for Germany Party, which could be called a "Germany-first," nationalist political party.

Washington's policy toward Russia, the AfD was promptly branded "far-right," a term that is saddled with Nazi connotations. In other words, if you stick up for Germany and the German people, you are a Nazi.

The German people have been so brainwashed by Washington since World War II that Germans have no positive conception of themselves, only guilt and fear of anything said to be "far right." Yet, the third largest vote went to the "far right" party.

Clearly, in Germany, a political party that does not want to be in conflict with Russia or to be the dumping ground for the human residue of Washington's wars in the Middle East and Africa is defined by prostitutes in the U.S., Europe, Canada, UK, Australia, and even in English language Russian news services such as Sputnik as "far right."

Although it is encouraging to see 12.6% of the

German people wake up, the vote seems to be based less on avoiding the looming conflict with Russia and more on the average German's fear that his nation will be expected to accommodate millions more refugees created from Washington's unending Middle East meddling. How does one judge these two threats to Germany?

Germany does not exist, nor does Europe, if Washington brings nuclear conflict to the world. Germany does not exist if the country is overrun by other peoples fleeing from Washington's atrocities in the Middle East and Africa.

In the first case, there is nothing left of Germany. In the second case, there is a country that is no longer German.

As far as we have evidence, Western Europe is held captive by Washington and will go to its destruction rather than dissociate from Washington's foreign policy. But there are signs of hope in parts of Eastern Europe.

Unlike Germany, some of the Eastern European countries have refused to accept their quota of refugees from Washington's wars. The EU Commission itself accepts its vassalage function as a dumping ground for Washington's "collateral damage," the euphemism Washington applies to the casualties of its wars for profits and hegemony, and is suing the EU members who refuse their quotas of refugees. The former president of the Czech Republic, Vaclav Klaus, responded to the EU's determination to impose immigrant quotas on the Czech nation by declaring: "The time has come to start preparing the exit of our country from the European Union."

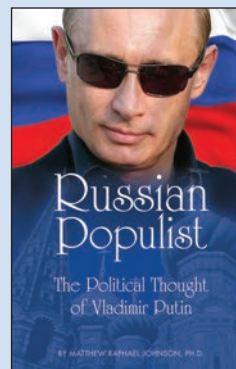
The dictatorial character of the EU is a good reason for every member to leave it. Countries already subjected to looting by American global corporations and financial entities have no spare money with which to support the victims of Washington's illegal wars. For the EU to try to force Washington's external war costs upon its members proves how much of a tool of Washington the EU really is.

The more important reason for Eastern Europe, or that part of it that still has the capability of independent thought, is to avoid nuclear armageddon. Washington's quest for world hegemony is driving the world to the third, and final, World War. Eastern European governments could prevent this looming war by breaking from their vassalage to Washington and forming a neutral buffer between NATO and Russia.

Such realistic behavior on the part of Eastern Europe could possibly even wake up Germany, France, and Great Britain to the extreme danger that they face as Washington's vassals. ★

Top Israeli Official Issues Death Threat to Putin?

“If Putin wants to survive” he had better get out of Syria. The apparent death threat was delivered by Israeli Justice Minister Ayalet Shaked at Herzliya’s International Institute on Counterterrorism Conference in Israel. She added that if Putin didn’t get the message, “We will do what we need to do.”

Ms. Shaked’s shocking statement raises serious questions. Is Ms. Shaked in her right mind? Was her threat to Putin authorized or tolerated by her boss, Benjamin Netanyahu? When a high-level government official threatens the life of a foreign head of state, isn’t that tantamount to an act of war? And why are Ms. Shaked and the Israeli government so angry at Putin?

Ms. Shaked may be crazy as a loon, but so is the rest of her country, so she fits right in. On July 1, 2014, Ms. Shaked called for the destruction of the entire Palestinian people, “including its elderly and its women, its cities and its villages, its property and its infrastructure.” She called for the murder of Palestinian mothers and their children, whom she described as “little snakes.”

After issuing her call to genocide, Ms. Shaked was not fired. Instead, she was promoted to justice minister. Now she presides over a “justice” system that allows or even encourages IDF soldiers to shoot Palestinian children for sport, as described in “Gaza Diary” by Chris Hedges:

“Yesterday at this spot the Israelis shot eight young men, six of whom were under the age of 18. One was 12. This afternoon they killed an 11-year-old boy, Ali Murad, and seriously wounded four more, three of whom are under 18. Children have been shot in other conflicts I have covered—death squads gunned them down in El Salvador and Guatemala, mothers with infants were

lined up and massacred in Algeria, and Serb snipers put children in their sights and watched them crumple onto the pavement in Sarajevo—but I have never before watched soldiers entice children like mice into a trap and murder them for sport.”

It is one thing for heavily armed Israeli soldiers to murder unarmed women and children for sport. It is another thing for Israel’s government to contemplate the assassination of Putin. Unlike the women and children of Occupied Palestine, Putin has a very serious security detail. He also has more than enough nuclear weapons to turn Israel into a glass parking lot.

Was Ms. Shaked’s statement serious? It seems she has not been rebuked or disowned by Netanyahu or anyone else in authority in Israel. So Putin has no choice but to consider the Israeli government his mortal enemy.

Why is Israel so furious at Russia? Because Russia has thrown a monkey wrench into the neocon-Zionist plan to overthrow the Syrian government in order to start a war with Iran. By helping President Bashar al-Assad and the Syrian state he heads, Putin has drawn a line in the sand. No more regime-change operations.

Israel is dedicated to smashing its neighbors into pieces, in accordance with the Oded Yinon plan to balkanize the region. Israel wants Iraq smashed into three pieces: a Shia Arab south, a Sunni Arab center, and a Kurdish north under Zionist control. Israel also wants Syria smashed into even more pieces, including an Israeli-dominated Kurdish statelet.

But Putin stands in the way. He saw what happened in Libya, saw it about to happen again in Syria, and said, “Not on my watch!”

The Zionists are enraged. They want the American military to do their dirty work for them—even if it means supporting ISIS, fighting the Russians, and risking World War III.

Many thoughtful people voted for Donald

Trump because they believed that, unlike Hillary Clinton, Trump would make peace with Russia and stop supporting ISIS and other Israeli-backed terrorists in Syria. A vote for Hillary, many Trump voters reasoned, would be a vote for World War III, whereas a vote for Trump was a vote for ending Obama’s war on Syria and letting Assad’s government rebuild the country.

It hasn’t worked out that way. While Trump did end official U.S. aid to CIA-backed Syrian “rebels” (i.e., ISIS and al Qaeda-affiliated, pro-Israel terrorists) he did not end a much larger Pentagon program supporting the same terrorists. Worse, he has increased U.S. involvement with radical Kurdish separatists who are fighting the Syrian, Iraqi, and Turkish governments (once again, on behalf of Israel).

And worst of all, Trump has apparently allowed the U.S. military to assassinate three Russian officers, Gen. Valery Asapov and two colonels. The killings came during a U.S.-backed Kurdish-Israeli invasion designed to steal Syria’s oil-producing region from Russian-backed Syrian forces.

If high-ranking Russians keep getting assassinated by or for Israel, there will be hell to pay.★

Russia Celebrates Closing of Weapons Plants

Russia has closed its last chemical weapons plant allowing it to seize the moral high ground over the U.S. and its allies. Russian President Vladimir Putin was quick to applaud his country's move, pointing out it no longer had any chemical weapons while the U.S. remained the world's largest hoarder of them. In fact, he went so far as to express dismay that the U.S. has blown through three deadlines set by the Organization for the Prohibition of Chemical Weapons (OPCW) to get rid of these types of weapons, claiming somewhat ironically that it lacked the funds to destroy them. For Putin, that argument was "odd" considering America's status as a superpower.

While he has indeed a point, the issue is much more complex. In past decades, Russia, too, failed to observe deadlines to destroy its chemical stocks. Nevertheless, Putin can now say confidently that Russia has fulfilled its treaty obligations in respect of its chemical stockpiles while the U.S. and some of its closest allies have made no efforts to follow Russia's lead. There is every reason to believe that Israel continues to run research and development facilities to create and test new forms of chemical components that could be used in missiles and artillery shells. Israel is also known to have used chemicals to assassinate some of its enemies, especially members of Hamas and the PLO.

The U.S. meanwhile has somewhere in the region of 3,000 metric tons of chemical weaponry stored at facilities in Kentucky and Colorado and has almost, according to its treaty obligations, another 10 years to ensure they are destroyed.

Putin's move, however, highlights the fact that, while Washington condemned the Assad government in Syria for allegedly deploying sarin gas

against ISIS and al-Nusra, it ignored evidence that Turkey, a NATO ally, secretly supplied sarin and mustard gas to Islamic militants in Syria to enable them to carry out false-flag attacks that could be blamed on Assad. Those gas attacks were designed to encourage the U.S. and its allies to unite to remove the Assad regime from power.

Turkey has a large supply of chemical weapons and so, too, has Egypt. In fact, Egypt continues to manufacture such weapons and holds sizeable stocks of them. When Egypt inserted itself into the civil war in Yemen in the 1960s it deployed bombs

and artillery shells filled with mustard gas and phosgene, gases that were used to slaughter soldiers on the battlefield and in the trenches in World War I. Phosgene is colorless, smells like a plant, and is made from a range of industrial components.

Japan was one of the most prolific users of chemical weapons. After the Sino-Japanese War of 1931-1945, Japan left 700,000 chemical munitions scattered across many parts of China. Despite efforts to clean them up, a high percentage of them have remained in place and cost lives annually. China claims, like Russia, that it has no interest in building or maintaining a chemical arsenal.

It is worth mentioning that biological—not chemical—weapons pose the greatest threat to mankind. Few of the major nations will admit to having active scientific centers for storing, developing, and weaponizing known pathogens. Unlike chemical weapons, research in the field of biological warfare can be conducted in laboratories that function as research facilities for combatting diseases such as the Ebola virus and smallpox. Some of these centers, scattered across the globe, are controlled by secret military outfits and intelligence agencies.

Their real task is to find ways to weaponize deadly viruses that can be spread across populations with almost no effort. The frightening terror presented by biological weapons is that they can deliver a virus that has the capacity to encircle the globe within weeks and eliminate tens of millions of people in a very short space of time. Like influenza, a weaponized virus could, with international travel, strike at every country. ★

Pentagon Waste Must Be Curbed

• If Trump wants to make America great again, he needs to audit military spending

In early September, the Department of Defense (DoD) inspector general released a report about a troubled DoD counter-narcotics initiative. The key aspect of the program, Global Discovery, is a modified ATR 42-500 aircraft. The aircraft is equipped with sophisticated equipment, designed to help eradicate the substantial heroin production taking place in Afghanistan. Thanks to a lack of oversight, the American taxpayers now have the world's most expensive paperweight sitting in a warehouse in Delaware.

During the seven-year program, DoD personnel purchased equipment, contracted for modifications to the aircraft, modified the aircraft, subsequently had the modifications removed from the aircraft, and returned the aircraft to its original form, but without the required Federal Aviation Administration (FAA) flight certification. Consequently, the DoD received no benefit for its years' of work, and \$64.8 million in funds were wasted.

This may seem like a lot, but the Pentagon is famous for wasting money.

In 2008, the Pentagon purchased 20 Italian G-222s for the Afghan air force. The planes were supposed to serve the cargo and transit needs of the Afghan military. The aircraft cost the U.S. taxpayers \$486 million.

Almost immediately a problem surfaced.

sold as scrap metal for a whopping \$32,000.

When the Pentagon was completed in 1943 it was the world's largest building. Since then the DoD has had a love affair with buildings, especially spending millions on useless buildings. One of the more idiotic examples is a multi-million dollar natural-gas filling station in Afghanistan.

The Special Inspector General for Afghan Reconstruction (SIGAR) found what appears to be the world's most expensive gas station, and—you guessed it—you paid for it. The project was originally a \$3 million contract, even though a similar station is only \$500,000 if Pakistan did it, but it quickly ballooned up to \$43 million thanks to poor planning, cost overruns, and overhead, according to SIGAR.

The wasteful spending is not only on objects like planes and buildings, it is in the DNA of the DoD. In 2015, a report released by the Defense Business Board and consultants from McKinsey and Company showed the Pentagon could save \$125 billion over the next five years by getting rid of bureaucratic waste. The report showed this

Afghanistan is covered in a fine powder dust, a substance that does not mix well with aircraft. The aircraft were constantly breaking down and required more maintenance and spare parts than originally requested.

So much maintenance was required, from January to September 2012, the aircraft were only able to fly 5% of their expected hours. By August 2014, the spare parts that could be sold were sold, and the rest of the aircraft were destroyed and

could be done without firing one employee or reducing the size of the active duty force.

What a great idea. Surely the Pentagon immediately instituted the ideas and put the savings towards military readiness?

Nope. The Pentagon buried the report.

This is more alarming than any gas station because it shows an institutional problem with the Pentagon. It shows the DoD has no problem with waste at its core. It is time for the president to change that, and a law passed in 1990 can help.

The Chief Financial Officers Act of 1990 instructs all government agencies to have an audit conducted by an Inspector General or independent accountant. However, the DoD has never complied with the law, and Congress keeps giving the Pentagon a free pass.

When the Pentagon did turn over some financial statements, the records were in such disarray the inspector general declared them "un-auditable," stating, "DoD OIG audits of those financial statements for FYs 1991 through 2001 identified pervasive and long-standing material weaknesses, which caused those financial statements to be un-auditable."

The president is addressing the issue by pushing reform within the Pentagon. Trump's appointee to comptroller for the Pentagon agrees

wholeheartedly with the president. David Norquist even went so far as to call for an audit of the Pentagon during his confirmation hearing, and he is pushing to move forward with the plan to audit.

Some have put the cost of an audit at \$200 million believing it is too expensive. This is a drop in the bucket when you consider the Senate just passed a \$700 billion DoD budget. The cost to conduct the audit the first time would be a fraction of a fraction of a percent. And, once the systems are in place to conduct the audit, it would get cheaper to conduct an audit in the future.

If an audit can identify only 10% of fraud, waste, and abuse in the DoD, that will give the president another \$70 billion to put toward the warfighter. That seems like very reasonable return on investment.

The President is the Commander in Chief. It is time for him to give a direct order to Secretary of Defense James Mattis for the Inspector General to conduct an audit of the Pentagon. It is reprehensible the U.S. military has lost more troops to training accidents than combat deaths this year, and that is directly linked to a lack of funding. Auditing the Pentagon is not only a way to prevent fraud, waste, and abuse, it will save lives. ★

among others—as being at least partially responsible for the serious injuries inflicted upon the officer during protests following the death of Sterling. During the protests, the officer was struck in the head by a rock hurled by BLM activists, severely injuring his face, jaw, and teeth.

In late September, U.S. District Judge Brian Jackson, who was appointed by Barack Obama in 2009, dismissed the unnamed officer's suit, declaring BLM to be a social movement rather than an organized entity capable of being sued.

“Although many entities have utilized the phrase ‘black lives matter’ in their titles or business designations, Black Lives Matter itself is not an entity of any sort,” Jackson opined in his 24-page ruling dismissing the lawsuit. Jackson argued that Mckesson and the other BLM leaders “solely engaged in protected speech” during the protests that turned violent.

“Plaintiff has pleaded facts that merely demonstrate that Mckesson exercised his constitutional right to association and that he solely engaged in protected speech at the demonstration that took place in Baton Rouge on July 9, 2016,” Jackson stated in his ruling.

“I’m happy that this was dismissed and that the judge ruled that the movement can’t be sued because the movement is not an entity,” Mckesson said in an interview with NPR following the judge’s ruling. “It wasn’t started by any one, two or three people.”

Billy Gibbens, Mckesson’s attorney, argued in court proceedings that because BLM is simply a social movement, “there isn’t a person who is responsible for it, or the leader or the founder of it.”

Ms. Grodner countered that BLM was an “unincorporated association” and should be held liable for her client’s injuries sustained during the violent protests.

“It’s organized. They have meetings. They solicit money. They have national chapters,” Ms. Grodner argued in court. “This shows a level of na-

tional organization.”

According to GuideStar, which specializes in reporting on non-profit organizations, there are 35 different non-profit organizations associated with the Black Lives Matter brand comprising various state and national non-profit entities. Additionally, three individuals—Patrisse Cullors, Opal Tometi, and Alicia Garza—are identified as founding members of the official #BlackLivesMatter Organization, which has numerous chapters across the country. Mckesson is also regularly identified by major media outlets as a national spokesman and leader of the organization.

On its official website, BLM describes itself as “a chapter-based national organization working for the validity of black life” that seeks to “(re)build the black liberation movement.” The organization affirms the lives of all blacks, including “black queer and trans folks, disabled folks,

black-undocumented folks, folks with records, women, and all black lives along the gender spectrum,” demonstrating its radical leftist agenda. It alleges that “black people are intentionally left powerless at the hands of the state” and that “black lives are deprived of [their] basic human rights and dignity,” when in reality blacks are often elevated in American society and popular culture, while also receiving special privileges such as affirmative action and other state-sanctioned benefits.

Ms. Grodner’s other lawsuit, filed on behalf of East Baton Rouge Parish sheriff’s deputy Nick Tullier, who was severely injured when he was shot three times in an attack by former Marine Gavin Long, is still pending in court and is being reviewed by Jackson as well. ★

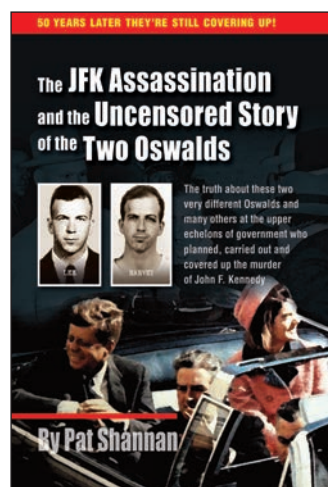

Group Seeks to Exonerate Oswald, Ruby

• Oswald Innocence Campaign thinks Jack Ruby was victim of frame-up, as well

While inherent in the moniker for the Oswald Innocence Campaign (OIC) is a fight for the historical innocence of Oswald in the 1963 killings of both President John F. Kennedy and Dallas Police Officer J.D. Tippit, the cause du jour for the OIC in 2017 is the innocence of Jack Ruby.

The OIC was created in 2012 by Ralph Cinque and James Fetzer to push the controversial theory that the famous photograph taken by Associated Press journalist James Altgens shows Oswald as the “man in the doorway” of the Texas School Book Depository as the Kennedy motorcade continued down Elm Street. Because shots rang out seconds later, if it is Oswald pictured in the doorway, then he would be exonerated from his “lone nut” position as the sixth-floor shooter.

Five years after its creation, the OIC has also taken up the case of Oswald’s reported assassin, Dallas night club owner Jack Ruby. Ruby was also associated with mob activities as well as earlier gunrunning operations in Cuba. The Warren Commission claimed that Ruby acted alone and was not a part of a larger conspiracy, the House Select Committee on Assassinations admitted that Ruby had mob ties, and many researchers have since called Ruby’s assassination of Oswald as a mob hit.

Cinque, the OIC’s administrator, points to the Pulitzer Prize-winning Robert Jackson photo of Ruby shooting Oswald, taken directly after the shot was fired, as well as the Jack Beers photo, which was taken a fraction of a second before the shot. Both show Ruby, stocky in build and wearing a fedora, from behind and to the left. Ruby, Cinque claims, also appears inches shorter than Oswald (5’9”) whereas, in reality, Ruby was only a half-inch shorter than Oswald.

In the Beers photo, Ruby is clearly wearing light-colored socks. In his mug shot, however, Ruby’s slightly pulled up pants reveal dark-colored socks. Dallas officials stated that the reason for the change was that Ruby was ordered to change clothes immediately after being taken to the fifth floor, the location of the jail.

The police order for Ruby to undress and submit each piece of clothing to authorities, Cinque points out, is in contrast to Oswald having only his shirt taken after his arrest. Cinque suggests that if Oswald had been allowed to keep his shirt, it could have been compared to the one worn by the man photographed in the doorway of the Texas School Book Depository.

Not all researchers on the OIC are on-board with Cinque regarding Bookhout as Oswald’s assassin. In fact, a majority of researchers have openly chided Cinque for the Bookhout theory.

The JFK assassination research community is a large community of factions. No theory will go without scrutiny, detailed analysis, or even attack. With such a unique theory as that of Bookhout and Ruby at the forefront, the OIC risks losing associations and respect within the tense community of many experts.

Cinque, like Fetzer, is unmoved and arguably fueled by the criticism. He still speaks and writes publicly about Bookhout today. ★

Cinque recently called the Dallas city jail, which confirmed that officers currently do not confiscate clothing, as most detainees are either bonded out or quickly transferred to the county jail.

Cinque names FBI agent James Bookhout as having been the stand-in for Ruby. To explain a hairline similar to but not exactly like Ruby’s, Cinque states that Bookhout is wearing a toupee under the fedora.

After Oswald cries out, the shooter is then swarmed by police officers and authorities at the scene. Neither the shooter nor the officers respond aggressively. The swarming, to proponents of the Bookhout theory, was to hide the shooter’s identity from cameramen, all of whom were placed in a funnel shaped gathering behind the shooter. Though the shooter had just assassinated the country’s most valuable prisoner, the officers chose not to treat him aggressively and chose not to handcuff him. What appeared most important was to get him out of sight from the cameras.

Cinque does not dismiss the idea that Ruby was in the basement of the Dallas police station that day. He believes Ruby arrived at least 30 minutes before reporters, who were allowed into the basement only minutes before Oswald was to be transferred. It was then—before the attempted Oswald transfer—that Ruby was jumped by police officers claiming that he had shot Oswald. Confused, Ruby repeatedly told officers that he had not shot anyone. Cinque believes that after the shooting Ruby was actually brought down from the fifth floor and paraded before the cameras.

Ruby later confessed, yet he retracted those statements later, stating that his first attorney had urged him to confess early. Ruby, known to abuse alcohol and drugs as well as having been a sufferer of extreme sleep deprivation, claimed to have experienced frequent blackouts.

NFL Takes Knee to Nation's Dismay

What started out in 2016 as a protest by one National Football League (NFL) player against “racism” and alleged “police brutality” directed toward American blacks has wound up costing the sports association a lot of money. But don’t start shedding any tears for the NFL yet. They’re still rolling in dough.

Founded in 1920, the NFL was a 501(c)(6) non-profit, exempt from federal income tax. Following public criticism in 2015, however, it gave up its tax-exempt status. The criticism was well-founded. Last year, the 32 teams that make up the NFL shared in a record \$7.8 billion in revenue, an increase of nearly 10% over the previous year.

The NFL is considered to be the most profitable professional sports league in the U.S., thanks in part to the billions of taxpayer dollars that local governments spend on teams as well as the tax breaks worth hundreds of millions for the teams, the league, their sponsors, and the fans.

As of 2015, since 1997 20 new NFL stadiums had opened, assisted by \$4.7 billion in taxpayer funds. Perversely, NFL teams get tax breaks for this as well, as stadium construction is financed using tax-free municipal bonds, which were originally created by Congress to help fund roads and schools.

Just how much does the NFL cash cow squeeze out of the lowly American taxpayer for just this scheme? About \$3 billion over the life of the bonds.

While the average fan will shell out around \$100 on game day, NFL teams sell between \$1.5 billion to \$2 billion worth of luxury and high-end club seats a year. Just one suite can run as much as \$750,000 per season, and since almost all suites and club tickets are bought by corporate clients, they will be able to write off the cost as an entertainment expense.

It gets even uglier for the paycheck-to-paycheck

American worker. Corporate sponsors spend around \$200 million each year to place their logos on city-owned stadiums, but the teams keep all those profits, not the cities. Worse for Joe Six-Pack, the corporations are allowed to deduct all of those expenditures as marketing expenses.

The players of the NFL, average age around 27 and 70% black, are incredibly well-compensated, especially considering that most of them only work from late August to late December, with an average career length of just over three years. Significantly, over 80—all black—current players have been arrested for domestic violence, with 132 arrested multiple times since 2000. An NFL player's average salary is \$1.9 million per year, with a median salary of

\$770,000.

League commissioner Roger Goodell was compensated \$150 million in salary and bonuses during his first eight years in that position. His income is now a closely guarded secret since the NFL dropped its tax-exempt status. Where he earned \$34.1 million in 2014, his income for 2015 and 2016 may have reached \$40, \$50, \$60 million or more; only Goodell and his closest compatriots know for sure.

The current contempt for this nation's flag and heritage had its beginnings on a bench.

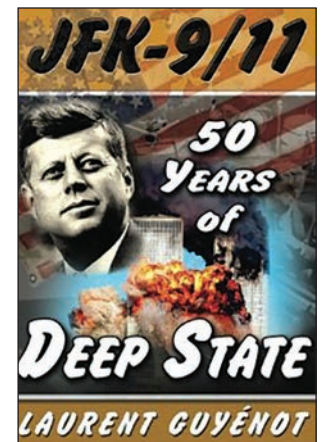

ing those games, his “protests” were largely ignored, until the third preseason game on Aug. 26, when his disrespect was noticed.

“For the 29 states we operate in, this isn’t much to them, but it’s a lot to us,” CEO Allan Jones wrote on his Facebook page, stating he “will not condone unpatriotic behavior.”

Viewership is suffering as well.

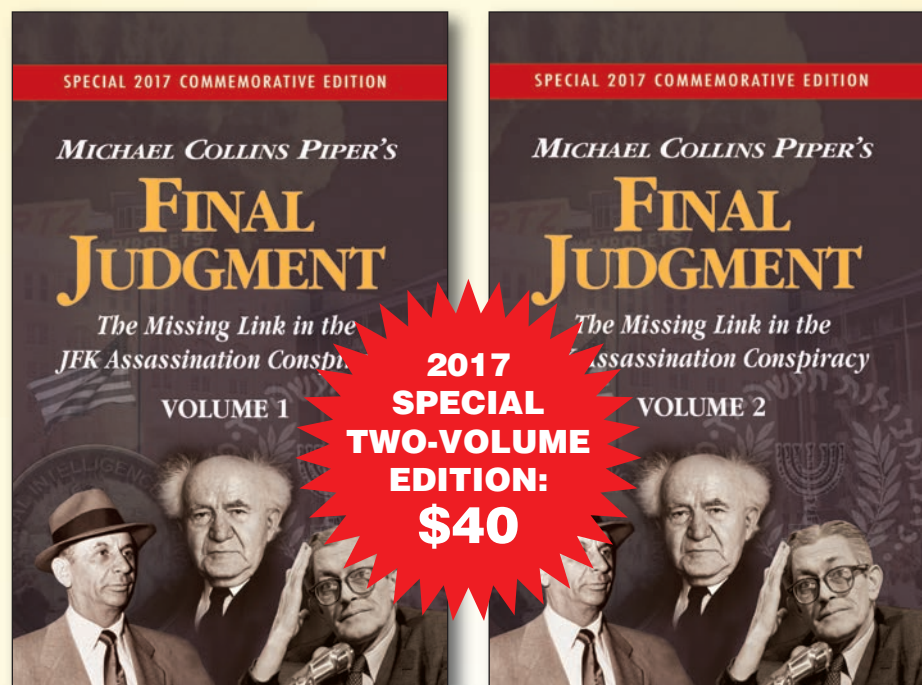

City Insider Reveals Why Lee Yanked

• Sandra Crenshaw explains how bevy of cultural communists worked to get general's statue pulled

Sandra Crenshaw, a black, 65-year-old former Dallas City Council member, who's part of a predominantly black group that formed to protect Confederate monuments, is steaming mad when she thinks about the recent assault on a statue in her beloved city. On Sept. 14—at a cost of almost a half-million dollars—a crane unceremoniously hoisted the Gen. Robert E. Lee statue that President Franklin D. Roosevelt dedicated in 1936, renaming Oak Lawn Park to Robert E. Lee Park.

"I was just devastated with these efforts to take down these Confederate statues," Ms. Crenshaw told this newspaper in an exclusive interview.

Ms. Crenshaw said, "We're just shocked at the conversation and the hatred and the protest rallies that we are seeing here in Dallas, and we keep asking where this is coming from."

She's surprised that the ostensibly organic protests to remove anything Confederate spread to her city, because no groups other than Dallas's large gay community, which has a long history of opposing the Lee statue, came out to protest. Ms. Crenshaw explained that denizens of Dallas had no need to protest the statue in what she sees as a racially fair city.

"When I was on the park board," Ms. Crenshaw began, "and we had a slave cemetery without markers, we asked for support to build a monument; it's the only one in the country. We asked to change the name of the recreation centers—which were named after geographical locations—after African-Americans. So we have federal buildings, an African-American museum at the state fair that rivals any other in this country, a beautiful memorial that sits to the left of a Lee Confederate statue on the state capitol that is just beautiful. Texas is the first state that made Emancipation Day for the blacks a state holiday. We have a Martin Luther King statue, a Rosa Parks statue, tributes to Malcolm X, and so I just don't know how you could be a much fairer city."

Ms. Crenshaw explained why the gay community has had their sights on the general for 25 years. "In 1992—when I was on the park board—that was only the second time since 1936 that there had been any desire to take down the Confederate statue in Lee Park," she said, "and it was the gay community then." That desire was generated, she explained, by the board's denial of a request to put up an AIDS memorial in the park.

Another event stirred the gay hornets' nest as well.

"Lee was a Southern, Christian person," Ms. Crenshaw explained, "and they used to have an annual Easter symphony [in the park]. The people

who lived in that area went to the park department and said they were concerned about bringing their families there for a Christian event and their children having to watch two men kiss. They were very upset about that, and they didn't know that the park director was a gay person, so the park director let some people know what they were saying. Some on the police department who were angered by this used a gay vice prostitute and caught him in the park having sex, and he got fired [in] a very public firing."

Since no protests had materialized over any of the Confederate monuments in Dallas in spite of the Charlottesville, Va. mayhem and removal of monuments in other locations, the city's gay community apparently decided to strike while the iron was hot. They had to overcome, however, a law that had been on the books for over 30 years to protect the monuments.

"In the 1980s," Ms. Crenshaw explained, "[Dallas] designated all of these statues as art, and to remove them, you had to go through a decommissioning process. So, when Charlottesville, Va. went off like it did, the [Dallas] mayor and the city council panicked, and they said, 'We better use an emergency clause to go ahead and take this statue down before any harm comes to it.' So when we filed for a temporary restraining order to keep the city from taking it down, the judge asked [the mayor and city council], 'What is your emergency purpose for you to circumvent your own public policy that allows the people to vote on whether or not they want to decommission this piece of art?' And they could not give any evidence of any threats—no call-ins, no pickets, no protestors.

"The next thing," she continued, "there were 10 or 15 African-Americans, all the TV media's out

there, and they've got this rope around Lee's neck trying to pull the statue down, but there were thousands of members of the gay community, all white people, standing around."

Ms. Crenshaw gave her take on these white agitators, who have made up the clear majority of protestors at anti-Confederate events across the country. "I get irate, I get angry, when I see an Anglo person walking around with a sign that says, 'Make the white race afraid again,' or wearing t-shirts that say, 'Black lives matter,'" she said. "The African-American community that lives here, we don't even see that statue."

The so-called protestors then petitioned the court, claiming the "protest" indicated there was indeed a threat to the statue, and got the temporary restraining order removed, leading to removal of the statue.

Ms. Crenshaw and her group may have the last laugh, however.

"When they took the Lee statue out of the park," she explained, "the gays and all of these students, they saw that as a victory for them, not knowing that it was only an emergency clause that allowed them to remove it, to protect the value of it. But it's coming back up. They can take Lee out of that park but you can't take Southern heritage out of Texas. This is a fight that we have got to fight. This is a fight that we have got to win, because what comes next?"

The city council will vote in late November on whether and when the Lee statue will be restored to its Lee Park home.

Ms. Crenshaw summed up her feelings on this issue: "We're not gonna keep fighting this 'civil war' over again every two years when someone decides that, 'I don't like this, and I don't like that.'" ★

Moore Represents Christian Values

• Roy Moore could give voice to millions of Americans vilified for religious beliefs

When elected chief justice of the Alabama Supreme Court in 2000, Judge Roy Moore installed in his courthouse a monument with the Ten Commandments that Moses brought down from Mount Sinai carved into it.

Told by a federal court his monument violated the separation of church and state, Moore refused to remove it and was suspended—to become famous as “The Ten Commandments Judge.”

Moore is now the Republican candidate for the Senate from Alabama, having routed Sen. Luther Strange, whom President Donald Trump endorsed and campaigned for.

Moore’s primary win is a fire bell in the night for GOP senators in 2018. And should he defeat his Democratic opponent, the judge will be coming to Capitol Hill, gunning for Mitch McConnell.

Yet it is the moral convictions of the candidate that make this an interesting race for all Americans. For Moore is a social conservative of a species that is almost extinct in Washington.

He believes that man-made law must conform to the “Laws of Nature and of Nature’s God,” as written in Jefferson’s Declaration of Independence.

If a law contradicts God’s law, it is invalid, non-binding. In some cases, civil disobedience, deliberate violation of such a law, may be the moral duty of a Christian.

Moore believes God’s Law is even above the Constitution, at least as interpreted by recent Supreme Courts.

Homosexuality, an abomination in the Old Testament, Moore sees as “an inherent evil.” When the high court, in *Obergefell v. Hodges*, discovered a constitutional right to same-sex marriage, Moore, back on the Alabama court, defied the decision, was suspended again, and resigned.

Moore’s questions and concerns are those of the silent millions on the losing side of the culture war.

Postmodern America may see the judge as a refugee from the Neolithic period. Yet, his convictions, and how he has stood by them, are going to attract folks beyond Alabama. And the judge’s views on God, man, and law are not without a distinguished paternity.

In his “Letter from Birmingham Jail,” Dr. King wrote:

[T]here are two types of laws: there are just laws, and there are unjust laws. I would agree with St. Augustine that “An unjust law is no law at all . . .”

A just law is a man-made code that squares with the moral law, or the law of God. An unjust law is a code that is out of harmony with the moral law. To put it in the terms of St. Thomas Aquinas, an unjust law is a human law that is not rooted in eternal and natural law.

In his Declaration, Jefferson wrote that all men are endowed by their “Creator” with inalienable rights, and among these is the right to life.

Many Christians believe that what the Supreme Court did in *Roe v. Wade*—declare an unborn child’s right to life contingent upon whether its

mother wishes to end it—violates God's law, "Thou shalt not kill."

Throughout our history, people acting upon such beliefs have defied laws, and are today celebrated for it.

Abolitionists, in violation of laws they believed immoral, set up the Underground Railroad to help slaves escape to freedom. King believed that laws imposing racial segregation violated the American "creed" that "all men are created equal" and acted on that belief.

Thomas More is considered by Catholics to be a saint and moral hero for defying Henry VIII's demand, among others, that he endorse a lie, that the king's marriage to Anne Boleyn was not adultery.

Early Christians accepted martyrdom rather than obey laws of the Caesars and burn incense to the gods of Rome.

After Hitler took power in 1933, he authorized the eradication of "useless eaters" in the Third Reich. Those who condemned these laws as violations of God's law, and even attempted to assassinate Hitler in 1944, are today regarded as moral heroes.

Moore, should he win, is going to become an object of fascination in the Secular City. Yet his questions and concerns are those of the silent millions on the losing side of America's culture war.

against their religious beliefs have to be obeyed? What is the duty of Christians in a paganized and perverted society?

What We Achieved in Six-Year War Against Syria . . .

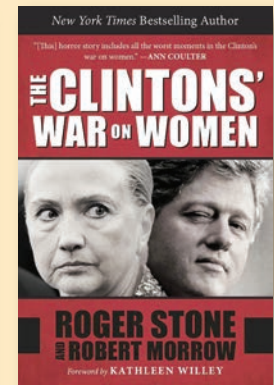
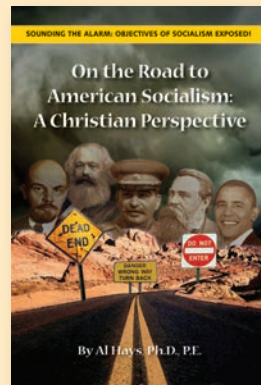
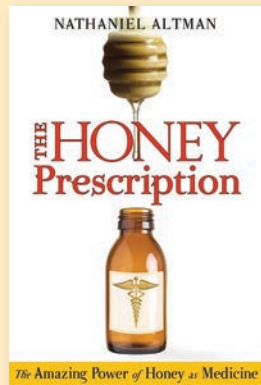
