African-American group applauds president for bringing jobs to inner cities
Economic policies credited with lowest black unemployment rate in 17 years

espite the persistent efforts of the hostile fake news media to discredit and demonize every move President Donald Trump makes, evidence continues to mount demonstrating that the economic prospects for all Americans—including black Americans—are looking brighter and brighter with each passing day.

Trump's populist, America-first economic agenda has prioritized creating and maintaining jobs in the U.S., reinvigorating American manufacturing and industry, cutting taxes, and dismantling or restructuring trade deals that favor multinational corporations or other nations. The president has repeatedly called for prioritizing American workers and American businesses, putting the interests of U.S. workers and industry first, a stark departure from virtually every American presidential administration in modern memory.

Black Americans in particular have benefited economically under Trump. The unemployment rate for black Americans fell to 7% in September, a 17-year low. One year ago, the black unemployment rate was 8.3%, and had reached a high of 16.8% in March 2010 at the peak of Obama's reign.

A variety of black conservatives and ac-



tivists have praised the Trump administration for the improved economic conditions for not only black Americans but all Americans. Project 21, an initiative of the National Center for Public Policy Research, endeavors to promote the views of black conservatives "whose entrepreneurial spirit, dedication to family, and commitment to individual responsibility has not traditionally been echoed by the nation's civil rights establishment," according to the Project 21 official webpage. Leaders and representatives of Project 21 applauded Trump's economic policies and the resulting consumer and worker confidence in the economy.

"Commonsense measures to reduce regulation are a major step in improving American economic conditions," Project 21 advisory board co-chair Horace Cooper recently stated. "Once Congress steps up to reduce taxes and repeal Obamacare, the markets and the economy will skyrocket taking such good fortunes to black America and the rest of the nation."

Unsurprisingly, this positive news has received little coverage in the fake news media, which is largely hostile to Trump and his America-first agenda.

"With the black unemployment rate falling to its lowest point since April 2000, and considering the persistently high levels of double-digit employment that existed during most of the previous administration, this news should really be garnering more attention," noted Dr. Derryck Green, a Project 21 member who focuses on economics and black unemployment. "This should be a source of economic optimism because the job market is expanding and improving overall-particularly among American blacks who were hit hard during the sluggish, so-called economic 'recovery' touted by our previous president. It bears remembering that the black unemployment rate at that point had skyrocketed. It was at or near 15% on nine occasions, and near or above 16% 24 other times. While still too high for my liking at 7%, the black unemployment rate has significantly improved since the days of double digits.'

By almost any objective measure, workers and consumers appear to be more confident in their economic prospects than at any other time since before the economic crisis in the mid-2000s. Americans of all racial and ethnic backgrounds are seeing their economic prospects rise, especially since Trump took office.

Hopefully, Trump will continue to work to implement his populist, America-first foreign and domestic policies.

News You May Have Missed

Populists Take Europe

Austria's election results are in and the new chancellor is Sebastian Kurz, a Eurosceptic who, at age 31, is now the world's youngest national leader. The victory is being called a "crushing blow for the EU." Exit polls found Kurz's conservative People's Party (OVP), described as "tough on migration, easy on taxes, and widely Eurosceptic," took 31.6% of the vote, followed by Chancellor Christian Kern's Social Democrats (SPOe) with 26.3%. Kurz is expected to form a coalition with the nationalist Freedom Party (FPO), which won 26.9% of the vote, twice what FPO ally Alternative for Germany (AfD) won and close to its alltime record of 26.8% in 1999 under then-leader Joerg Haider.

Populists Take Europe II

In the upcoming Oct. 20 and 21 general election in the Czech Republic, the clear favorite is the ANO party, a populist movement led by Andrej Babis, a billionaire referred to as the "Czech Trump." Traditional parties are expected to be thoroughly defeated. Recent polling by the Czech Academy of Sciences reported the ANO scored 30.9%, more than the two traditionally strong parties in Czech politics—the Social Democrat CSSD and the rightwing ODS—combined, which scored only 13.1% and 9.1% respectively.

Unchecked Immigration

A new report from the Center for Immigration Studies states that as of July 2016, over the past 16 years the U.S. immigrant population, legal and illegal, grew to 43.6 million. The number increases to over 60 million when immigrants' 16.6 million U.S.-born children are added, which totals nearly 20% of the U.S. population.

California in Rebellion

Starting January 2018 illegal aliens in the Golden State will have little fear of being sent back to where they came from, as Gov. Jerry Brown (D) has signed a bill making the whole state a "sanctuary" for invaders. Fourteen out of 18 states that do not require ID to vote are either Democrat or swing states.

Dark, Menacing Hillary

In an interview on ABC Australia's "Four Corners" TV show, Hillary Clinton described Julian Assange as a "nihilistic opportunist who does the bidding of a dictator." When the interviewer challenged her, stating many consider Assange a "martyr for free speech and freedom of information," Mrs. Clinton responded by calling the WikiLeaks founder "a tool of Russian intelligence." Commenting on the interview, Assange said: "There's something wrong with Hillary Clinton. It is not just her constant lying. It is not just that she throws off menacing glares and seethes thwarted entitlement. Watch closely. Something much darker rides along with it. A cold creepiness rarely seen."

NFL Hypocrisy

Back in 2012, the National Football League objected to Tim Tebow kneeling in prayer for each game and made him remove the Bible citation (John 3:16) he wore as part of his anti-glare "blackout" face paint. In 2013 the NFL fined Brandon Marshall for merely wearing green cleats, and in 2014 Robert Griffin III, who entered a press conference wearing a Jesus shirt, was forced to turn the shirt inside out before he was allowed to speak. Every year since, the NFL has cracked down on players exercising free speech-De-Angelo Williams, William Gay, the Dallas Cowboys, and those who wanted to commemorate 9/11. Yet, suddenly, we are expected to believe the NFL supports free expression, and that Roger Goodell, NFL commissioner, lacks the backbone to stop players from disrespecting their flag and country?

Mass Murder Not on Rise

Despite what anti-Second Amendment activists claim, mass shootings are actually not up in the United States. According to a new study by University of Illinois professor Sheldon Jacobson, there were 323 mass killings—in which four or more people are killed in one incident—between January 2006 and October 2016. He added that the mass killings were evenly distributed over that time, meaning their rate remained stable over the past decade, and they did not spike during any season or year.

Violent Anti-Gunners

National Rifle Association spokeswoman Dana Loesch announced that because of multiple death threats against her by gun control advocates, her family has been forced to move suddenly. She tweeted, "One guy hunted down my private cell phone number, called when police were here, threatened to shoot me in my front yard. . .. Another guy created a string of social media accounts, posted photos of my house, threatened to rape me to death. ... Another gun control advocate, after threatening to hunt me down and assault me, dragged my kids into it. I'm grateful that my kids' school worked with law enforcement and private security to ensure campus safety, and work with me." Also a syndicated talk radio host and conservative commentator, Mrs. Loesch tweeted her condemnation of the way "politically progressive society" treats not only her but conservative women in general.

Attacks on Cops Up

The FBI reports that in the last year 118 law enforcement officers died in the line of duty. In addition, 57,180 officers were assaulted in the line of duty in 2016, and of those, about 29% (16,535) were injured in the assault. In comparison, 50,212 assaults were reported in 2015, and the FBI notes, "These numbers increased from figures reported in 2015, when 45 officers died accidentally and 41 were feloniously killed in the line of duty."

Ill-Gotten Windfall

Slash-and-burn speculator George Soros reportedly turned over \$18 billion—nearly all of his ill-gotten wealth —to his nonprofit Open Society Foundations. His foundation is notorious for supporting radical leftist organizations that preach violence, like the Antifa and Black Lives Matter groups.

Robot Army

At a recent Association of the U.S. Army show in Washington, D.C., Ukrainian defense industry officials and military leaders introduced their experimental "Phantom" robot. Its extendable frame can be outfitted with six wheels or with tank-like treads, and can be armed with machine guns, anti-tank weapons or grenade launchers. The officials said the Phantom is now in testing and could be sent into action against Russian-backed forces as soon as next year.

China and India to War?

Chinese and Indian soldiers clashed in an "altercation" in the western Himalayas recently, Reuters reported, raising tensions between the two major countries, which were already locked in a now-two-month standoff at another part of their disputed border. Amid strained relations over the Doklam standoff in the Sikkim sector, Indian and Chinese boat patrols clashed at the Pangong Tso Lake in Ladakh, the *Indian Express* reported.

High-Speed Monorail

China's "new energy" carmaker BYD has announced plans to build a monorail transit system in the city of Iloilo, Philippines by 2019. The monorail is named Yungui, which translates as Cloud Rail. Running as fast as 400 miles per hour, Yungui will cost much less than a conventional metro system such as the Washington, D.C. subways.

Above the Law?

Yvette Felarca, a Filipina-American, 47, is a leader in the communist "By Any Means Necessary" group and a related Trotskvite outfit. This Antifa moonbat is also a teacher at Berkeley's Martin Luther King Jr. Middle School. She has been repeatedly arrested for rioting and inciting violence. Most recently she was among four people busted for brawling when political groups clashed over a planned Free Speech Week featuring alt-right speaker Milo Yiannopoulos. Ms. Felarca was charged with battery and resisting arrest. Why is this maniac not only not in jail but allowed to continue teaching children in a public school?

Santilli Cops Plea to Avoid Prison, Fine

• Internet radio show host pleads guilty to charge stemming from Nevada standoff

here have been new surprising developments in the upcoming trial of Cliven Bundy, his sons, and several of his supporters in the U.S. District Court in Nevada.

In the first twist, Internet-radio personality Pete Santilli "pled guilty [Oct. 6] and was released pending sentencing," his attorney, Chris Rasmussen of Las Vegas, confirmed for AFP by phone about 4:30 p.m. Eastern time that day. Santilli is one of the defendants in the next trial, which had been set to begin with jury selection on Oct. 30.

The trial that would have included Santilli involves the federal government trying cattleman Cliven Bundy, his sons Ammon and Ryan, and Ryan Payne.

Following his plea deal, Santilli will no longer be a defendant. Two other defendants, O. Scott Drexler and Eric Parker, who are being retried on some counts for a third time, will join the others in this second of three planned trials of all the defendants charged in the Bunkerville "standoff."

The second turn of events is that both the prosecution and defense sought and secured yet another delay in these complicated proceedings, this time due to fear that the highly emotional aftermath of the recent deadly shooting during a country music concert outside Mandalay Bay Resort and Casino in Las Vegas would adversely impact the attitudes and opinions of jurors.

It's worth noting that the Oct. 30 trial could be subject to change again, given the bumpy track record of these multiple-defendant trial proceedings—which the federal government has been largely losing so far.

Santilli, who shot extended livestream video footage at the Malheur National Wildlife Refuge building in eastern Oregon, was jailed for his role in that affair. Although he was cleared of charges in Oregon, Santilli was kept behind bars and transferred to Nevada to stand trial because he had also taken part in the spring 2014 Bunkerville, Nev. "standoff." That peaceful confrontation saw Bundy, his sons, and other supporters gather to protest the policies and conduct of the Bureau of Land Management (BLM) and other federal agencies that unsuccessfully attempted to confiscate Bundy's cattle over a grazing-fee dispute.

In Nevada, Santilli pled guilty to a felony count of obstruction of justice, based on the government's assertion that he used his own vehicle to impede the movement of a BLM truck during the attempted cattle impoundment.

Attorney Rasmussen believes the government may be willing to consider the prison time that Santilli has already served—behind bars since Jan.



The Feds threatened Santilli with forfeiture of assets, six years in prison, and a fine as high as \$250,000.

26, 2016—as sufficient punishment for that felony charge. But a reading of the plea memo shared with AFP by Rasmussen shows that the government reserves the right to impose a longer prison term, possibly six years, when Santilli is sentenced, probably in January.

Meanwhile, two pending defense motions—one to exclude Oregon-related evidence in the government's Nevada case against Santilli and another to challenge the government's claim that Santilli could not excuse his Nevada actions because of his journalistic background—are now moot, Rasmussen added.

According to court documentation, Santilli copping a guilty plea to this single felony-obstruction charge requires, under penalty of perjury, that he accept the following government-sourced statements as "true and correct," regarding the "standoff" in southern Nevada:

Beginning on or around March 28, 2014, federal law enforcement officers from the United States Department of Interior, Bureau of Land Management, and National Park Service were engaged in the official duties of executing federal court or**Pete Santilli** was a fixture at the Nevada and Oregon standoffs featuring members of the Cliven Bundy family. By pulling his vehicle into the path of federal agents trying to impound Bundy's cattle, Santilli was charged with obstructing their efforts. Santilli could still get time in prison.

ders to remove and impound cattle trespassing upon federal public lands in and around Bunkerville, Nevada, the cattle belonging to Cliven Bundy, a local rancher.

Defendant Santilli knew that Cliven Bundy and his sons, Ammon, Dave, Mel, and Ryan, (collectively, "the Bundys"), and others associated with them, planned to thwart, impede and interfere with impoundment operations.

On April 9, 2014, Defendant Santilli used force to prevent officers from discharging their duties by using his vehicle to block BLM law enforcement officers and civilian employees as they were performing their duties related to the impoundment. Defendant Santilli drove his vehicle straight toward a BLM law enforcement officer's vehicle, preventing the officer and the rest of the convoy behind him from being able to move forward.

The officer ordered Defendant Santilli to move out of the way but Defendant Santilli continued to block the convoy's path. Defendant Santilli finally reversed his vehicle out of the path of the convoy only after the officer repeated the command several times.

By using force to block the convoy, Defendant Santilli allowed others to surround the convoy and threaten the occupants of the vehicles by force of violence and fear, inducing the officers to leave the place where their duties were required to be performed.

Defendant Santilli acknowledges that all of the above took place within the state and federal district of Nevada.

The maximum penalty for "conspiracy to impede or injure a federal officer," the formal name of this count against Santilli under 18 U.S.C. § 372, is six years' imprisonment, a fine of \$250,000, or both. But the plea memo shows that Santilli owes no restitution under this charge, nor will he be required to forfeit any of his assets—provided he meets the strict terms of his supervised release until he's sentenced.

He must not violate any federal, state, or local laws, is restricted from any significant travel, and among other things must avoid any known association with anyone who's breaking any law. Nor can Santilli possess a gun or any other item deemed a weapon by the government. Failing to show up for a hearing or other procedural matter would also result in this deal being dissolved. ★

Rhode Island Tackles 'Geoengineering'

n late September, Rhode Island became the first state to enact legislation that calls on officials to examine how atmospheric-modification programs, commonly referred to as "geoengineering," are affecting the Earth. The measure in question is the Geoengineering Act of 2017 (H. 6011), which was introduced by state Rep. Justin Price (R) earlier this year.

"The Rhode Island general assembly finds that geoengineering encompasses many technologies and methods involving hazardous activities that can harm human health and safety, the environment, and the economy of the state of Rhode Island. . . . It is therefore the intention of the Rhode Island general assembly to regulate all geoengineering activities," the bill says.

Specifically, the bill would "provide that a person seeking to engage in geoengineering activities would require a license from the director of the Department of Environmental Management," an April 2017 legislative news release explained, adding: "Geoengineering is defined as the intentional manipulation of the environment, involving nuclear, biological, chemical, electromagnetic and/or other physical-agent activities that effect changes to earth's atmosphere and/or surface."

Cloud-seeding has long existed as a form of weather modification. One example is the U.S. military's clandestine Operation Popeye, which illegally applied a "cold cloud modification system" using three WC-130 planes to shoot silver-iodide flares into the skies to induce heavy rains to muddy the Ho Chi Minh Trail. The purpose was to stop or slow North Vietnamese troop convoys.

But there's a growing recognition that much else is going on above us—and has been for a long time. Many people call those criss-cross vapor streaks that often mar otherwise beautiful blue skies "chemtrails," a broad term referring to visual evidence of an apparent program involving atmospheric spraying that allegedly goes beyond creating rainfall.

Perhaps the most common claim is that atmospheric aerosols are being sprayed to deflect sunlight and keep the Earth from getting too warm, in keeping with the climate change theory that world temperatures are unnaturally rising, and humanity's industrial emissions are chiefly to blame.

Specialists interviewed by this AFP writer regarding geoengineering have some weighty concerns, especially regarding the bill's "regulation" provision.

"There are concerted efforts in America and in Europe," nuclear physicist and atmospheric researcher J. Marvin Herndon told AFP, "that are aimed at geoengineering 'governance.' All of those efforts, to my knowledge, fail to tell the full truth, fail to admit that geoengineering has been taking place covertly for decades."

He continued, "The more I learn of the horrific adverse health consequences for humans and other biota, the more I realize that there is only one acceptable act of governance: The total and complete ban on placing any and all substances into the air we breathe for any reason."

Herndon did add, "Representative Justin Price deserves major kudos for not burying his head in the sand as most (virtually all) civic leaders do."

Price's bill requires advance disclosure of precise geoengineering plans before they're carried out. Otherwise, geoengineering should be banned, said Price, who told reporters: "I think the public should not take the idea of geoengineering lightly, because we have no idea what irreversible damage could be done to the planet or our atmosphere Either the entire process is completely transparent to the public, with strict oversight, or I say, it absolutely should not happen."

This bill, introduced on March 24 and passed by the House Sept. 19 by a 67-0 vote, would "create a 5-member commission to study and provide recommendations on the regulation and licensure of geoengineering."

Yet this issue runs even deeper than many may suspect. Jim Lee of South Carolina, a researcher on geoengineering, especially weather modification, spoke at length on such matters at last December's Freedom Force International conference entitled "Global Warming: An Inconvenient Lie" in Phoenix, Ariz.

Lee credits Price for waking people up about geoengineering, but there already are broader laws on this subject that have long been on the books such as the federal Weather Modification Reporting Act of 1976—that should be utilized to bring clandestine atmospheric modification into full public view and establish a means of policing, punishing or banning it.

The Rhode Island bill's text says that violators would be punished \$500,000 per occurrence with "not less than 190 days" in jail, and per occurrence could mean per day.


"With the Rhode Island bill, there's no way to punish anybody," Lee countered. "It doesn't say anything about how you catch somebody [engaging in geoengineering flights] without a license. The 24hour prior notice in the bill is okay, but we have to deploy atmospheric sensors to catch violators in the act."

As he understands it, most atmospheric modification programs are "deep-state" and by definition would be hard to thwart under the Rhode Island bill—given the limited jurisdiction and land area of that small eastern state.

Homelessness & Infectious Diseases Combine to Create Health Disaster

• California declares 'Hep A' state of emergency

he breakdown of the United States is manifested in many ways, but perhaps no way illustrates the decline of this once-great nation more than its swelling homeless population, and, with it, diseases that were once seen only in Third World countries. The numbers back up what many of us suspect: According to the U.S. Department of Housing and Urban Development's November 2016 Annual Homeless Assessment Report to Congress, "on a single night in 2016, 549,928 people were experiencing homelessness in the United States."

Indicative of the disaster, two separate outbreaks of hepatitis A in California and Michigan that began last year and have killed dozens of people are threatening to spread across the country, and public health officials have very few tools in their arsenal to stop the wave of contagion.

On Oct. 13, California Gov. Jerry Brown declared a state of emergency, which will allow state health officials to buy additional doses of the hepatitis A vaccine to try to halt the outbreak, the country's second largest in more than 20 years. The only one larger occurred in Pennsylvania in 2003, when almost 1,000 people caught hepatitis A from contaminated green onions.

The outbreak, which began in San Diego's homeless community last year, has now spread into other regions. Los Angeles and Santa Cruz counties are now experiencing outbreaks. It has gotten so bad in San Diego that contractors have started blasting the city's downtown streets with bleach.

Hepatitis A "is a viral infection that involves the liver and makes people sick for maybe a month or so," Dr. Jane Orient, the chairman of the Pima County, Ariz. Medical Society's Public Health Committee for about 30 years and the president of Doctors for Disaster Preparedness, told AMERICAN FREE PRESS in an exclusive interview.

"They become jaundiced, and they may have nausea and vomiting," Dr. Orient continued. "It is generally a self-limited disease, although it is contagious, and people generally get over it and do fine and are immune to it afterwards. It is generally transmitted in contaminated food; it's a fecal-oral route that is excreted in the stool, and if you contaminate the food with it then that's how it's usually transmitted—although the San Diego outbreak does not appear to involve food handlers, but rather people are getting it from the environment, because, I guess, in San Diego they have a particularly filthy environment."

AFP asked Dr. Orient why a First World nation like the United States has seen 19 people die from the disease in the San Diego area and 14 people die so far in the Detroit area, with over 1,000 infected in both regions.

"I think that we're just seeing a breakdown in our civilization," she said, "which includes standards of cleanliness that have been accepted for decades at least and maybe for centuries. Why are we going back to the time when they denied the germ theory of disease?"

The germ theory of disease, Dr. Orient explained, "means that disease is transmitted by microscopic organisms that you can acquire by drinking dirty water or contamination of your food, that these are bacteria or viruses that grow and multiply in your body and that make you sick. This is the most important reason why Third World countries have such high rates of diseases: They do not have clean water and sanitation."

AFP asked why she thinks the germ theory of disease is not being addressed by those in power.

"I think it's a matter of political correctness that would involve critiquing things like allowing people to wander through the streets and live in a way that endangers the health of the whole population," she explained. "It seems that there are people that care more about political correctness than they do about the health of the average American citizen. I think they consider themselves to be sort of immune: They're protected, they live in an elite community, and they're in charge of things. They're not like the rest of us 'deplorables,' who are barely getting by on what we can earn in this deindustrializing society, and I think they just really don't care about the average patient."

AFP asked if she believes that unfettered immigration is contributing to this and other outbreaks.

"Oh, I think it definitely is," she answered. "We have people coming into the country that are not screened medically in any way, and sometimes are deliberately dispersed throughout the country, and go to public schools and infect children with diseases to which the children have never been exposed before and they have no immunity."

She continued: "That was probably responsible for outbreaks of hundreds of cases of the Enterovirus D68 (EV68) that sent a lot of American children to intensive care units. Some of them became paralyzed because it is a disease somewhat like polio to some people. This probably came in from Central America where it's endemic in the population. It doesn't usually make people [who live there] very sick because they have some immunity to it, but American children just don't."

As several California counties are offering free hepatitis A vaccine shots to the homeless in order to stem the tide of the outbreak, AFP asked Dr. Orient her opinion on the vaccinations, which are being almost forced on the homeless.

"I just think that mass imposition of any type of medical intervention is a very bad idea," she said. "It's contrary to our civil rights, and it's also just a very imprudent idea, because a lot of times we don't find out about the bad effects of the medical things we do until it's too late."

Dr. Orient warned further about vaccines.

"I think that people who deny that vaccines can have lifelong disabling, very serious complications is rampant," she said. "Vaccine manufacturers have virtually absolute immunity for any type of liability, so they're really quite protected, even if they lie and cover up or are negligent about doing safety studies."

AMERICAN FREE PRESS asked if the elites had a more nefarious agenda.

"I think there are people who really want to destroy the United States of America—to destroy our economic and our military power—because we're the biggest impediment to their ideal of a global regime," she said. "I think the United States is in serious danger, existential hazard really, of loss of the freedom on which our prosperity depends, as well as a decent civilized life."

Dr. Orient summarized her feelings on this disturbing issue.

"Large populations are using the streets and outdoor areas as a toilet," she said. "There used to be punishment for merely spitting on the sidewalk. If we tolerate Third World hygiene standards we will have Third World diseases. We have got to break the chain of transmission by just cleanliness. We don't have a vaccine for every disease that exists. We can't vaccinate everybody for everything." PAID POLITICAL ANNOUNCEMENT



Trump Moves Forward With Plan to Limit Immigration

• Democrats say border security demands unreasonable

or the first time in nearly 50 years, Americans may have a chance to actually debate stopping mass illegal immigration into the United States. Sen. Edward Kennedy (D-Mass.) opened the immigration floodgates by eliminating numerical caps and opening up massive migration to the United States. America's failure in Vietnam opened up even more loopholes in the 1970s followed by a deal in 1986 between Kennedy and President Ronald Reagan, all of which resulted in the 11 million to 40 million illegal immigrants—depending on differing estimates—living in the nation today.

Supporters of President Donald Trump thought the president had flip-flopped on an America-first immigration policy last month when he met with Senate Minority Leader Chuck Schumer (N.Y.) and House Minority Leader Nancy Pelosi (Calif.) to work on an immigration bill Republicans and Democrats could support. The Democrats said they thought the president would extend the Deferred Action for Childhood Arrivals (DACA) program protections in exchange for border-security measures. Trump gave Congress six months to come up with a legislative fix before so-called "Dreamers" began to lose their status.

Trump opened negotiations on immigration reform Oct. 8—a Sunday night—sending members of Congress a letter outlining 71 demands in exchange for some form of amnesty for about 800,000 illegal aliens. The plan is a step back toward an America-first immigration policy. Trump's plan would reduce the 1.1 million people admitted to the United States annually by limiting immigration by certain family members of U.S. citizens and legal The president wants 370 more immigration judges, and an additional 1,000 ICE attorneys and staff.

permanent residents. Those with the ability to speak English or with a pending offer of high-paying employment will likely be considered, but those conditions were not explicitly spelled out in Trump's wish list.

The president's guidelines include many of the same provisions included in the Reforming American Immigration for Strong Employment (RAISE) Act, which has been sitting in the Senate Judiciary Committee since February. Extended family members and those categorized as unskilled lose most in terms of allowances while immediate family members and skilled workers earn high points in a new merit-based system under RAISE. The legislation, introduced by Sens. Tom Cotton (R-Ark.) and David Perdue (R-Ga.), would create economic growth and raise American worker wages through prioritizing skilled immigration and cutting current immigration levels by roughly half, according to the authors.

Trump also wants loopholes fixed in the law that prevents removal of unaccompanied alien children that arrive in this country unless they are victims of human trafficking. Further, the president wants the burden of proof placed on juveniles, to prove that reunification with both parents is not viable due



to abuse, neglect, or abandonment and that the applicant is a victim of trafficking.

The president wants 370 more immigration judges, performance metrics for immigration judges, and money to hire an additional 1,000 U.S. Immigration and Customs Enforcement attorneys, with sufficient support staff.

Trump asks for even more, including U.S. funding, not Mexican, for a border wall. The question is, what will he settle for? Democrats say they are revolted by the president's proposals.

"We told the president at our meeting that we were open to reasonable border-security measures alongside the DREAM Act, but this list goes so far beyond what is reasonable. This proposal fails to represent any attempt at compromise," Pelosi and Schumer said in a joint statement. "The list includes the wall, which was explicitly ruled out of the negotiations. If the president was serious about protecting the Dreamers, his staff has not made a good faith effort to do so."

Pseudo-conservatives like Sens. Lamar Alexander (Tenn.), Bob Cornyn (Texas), Bob Corker (Tenn.), Mitch McConnell (Ky.), Lindsay Graham (S.C.), Jeff Flake (Ariz.), and John McCain (Ariz.), and Reps. Mike Coffman (Colo.), Steve Scalise (La.), and Paul Ryan (Wisc.) seek amnesty, according to the immigration-control organization Numbers USA.

Media Watchdog Group Catches Shocking NYT Admission on Tape

• Reporter exposes official New York Times anti-Trump policy

• Reveals editor's bias, conflicts of interest, strange ties to Antifa

roject Veritas, an independent non-profit media and watchdog organization founded by James O'Keefe that seeks to expose corruption and misconduct in both the public and private sphere, continues to reveal *The New York Times* and some of its leading contributors and editors as the partisan, biased, and unprofessional hacks the American public is coming to know them as.

As part of Project Veritas's ongoing American Pravda series, which began in earnest this summer with a detailed exposure of CNN's anti-Trump bias and blatant promotion of fake news stories, an undercover reporter with the media watchdog and investigative outfit captured a leading video editor for *The New York Times* on film exposing himself as an unprincipled, unethical, and dishonorable stooge for the anti-Trump establishment.

In the recently released video by Project Veritas, Nicholas Dudich, who serves as audience strategy editor for *New York Times* video, candidly admits that he and his so-called media organization are not objective in their coverage, particularly of Trump.

"No, I'm not [objective]," Dudich proudly concedes on video. "That's why I'm here."

Dudich also admitted that the *Times* slants its coverage of Trump in an effort to discredit and demonize the populist billionaire who has upset the ruling political and media establishment with his America-first positions and stinging attacks on what Trump accurately calls "the fake news" media that have manipulated and deceived the masses in this country for far too long. Prior to working for the *Times*, Dudich worked on the political campaigns of both Hillary Clinton and Barack Obama, revealing his partisan nature.

In the video, Dudich also admitted to once being involved with Antifa, the radical and oftentimes violent coalition of far-left activists who regularly protest conservative and right-wing rallies and events. Antifa and their allies are also prone to physically attacking Trump supporters, and often attempt to shut down and disrupt conservative gatherings and events, publicly expose right-wing activists in an attempt to get them fired from their jobs, and otherwise cause mayhem and violence in cities across the United States.

"Yeah, I used to be an Antifa punk once upon a time," Dudich explained to the undercover Project Veritas reporter. Dudich went on to bizarrely admit

that James Comey, the former director of the FBI, asked him to join Antifa as a protected FBI asset to gather intelligence about the radical movement.

"I joined that stuff for them [the FBI]," Dudich told the undercover reporter. "I was an asset."

Dudich's purpose, he explained, was to gather information and to assess whether Antifa was a real threat to the government and society.

Dudich also told Project Veritas that Comey was his godfather, and that his father and mother have known Comey and his wife "for a really long time." He admitted that he "should have recused [himself]" when covering the Comey trial, given his alleged close personal ties to Comey. However, Dudich's father, who was contacted by Project Veritas, denied his son's claims, stating that Comey is not Dudich's godfather and that he doesn't "even know James Comey."

The bizarre and quite revealing investigative video series once again exposing a major American media outlet produced by Project Veritas has been released as a three-part series as AFP goes to press, and is well worth watching in its entirety. The video series can be viewed on YouTube or on AmericanFreePress.net, AFP's website.

"The fact remains that Nick Dudich lies and he's a gatekeeper at *The New York Times*," O'Keefe stated following the release of the investigative report. "And that fact should be worrisome to the bosses at 'the paper of record.' Who else are they letting spread misinformation in their name?"

Top-Tier Treason & the USS *Liberty*

• *Liberty* survivors, Philip F. Nelson document U.S. treason in high seas slaughter

hillip F. Nelson's new book, *Remember* the Liberty! Almost Sunk by Treason on the High Seas,* seeks to out the American politicians responsible for the planning, execution, and cover-up of the Israeli attack on the USS Liberty in 1967. In tracing the planning of the June 8 attack back to 1965, Nelson has written a work that holds President Lyndon B. Johnson and Secretary of Defense Robert McNamara responsible.

In 1979 *Liberty* survivor James M. Ennes Jr. wrote the first full treatment concerning the Israeli assault on the unarmed U.S. naval ship. After the release of his book, Ennes pursued further research at the LBJ Library in Austin, Texas. Within that research, Ennes found a misfiled document that detailed the minutes of a meeting held by a "303 Committee" in April 1967. The 303 Committee was responsible for all covert CIA operations within the Johnson administration.

The 303 Committee consisted of CIA director Richard Helms, former ambassador to the Soviet Union Foy Kohler, chairman of the Joint Chiefs of Staff General Earle Wheeler, Deputy Secretary of Defense Cyrus Vance, and National Security Adviser Walt Rostow.

Rostow also headed a separate White House group that consisted of Johnson's most adamantly Zionist advisors.

McNamara was often used by LBJ as the key liaison and chief executioner of the covert operations birthed by the 303 Committee and the other groups.

The minutes of the 303 Committee meeting held two months before the attack on the *Liberty*—referenced an operation called "Frontlet 615." Operation Cyanide was found within the subparts of Frontlet 615. The 303 Committee used Frontlet 615 as a code name for the pending Six-Day War between Israel and Egypt. As planned, the war was scheduled to begin on June 15. The Americans had agreed to provide equipment, officer training, and the limited use of aircraft to the Israelis.

Operation Cyanide was a provocative false flag that called for an Israel Defense Force attack on a U.S. ship. The assault on the unarmed ship would use unmarked fighter jets so that the destruction could then be blamed on the Egyptians, and the Americans could enter the war on the side of Israel.

It was not the first time Johnson had dabbled in false-flag operations. Years earlier, he had tasked National Security Advisor McGeorge Bundy with "Plan 34A" in Vietnam. Bundy was charged with constructing a series of provocations that would cause the North Vietnamese to attack American destroyers (i.e., Gulf of Tonkin). Some historians cite Tonkin as the primary reason for Johnson's 1964 win over Sen. Barry Goldwater (R-Ariz.).

In a decision that confounded LBJ, Israel began its war with Egypt 10 days early. The USS *Liberty* was rushed from its position off the horn of Africa to the Mediterranean Sea. The *Liberty* had been chosen as the victim of Operation Cyanide.


In *Remember the Liberty!* Nelson recalls the tense confusion and abandonment Admiral Lawrence Geis experienced as the *Liberty* was being attacked. Geis later relayed the tale to Chief Intelligence Officer David Lewis, who agreed not to reveal the information until Geis had died, which he did in 1987.

Geis explained to Lewis that Johnson had ordered two sorties of fighter jets recalled—one that had been en route to the *Liberty* ten minutes after the attack. Johnson had also recalled two A-4s, launched from the USS *America* within minutes, armed with nuclear weapons and headed for Cairo, Egypt.

McNamara called Geis and instructed him to recall the aircraft. "We're not going to war over a few dead soldiers," McNamara told Geis. McNamara, expecting the *Liberty* to sink within the hour, told Geis that he could order another sortie of fighter jets in 90 minutes. When the hour-and-a-half had passed, Geis prepared to order assistance. McNamara again instructed him to recall the order.

Geis demanded to speak to the president, who was standing next to McNamara. Johnson confirmed to Geis that he should "recall the wings." He told Geis that he didn't care if the *Liberty* sunk to the bottom of the Mediterranean. He was not going to embarrass his ally.

Upon assuming the presidency after the assassination of John F. Kennedy, Johnson had told Israeli Minister of Foreign Affairs Golda Meir in

1963, "You've lost a great friend, but you've found a better one." He promised Ms. Meir that there would be no repeat of the Eisenhower incident of 1956. Ike had rebutted Johnson, who had attempted to persuade the president to back off on sanctioning Israel. The threat of sanctions was levied by Eisenhower after Israel had refused to release lands in the Sinai Peninsula.

In *Remember the Liberty!*, Nelson further details the political maneuverings that make Johnson, McNamara, and LBJ's administration culpable in the 1967 attack on American sailors off the coast of Egypt and Israel. A part of the proceeds from Nelson's work are donated to the Liberty Veterans Association.

The Origins of Judeo-Christianity

uring the 20th century, Christianity has gone through great changes that have changed the Christianity at the time of the reformers to what it has become today. I think it's time to ask ourselves: Where did these strange doctrines originate and who came up with them? Most of the following information is available on the Internet.

The order of the Jesuits came into existence shortly after Queen Isabella expelled most of the Jews in Spain because of their treachery in 1492. The only ones that stayed were the ones that were baptized into Christianity and became "Christians" also called "Marranos," crypto-Jews, Christians in name only, as they never recanted their Judaism. Although Loyola was possibly not a Jew, it did not take long for the Marranos to infiltrate the order. The Rapture Theory is based largely on the teachings of Manuel Lacunza, a Jesuit priest (a crypto-Jew) in the early 1800s, who originated the pretribulation rapture belief and introduced it in his notable work, The Coming of Messiah in Glory and Majesty. The theory teaches that the church will be removed from the world as God executes His wrath against evil. It was John Darby (1800-1882) that picked it up later and ran with it.

Francisco Ribera (1537-1591) was a Spanish theologian (a crypto-Jew) identified with the Futuristic Christian eschatological view. He wrote a 500-page

commentary on the book of Revelation titled *Evangelistiac Apocalypsin Commentary*, proposing that the first few chapters of Revelation apply to ancient Rome, and the rest he limited to yet a future period of three and one-half literal years, immediately prior to the Second Coming. He then proposed a singular antichrist, never mentioned by the Apostle John, as he noted that there were many antichrists, who would: • persecute and blaspheme the saints of God; • rebuild the temple in Jerusalem; • abolish the Christian religion; • deny Jesus Christ; • pretend to be God; and • kill the two witnesses of God. Does any of this sound familiar? Again, it was John Darby that put this and the rapture theory together which is now the foundation of the New Christianity's Dispensationalism.

It was **Samuel Maitland**, the librarian for the Archbishop of Canterbury, that came across these ancient writings of the Spanish Jesuit priests and published them at separate times, and it was ideas from his publications that Darby seized to create a New Christianity far different from the old.

All Christians reading this should ask themselves the obvious questions: Since the Holy Ghost is only for

Christians, this must have been given to these promoters, directly by God, as it is not found in the Scriptures, so why would He reveal it unto them? Could it have been the product of their devious minds? Why were these amazing discoveries not uncovered by our great theologians and pastors since the reformation till the end of the 19th century? 
maybe look to them today for answers to all the problems we are facing and the direction our nation is going? Or is it possible that we already are?

He forged the documents that made him an attorney without attending law school and at 29 became the youngest U.S. District attorney for the state of Kansas. He was later convicted for forgery and served prison time. While he was married with two young daughters he was seeing two other women. After convincing his mother-in-law to give him over \$2000 to invest for her benefit, and then kept it (it was enough at that time to buy three brand new cars) and left his wife and married one of the women he had been seeing after he got out of prison. hard to believe that there are pastors naive enough to believe that the Jews would invest over \$100,000 of their money in Scofield for 20 years so as we Christians can understand our Bible better. One of their favorite songs, especially now, is *Hurray for Hollywood*.

Phil Giraldi Speaks Candidly With AFP

• Former CIA agent finds out there is a limit to free speech—even amongst "conservatives"

eorge Orwell once said, "The further a society drifts from the truth, the more it will hate those that speak it." That ominous warning was clearly on display last month when Philip Giraldi—one of the heavyweights who has been able to cross the line between the alternative media and the established media—was banned from writing for *The American Conservative* magazine, where he had been a contributor since its inception, because they didn't like an article he wrote not for them, but for another publication.

Giraldi, born in New Jersey and educated at the University of Chicago and the University of London, served in U.S. Army intelligence during the Vietnam War and was a CIA operations officer, i.e., agent, for 17 years. Since his time with "the Agency," Giraldi has been writing for several websites and magazines about national security issues and most particularly about the war on terror.

He has also been the executive director for the past seven years of the 30-year-old Council for the National Interest (CNI), founded by former U.S. diplomats "outraged by the U.S. policy in the Middle East, which was favoring Israel very heavily and damaging our other interests in the region," explained Giraldi in an exclusive interview with AMERICAN FREE PRESS.

CNI's objective is to change "U.S. policy to make it more aligned with U.S. interests and less with Israeli interests," he added.

The hullaballoo over some words started Sept. 19 when Giraldi penned a 1,483-word piece entitled "America's Jews Are Driving America's Wars: Shouldn't they recuse themselves when dealing with the Middle East?" The story may have been relegated to appealing to the choir, if not for a chance event.

Giraldi explained what happened.

"Valerie Plame is a former CIA officer like myself," he began. "She's best known for involvement with her husband, Joe Wilson, who was in Niger to see if Iraq was buying uranium. This was before the war against Iraq. [Wilson] came back and said, 'No way, this had never happened.' And when he did that he was punished, but his wife was punished worse. She was a serving CIA officer, undercover, and Scooter Libby, who was an advisor to Vice President Cheney—and an ardent Zionist, I might add—was so angered by this that he leaked her name and identity to the media, *The Washington Post*, which picked up on it."

He continued: "She has been punished again, because she made the mistake of seeing my article online and reading it and then making a comment that it was interesting material. She got jumped on



by all and sundry of the Jewish oligarchy in the media and she apologized repeatedly, but they didn't let up on her for a whole week. I suspect that the fact that she got into the story, and the story then made national news, was what made the story have the kind of currency that it got. I think if she had not been involved, my story would've been like other articles that I've written where people will say, 'He's just another crackpot; he's an anti-Israeli crackpot.' "

Ms. Plame sent the article out to her followers on the social media platform Twitter, and "the Jewish oligarchy in the media" used the "anti-Semitic trick" to get her to grovel and genuflect.

The upside of Ms. Plame's tweet was the exposure Giraldi's article received, as well as a followup piece he wrote on Oct. 3, entitled "How I Got Fired: Exposing Jewish power in America has real consequences."

"The original article's been viewed about 150,000 times," Giraldi said, "and the comments [responding to the online article] are up to about 1,500. The second article has had about 60,000 views and I think it just broke 1,000 in terms of comments. And some of my older articles also found a new readership as a result and are approaching 50,000 views. So it certainly had a dramatic impact in terms of getting the message out."

Considering all the exposure his articles had received, AFP asked if the mainstream media reached out to him for comment, as they were re**Former intelligence insider Phil Giraldi** wrote for *The American Conservative* since its inception in 2002, but a recent column on the real forces driving America's wars ended that relationship in a heartbeat. No other mainstream news outlet has asked Giraldi to write for them or contacted him about the story, but he has been inundated with requests for interviews from independent media organizations.

lentlessly skewering him.

"The short answer is, 'No,' " he said. "No established mainstream-type outlets have gotten in touch with me, even though the story has been all over the place. It was in *The Washington Post*, it was in *The New York Times, Los Angeles Times*; it was everywhere. It was on MSNBC, CNN. But nobody has gotten in touch with me to talk about this. However, from the alternative media, I've been run off my feet, in terms of doing interviews, in terms of talking about what this all means."

Giraldi continued: "Unfortunately, we are seeing the classic exploitation of the heavy Jewish presence over-representation in the media and entertainment industries, to make sure these kinds of stories don't get out. How long they're going to be able to do that, I don't know. I've long felt that what the Israelis have been doing to the Palestinians and also to all of their neighbors is totally indefensible. So how long do you keep this fiction going? I don't know. I don't have an answer to that."

Giraldi explained to this newspaper what he wrote about and why it caused a stir.

"The article was about what I was describing as Jewish power, the ability of Jewish groups and individuals to distort our foreign policy in the Middle East to benefit Israel and to the damage of the United States," he said. "And I think what set these people off was the fact that I didn't use a euphemism about who these people were: I said that they were Jewish. And very often you'll see people writing about Middle East policies and they'll use expressions like 'the Israel lobby' or 'Zionist' or 'neoconservatives.' But [they are] fudging the basic issue. The basic issue is that this is Jewish money, this is Jewish people with access to the political class and with lots of money, and creating these foundations and organizations that only exist to benefit the Jewish state."

Giraldi was emphatic that he was not talking about all Jews. He said he was only referring to a select few.

"Not all Jews by any means," he said, "but I was indicting these people by name. I mentioned who they were and what the organizations were. These organizations are, as far as I'm concerned, committing treason."







The article made a few recommendations as well, in order to return this once-great nation to the people it was created to serve.

"Actually, I made two proposals," he explained. "I said, 'Look, if you've got a guy like Bill Kristol– a leading neoconservative and great lover of Israel-on television, and he's talking about the Middle East and Middle East policy, it might be nice to have a label underneath to tell people who are listening that don't know about him, that this is a guy who's partisan.' And it was kind of a lighthearted comment, because I knew this was never going to happen, but I immediately got jumped on by the usual crowd—like Alan Dershowitz—for this 'outrageous, anti-Semitic slur.' And the other proposal I made was that for Jewish officials in the government who are involved with policymaking, I said, 'Well, look, if you're Jewish and you have strong feelings about Israel, when the issue of what the policy should be in Syria or in Iran or indeed in Israel, you should recuse yourself, just like a judge would do in a trial in which he had a personal interest.' It seemed to make extremely good sense to me to suggest that, and, of course, I got bombed for that one, too."

Shortly after the article appeared online, Giraldi got a call.

"I received a call from the editor [at *The American Conservative*] about two days after it came out," Giraldi explained, "telling me that it was completely unacceptable by their standards, and as a result they were terminating their relationship with me."

AFP asked if his firing sets a dangerous precedent.

"Yeah, we're in danger," he said, "because I think the example of what happened to me will keep anyone else from crossing that line and using what I refer to as the 'J' word. And I think a lot of people have already figured that out."

One of the founders of *The American Conservative* was Pat Buchanan, and his 2003 article, "Whose War? A neoconservative clique seeks to ensnare our country in a series of wars that are not in America's interest," about Jewish political power, set the stage for the anti-war magazine.

"That's the irony about this whole thing," Giraldi said. "Pat Buchanan became famous—or infamous, depending on how you want to look at it when he wrote [that] article denouncing the war in Iraq. And he basically said the same thing that I did. And so here we have the irony of the guy who founded the magazine 15 years ago, and here I'm continuing this tradition of asking the same questions he was asking, and I get fired for it."

AFP asked what he felt has transpired between the time Buchanan wrote his article and now.

"I think what has happened is that everybody in the publishing industry, which has changed dramatically in the past 15, 20 years, is scrambling for the same dollars, looking for money to survive," he said. "I suspect what's happened with *The American Conservative*, like many other publications, is that they have to basically triangulate where their money is coming from and they move toward what they think is the center. And that means that views that are even quite legitimate—which I feel my viewpoint was—are considered to be too dangerous and too risky. In this case it was too dangerous and too risky even to have me around."

One of the bright spots of this rather sad affair is the support Giraldi has received.

"I've had a lot of calls from friends and people whom actually I didn't even know," Giraldi explained, "telling me that, 'Look, it's about time that we change the way we think and talk about this issue because there clearly is a superbly well-organized and funded cabal out there which is doing a lot of damage to the United States, and we have to talk clearly about what this means.' "

Giraldi next addressed another glaring example of Jewish control over America's political institutions most painfully illustrated through Senate Bill 720, Sen. Benjamin Cardin's (D-Md.) Israel Anti-Boycott Act, which "would make it a felony for U.S. citizens to support boycotts of Israel and Israeli settlements, punishable by at least a \$250,000 fine, with a maximum penalty of a fine of \$1 million and 20 years in prison." AFP covered this topic in the Oct. 9 & 16 issue on page 15. In the Senate, there are 49 cosponsors—36 Republican and 13 Democrat—and 261 in the House, where it was introduced by Peter Roskam (R-III.), from both sides of the aisle. Naturally, the American Israel Public Affairs Committee has made the anti-First Amendment measure's passage one of the group's top lobbying priorities for the year.

"I had lunch yesterday with a university professor and he told me his tale," Giraldi said. "He teaches a course in international relations, and as part of the syllabus he had an article that was talking about the Middle East and the author of the article—this was not him, it was the author of the article—had a comment about Israel and its neighbors. The comment was essentially that Israel has very strict immigration laws, but Jewish Americans who support Israel want open immigration in the United States. The article was basically [pointing out that] there's a contradiction in the way Jewish supporters of Israel see the world. And this professor was admonished for being an anti-Semite and was almost fired as a result."

Giraldi concluded the interview by alluding to the obvious.

"When all is said and done the punishment that has been meted out to me and Valerie Plame proves my point: The friends of Israel rule by coercion, intimidation, and through fear," he said. "If we suffer through a catastrophic war with Iran, fought to placate Benjamin Netanyahu, many people might begin to ask 'Why?' But identifying the real cause would involve criticism of what some American Jews have been doing, which is not only fraught with consequences but something that also will possibly become illegal thanks to congressional attempts to criminalize such activity. We Americans will stand by mutely as we begin to wonder what has happened to our country, and some who are perceptive will even begin to ask why a tiny client state has been allowed to manipulate and bring ruin on the world's only superpower. Unfortunately, at that point it will be too late to do anything about."

Who Really Drives America's Wars?

• Columnist for American Conservative canned for voicing taboo opinions

On Sept. 21, former CIA analyst and columnist Phil Giraldi was fired by *The American Conservative*, a conservative publication that was founded by Patrick Buchanan. Giraldi had been contributing to the publication for 14 years before he was told recently that a column he penned on Israeli influence over the U.S. government was unacceptable. But there is good news. Giraldi will be contributing to AMERICAN FREE PRESS with a biweekly column in the months ahead.

spoke recently at a conference on America's war party where afterwards an elderly gentleman came up to me and asked, "Why doesn't anyone ever speak honestly about the 600-pound gorilla in the room? Nobody has mentioned Israel in this conference and we all know it's American Jews with all their money and power who are supporting every war in the Middle East for [Israeli Prime Minister Benjamin] Netanyahu. Shouldn't we start calling them out and not letting them get away with it?"

It was a question combined with a comment that I have heard many times before and my answer is always the same: Any organization that aspires to be heard on foreign policy knows that to touch the live wire of Israel and American Jews guarantees a quick trip to obscurity. Jewish groups and deep-pocketed individual donors not only control the politicians, they own and run the media and entertainment industries, meaning that no one will hear about or from the offending party ever again. They are particularly sensitive on the issue of socalled "dual loyalty," particularly as the expression itself is a bit of a sham since it is pretty clear that some of them only have real loyalty to Israel.

Most recently, some pundits, including myself, have been warning of an impending war with Iran. To be sure, the urging to strike Iran comes from many quarters, to include generals in the administration who always think first in terms of settling problems through force, from a Saudi government obsessed with fear over Iranian hegemony, and, of course, from Israel itself. But what makes the war engine run is provided by American Jews who have taken upon themselves the onerous task of starting a war with a country that does not conceivably threaten the United States. They have been very successful at faking the Iranian threat, so much so that nearly all Republican and most Democratic congressmen as well as much of the media seem to be convinced that Iran needs to be



dealt with firmly, most definitely by using the U.S. military, and the sooner the better.

And while they are doing it, the issue that nearly all the Iran haters are Jewish has somehow fallen out of sight, as if it does not matter. But it should matter. A recent article in *The New Yorker* on stopping the impending war with Iran strangely suggests that the current generation of "Iran hawks" might be a force of moderation regarding policy options given the lessons learned from Iraq. The article cites as hardliners on Iran David Frum, Max Boot, Bill Kristol, and Bret Stephens.

Daniel Larison over at *The American Conservative* has a good review of *The New Yorker* piece entitled "Yes, Iran Hawks Want Conflict with Iran," which identifies the four above-cited hawks by name before describing them as "... a who's who of consistently lousy foreign policy thinking. If they have been right about any major foreign policy issue in the last 20 years, it would be news to the entire world. Every single one of them hates the nuclear deal with Iran with a passion, and they have argued in favor of military action against Iran at one point or another. There is zero evidence that any of them would oppose attacking Iran."

And I would add a few more names: Mark Dubowitz, Michael Ledeen, and Reuel Marc Gerecht of the Foundation for Defense of Democracies; Daniel Pipes of the Middle East Forum; John Podhoretz of *Commentary* magazine; Elliot Abrams of the Council on Foreign Relations; Meyrav Wurmser of the Middle East Media Research Institute; Kimberly Kagan of the Institute for the Study of War; and Frederick Kagan, Danielle Pletka, and David Wurmser of the Amer**William Kristol** is the extremely affluential publisher of *The Weekly Standard*, a neocon/Zionist mouthpiece that wields political influence well beyond its quite limited readership.

ican Enterprise Institute. And you can also throw into the hopper entire organizations like the American Israel Public Affairs Committee (AIPAC), the Washington Institute for Near East Policy (WINEP), and the Hudson Institute.

And yep, they're all Jewish, plus most of them would self-describe as neoconservatives. I might add that only one of the named individuals has ever served in any branch of the American military—David Wurmser was once in the Navy reserve. These individuals largely constitute a cabal of sanctimonious chairborne warriors who prefer to do the heavy thinking while they let others do the fighting and dying.

So it is safe to say that much of the agitation to do something about Iran comes from Israel and from American Jews. Indeed, I would opine that most of the fury from Congress regarding Iran comes from the same source, with AIPAC showering our solons on the Potomac with "fact sheets" explaining how Iran is worthy of annihilation because it has pledged to "destroy Israel," which is both a lie and an impossibility, as Tehran does not have the resources to carry out such a task. The AIPAC lies are then picked up and replayed by an obliging media, where nearly every "expert" who speaks about the Middle East on television and radio or who is interviewed for newspaper stories is Jewish.

One might also add that neocons as a group were founded by Jews and are largely Jewish, hence their universal attachment to the state of Israel. They first rose into prominence when they obtained a number of national security positions during the Reagan administration, and their ascendancy was completed when they staffed senior positions in the Pentagon and White House under George W. Bush. Recall for a moment Paul Wolfowitz, Doug Feith, and Scooter Libby. Yes, all Jewish and all conduits for the false information that led to a war that has spread and effectively destroyed much of the Middle East-except for Israel, of course. [9/11 Commission executive director] Philip Zelikow, also Jewish, in a moment of candor, admitted that the Iraq War, in his opinion, was fought for Israel.

Add to the folly a Jewish U.S. ambassador to Israel who identifies with the most right-wing Israeli settler elements, a White House appointed chief negotiator who is Jewish, and a Jewish son-in-law who is also involved in formulating Middle East policy. Is anyone providing an alternative viewpoint to eternal and uncritical support for Ne-

tanyahu and his kleptocratic regime of racist thugs? I think not.

There are a couple of simple fixes for the dominant involvement of American Jews in foreign policy issues where they have a personal interest due to their ethnicity or family ties. First of all, don't put them into national security positions involving the Middle East, where they will potentially be conflicted. Let them worry instead about North Korea, which does not have a Jewish minority and which was not involved in the holocaust. This type of solution was, in fact, somewhat of a policy regarding the U.S. ambassador position in Israel. No Jew was appointed to avoid any conflict of interest prior to 1995, an understanding that was violated by Bill Clinton (wouldn't you know it!) who named Martin Indyk to the post. Indyk was not even an American citizen at the time and had to be naturalized quickly prior to being approved by Congress.

Those American Jews who are strongly attached to Israel and somehow find themselves in senior policy-making positions involving the Middle East and who actually possess any integrity on the issue should recuse themselves, just as any judge would do if he were presiding over a case in which he had a personal interest. Any American should be free to exercise First Amendment rights to debate possible options regarding policy, up to and including embracing positions that damage the United States and benefit a foreign nation. But if he or she is in a position to actually create those policies, he or she should butt out and leave the policy generation to those who have no personal baggage.

For those American Jews who lack any shred of integrity, the media should be required to label them at the bottom of the television screen whenever they pop up, e.g., Bill Kristol is "Jewish and an outspoken supporter of the state of Israel." That would be kind of like a warning label on a bottle of rat poison—translating roughly as "ingest even the tiniest little dosage of the nonsense spewed by Bill Kristol at your own peril."

As none of the above is likely to happen, the only alternative is for American citizens who are tired of having their country's national security interests hijacked by a group that is in thrall to a foreign government to become more assertive about what is happening. Shine a little light into the darkness and recognize who is being diddled and by whom. Call it like it is. And if someone's feelings are hurt, too bad. We don't need a war with Iran because Israel wants one and some rich and powerful American Jews are happy to deliver. Seriously, we don't need it.



Butchering the Iran Deal

• Mr. Trump: War with Persia not in America's best interests

ith his declaration Friday that the Iran nuclear deal is not in the national interest, President Donald Trump may have put us on the road to war with Iran. Indeed, it is easier to see the collisions that are coming than to see how we get off this road before shooting starts.

After "de-certifying" the nuclear agreement, signed by all five permanent members of the Security Council, Trump gave Congress 60 days to reimpose the sanctions that it lifted when Tehran signed.

If Congress does not reimpose those sanctions and kill the deal, Trump threatens to kill it himself.

Why? Did Iran violate the terms of the agreement? Almost no one argues that—not the UN nuclear inspectors, not our NATO allies, not even Trump's national security team.

Iran shipped all its 20% enriched uranium out of the country, shut down most of its centrifuges, and allowed intrusive inspections of all nuclear facilities. Even before the deal, 17 U.S. intelligence agencies said they could find no evidence of an Iranian nuclear bomb program.

Indeed, if Iran wanted a bomb, Iran would have had a bomb.

She remains a non-nuclear-weapons state for a simple reason: Iran's vital national interests dictate that she remain so.

As the largest Shiite nation with 80 million people, among the most advanced in the Mideast, Iran is predestined to become the preeminent power in the Persian Gulf. But on one condition: she avoid the great war with the United States that Saddam Hussein failed to avoid.

Iran shut down any bomb program it had because it does not want to share Iraq's fate of being smashed and broken apart into Persians, Azeris, Arabs, Kurds, and Baluchis, as Iraq was broken apart by the Americans into Sunnis, Shiites, Turkmens, Yazidis, and Kurds.

Tehran does not want war with us. It is the War Party in Washington and its Middle East allies—Bibi Netanyahu and the Saudi royals—who hunger to have the United States come over and smash Iran.

Thus, the congressional battle to kill, or not to kill, the Iran nuclear deal shapes up as decisive in the Trump presidency. Yet, even earlier collisions with Iran may be at hand.

In Syria's east, U.S.-backed and Kurd-led Syrian Democratic Forces are about to take Raqqa. But as we are annihilating ISIS in its capital, the Syrian army is driving to capture Deir Ezzor, capital of the province that sits astride the road from Baghdad to Damascus.

Its capture by Bashar Assad's army would ensure that the road from Baghdad to Damascus to Hezbollah in Lebanon remains open.

If the U.S. intends to use the SDF to seize the border area, we could find ourselves in a battle with the Syrian army, Shiite militia, the Iranians, and perhaps even the Russians. Are we up for that?

In Iraq, the national army is moving on oil-rich Kirkuk province and its capital city. The Kurds captured Kirkuk after the Iraqi army fled from the ISIS invasion. Why is a U.S.-trained Iraqi army moving against a U.S.-trained Kurdish army?

The Kurdistan Regional Government voted last month to secede. This raised alarms in Turkey and

Iran, as well as Baghdad. An independent Kurdistan could serve as a magnet to Kurds in both those countries.

Baghdad's army is moving on Kirkuk to prevent its amputation from Iraq in any civil war of secession by the Kurds.

Where does Iran stand in all of this?

In the war against ISIS, they were *de facto* allies. For ISIS, like al Qaeda, is Sunni and hates Shiites as much as it hates Christians. But if the U.S. intends to use the SDF to capture the Iraqi-Syrian border, Syria, Iran, Hezbollah, and Russia could all be aligned against us. Are we ready for such a clash?

We Americans are coming face to face with some new realities. The people who are going to decide the future of the Middle East are the people who live there. And among these people, the future will be determined by those most willing to fight, bleed, and die for years and in considerable numbers to realize that future. We Americans, however, are not going to send another army to occupy another country, as we did Kuwait in 1991, Afghanistan in 2001, and Iraq in 2003.

Assad, his army and air force backed by Vladimir Putin's air power, the Islamic Revolutionary Guard Corps of Iran, and Hezbollah won the Syrian civil war because they were more willing to fight and die to win it. And, truth be told, all had far larger stakes there than did we.

We do not live there. Few Americans are aware of what is going on there. Even fewer care.

Our erstwhile allies in the Middle East naturally want us to fight their 21st-century wars, as the Brits got us to help fight their 20th-century wars.

But Trump was not elected to do that. Or so at least some of us thought. \star

Al Jazeera Report 'Not Anti-Semitic'

• UK arbiter says media outlet's exposé of pro-Israel lobby groups was accurate

l Jazeera was recently cleared of bias by a leading journalism organization after it was attacked by pro-Israel groups earlier this year following the release of its four-part investigative series into the subversive and manipulative influences of the pro-Israel lobby in the United Kingdom.

The news organization is fast becoming a popular Internet and television news source founded in 1996. It is funded by the government of Qatar, a small yet oil-rich and extremely wealthy Middle Eastern nation.

The series, entitled "The Lobby," aired in January and focused on a number of aspects of the pro-Israel political lobbying apparatus that largely dominates the government and civil society of much of the United Kingdom, revealing its insidious nature and corrupt practices.

Across the Western world—especially in the United States and the United Kingdom—the various political lobbies, pro-Israel groups, and Jewish organizations comprising "The Lobby" have almost exclusive access to the highest levels of political and media power.

The pro-Israel lobby essentially dominates discussion of issues pertaining to Israel and the organized Jewish community, targeting and demonizing anyone who stands in their way. Simply opposing "The Lobby" or exposing or criticizing its actions is regularly equated with "anti-Semitism," a weaponized slur leveled against independent thinkers, anti-Zionist activists, and those that support the Palestinian struggle for independence and civil rights in the Jewish state.

The six-month investigative report revealed the various ways the pro-Israel lobby influences and manipulates British politics, British political leaders, student organizations, and civil society, among other aspects of British culture. The investigation exposed "how Israel penetrates different levels of British democracy," according to Al Jazeera, including the Israeli embassy's role in attempting to slander and discredit critics of Israel and the Zionist agenda in the Middle East.

Following the release of the investigative series, which drew global headlines and much consternation among the pro-Israel community, a number of complaints were registered with the Office of Communications, more commonly referred to as Ofcom, the United Kingdom's government-authorized telecommunications regulatory agency that establishes and enforces journalistic standards and ethics. Early last week, Ofcom dismissed those complaints, ruling that Al Jazeera did not violate any broadcasting rules in its undercover investigative series highlighting and expos-



ing the subversive influences of the pro-Israel lobby in the UK.

The complaints registered and ultimately dismissed by Ofcom were filed by a number of pro-Israel activists in the UK along with at least one official working at the Israeli embassy in London. The critics accused Al Jazeera of "anti-Semitism" and bias in its reporting, and argued that the undercover reporter who infiltrated the pro-Israel community to film the series violated privacy rights. **Clayton Swisher** is the director of investigative journalism for Al Jazeera news outlet. His division was accused of "anti-Semitism" and rule-breaking when it did an exceptional undercover exposé on how groups lobbying for Israeli interests in the UK were undermining the political process.

Every single complaint was dismissed by Ofcom, much to the dismay of the pro-Israel community.

"The fact that the programs uncovered evidence of inappropriate behavior by those acting on behalf of the Israeli government, or by those belonging to a small number of organizations that promote Israeli policy, does not mean that they were anti-Semitic," Ofcom boldly declared in a statement dismissing the complaints. "In the same way, programs that expose the violence associated with some black gang culture in Britain's inner cities are not, by default, racist."

Clayton Swisher, Al Jazeera's director of investigative journalism who also narrated the four-part series, was thrilled with Ofcom's ruling.

"We are extremely pleased with the verdict," Swisher stated following Ofcom's decision. "It overwhelmingly validates the revelations captured by our brave undercover, known as 'Robin.' Our entire team put a ton of care into making this film, under full legal review throughout. This totally vindicates our work and is a terrific verdict for all journalists exposing wrongdoing."

Saudi Royals, Israel Shape Mideast Policy

• Behind the scenes, two unlikely allies work together to suppress Shiite nations

here is growing evidence that President Donald Trump has abandoned his preelection promises about forging a new Mideast era. Instead, he appears to be handing the future of the region to the Israelis and the Saudis.

That would be a harsh judgement about our new president were it not for the fact that the evidence speaks for itself. His latest move to decertify the Iran nuclear deal, contrary to advice from U.S. allies like France and Britain, as well as Russia and China, which were signatories to the deal, is a rash move that has only been applauded by Israel and Saudi Arabia, two countries that would like to see Iran go down in flames.

On the very day, Oct. 13, that Trump unilaterally decided to upend the Iran deal, all the other signatories to the deal agreed Iran was in compliance. Congress will now have 60 days before the deal is likely to be wrecked entirely, placing the Middle East and perhaps the world in greater danger.

Secretary of State Rex Tillerson made the lame excuse that the president's decision was motivated by the fact that Iran was a sponsor of terror. He forgot to include the biggest sponsor of terror in the region, Saudi Arabia, which financed the 9/11 attackers, and Israel, which has been backing the al-Nusra Front in Syria among other groups. The Iran nuclear deal was never about Iran's involvement in the region, which has included fighting alongside U.S. forces to defeat ISIS in Mosul and now in Raqqa in Syria. Tillerson could also have included Washington in his terror argument since Barack Obama provided weapons to ISISconnected militants who launched the war in Syria to unseat the regime there.

But the Iran issue is not the only scenario that exposes the growing number of Trump administration Mideast failures. At the very start of his presidency, Trump launched his foreign policy with a visit to Saudi Arabia. The Saudis appeared to know he was vain and liked being treated like royalty because they laid on for his visit the kind of celebrations normally reserved for the queen of England. He did a sword dance with Saudi princes and genuflected before kissing the Saudi monarch's ring.

He also used the visit to announce a \$110 billion arms deal with the kingdom and has since agreed to sell them America's highly advanced THAAD missile shield. Contrast that performance with his pre-election attack on Hillary Clinton's Saudi connections when he said, "These are the people who treat women horribly and yet you take their money."

Recently, it was revealed that Saudi diplomats

spent almost \$250,000 at the Trump hotel in Washington.

Then there is the decision by the president to abandon UNESCO, a body the U.S. helped create in 1945, which has been critical of Israel's occupation of parts of the West Bank in contravention of international law. While it is not a bad thing that Trump is scaling back U.S. involvement in global groups, the reason for the U.S. departure is telling. Israel was thrilled by the president's decision to leave the body, largely because UNESCO had become increasingly critical of how the Israelis treat Palestinians.

More significant is the fact that Trump has abandoned his election promises to restore relations with Russia. By killing the deal with Iran, an ally of Russia, he is effectively souring relations with Moscow. He may also be creating a situation in which Iran will feel it needs to build nuclear weapons. That would give Israel the opportunity to attack Iran, leading to a war in which Russia would side with Tehran. The Middle East would go up in flames and Europeans would no doubt be faced with an even greater migrant crisis than the one that arose from the West's ongoing Middle East misadventures.

It should also be noted that more civilians have been killed in U.S. bombings in the region under this new president than under his predecessor who was fond of using missiles launched from drones. This could be due to the fact that Trump has removed much of the civilian oversight of the military in all war zones, including Afghanistan. Most observers agree that passing unfettered control of conflict to generals is never a wise move.

At the outset of his presidency, Trump demonstrated a flagrant naiveté when he handed Middle East decision-making to his son-in-law Jared Kushner, a rich kid who worked in his father's real estate business. He is known to favor Israel's vision of Middle East policy and calls Netanyahu a family friend.

People expected more from our new president, especially after he insisted before the election that he would take America out of foreign wars. \star

Vegas Shooting Timeline Makes No Sense

arely do America's mainstream newspapers evince skepticism toward official pronouncements about suspected false-flag events. But the problems with the police timeline of the Oct. 1 Las Vegas, Nev. massacre are so egregious that even the Los Angeles Times couldn't help but notice.

An Oct. 9 *Times* article is headlined "Las Vegas gunman shot security guard a full six minutes before opening fire on concertgoers, police reveal." The article, authored by three *Times* journalists, begins: "Police have dramatically changed their account of how the Las Vegas massacre began on Oct. 1, revealing Monday that the gunman shot a hotel security guard six minutes before opening fire on a country music concert—raising new questions about why police weren't able to pinpoint the gunman's location sooner."

The previous official story held that the lone gunman, Stephen Paddock, fired from his 32nd


floor hotel room on the crowd below from 10:05 to 10:15 p.m. Then at 10:15, using his surveillance cameras, he saw hotel security guard Jesus Campos in the hallway and unleashed a barrage of gunfire through the door, wounding Campos. Campos notified the authorities, who arrived shortly thereafter. But the police were apparently in no hurry to breach Paddock's room and ensure the safety of the people below. They didn't break into Paddock's room until 11:20, an hour later. When they finally did so, they discovered that Paddock was dead, supposedly from a self-inflicted gunshot.

The original timeline made no sense. Why would police linger for an hour outside the door of a mass shooter who had just killed more than 50 people and wounded hundreds—and who might still have guns and ammunition available with which to kill and wound hundreds more? Aren't SWAT teams trained to take heroic action, risking their lives if necessary, to kick in doors Above, a Las Vegas policeman stands in front of a vendor's station. and stop mass shootings?

It isn't surprising that the Las Vegas Sheriff's Department has seen fit to radically revise its original timeline. What is surprising, even shocking, is that the new timeline is even more absurd than the old one.

According to the new timeline, Paddock shot through his door, wounding Campos, at 9:59 p.m., six minutes before the mass shooting started. Campos must have immediately notified authorities. So by around 10 p.m., five minutes before the slaughter began, hotel security must have called 9-1-1 to report that someone had fired a burst of automatic gunfire on the 32nd floor.

When reports of a massacre began rolling in shortly after 10:05, police should have already known which floor and which room the suspect was shooting from. Yet they didn't bother to breach Paddock's door till 11:20 p.m.


The problematic Las Vegas timeline resembles the even more absurd official 9/11 timeline, which, as David Ray Griffin and others have shown, is riddled with inconsistencies and absurdities. On 9/11, we are told, the FAA and the military knew by around 8:15 a.m. that "hijackings" were underway. Yet there was no response from America's air defenses even as planes hit the Twin Towers at 8:46 and 9:03, crashed into the Pentagon at 9:37, and plunged into the ground in Shanksville, Penn. at 10:03.

My late friend Col. Robert Bowman, who flew more than 100 missions in Vietnam and headed the Star Wars Missile Defense Program under Presidents Ford and Carter, said he knew by the afternoon of Sept. 11 that it was an inside job. 

Vaccination Persecution Rampant

• Police states make forced vaccinations, jail time for parents more common

t hasn't yet gotten to the point that the growing American police state has begun force vaccinations on the populace, but it's getting close. On Sept. 27 in Michigan, Oakland County Circuit Judge Karen McDonald told Rebecca Bredow: "You have seven days to get your child vaccinated. If not, you will appear here Wednesday and, if you have not, I'll send you to jail. Let me say it one more time: You have seven days. It's ridiculous. Don't make me do that."


Ms. Bredow opposed the shots and stood on principle, so the following week Judge McDonald made good on her promise and found Ms. Bredow in contempt of court and sent her to jail.

While she was behind bars, her nine-year-old son's father—from whom Ms. Bredow had separated before the boy was born—vaccinated the boy while he had custody of him.

On her release from jail, Ms. Bredow said, "The jail, it was horrific. The conditions in there at that time, it was really, really hard, the conditions at Oakland County Jail. It was the worst five days of my life pretty much, except for the fact that I just found out that [my son] was vaccinated and I'm not going to get him back today to top that off. It's been a rough few days to say the least."

Incredibly, the maximum-security Oakland County Jail in Pontiac, Mich., built in 1973 with a general inmate population of around 440, was in the vaccine spotlight this past May when Oakland County Jail officials warned its inmates "they may have been exposed to hepatitis A."

"The jail population often comes with signifi-

cant health issues, such as cases of AIDS, tuberculosis, and hepatitis," the county's sheriff wrote in a statement.

Judge McDonald's on a roll doing the dirty work of Big Pharma. Incredibly, her court heard a second case on vaccines the week after Ms. Bredow was jailed, in which another divorced couple disagreed on whether or not to vaccinate their child. And yet again, Judge McDonald issued a court order in favor of the father's wishes to force vaccinate a child.

In that case, the parents are arguing "on whether or not to vaccinate their two-year-old daughter." The mom told Judge McDonald she objects to vaccines on both religious and medical grounds, and that "her family is pre-disposed to autoimmune injuries."

Every state in the union except for California, Mississippi, and West Virginia allow parents to opt out of vaccines for their children based upon philosophical and religious exemptions.

Earlier this year, data from the Centers for Disease Control and Prevention (CDC) indicated that nonmedical exemptions are declining across the country, but that's true only in some states. In Connecticut, Florida, Iowa, Kentucky, Maryland, New York, North Carolina, North Dakota, Ohio, Oklahoma, and Virginia "the number of kids not being vaccinated for nonmedical reasons is higher than at any point in the past five years."

Big Pharma's mouthpiece, the American Academy of Pediatrics, chimed in, "urging all states to eliminate nonmedical vaccine exemptions," claiming that these personal-choice exemptions are "inappropriate for individual, public health, and ethical reasons."


For parents concerned the police state might snare them in their vaccination net, of the states that still allow exemptions, the most parentchoice-friendly one seems to be North Dakota, where "nonmedical vaccinations went from 0.8% in 2010 to 3% last year."

"At some schools," said Molly Howell, the Rough Rider State's immunization program manager, "they just hand out the exemption forms." \star



Tax Cuts Won't Work Without Spending Cuts

• Many facets of Trump tax plan are good, but useless without budget reduction

resident Donald Trump and the congressional Republican leadership recently unveiled a tax reform "framework." The framework has a number of provisions that will lower taxes on middle-class Americans. For example, the framework doubles the standard deduction and increases the child care tax credit. It also eliminates the alternative minimum tax (AMT). Created in the 1960s, the AMT was designed to ensure the "wealthy" did not use "loopholes" to "get out of" paying taxes. Today, the AMT is mostly a means to increase taxes on the middle class.

The framework eliminates the "death tax," thus enabling family-owned small businesses and farms to remain family owned. It also helps the economy by lowering the corporate tax rate to 20%, reducing taxes on small businesses. The framework also adopts a territorial tax system, which means U.S. companies would only pay tax on profits earned in the United States.

However, the framework is far from a total victory for liberty. Concerns have been raised that, depending on what income levels are assigned to what tax brackets, the plan could increase taxes on many middle- and lower-income Americans. This is largely due to the framework's elimination of most tax deductions.

The framework also contains a stealth tax increase imposed via the chained consumer price index (CPI). Supporters of chained CPI claim the government is currently overstating inflation. The truth is exactly the opposite: Government statistics



are manipulated to understate inflation.

Chained CPI enhances the government's ability to lie about inflation. One way it does so is by claiming that inflation does not lower our standard of living if we can substitute cheaper goods for goods made unaffordable by inflation. So inflation does not harm you if you can't afford a steak dinner as long as you can still buy a cheeseburger.

Chained CPI allows the government to take maximum advantage of "bracket creep," where individuals are pushed into higher tax brackets not because they are actually earning more money, but because inflation creates the illusion they are wealthier. In fact, by decreasing their purchasing power, inflation makes most people poorer. The inflation tax thus raises taxes on declining incomes. It is hidden and regressive, making it the most insidious of all taxes.

Most of the framework's problems stem from Congress's continued refusal to offset tax cuts with spending cuts. Instead, Congress continues to increase spending, with the only real debate over whether the government should spend more on welfare or warfare.

Pairing tax cuts with increases in federal spending and debt—and the drafters of the framework admit their plan will increase the debt by at least \$2.2 trillion—means that the economic benefit from the tax cuts will be outweighed by the economic harm caused by the increase in debt. Increasing the debt also means the Federal Reserve will further devalue the dollar in order to monetize that debt. While the Republican tax and budget plans predict uninterrupted economic growth, the U.S. economy is far more likely to undergo a major economic crisis caused by a rejection of the dollar's world reserve currency status.

While all supporters of individual liberty and sound economics should support tax cuts, the Republicans' failure to cut spending means that their tax plan will do little to increase liberty or prosperity.

Instead of increasing debt, eliminating deductions, and relying on the inflation tax to "pay for tax cuts," Congress should cut two dollars in spending on the military-industrial complex and other forms of corporate welfare for every dollar in tax cuts. Cutting both taxes and spending is the only way to protect prosperity and liberty.

She told me they wanted to sell it and move to another city but there was asbestos in it and it could not be sold until all of it was removed. The cost of the removal was almost the price of the house, and I don't know what ever happened to it.

I went to a modern school building through 9th grade that had steam heat throughout all the rooms. The exposed pipes carrying the steam were all wrapped in asbestos. I have worked with asbestos for over 50 years and it is completely harmless unless you're sawing hard sheets of it for some time and breathing it in. It is not something that gives off some type of radiation or mold when you're close to it. The cell phones are doing far more harm to our people than all the asbestos in our buildings.

That brings up an interesting situation. The World Trade Center, including both towers, was loaded with asbestos and the owners were told to remove it. The cost of removal was astronomical to the point that they would have had to be demolished. Instead, they were sold for a few million dollars down and insured in the billions. The question then arises, how were they allowed to be sold with all the asbestos inside? 9/11 took care of the problem by eliminating the asbestos and making billions doing it, by killing 3,000 of our people in the planes and towers, while thousands of New Yorkers are now dying as a result of inhaling all the asbestos dust.

We now have the big mercury scare. I have also worked with mercury for over 50 years. I have held it in my hand many times and I would not hesitate to do it today. For many years millions of us have had fillings in our teeth that contain mercury. Why is it allowed to be used in vaccinations on babies if it's as bad as they say it is? Last year a small bottle of mercury was spilled on a street in Green Bay. Instead of just cleaning it up, they called a Hazmat team up from Milwaukee, a hundred miles away. I can imagine that they were laughing all the way up and back.

Years ago, we had the big fear of freon, promoted by the environmentalists and the EPA to stop the use of it as it was "responsible for skin cancer." It was the Bronfmans, the richest family in Canada, who were responsible for the scare, and made their fortune through their ownership of Seagram's Liquor and the Canadian Pacific Railroad that was also used during our years of prohibition to ship their liquor into the States. They also own one of our Hollywood movie studios. But what do they have to do with freon?



At that time, the DuPont company came out with a substitute for freon. The Bronfmans then bought controlling interest in the company and turned the environmentalists and the EPA loose and banned the use of freon. Overnight the cost of a simple filling of freon in a car for \$25 jumped up to over \$100 or much more. The costs to retail stores as well as office buildings were staggering. All the car dealerships had to buy new equipment to fill the air conditioners. Any small repair shops caught using freon were fined heavily. With the government on their side it was like a license to steal, and steal by the millions they did. To prove what a complete fraud this was, I'll mention the following.

Lewis du Pont Smith, in an April 27, 1994 open letter to shareholders on DuPont's CFC policy, warned that DuPont Corporation will be destroyed when a consumer backlash demands a congressional investigation "regarding the science behind the ozone depletion fraud and the economic forces that pushed for the CFC ban."

This descendant of the company's founder accuses Edgar Bronfman, Charles Bronfman, and Charles Bronfman Jr., Canadians who own 25% of DuPont, have led the whole international campaign, including the Montreal Protocol, to phase out CFCs. Lewis du Pont Smith calls this CFC policy "the most massive consumer fraud of this century."

A few decades ago we had a big problem regarding the Sierra Club and the lumber companies cutting down the trees out west. The Sierra Club along with many other groups were founded and financed by the cabal that controls our government and media. Our government also has groups that work with the Sierra Club. They represent and act according to their benefactors, which include big business. Weyerhaeuser is the largest name in the lumber and related businesses. The "tree huggers" were sent to the forests that were not owned by the Weyerhaeuser giant to eliminate their competitors by driving nails into the trees, which injured the climbers needed to trim the trees, along with all kinds of other dirty tricks. The Sierra Club along with all the other groups do not represent us or the environment, and they have been responsible for the closing or bankrupting of many factories, with the loss of thousands of jobs.

In 1996 GM came out with the EV1, an all-electric car that was leased only through Saturn dealerships. Initially it had a range of only 40 miles, but later that grew to 160 miles without a recharge, and would go over 60 miles an hour. It appeared different from the front, as it had no need for a grill. When the leases expired, consumers were not allowed to buy the cars from the dealers no matter how much they were willing to pay. They were then driven to the salvage yards. When I went to Google I saw a row of about 10 EV1s stacked about four high waiting to be turned into scrap.

These were great cars to be used in any suburban area, especially in LA and the surrounding area where "everyone" has a car. It would eliminate much of the carbon emissions that hang in that area. You would think the environmentalists would be out in droves fighting to keep the electric car, but they all remained silent along with the EPA. Can you think of any cartel big enough, rich enough, and powerful enough to buy off or threaten General Motors from making cars that did not need gasoline? They also have cars now that can run on compressed air with a range of about 30 miles, good enough for shopping or working around town. They have also come a long way with cars that run on hydrogen.

This was written about five years ago, and about two years later I received an email that adds much credence to what I have written. The first paragraph validates what I have stated:

The alarmists keep telling us their concern about global warming is all about man's stewardship of the environment. But we know that's not true. A United Nations official has now confirmed this. At a news conference last week in Brussels, Christiana Figurers, executive secretary of UN's Framework Convention on Climate Change, admitted that the goal of environment activists is not to save the world from ecological calamity but to destroy capitalism.

I think they have done a great job.

What a cop-out and what an insult. And all of this "social protest" is coming from people who make 10 to 40 times more money a year than a fan.


