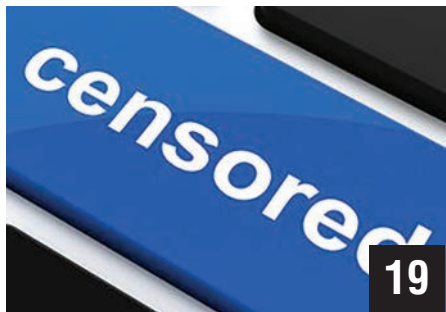

A PERSONAL MESSAGE FROM THE EXECUTIVE EDITOR

The Media Is the Enemy? No Kidding . . .

Echoing what AFP has been saying since its founding, President Donald Trump took to the Internet to declare on Feb. 17: The media “is the enemy of the American people.”

At the time, he was giving both barrels to the mainstream media, more specifically, CNN, NBC, CBS, MSNBC, *The New York Times*, *The Washington Post*—all of those billion-dollar media conglomerates that for decades have maintained a stranglehold on what kind of information Americans get access to. They had been attempting to ridicule Trump for commentary he gave during a rally about the rising violence in Europe due to mass immigration. But it didn't work. Instead, Trump turned his back on the media outlets, blasting them for supporting dangerous immigration policies that put Americans at grave risk.

To be fair, Trump has actually had harsher words for the media, calling them liars and fakes. But his latest broadside has been getting a lot of attention. Everyone is talking about it, and it's chipping away at the mainstream media's dwindling credibility.

Think about it for a second. Go back to election day on Nov. 8 when every single media outlet—even Fox News—claimed that Democratic presidential candidate Hillary Clinton was going to take the White House in a landslide. Despite the fact that even their own polls showed Mrs. Clinton and Trump neck and neck over the course of the presidential campaign, all of the major news outlets in America called it for Mrs. Clinton early in the day, long before the final votes had even been cast.



He said what everyone should know by now.

We all know what happened, however. As the votes rolled in, and more and more states went for Trump, the highly paid political prognosticators couldn't have been more wrong. Trump swept the country, winning 30 out of 50 states, turning most of the U.S. a solid, bright Republican red. In fact, Trump won more counties across the U.S. than any Republican presidential candidate has in the past four decades.

But while the nattering class should have been humbled after this humiliating embarrassment, the talking heads instead went on an offensive and have been attacking every move Trump and his staff have made, mocking, exaggerating, and even lying about what has been done and twisting every word he has said.

Take, for example, Trump's immigration policies. On page nine in this week's issue, AFP writer Ronald Ray takes an in-depth look at immigration, pointing out that, so far, arrests and


deportations under Trump have not even been as aggressive as President Barack Obama's were during his first term.

In truth, none of this should come as a surprise. Since our founding in August 2001, AFP has been saying that the big media is the enemy. Owned and controlled by a couple of billionaires and a shrinking number of corporations, the mainstream media is completely out of touch with most of America. They savagely attack anyone who rejects globalism and puts America first. News You May Have Missed

2.1 Million Illegal Voters

According to a recent study, as many as 2.1 million illegal aliens voted (mostly for Hillary Clinton) in the November election. The mainstream press has been lampooning Donald Trump for saying so, but it turns out he hit the nail on the head. “A sizable number of non-citizens in the U.S. are registered to vote,” said James Agresti of Just Facts. That flies in the face of claims by many media outlets and so-called fact checkers. Trump says he lost the popular vote because of the illegal voters.

Illegal Settlements

President Donald Trump is following through about Israel’s illegal Jewish settlements on Palestinian land. Neo-“conservatives” and other blind supporters of the Israeli state have long contended the settlement issue is an internal matter for the Israelis to decide. Trump’s principled stand is bound to ruffle some Zionist feathers. During a joint press conference at the White House with Israeli ruler Benjamin Netanyahu, Trump told the Israeli: “I’d like to see you hold back on settlements for a little bit. We’ll work something out, but I would like to see a deal be made.”

Trump Proven Right

President Donald Trump was mocked by the mainstream media for mentioning Sweden alongside a list of European targets of terror during a recent rally. Trump later said his remarks were in response to a Fox News report on Sweden’s refugee crime crisis. Sweden’s official Twitter account on the Internet tweeted at Trump on Monday morning: “Hey Don, this is Sweden speaking! It’s nice of you to care, really, but don’t fall for the hype. Facts: We’re OK!” Hours later, however, a town in Sweden that is mostly made up of immigrants exploded in riots. A dozen cars were torched, and many stores saw looting, according to Swedish newspapers. A photographer from media outlet *Dagens Nyheter* said a group of 15 people beat him as he tried to document the chaos. Liberals are now blaming Trump’s comments for the riot. McCain a Security Threat

Russian comedians Vladimir Kuznetsov and Alexei Stoliarov recently called Sen. John McCain (R-Ariz.), pretending to be the prime minister of Ukraine Volodymyr Groysman in a prank phone call. According to news



reports, the two funnymen got McCain to discuss key national security issues on U.S. policy toward Ukraine and Russia, including an offer to send weapons for the civil war there and increase sanctions against Moscow.

Hyping Hate Crimes

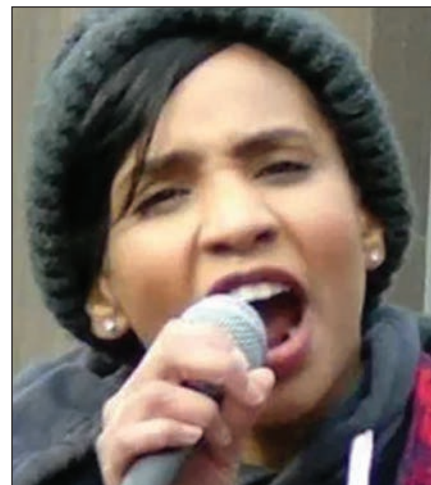
Recent news detailing a purported rash of bomb threats in the U.S. this year is nothing new. In 2016, there were over 1,200 bomb threats called into schools across the country. This compares to a recent press release issued by the Anti-Defamation League (ADL) that claimed as many as 50 Jewish community centers had been targets of bomb threats this year. In the release, the ADL said this was a sign that anti-Semitism is on the rise in the U.S. While AFP does not condone violence or threats to innocent people, it’s worth mentioning that one crazy person in the U.S. could have easily made all of the calls to the religious institutions—hardly a sign of anything other than a nut was trying to scare people. The FBI is reportedly investigating the bomb threats—all of which have turned out to be hoaxes—but has not released to media outlets any specifics on the calls such as whether or how many different people made them or from where the calls were placed.

Trump Agrees: The Media is the Enemy

• Mainstream media wages relentless war on the credibility of the president

Donald J. Trump has singlehandedly knocked the bought-and-paid-for press off its exalted throne as the self-appointed czars of “real news.” That’s right. He said it. “The media is the enemy.” Now the elite media is scrambling frantically to try to explain to viewers why anyone should be listening to them at all. They have been humiliated. And, to make matter worse for them, the president continues to take his message straight to the American public, bypassing the cringing gatekeepers of “truth” who formerly had a monopoly on what you could hear or watch or read. They are like the emperor with no clothes—hoping desperately nobody notices they are altogether in the raw—birthday-suit, buck-naked bare for all to see.

Right now, the masters of the controlled media are frantically lashing out with all the ammo they have in their once formidable arsenals in a vain attempt to hold their slipping grip on whatever diminishing shred of relevance they can to maintain their lucrative dominance of the news business.

Fortunately for that segment of the American public that thinks with their brains and not their buttocks, they realize the bombs and bullets being fired at Trump are duds. Their con game is over.

And even as they try to tell us Trump is the liar, another massive news outlet has been caught running with a story that none of their reporters bothered to check. This latest example of shoddy reporting comes from Germany.

The tabloid *Bild*, with the eighth-largest circulation (2.5 million) of any newspaper worldwide, apologized to its readers for an article that claimed “a ‘mob’ of Arab men had sexually assaulted women . . . in a Frankfurt restaurant.” The police admit they can find no evidence of the event.

Following the Frankfurt police confession, *Bild* was forced to make its public *mea culpa*. *Bild* pledged an internal review and emphatically apologized for this fake report, but their credibility is ruined. Even worse, though, *Bild* failed to reiterate that dozens, if not hundreds, of immigrants from the Mideast and north Africa had in fact attacked, robbed and, in some cases, sexually molested dozens and dozens of innocent German men and women in Cologne, Hamburg, Dortmund, Düsseldorf, Stuttgart, and Bielefeld last New Year’s Eve.

In Stockholm, Sweden, events there involving immigrants further embarrassed the entrenched media and, as a result, vindicated their favorite target of late, Donald Trump, after he evoked the consequences of allowing unchecked immigration into Western nations at a Florida rally. “You look at what’s happening in Germany, you look at what’s happening in Sweden. . . . Sweden! Who would believe this? Sweden. They took in large numbers [of

immigrants]. They’re having problems like they never thought possible,” Trump said.

Trump’s statements unleashed a firestorm of vitriolic attacks against him. The U.S. news media in particular was slaving to make him look like a racist xenophobe and convince listeners the America-first president was lying, and that all was just dandy in Sweden. Their celebration was short lived.

Just several days after his Florida comments, violent riots broke out in a “refugee” suburb of Stockholm after an immigrant drug dealer was stopped by police and shots were allegedly fired. Outraged immigrant hooligans set cars ablaze, looted local stores, and threw rocks at cops, injuring several officers, Swedish officials confirmed.

These riots—as well as statistics—back up Trump’s claims. Reports of rapes in Sweden jumped 13% in 2016 compared to 2015, and reports of sexual assaults were up 20%, according to data from the Swedish National Council for Crime Prevention. Liberals claim this is because more people are required to report sexual assaults. They insist that no real rape or immigrant problem exists in Sweden. Who are they kidding? Not you nor me.

THE MEDIA IS THE ENEMY

The same day as Trump’s Florida rally, White House Chief of Staff Reince Priebus said during an interview with CBS’s “Face the Nation” that his boss should be taken seriously when he calls the media

“the enemy.” Trump had tweeted: “The FAKE news media . . . is not my enemy, it is the enemy of the American people!”

Readers of this newspaper have known for years that this was a slogan of the late, great Michael Collins Piper, who used it not only in his own writings, but in promotional material for AMERICAN FREE PRESS. He wrote more than 15 years ago:

The Media is the Enemy. In the old Soviet Union, the government controlled the media. Not a word of substance could be published without prior approval from the Bolshevik commissars. Today, in the U.S., the situation is starkly similar. But most Americans don’t know it. In America today, it is a select handful of super-rich families and tightly knit financial interests—a plutocratic elite—who own the Big Media and who control the government through their ownership of that media. . . . Every single one of the major media outlets is controlled by this powerful interlocking combine.

When Sebastian Lukacs Gorka, a legal immigrant to this country now serving as a deputy assistant to President Donald Trump, was asked by a BBC reporter during an interview about the president’s plans regarding the controlled press, he said:

We are going to continue to do what we did very, very successfully [during the campaign] . . . which is to break your . . . monopoly on the news. . . . The mainstream media no longer gets to monopolize news, and we are going to go straight to the audiences, whether it’s through Twitter, whether it’s through YouTube, it doesn’t matter. We are not going to put up with [the] distortions of people who believe they have a monopoly on the truth simply because they have 60 years of a letterhead above them.

That’s right, folks. The media is the enemy. And for the first time we can remember, the president of the United States has said so in public.

TIME FOR A BOYCOTT

AFP urges you to boycott all mainstream news outlets—TV, radio, and Internet sites. Boycott Hollywood films that promote perversion (almost all do). Don’t listen to these far-left, out-of-touch, multi-millionaire stars or latenight idiotic comics like Stephen Colbert, Jimmy Kimmel et al. Is the Left Playing With Fire Again?

• Liberals would do well to remember what happened in the 1960s and 1970s

To those who lived through that era that tore us apart in the 1960s and 1970s, it is starting to look like *deja vu* all over again. And as Adlai Stevenson, Bobby Kennedy, and Hubert Humphrey did then, Democrats today like Chuck Schumer and Nancy Pelosi are pandering to the hell-raisers, hoping to ride their energy to victory.

Democrats would do well to recall what happened the last time they rode the tiger of social revolution. As the riots began in Harlem in 1964 and Watts in 1965, liberals rushed to render moral sanction and to identify with the rioters.

“In the great struggle to advance civil and human rights,” said Adlai at Colby College, “even a jail sentence is no longer a dishonor but a proud achievement. . . . Perhaps we are destined to see in this law-loving land people running for office . . . on their prison records.”

“There is no point in telling Negroes to obey the law,” said Bobby. To the Negro, “the law is the enemy.”

Hubert assured us that if he had to live in a slum, “I could lead a mighty good revolt myself.”

Thus did liberals tie themselves and their party to what was coming. By 1967, Malcolm X had been assassinated, Stokely Carmichael with his call to “Black Power” had replaced John Lewis at the Student Nonviolent Coordinating Committee (SNCC), and H. Rap Brown had a new slogan: “By any means necessary.”

Came then the days-long riots of Newark and Detroit in 1967 where the 82nd Airborne was sent in. A hundred cities were burned and pillaged following the assassination of Dr. Martin Luther King on April 4, 1968.

And what happened in our politics? The Democratic coalition of FDR was shattered. Gov. George Wallace rampaged through the Democratic primaries of Wisconsin, Indiana, and Maryland in 1964, then ran third-party and carried five Southern states in 1968.

His presidency broken by Vietnam and the riots, Lyndon Baines Johnson (LBJ) decided not to run again. Vice President Humphrey’s chances were ruined by the violent protests at his Chicago convention, which were broken up by the club-wielding cops of Democratic Mayor Richard J. Daley.

Race riots in the cities, student riots on campus, and that riot of radicals in Chicago helped deliver America to Richard Nixon.

Came then the huge anti-Nixon, anti-war demonstrations of the fall of 1969, the protests in the spring of 1970 after the Cambodian invasion and the Kent State killings, and the Mayday siege by thousands

of anarchists to shut down D.C. in 1971.

Again and again, Nixon rallied the Silent Majority to stand with him—and against them. Middle America did. Hence, what did its association with protesters, radicals, and Black Power militants do for the Democratic Party?

Where LBJ swept 44 states in 1964 and 61% of the vote, in 1968 Humphrey won 13 states and 43%. In 1972, Nixon and Spiro Agnew swept 49 states, routing the champion of the countercultural left, George McGovern.

And the table had been set for California Gov. Ronald Reagan, who defied campus rioters threatening him with violence thusly: “If it takes a blood-bath, let’s get it over with.”

Without the riots and bombings of the 1960s and 1970s, there might have been no Nixonian New Majority and no Reagan Revolution.

Today, with the raucous protests against President Donald Trump and his travel ban, the disruption of congressional town hall meetings, the blocking of streets every time a cop is involved in a shooting with a black suspect, and the rising vitriol in our politics, it is beginning to look like the 1960s again.

There are differences. In bombings, killings, beatings, arrests, arson, injuries, and destruction of property, we are nowhere near 1968.

Still, the intolerant left seems to have melded more broadly and tightly with the Democratic Party of today than half a century ago.

Where Barry Goldwater joked about sawing off

the East Coast and “letting it drift out into the Atlantic,” Californians today talk of secession. And much of Middle America would be happy to see them gone.

Where Nixon was credited with the “cooling of America” in 1972, and Reagan could credibly celebrate “Morning in America” in 1984, any such “return to normalcy” appears the remotest possibility now.

As with the EU, the cracks in the U.S. seem far beyond hairline fractures. Many sense the country could come apart. It did once before. And could Southerners and Northerners have detested each other much more than Americans do today?

Fifty years ago, the anti-Nixon demonstrators wanted out of Vietnam and an end to the draft. By 1972, they had gotten both. The long, hot summers were over. The riots stopped.

But other than despising Trump and his “deplorables,” what great cause unites the left today? Even Democrats confess to not knowing Hillary Clinton’s presidential agenda.

From those days long ago, there returns to mind the couplet from James Baldwin’s famous book *The Fire Next Time*, from which he took his title: “God gave Noah the rainbow sign/No more water, the fire next time.” ★

Trump Needs to Stand Ground on Illegals

• Media, liberal hysteria over raids on immigrants is all part of fake news propaganda

During the week of Feb. 12, 2017, U.S. Immigration and Customs Enforcement (ICE) arrested 683 illegal aliens in targeted enforcement actions across at least six states around the country. To hear the caterwauling of pro-alien-invasion organizations and the shrieking banshees in the lamestream media, one would think that President Donald Trump's new administration had unleashed Armageddon on the world. But what is the reality, and how does it compare to actions of past presidential administrations?

In point of fact, no massive roundup of foreigners occurred. There were no "checkpoints" with jackbooted thugs asking for "papers, please." An Associated Press story alleging that Trump had called for 100,000 National Guardsmen to be used to apprehend illegal invaders was, sadly, just more "fake news" that was quickly debunked.

To provide some perspective on the mid-February ICE enforcement actions, however, that agency tweeted out statistics from a single Obama-era roundup, which apprehended 3,168 illegal aliens—over 350% more than the Trump administration efforts so far. In fact, of the 950,062 aliens who have received deportation orders—a small percentage of all the invaders—only 11,006 are in ICE custody.

Rather, the entire narrative created by media presstitutes around a routine and unremarkable ICE action is just another example of hysterical internationalist agitprop—"agitation and propaganda"—intended to hamstring any effort by Trump to rein in the crushing flood of foreigners illegally invading the United States. While most average citizens may not be fooled, many in Congress tend to be terrified of the George-Soros-backed "rent-a-mob" crowd.

It has not been without effect, as the president seems to have backed away from his promise to "immediately terminate" Barack Obama's "Deferred Action for Childhood Arrivals" program (DACA). That executive amnesty policy allows the "Dreamer" children and youths, who came here illegally and are now exploiting our educational system for their personal benefit, not only to siphon off educational resources and funding from taxpayers but even to obtain work permits and take jobs away from Americans as well. Trump apparently has stated that he now will "show great heart" toward the increasing waves of young lawbreakers, over 750,000 of whom have taken advantage of the DACA amnesty.

Seen historically, both voluntary and involuntary "removals" of illegal aliens increased significantly, year after year, from 2001 to their peak of 409,849



immigration arrests across the country over the past few weeks were planned while Barack Obama was president and could be compared to similar operations that occurred during the summer of 2016, according to Immigration and Customs Enforcement officials. And, contrary to reports, President Trump is not targeting "innocent" families, but illegal immigrant criminals—drug dealers, gang members, etc. All of this is part of the fake news generated to discredit Trump.

in 2012—more than doubling during that time. Since then, the numbers have declined significantly due to Obama's realignment of enforcement priorities. Fiscal year 2016 removals (240,255) were lower than any time since 2004, except FY2015.

That is not the full story, though. Because of apparent federal reluctance or inability to provide actual numbers of those reaching this country illegally, it is impossible to know if the percentage of them apprehended has increased at a proportionate or greater rate. But given the rapidly increasing numbers of aliens getting past the border, it must be supposed that the arrest and deportation rates have declined significantly relative to the overall foreign-born population in the U.S.

Trump has his work cut out for him, if he is to honor his promises to the American people. It is not just Democrats trying to undermine American society through an unrestricted influx of immigrants, illegal and legal. It is also a large share of Republican politicians, who, under pressure from the likes of the U.S. Chamber of Commerce and greedy corporate executives, want to ensure an unending supply of wage slaves for the plutocrats, no matter the cost to the nation's citizens.

Still, some positive progress is being made. Secretary of Homeland Security John F. Kelly has submitted two memoranda for review, intended to implement Trump's immigration executive orders. Although some modifications are expected, the new directives when approved would authorize the hiring of up to 10,000 new ICE agents and 5,000 Border

Patrol officers.

According to *The Washington Post*, the administrative changes would also "expand the pool of immigrants who are prioritized for removal, speed up deportation hearings, and enlist local law enforcement to help make arrests. The new directives would supersede nearly all of those issued under previous administrations." Particularly noteworthy is the desire to expand cooperation with local law enforcement to halt illegal immigration by increasing the number of communities where police or sheriff's deputies are also deputized to act as federal immigration enforcement agents.

According to Brandon Judd of the National Border Patrol Council, America's southern border is already seeing a noteworthy drop in attempted illegal crossings, as fear of increased ICE activities spreads. Just the talk of stepped-up enforcement has had a deterrent effect. Illegal aliens are already re-considering whether to remain in the U.S.

Regaining control of America's borders and eliminating the illegal invader problem are essential to maintaining the United States as a sovereign nation and to preserving our part in Western civilization. While it is too early to know how successful Trump will be in the effort, we hope he will keep his campaign promises, and we urge all of our readers to contact the White House and tell Trump to make America safe from illegal invasion again. ★

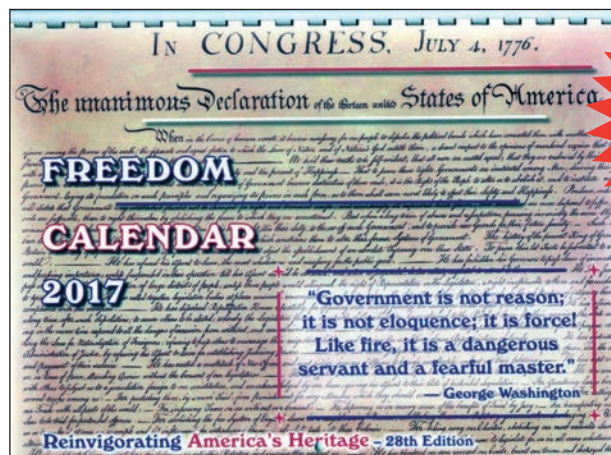

Immigration's Sociological Impact

• Author explains why greatest threat is the multicultural “clash of civilizations”

Author Samuel P. Huntington wrote in *The Clash of Civilizations and the Making of World Order*: “It is my hypothesis that the fundamental source of conflict in this new world will not be primarily ideological or primarily economic. The great divisions among humankind and the dominating source of conflict will be cultural. Nation states will remain the most powerful actors in world affairs, but the principal conflicts of global politics will occur between nations and groups of different civilizations. The clash of civilizations will dominate global politics. The fault lines between civilizations will be the battle lines of the future.”

As an American, living in a high-speed, highly technological society, how would you respond if suddenly someone flew you out of your home and transported you to an African village in Sudan or Somalia? What if a plane lifted you out of Chicago and transported you to Calcutta, India?

What would you do when you arrived? First of all, you would realize there's no housing, no toilets, no safe food, no clean water, no jobs, no familiarity with a radically different culture and no ability to speak the language. No matter how smart, old or skilled, you would not recover from the shock of being injected into a third-world society. You would huddle with your own until rescued. But if not rescued, you would live in oblivion.

Fast forward: What if you were a Somalian, Sudanese, Ethiopian or Congolese citizen transported by the U.S. government to save you from starvation and war? You arrive in America with no skills, no job, and no language ability, and you find a culture diametrically opposed to your own.

Once in America, because you lack any qualifications for work, you enjoy free food, free housing, free medical care, free education, a free car, free gasoline, free clothing—all paid for by working Americans, who are having their own troubles paying the bills.

From there, your kids fail in school because education standards run beyond their previous schooling. You combat new ideas of women's rights, free choice of religion, and free speech and try to cope with living in an ultra-high-speed society. Because you lack skills, educational abilities and a comprehension of American culture—you live in enclaves with your fellow immigrants and become permanent wards of the state.

This is not fake news. These are the facts

today. Every year, legal immigrants cost American taxpayers \$113 billion annually with no end in sight.

This fact must also be realized: Today, American industry robotizes redundant jobs at an astounding rate of speed. Robots now can make fast food completely without human hands. Automobile lines complete a car 90% by robots. Crops see machines plant and pick everything going to market.

Let's look ahead to 30 years from now, assuming the U.S. government continues the 1965 Immigration Reform Act that brings in 110,000 unskilled refugees every 30 days and 1.5 to 1.7 million legal and illegal refugees annually. In the next 30 years, that equates to our country adding 100 million legal immigrants from 190 different countries with 190 different worldviews. That means we import 100 million people with 190 different cultures, 190 different religions, and 190-plus different languages.

We cram them into America in three short decades—so fast that they cannot and will not assimilate. They form tribal enclaves like in Minneapolis, Minn. where 120,000 Somali immigrants created “Somaliland,” where Americans avoid them and the majority exist on permanent welfare, as well as “Dearbornistan” in Michigan, with 350,000 Middle Eastern immigrants, where Arabic dominates, and schools teach from the Koran. They do not subscribe to anything American, and, again, many live on welfare.

Yet the United Nations, Lutheran churches, Catholic churches, and others force those refugees into every town that features a welfare office—knowing full well it will be next to impossible for those refugees to become functioning parts of the American workforce. And worse, those organizations understand that places like Africa, India, and Indochina continue adding 80 million new babies, net gain, annually—so the line of refugees never ends.

On a sociological level, America, Europe, Canada, and Australia find their countries becoming “everybody else's countries.” Whether it's the impact of cultural conflict, religious conflict, or linguistic chaos, first world countries will not survive the “Clash of Civilizations.”

All cultures and ethnic groups compete for dominance. With 100 million added immigrants from 190 different countries by 2050, the U.S. finds those millions pulling for their own culture, ethos, language, and religion.

America today is already fractured and fragmented in the big cities with Black Panthers and Black Lives Matter calling for a separate black country. With the advent of more Africans and Muslims, you will see them demanding their own local representation in the U.S. much like Europe.

If you Google: Nursing Sisters Port Dover, you’ll see a book by Harry B. Barrett. In that book are pictures of my grandmother and her heroic nursing sisters during WWI, including one sister who was mentioned in wartime dispatches for her heroism along with a certificate presented to her by King George V. (In spite of her “valor in the face of the enemy,” a woman was ineligible to receive the Victoria Cross!)

There are hundreds of letters and pictures, including one of the ambulances my grandmother donated (before we entered WWII) encouraged by her friend, suffragist CARRIE CHAPMAN CATT, who moved around the corner from my grandmother in New Rochelle, N.Y. As a youngster, I remember all the sewing machines and their many friends at my grandmother’s house sewing thousands of pre-die cut clothes together to keep children warm during the brutally cold English winters. Carrie Chapman Catt also founded

the League of Woman Voters and is most famous for her Congressional speech resulting in the 19th Constitutional Amendment that gave woman the right to vote in 1920!

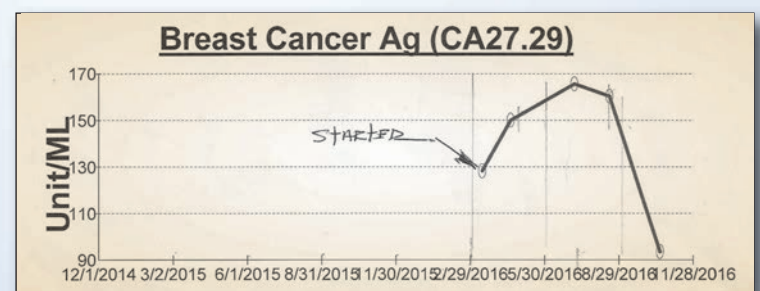
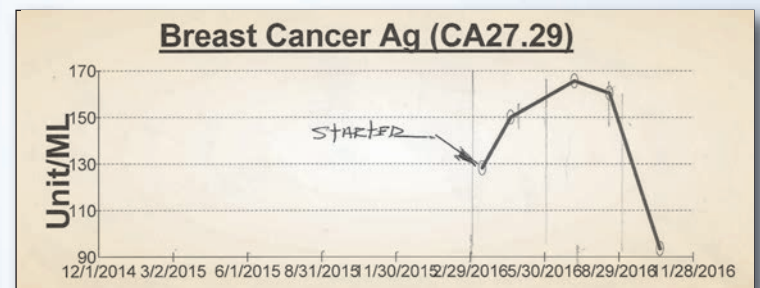
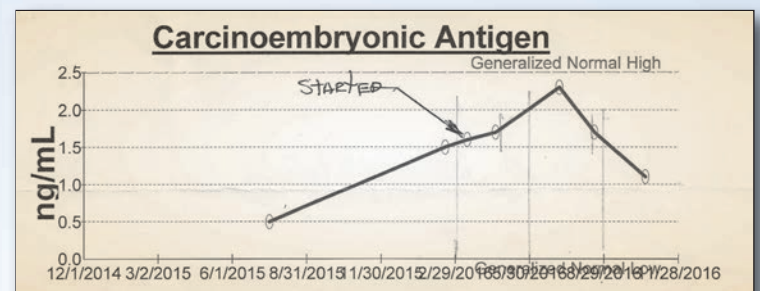

College Student Is Suspended for Filming Anti-Trump Racist Rant

Earlier this month AMERICAN FREE PRESS reported on the ongoing case of tenured professor and award-winning media analyst Dr. James F. Tracy, who was fired last year from Florida Atlantic University (FAU) for blogging on his own time. Now, a student clear across the country is in the crosshairs of school administrators for exercising his right to free speech. Like Tracy, he's fighting back.

In a surreal twist that highlights the grasp the liberal left has on possibly all college campuses across the country, a psychology instructor who went on a wild verbal rampage, spewing anti-Donald Trump comments to her students, will not face any disciplinary action, but the student who filmed the inappropriate invective will.

Caleb O'Neil, 19, a California freshman student at Orange Coast College (OCC), who secretly filmed Olga Perez Stable Cox's rant, will be suspended from the college for an entire semester unless he apologizes.

O'Neil, who wore pro-Trump attire regularly, said he began filming Ms. Cox "because I was honestly scared that I would have repercussions with my grades because she knew I was a Trump supporter."

"O'Neil is suspended for a full semester and the summer term," reported the *Orange County Register*. "Before being readmitted, he must

write a letter of apology to Cox and a three-page, double-spaced essay explaining his actions and provide his analysis of the aftermath."

When O'Neil anonymously sent the video to the college's Republican Club and they put it online, a barrage of complaints against Ms. Cox followed, sending her "into hiding to avoid the criticism, including death threats."

Ms. Cox, who is a lesbian, told the *Orange County Register*: "My privacy has been demolished. And that's awful. I'm a very private person. And it's very scary."

Ms. Cox and "her longtime partner, who asked not to be identified . . . left town for about a week last month because . . . they feared for Cox's safety following angry emails and threats, including one that displayed her home address. Her last week of classes was canceled. The couple disconnected their home phone. They are considering a safety alarm system."

Ms. Cox, who is 66 years old, was born in Cuba and immigrated to the U.S. in 1961. She has been an instructor at OCC for 30 years and obviously felt comfortable intimidating those students who didn't share her particular views.

Here's what she told students in her human sexuality class a week after Trump's stunning electoral victory, which shed light upon her warped mental state:

[Trump is] a white supremacist and [Vice President Mike Pence] is one of the most anti-gay humans in this country. Our nation is divided. We have been assaulted. It is an act of terrorism. . . . We are way beyond Republicans and De-

mocrats, and we're really back to being [in] a civil war. And I don't mean it in a fighting way, but our nation is divided as clearly as it was in Civil War times, and my hope is that we will get some good leadership to help us to overcome that. We are the majority; more of us voted to not have that kind of leadership, and we didn't win because of the way our Electoral College is set up, but we are the majority. One of the things I'm doing to cope, is to look for positive messages and glimmers of hope.

Feb. 15 O'Neil filed an appeal with the school.

On Feb. 21, the U.S. district judge assigned to Dr. Tracy's lawsuit issued an order denying FAU's motion to dismiss the case, requiring the defendants to answer Tracy's amended complaint within seven days. "Great news," wrote Tracy's attorney to this reporter when he emailed the order, the same day as the decision. ★

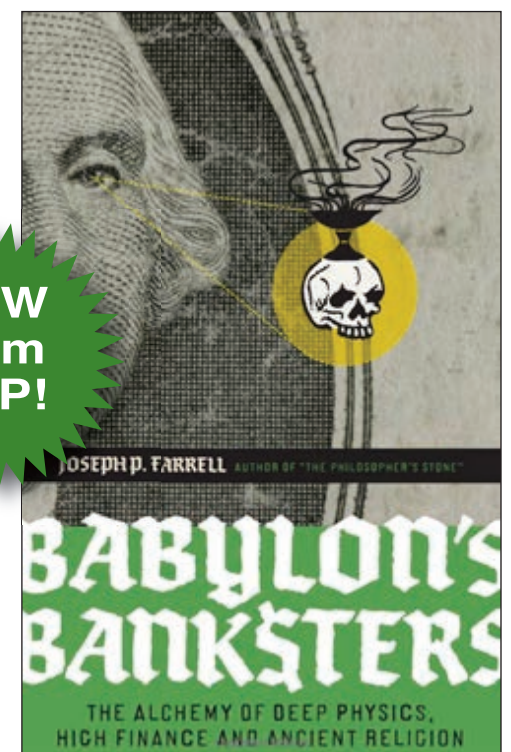

Iran Responds to Trump Threats by Announcing Currency Change

- Iranians says they will replace U.S. dollar as exchange currency

In the wake of President Donald Trump's controversial executive order restricting immigration from seven predominantly Muslim countries, Iranian officials say they are preparing to stop using the U.S. dollar in official financial reporting, according to Iran's PressTV. Iran is among the countries Trump's executive order targets for restricted immigration into the U.S. and much stronger vetting by customs and law enforcement officials of potential visitors.

Valiollah Seif, who serves as the governor of the Central Bank of Iran, told local Iranian media outlets that the Islamic Republic "would either replace the U.S. dollar with a new common foreign currency or use a basket of currencies in all official financial and foreign exchange reports," PressTV reported.

Seif anticipates making the transition by March 21, which marks the start of a new fiscal year.

According to Mohammad Baqer Nobakht, a government spokesman, Iran's oil revenue, which is measured in U.S. dollars, is entering the country without any major obstacles, despite the sanctions currently leveled against the Islamic Republic.

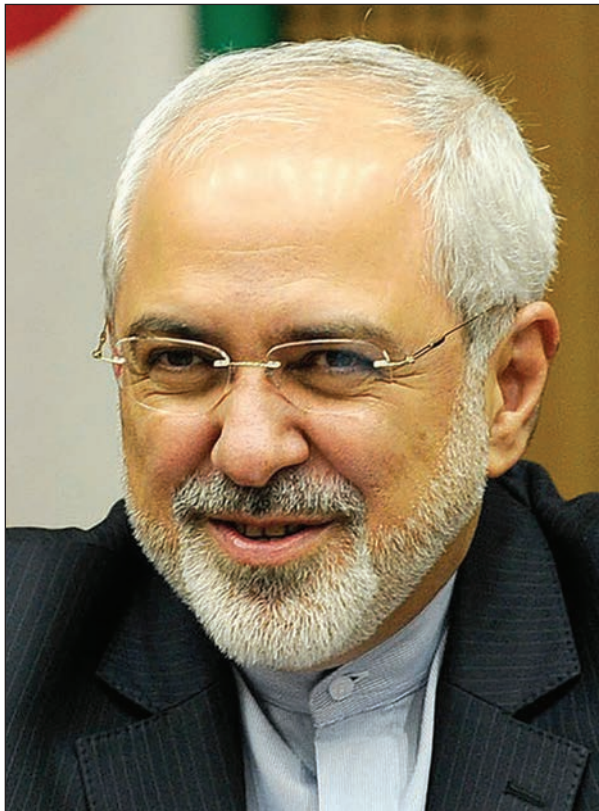
"Under the current circumstances we can receive our oil money without any trouble," Nobakht recently stated. "Based on what the Iranian minister of petroleum has said, we expect to collect over \$41 billion by selling crude oil and gas condensate by the end of the current calendar year."

Tensions between Iran and the U.S. have increased sharply in the past month, particularly following the news Iran had tested a ballistic missile late last month. The Trump administration strongly rebuked Iran, arguing the Persian state violated UN resolution 2231, which calls on Iran to not "undertake any activity related to ballistic missiles designed to be capable of delivering nuclear weapons, including launches using such ballistic missile technology," according to the text of the resolution.

For its part, Iran has correctly pointed out that the resolution does not restrict the Islamic Republic's development and use of non-nuclear ballistic missiles, and that the recent tests are for missiles not designed to carry nuclear weapons.

The Trump administration officially put Iran "on notice" following the test and enacted more sanctions against officials and entities connected to Iran's ballistic missile program. Trump and leading officials in his administration, including former U.S. National Security Adviser Michael Flynn, who resigned Feb. 13, used increasingly hostile rhetoric toward the Islamic Republic, generating comparisons to the lead-up to the invasion of Iraq during the George W. Bush administration.

As he is prone to do, Trump took to Twitter to

condemn Iran, tweeting that Iran is "playing with fire," and that he will not be as kind to the Islamic Republic as former President Barack Obama was.

In addition to vowing to dump the U.S. dollar for official financial reporting, Iran also took efforts to restrict visas to potential American visitors in the wake of the Trump administration's retaliatory actions.

Mohammad Javad Zarif, Iran's foreign minister, declared that Iran would be "unmoved by threats," following the dust-up between his nation and the United States.

"We will never use our weapons against anyone, except in self-defense," Zarif went on to argue.

Throughout the presidential campaign, Trump had vowed to end the disastrous neoconservative-driven foreign policy agenda that dominated the former Bush and, to perhaps a lesser extent, Obama administrations. Increasing tensions with Iran and alluding to possible military action appear to fall right in line with the neoconservative desire to militarily confront and invade Iran to pave the way for Israeli hegemony in the Middle East.

Trump would be wise to recognize a military confrontation with Iran would represent a stark departure from his America-first foreign policy, which he has articulated so well thus far. ★

How the Deep State Plans to Destroy Donald J. Trump

We need to understand, and so does President Trump, that the hoax “war on terror” was used to transform intelligence agencies, such as the NSA and CIA, and criminal investigative agencies, such as the FBI, into Gestapo secret police agencies. empower, are cheering for as they exert power separate and apart from—in fact, in opposition to—the political officials to whom they’re supposed to be subordinate.

And you go—this is not just about Russia. You go all the way back to the campaign, and what you saw was that leading members of the intelligence community, including Mike Morell, who was the acting CIA chief under President Obama, and Michael Hayden, who ran both the CIA and the NSA under George W. Bush, were very outspoken supporters of Hillary Clinton. In fact, Michael Morell went to *The New York Times*, and Michael Hayden went to *The Washington Post* during the campaign to praise Hillary Clinton and to say that Donald Trump had become a recruit of Russia. The CIA and the intelligence community were vehemently in support of Clinton and vehemently opposed to Trump, from the beginning. And the reason was because they liked Hillary Clinton’s policies better than they liked Donald Trump’s.

One of the main priorities of the CIA for the last five years has been a proxy war in Syria, designed to achieve regime change with the Assad regime. Hillary Clinton was not only for that, she was critical of Obama for not allowing it to go further, and wanted to impose a no-fly zone in Syria and confront the Russians.

Why We Should Fear the ‘Deep State’

- State-sponsored false-flag terror their favorite mode of operation to seize power

The growing controversy about leaks and deteriorating relations between the White House and the national intelligence agencies has heightened fears that America has a state within a state. Some have claimed that the intelligence leaks have come from an American deep state, a term more commonly used when describing how a secret, hybrid “government” has existed within Turkey since the start of the 20th century.

A deep state can be defined as an alternative government, or an ad hoc organization comprised of power players from banking, security, the military, intelligence, and politics. In the case of Turkey and other nations, including Pakistan, Egypt, and India, the controlling members of the secret state within a state have mostly been retired generals with direct links to serving military chiefs, or retired judges with ties to the judiciary, police, and internal security networks.

The secret merging of a cabal of policymakers has often been justified as serving the common good. They would argue that in a time of constitutional crisis, or an external threat, there could be a need for an organization capable of forming a new government if all existing leaders had been arrested or executed. While proponents might deem the concept honorable, and an important element designed for an emergency, in practice it is nevertheless a highly secretive and truly manipulative endeavor that permits no oversight from an elected government.

In Turkey particularly, the deep state used its power to run the country from the shadows. It employed secret military units to operate alongside organized crime syndicates, eliminated enemies, and enriched its leaders.

THE U.S. DEEP STATE

If all that seems incongruous in an American context, it should not be. The leaders of Western European democracies have been so uniquely familiar with the existence and the workings of the deep state that there is good reason not to dismiss the fear that the U.S. has its own state within a state. For example, most voters would agree that a military-industrial complex exists, even though they may not know how it is structured, who runs it, and who benefits from it. But before one unravels that issue, it is important to focus on NATO and how it has a known history of running a series of deep states within Western Europe and Turkey.

NATO’s creation of such states in Britain, France,

Italy, and Turkey, to name a few of the major countries where they established them, can be traced to the post-World War II era when the specter of the onward march of communism drove a Cold War and encouraged a widespread fear that countries were ripe to be overrun by the Red Army. NATO’s leadership established what were secretly known as mini “stay-behind” armies that could be activated to harass and begin the struggle against the Red Army if it conquered a NATO member. However, built into the concept was a proviso that the deep state could deploy its power if a country’s constitution or Western democracy was under siege. As a result, during the Cold War deep states used their paramilitary forces to assassinate political enemies throughout Europe, and with regularity in Turkey.

OPERATION GLADIO

In Italy, the deep state, codenamed “Gladio,” was tasked to operate in Italy and Central Europe. It carried out false-flag operations, including bombings and assassinations, in Greece, Italy, and Turkey. Gladio was condemned by the European Parliament in 1972 for its role in a long campaign of terror and crime that led to many deaths. There has never been a proper investigation of the full scope of NATO’s deep-state project, which had other codenames like Absalon, Mountain Rider, and Plan Bleu. No one can say for certain that these secret armed “states” do not exist in some form today.

The CIA and Britain’s Secret Intelligence Service, now known as MI6, were deeply involved with Gladio and coordinated operations with parallel deep-state networks. The CIA, for example, made use of the “Grey Wolves,” a terror organization of assassins controlled by Turkey’s deep-state actors. Turkey set up a new deep state called Ergenekon.

Prof. Peter Dale Scott, a reputable Canadian author, former ambassador, and expert on the deep state phenomenon, argues that the U.S. has its own state within a state, with decades of continuity. He points to a secret group during the Reagan ad-

ministration in 1981 that worked on “Continuity of Government Plans” (COG) to ensure that the U.S. government would survive a national crisis. He asserts that COG plans were activated, without the public’s knowledge, on 9/11. The plans are also known as Continuity Annexes, but are classified top secret and cannot be viewed by members of Congress. He believes that America’s deep-state politics expanded under Barack Obama, as evidenced by his excessive approach to secrecy and the fact that he hounded whistleblowers.

Scott is not alone in worrying that America has a secret hybrid state. So, too, does the post-9/11 FBI whistleblower Sibel Edmonds. She has said that truths about 9/11 were concealed, as were linkages to treason and corruption involving working and former members of the FBI, members of Congress, drug lords, foreign intelligence agencies, particularly Turkey’s, and crime syndicates. She was an FBI foreign languages translator with access to highly classified secrets that were deliberately buried. She was dismissed from the FBI and placed under a gag order, but her claims were never proved false.

If one examines the available evidence of deep-state politics and the fact that the existence of a secret military-industrial complex is no longer disputed by even the most skeptical critics, it is hard to dismiss the suspicion that deep states function within Britain and America, with an agenda to take power in a national crisis. ★

Are Hate Crimes Really on the Rise in America?

According to the Southern Poverty Law Center (SPLC) and other leftist activist organizations, “hate” is on the rise in America. They’re blaming President Donald Trump and his America-first populism, but is this just another example of fake news that’s being promoted by the radical left and the mainstream media?

A major theme throughout the 2016 presidential election was the alleged rise in “hate incidents” and “hate groups” purportedly targeting minorities, topics the SPLC has made its living on by hyping and exaggerating for decades now.

The spring 2017 edition of the *Intelligence Report*—a quarterly publication written and produced by the SPLC, which “provides comprehensive updates to law enforcement agencies, the media and the general public” about the “radical right” in America—argues that the number of “hate groups” operating in the U.S. has risen for the second consecutive year. According to the report, “hate incidents” are also on the rise, fueled largely by Trump’s presidential victory and his populist, America-first policy positions on immigration.

The report goes on to argue that hate incidents against Muslims and other immigrants have risen dramatically, driven largely by Trump’s rhetoric concerning illegal immigration and the threat of radical Islamic terrorism.

But what exactly constitutes a hate incident is largely open for interpretation.

As this newspaper has covered extensively, so-called hate crimes are, in many cases, exaggerated and even faked by individuals and a complicit mainstream mass news media. On the

other hand, so-called hate incidents need not be investigated by law enforcement. They are merely an accounting of someone’s claim that a person was the victim of someone’s “hate.”

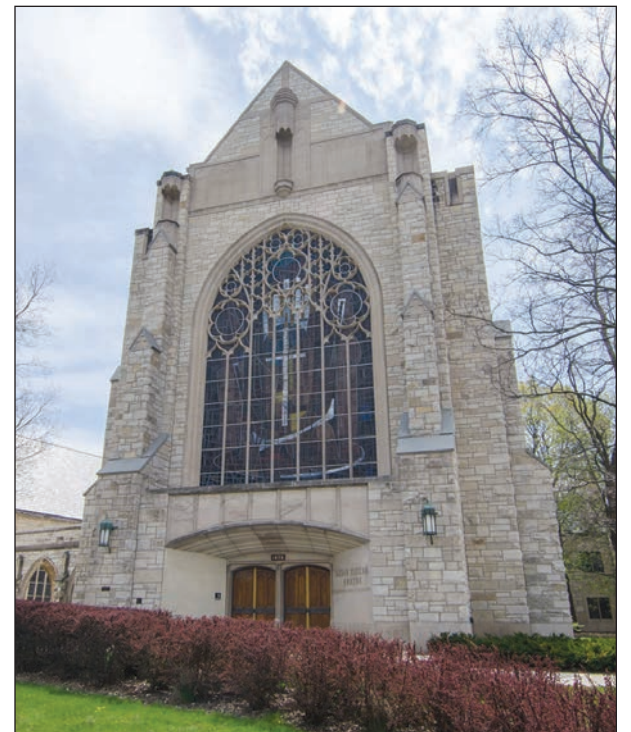
For instance, according to a local NBC affiliate in D.C., Montgomery County, Md., which sits just north of the nation’s capital, allegedly saw a dramatic spike in hate incidents in 2016. The report notes that 94 “biased incidents” were reported in the county during 2016, a 42% increase in such incidents from the previous year.

“The spike in hate crimes was a direct correlation to the kind of campaign that was run for the president of the United States,” County Council President Roger Berliner told reporters. “It unleashed an energy that is very destructive.”

Incredibly, one example of a “hate crime” cited in the report included Trump supporters’ being called nazis or cars being vandalized with swastikas, which runs contrary to Berliner’s line of thinking.

In fact, Trump supporters—or perceived Trump supporters—were violently attacked and abused throughout the presidential campaign season, a fact that is rarely, if ever, brought to light by leftist groups. In comparison, violence allegedly committed by Trump supporters is regularly hyped, exaggerated, and, in some cases, entirely invented by groups such as the SPLC and their enablers and supporters in the mainstream mass news media.

Similarly, some Jewish groups have argued that “anti-Semitism” and “hate” are on the rise as well. The Anti-Defamation League (ADL) recently published a list of the top 10 manifestations of “anti-Semitism” in 2016, which included Jewish journalists being called bad names on the Internet in addition to the rise of the alt-right, an increasingly popular political dissident movement

driven largely by nationalist and racist ideas. Adding to this claim, the ADL also released a report saying that Jewish community centers had received around 50 bomb threats in the last two months.

Hurt feelings aside, the FBI is reportedly investigating the bomb threats but has not released any specifics on these bomb threats, which all turned out to be hoaxes.

It’s worth noting that, while Jewish community centers may have received 50 bomb threats in two months, in 2016, schools across the U.S. averaged over 100 bomb threats every month, or over 1,200 for the entire year—a startling statistic that shows, overall, American schools regularly face four times the number of threats as compared to Jewish community centers. ★

Radical Left Targets Alternative Media

• Internet giants work hand-in-hand with thought censors to shut down independent outlets

AdSense, the online advertising giant owned by Google, has cut ties with two politically incorrect media outlets, one of which is this newspaper's website, following pressure from Media Matters, a leftist media watchdog group financed in part by George Soros.

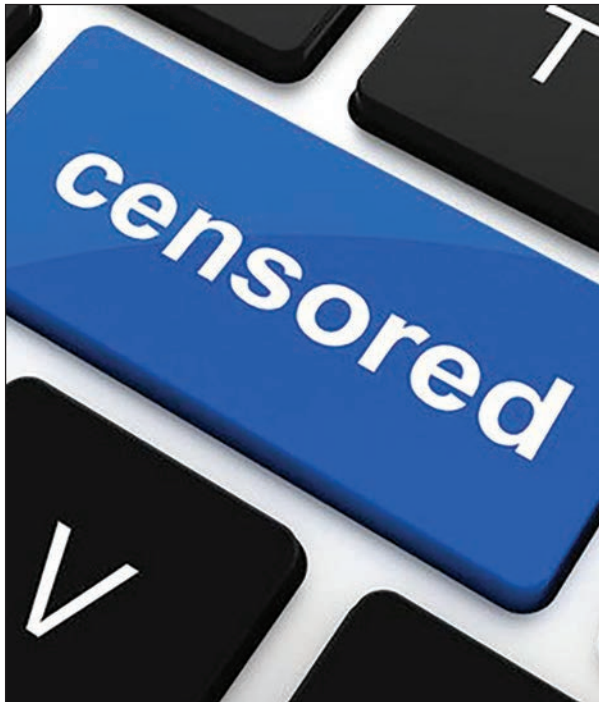
In addition to AFP's website, Counter-Currents Publishing, a white nationalist book publishing company that also maintains a website featuring blog posts and longer essays from various contributors, had its AdSense account terminated, according to a recent monthly newsletter written by Greg Johnson, the editor-in-chief of the company.

On Jan. 30, Media Matters, which has close ties to many of the leading personalities that ran Hillary Clinton's 2016 presidential campaign, including John Podesta, published an inflammatory article entitled, "How Anti-Semitic and Holocaust-Denying Websites Are Using Google AdSense for Revenue." The article highlighted four independent media outlets—AMERICAN FREE PRESS, Counter-Currents Publishing, *The Right Stuff*, and "Veterans Today"—that used Google's AdSense program to place online advertisements on their respective websites to generate income. The article argued that "some of the worst purveyors of anti-Semitism on the Internet" were using AdSense to generate advertising revenue, and that these independent media outlets were "seemingly in direct violation" of AdSense's program policy of prohibited content.

"Google believes strongly in the freedom of expression, but also recognizes the need to protect the quality of the AdSense network for users, advertisers, and publishers," according to AdSense's prohibited content policy. "Google ads may not be placed on pages that contain harassing or bullying content, or on content that incites hatred or promotes violence against individuals or groups based on race or ethnic origin, religion, disability, gender, age, veteran status, or sexual orientation/gender identity. Additionally, Google ads may not appear on content that incites or advocates for harm against an individual or group. However, pages containing educational, documentary, historical, scientific, or artistic content related to such subjects are permitted to participate in AdSense."

Any objective reader of this newspaper and its online platform will fully recognize the fact that AMERICAN FREE PRESS has never and would never publish articles or opinion pieces that "contain harassing or bullying content" or content that "incites hatred or promotes violence" against any individual or group for any reason whatsoever.

This is just the latest attempt by the left and



the enforcers of political correctness to shut down or otherwise limit free expression on the Internet. Politically incorrect media outlets and personalities are regularly targeted for "hate speech" violations on social media, resulting in their accounts being terminated. Major Internet giants such as PayPal, Amazon Affiliates, and AdSense often consult with leftist activist organizations—including Media Matters, the SPLC, and the Anti-Defamation League (ADL)—to determine which organizations or individuals to target for censorship.

This writer, for instance, had his PayPal ac-

count permanently shut down in late November 2014 following pressure from the SPLC and ADL. To this day, I remain banned as an individual from utilizing PayPal's services. Other writers, activists, and online content producers have also had their PayPal accounts permanently limited. These actions have severely hampered the ability of independent media outlets and journalists to solicit donations and raise much-needed revenue.

Unlike many European nations, which jail political dissidents and those who engage in "hate speech," those with politically incorrect views cannot be legally discriminated against by the state in America. However, private entities and corporations, such as Google, AdSense, PayPal, Twitter, Facebook, and other Internet giants, can and do discriminate against those daring to challenge the sacred dogmas of the left, often at the behest of radical leftist activist organizations.

Engaging in meaningful political dissent, challenging the officially sanctioned narratives of history as well as current events, and publishing information and perspectives that run contrary to the wishes and dictates of the powers that be is a risky business in America, despite the First Amendment and longstanding tradition of freedom of thought and intellectual inquiry.

Readers would be wise to support the efforts of independent media outlets, especially AMERICAN FREE PRESS—America's last real newspaper—while limiting their support and business dealings with the top Internet monopolies, which have proven over and over again their willingness to become the enforcers of political correctness at the behest of the radical left. ★

AFP Heads to Southern Border to Attend Multiple Meetings on Illegal Immigration

RIO GRANDE VALLEY, Texas—President Donald Trump's promise to shore up America's porous border has placed a spotlight on the Lone Star State, specifically in the south where it's widely accepted that more people illegally enter the U.S. through the Rio Grande Valley than any other location.

For example, two recent southern-Texas forums that addressed immigration and the border wall revealed that open-borders advocates are willing to torture logic in order to demonize Trump and justify nearly unconditional passage across the U.S. southern border.

This became strikingly apparent when this writer covered both events: A Feb. 16 "border wall" forum in Pharr and a Feb. 20 roundtable led by five House Democrats at the LUPE (La Union del Pueblo Entero) union hall in San Juan. LUPE is a Hispanic social assistance and advocacy organization operated by and for the area's most strident backers of liberal immigration policies.

The five Democrats present at the San Juan meeting were Reps. Filemon Vela (Texas), Joe Crowley (N.Y.), Lucille Royal-Allure (Calif.), Vince Gonzalez (Texas), and Rosa DeLauro (Conn.). The House Democrats were there mainly to hear local

people's views. To the extent that they spoke it was mostly to cast doubt on building a border wall while also relating personal stories. For instance, Crowley said his parents immigrated from Ireland to work in the U.S., though he didn't mention that Europeans have traditionally come to America legally, not illegally.

BUILD A WALL

Some in attendance at the Pharr forum clearly took issue with the pro-immigration Democrats. After the Pharr forum, "Silver" Treviño, who worked for federal immigration for 29 years and helped qualify people for residency and citizenship, told AFP that border security needs the human factor. "The lack of manpower [starts] at our ports of entry and extends to adjudication officers," he said. "You have people coming in from all over the world, through airports, through seaports, by train, and guess what? There's not enough officers out there, either. And the border at the south of Mexico should be enforced. Actually, 'the wall' deserves to be over there."

That tied into comments by Brooks County rancher and veterinarian Dr. Michael Vickers, one of four forum panelists.

"The numbers are staggering. We've been at the top for a long time, [surpassing] Yuma, Ariz.," he said, referring to south Texas being the nation's illegal-entry capital, "especially OTMs—other than

Mexicans—people from all over the world." As he noted during the forum, that even includes people from Bangladesh and the Middle East.

On his 1,000-acre Brooks County ranch, he recalled a group of 16 illegals being caught there. It was a "hodge-podge," he said, with "one Mexican, two or three Chinese girls, a couple of guys from Pakistan . . . a couple of Central Americans."

While he agrees Mexico's border with Central America needs major security improvements, he continued: "Some people fly into Monterrey and hire a cartel or gang member to take them into our country illegally. We've actually had people apprehended on my ranch who did that—they flew into Mexico City from Venezuela, or from some other country, maybe China—Chinese flying in from Ecuador to Mexico City or to Monterrey and then hiring the cartels to bring them into the country illegally."

He repeated a key question raised during the Pharr forum: "Why don't we put more pressure on Mexico to shut down this traffic coming into our country illegally?"

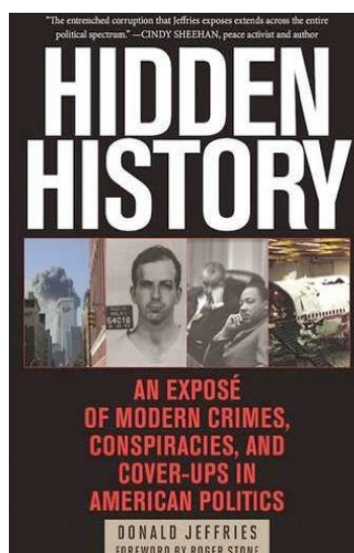

This writer pressed the congressional panel in San Juan regarding how tens of thousands of Central Americans—most of whom are desperate and penniless, often escaping immediate drug-cartel danger or chronic malnutrition or poverty—manage to travel 1,900 miles from Central America to Texas in searing heat.

The question was deferred to Elaine Hernandez, the south-Texas representative of Baylor University's Hunger Initiative.

“By the grace of God, using buses [and trains] they are brought through the ‘coyote’ systems, so they are trafficked through Central America, through Mexico to Texas,” she said, adding, “They are being transported to the border through a big network of criminals.”

That reply reveals a key fact that few are willing to confront: Loose U.S. border regulations undergird and help enable the transnational gateway

for smuggling humans and drugs.

And it's well known that “coyotes” (human-traffickers in the field who do the dirty work, shuffling people and contraband from country to country) have no qualms about forcing vulnerable Central Americans and others into earning their travel arrangements by assisting in criminal activities. Obedience is also secured by threatening family members and other means.

OFFICIAL VISITS

In addition to these two forums, Texas Sen. Ted Cruz (R) visited the Rio Grande Valley's border zone and met with area mayors in a closed-door meeting Feb. 18. The other Texas senator, John Cornyn, was joined by several senators for a border tour Feb. 19-20. Cruz and Cornyn say they support stricter border security, though their comments have been tentative while they gather more firsthand border information.

Finally, in what is perhaps the largest presence of Congress in south Texas history, House Speaker Paul Ryan (R-Wisc.) on Feb. 22 also visited the Rio Grande Valley—amid protests that typically include LUPE members. ★

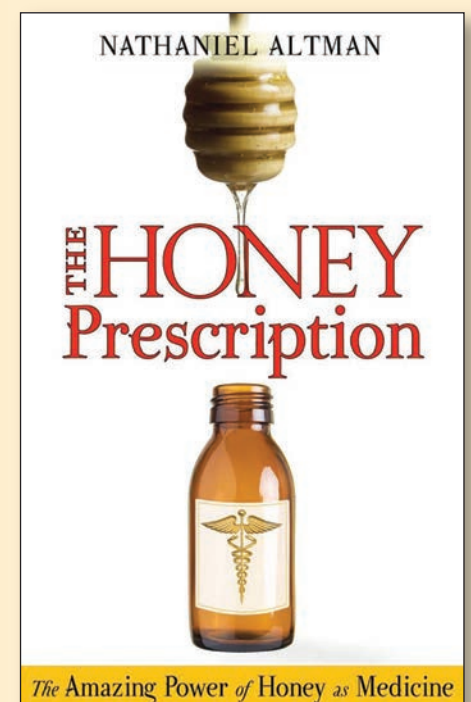

Globalists Gather in Middle East to Openly Advance the Cause of World Government

The subtly named “World Government Summit,” Feb. 12-14 in Dubai, United Arab Emirates, included a few Bilderberg Group and World Economic Forum (WEF) members, such as WEF founder Klaus Schwab and frequent Bilderberg attendee Christine Lagarde, longtime International Monetary Fund chief.

But with Arab officials comprising perhaps half of the attendees, the pedigree of this much-less-known annual summit differs significantly from the Bilderberg-WEF axis and its North American-European complexion. An overriding fixation on world rule, though, is the irreducible shared goal.

The annual Bilderberg meeting involves a mere 140 high flyers from finance ministries, banking, royalty, parliament, the technology sector, select silent media etc. Bilderberg’s anonymous press department issues one sketchy annual press release and produces zero video footage of its speeches and proceedings.

But with 90 speakers and 4,000 attendees from 130 countries, the Dubai summit, much like the WEF, is a larger and more open forum that’s broadcast worldwide via the summit organizers’ YouTube channel and official website.

Notably, the Dubai summit follows another recent indication that world government is really upon us. The world-government deniers over at *The New York Times*, referring to the 2017 WEF in Davos in January, quoted economist John Mauldin as saying: “Trump’s election victory is a clear indication that the majority of people are not interested in a world government, but want to return to a classical local democracy. Strange as it may seem to the Davos [WEF] men, most people tend to love their ‘patria,’ the land of their fathers.”

CURIOUS PRONOUNCEMENTS IN DUBAI

The Dubai summit’s website is littered with quotes from attendees that seek to inspire—but often carry ambiguous meanings with a rather negative aftertaste.

For example, Sheikh Nahyan bin Mubarak Al Nahyan, who heads UAE’s Ministry of Culture, Youth, and Social Development, was quoted as saying, “An outstanding government views every citizen as a natural resource,” implying that people are considered commodities.

To be fair, other attendees stated nicer-sounding pabulum like, “The happiness of our people is prioritized as a public good”—an object of “our efforts to promote human and sustainable development.”

Sustainable development, which has an imprecise meaning, may in some cases lead to better poli-

cies to preserve water and soil, but in many cases, United Nations-style sustainable development involves top-down policies that impose costly regulations that erode private property and make land less productive, while actually harming the environment and eroding the food supply.

UN BUREAUCRAT SPEAKS

Getting into deeper essentials in Dubai, Helen Clark, the 8th director of the United Nations Development Program and former prime minister of New Zealand, gave an address that summed up the core outlook of the summit. In so doing, she addressed certain challenges she described as “being beyond the capacity of nation-states” to resolve themselves.

Her talk was not without its surprises. “We’re now for global governance,” she announced, as if full support for world governance is just now coming to the fore. But, as she said, the framework for world government came when the League of Nations (precursor to the UN) was formed 100 years ago, although the league, purportedly devoted to peace, failed to stop World War I.

Besides, those in elite circles, like Ms. Clark, have for decades pushed for and helped establish de facto world government through the UN (founded in 1945) and through various other institutions.

She also noted, “I think the magnitude of the shared problems we have does require us to continually reinvigorate the multilateral institutions.”

For instance, in the “peace and security” realm, “effective global governance . . . is struggling,” she admitted. Therefore, she said, UN member states should move ahead “with progressive agendas” to reinvigorate the UN’s mission to address “the root

causes of conflict.”

She was silent, however, on UN members like the U.S., Israel, and the UK helping terrorist outfits like ISIS under the guise of fighting them via arms shipments and official lies about the goals of ISIS.

Moreover, Western powers are always blaming Russia and the Syrian government—who’ve managed to put down ISIS and liberate the Syrian city of Aleppo—for much of the widespread destruction in that nation, which, since 2011, has driven tens of thousands of Syrians into Europe and beyond.

Yet UN and EU officials have a tough time fully admitting that Western-armed wars are the chief cause of the refugees, while these same officials profess a desire to address the “refugee problem.”

Furthermore, the UN’s 2030 Agenda for Sustainable Development, Ms. Clark cryptically reminded the Dubai audience, “boldly asserts there can be no sustainable development without peace and no peace without sustainable development.”

She concluded that “success” in implementing the UN agenda, besides presumably helping “people and planet” will have “long-term benefits . . . for the legitimacy, relevance, and credibility of the multilateral system,” suggesting that this system’s legitimacy and relevance are on fragile ground.

That’s largely due to more people losing their appetite for world governance, voting for Brexit (for the UK to leave the EU) and for Donald Trump as U.S. president among other signs of people rebelling against “the rules-based world order.” That new order, according to the one-worlders in Dubai, at Bilderberg, and at other such gatherings, is among the great wonders of the world—with its Bretton Woods-based financial system comprised of the World Bank, the IMF, and world-trade arrangements.

But the usurious, debt-based central banking system, whose early roots include the Bank of England’s formation in 1694 and the private Federal Reserve’s in 1913, was taken to the next level at the 1944 Bretton Woods Conference that spawned these worldwide financial arrangements.

The IMF, by entangling nations in revolving-debt schemes to keep them subservient to their creditors, has become synonymous with creating poverty, which Ms. Clark named as a chief cause of the wars and conflicts that the UN system seeks to prevent or stop.

Unless Ms. Clark is unaware that the world-governance organizations are sometimes causing the very problems that the system’s managers say they want to solve, then she’s being disingenuous, at best. ★

Forced Vaccinations Unconstitutional

• Government shouldn't be able to deny people the right to make own medical choices

Chances are, you've never heard the tragic story of Lucille Sturdevant, who died at six years of age, likely due to forced vaccination. As reported in *Vaccination and Naturopathic Medicine*, "On May 15, 1902, she was in Buffalo, New York's School 35, and two public vaccinators, accompanied by two policemen, visited the school to engraft cow virus into the children at a dollar a head. Though Lucille was only six years old, she objected, saying she had been vaccinated and that she would go home, but would be vaccinated if she must. In spite of this, the officers threatened and forcibly vaccinated her.

"She died of blood poisoning 13 days later."

In the *Journal of the American Medical Association's* "Medical News" on March 4, 1904, it was reported that Lucille's father was attempting to raise money after losing a lawsuit against the city for causing the death of his daughter.

The *Journal* wrote, "A stone erected over her grave in Forest Lawn Cemetery states that she died of compulsory vaccination."

The horror surrounding Lucille's death reverberated through the United States, and as reported in *Vaccination and Naturopathic Medicine*, "Sad stories such as Lucille Sturdevant's sent alarms and parents rose up with more conviction to defeat compulsory vaccination bills within their state. In Berkeley, Calif., a group of parents removed their children from public school and 'an anti-vaccination school was opened on Aug. 7, 1905 for all the children whose parents were opposed to vaccination.' These parents belonged to the California Anti-Compulsory Vaccination League and together they were able to change the laws so that 'children need not be vaccinated, provided the parents sign a certificate that they are opposed to the practice of vaccination, and that it is the duty of the school board to furnish every parent with one of these blanks [exemption forms].' The struggle to win their state legislature was no easy task. California's governor, Dr. G.C. Pardee, had the power to veto efforts to modify compulsory vaccination laws, which he did in fact do."

If you're new to the vaccination topic, know that the controversy has a long history in the United States, going back more than 100 years, with some medical doctors and most naturopaths opposing compulsory vaccination.

In 2017, to question vaccines is like saying the Earth is flat.

Dr. A.J. Clausen, M.D., a leading anti-vaccination medical doctor and member of the Anti-Vaccination



Dr. Bob Sears of California has been an outspoken advocate of the rights of parents to resist mandatory vaccinations. For doing so, he could lose his medical license. Sears had merely exempted one toddler from mandatory vaccinations after the child's parents expressed legitimate concerns about the dangers of vaccines and the additives used to give them a longer shelf life.

Society, was incensed that compulsory vaccination could even exist under the Constitution.

Speaking at the St. Paul chapter of the Anti-Vaccination Society in 1901, Clausen passionately argued, "if there is anything a man owns, it is his own blood, and just as a man has the unquestioned right to choose his political party, religion, physician, and to say whether a surgical operation shall be performed on his body, just so he has the right to reject vaccination."

In 2017, parents in states like California struggle with the reality of being ordered to have their children be vaccinated if they wish to attend public school. California allows only a "medical" exemption for vaccination, rejecting religious and philosophical waivers under SB 277, a mandatory vaccination law passed in 2015, which became effective in 2016.

California parents objecting to mandatory vaccination sued in U.S. district court in San Diego, requesting an injunction to block its enforcement on the grounds SB 277 violates constitutional rights to an equal education and free exercise of religion.

The federal judge hearing the case denied the plaintiffs' claim, holding that, "Even outside the con-

text of vaccination laws, the Supreme Court has reiterated the fundamental rights under the First Amendment to the United States Constitution do not overcome the state's interest in protecting a child's health."

Robert Moxley, one of the attorneys representing the parents, was quoted in *The San Diego Union*, "The principle we have to defend and establish is the right of healthy people to make their own healthcare choices. We're going to have to delve into a thicket that, of course, a preliminary injunction hearing just doesn't delve into. What we are exploring is individual rights versus the power of the state and all of the nuances and legal background is going to have to be applied to vaccines which, obviously, it never has. When most of the precedents being relied on are 100 years old, there is room to litigate this thing."

Some parents homeschool their children or have left the state because of this issue. Others who attempt to receive medical exemptions may find themselves out of luck because the California Medical Board severely minimizes the need for medical exemptions for vaccinations, just as the Centers for Disease Control and other federal agencies have done

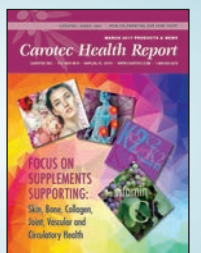

Establishment writers criticize Sears for not properly documenting and investigating the claims of the parent, but adverse reactions to vaccinations, medications, and other orthodox treatments routinely fall on deaf ears.

When parents who oppose vaccinations—in the trend-setting, most populous state of the union—cannot exercise judgment about whether it's a good idea to inject viruses, with questionable adjuvants, because they will be supposed carriers of disease, which will affect those who receive such vaccinations, we can fairly say American liberty has not advanced at all since the tragic death of Lucille Sturdevant, who sadly, died in vain. ★

Oroville Dam: A Symbol of U.S. Decay

• Will spillway failure be wake-up call to fix crumbling infrastructure?

Oroville Dam in the Sierra foothills of northern California is the tallest dam in the United States at 770 feet. Its man-made lake can store up to 3.5 million acre-feet of water and is California's second largest. But unusually high rainfall and snowmelt, combined with recent major structural damage, created a highly volatile and dangerous situation for the countless residents downstream. The dramatic events have become a metaphor for the country's collapsing infrastructure—unrepaired and unreplaced, while trillions of dollars are spent on needless foreign “aid” and wars of aggression.

The threat of potential failure of the Oroville Dam's earthen-wall emergency spillway, following major erosion damage to the main spillway into the Feather River, resulted from a series of weather events called atmospheric rivers—plumes of va-

por carrying tropical moisture, which turn into massive rainfall and snowstorms when they hit land. Normally, northern California sees one or two per winter. There have been five already this season, and rainfall in San Francisco has exceeded in less than four months what is normal for a full year.

Combined with higher-than-usual temperatures early in the year melting part of the snowpack in the mountains to the east, all the rain has filled numerous rivers and lakes, including those behind dams, to their capacity. Flooding has occurred already in numerous locations, but it is nothing compared to what is impending if the rains and snow do not stop soon.

The situation in Oroville became critical in early February, and more than 180,000 down-river residents had to be evacuated twice due to fears of the dam's water retention capacity being overwhelmed. When its emergency spillway began releasing water, it was the first time in its 50-year history. Dramatic videos showed the massive volume of water destroying part of the main spillway and

eroding the hillside below the emergency spillway.

As of this writing, Oroville Dam has not failed, but government officials appear to be overly optimistic about their efforts to control the situation through allowing nine dams above Oroville to fill to capacity, despite ongoing heavy rains and the greatest part of the snowmelt still to come.

The political desire to present an appearance of normalcy, however, may in the long run lead to tragedy, as local residents may have less than an hour to evacuate ahead of a flood. A previous Oroville evacuation was already a disaster in itself, due to inadequate roads, lack of government preparation, and panic.

Even the five hours' notice that residents far down the Sacramento Valley may receive would not be sufficient for a safe evacuation. If a flood occurs, most residents likely would be trapped. The same scene is being repeated across much of northern California now.

But the Oroville situation could have been averted. Federal, state, and local officials were warned

Oroville Disaster a Warning

According to “GovTech.com”: “The torrent chewed up trees and soil alongside the concrete spillway before rejoining the main channel below. Engineers don’t know what caused what state Department of Water Resources spokesman Eric See called a ‘massive’ cave-in that is expected to keep growing until it reaches bedrock.” Of course they may not know exactly what caused the massive cratering of the concrete spillway, but experts have been warning about it since 2009. Furthermore, these were potentially catastrophic problems with both the primary and emergency spillways that were brought to the attention of not only state but federal officials. How many other U.S. dams are ready to burst from neglect and lack of proper maintenance?

12 years ago of design and maintenance inadequacies in the dam and its spillways, but those who could have done something refused to listen and did not take action. Some authorities actively opposed remediation efforts, in part due to costs. The same conflict was repeated some years later. They sowed the wind and now reap the whirlwind. Past political shortsightedness has very human consequences—as we clearly saw with the levees in New Orleans.

Even now, authorities appear to have minimized events repeatedly at Oroville. While officials claim everything is “stable,” an engineer at the site warned that people should get out.

Oroville Dam is not unique, however. Two thousand California bridges are structurally deficient, according to SFGate.com. Some 71% of San Francisco Bay area roads are in poor condition.

Nearly everywhere in the United States, roads, freeways, bridges, overpasses, railway lines, and more are decaying or crumbling. If repairs are made, they may be minimal and employ inferior materials and workmanship, which do not hold up, but guarantee more business to the contractors.

Readers can go to “UglyBridges.com” and search out the condition of bridges across the country. Kansas, for example, has over 20,000 of them, mostly in rural areas. A significant percentage of them are structurally deficient, with little or no funding available to repair or replace them. In this author’s home county alone, around 30%-40% are apparently structurally deficient.

And if Kansas roads are, as politicians claim, among the best in the nation, one shudders to think how bad they are elsewhere. Many streets and highways in the state capital, Topeka, are genuine

obstacle courses.

Similar situations exist in nearly every state, but politicians of both parties at all levels would rather play footsie with illegal foreigners or cause death and destruction in distant lands than do anything to help their own constituents at home in America. It is past time for change.

Tell Congress to stop obstructing President Donald Trump’s plans to rebuild America’s infrastructure and to fund the work by ending U.S. overseas interventionism. The military-industrial-banking complex needs to yield the right-of-way to real Americans. Then tell your state and local governments to stop bankrolling illegal foreign invaders and fix the infrastructure, too. ★

President Can

By excluding foreign immigrant Muslims from coming to America to live, President Donald Trump does no wrong. The provisions of the Constitution extend only to the territory of the United States, and to the legal citizens living therein. Foreign nationals do not have any intrinsic birthright of access to the Constitution and the liberties it enumerates therein.

A sitting president may issue an executive order based on a previously passed piece of legislation from Congress. Also, the president takes a public oath of office before God Almighty to "preserve, protect, and defend the Constitution of the United States." The Declaration of Independence, while not law per se, still gives a prologue, or a statement of *raison d'être*, for the Constitution.

Governments are instituted among men to secure to them certain God-given and therefore inalienable rights—one of which is the right to life. Government therefore has every intrinsic obligation to protect the safety and security of the American people from all enemies, foreign and domestic. Indeed, the Fifth Amendment asserts that Americans shall not be deprived of life, without due process of law. Pro-Life Americans Still Subsidizing Abortions

Last month marked 44 years since the Supreme Court's *Roe v. Wade* decision declaring a constitutional right to abortion. *Roe* remains one of the Supreme Court's most controversial decisions. Even some progressive legal theorists who favor legalized abortion have criticized *Roe* for judicial overreach.

Throughout my medical and political careers, I have opposed abortion. I believe abortion is the killing of an innocent human life and, thus, violates the non-aggression principle that is the basis of libertarianism. Unfortunately, many libertarians, including some of my close allies, support legalized abortion. These pro-abortion libertarians make a serious philosophical error that undermines the libertarian cause. If the least accountable branch of government can unilaterally deny protection of the right to life to an entire class of persons, then none of our rights is safe.

While I oppose abortion, I also oppose federal laws imposing a nationwide ban on abortion. The federal government has no authority to legalize, outlaw, regulate, or fund abortion. Instead of further nationalizing abortion, pro-life Americans should advocate legislation ending federal involvement in abortion by

restoring authority over abortion to the states.

Congress should also end all taxpayer funding of abortion and repeal Obamacare's abortion mandates, along with the rest of Obamacare. Forcing pro-life Americans to subsidize what they believe to be murder is, to paraphrase Thomas Jefferson, "sinful and tyrannical." That is why I was glad that one of the first actions of the new House of Representatives was to pass legislation ending all taxpayer support for abortion. Hopefully the bill will soon pass in the Senate and be signed into law by President Donald Trump. Congress should follow this action by passing legislation allowing antiwar taxpayers to opt out of funding the military-industrial complex as well.

The House-passed bill also repeals Obamacare's mandates forcing private businesses to cover abortion and birth control under their health insurance plans. Of course, I oppose these mandates. But, unlike many other opponents of the mandates, I oppose them because they violate the rights of property and contract, not because they violate religious liberty.

Opposing the mandates because they violate the religious liberty of a few, instead of the property rights of all, means implicitly accepting the legitimacy of government mandates as long as special exemptions are granted for certain groups of people from certain groups of mandates.

President Trump has already protected pro-life tax-

payers (and unborn children) by reinstating President Ronald Reagan's Mexico City policy. The Mexico City policy forbids U.S. taxpayer money from being used to support any international organization that performs abortions or promotes abortions. Using taxpayer money to perform and promote abortions overseas is not only unconstitutional and immoral, it also increases resentment of the U.S. government. Unfortunately, as shown by the recent Yemen drone strikes, President Trump is unlikely to substantially change our militaristic foreign policy, which is responsible for the deaths of many innocent men, women, and children.

Ending taxpayer support for abortion is an important step toward restoring limited, constitutional government that respects the rights of all. However, those who oppose abortion must recognize that the pro-life cause's path to victory will not come through politics. Instead, pro-lifers must focus on building a culture of life through continued education and, among other things, support for crisis pregnancy centers. These centers, along with scientific advances like ultrasound, are doing more to end abortion than any politician. Anti-abortion activists must also embrace a consistent ethic of life by opposing foreign policy militarism and the death penalty. ★

Will Steve Bannon Be Trump's Downfall?

• Quixotic "bookworm of the Beltway" leading president down a dangerous path of war

By all accounts, President Donald Trump is not exactly an avid reader. But don't worry: His top advisor, Steve Bannon, more than makes up for Trump's deficiencies as a bookworm.

People who knew Bannon before he was famous say his apartments were so cluttered with books there was barely room to sit down. Today, an associate calls him "the most well-read person in Washington." Some might find that reassuring. But those of us who are aware of the perils of hyper-literacy might add one more book to Bannon's reading list: Miguel Cervantes's *The History of the Valorous and Wittie Knight-Er-rant Don-Quixote of La Mancha*.

Cervantes's classic forged the prototype for all comedy duos: a bookworm with his head in the clouds (Don Quixote) and an illiterate bon vivant (Sancho Panza). It's a pair reminiscent of Bannon and Trump. Like Laurel and Hardy or Abbott and Costello, this kind of pairing can wind up in a whole lot of trouble. One imagines Trump turning to the rumples, idea-crazed Bannon and saying, "Well, here's another nice mess you've gotten me into!"

Bannon is already tilting at windmills. And the two big windmills on his agenda are Iran and China.

It was Bannon who had Trump put Tehran "on notice" after Iran's latest routine, treaty-permitted missile test. Bannon also tried to convince Trump to at-

tack an Iranian ship in international waters on the pretext that the ship was delivering arms to Houthi forces, who are fighting U.S.-Saudi sponsored al Qaeda terrorists in Yemen. Thankfully, Bannon's lunatic, war-criminal proposal was nixed by the rest of the National Security Council.

Iran is a vastly bigger, stronger, better-defended country than Iraq ever was. Its people will defend themselves to the death, as they proved in the "imposed war" against Saddam's Iraq during the 1980s. And Iran is closely allied with Russia and China. Iran has the world's best Russian and Chinese anti-ship missiles and can shut down the Persian Gulf and cripple the world economy any time it chooses. Even the necons at *The Atlantic* magazine discovered that no matter how they tweaked the parameters of their war games, the U.S. could not win a war with Iran.

Bannon is also tilting at an even bigger windmill: China. He insists that the U.S. is doomed to fight the world's most populous (and biggest GDP) nation: "We're going to war in the South China Sea in five to 10 years, aren't we? There's no doubt about that."

How will the U.S. fare in Bannon's wars? Like Don Quixote, Uncle Sam will be lucky to emerge from such insane skirmishes badly bruised and battered. But at least Don Quixote survived. After all, he is basically a comic book character, like Wile E. Coyote, who can dust himself off for the next episode no matter how badly he gets pummeled.

The real-life United States is not a comic book character. Its economy, morale, and global leadership credentials have already been devastated by the ruinous

series of wars unleashed by the 9/11 false-flag operation. Even if in some sense we "won" those wars—by overthrowing Iraq's Saddam Hussein and Libya's Muammar Qaddafi, shattering Sudan, Syria, and Somalia, and establishing a permanent occupation in Afghanistan—such "victories" have come at a terrible price. In the words of the Roman General Pyrrhus, one more victory like that will utterly undo us.

Not one of these "victories" has improved America's strategic position. Their only beneficiary is Greater Israel.

Bannon recognizes the sorry state we are in. He knows we are facing a crisis. He understands that the disastrous 9/11 wars are the single biggest cause of that crisis.

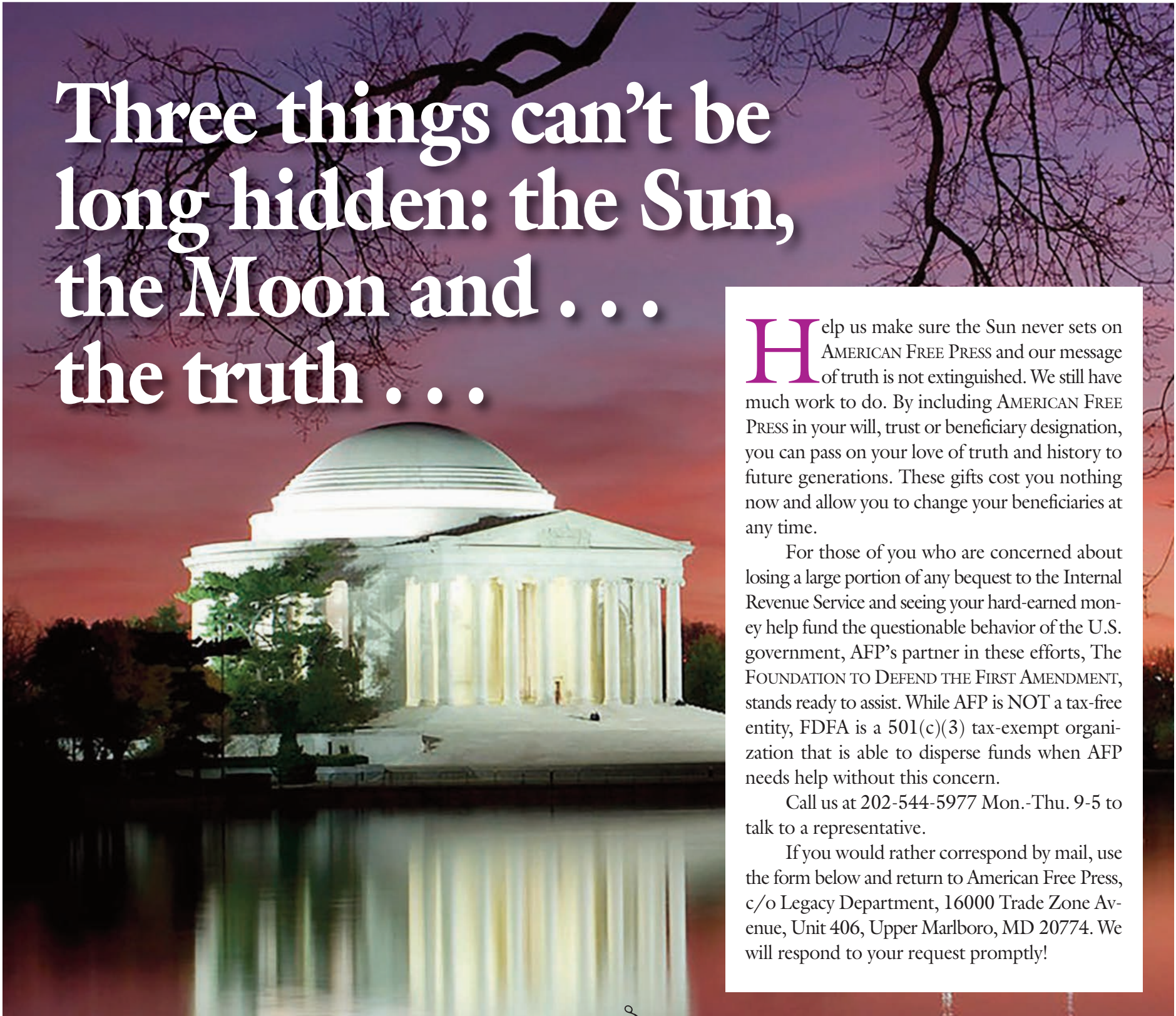
But the obvious solution—George Washington's foreign policy of non-attachment, which is basically Trump's instinctive policy as well—isn't exciting or romantic enough for Steve "Quixote" Bannon. The former "Breitbart" news executive thinks the remedy for a patient afflicted by the disease of war is to afflict him with even bigger wars.

Trump's instincts are right. Bannon's Quixotic fantasies are not just wrong, they are insane.

Bannon must be removed from power. America's and the world's survival depend on it. ★
